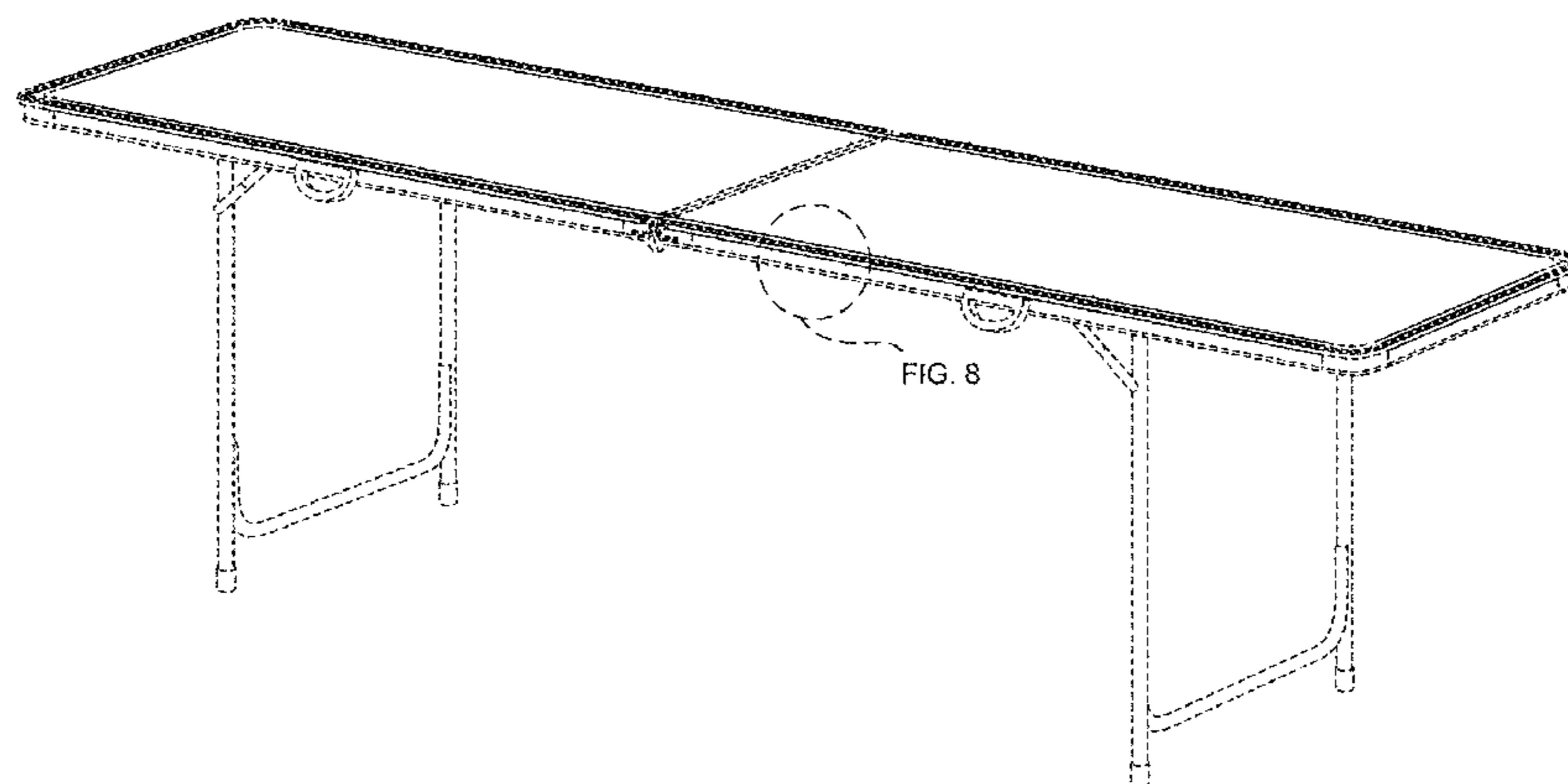
(57) **CLAIM**

An ornamental design for a gaming table, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of our new design of a gaming table;

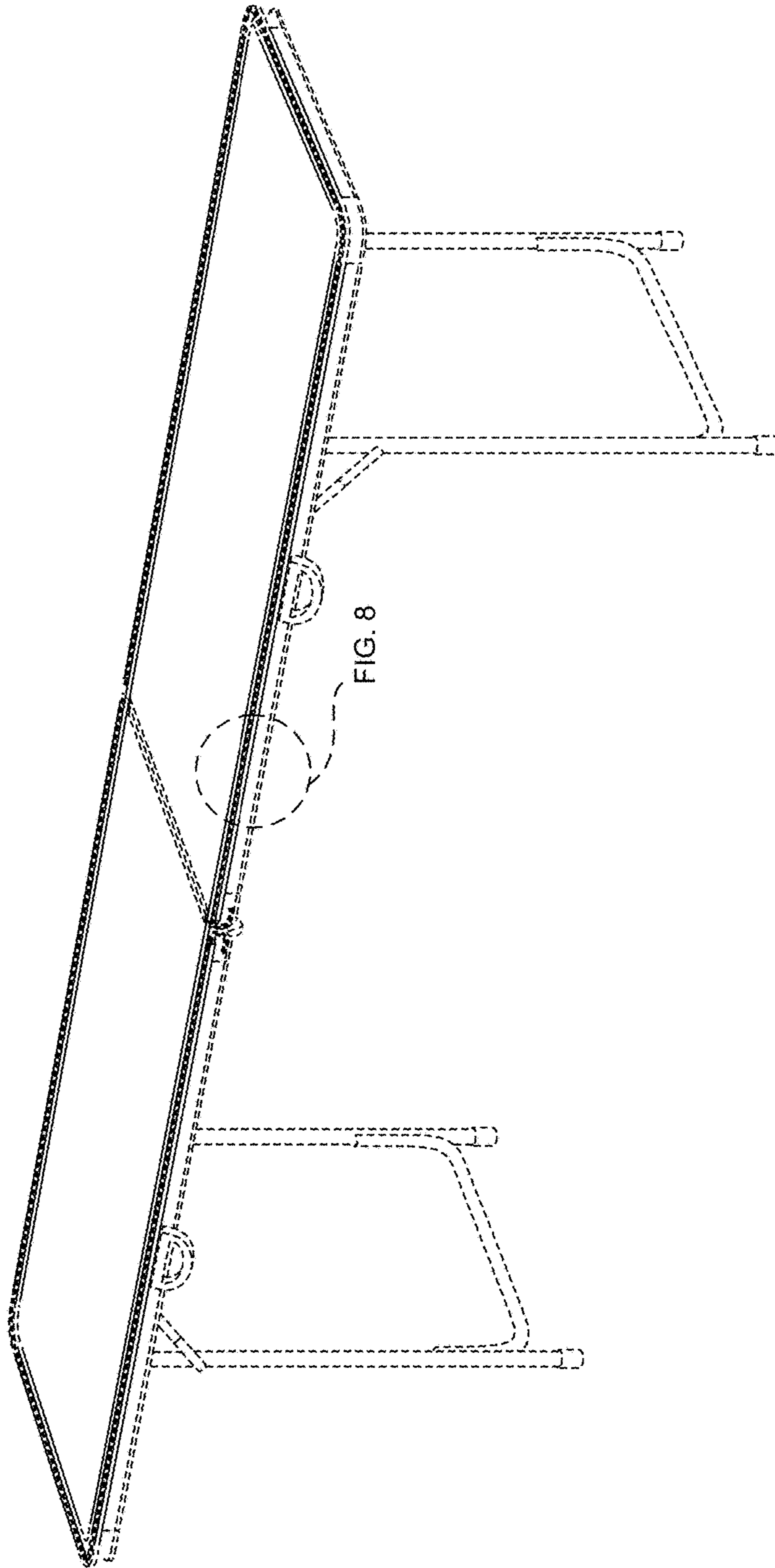

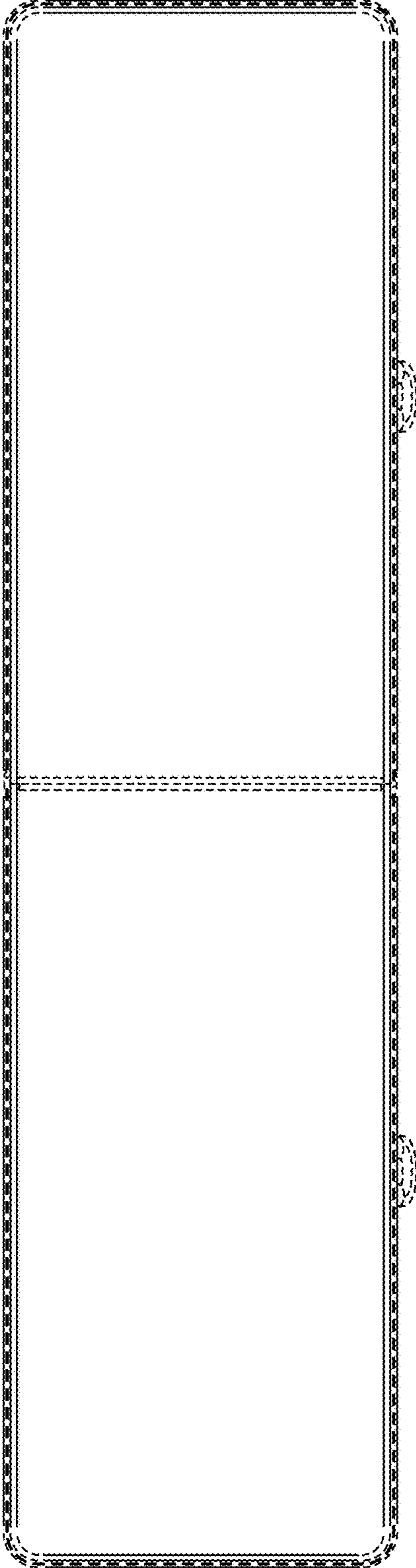

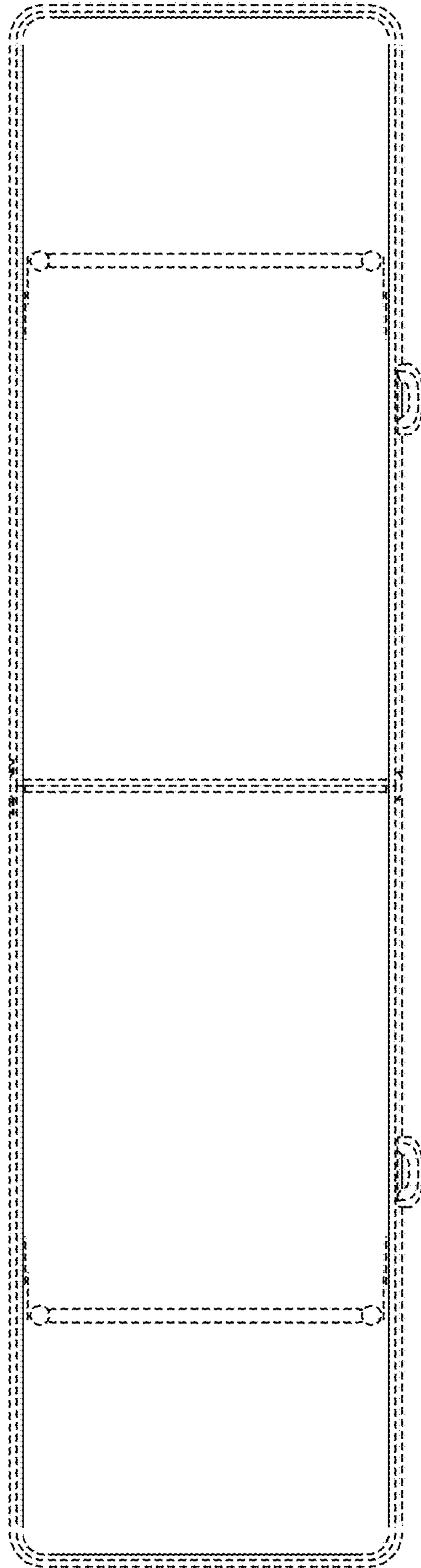

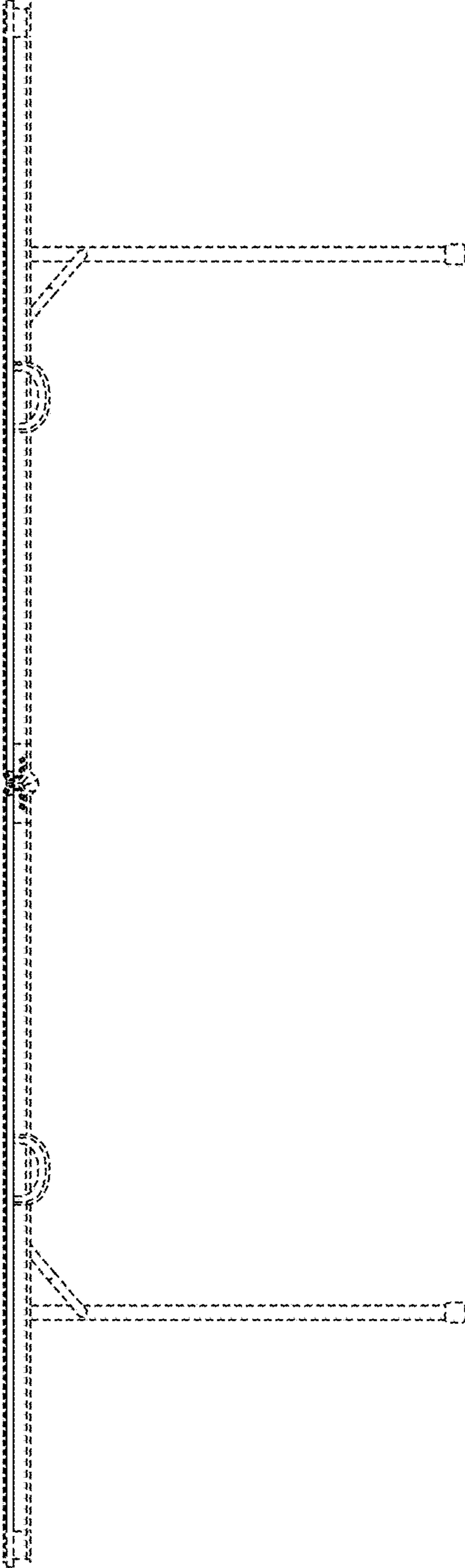

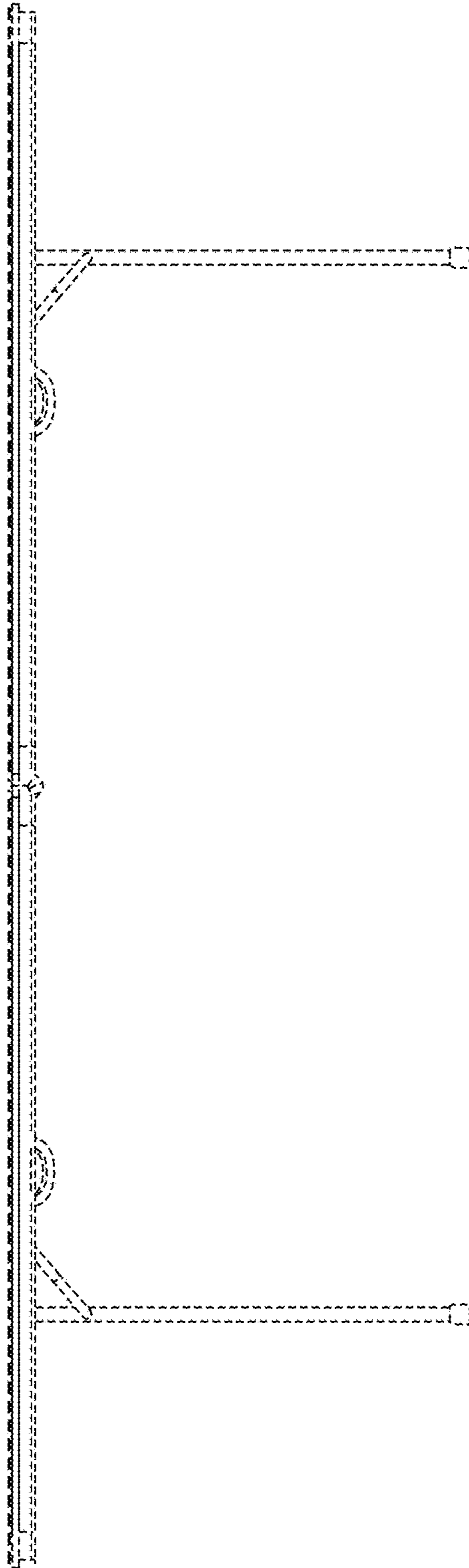

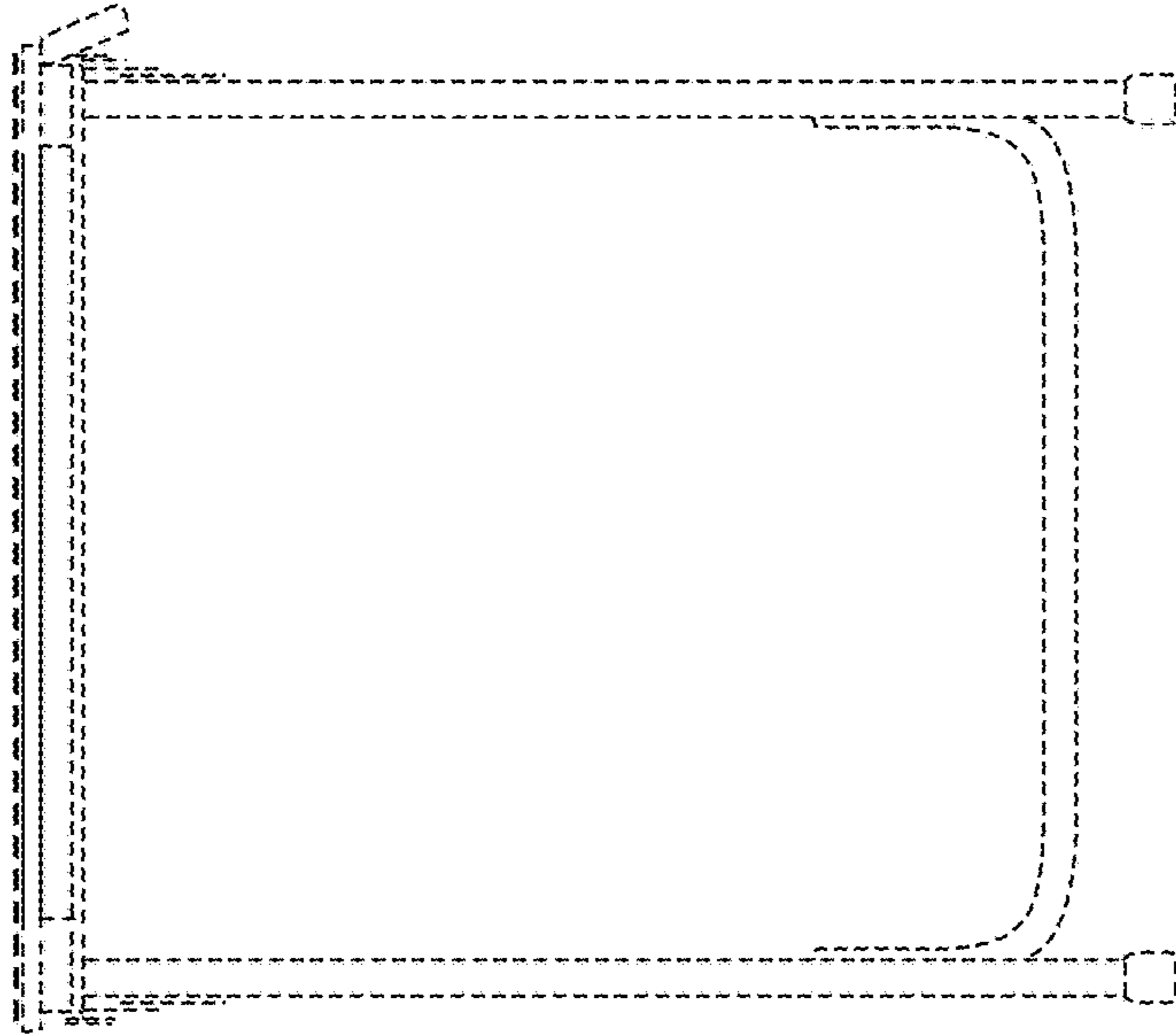

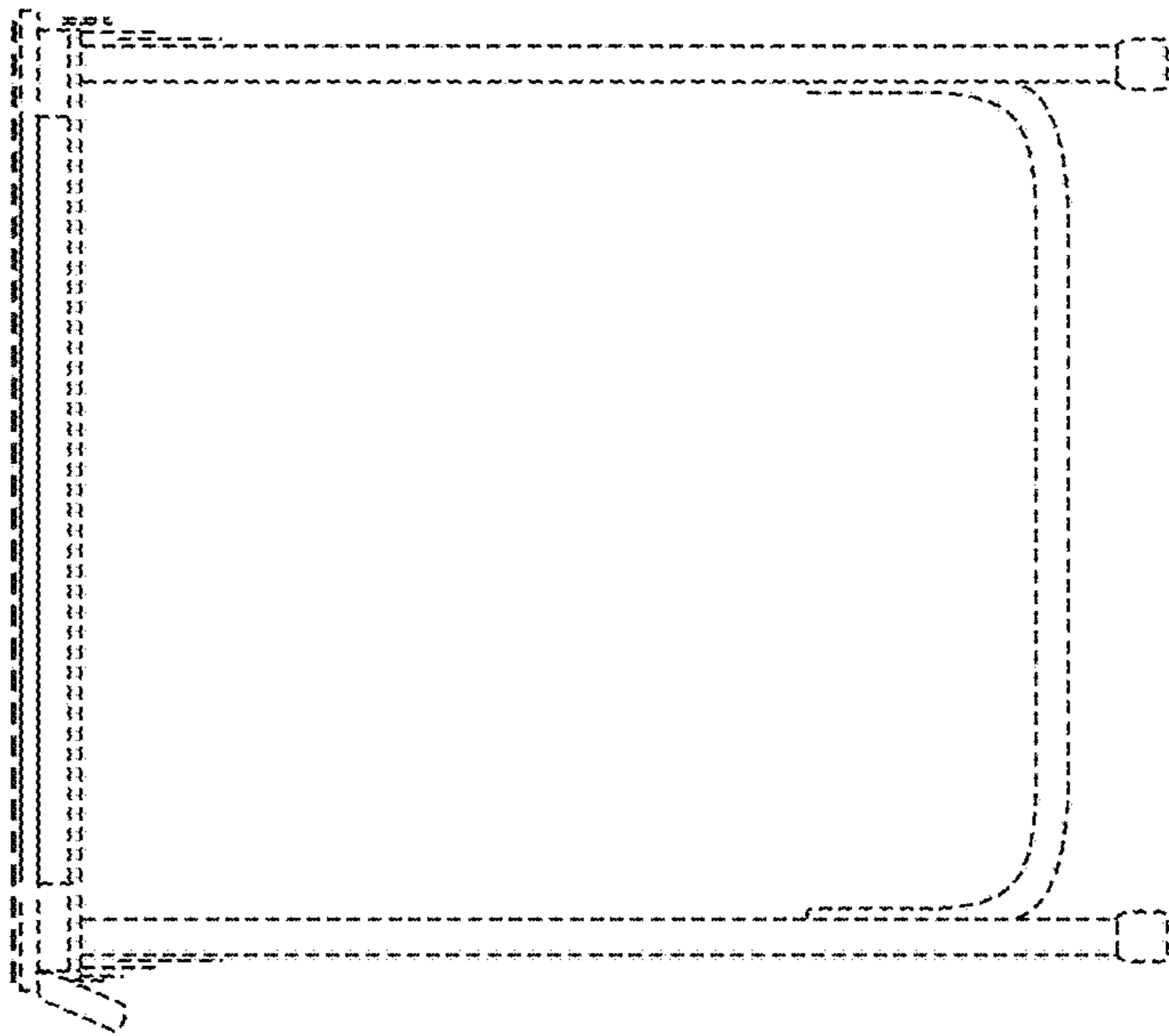

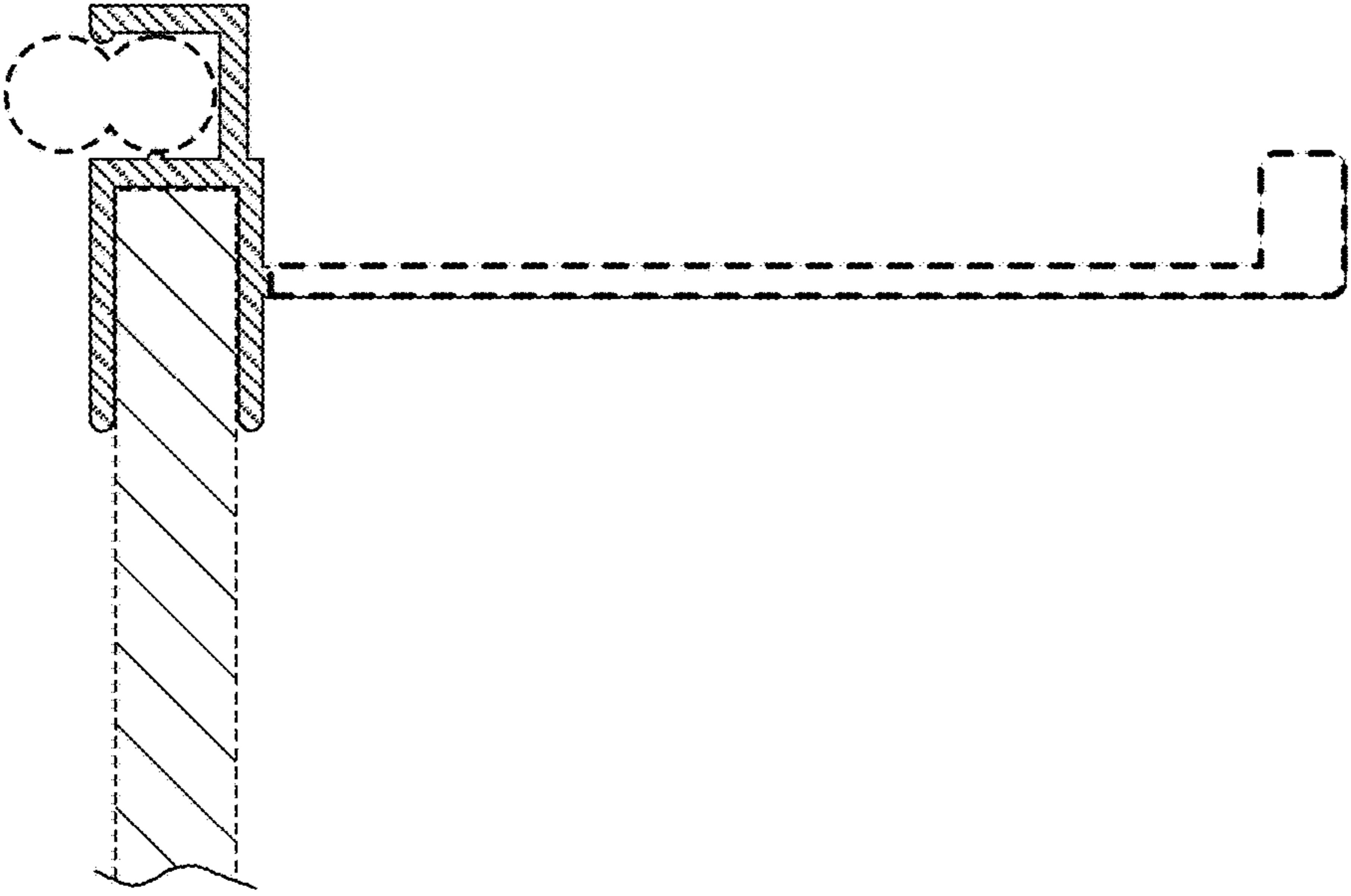

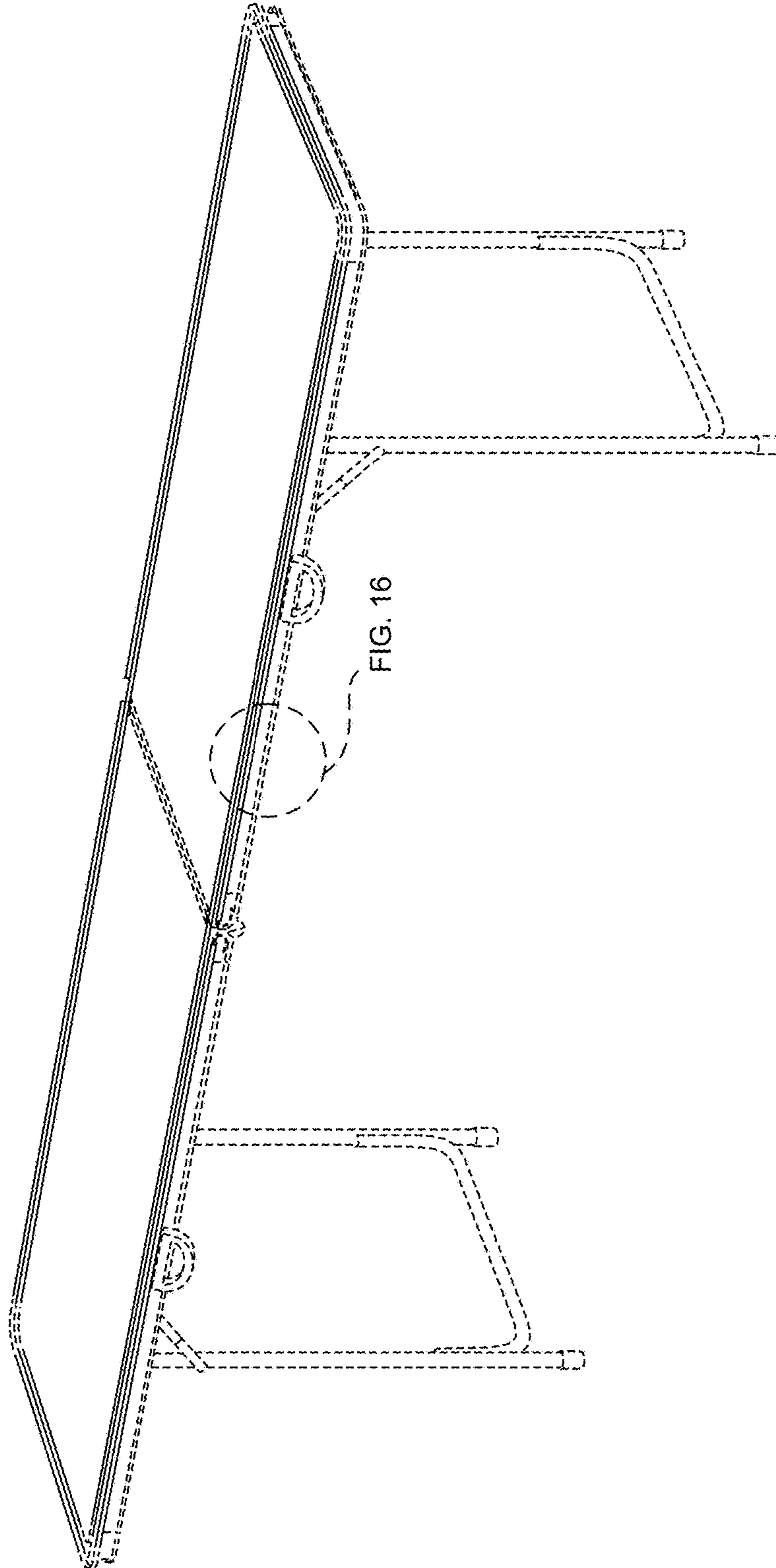

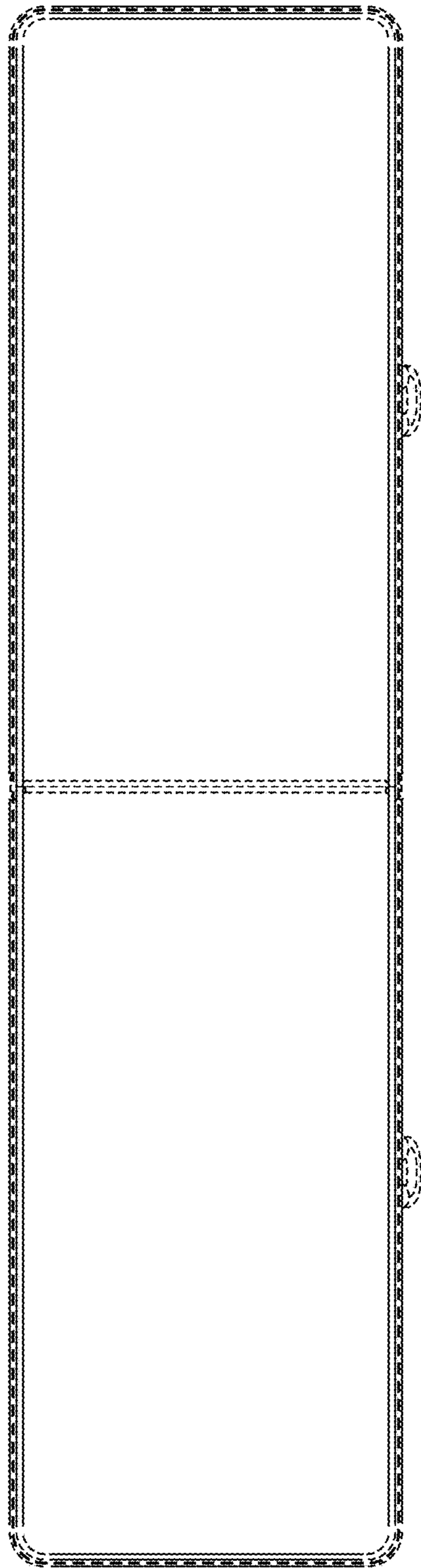

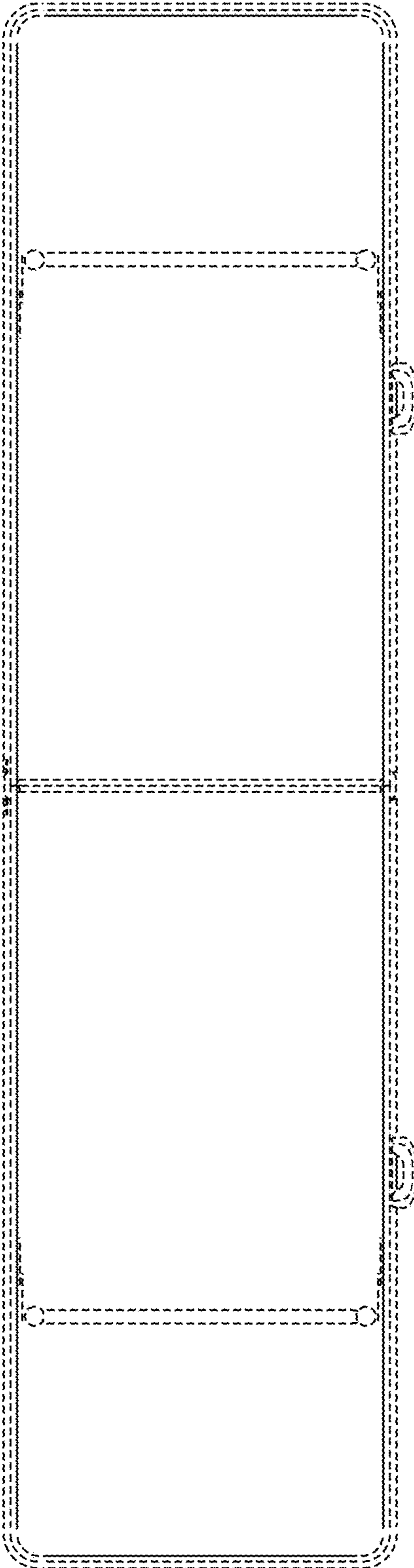

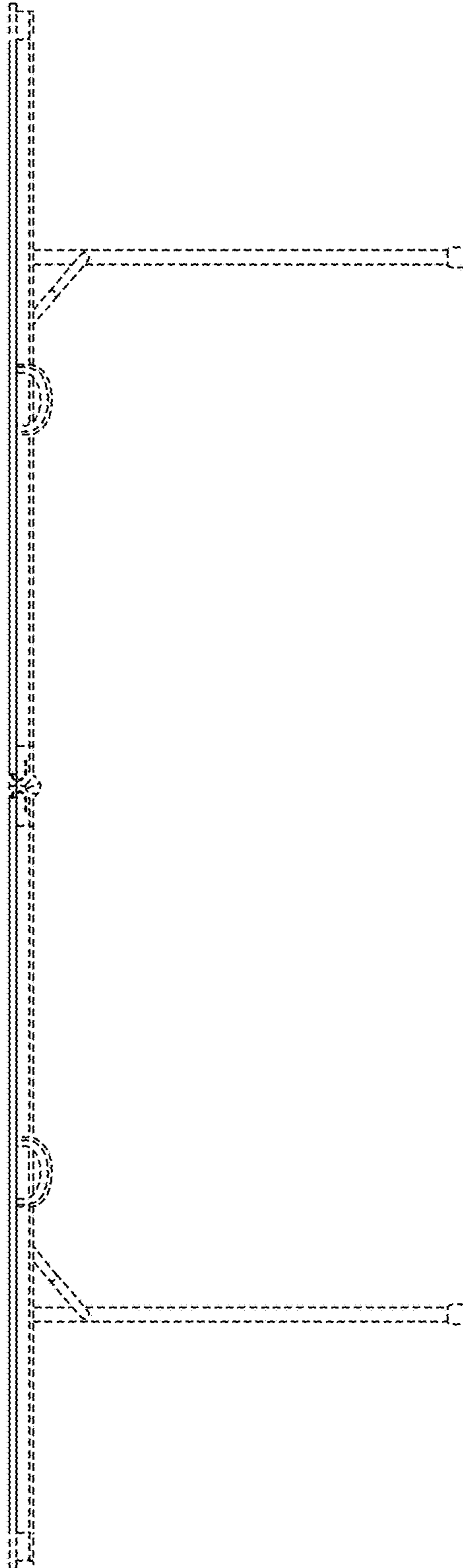

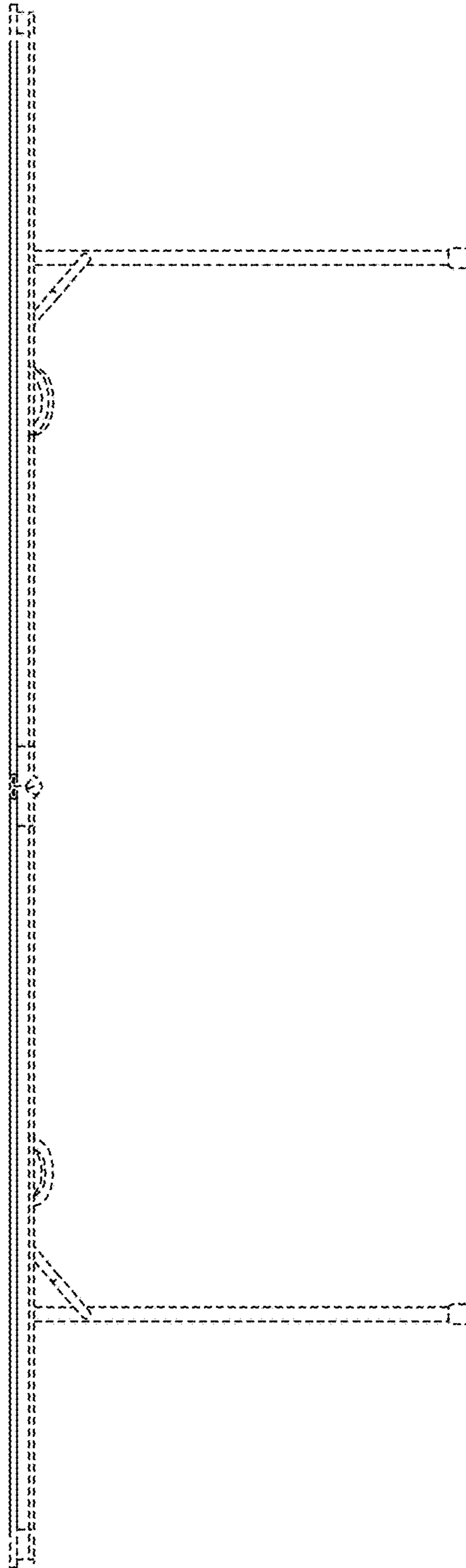

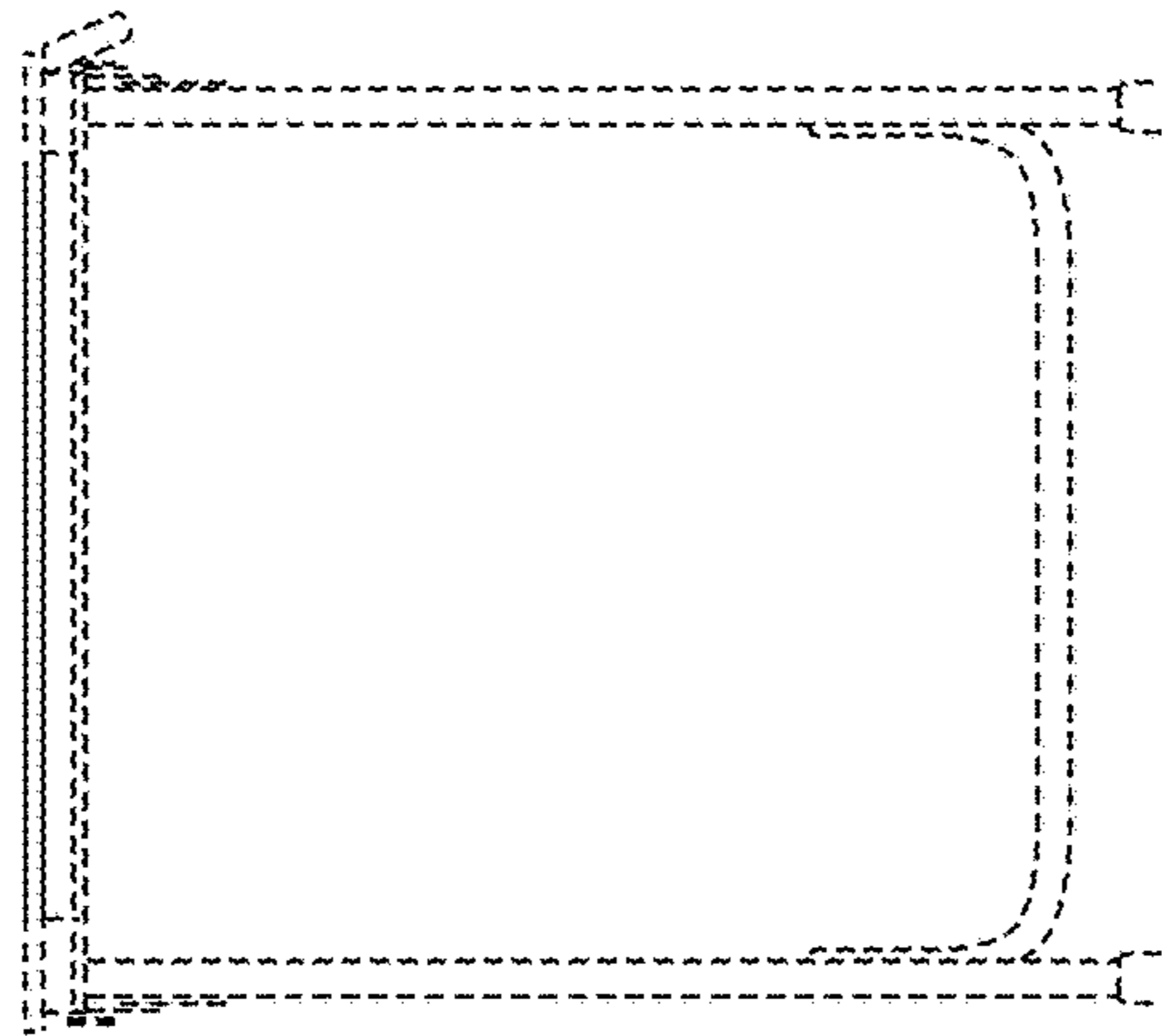

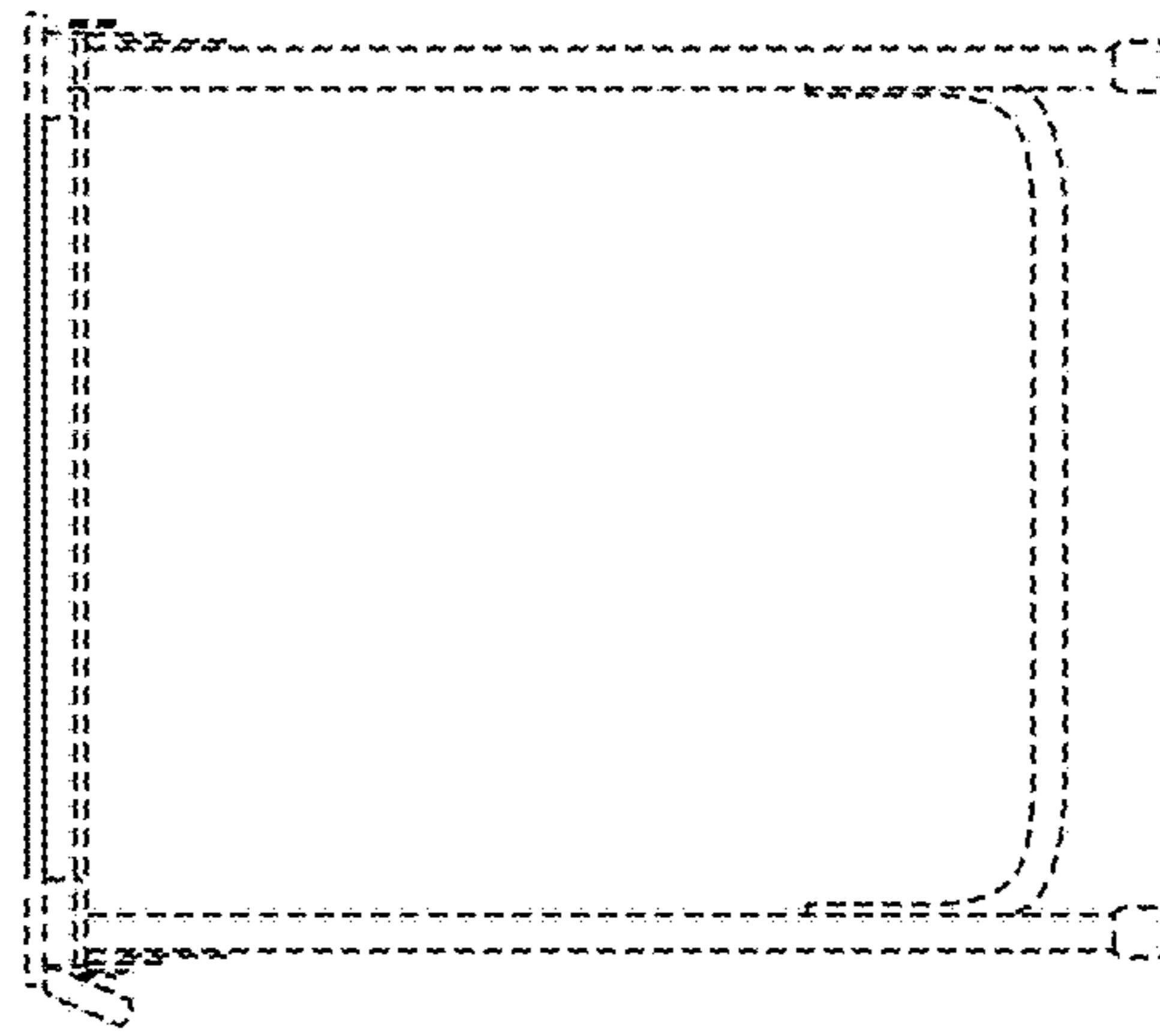

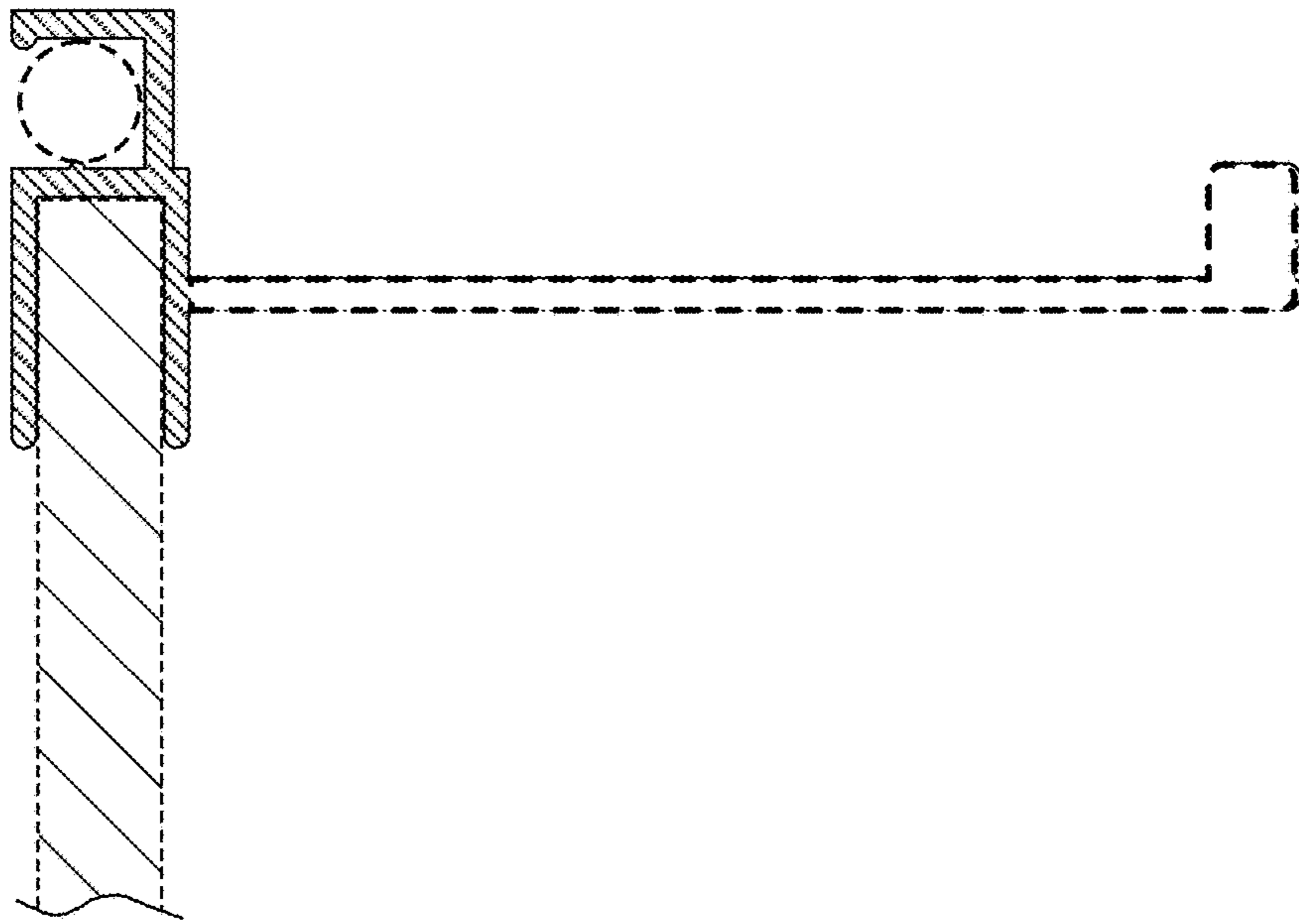
