(57) **CLAIM**

The ornamental design for a cosmetic applicator, as shown and described.

FIG. 1 is a perspective view of a first embodiment of the cosmetic applicator;

FIG. 2 is a side view of the cosmetic applicator shown in FIG. 1;

FIG. 3 is an opposite side view of the cosmetic applicator shown in FIG. 1;

FIG. 4 is a top end view of the cosmetic applicator shown in FIG. 1;

FIG. 5 is a bottom end view of the cosmetic applicator shown in FIG. 1;

FIG. 6 is a plan side view of the cosmetic applicator shown in FIG. 1;

FIG. 7 is a bottom side view of the cosmetic applicator shown in FIG. 1;

FIG. 8 is a perspective, exploded view of the first embodiment of the cosmetic applicator;

FIG. 9 is a perspective view of a second embodiment of the cosmetic applicator;

FIG. 10 is a side view of the cosmetic applicator shown in FIG. 9;

FIG. 11 is an opposite side view of the cosmetic applicator shown in FIG. 9;

FIG. 12 is a top end view of the cosmetic applicator shown in FIG. 9;

FIG. 13 is a bottom end view of the cosmetic applicator shown in FIG. 9;

FIG. 14 is a plan side view of the cosmetic applicator shown in FIG. 9;

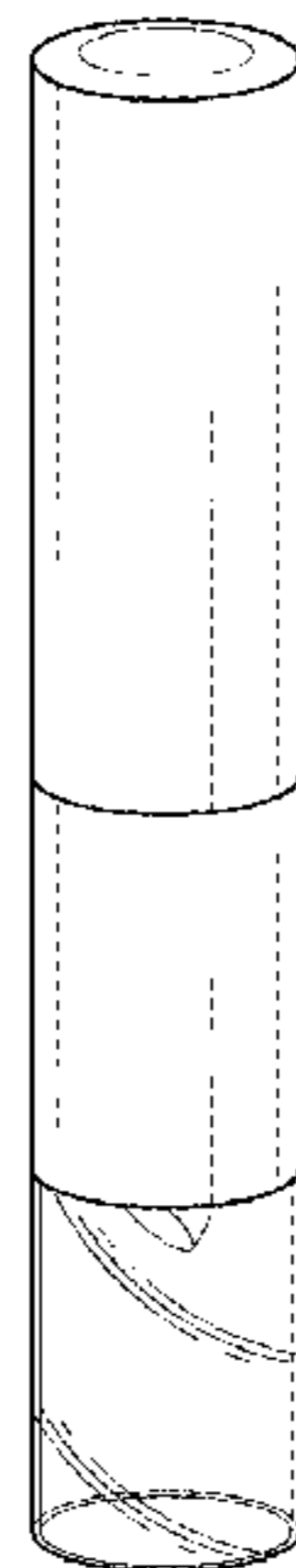
FIG. 15 is a bottom side view of the cosmetic applicator shown in FIG. 9; and,

The present article is a cosmetic applicator used for applying cosmetics such as eye shadow. In the first embodiment, the lower end of the container body is opaque while in the second embodiment the lower end of the container body is transparent.

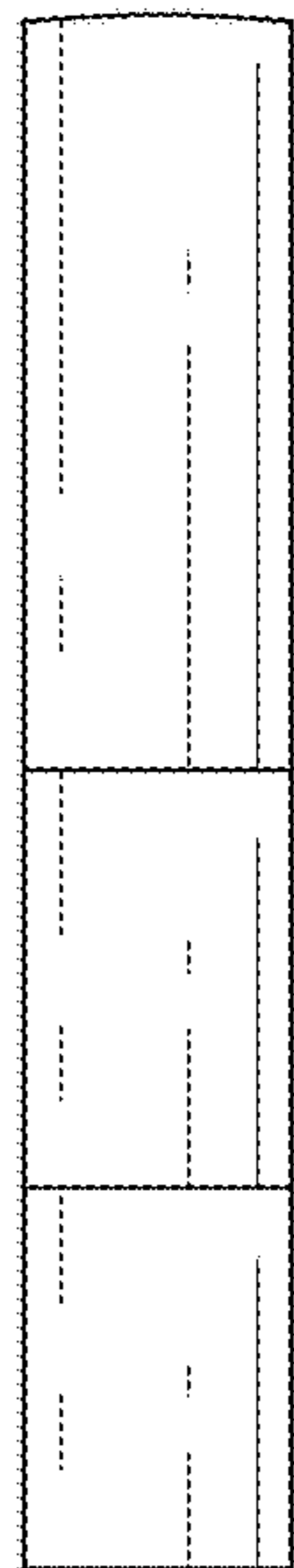

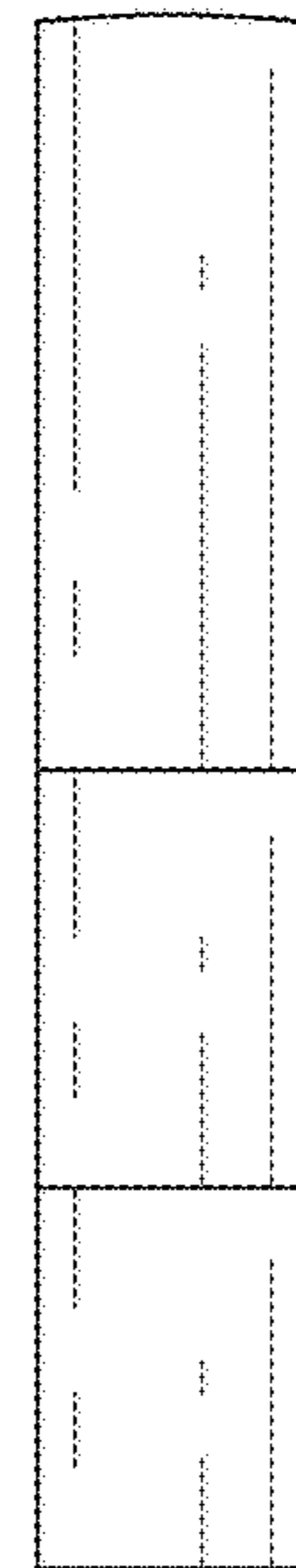

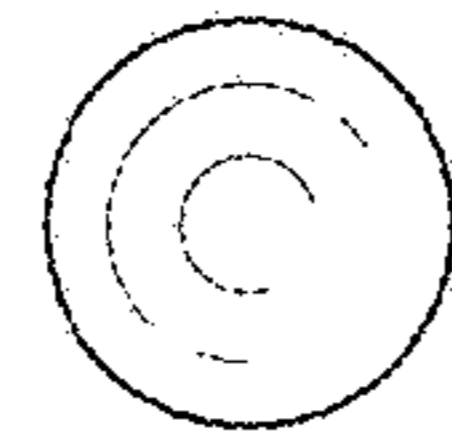

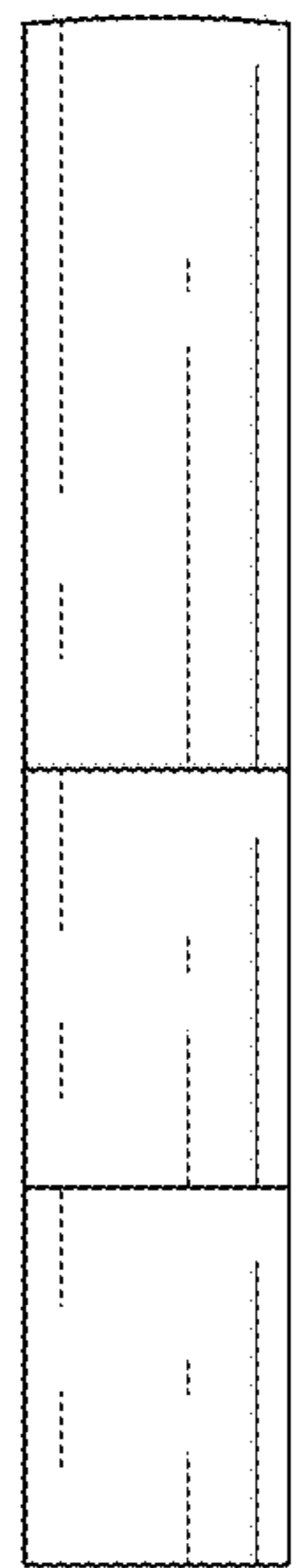

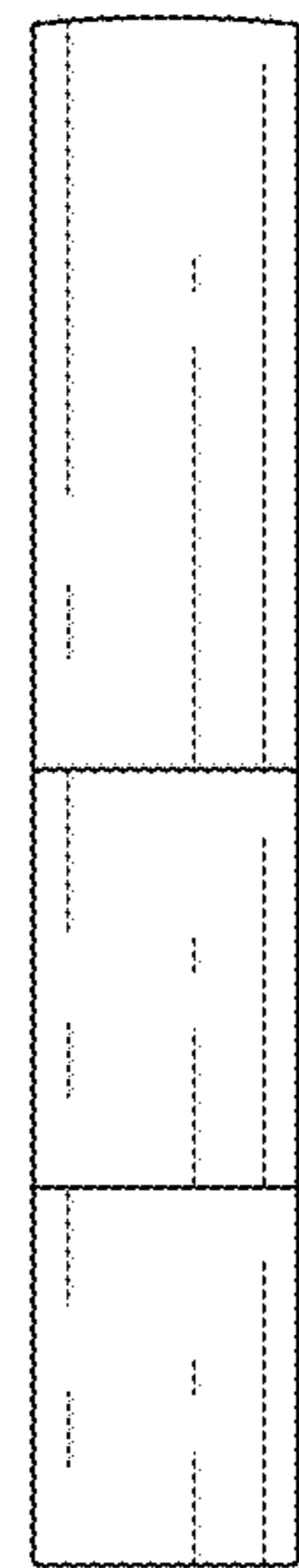

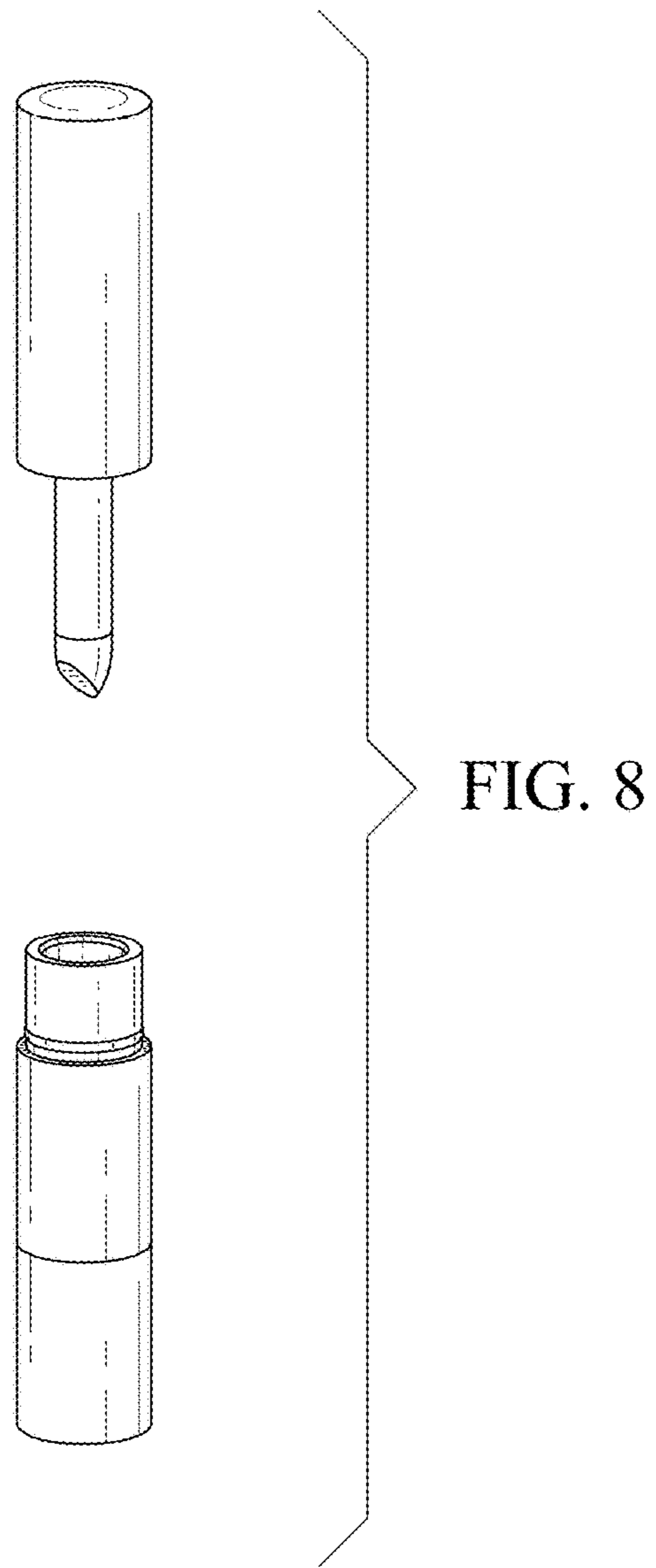

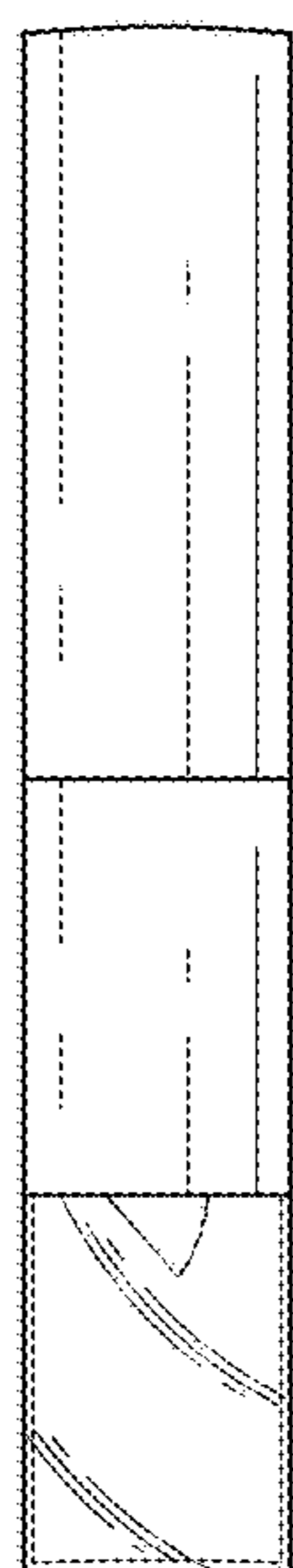
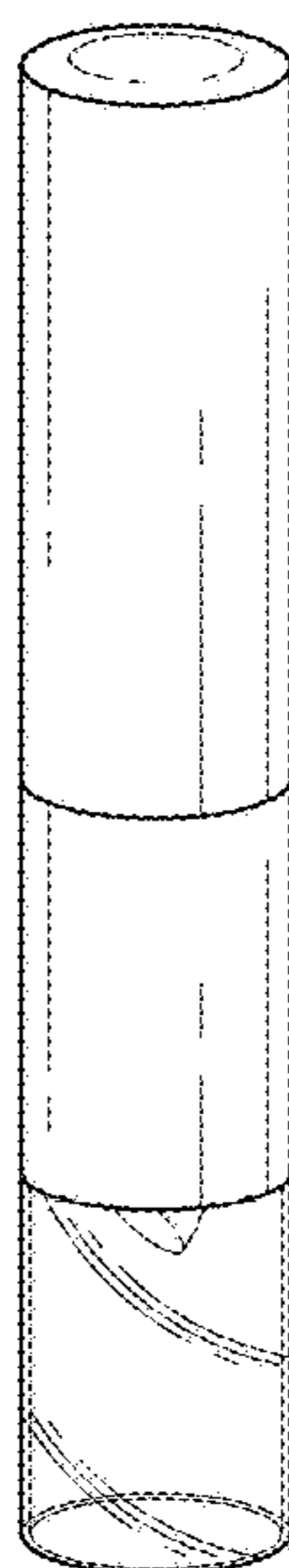

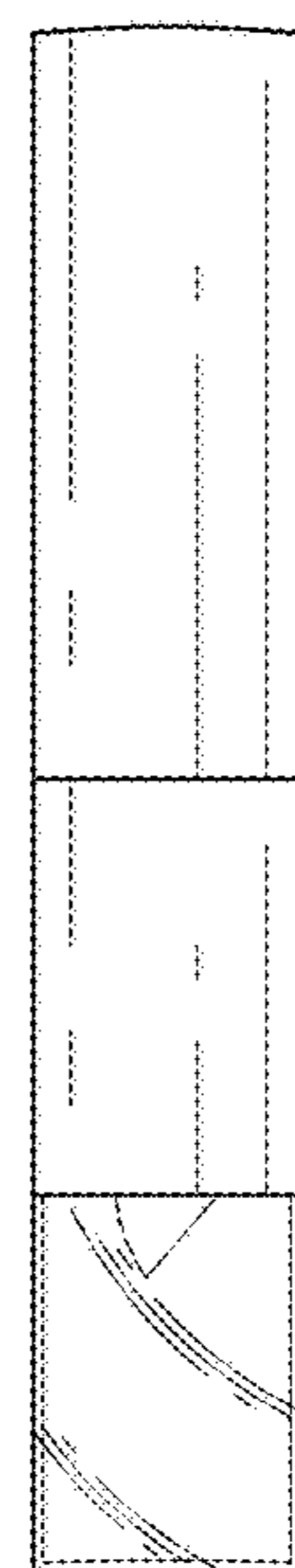

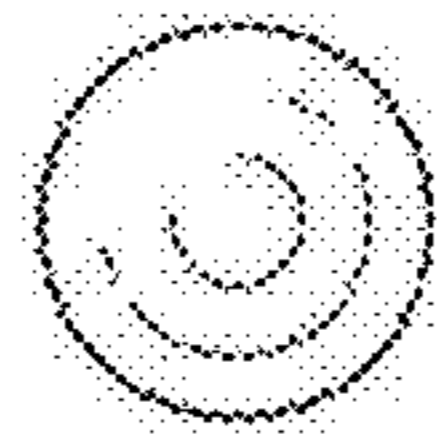

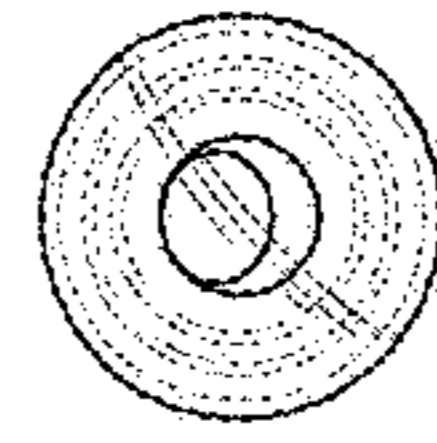

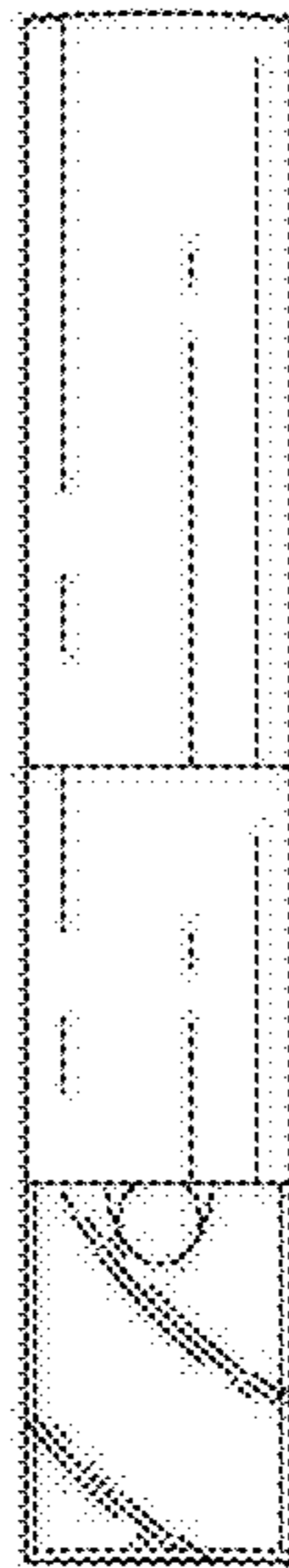

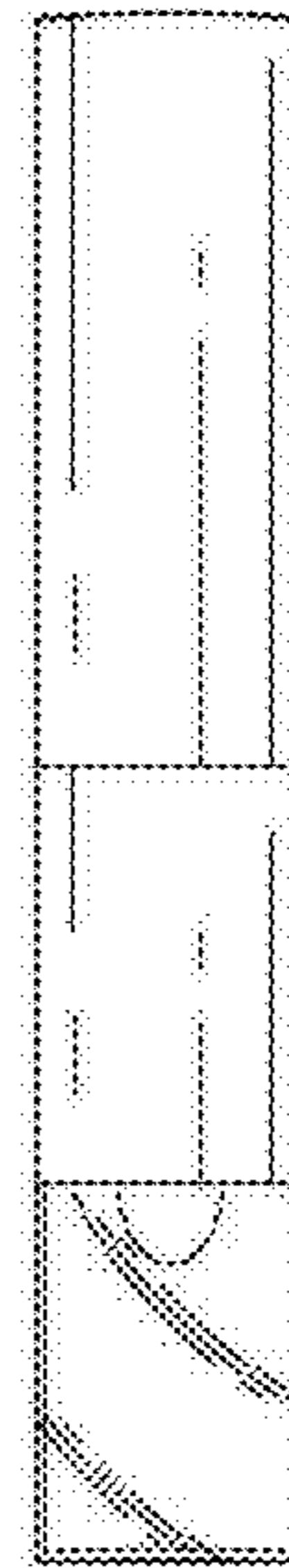

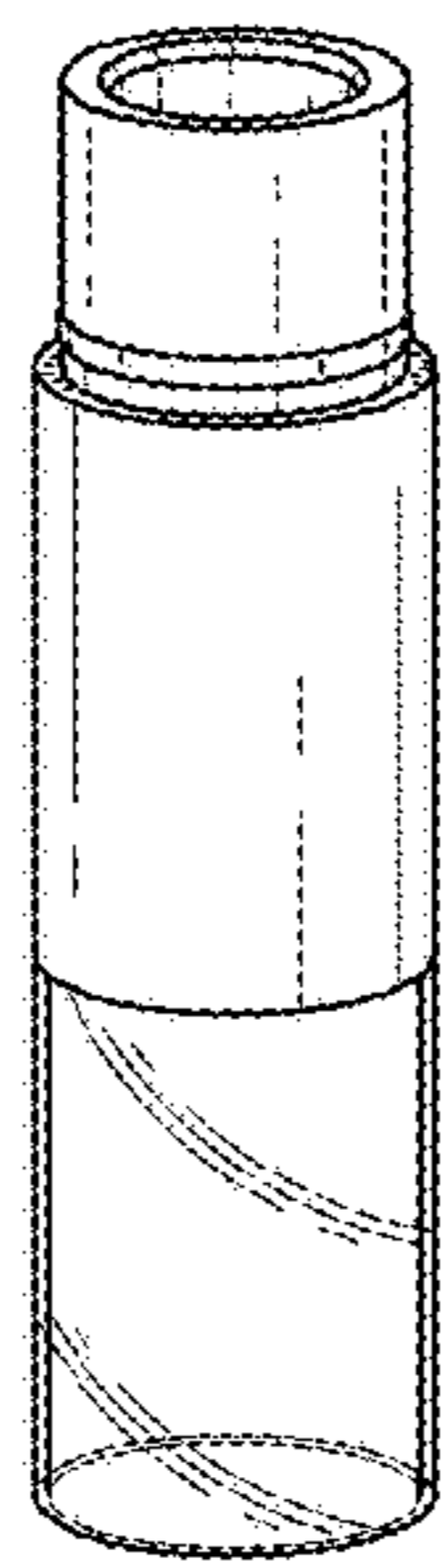
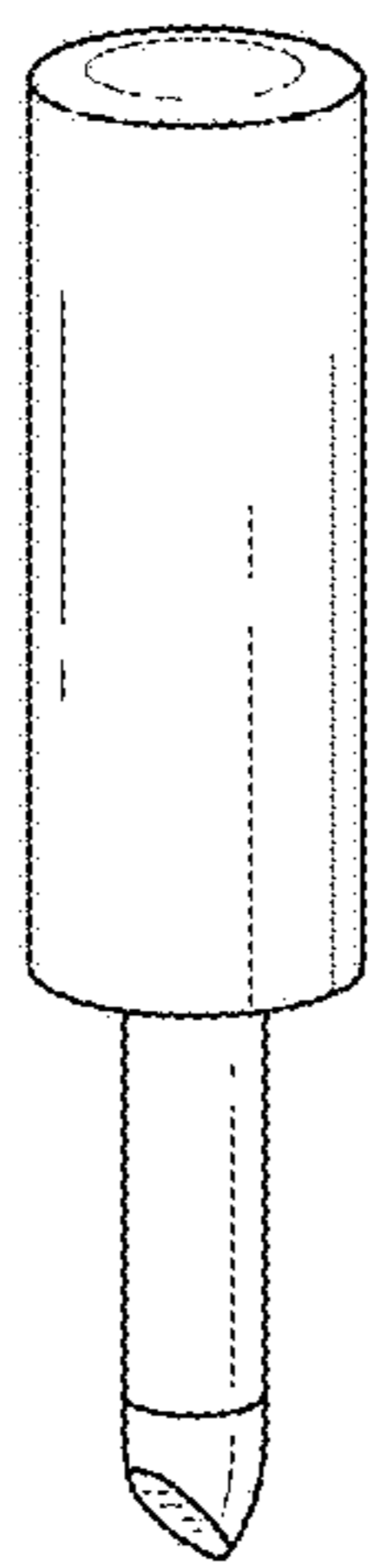
