DESCRIPTION

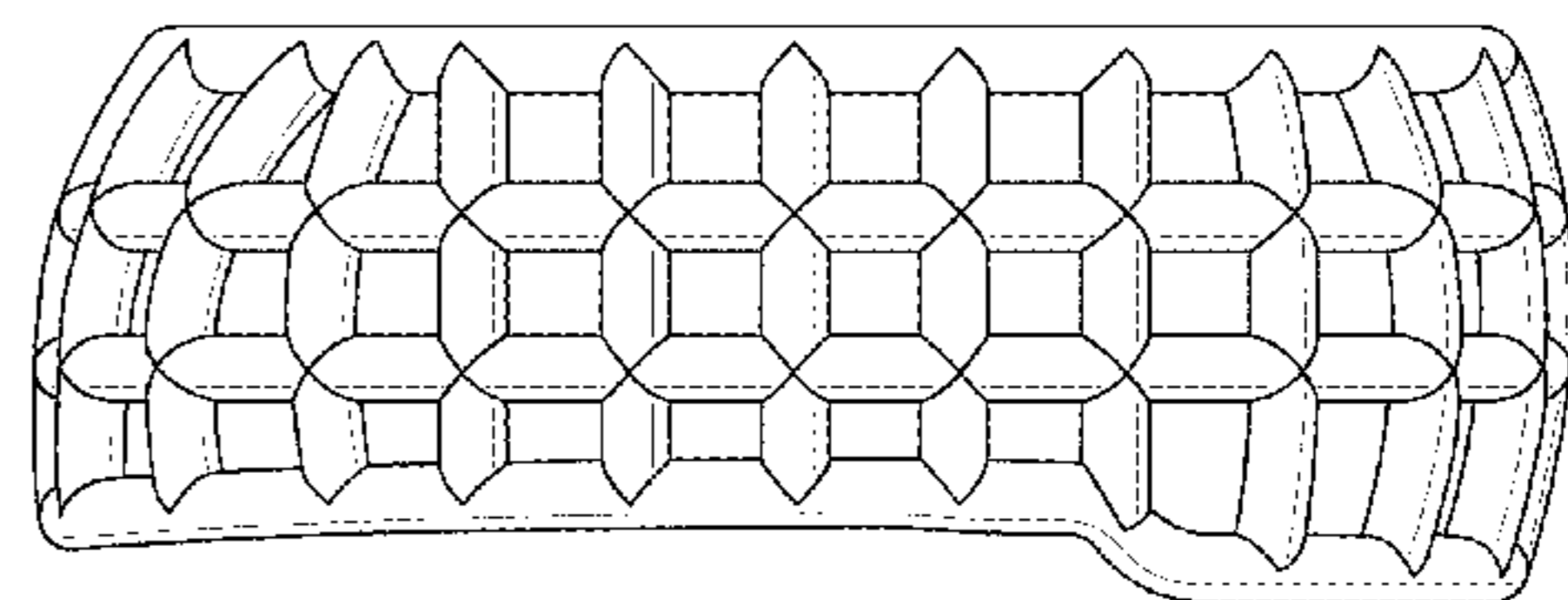
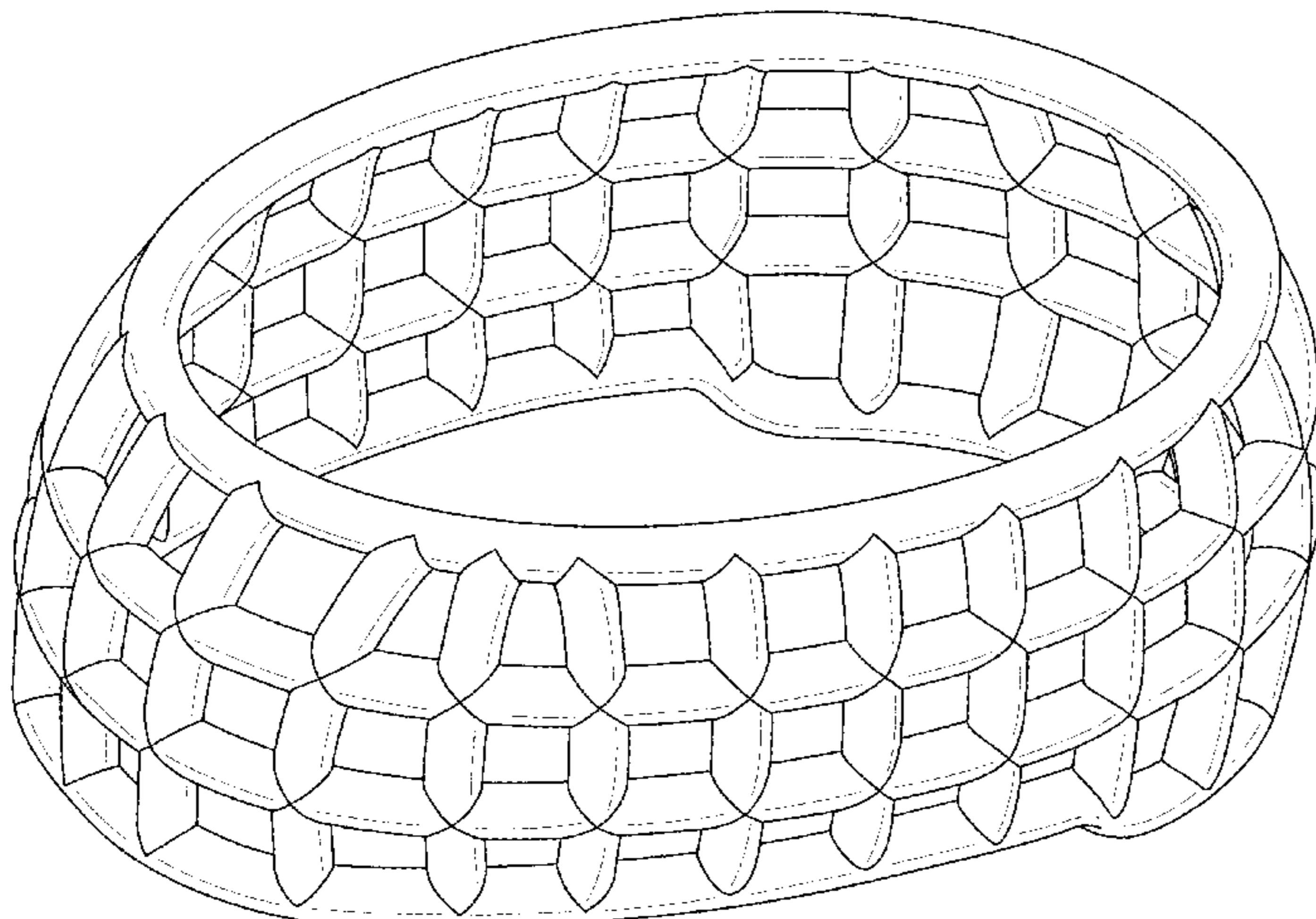
FIG. 1 is a perspective view of a head protector showing my new design;

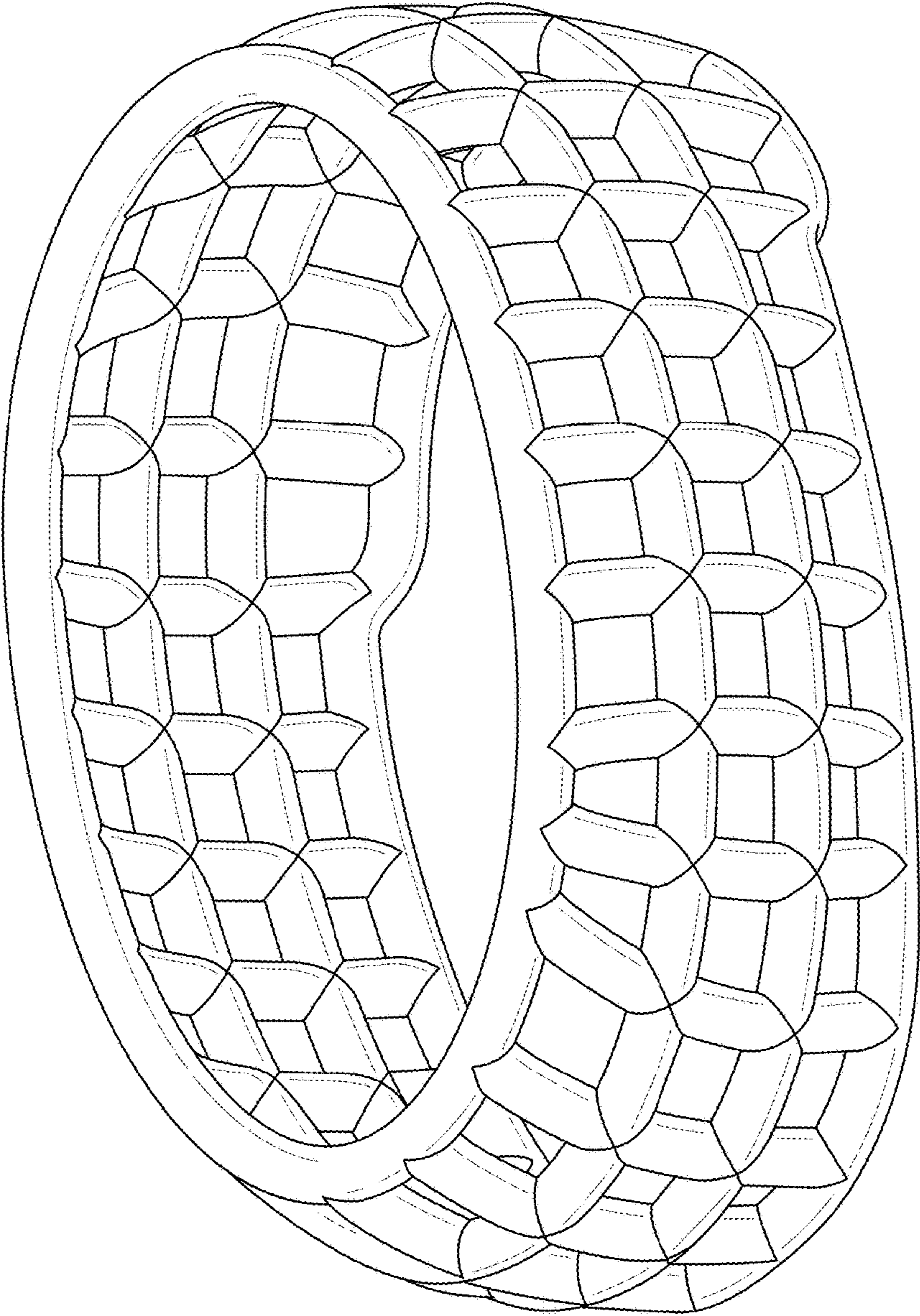

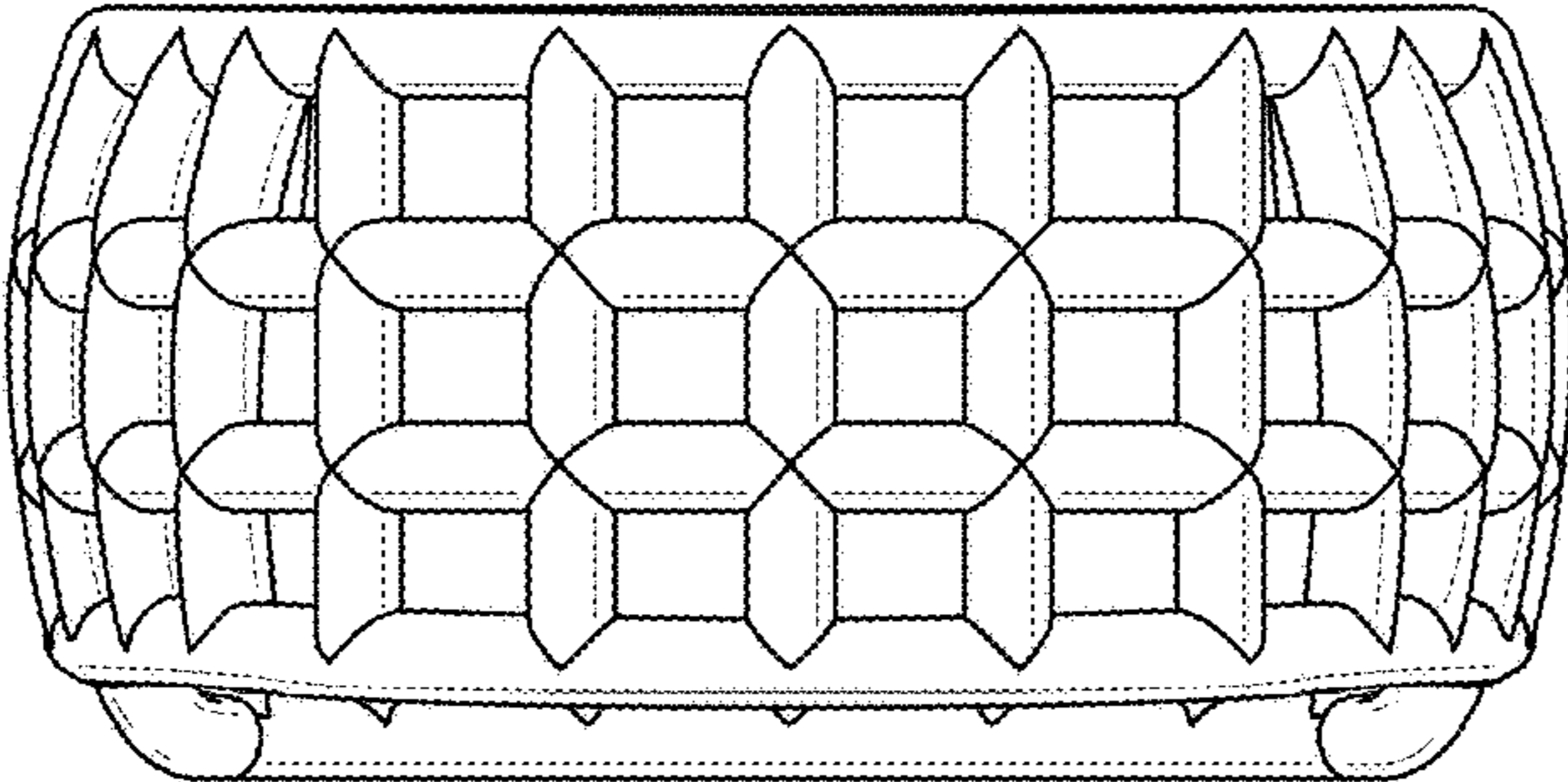

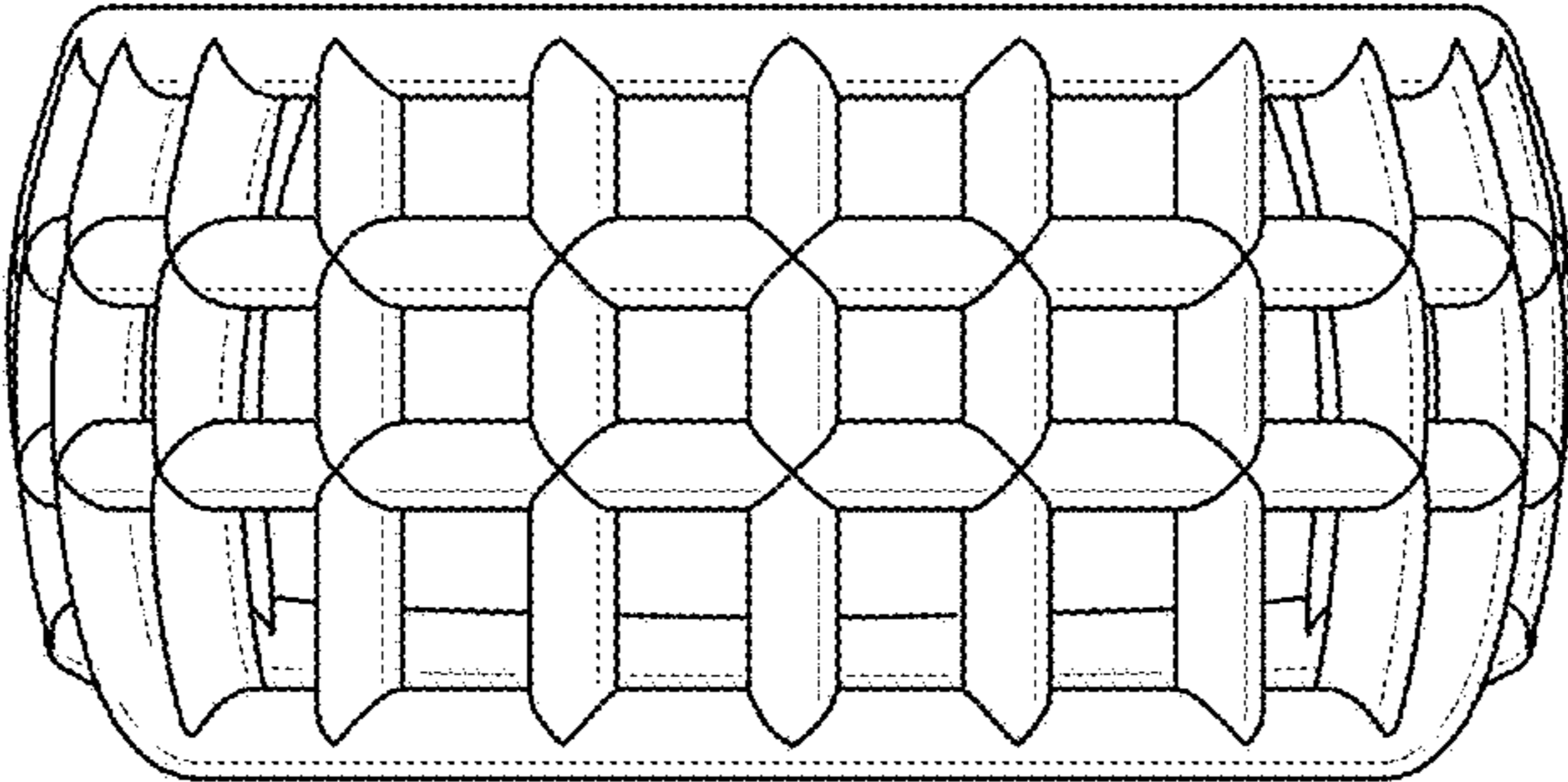

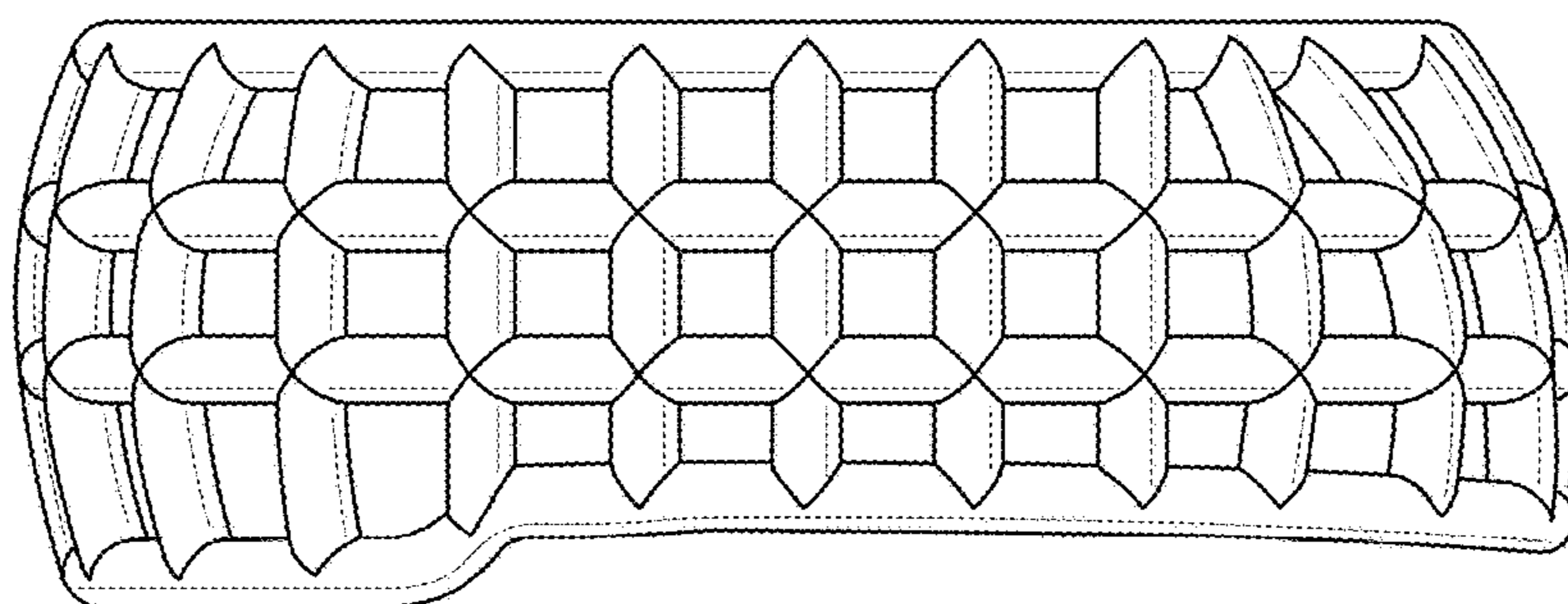

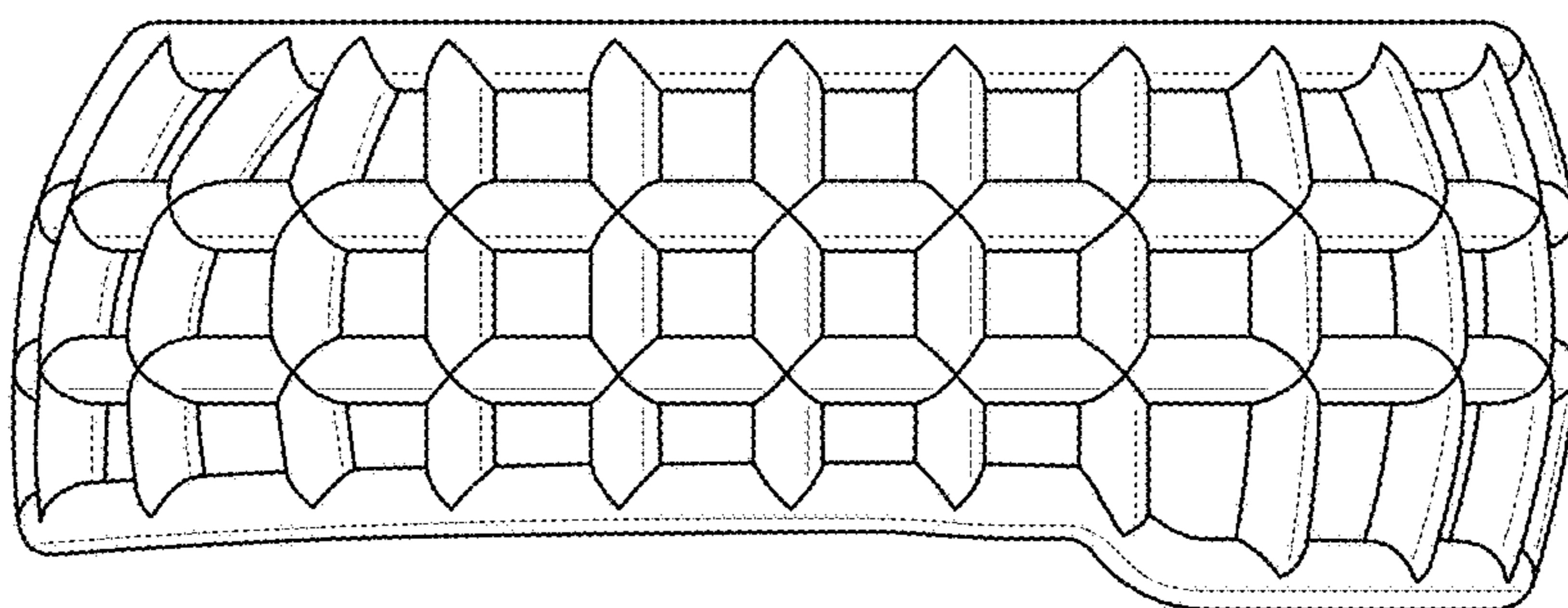

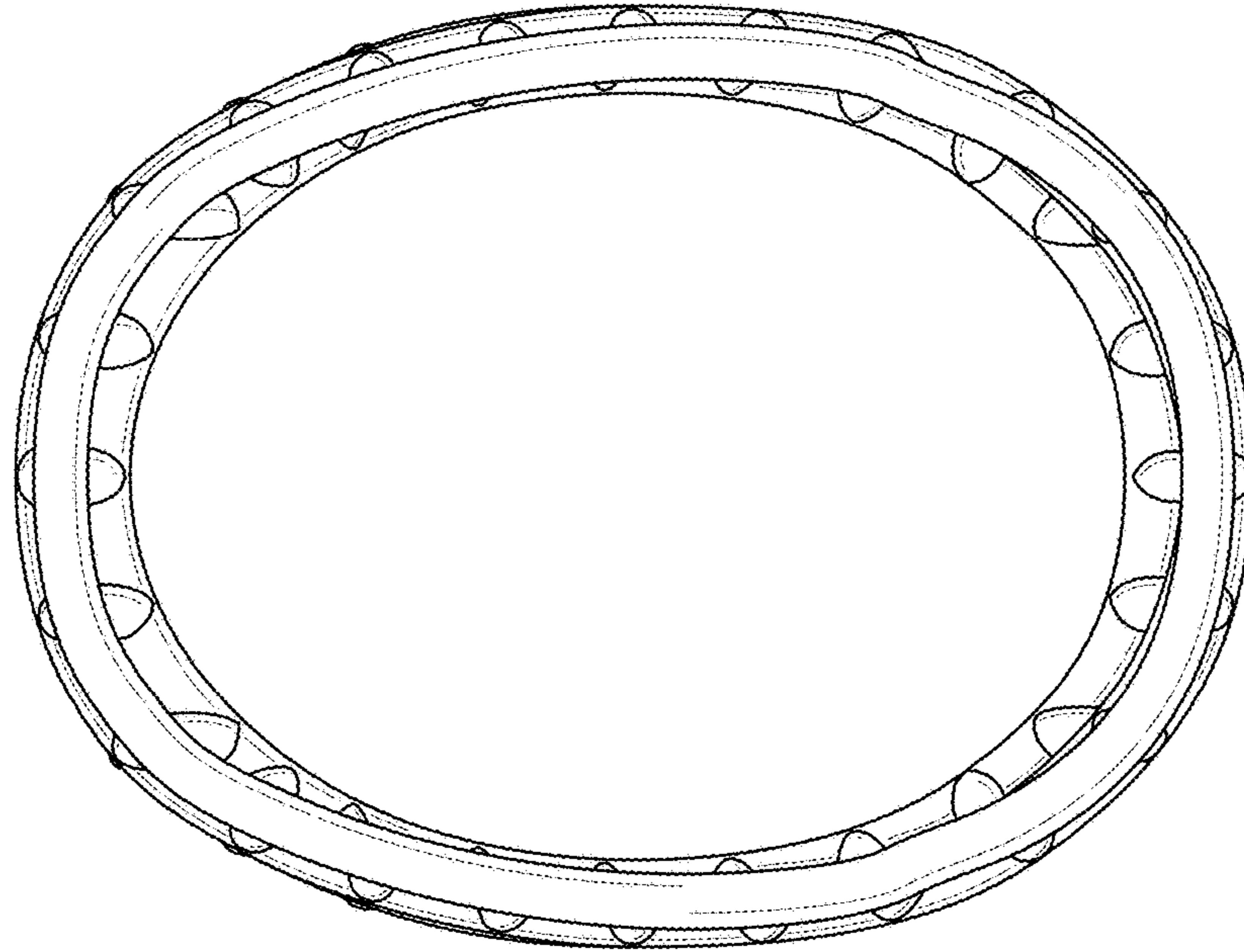

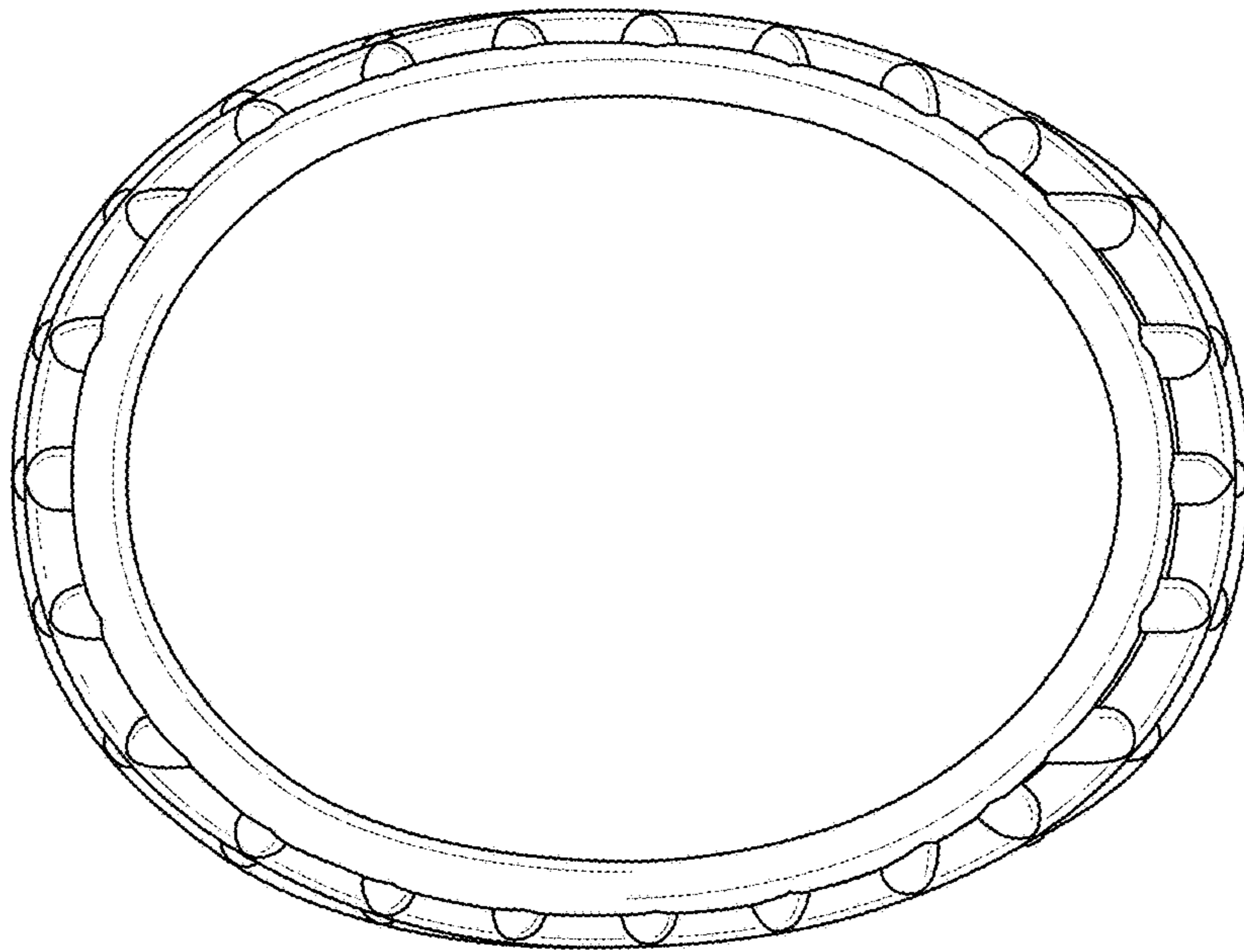
