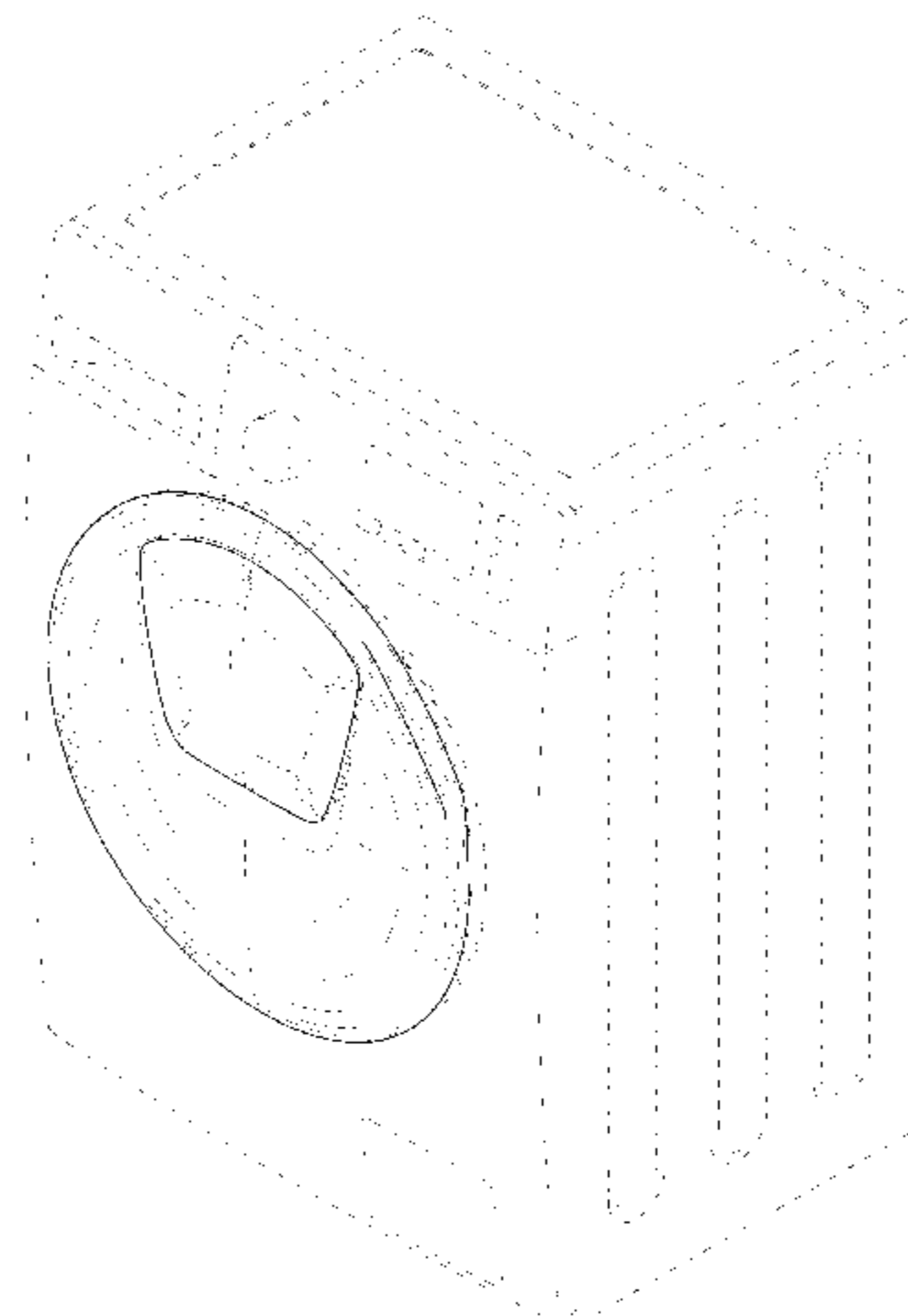
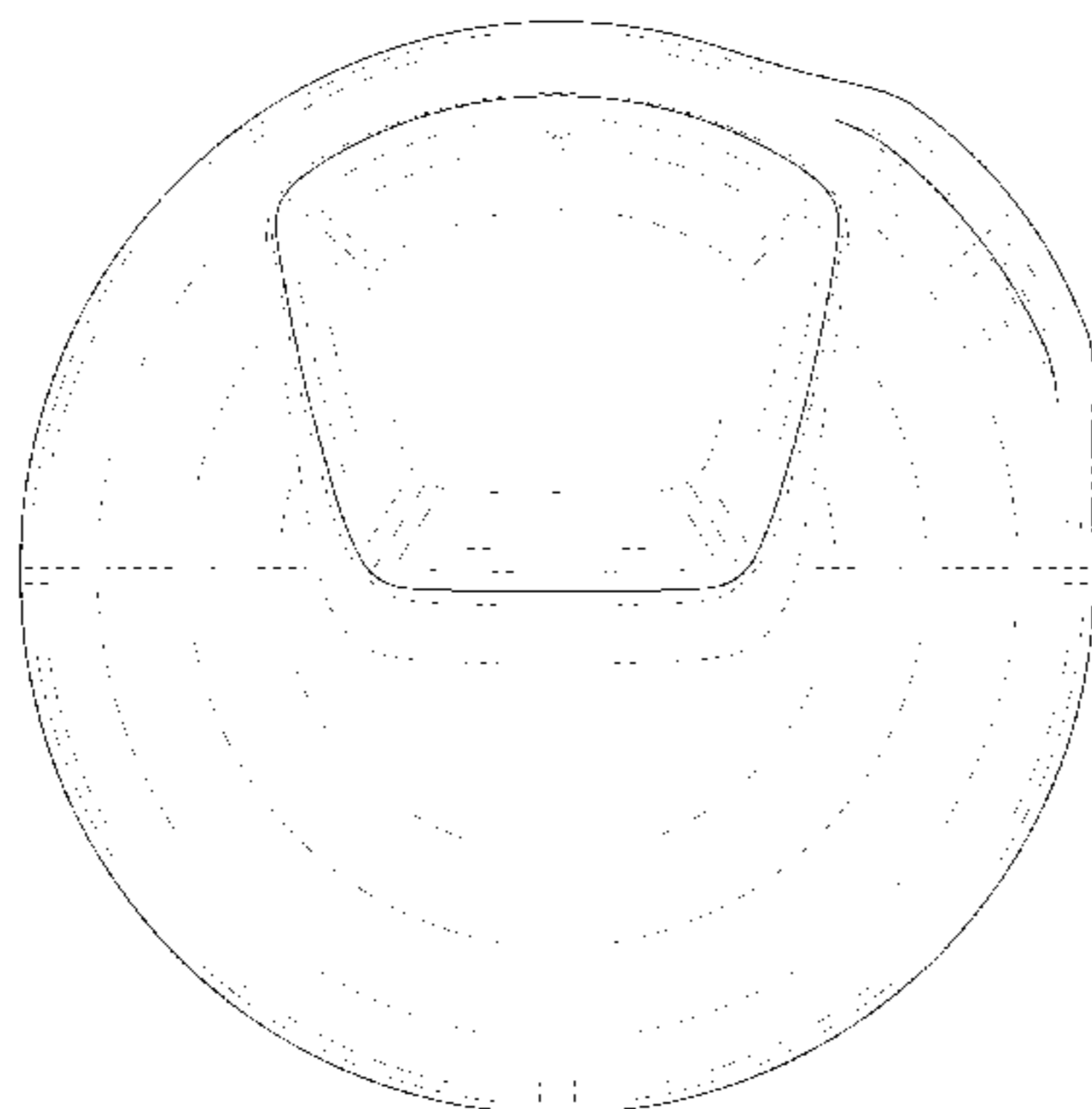
The ornamental design for a door for drum washing machine, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a door for drum washing machine, showing my new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a side view thereof; FIG. 5 is another side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is another perspective view thereof in an environment of use.

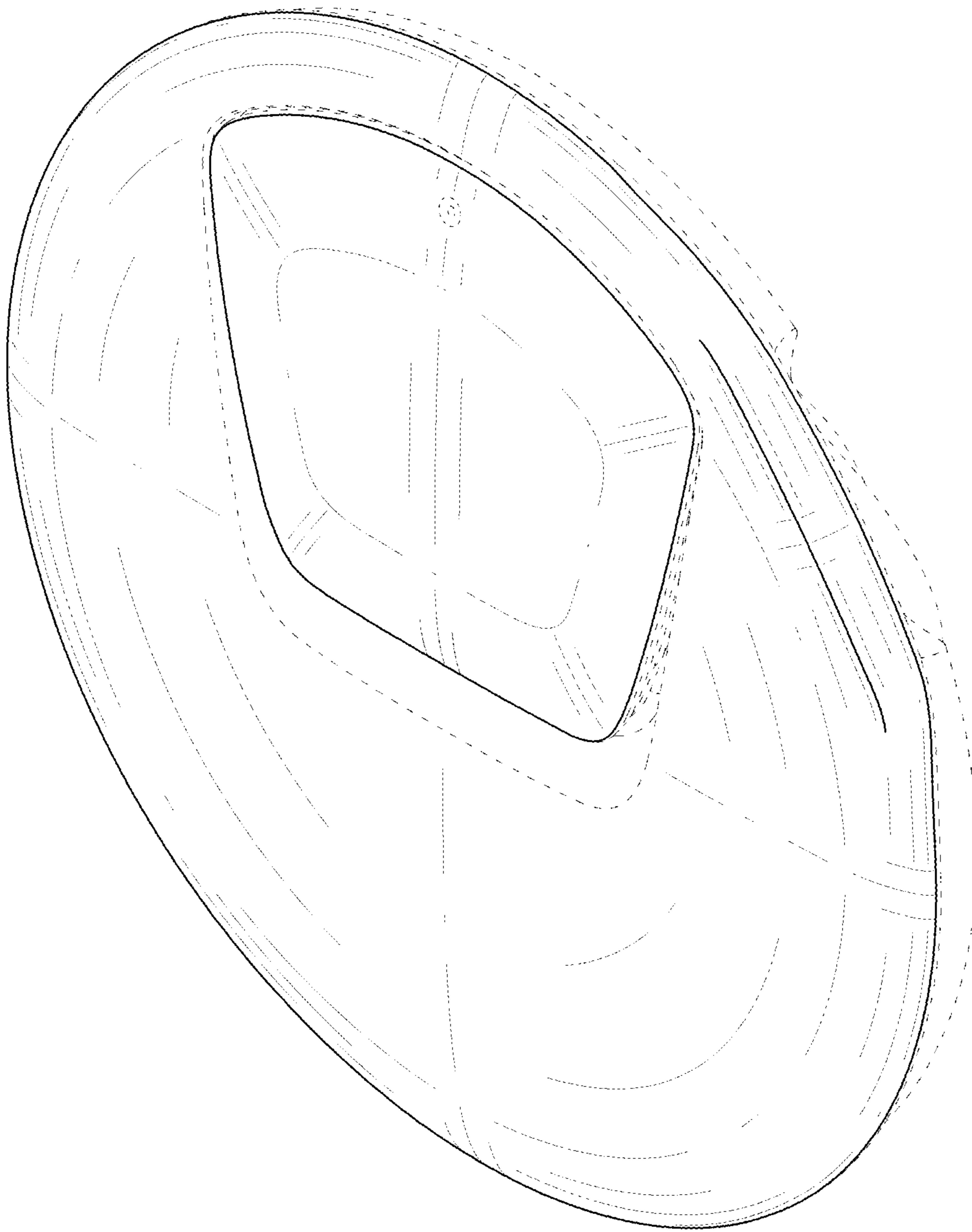

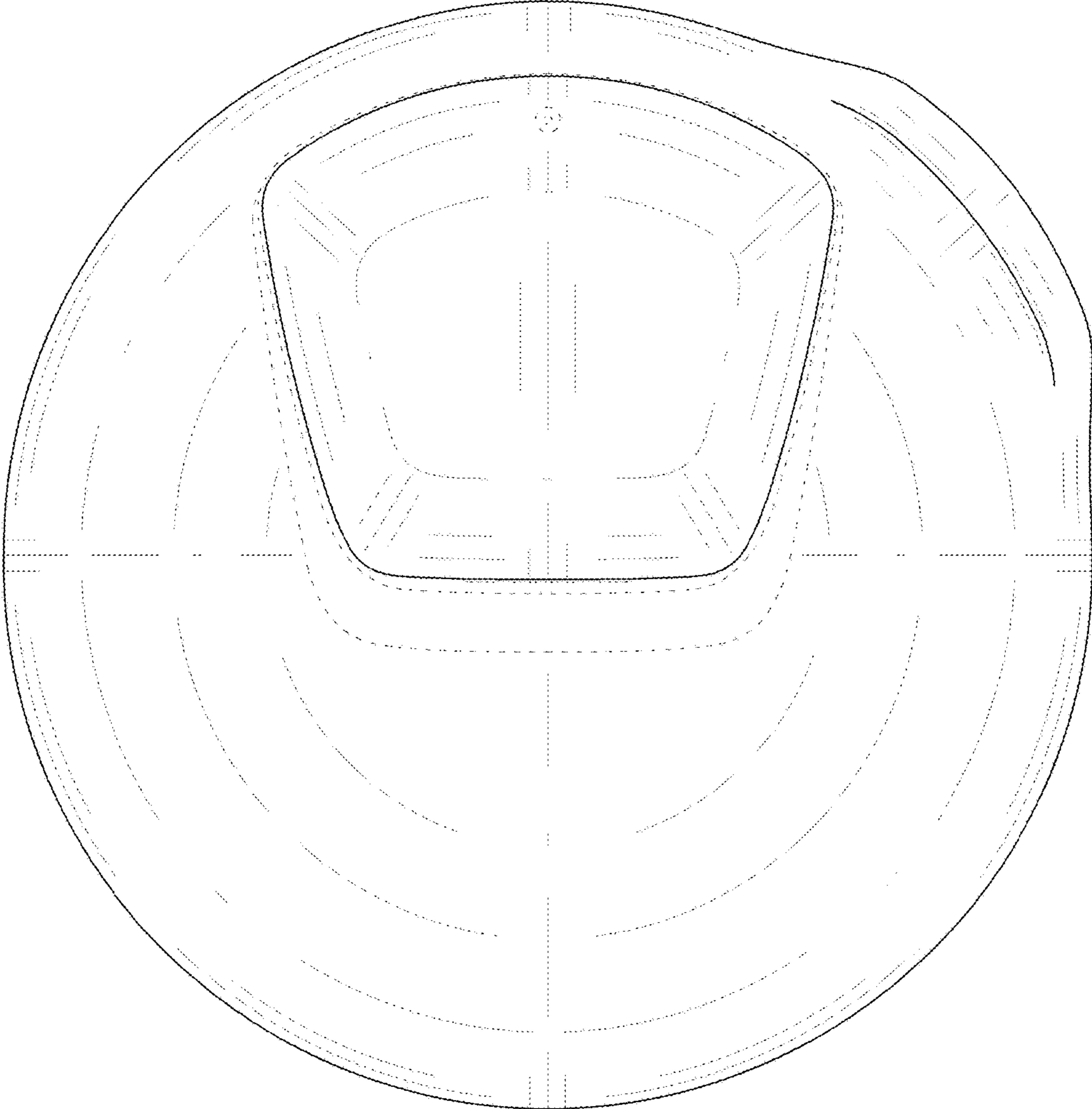

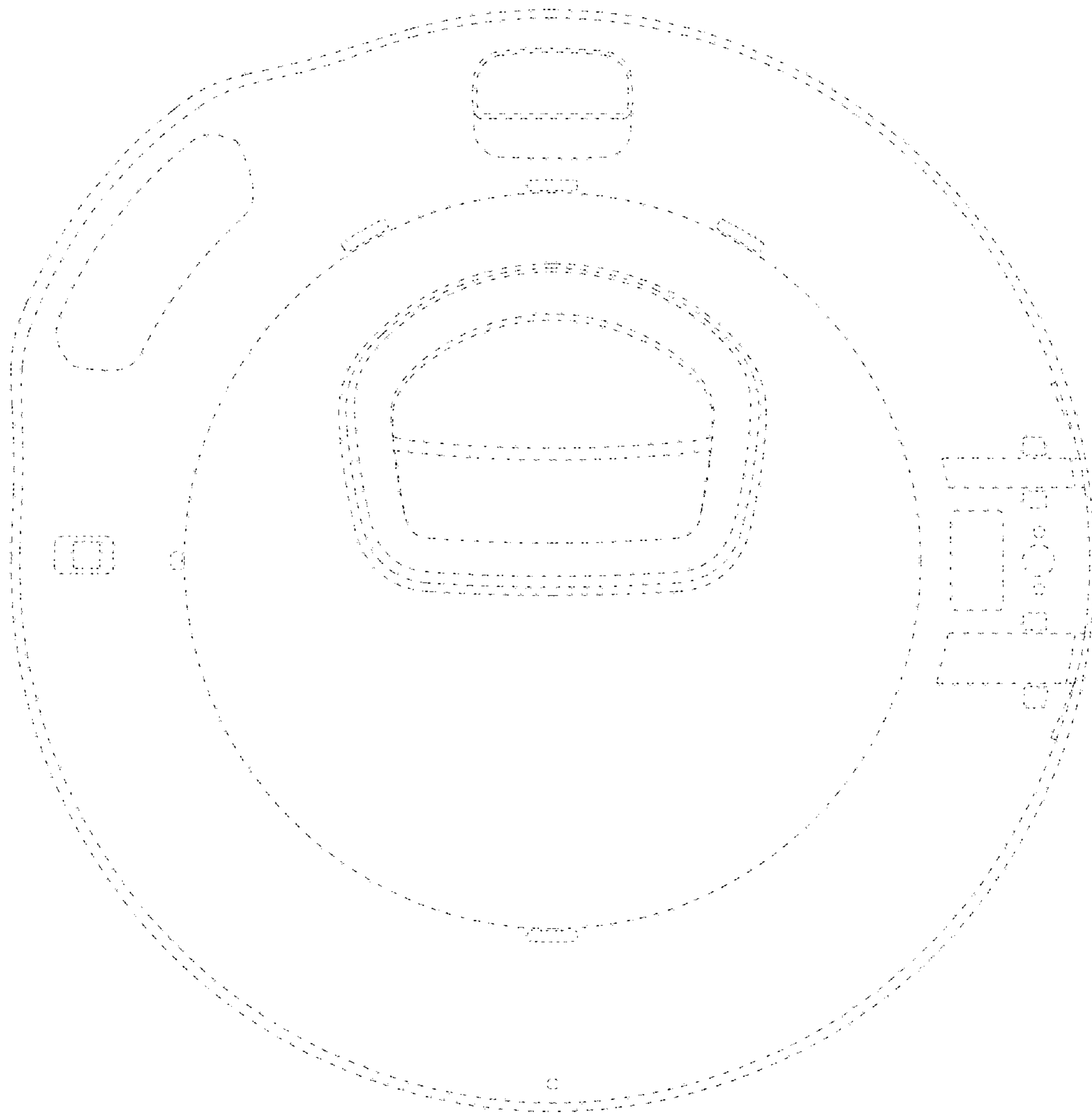

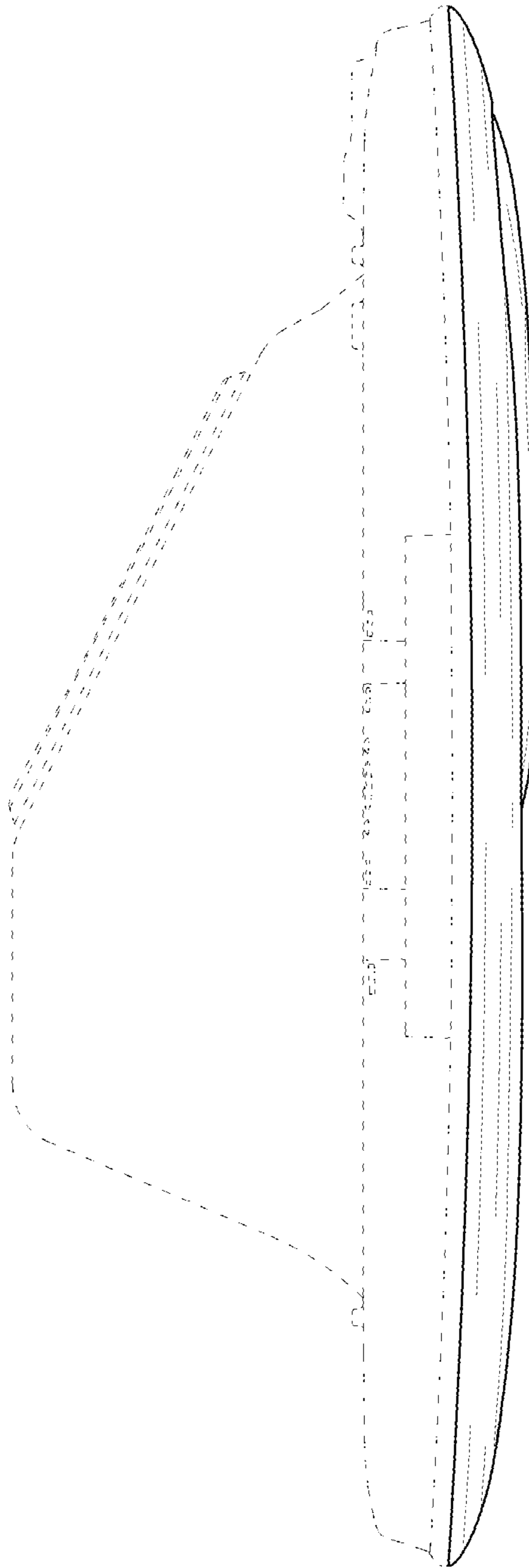

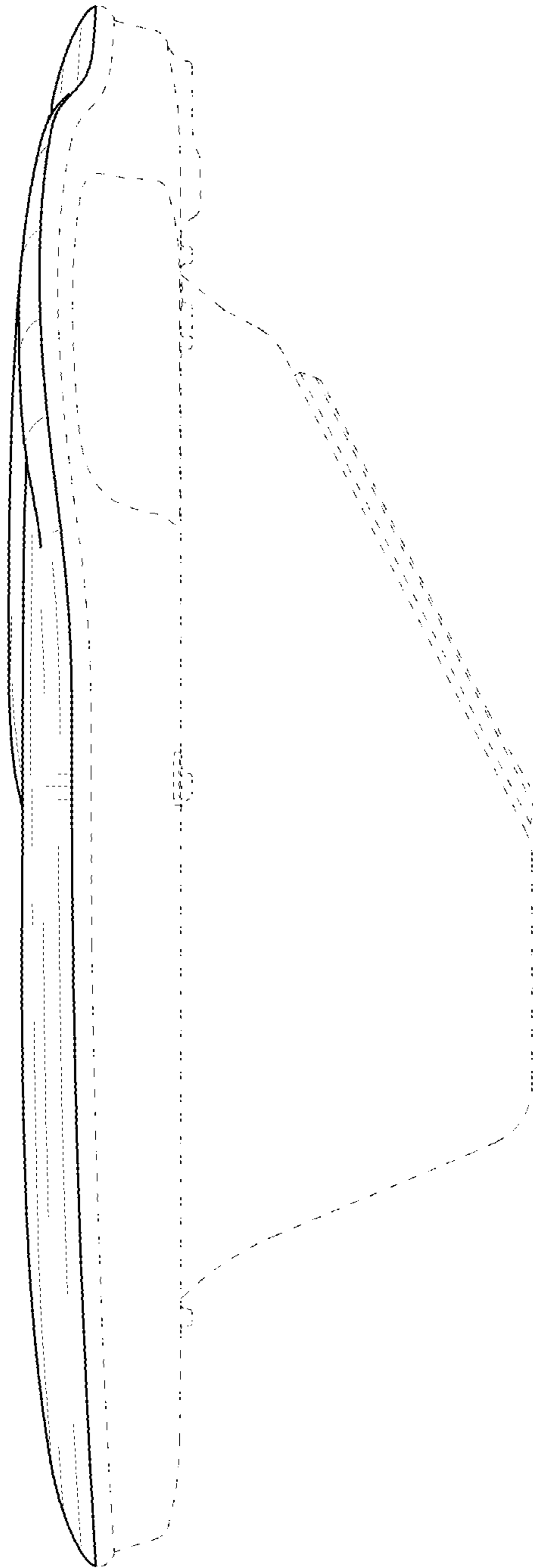

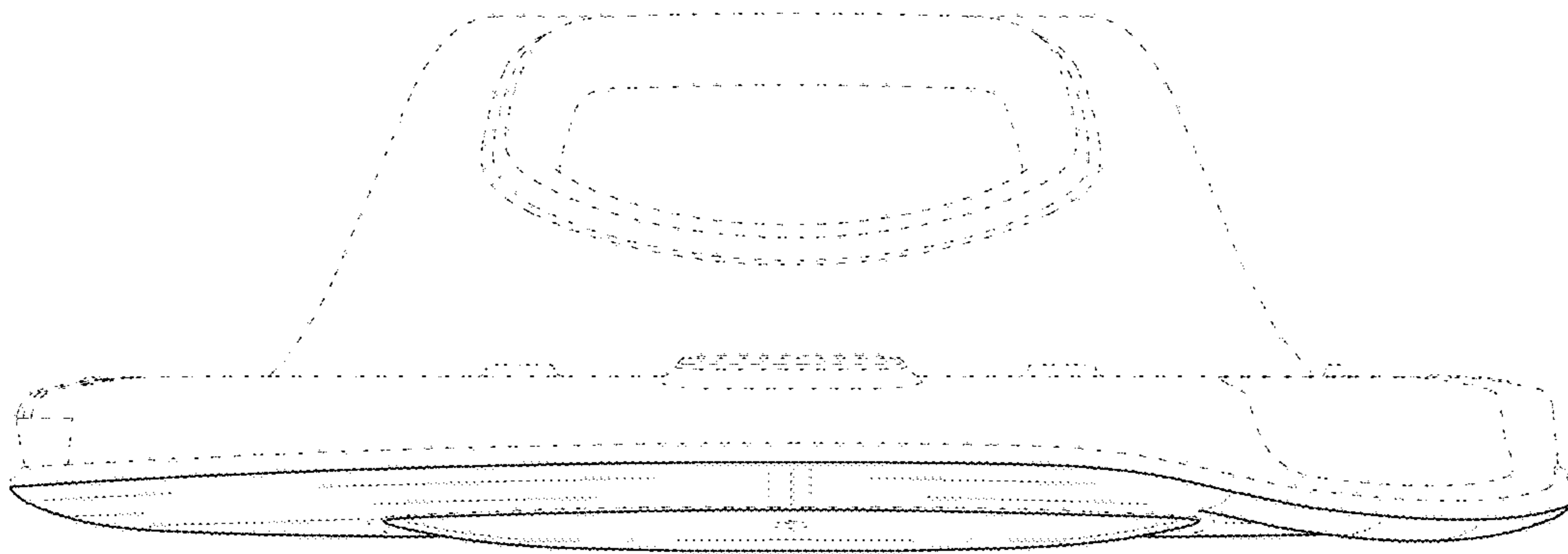

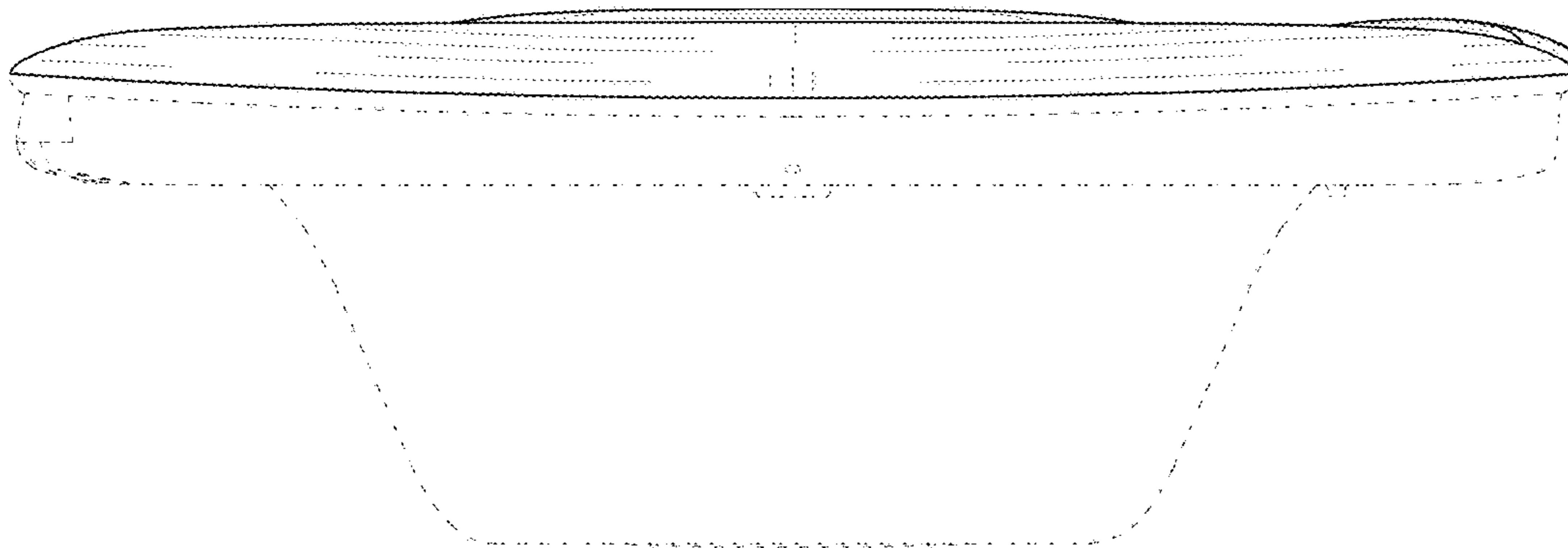
