(57) **CLAIM**

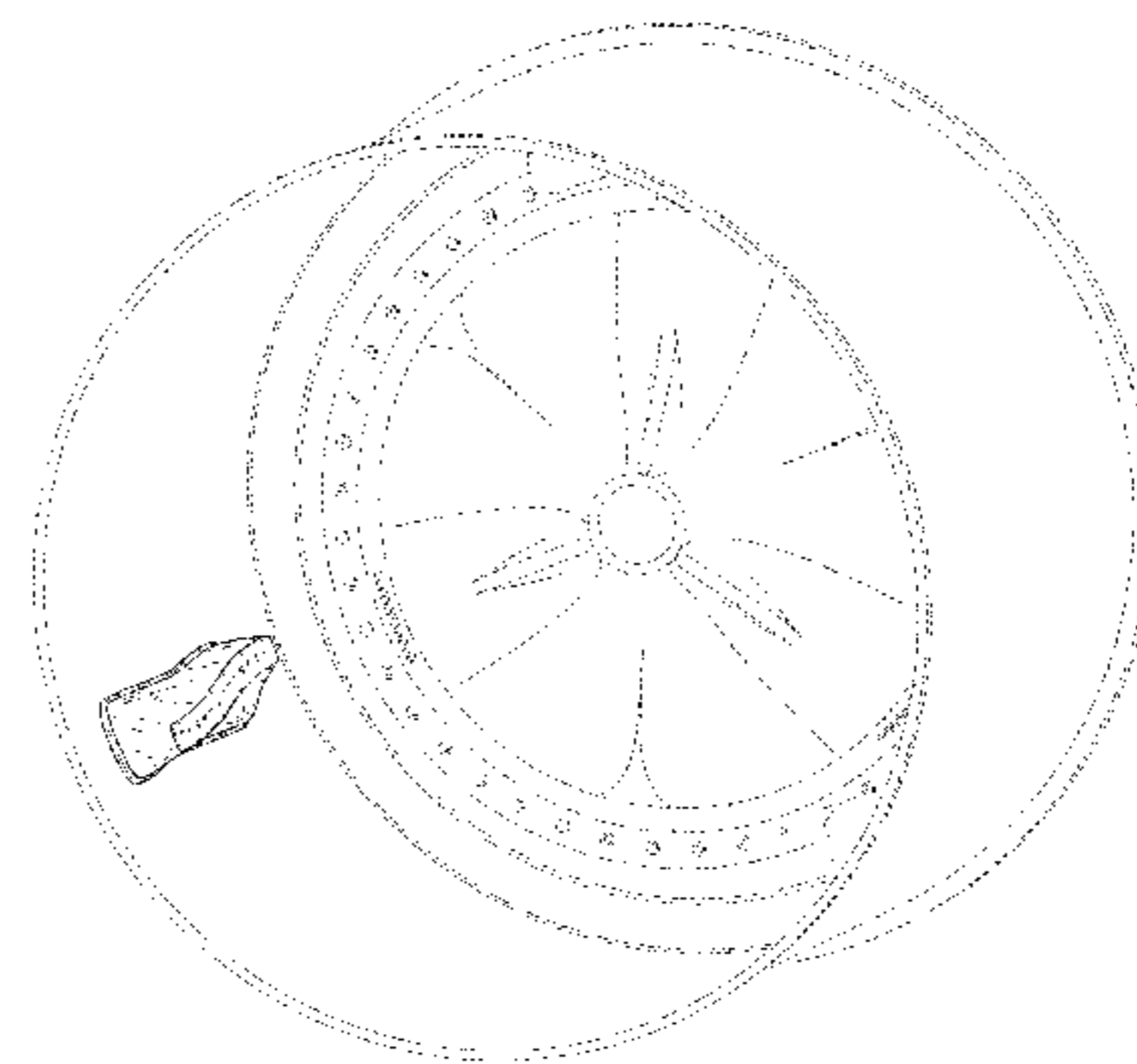
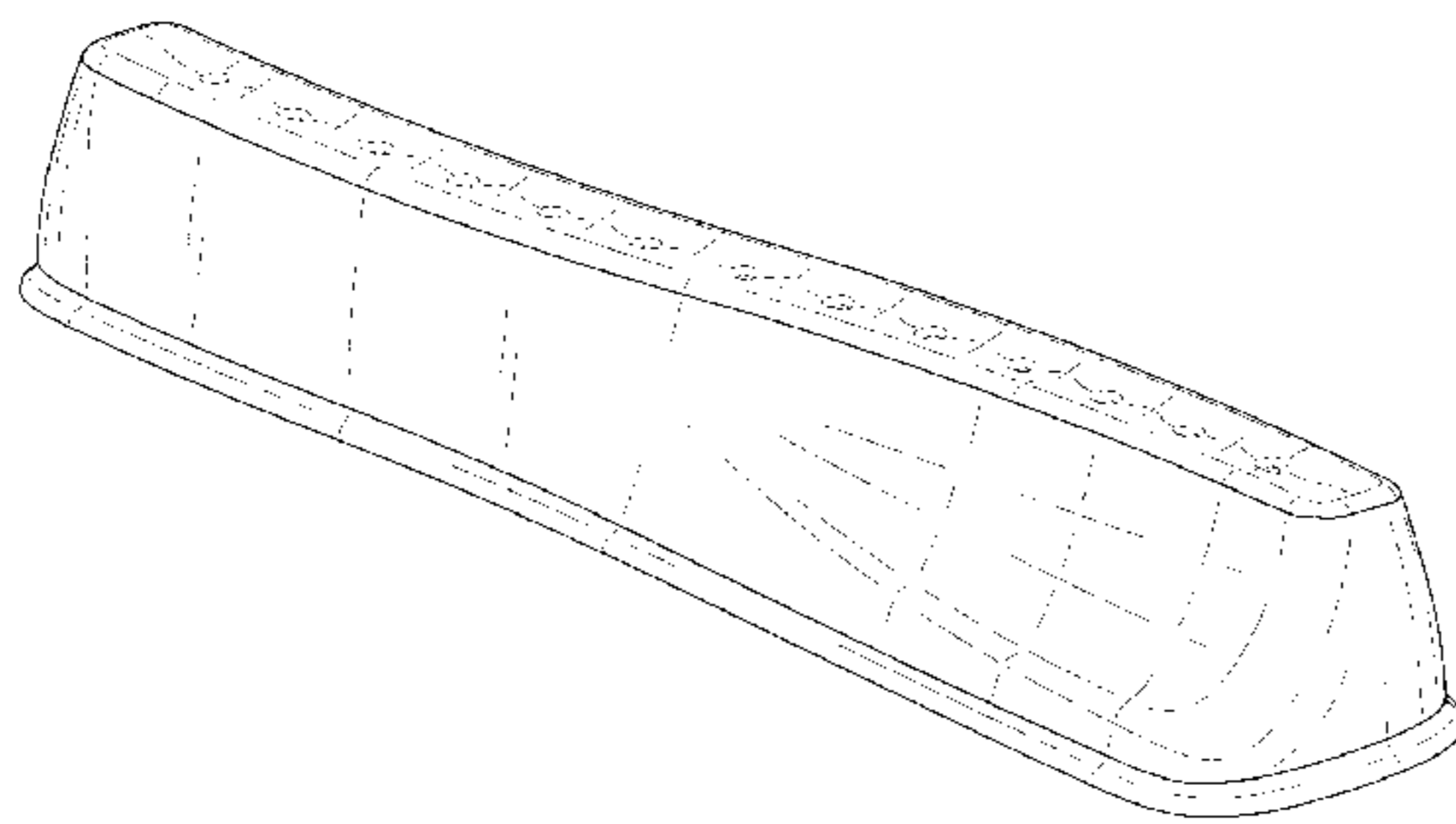
We claim the ornamental design for a paddle lifter for washing machine, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a paddle lifter for washing machine showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left-side elevational view thereof; FIG. 5 is a right-side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is rear perspective view thereof; and, FIG. 9 is another perspective view of the paddle lifter for washing machine in use.

The broken lines in the figures illustrate portions of the paddle lifter for washing machine that form no part of the claimed design. The broken lines in FIG. 9 of a washing machine illustrate environment and form no part of the claimed design.

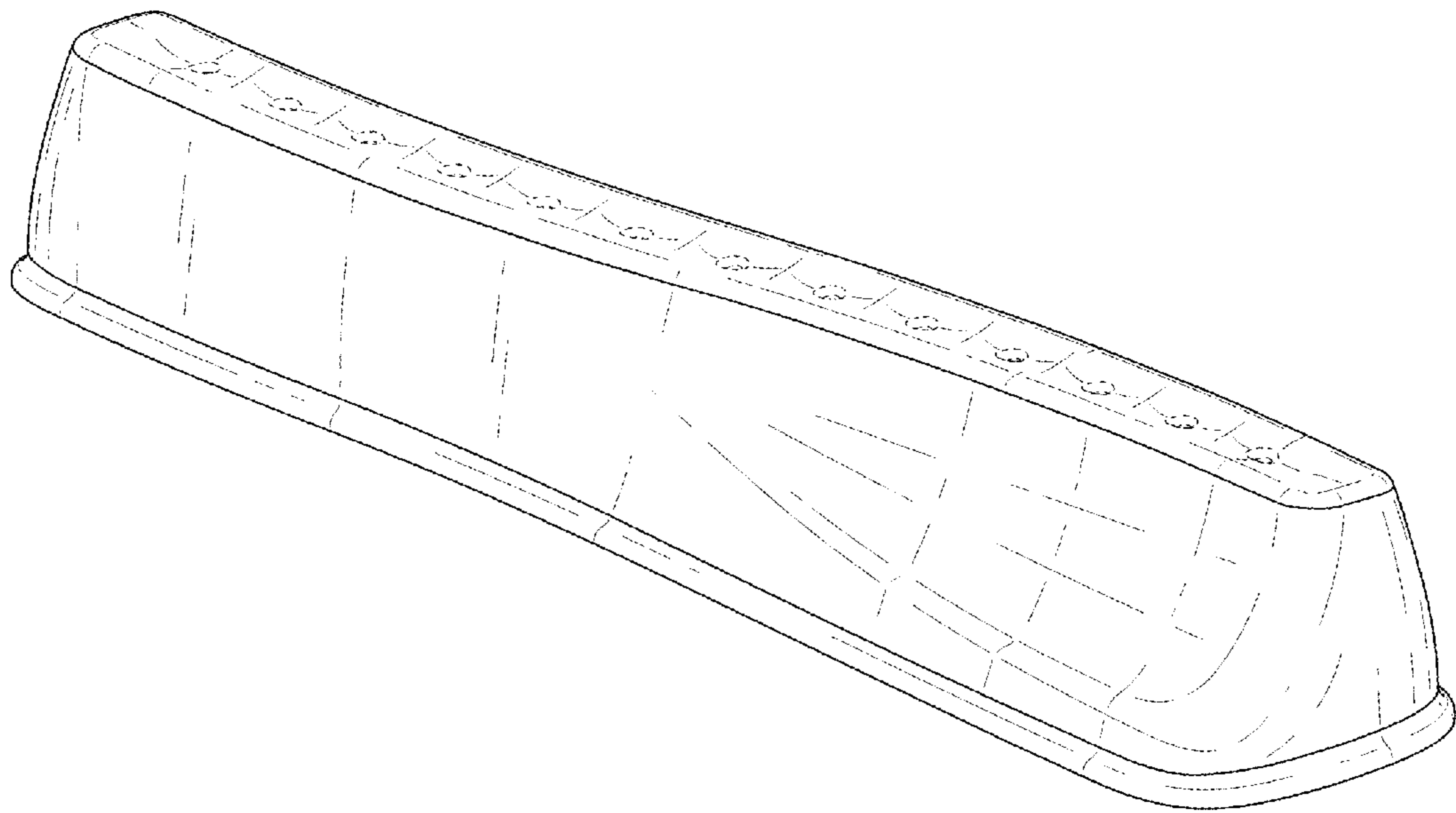

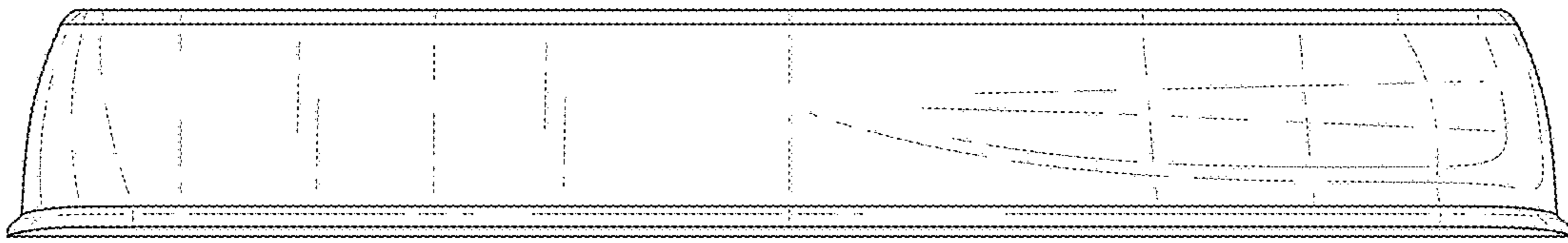

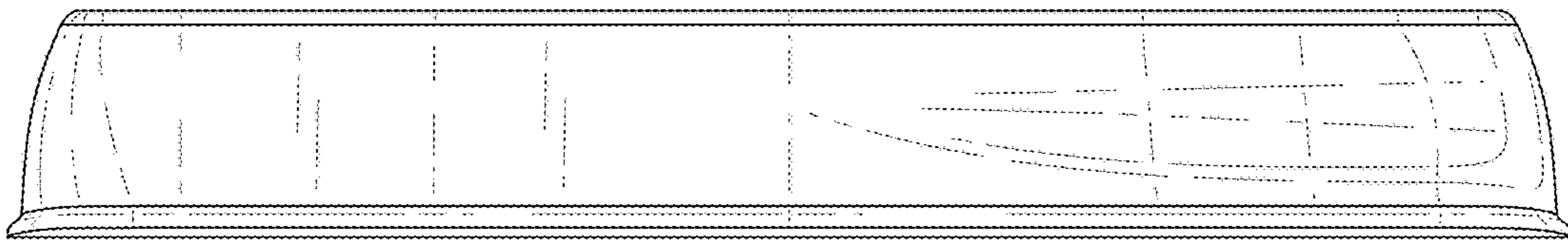

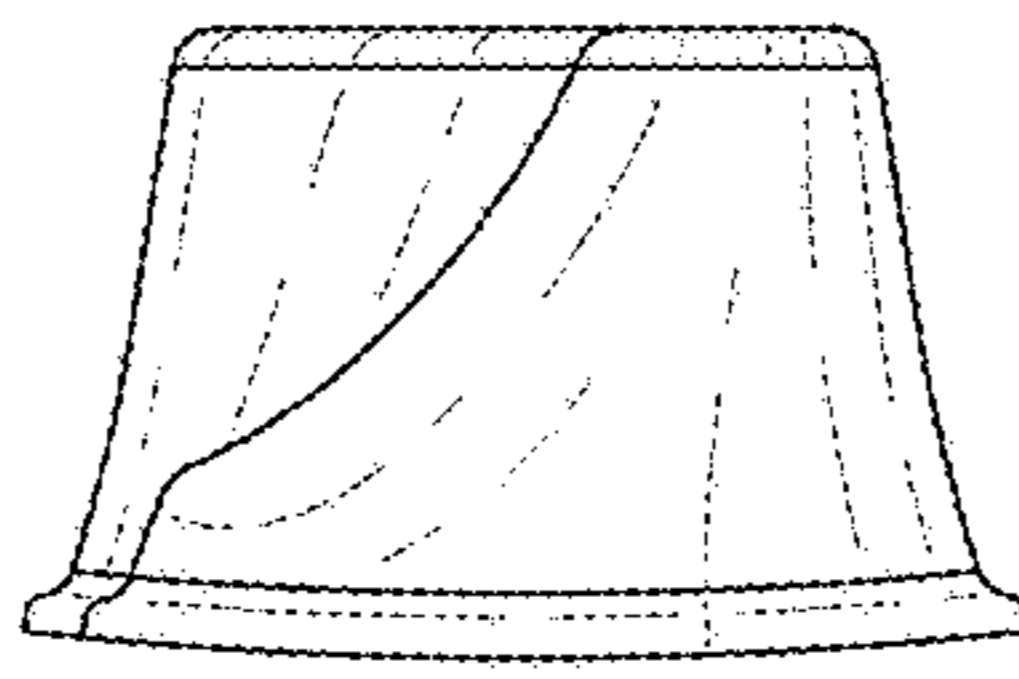

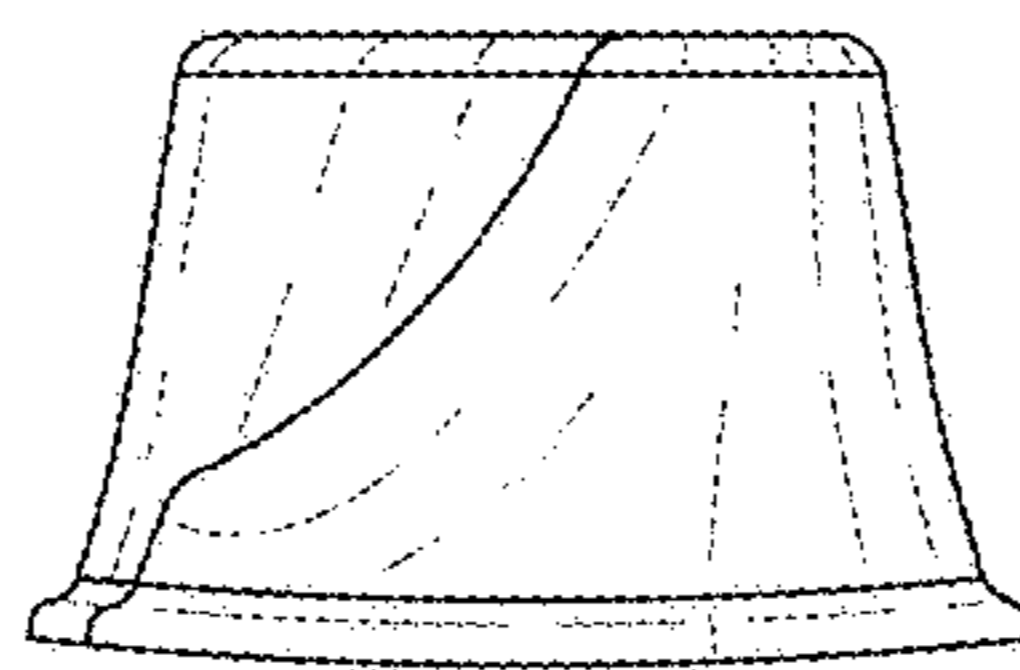

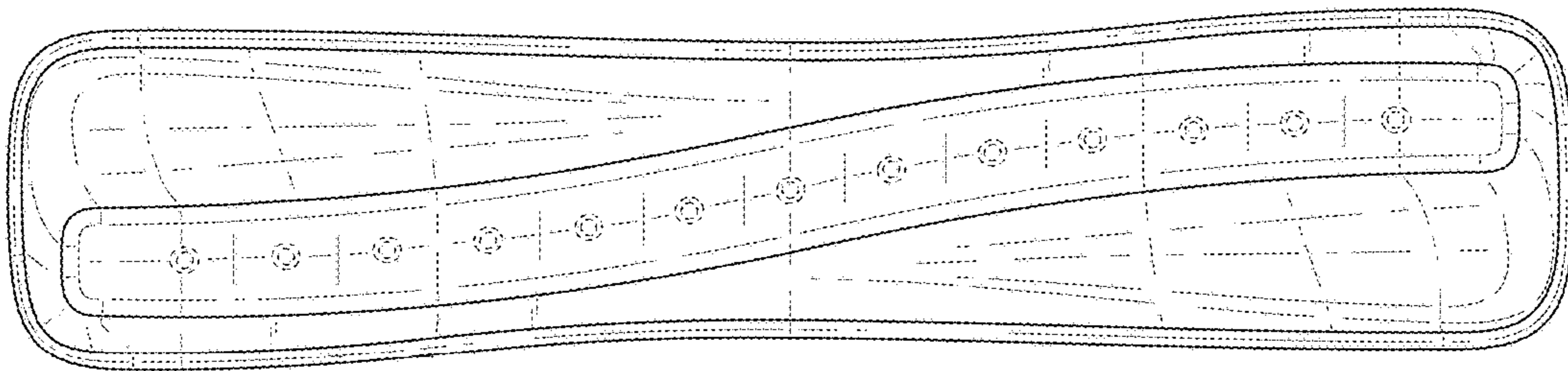

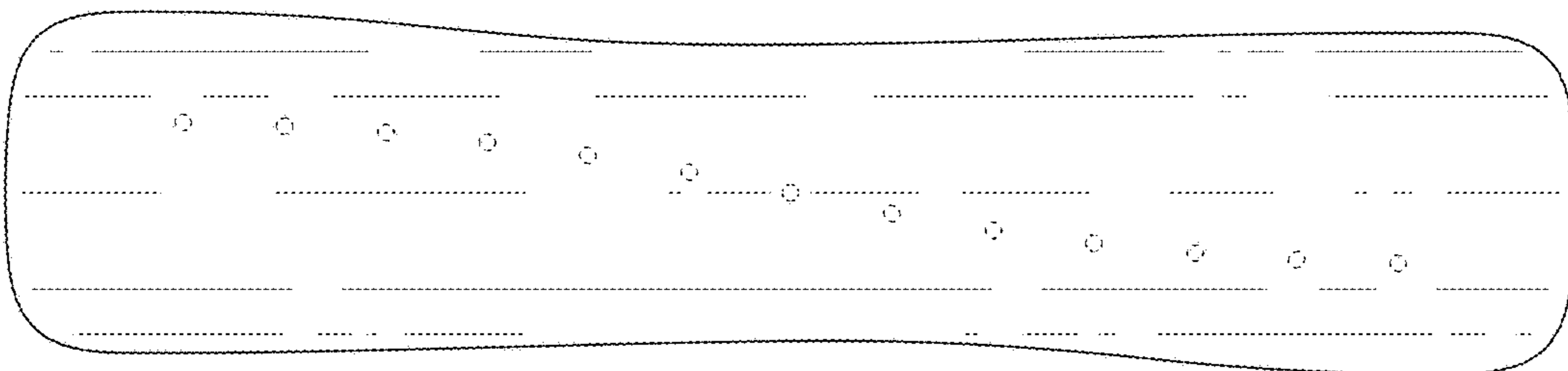

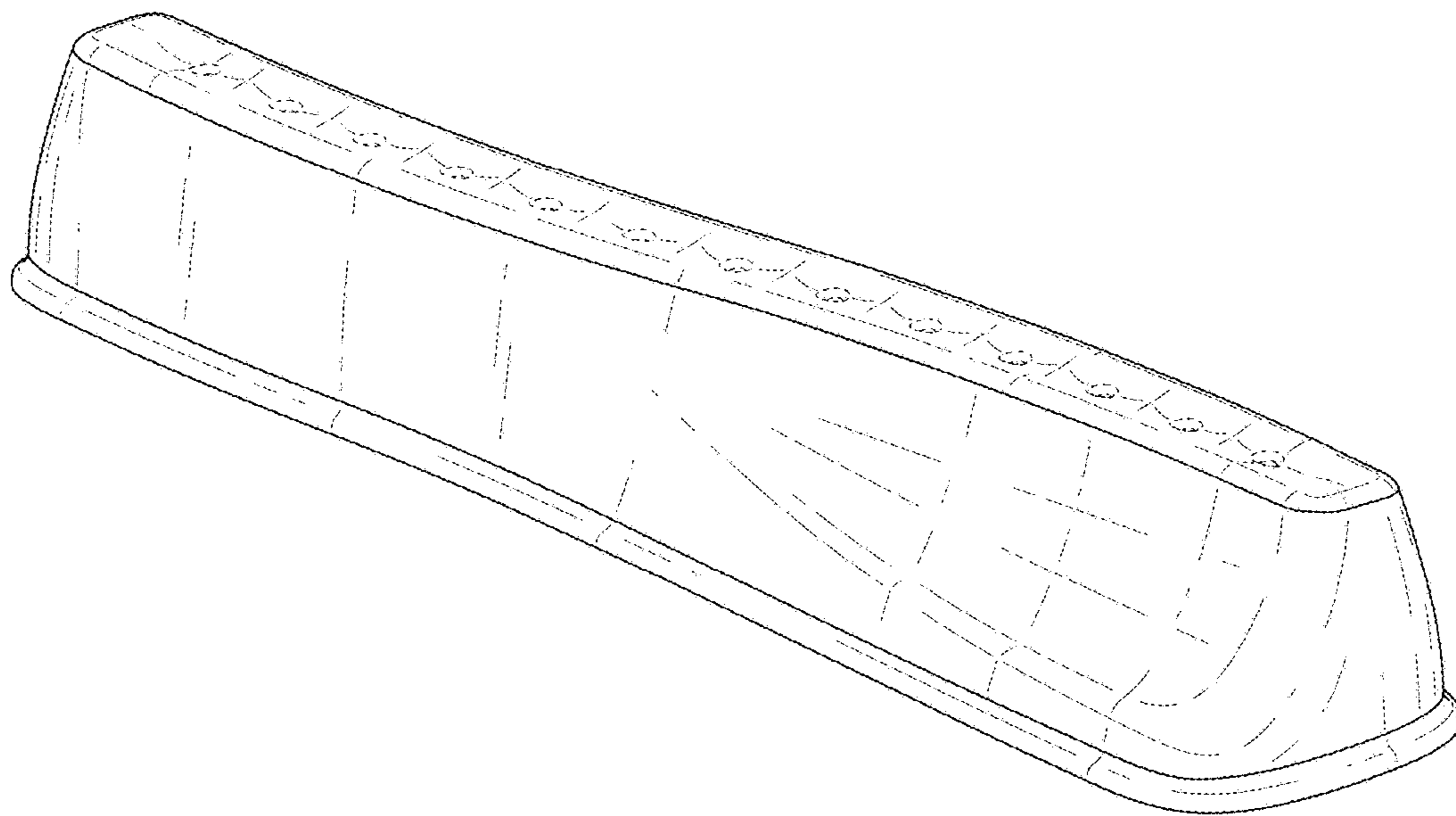
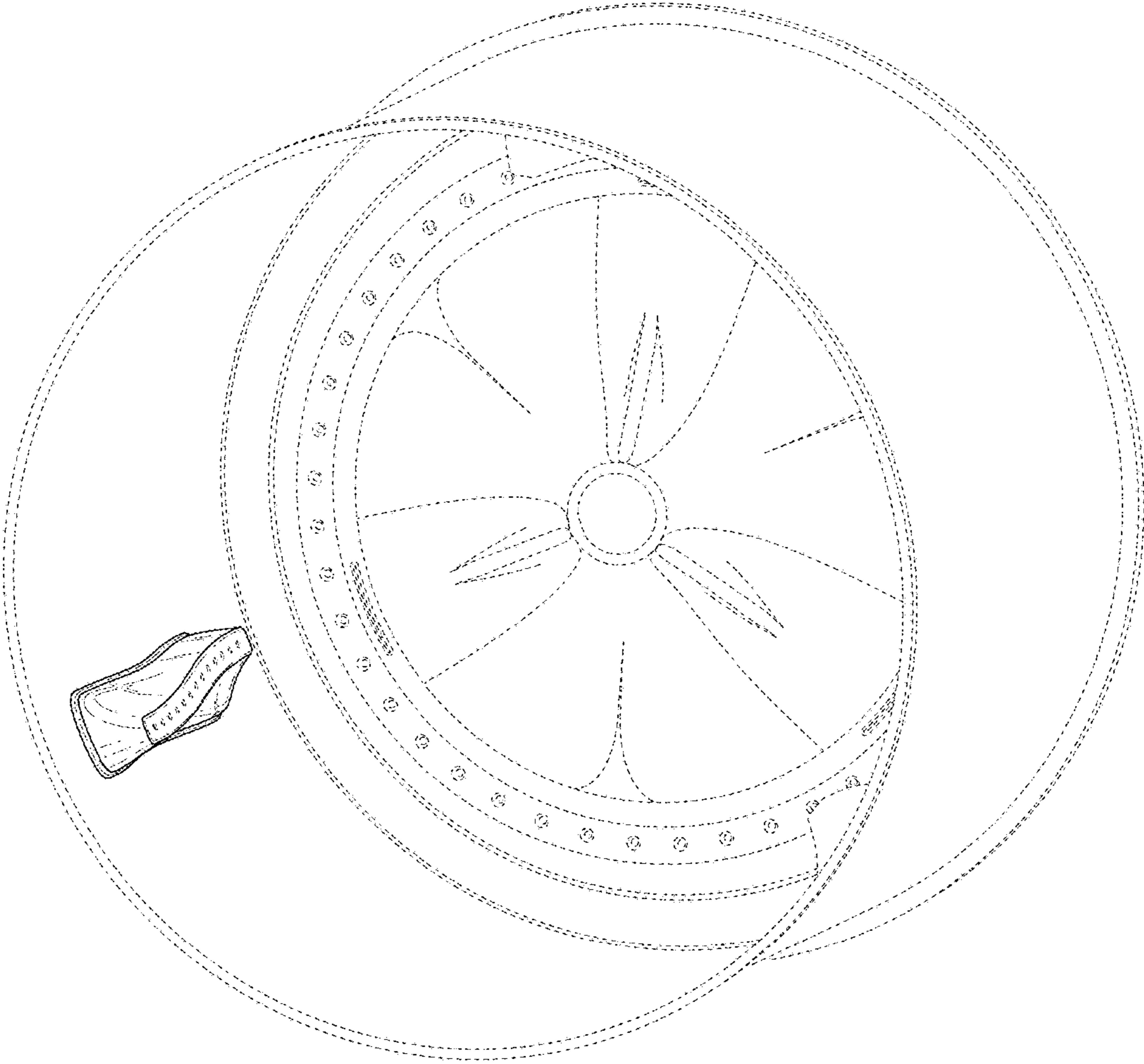
