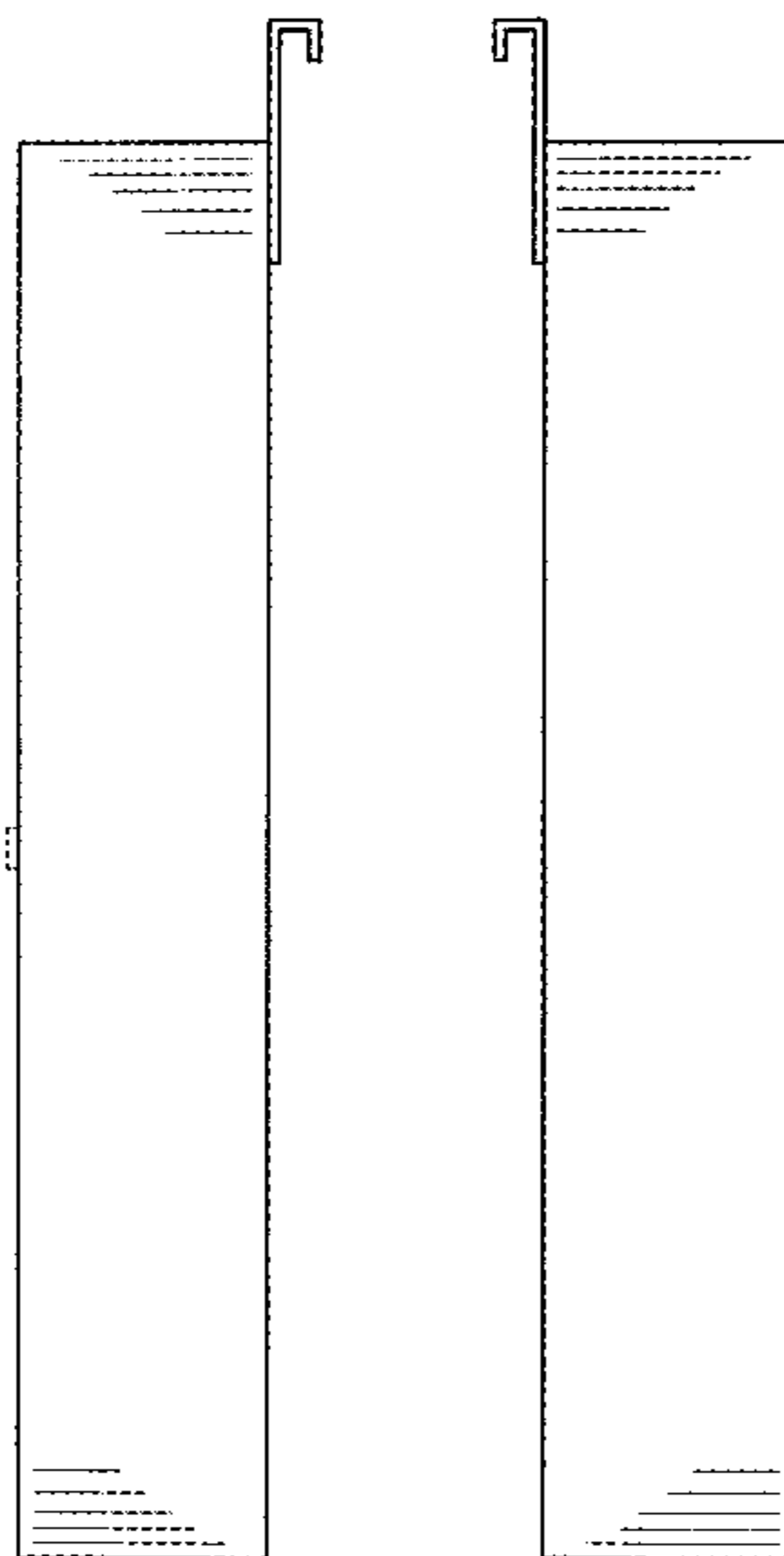
(57) **CLAIM**

The ornamental design for a package delivery box, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view of a package delivery box showing my new design;  
 FIG. 2 is a right side view thereof;  
 FIG. 3 is a left side view of thereof;  
 FIG. 4 is a top view thereof;  
 FIG. 5 is a bottom view thereof;  
 FIG. 6 is a front view thereof;  
 FIG. 7 is a rear view thereof; and,  
 FIG. 8 is another left side perspective view thereof, shown in a used condition attached to a door shown in broken lines. The three circles shown on each of the two brackets in FIG. 7 are flat screws.  
 The broken lines shown in the drawing views form no part of the claimed design.

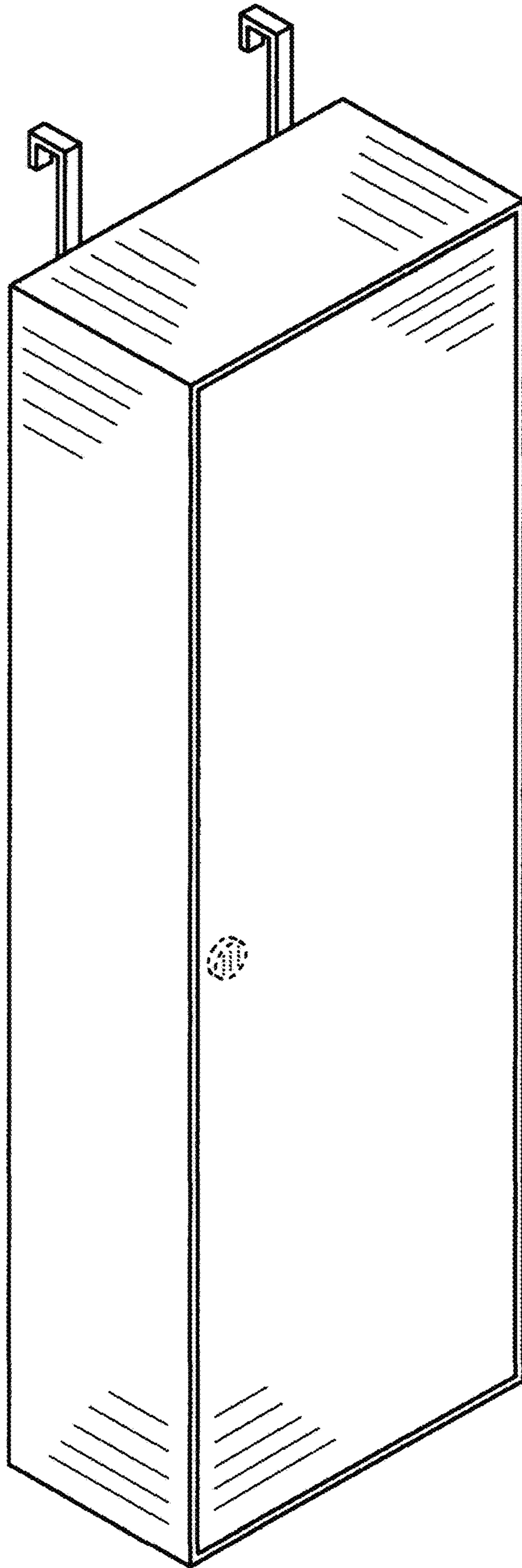

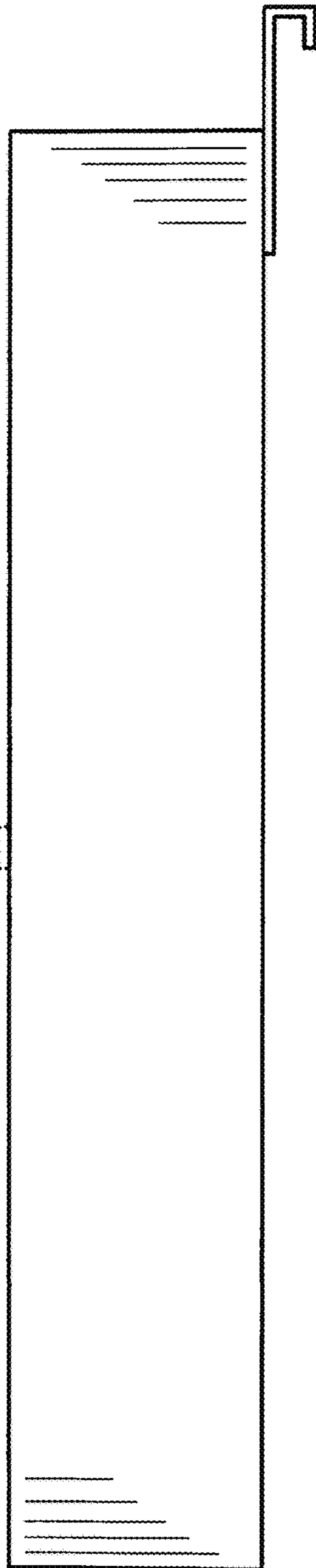

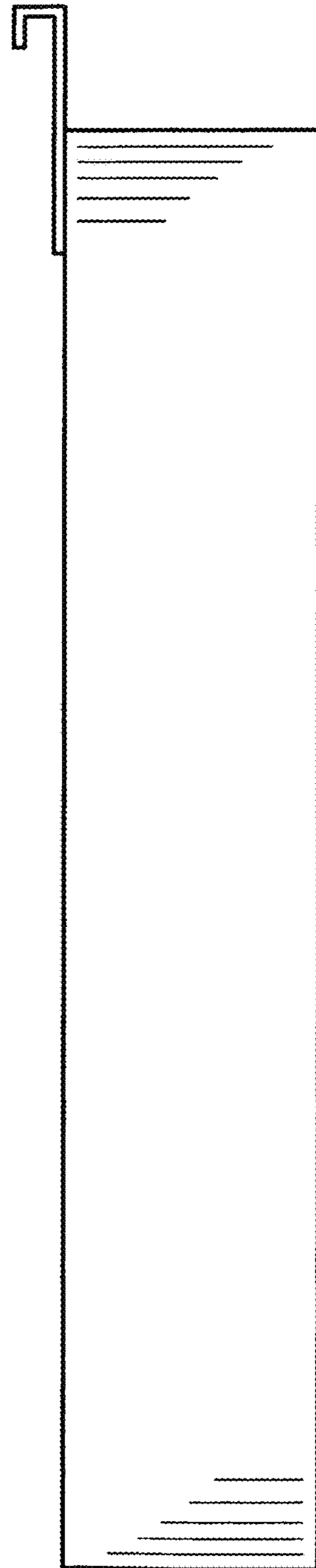

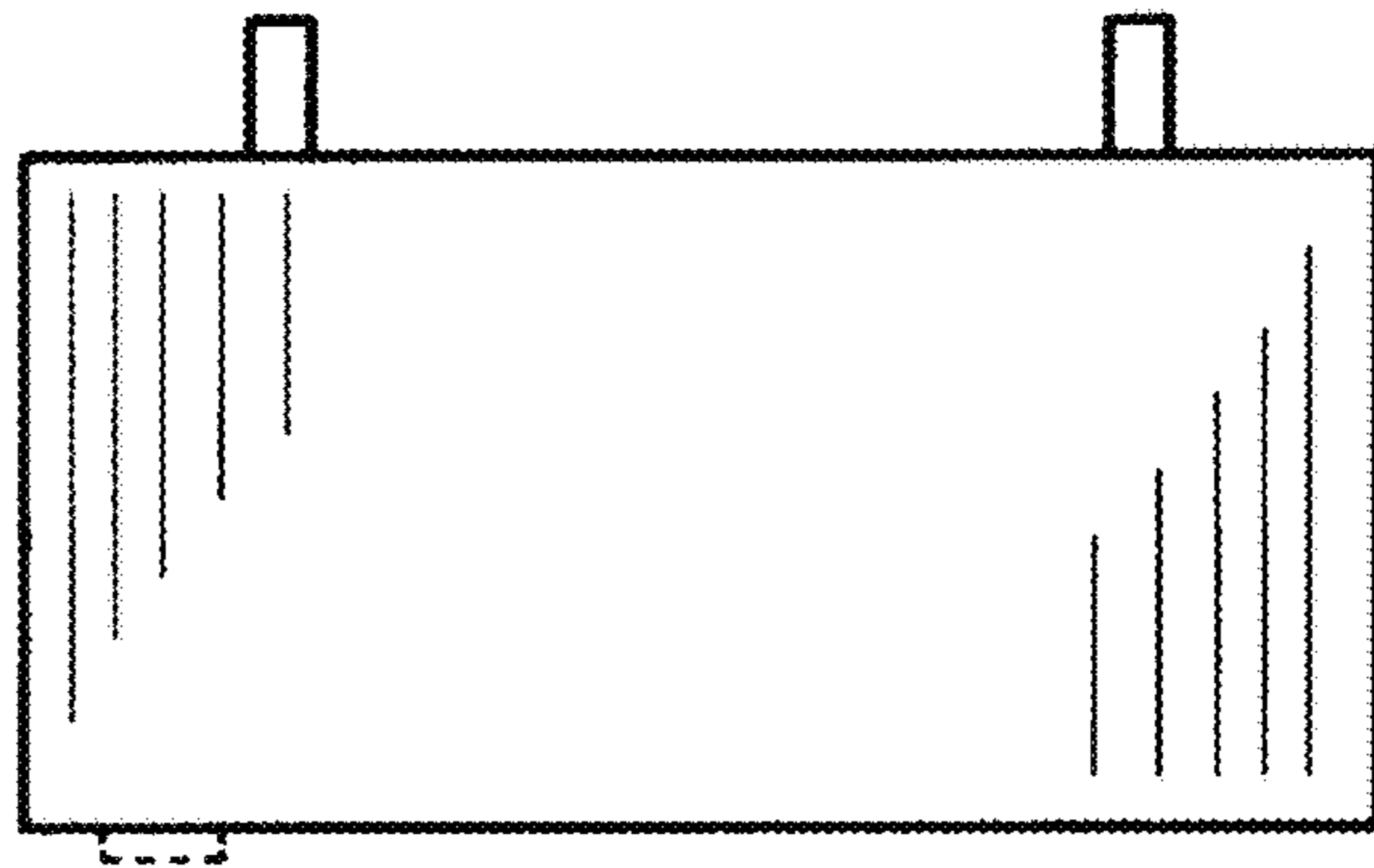

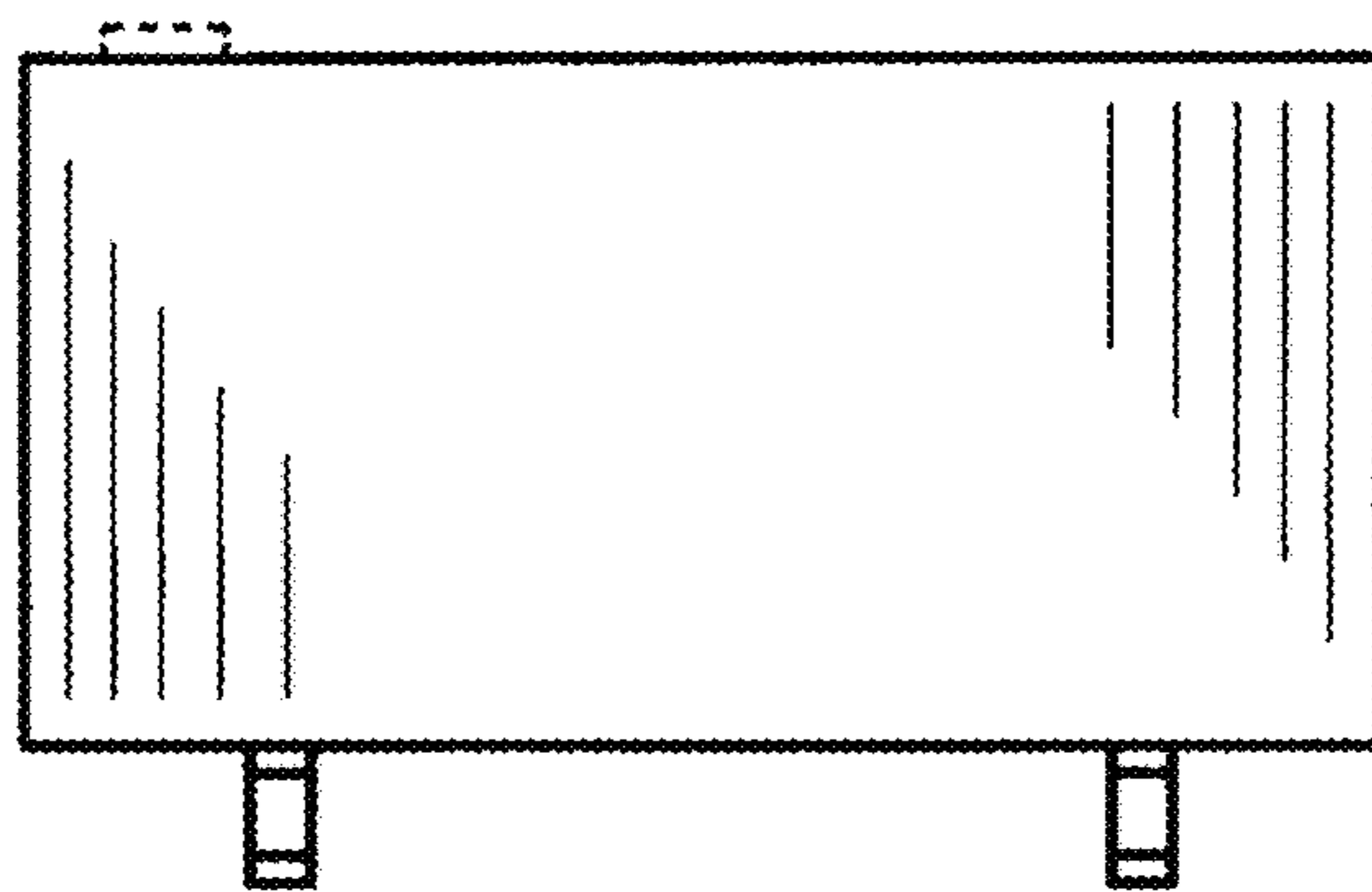

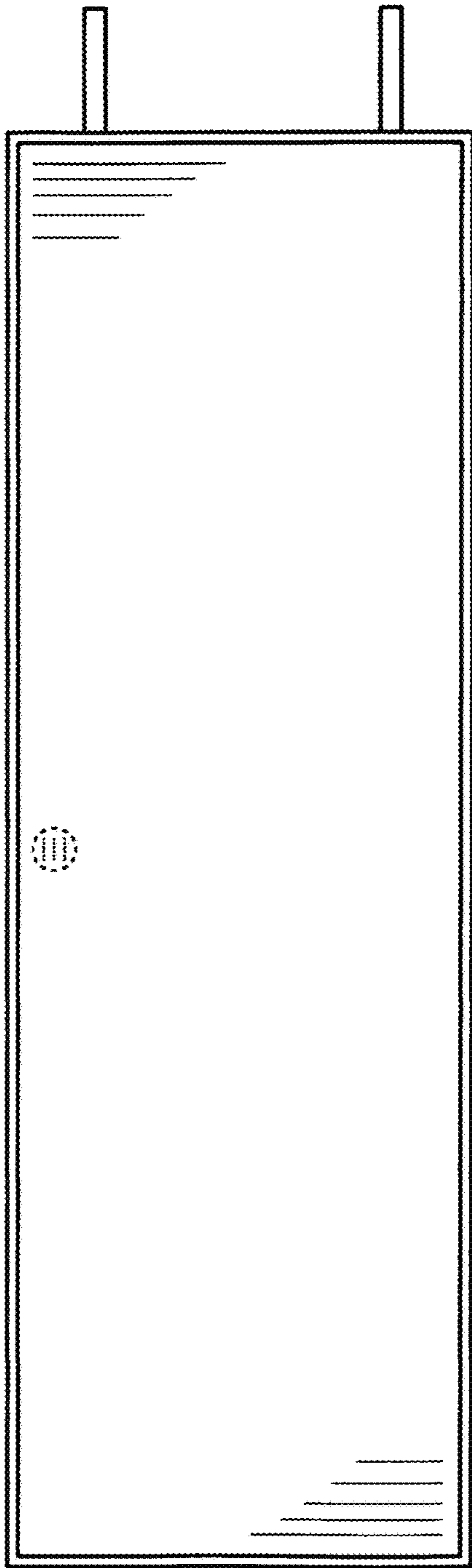

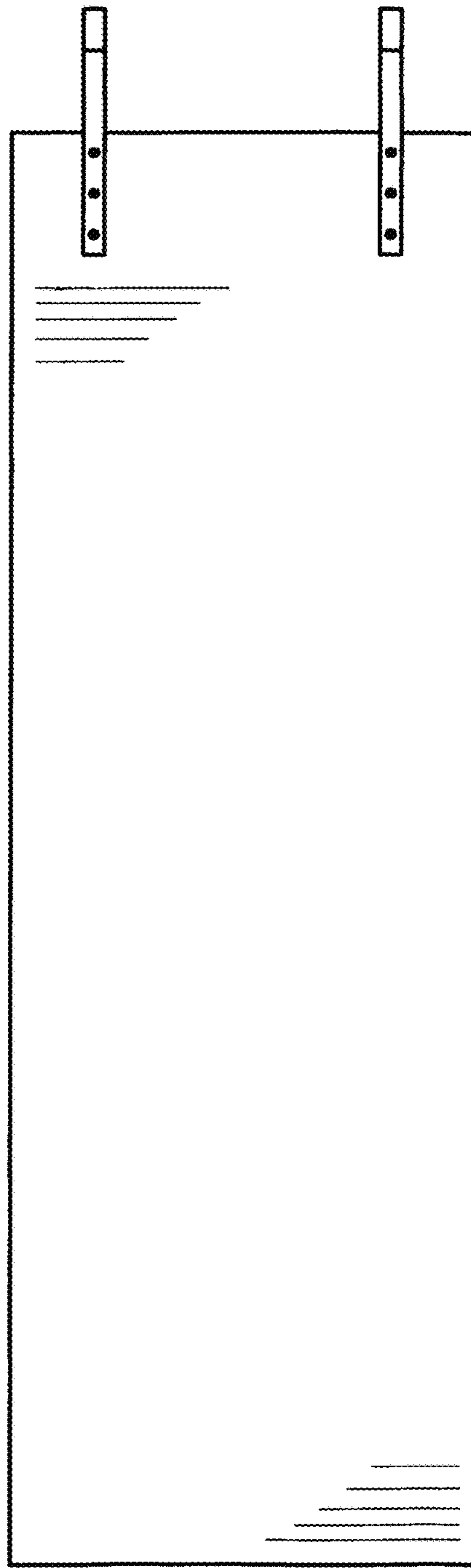

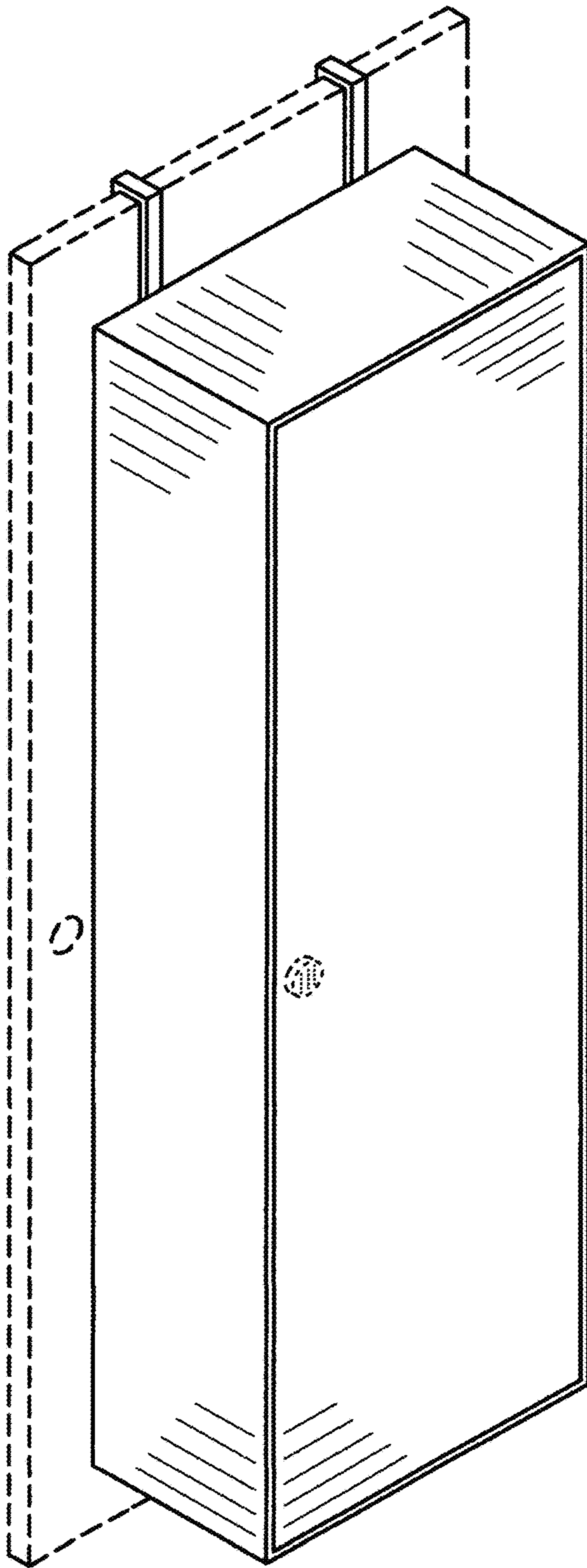
