The ornamental design for a brassiere, as shown and described.

**DESCRIPTION**

FIG. 1 is a front left perspective view of a first embodiment of a brassiere showing my new design;

FIG. 2 is a front elevation view of the brassiere of FIG. 1;

FIG. 3 is a rear elevation view of the brassiere of FIG. 1;

FIG. 4 is a left side elevation view of the brassiere of FIG. 1;

FIG. 7 is a bottom plan view of the brassiere of FIG. 1;

FIG. 8 is a front left perspective view of a second embodiment of a brassiere showing my new design;

FIG. 11 is a left side elevation view of the brassiere of FIG. 8;

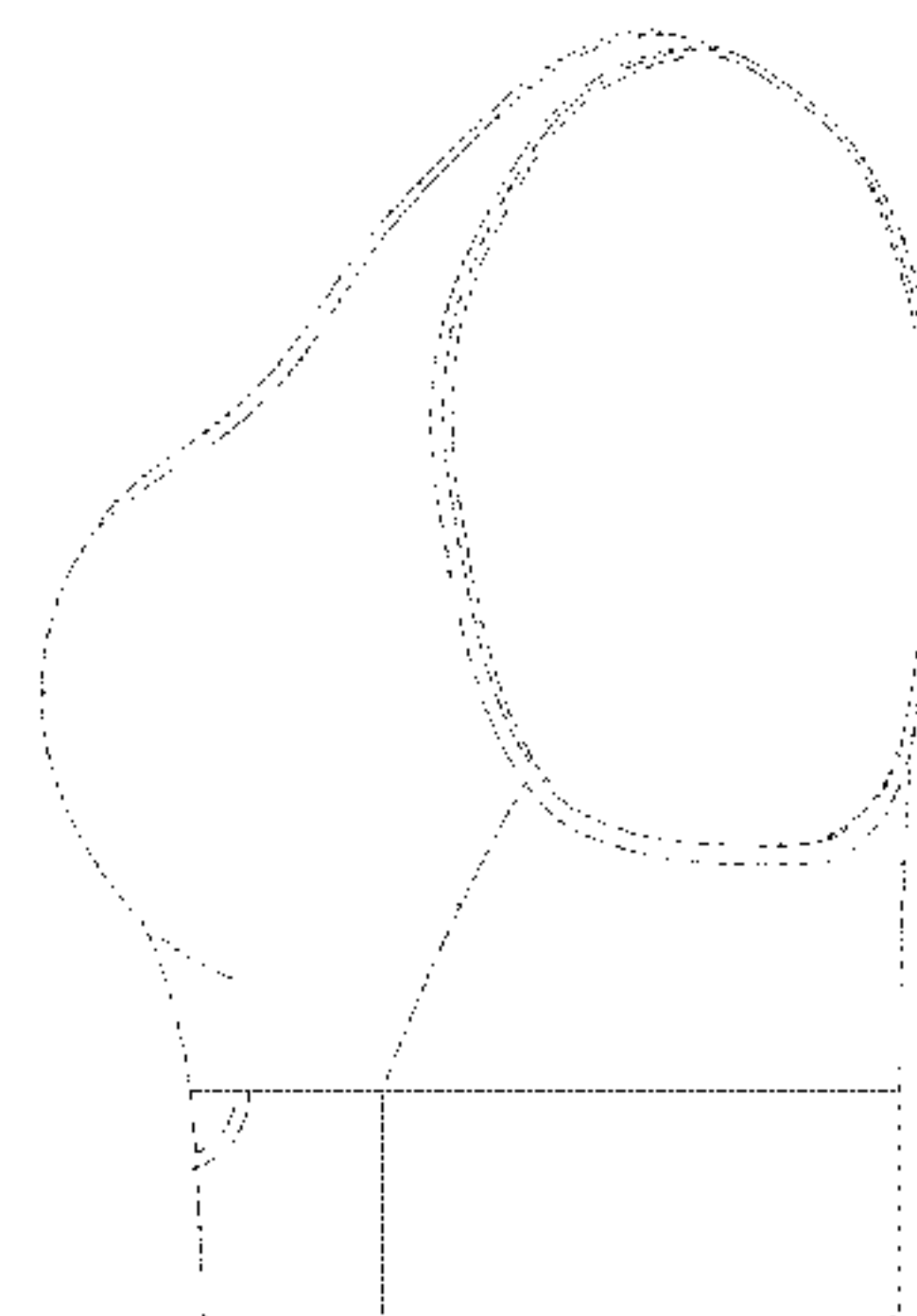
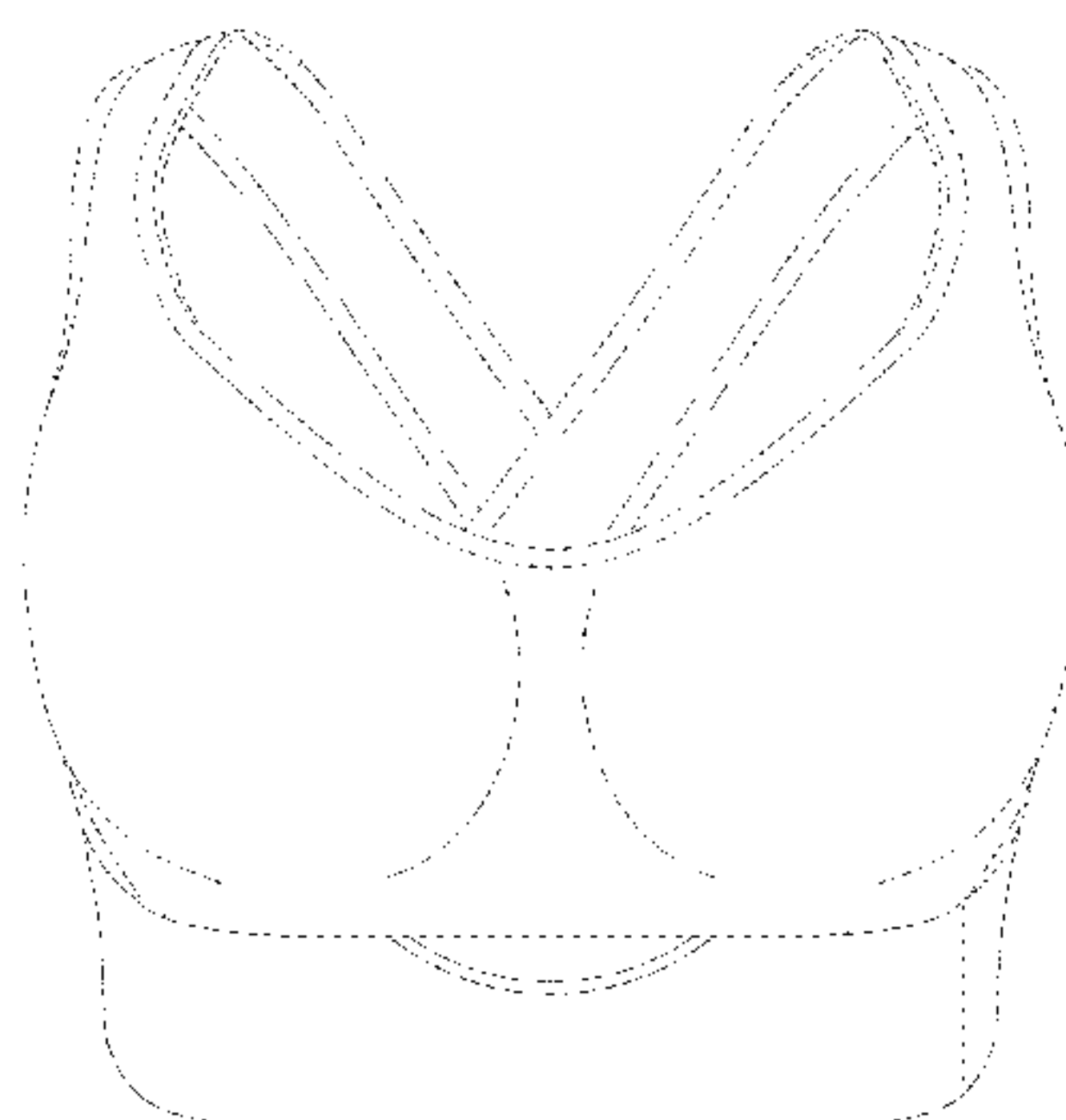
FIG. 12 is a right side elevation view of the brassiere of FIG. 8;

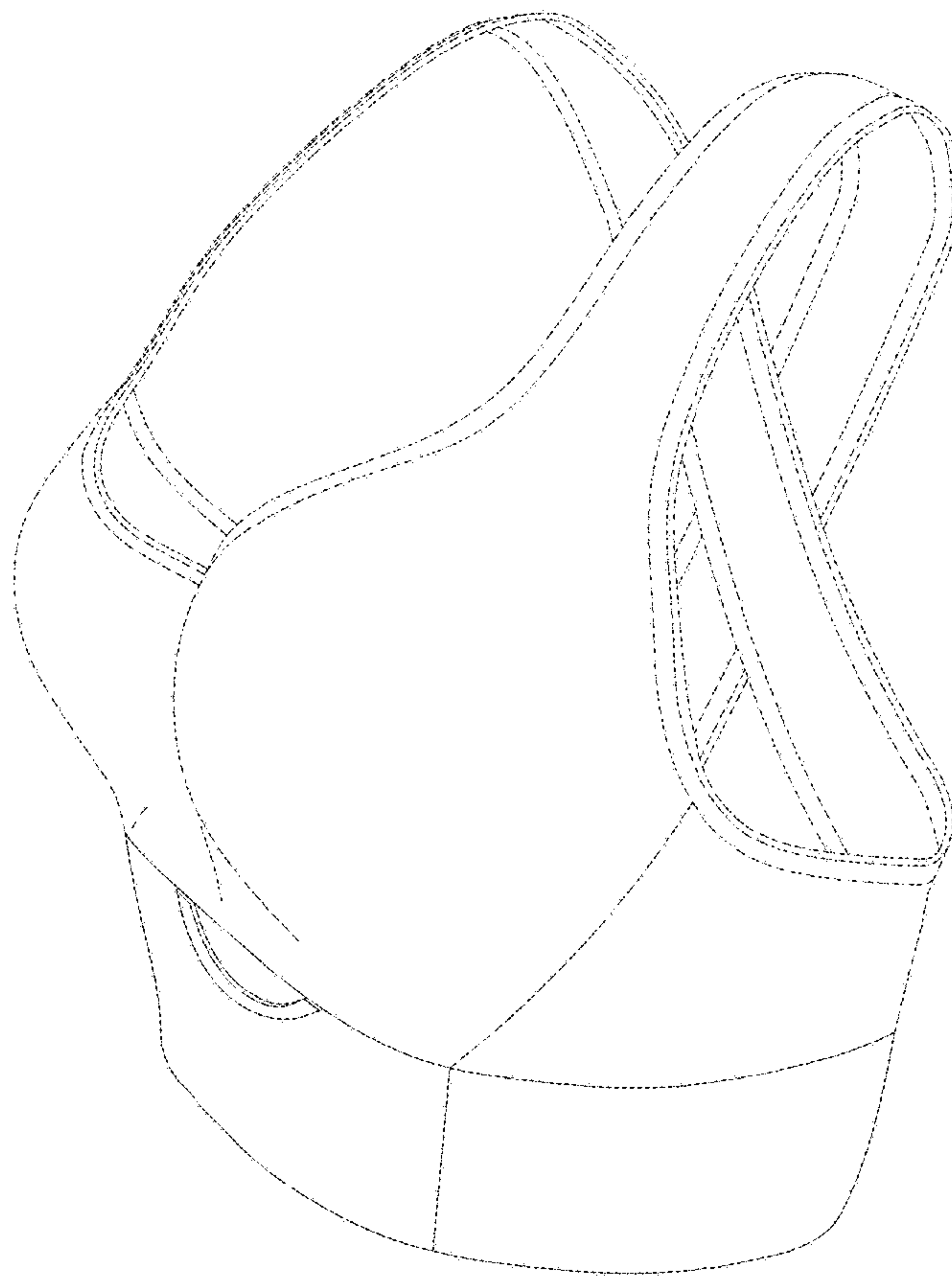

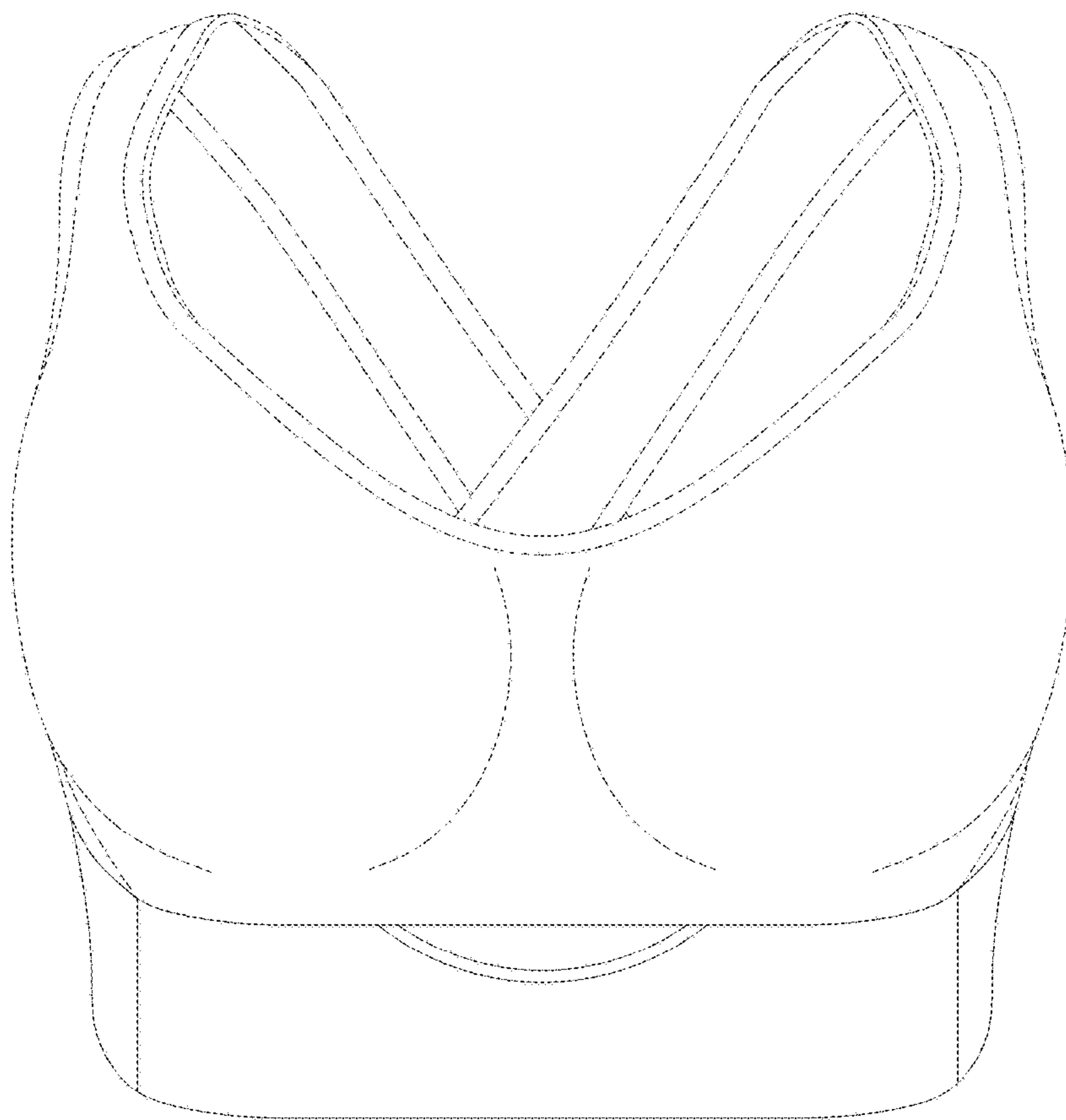

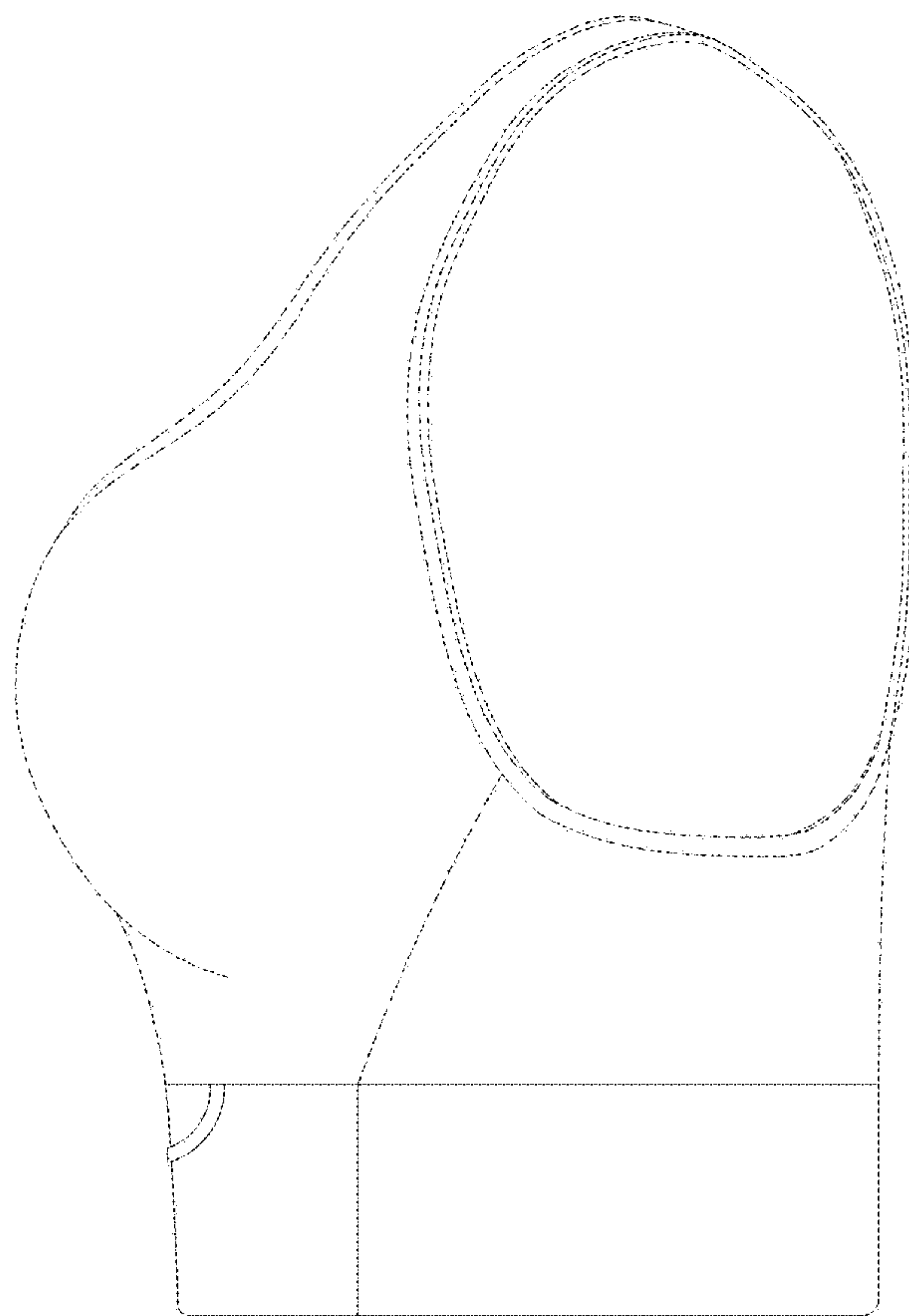

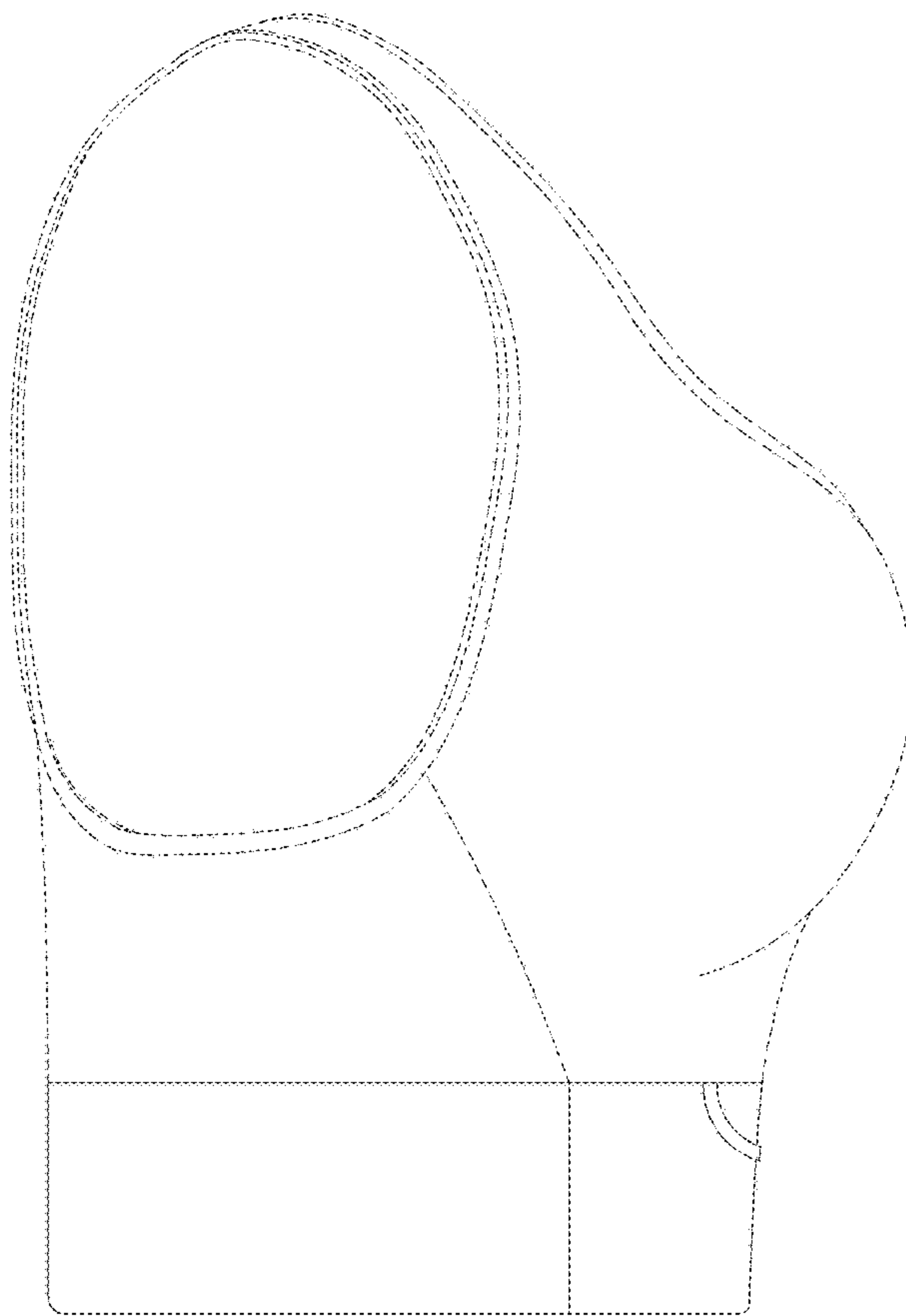

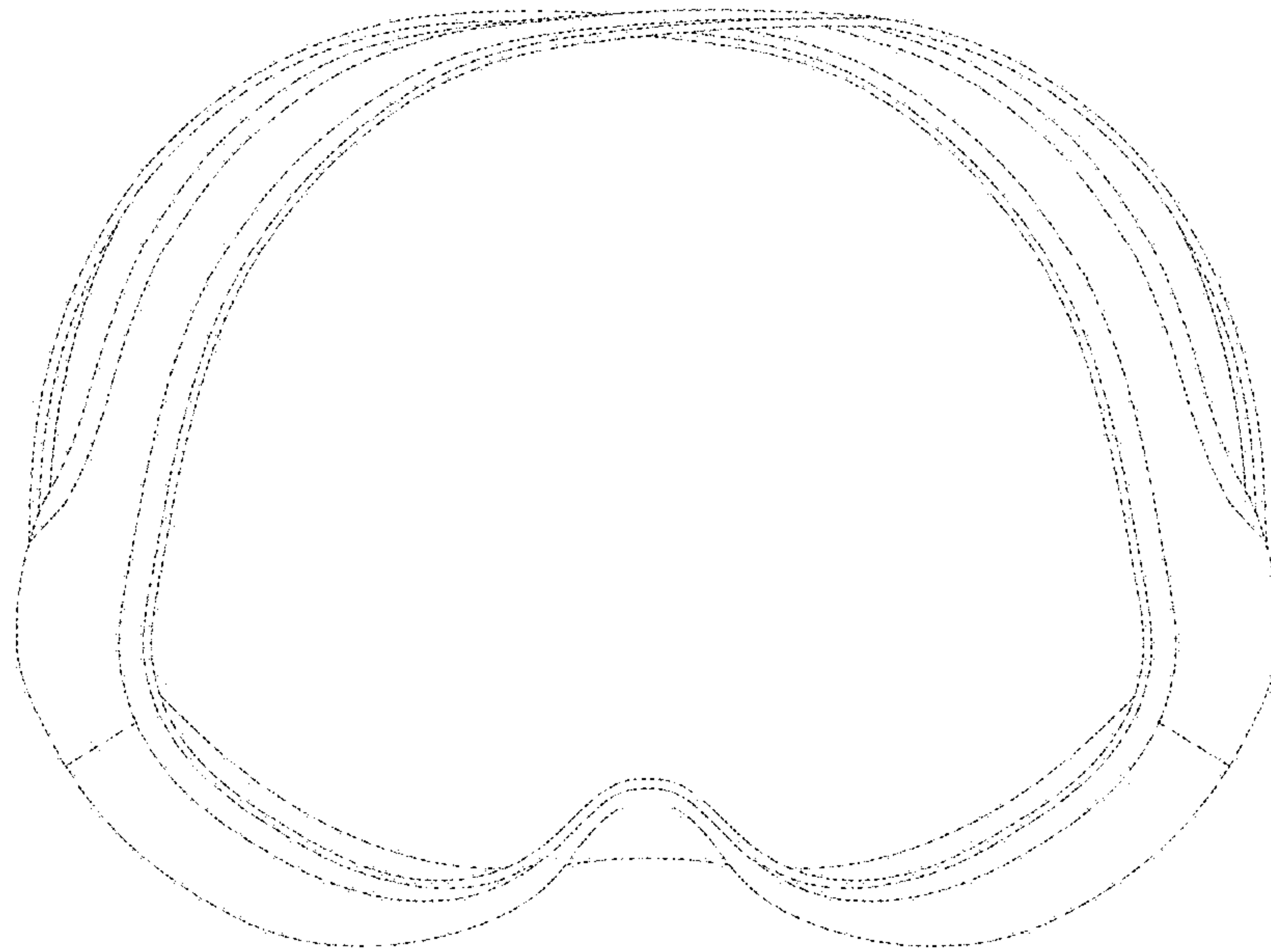

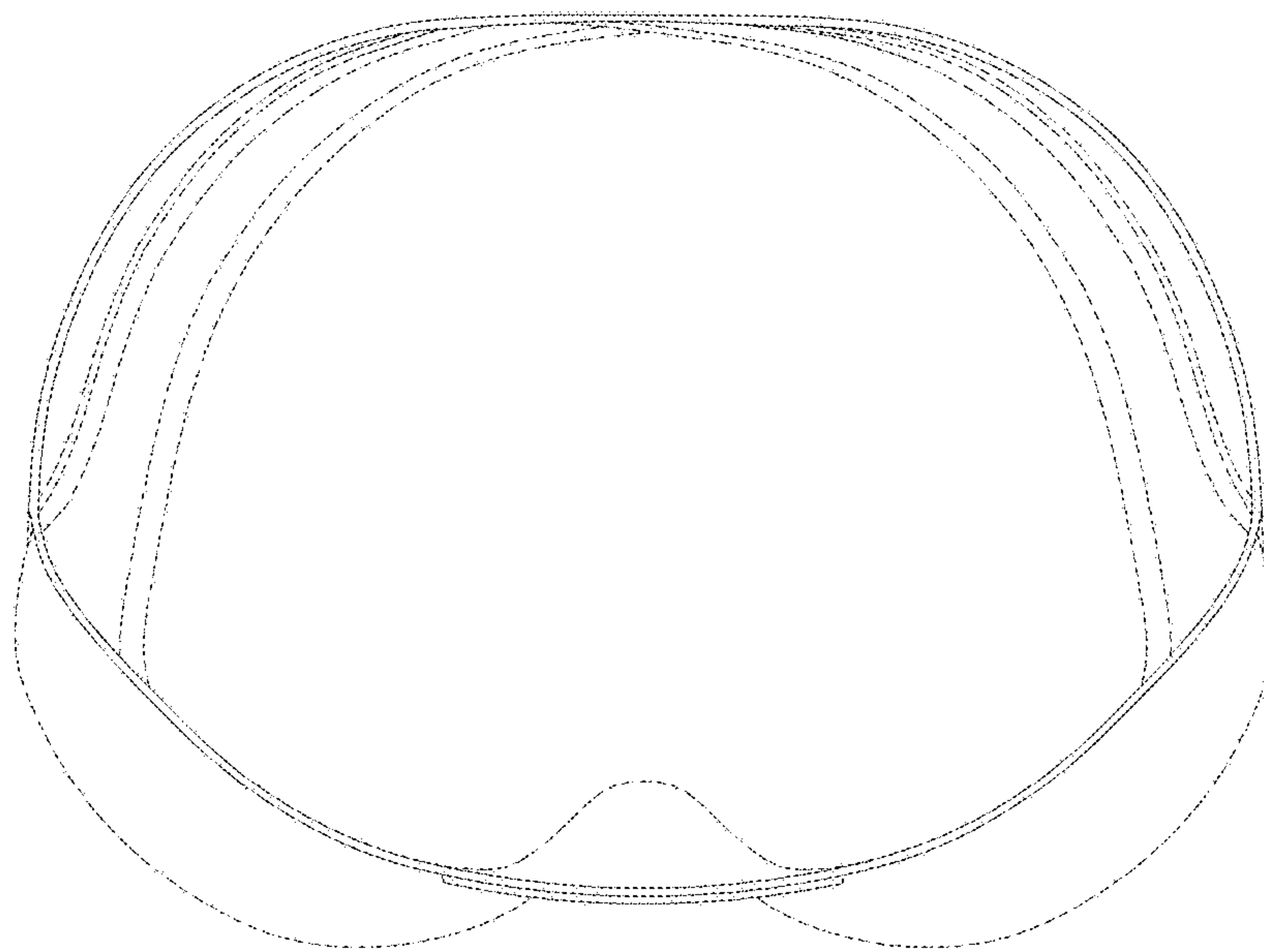

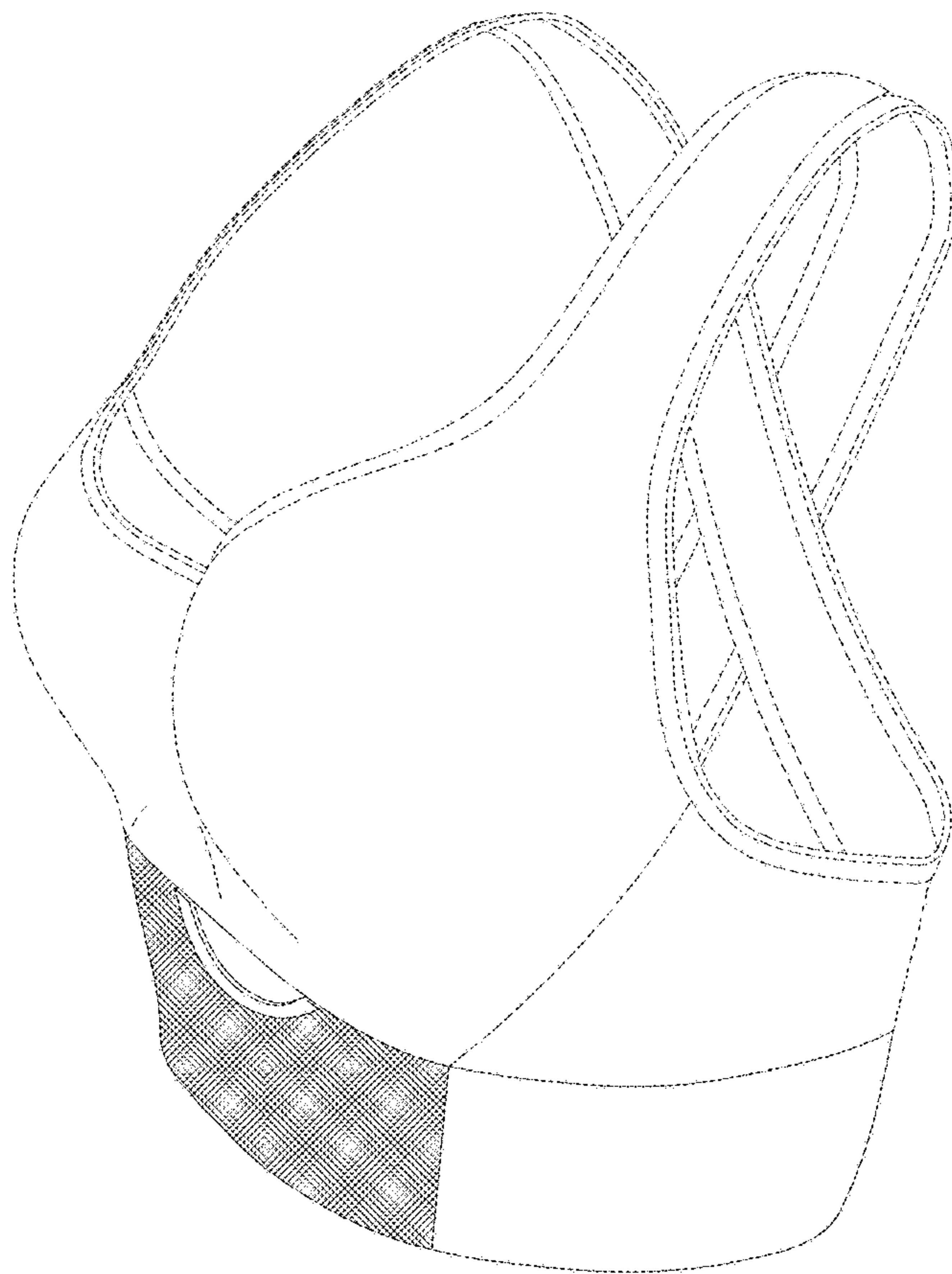

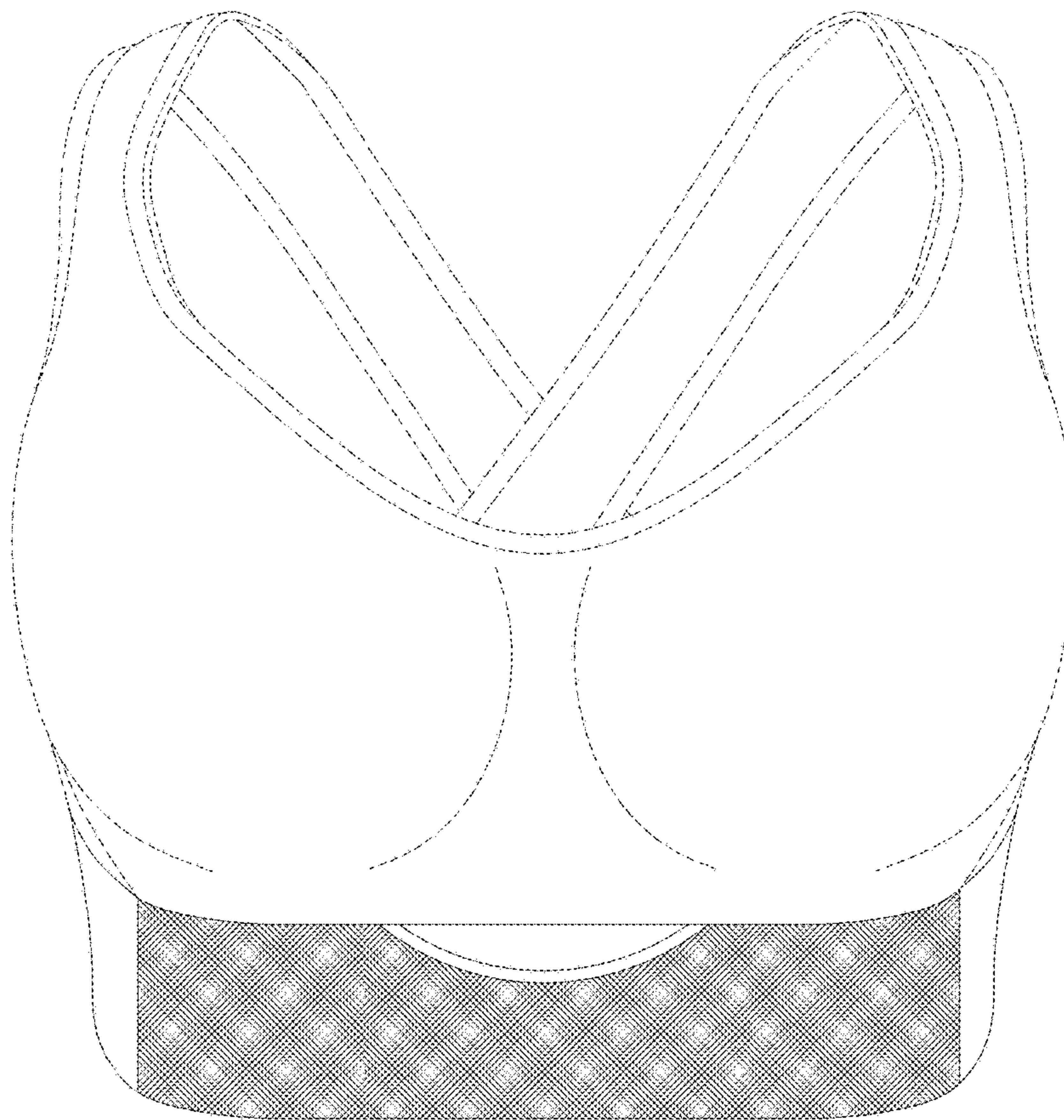

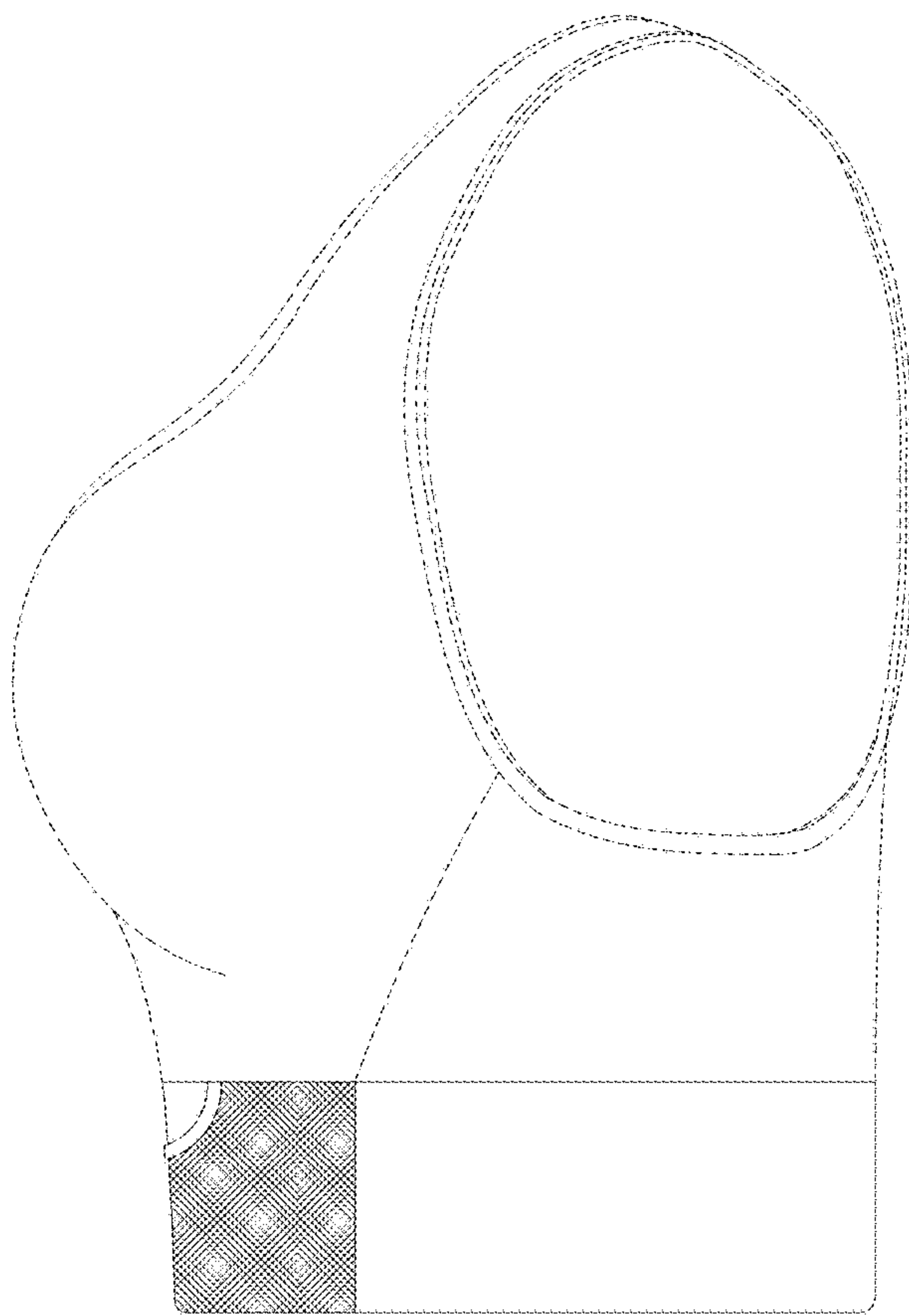

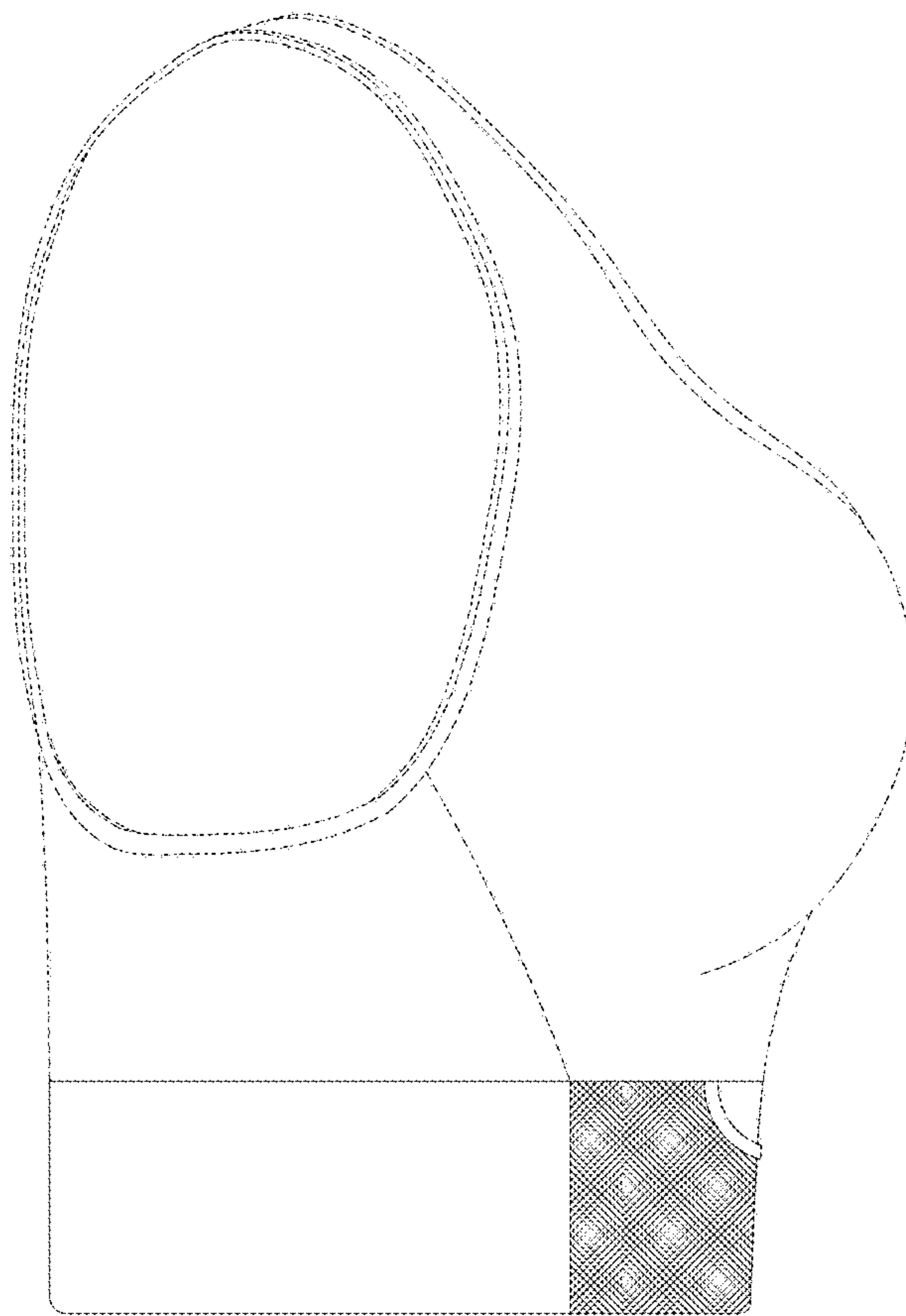

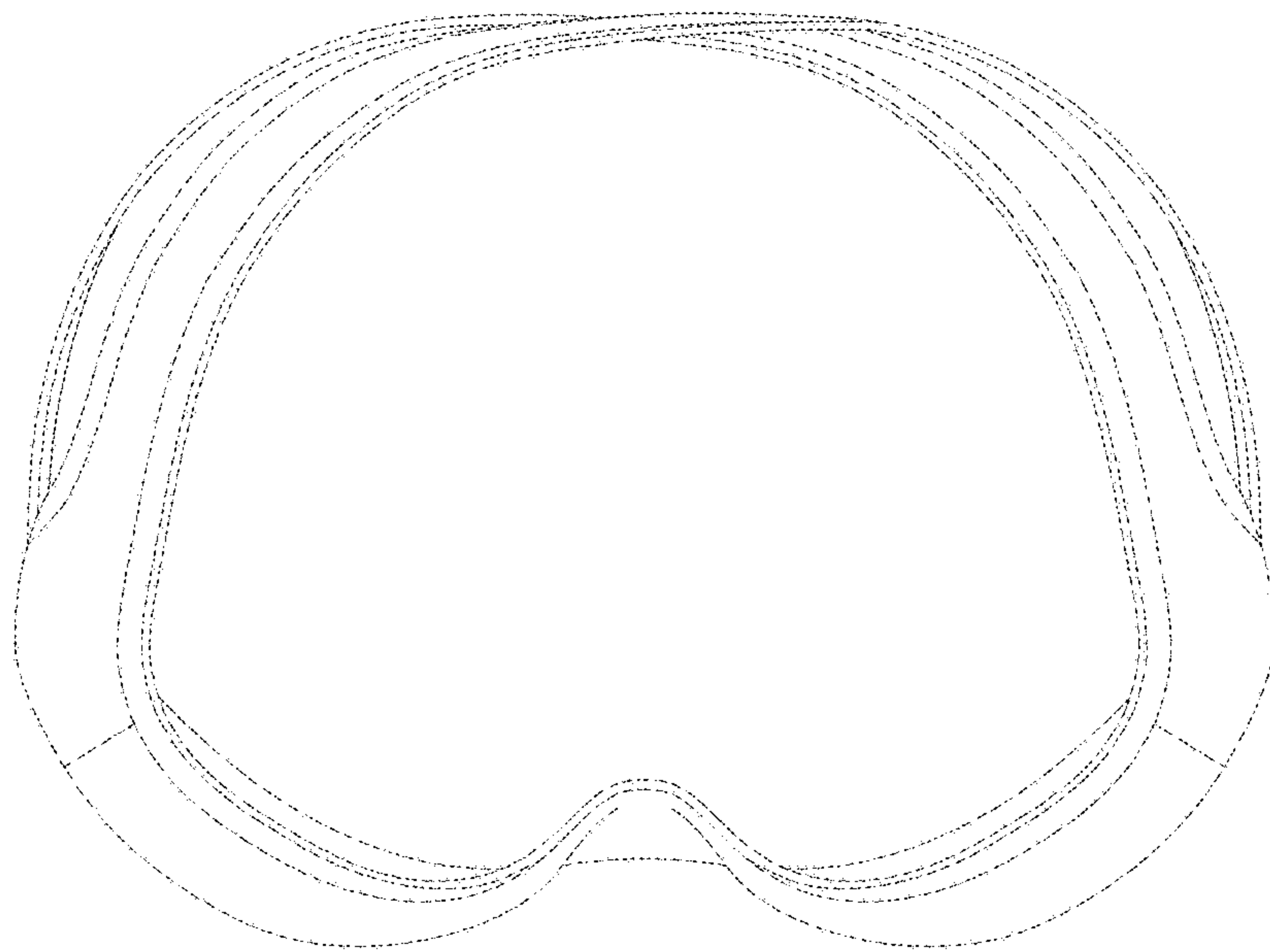

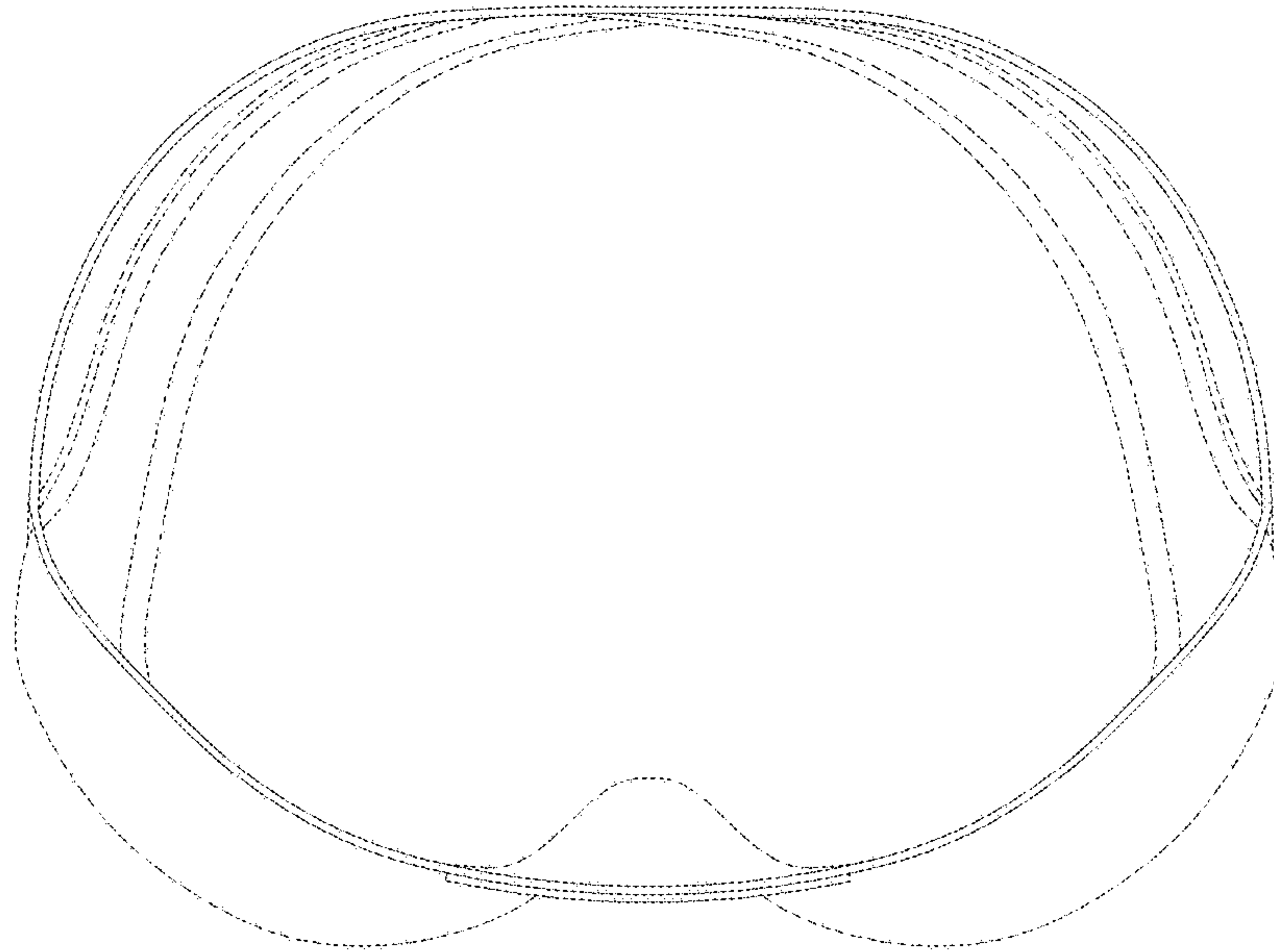
