The ornamental design for a clutch bag, as shown and described.

**DESCRIPTION**

1. Clutch bag

FIG. 1.1 is a perspective view of a clutch bag of the claimed design;

FIG. 1.2 is a front elevational view of the clutch bag shown in FIG. 1.1;

FIG. 1.3 is a back elevational view of the clutch bag shown in FIG. 1.1;

FIG. 1.4 is a right elevational view of the clutch bag shown in FIG. 1.1;

FIG. 1.5 is a left elevational view of the clutch bag shown in FIG. 1.1;

FIG. 1.6 is a top plan view of the clutch bag shown in FIG. 1.1;

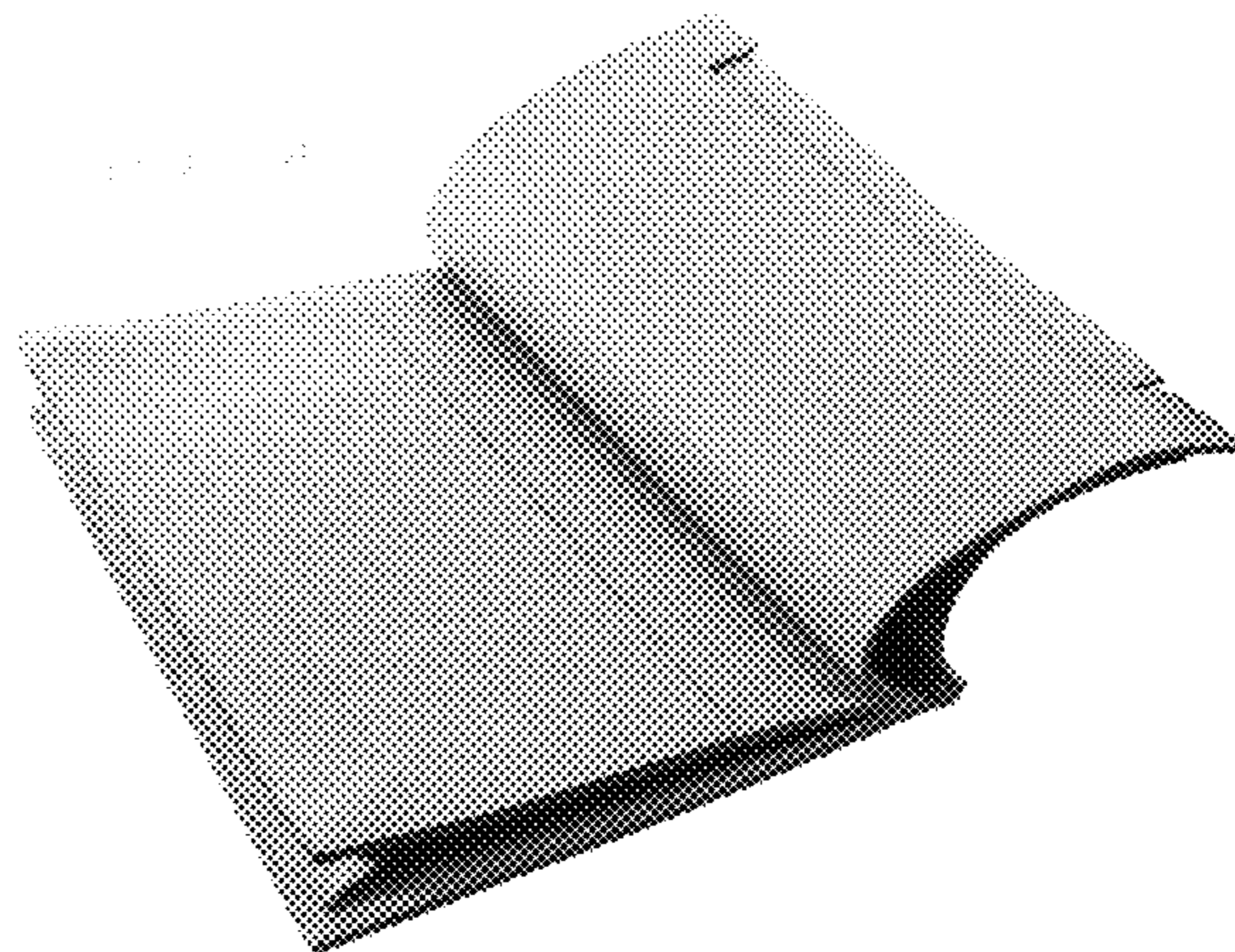
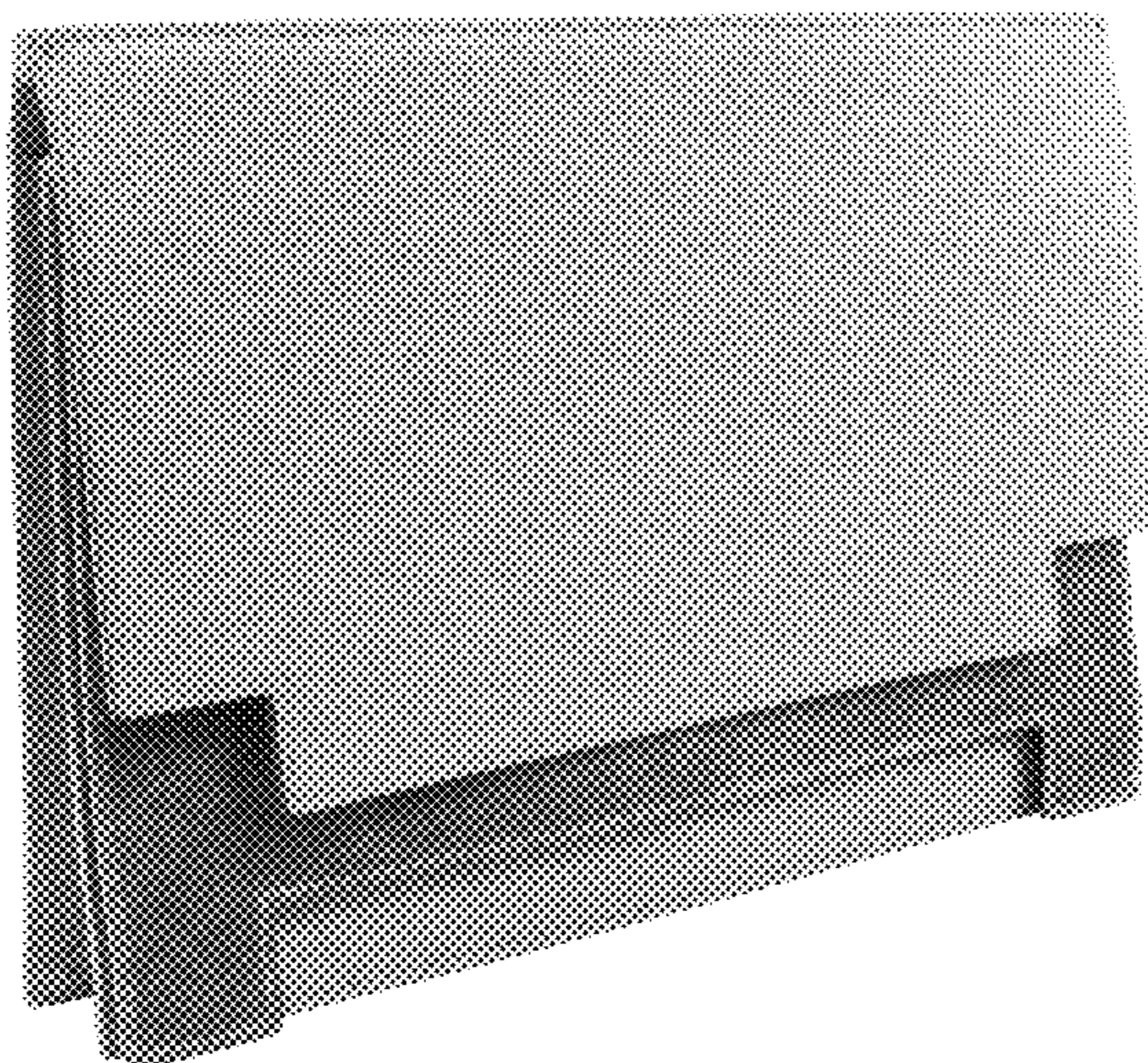
FIG. 1.7 is a bottom plan view of the clutch bag shown in FIG. 1.1;

FIG. 1.8 is an unfolded, perspective view of the clutch bag shown in FIG. 1.1 in an alternate configuration; and

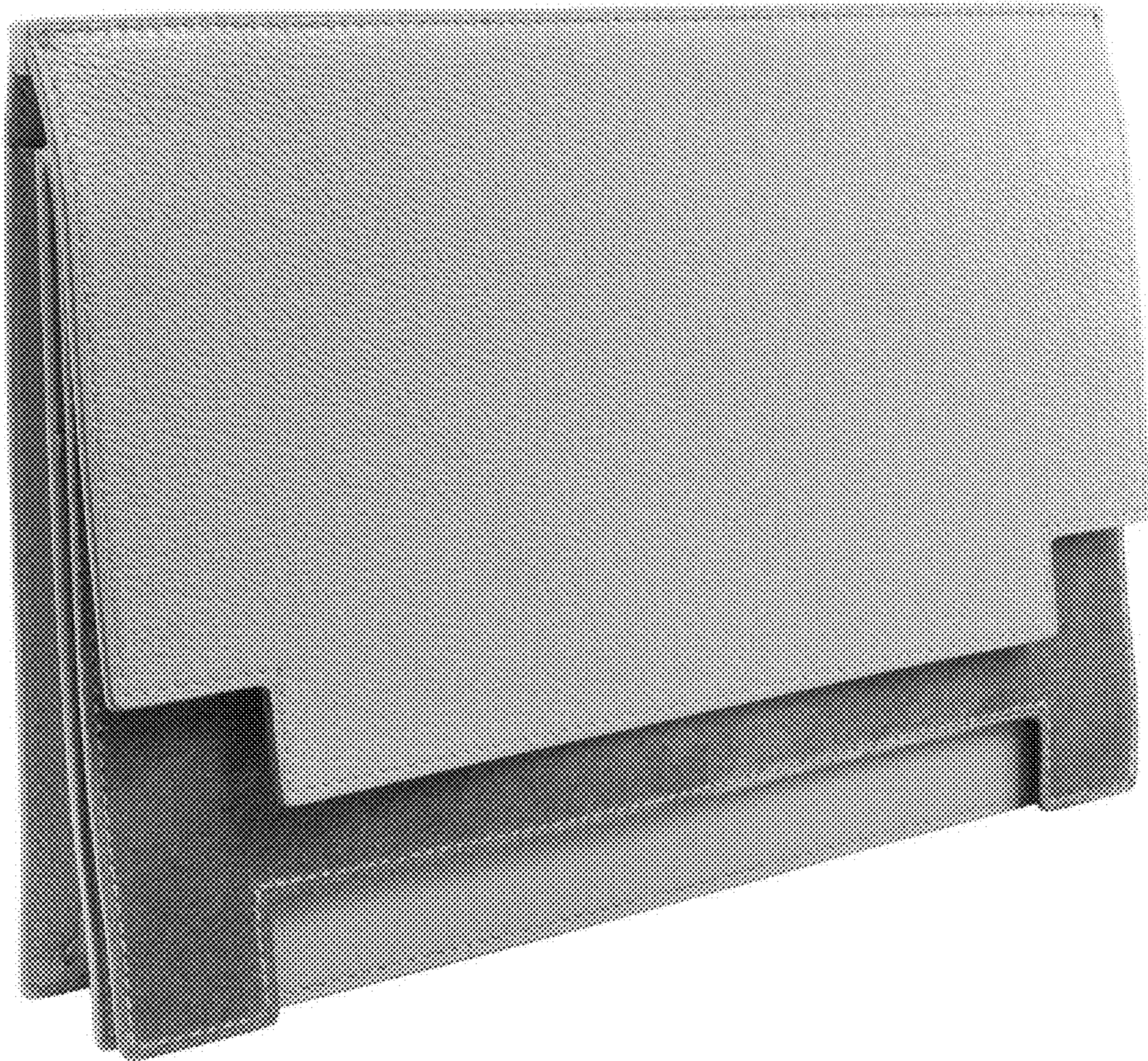
FIG. 1.9 is an unfolded, perspective view of the clutch bag shown in FIG. 1.1 in an alternate configuration.

The claimed design is shown in the figures by solid lines as well as by broken lines that represent stitching.

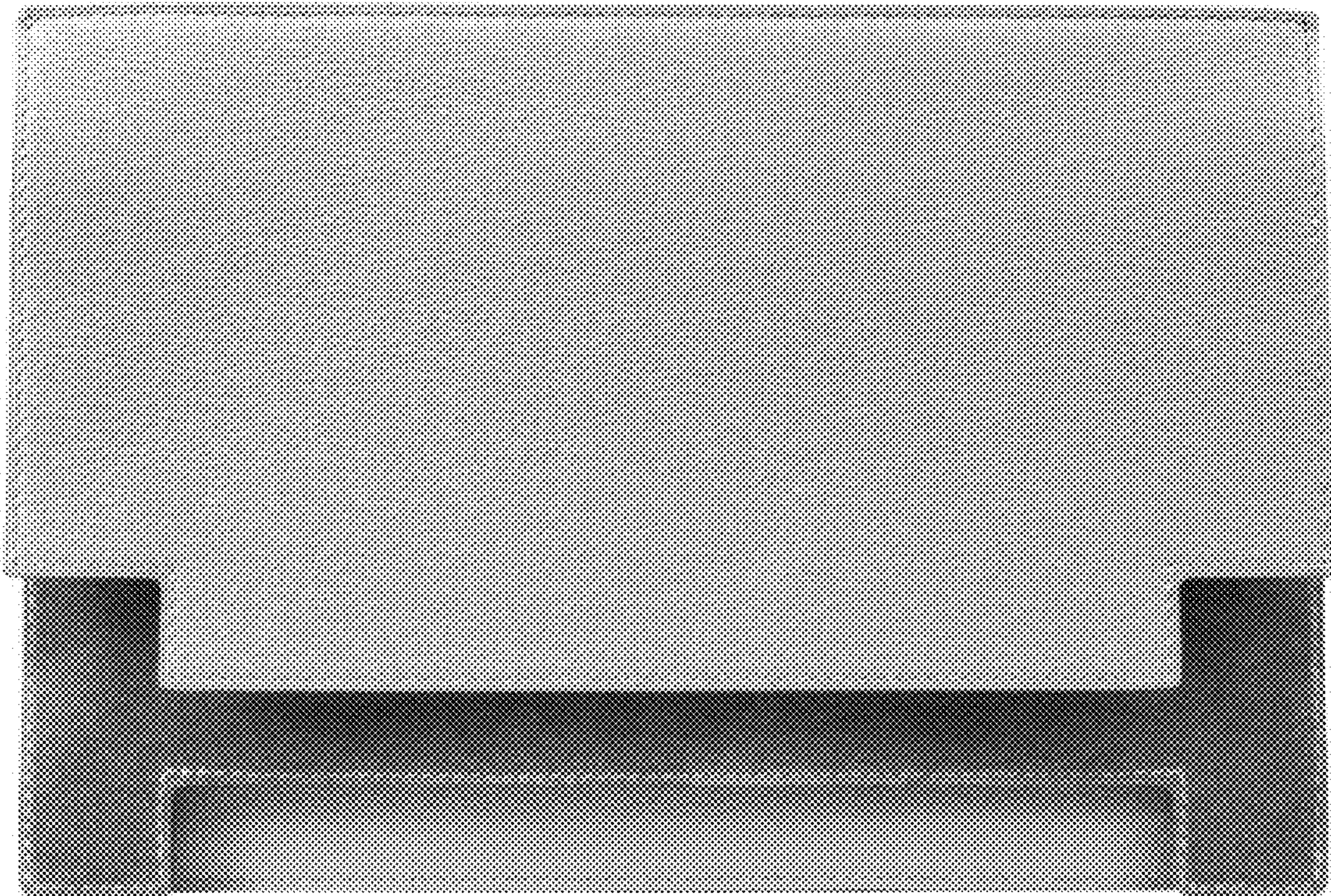

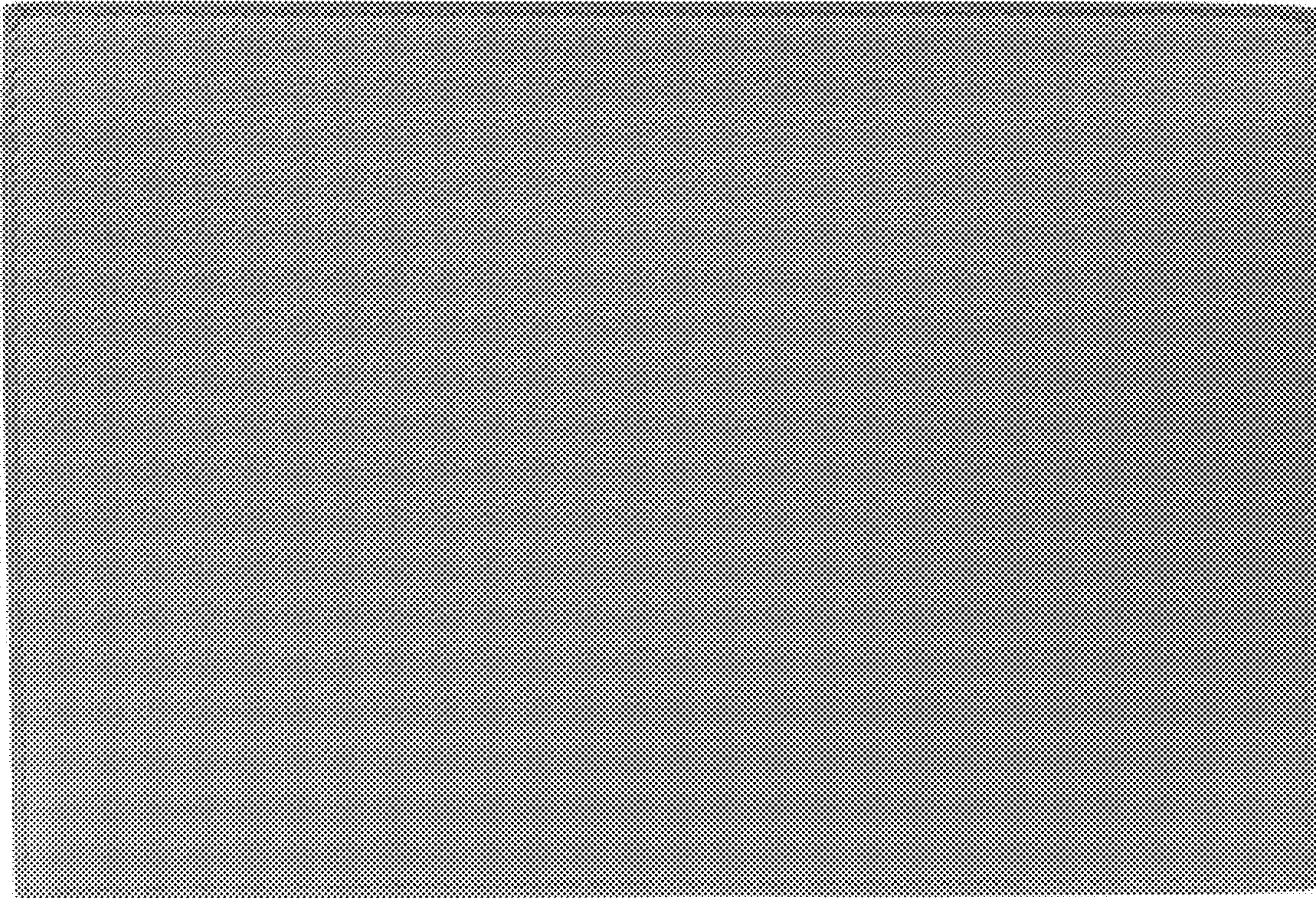

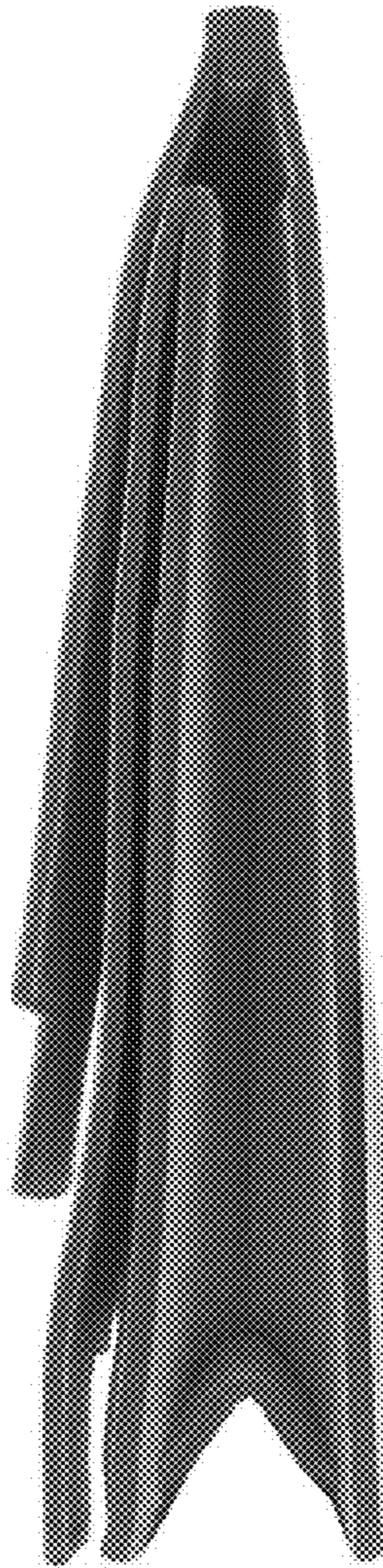

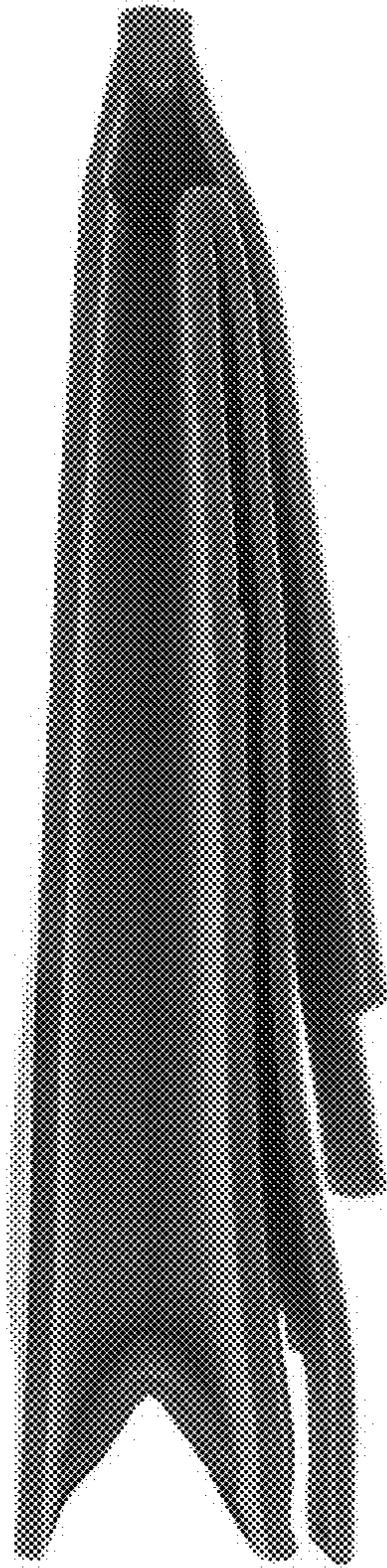

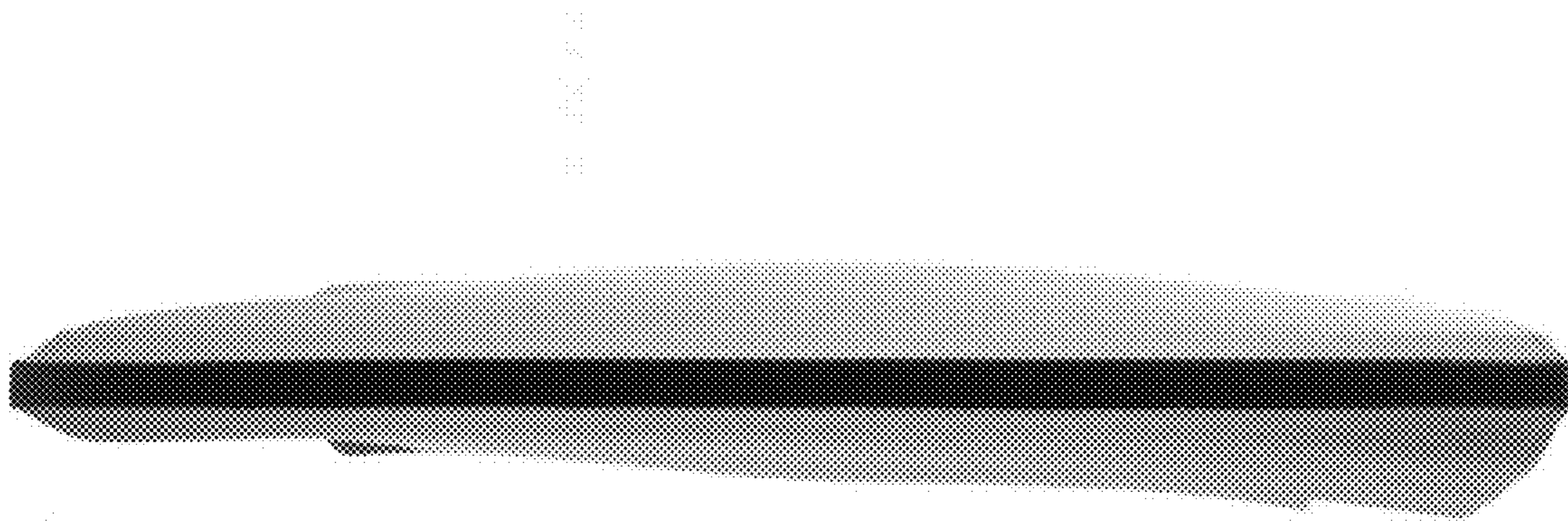

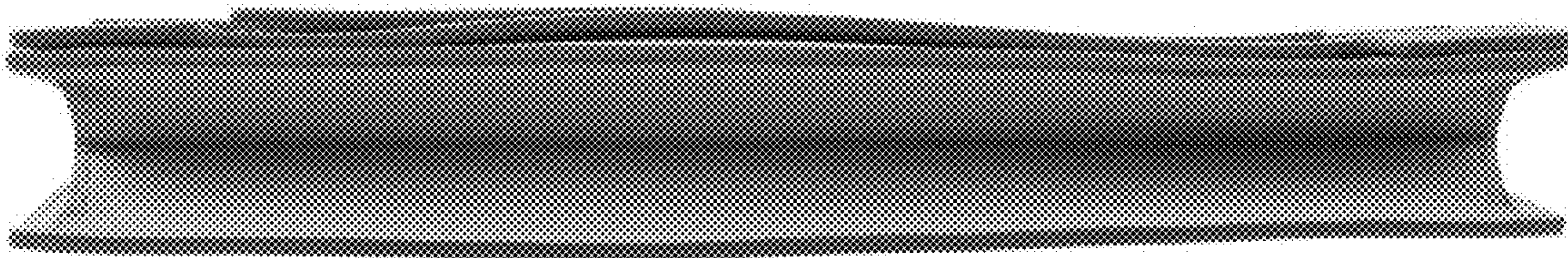
