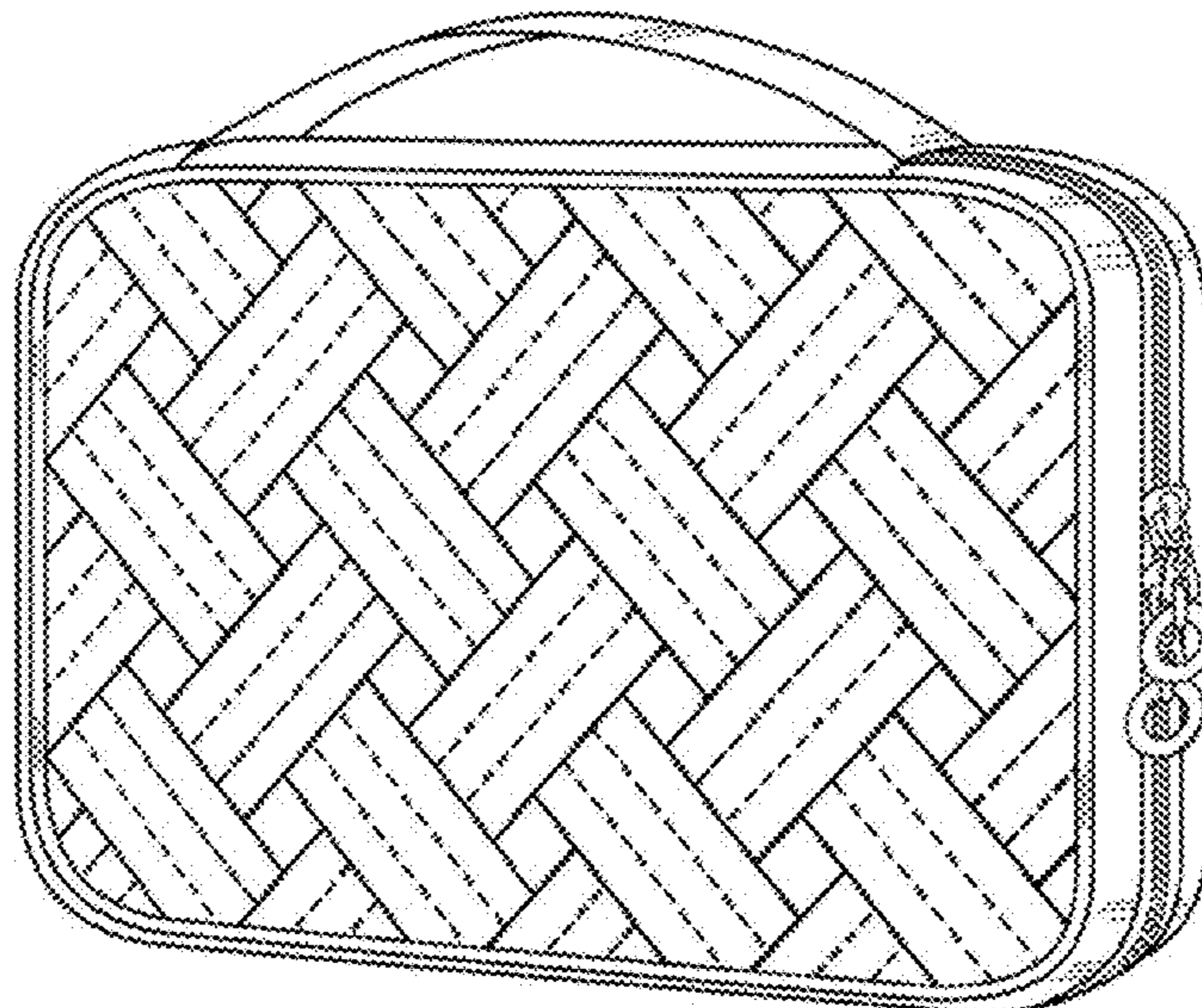
(57) **CLAIM**

The ornamental design for a jewelry bag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a jewelry bag showing the claimed design;
FIG. 2 is another front perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof;

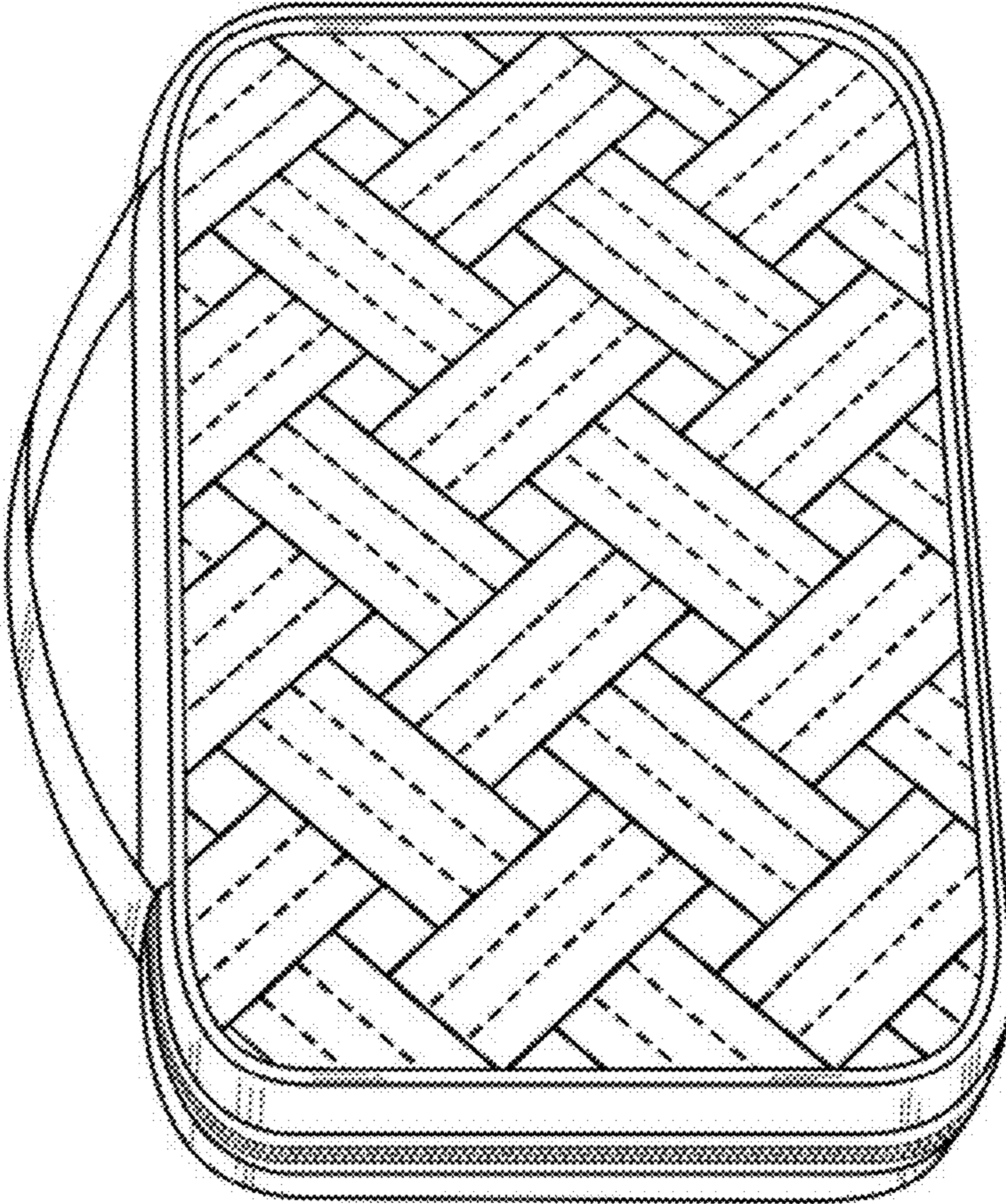

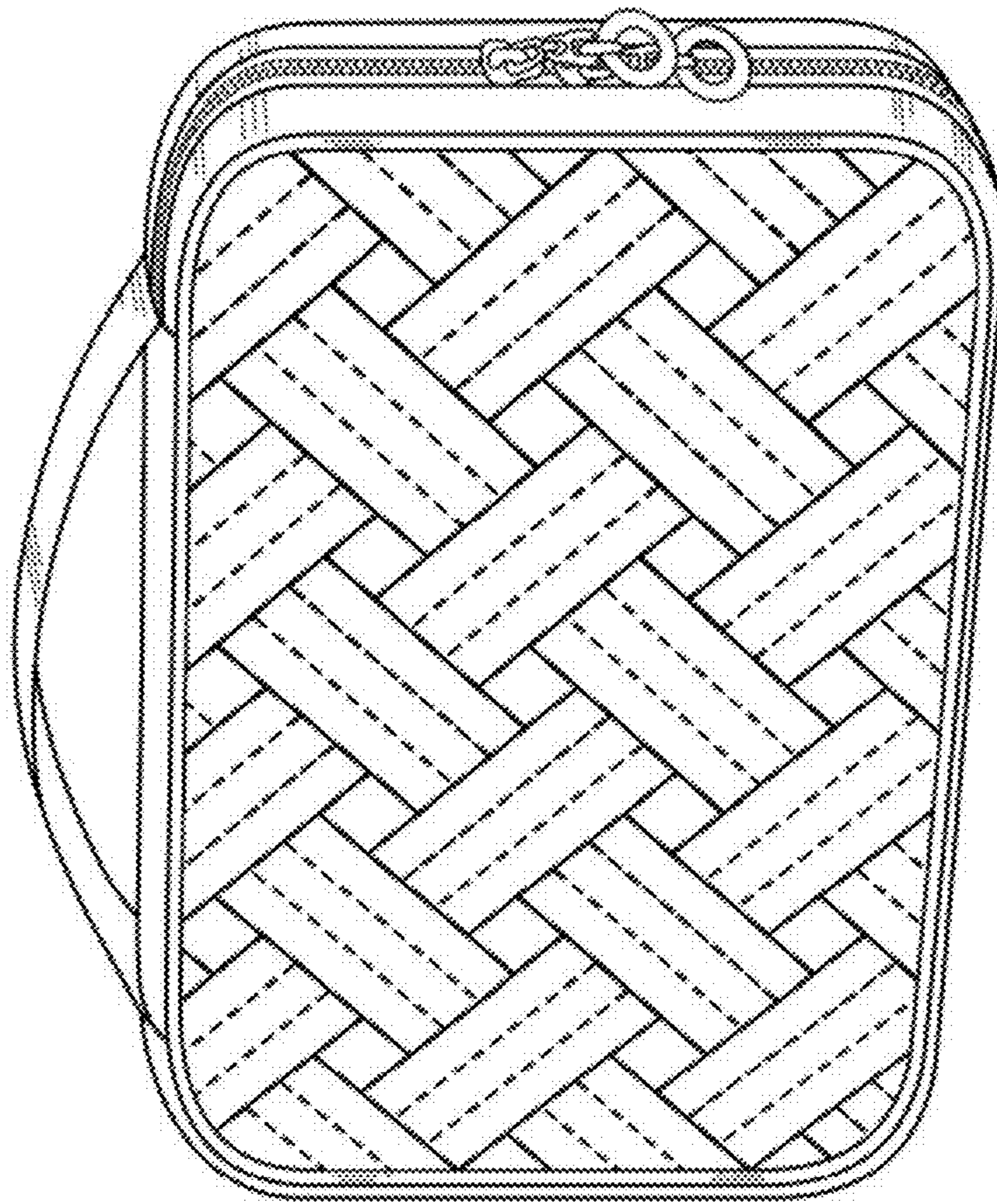

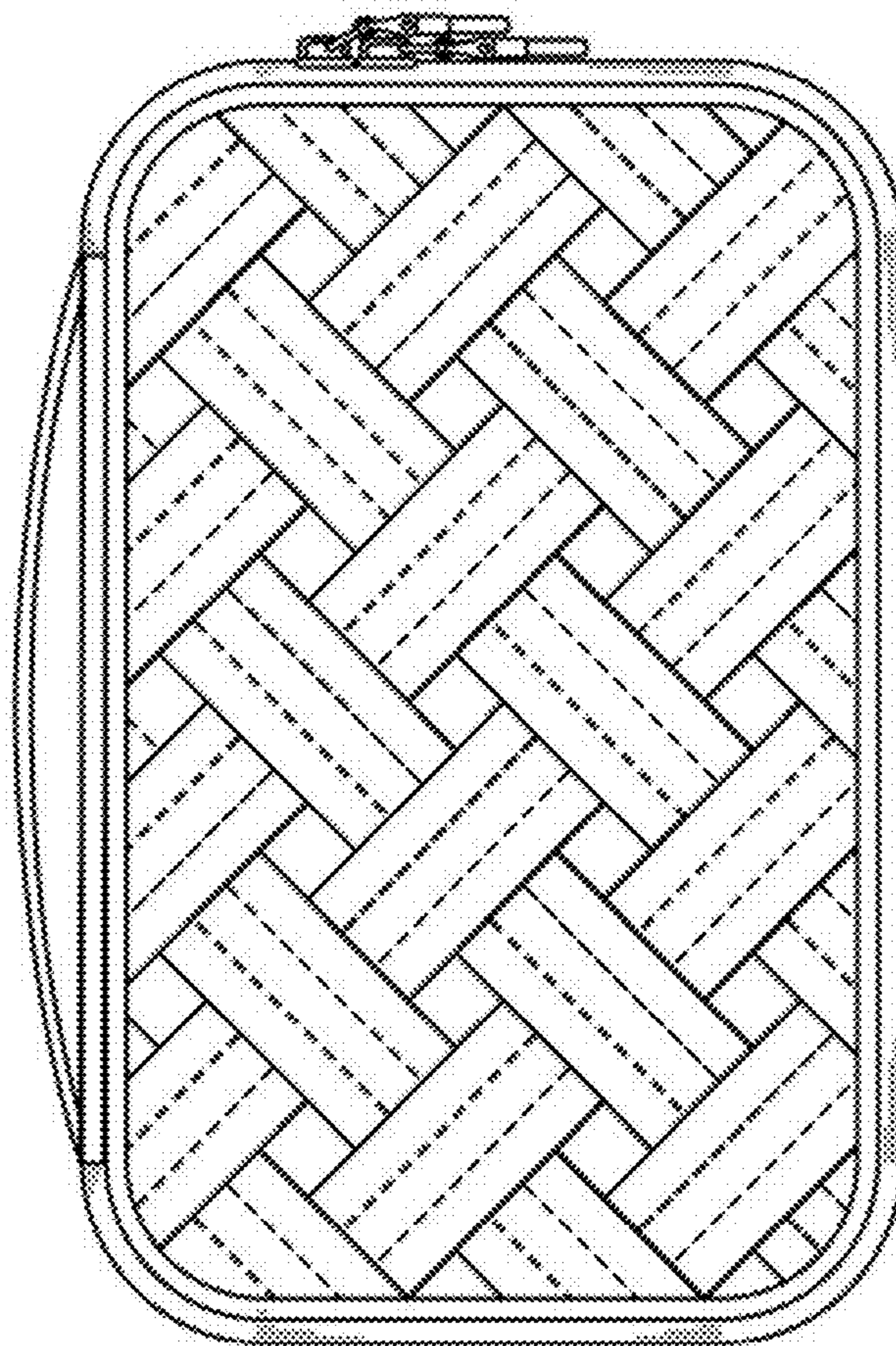

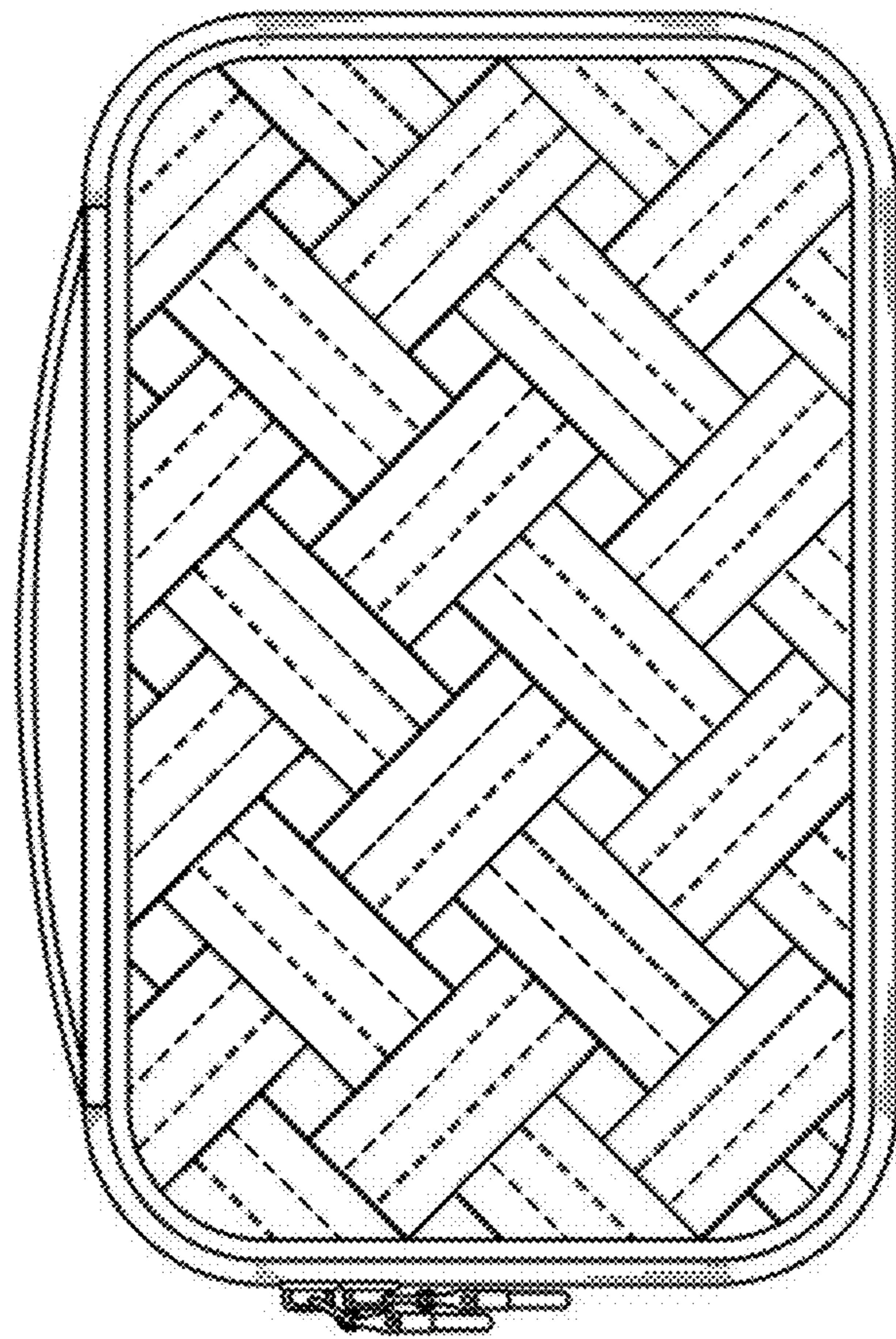

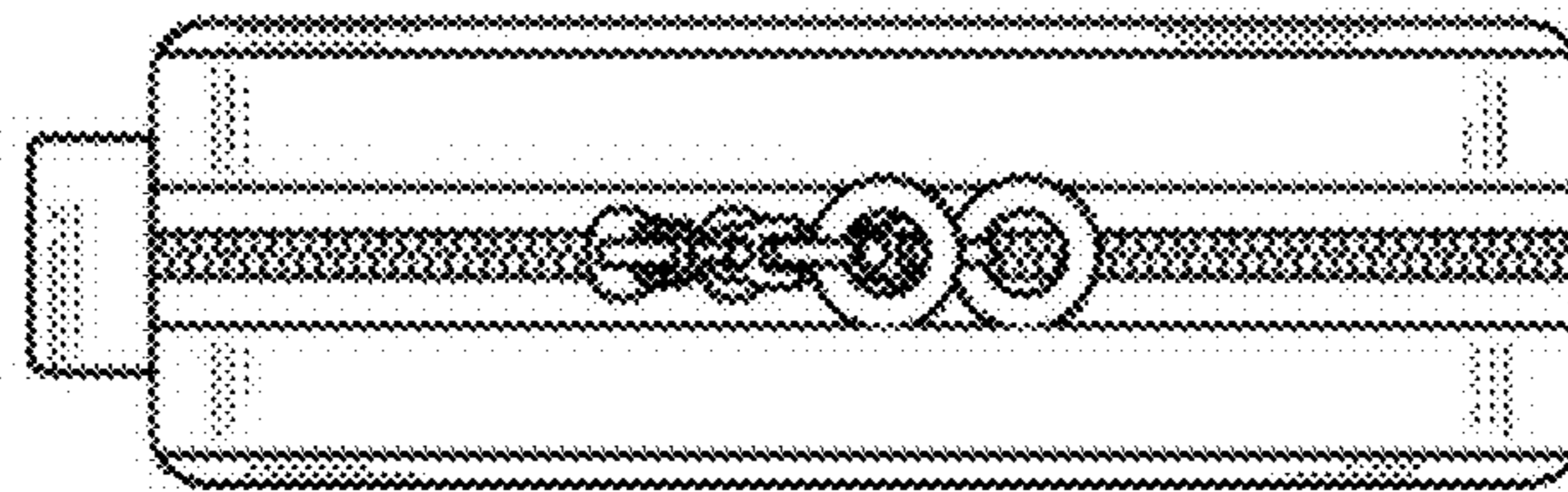

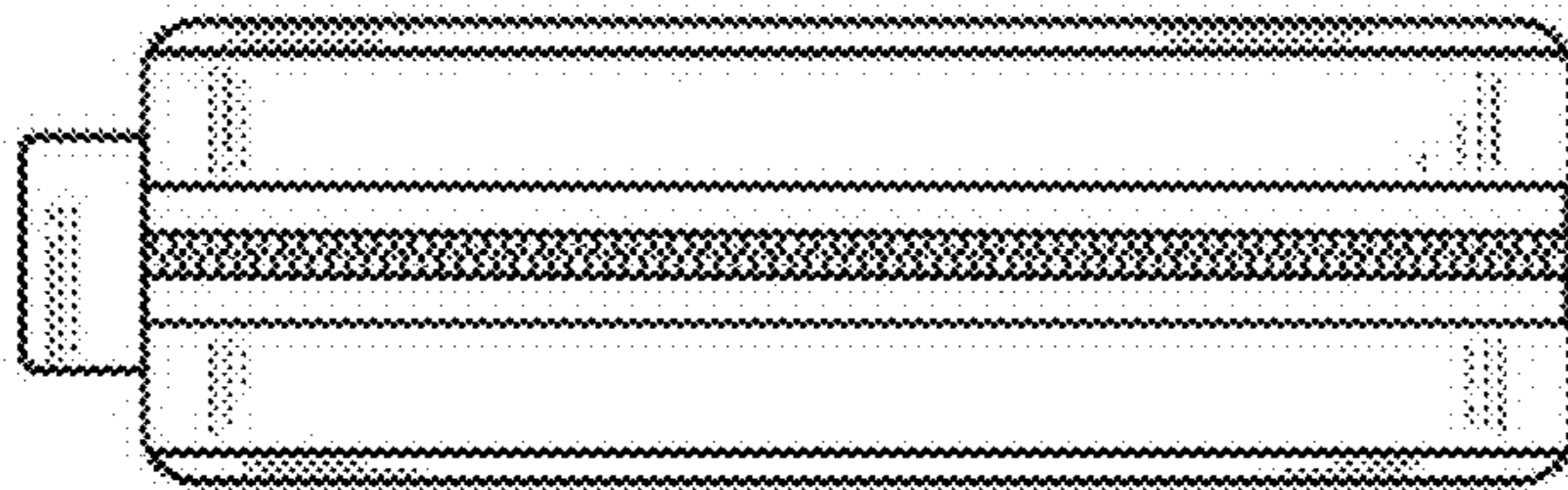

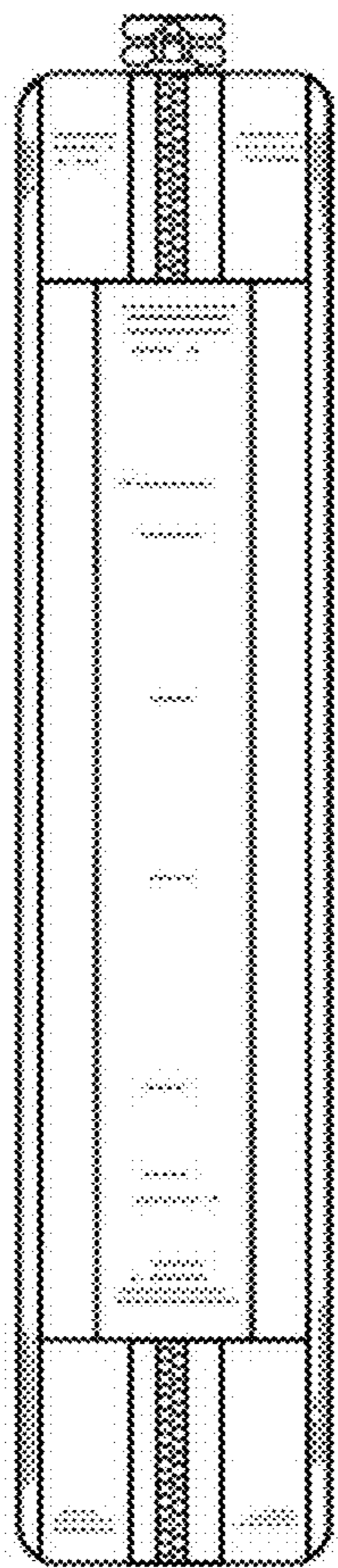

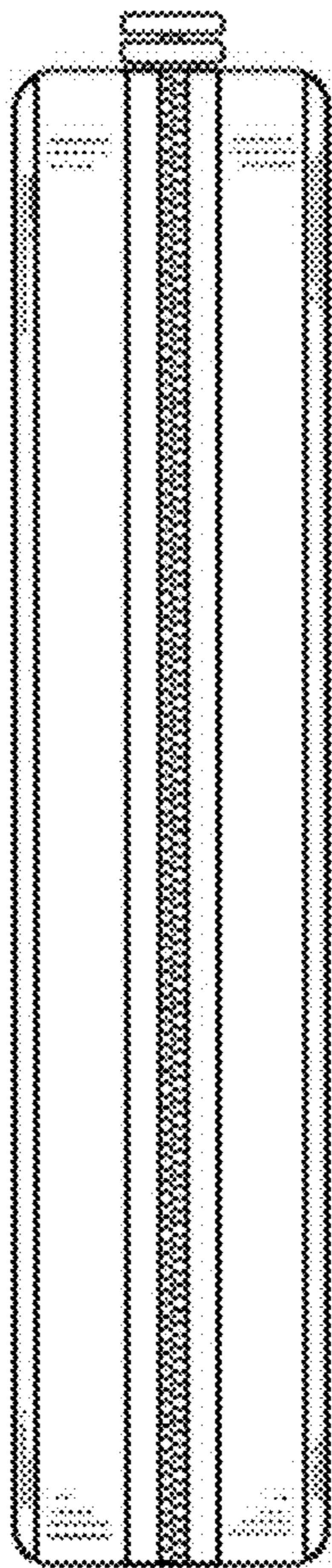
