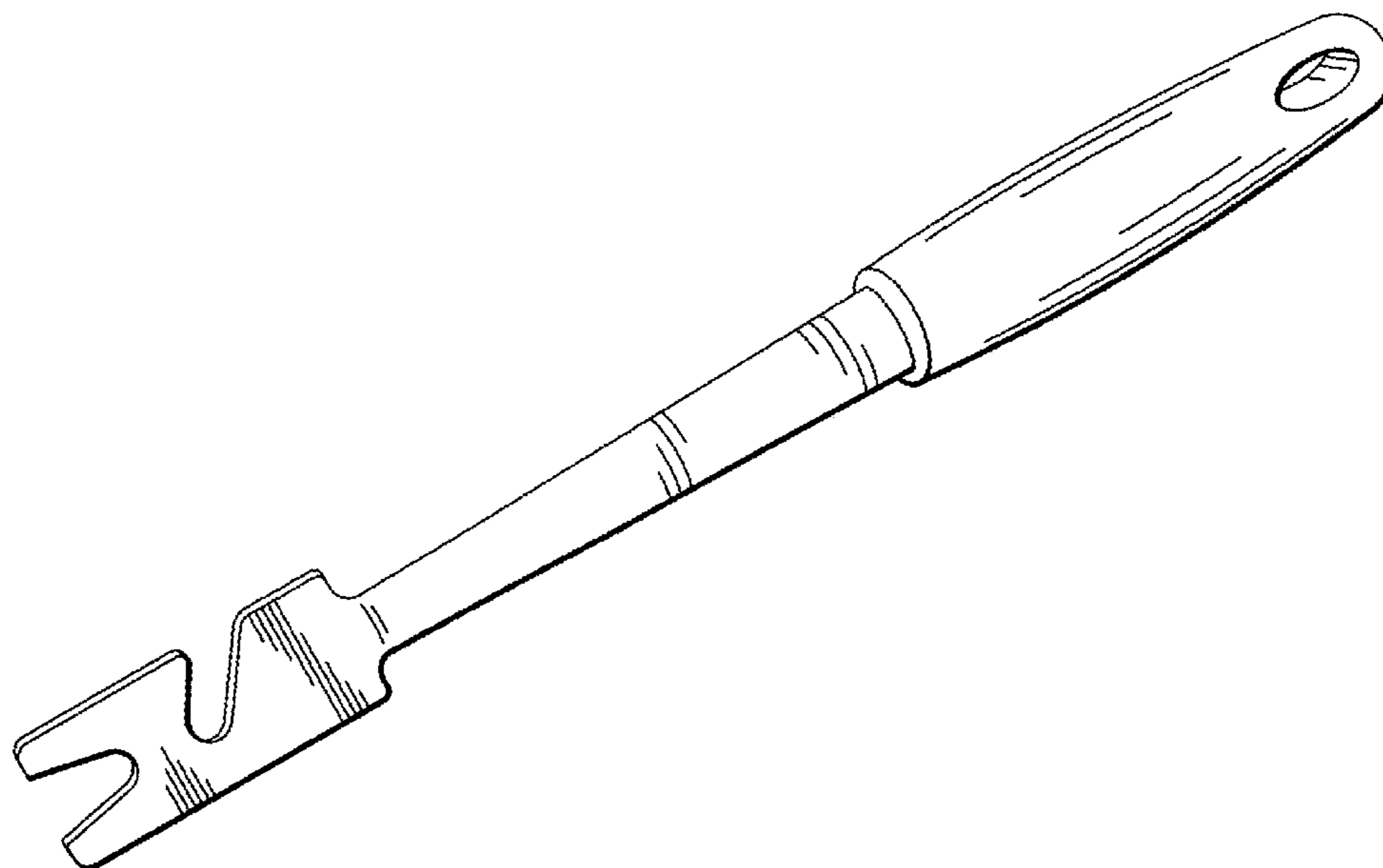
(57) **CLAIM**

The ornamental design for an oven rack sliding in-and-out tool.

**DESCRIPTION**

FIG. 1 is a perspective view of an oven rack sliding in-and-out tool showing my new design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a right side elevation view of FIG. 1  
 FIG. 4 is a front end view of the left end of FIG. 1; and  
 FIG. 5 is a top plan view thereof;

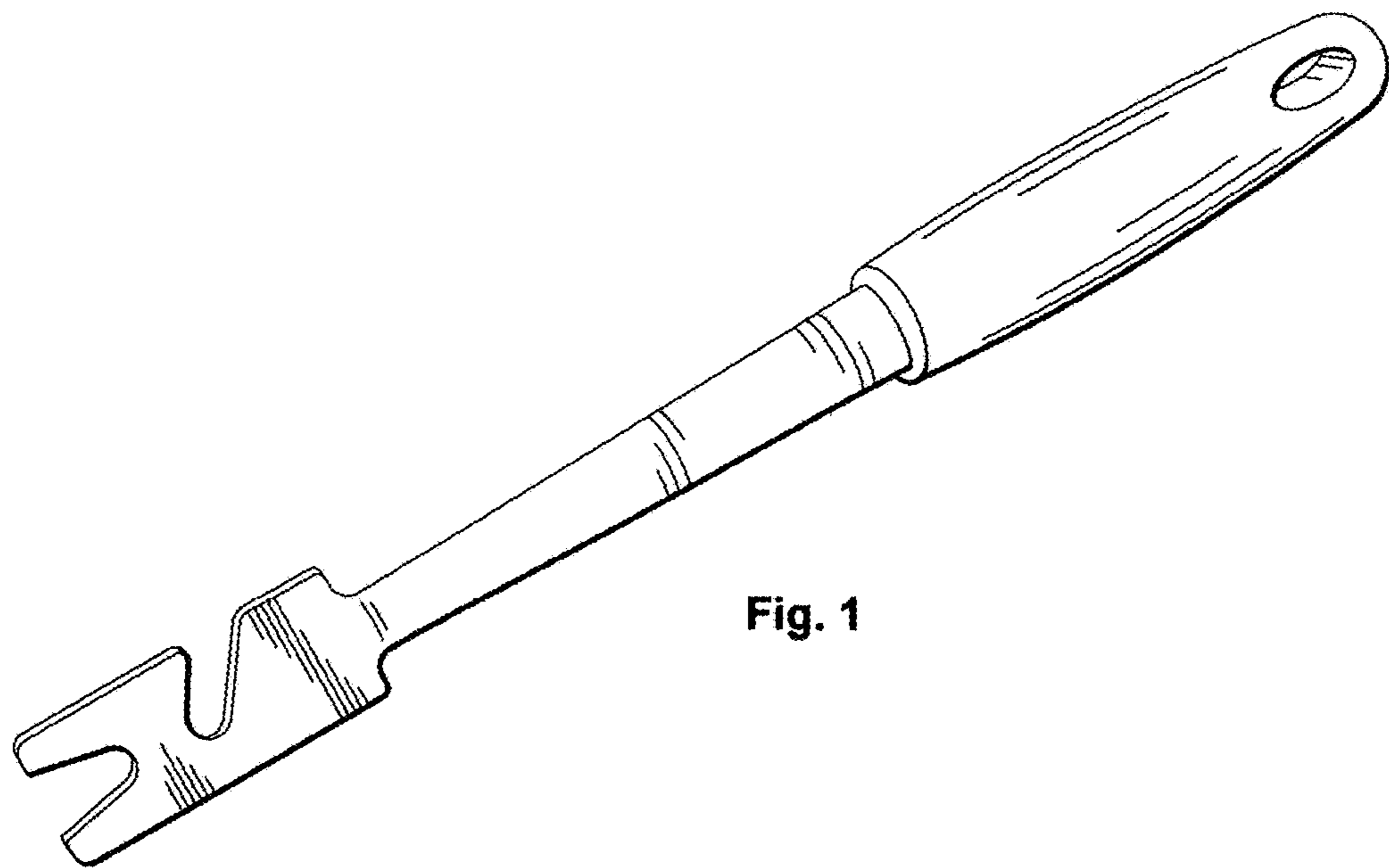

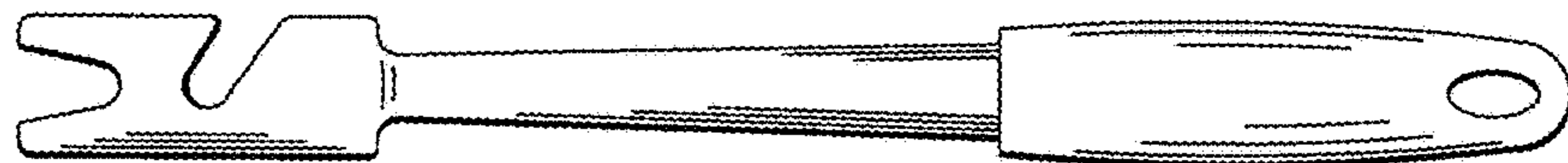

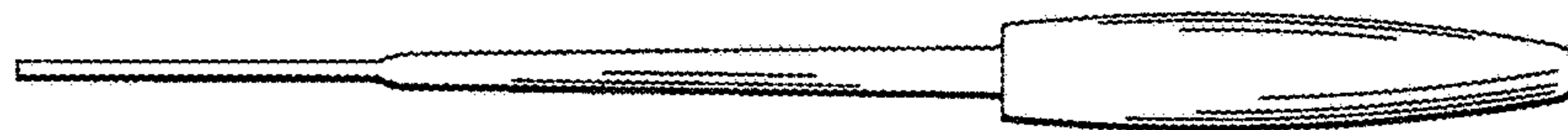

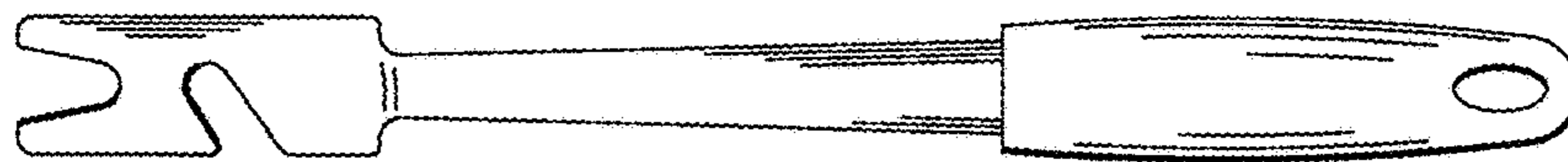
