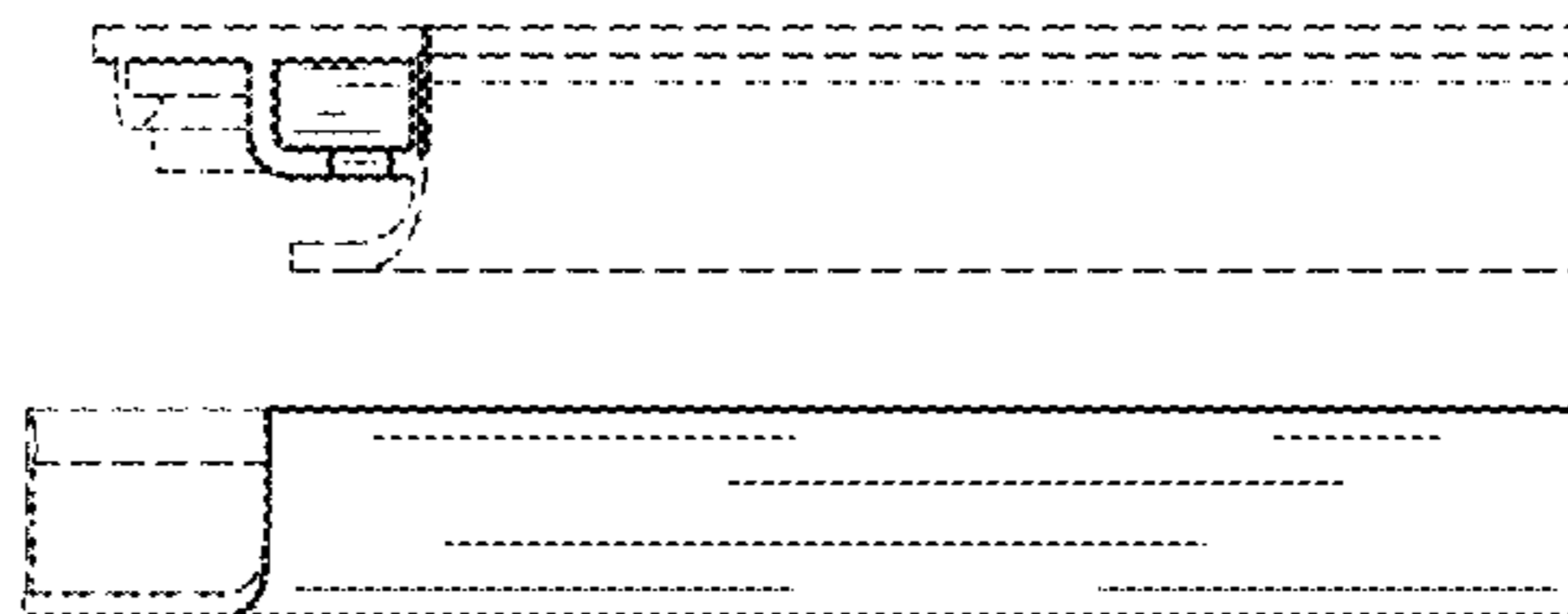
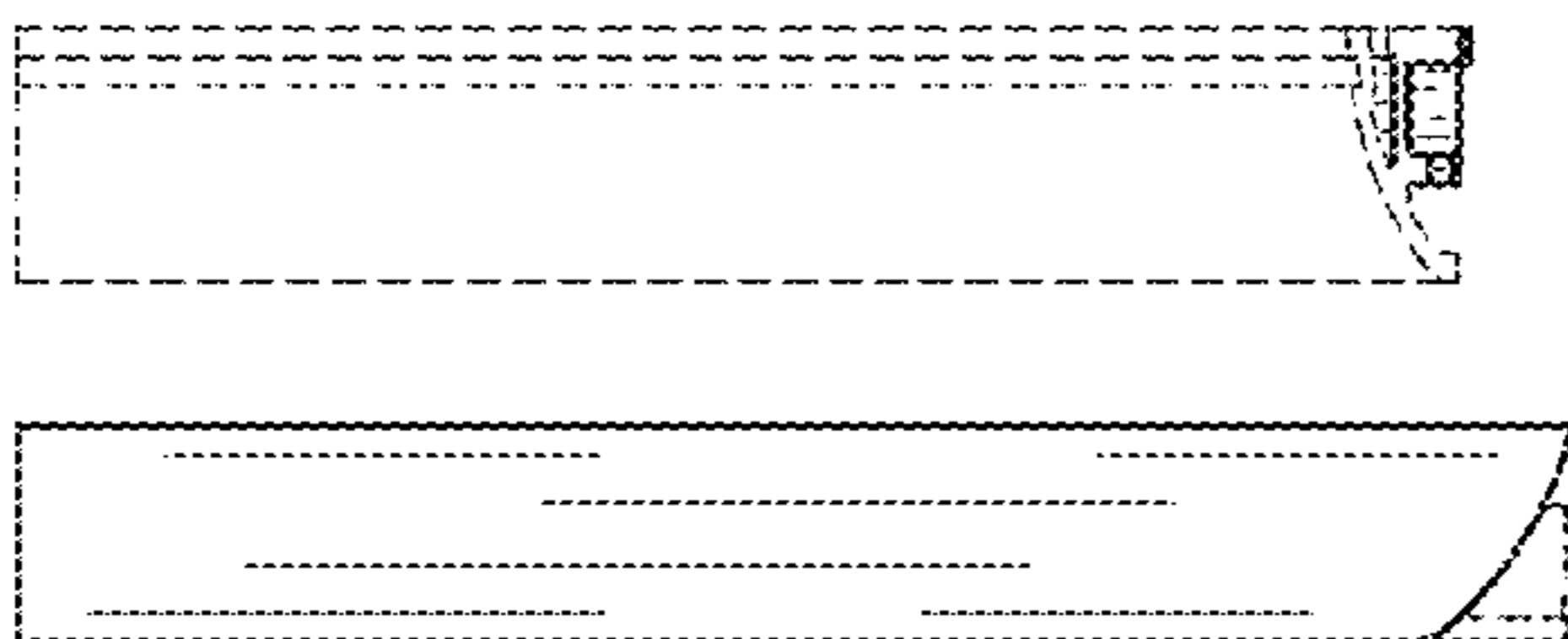
(57) **CLAIM**

The ornamental design for a cabinet toe kick assembly, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a cabinet toe kick assembly. FIG. 2 is a bottom plan view of the cabinet toe kick assembly of FIG. 1. FIG. 3 is a front elevation view of the cabinet toe kick assembly of FIG. 1. FIG. 4 is a back elevation view of the cabinet toe kick assembly of FIG. 1. FIG. 5 is a left side view of the cabinet toe kick assembly of FIG. 1. FIG. 6 is a right side view of the cabinet toe kick assembly of FIG. 1. FIG. 7 is an isometric view of the cabinet toe kick assembly of FIG. 1; and, FIG. 8 is another isometric view of the cabinet toe kick assembly of FIG. 1. Portions of FIGS. 1 through 8 are shown in broken lines illustrating portions of the article that form no part of the claimed design.

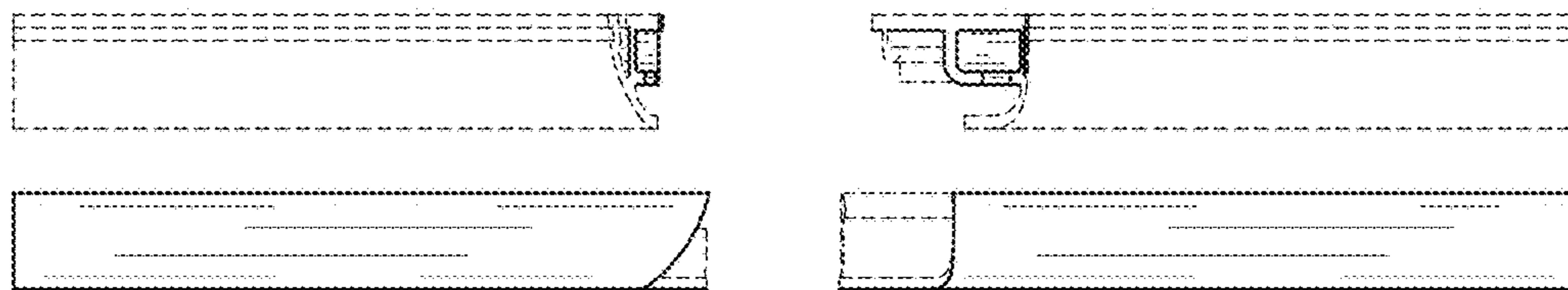

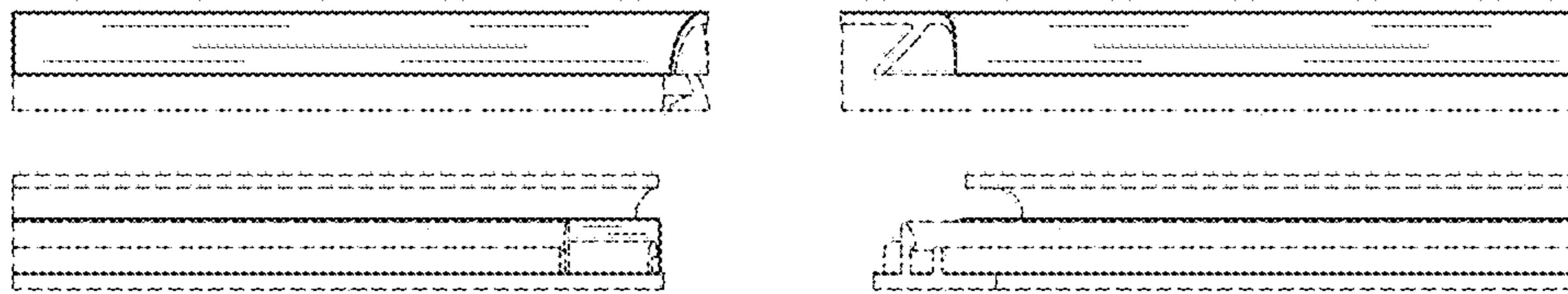

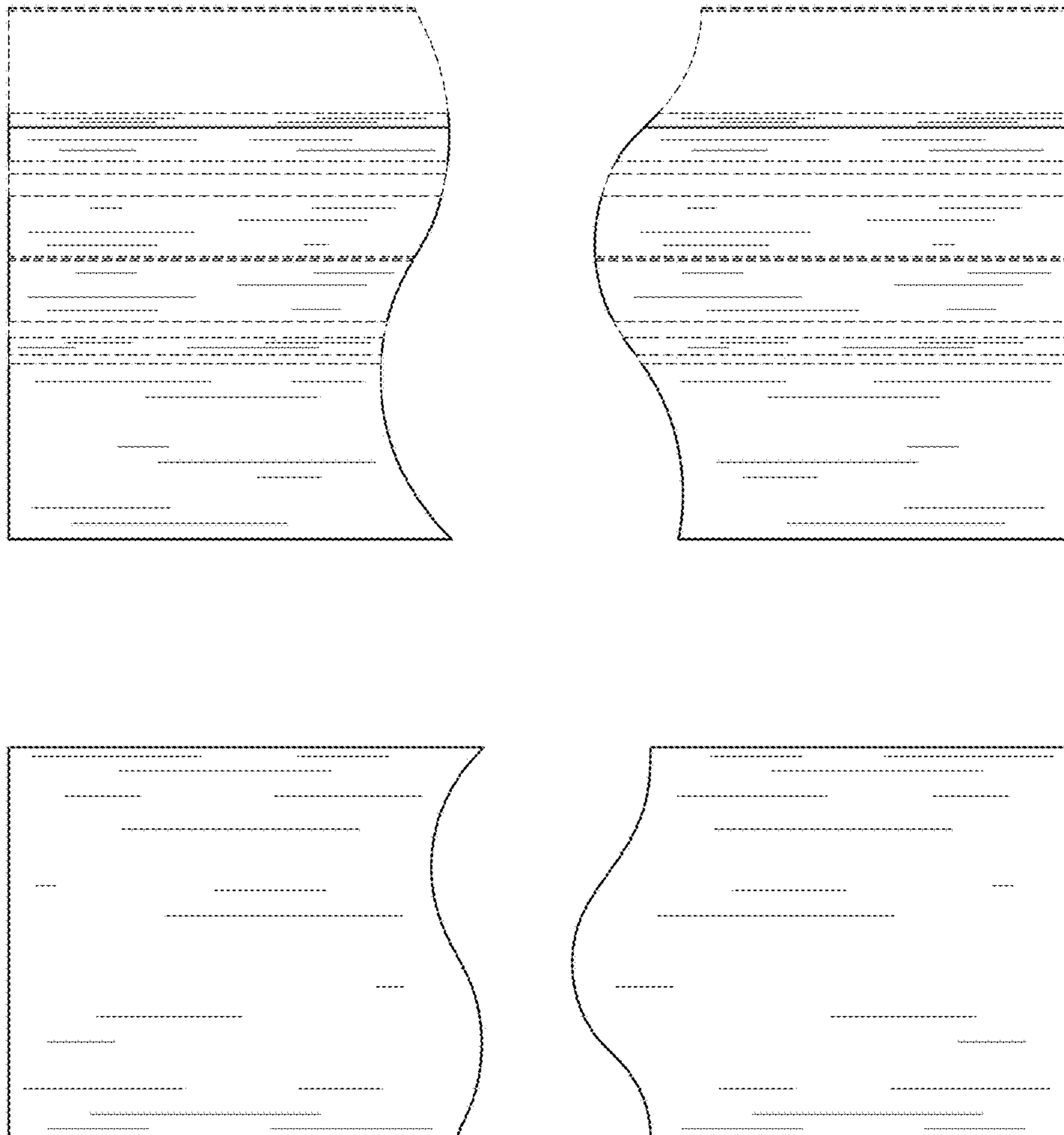

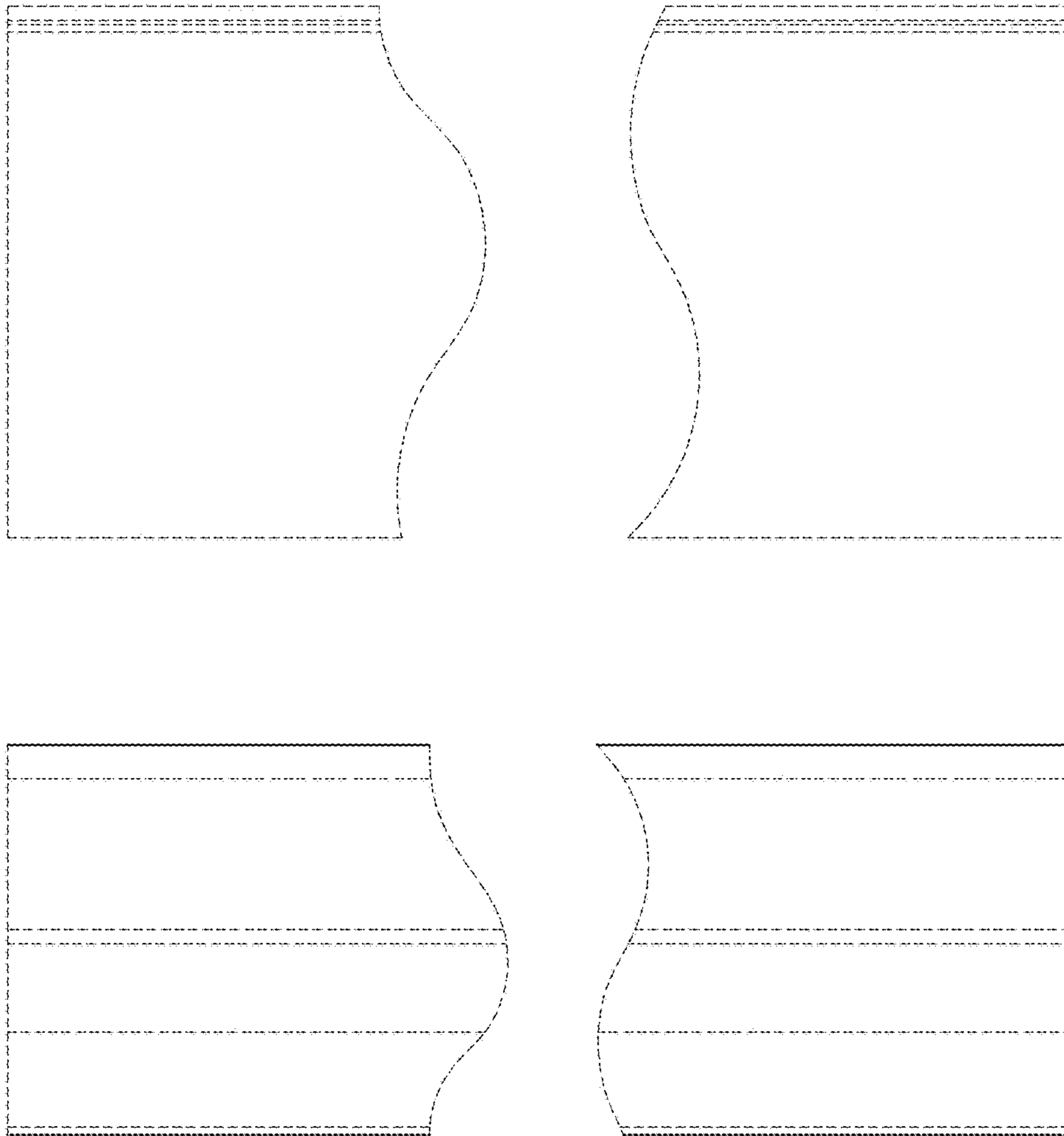

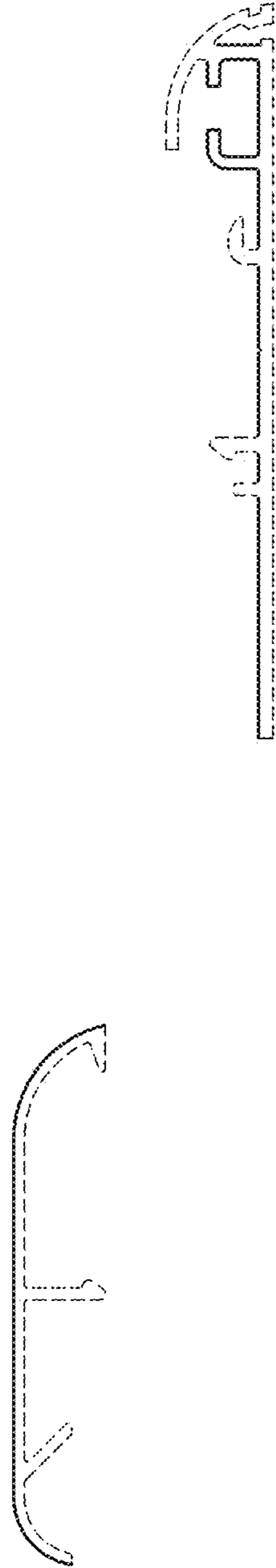

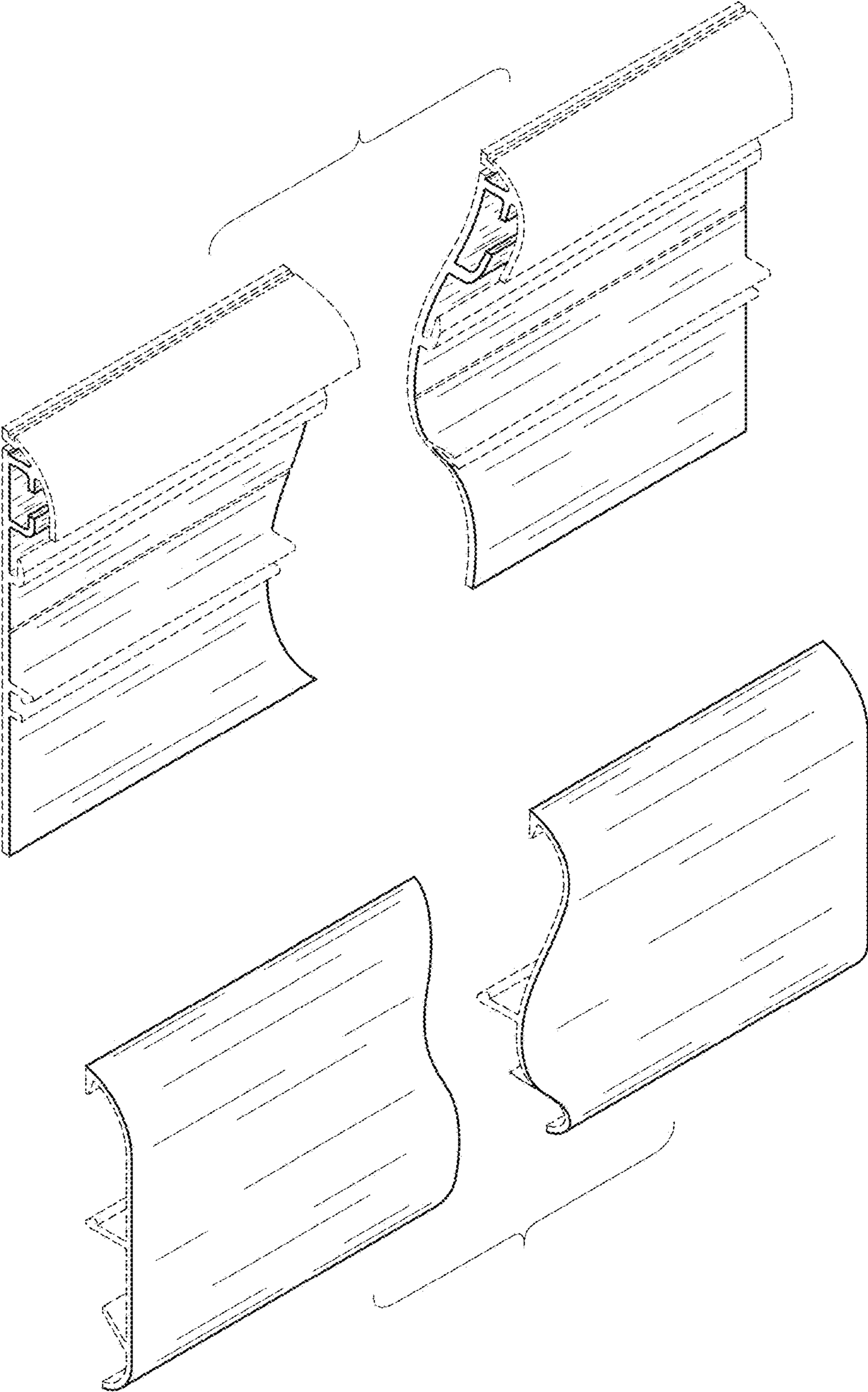

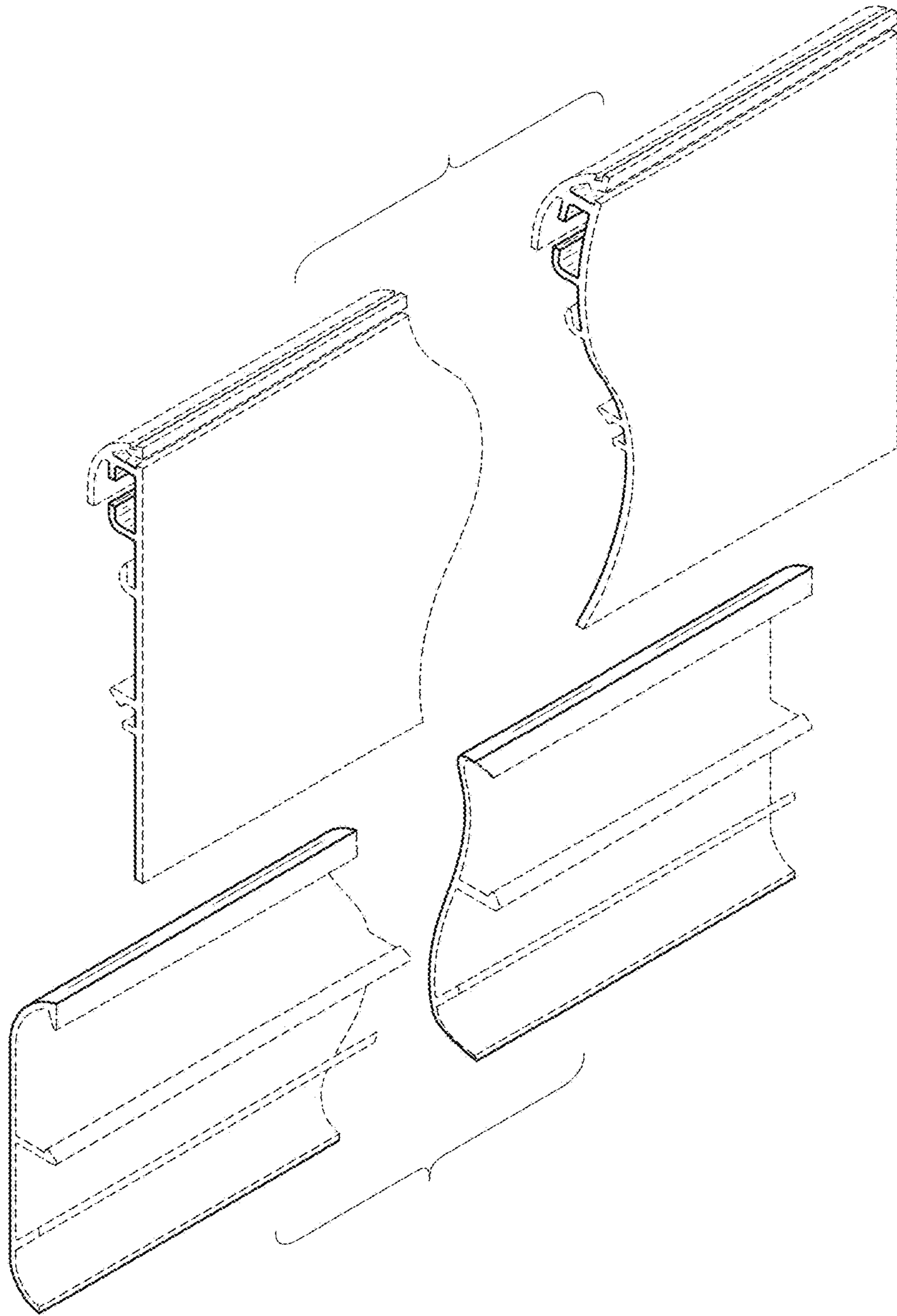
