(57) **CLAIM**

I claim, the ornamental design for a package wrapper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a package wrapper, showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

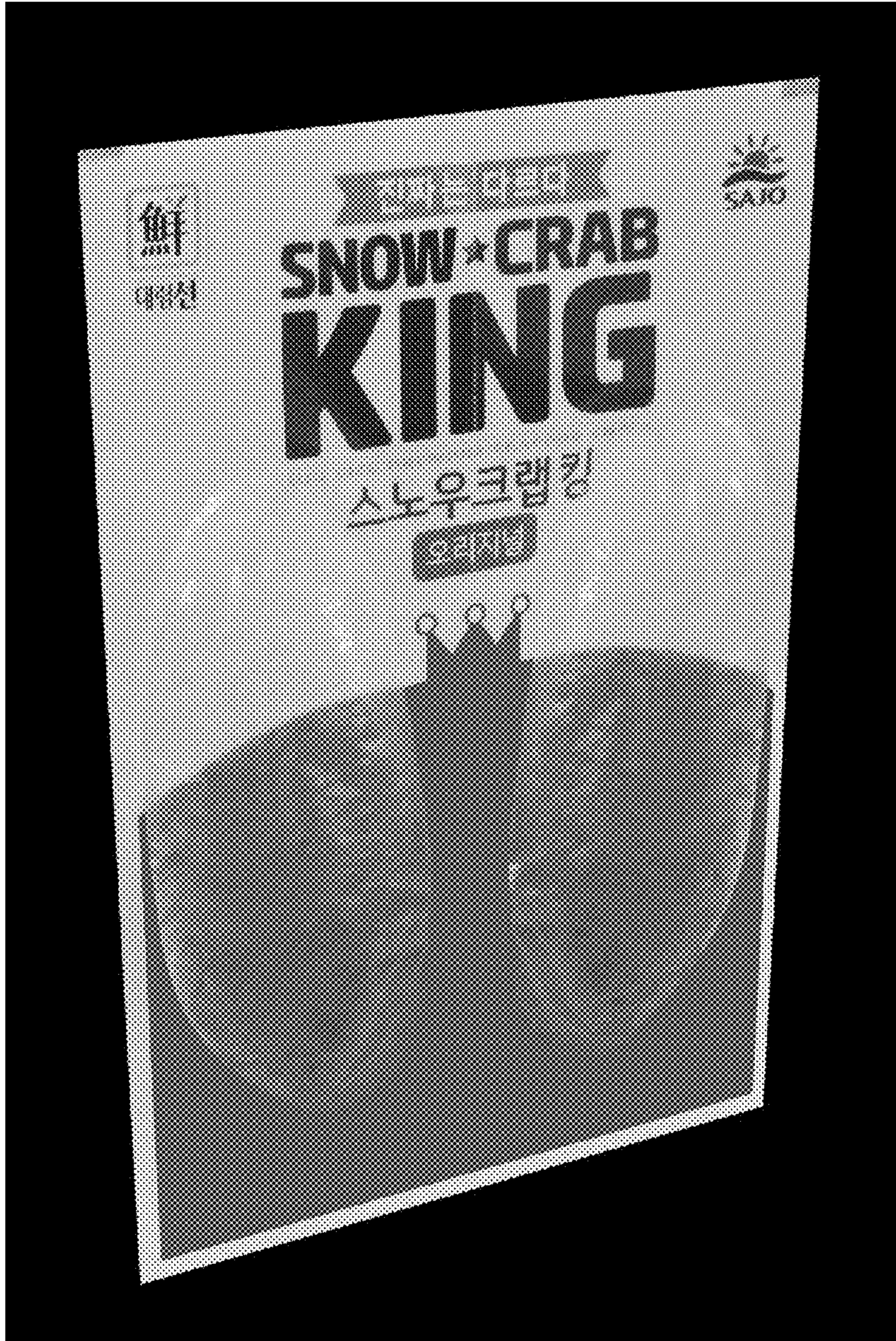

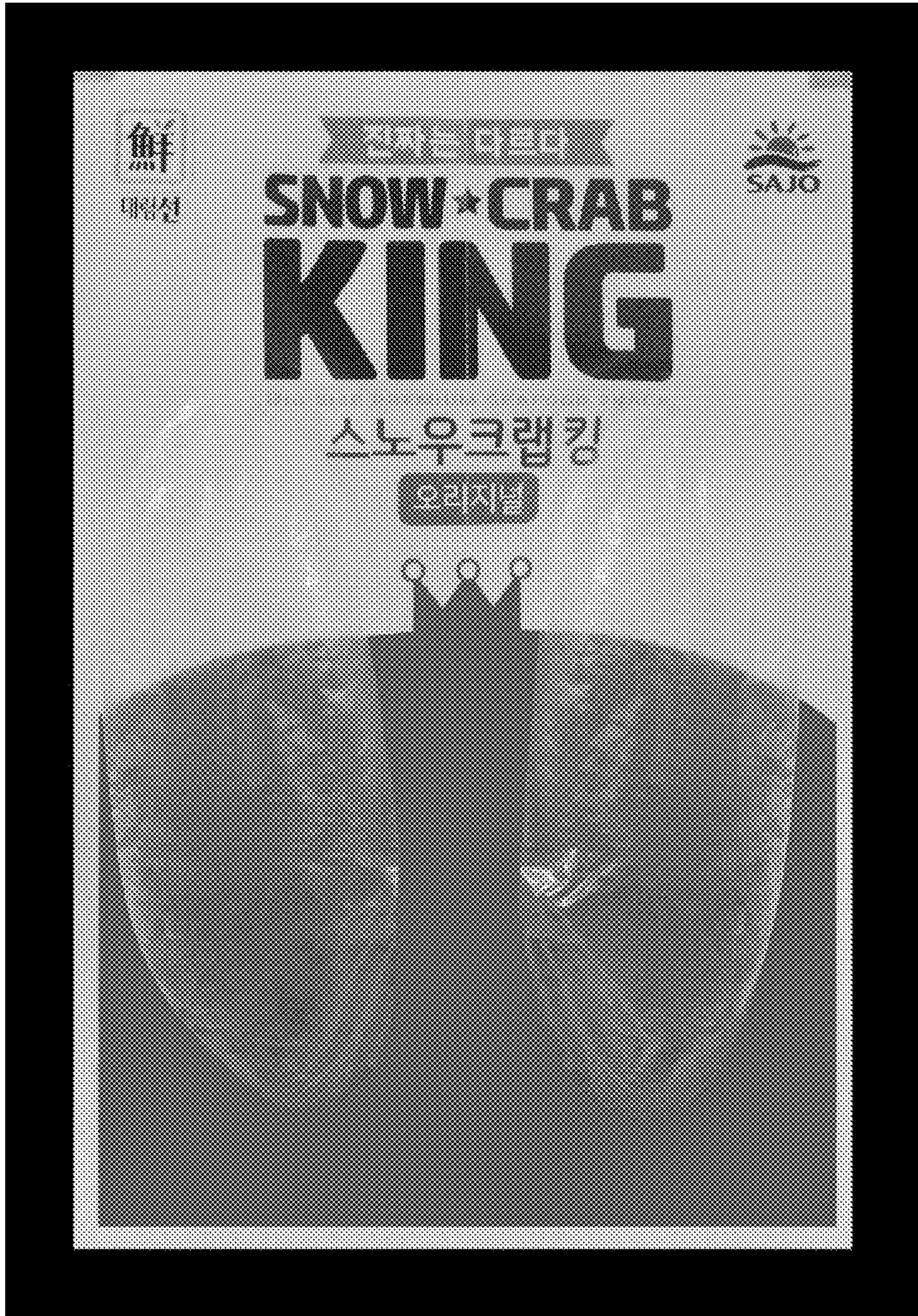

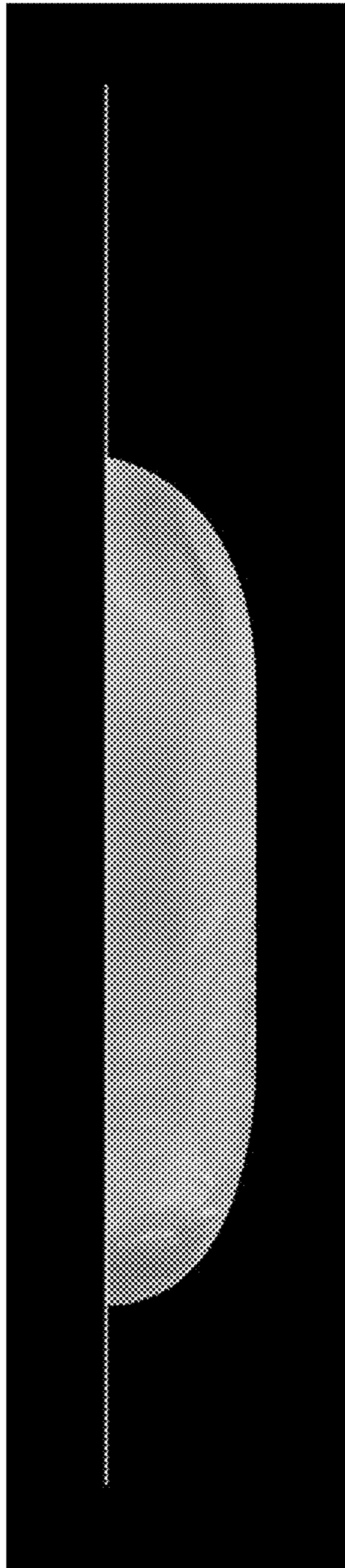

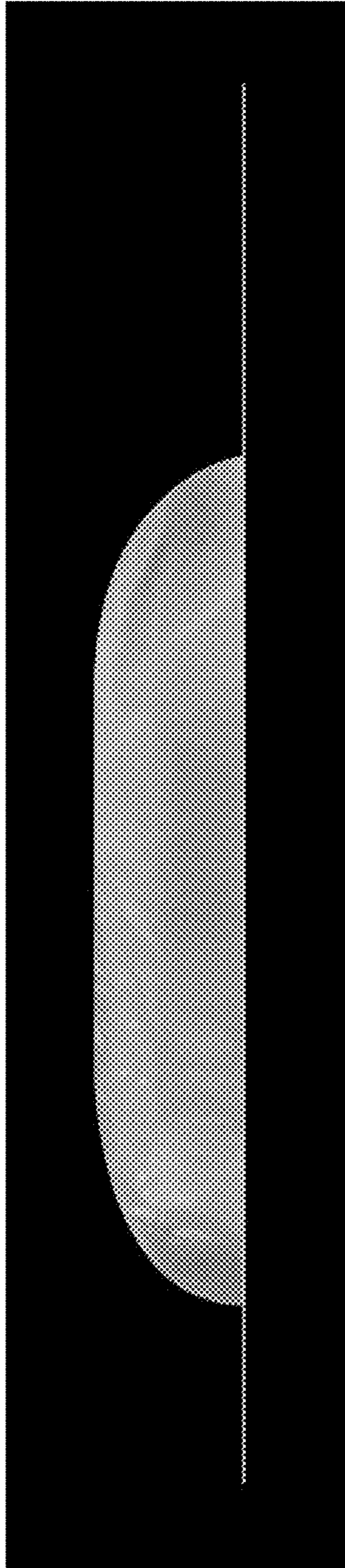

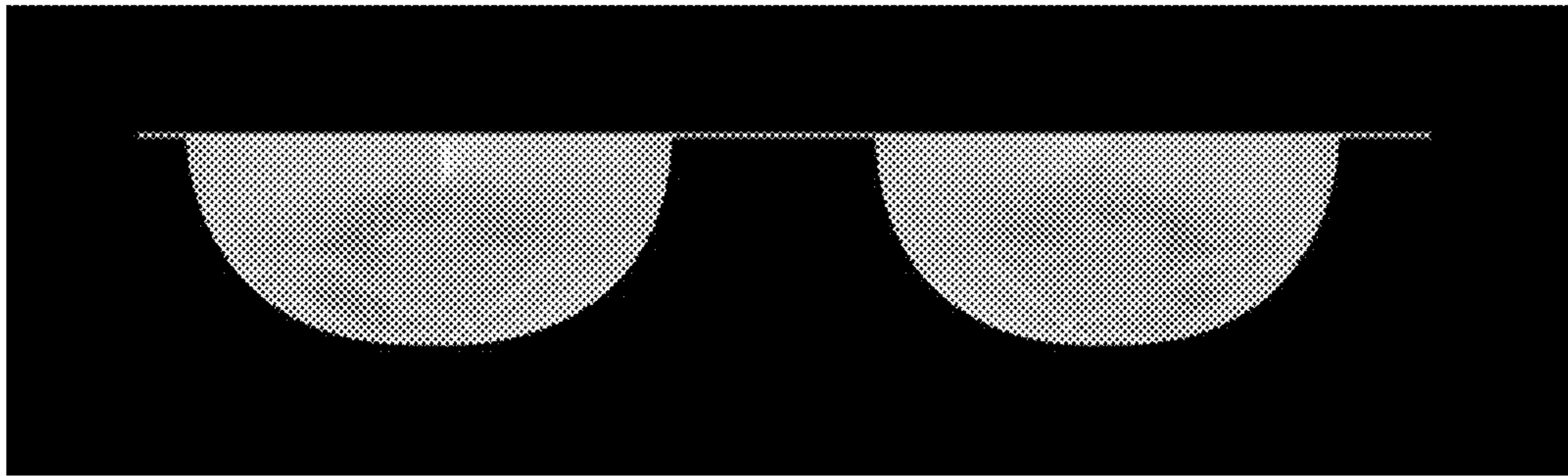

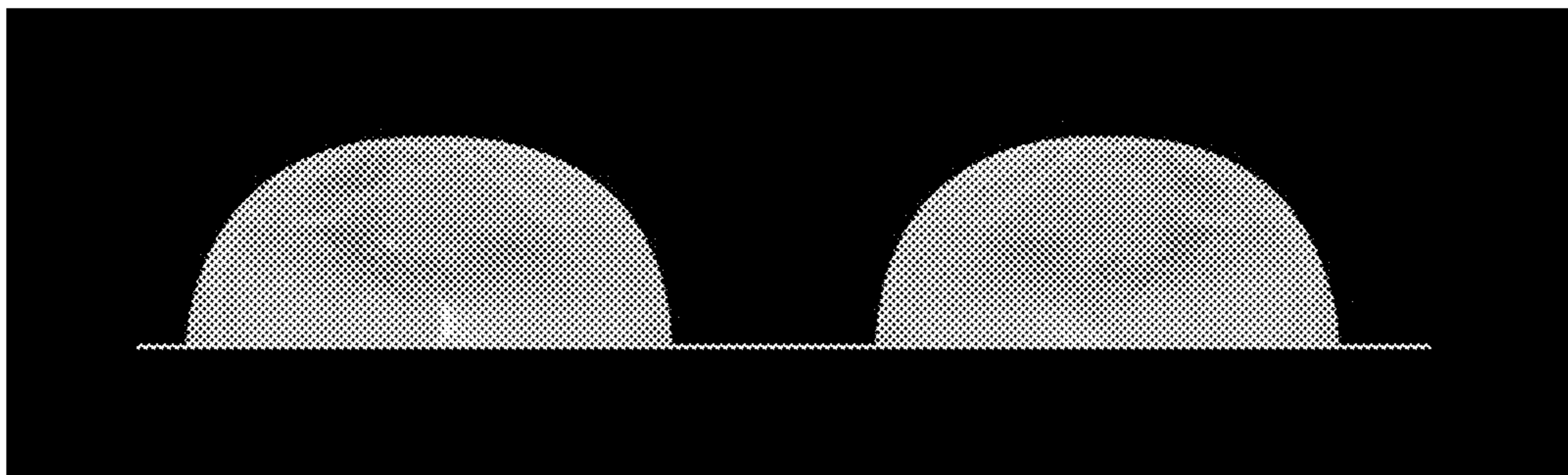
