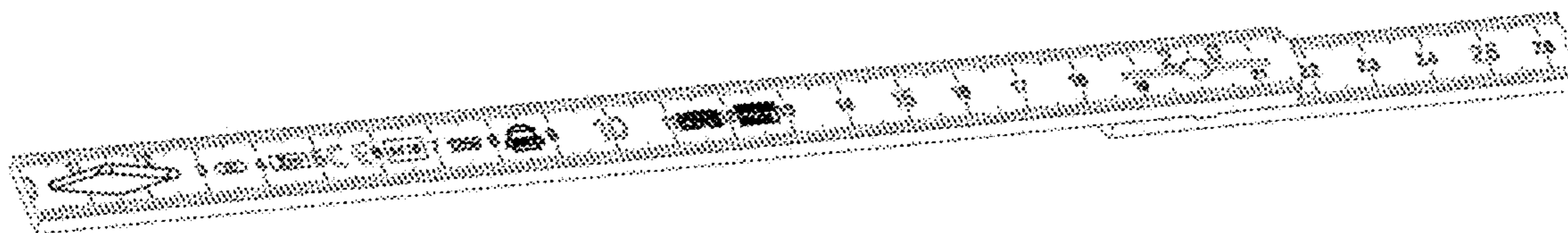
The ornamental design for a folding rule, as shown and described.

The design concerns the part of a folding rule comprising an opening; the scale on the folding rule part does not form part of the design.

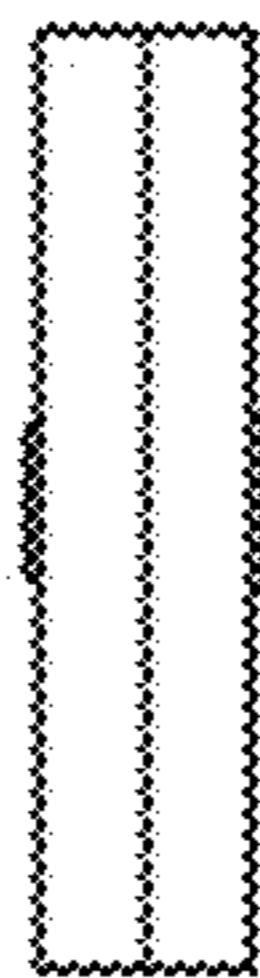

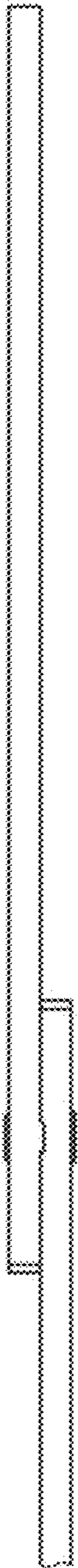

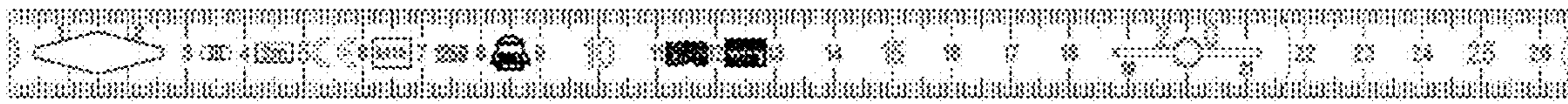

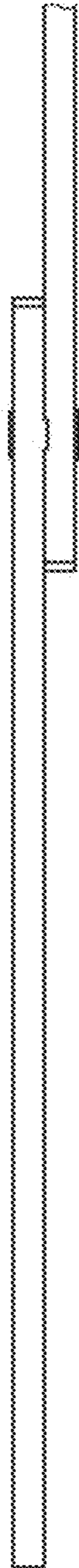
