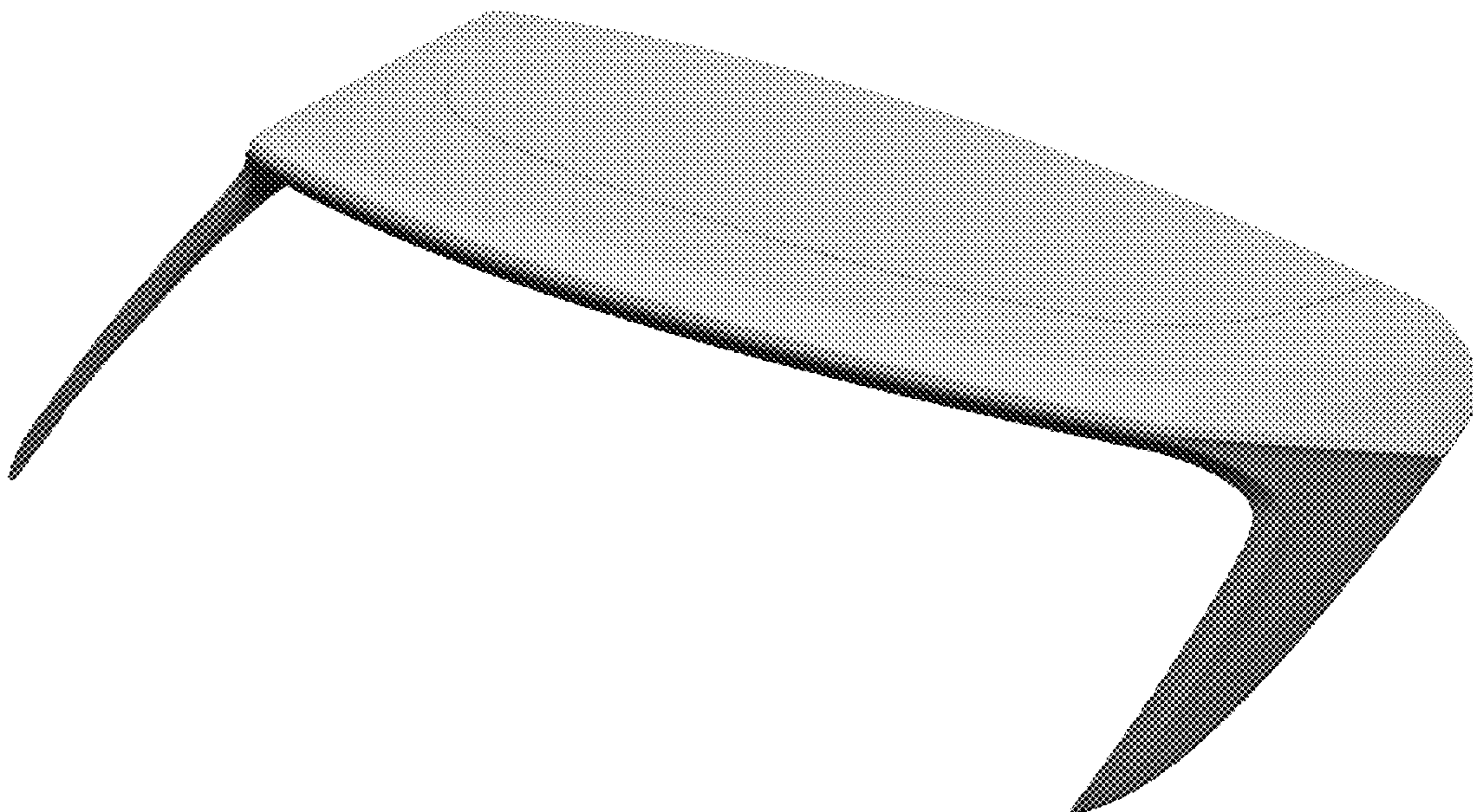
(57) **CLAIM**

The ornamental design for a rear spoiler for a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front top right perspective view of a rear spoiler for a vehicle according to the present invention.  
FIG. 2 is a rear left bottom perspective view thereof.  
FIG. 3 is a rear right top perspective view thereof.  
FIG. 4 is a front left bottom perspective view thereof.

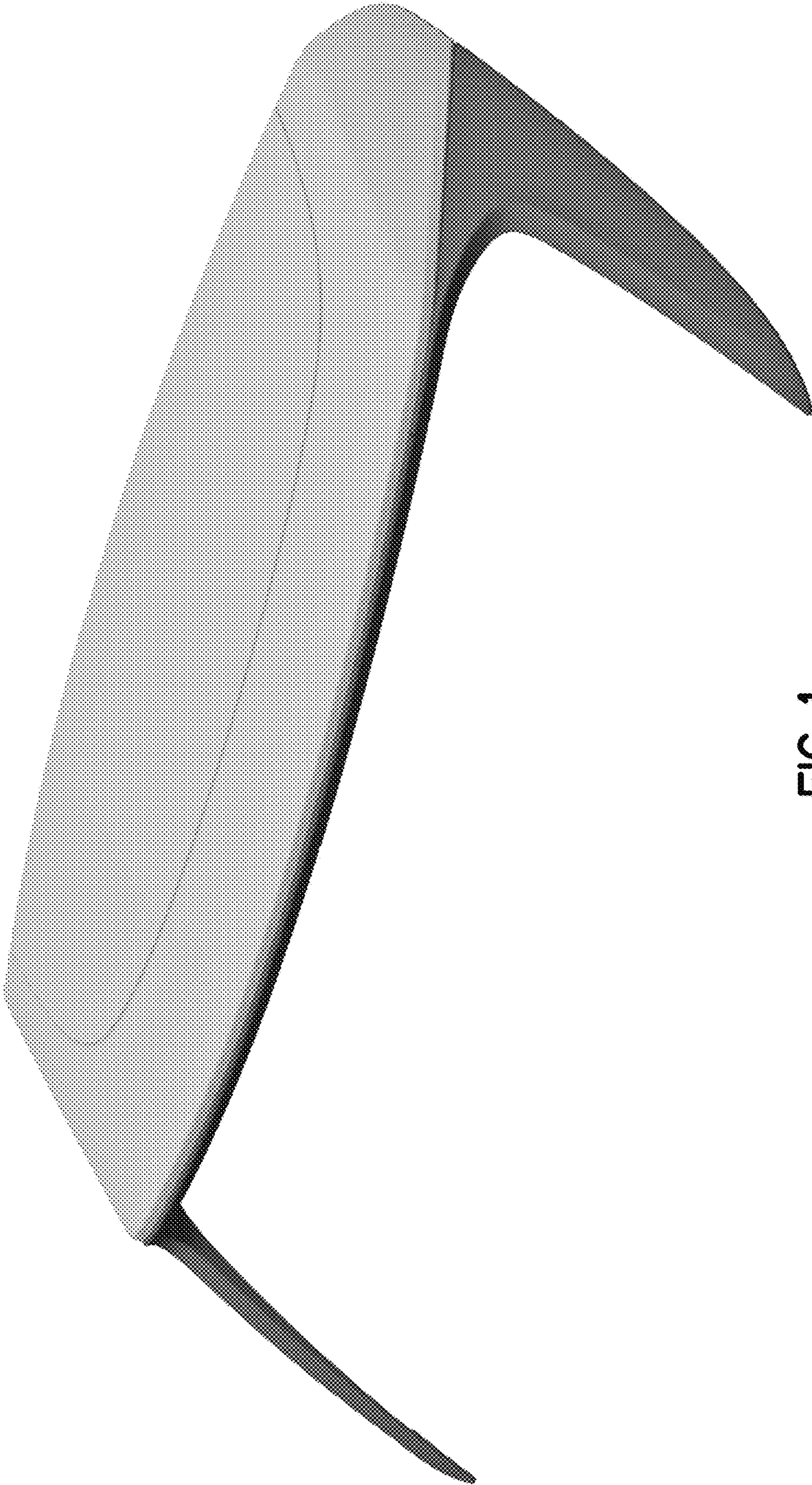

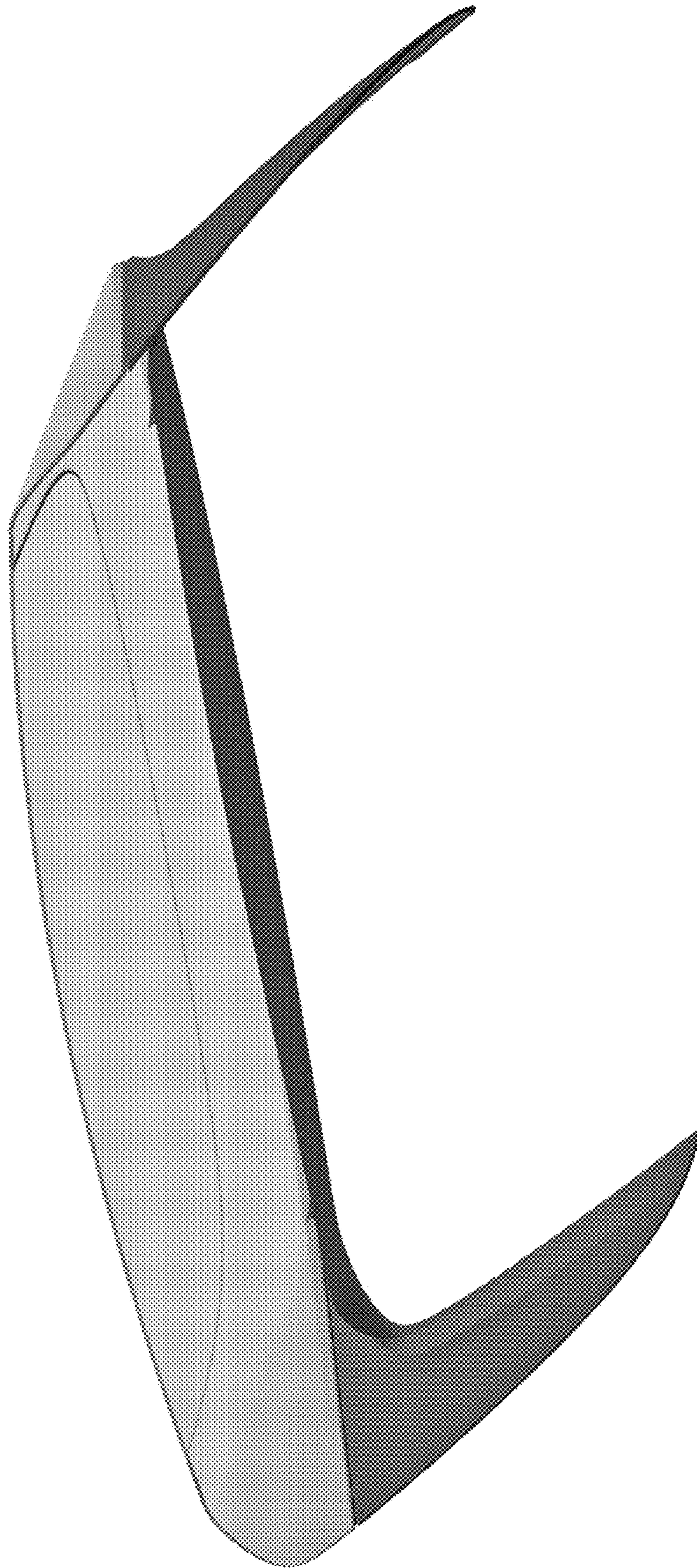

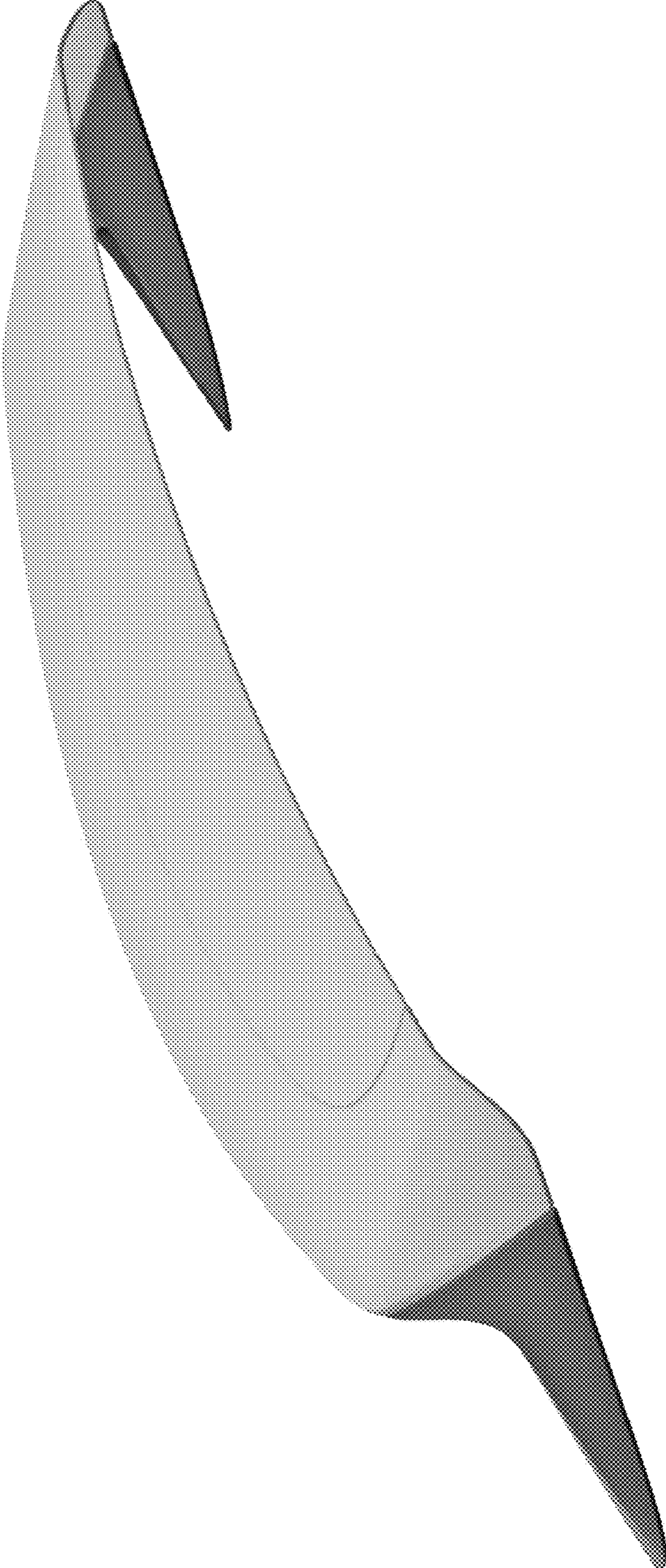

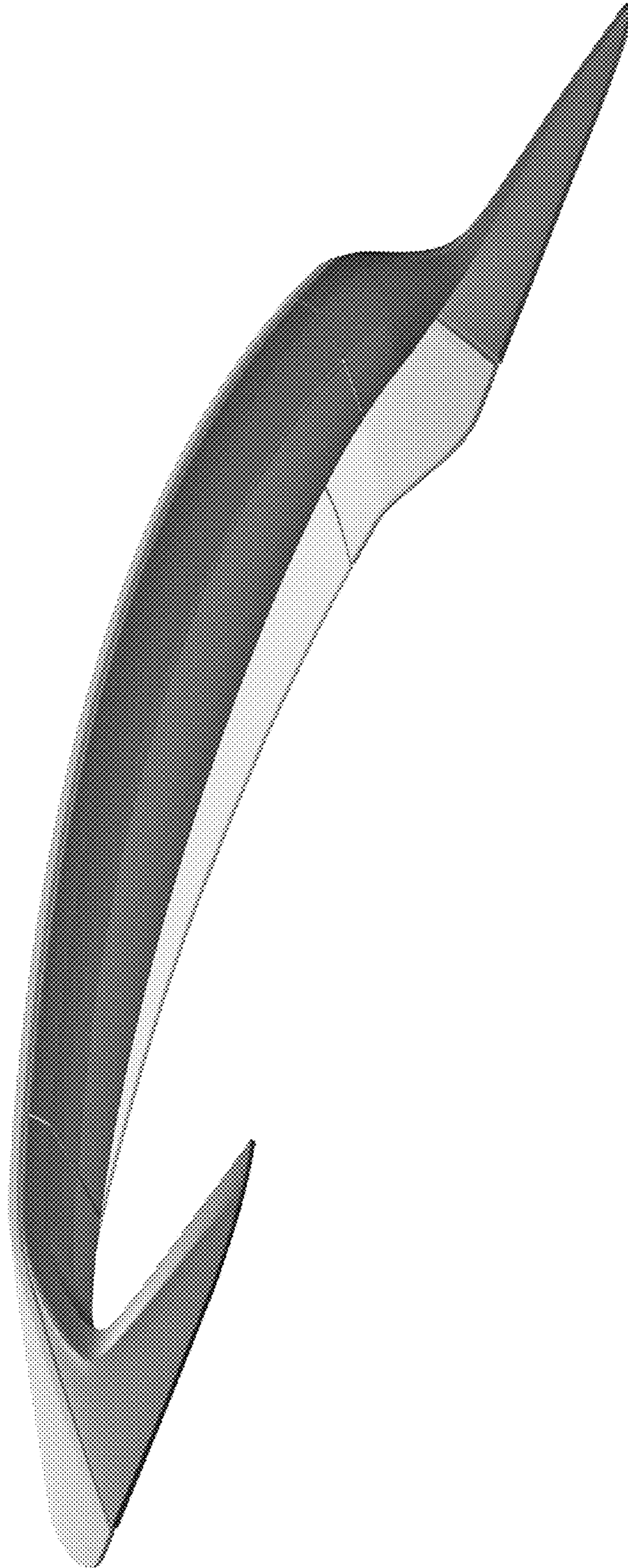

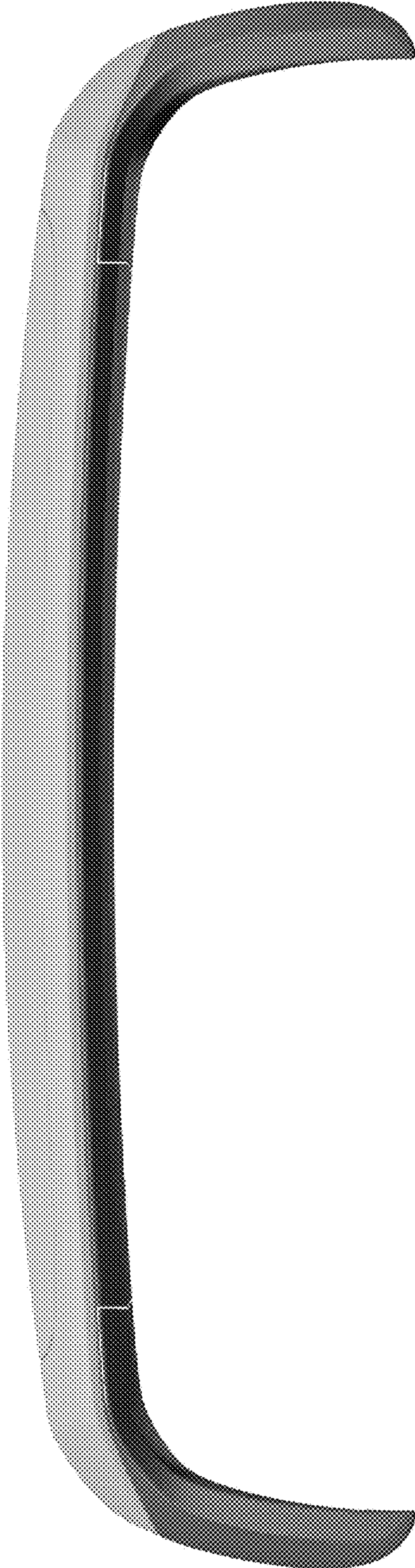

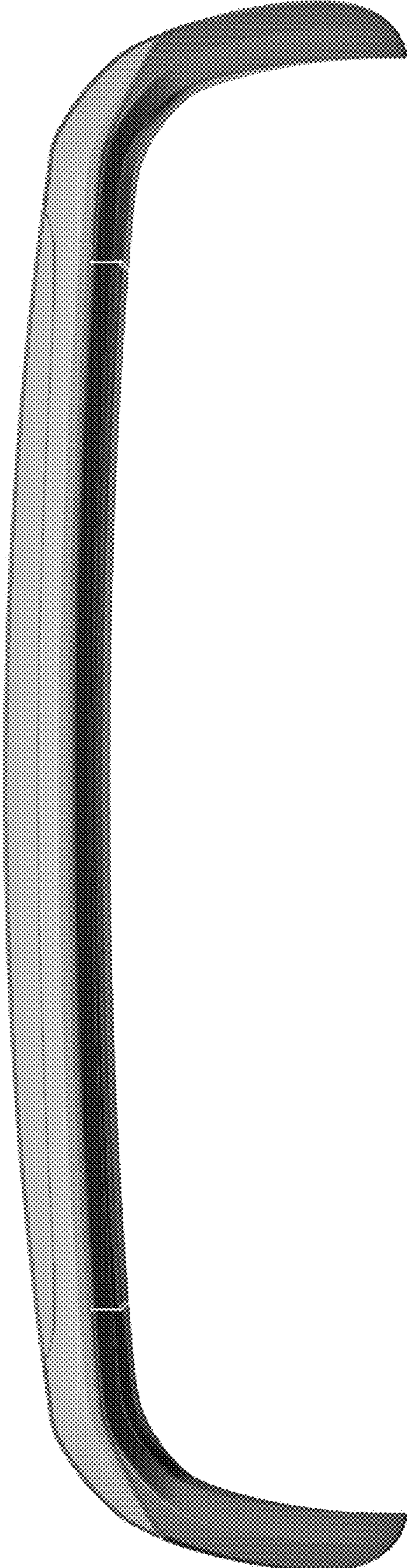

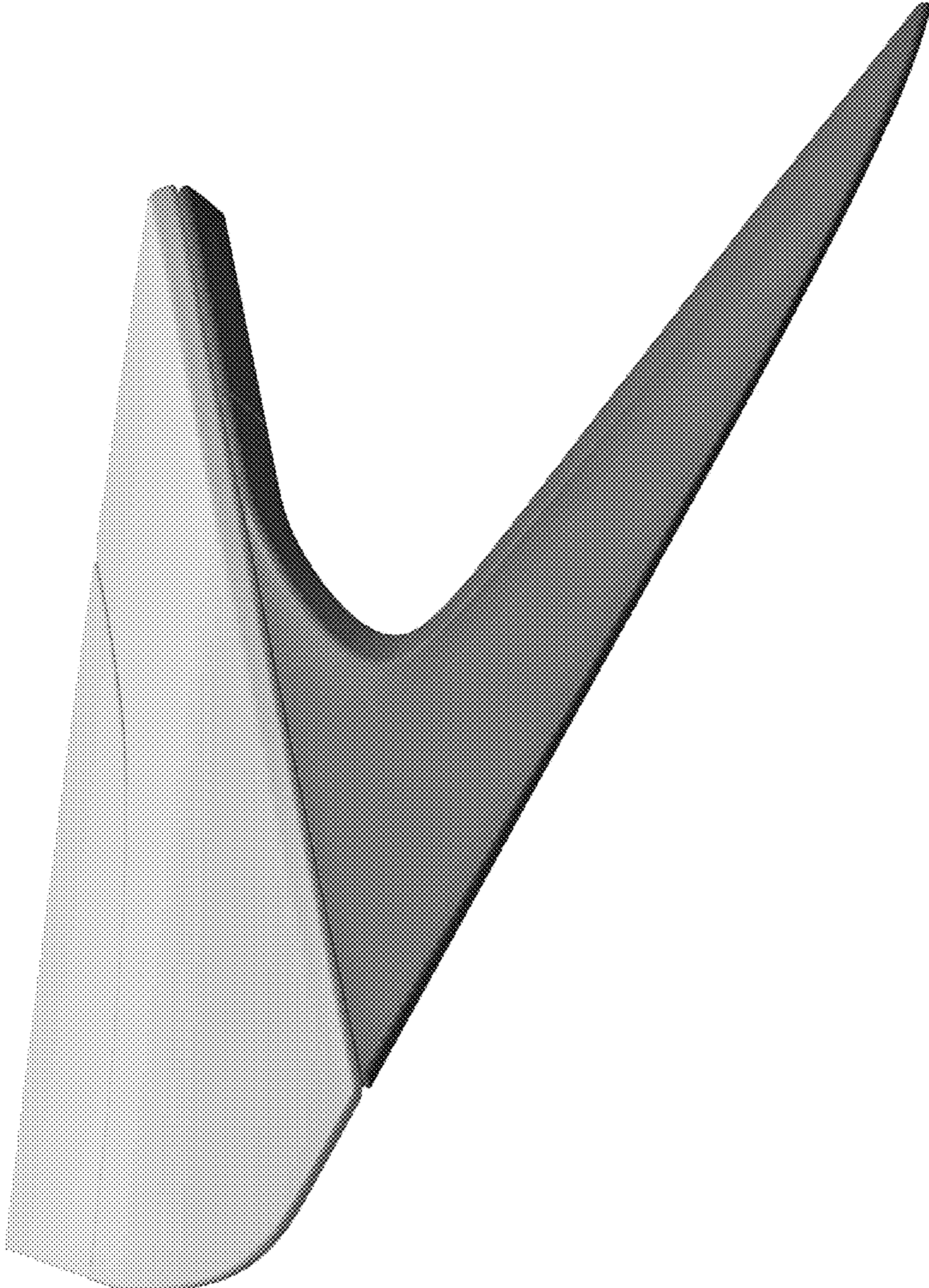

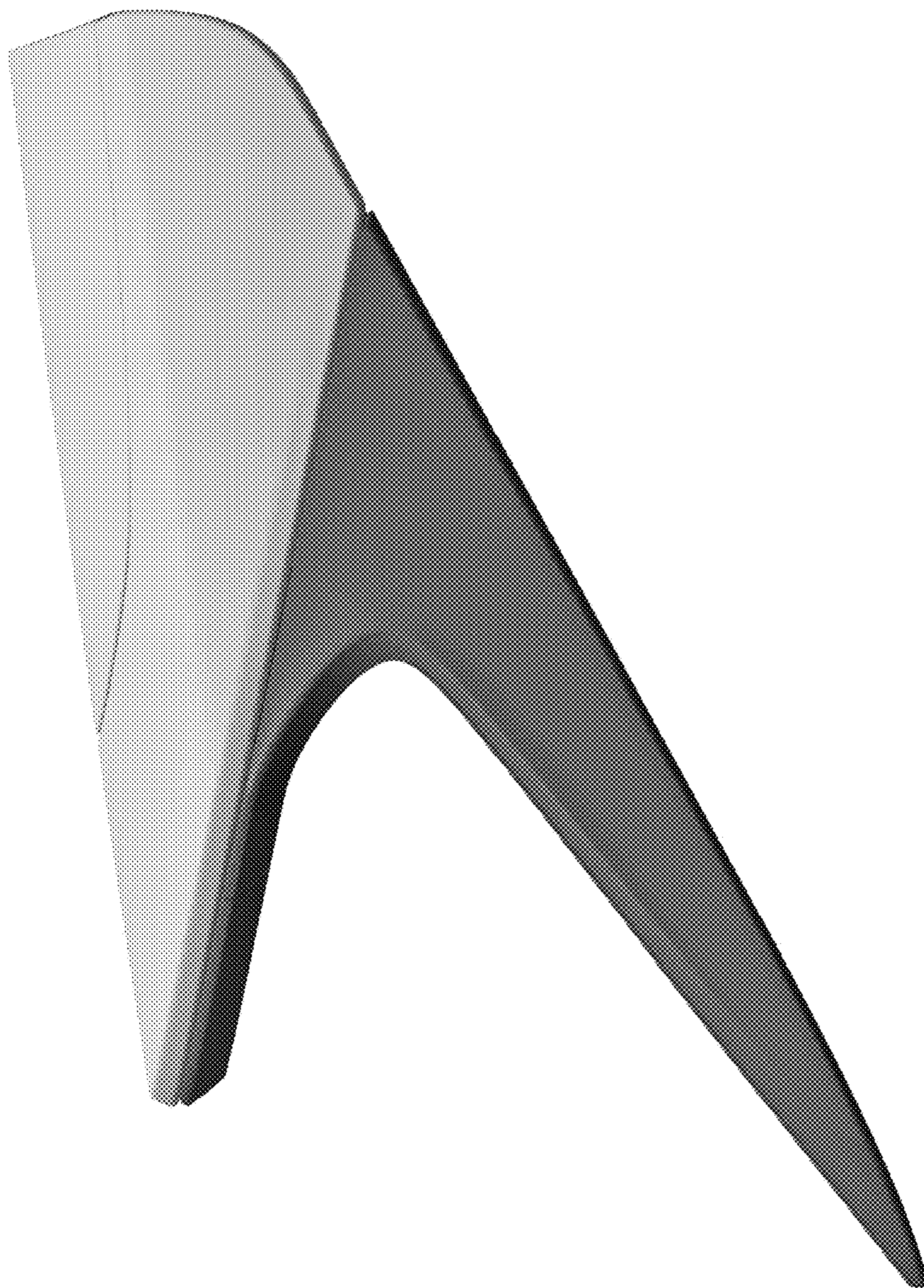

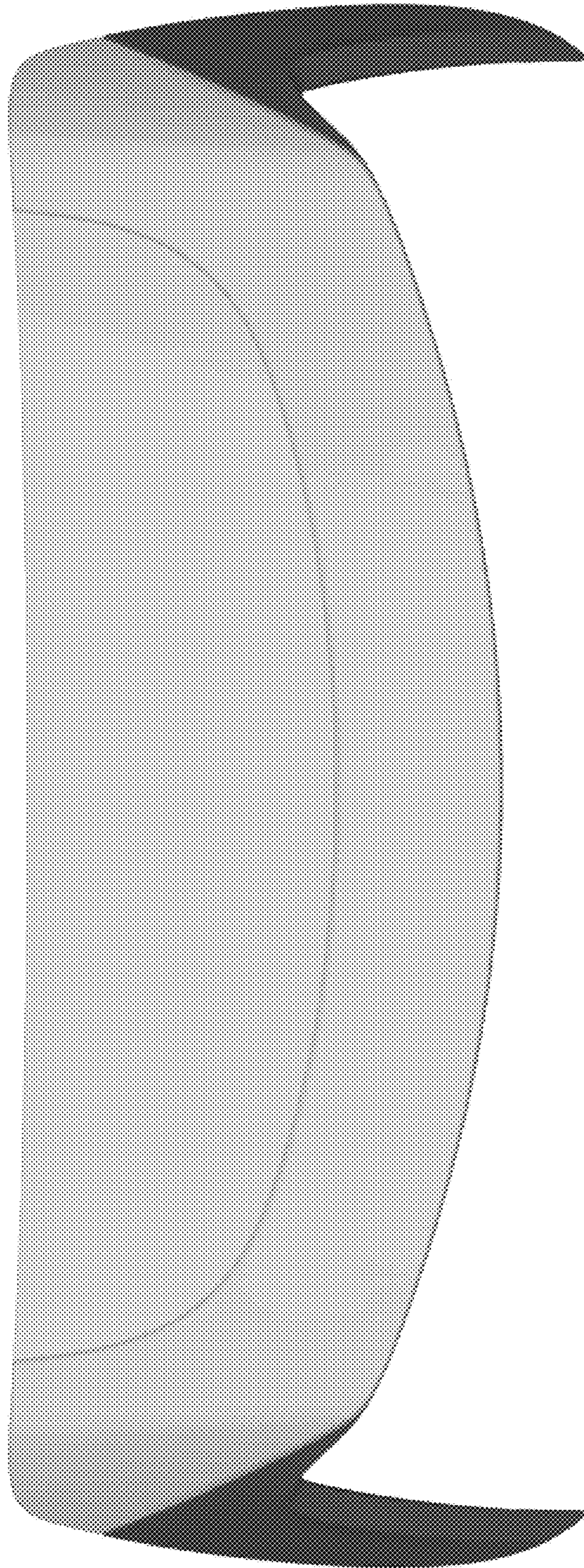

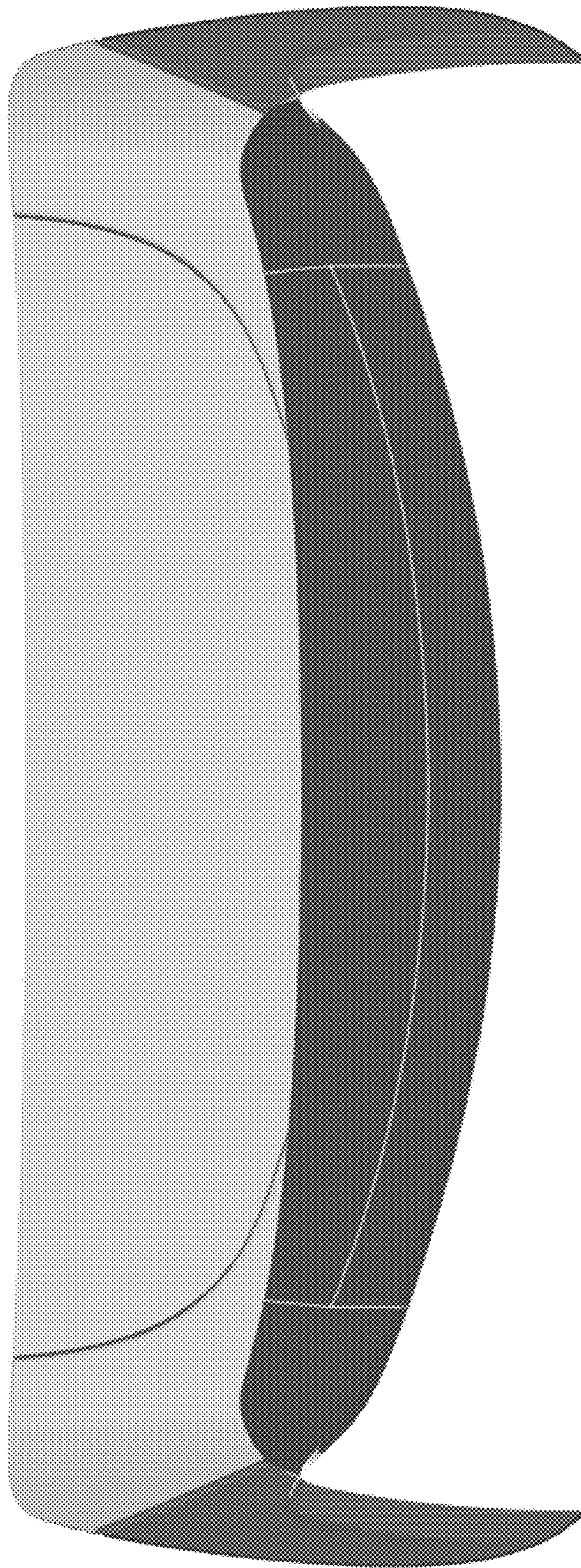

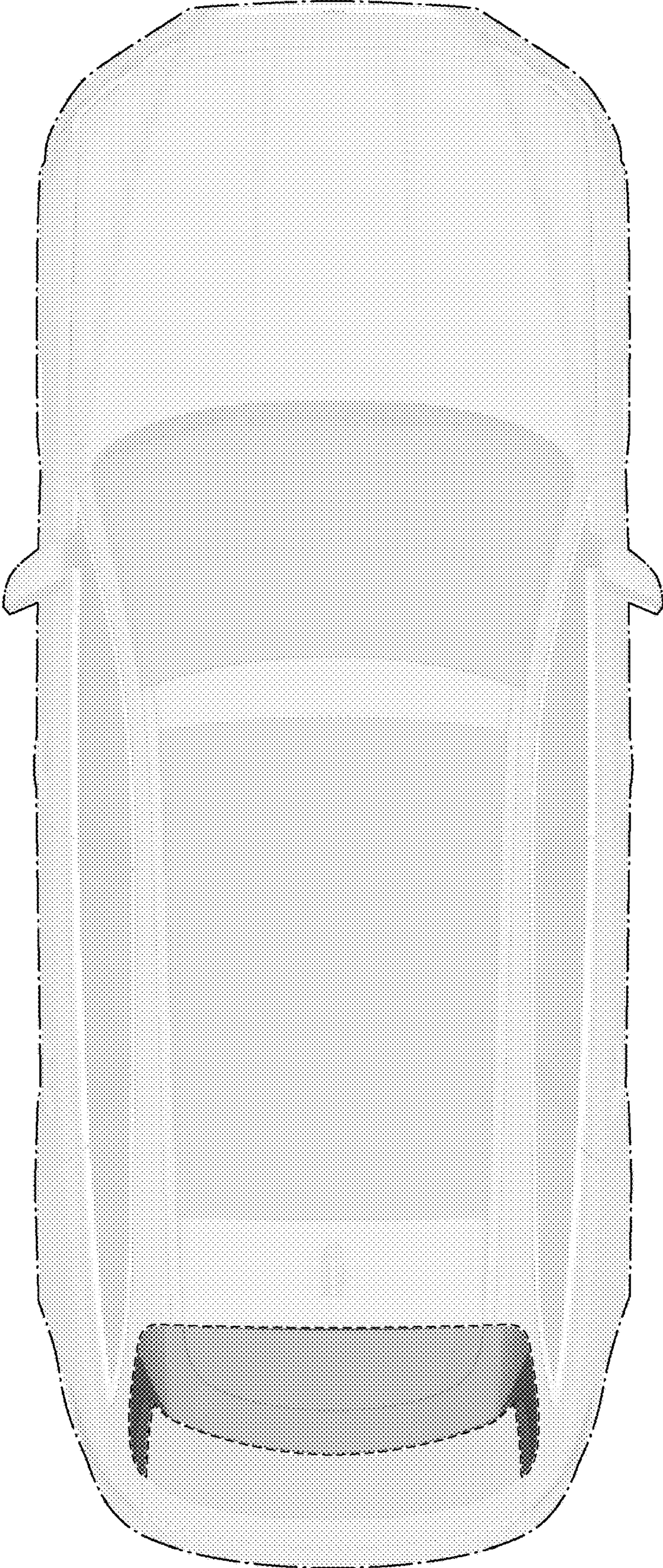
