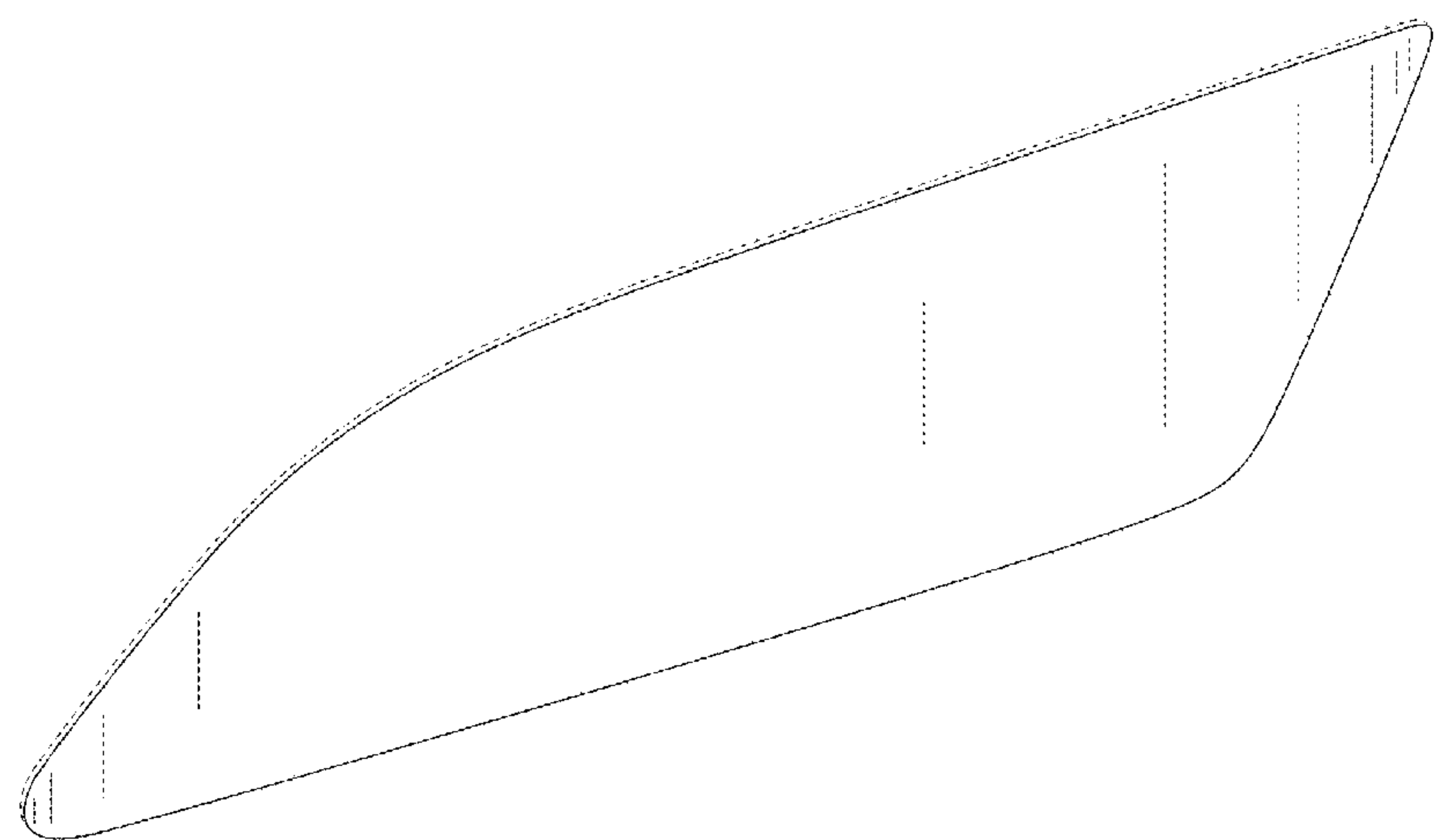

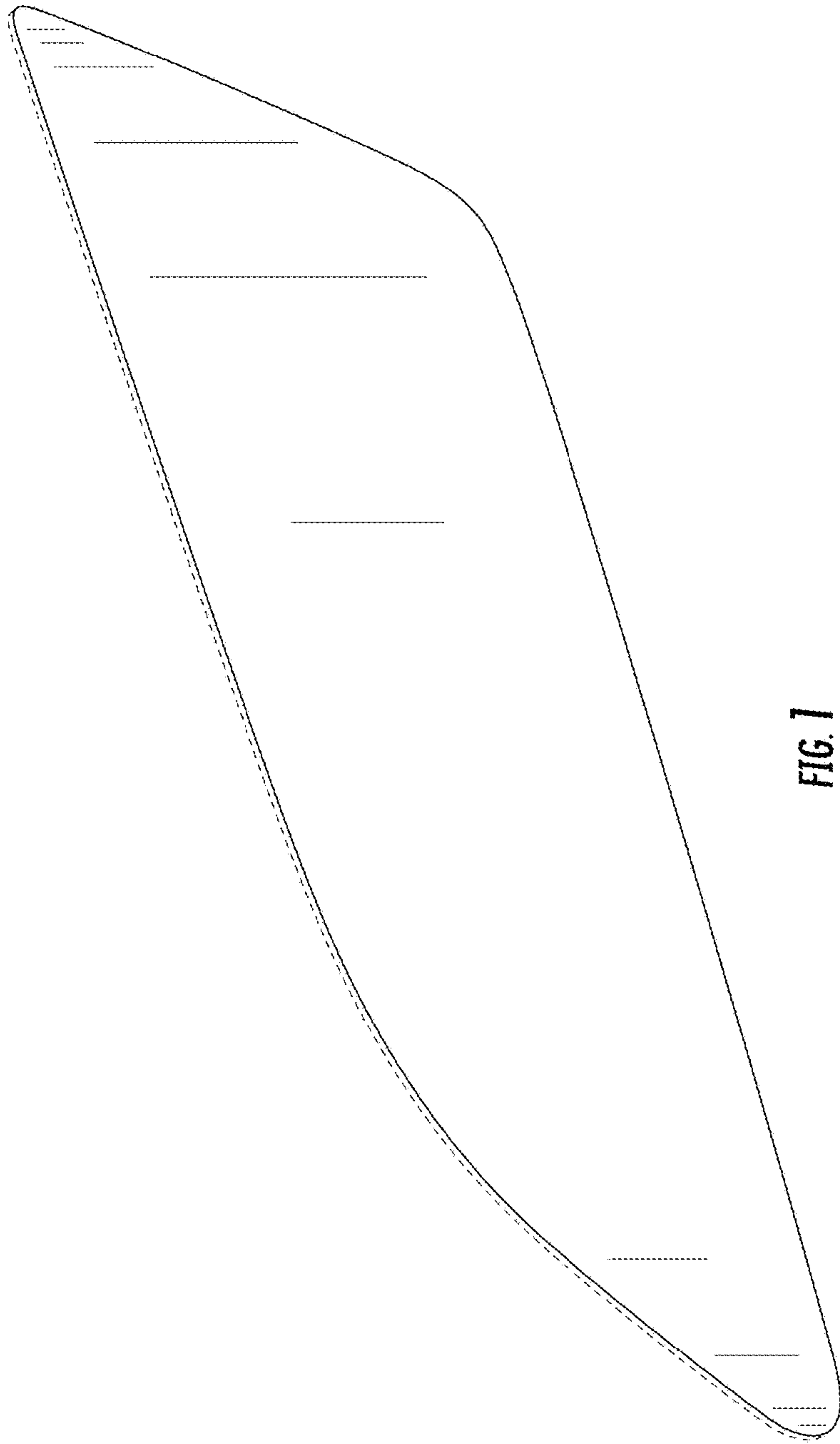

(57) **CLAIM**
The ornamental design for a charge-port door, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a charge-port door.
FIG. 2 is a front elevational view of the charge-port door of FIG. 1.
FIG. 3 is a back elevational view of the charge-port door of FIG. 1.
FIG. 4 is a side elevational view of the charge-port door of FIG. 1.
FIG. 5 is a side elevational view of the charge-port door of FIG. 1 from the opposite side from FIG. 4.
FIG. 6 is a top plan view of the charge-port door of FIG. 1.
FIG. 7 is a bottom plan view of the charge-port door of FIG. 1; and,
FIG. 8 is a perspective view of the charge-port door of FIG. 1 as part of a semi-truck cab.
The items shown with broken lines form no part of the claimed design.

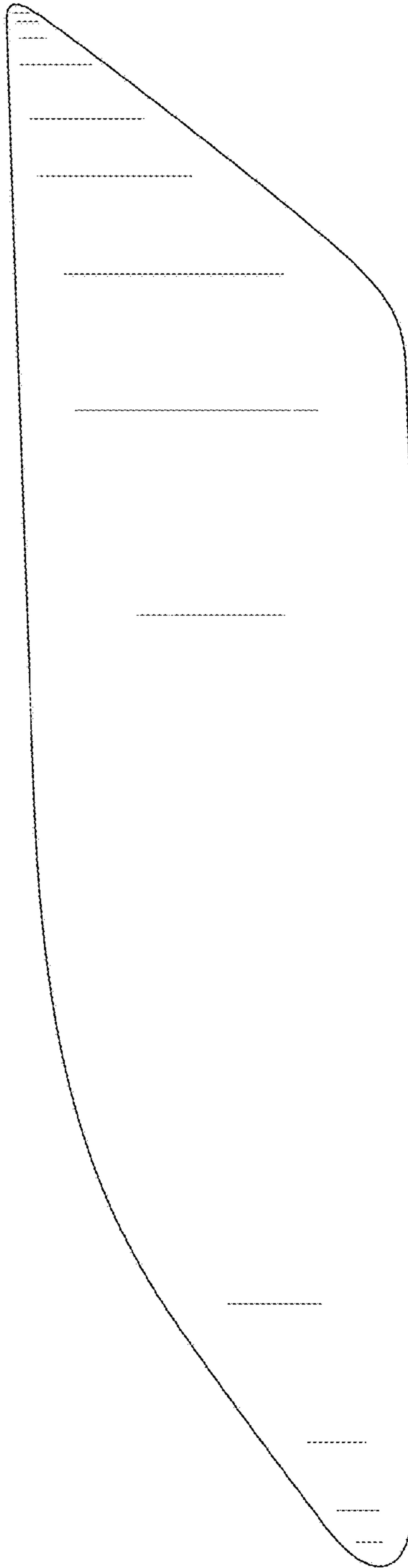

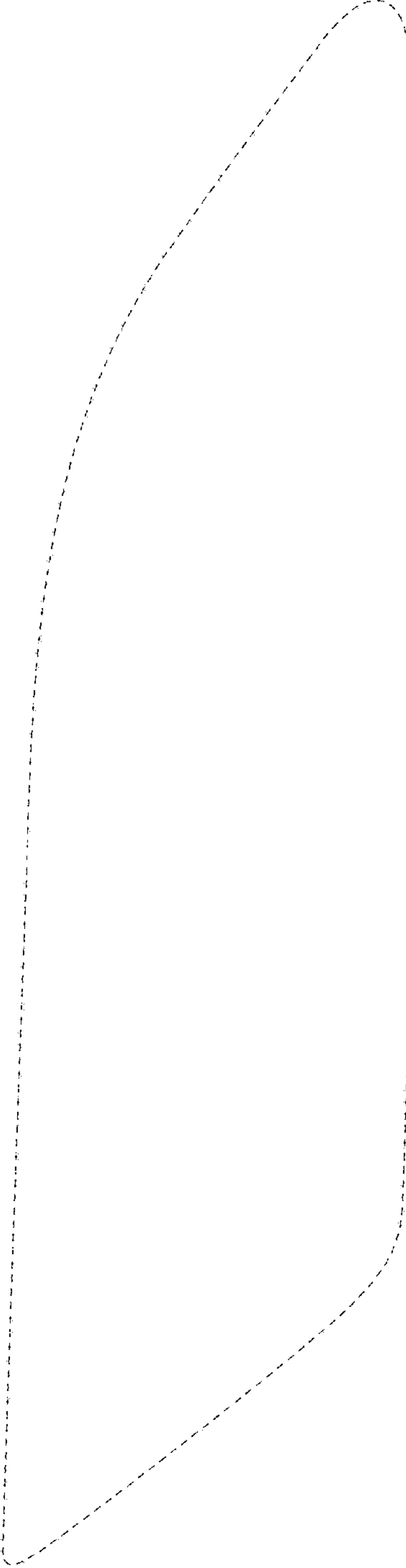

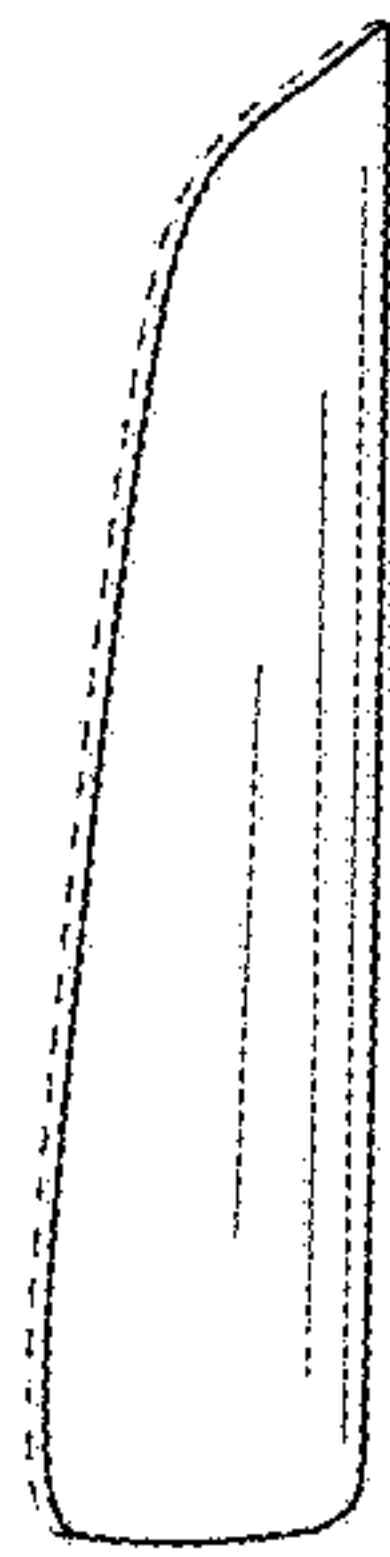

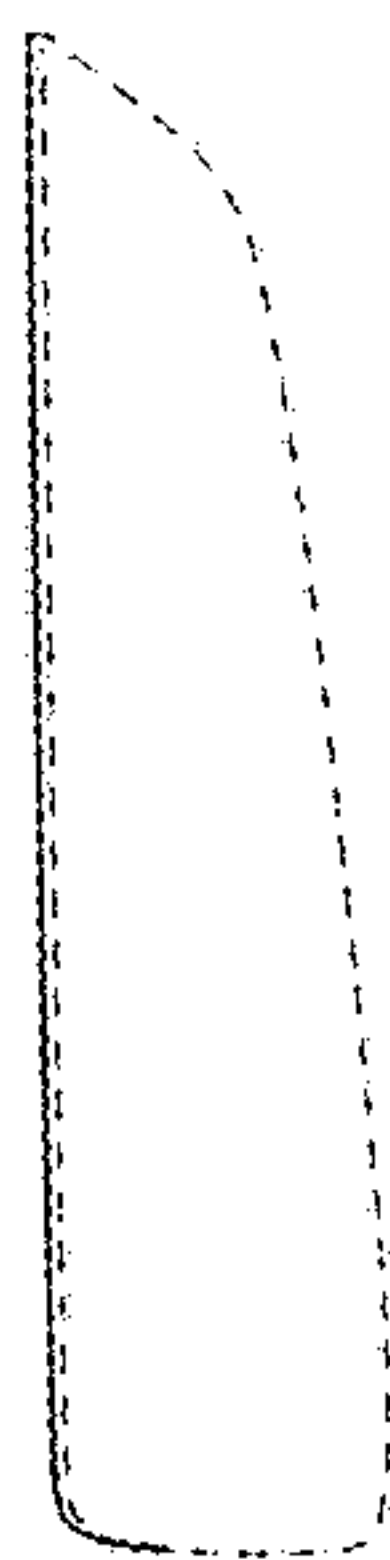

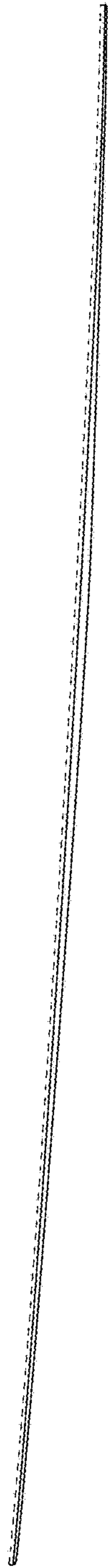

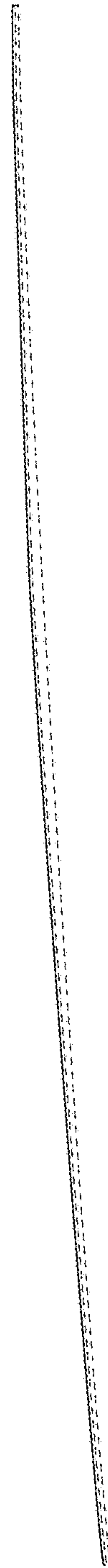

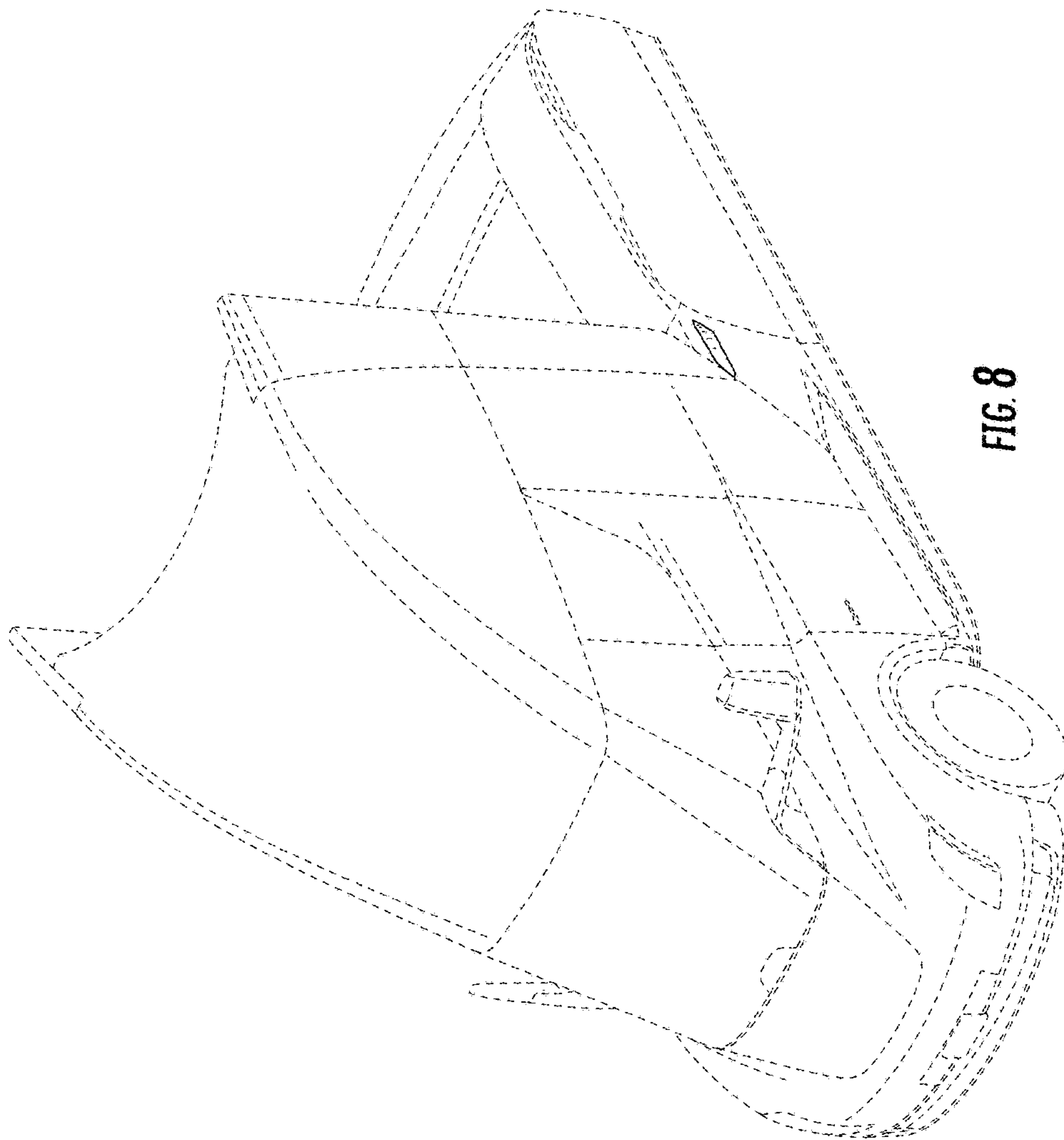
