(57) **CLAIM**

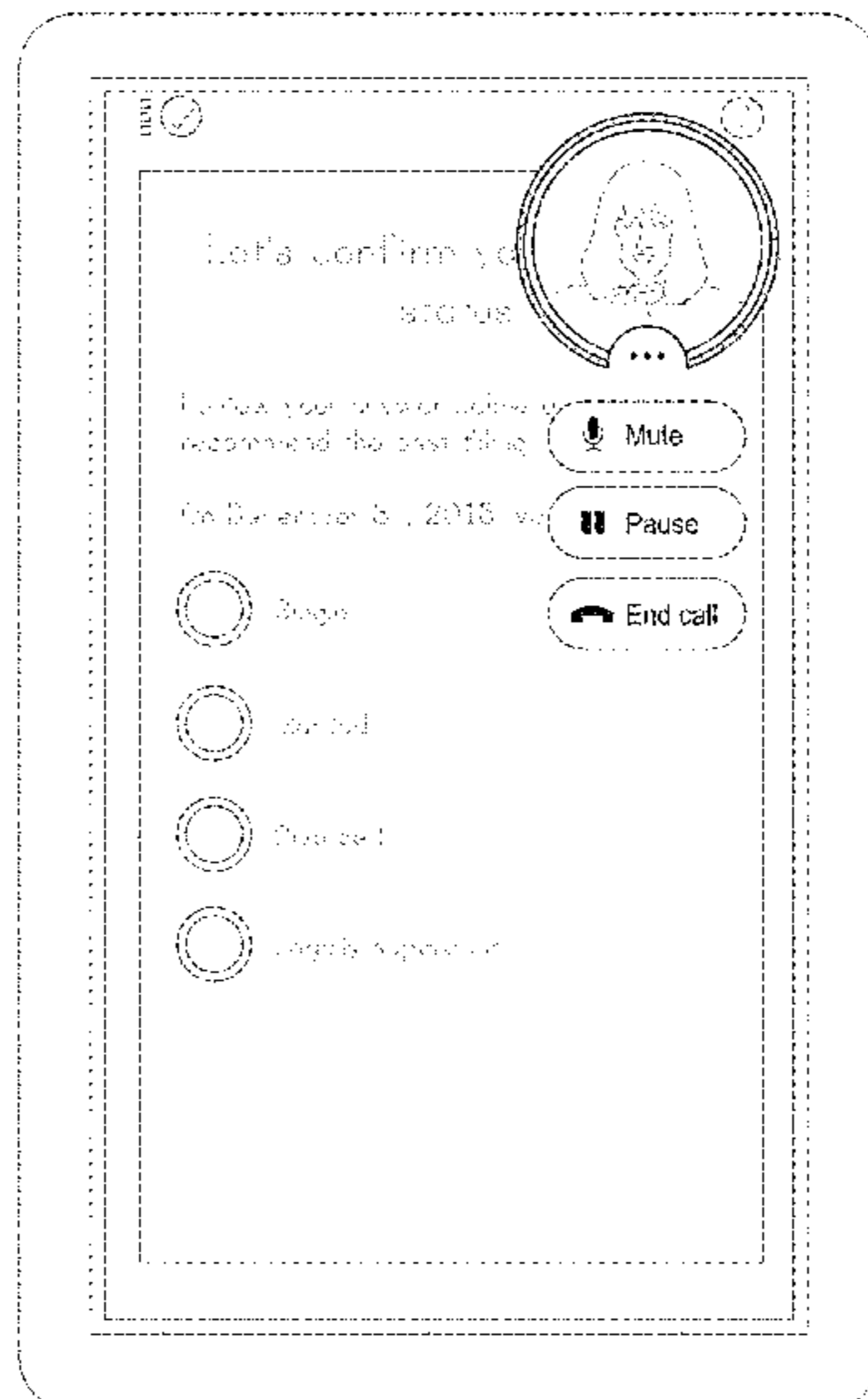
The ornamental design for a display device with a graphical user interface presenting call options, as shown and described.

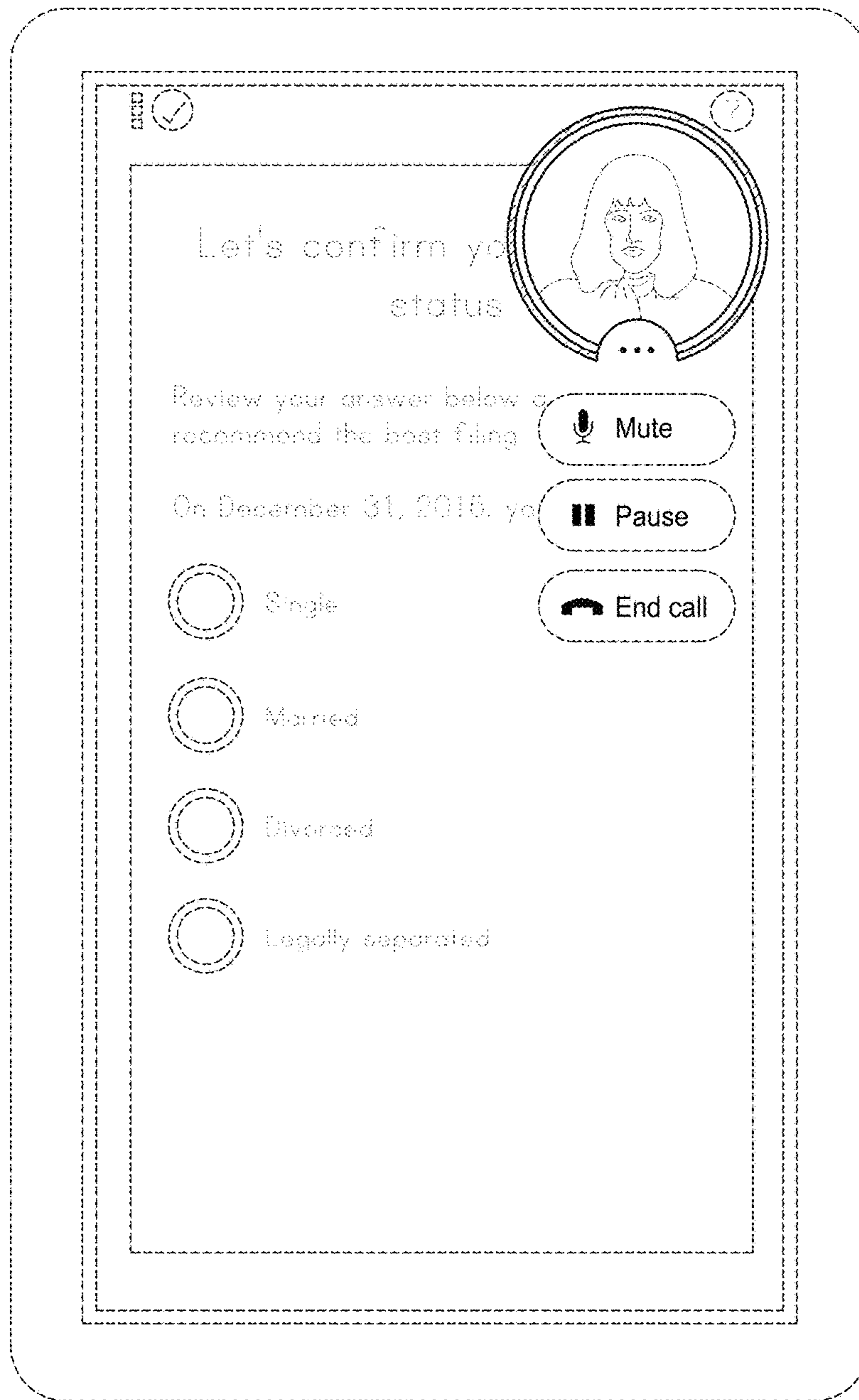

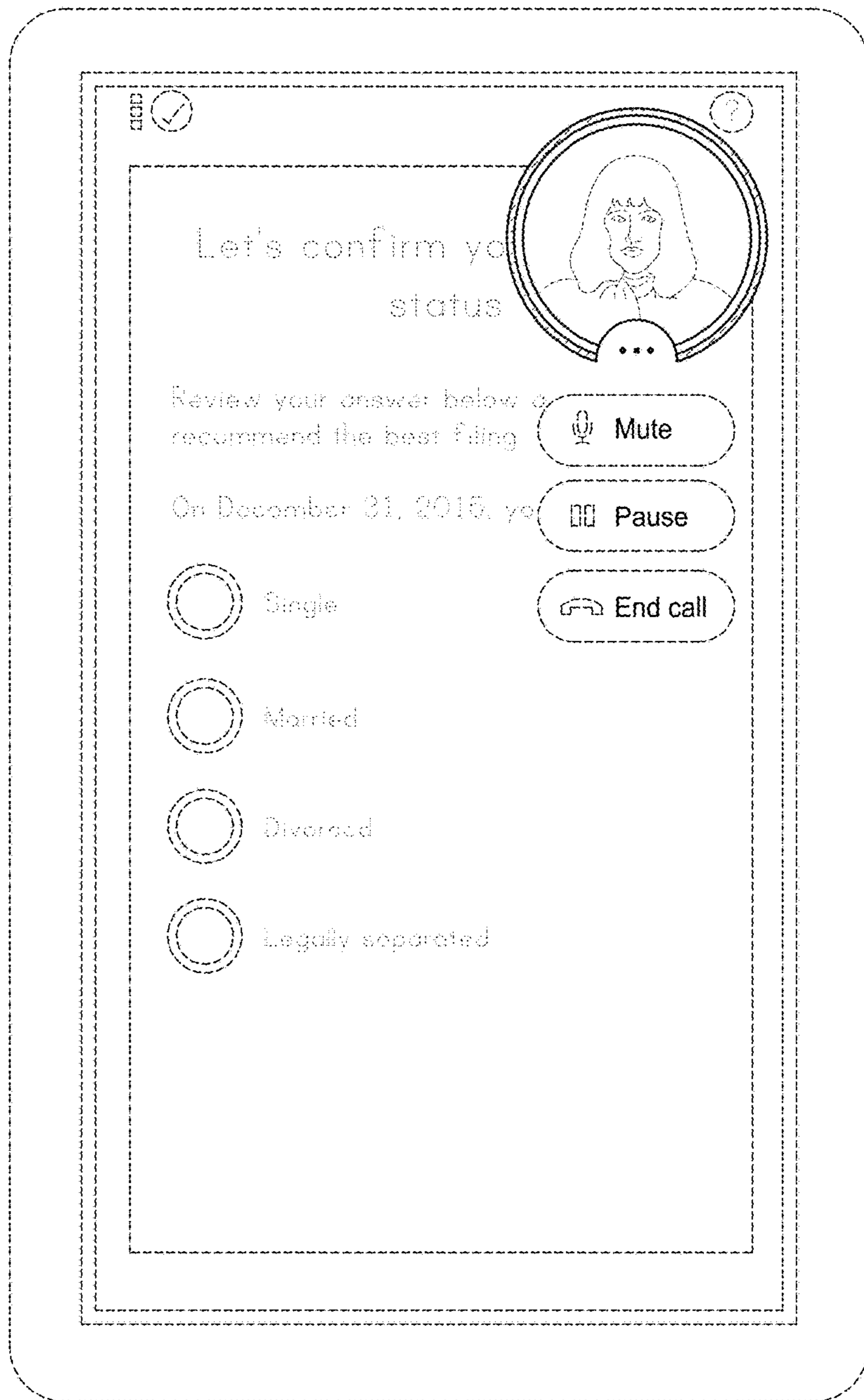
