FIG. 1 is a left side view of a buttpad according to the invention; and,

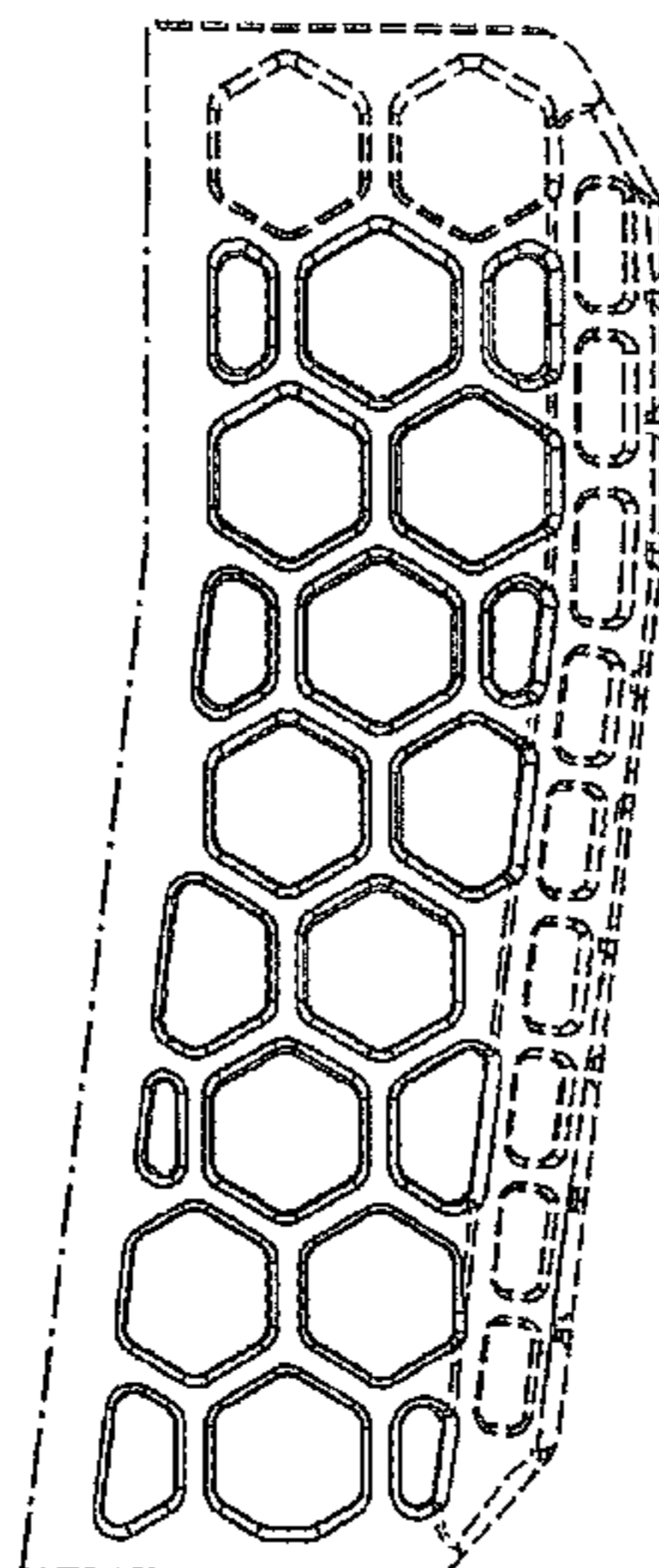
FIG. 2 is a right side view of a buttpad according to the invention.

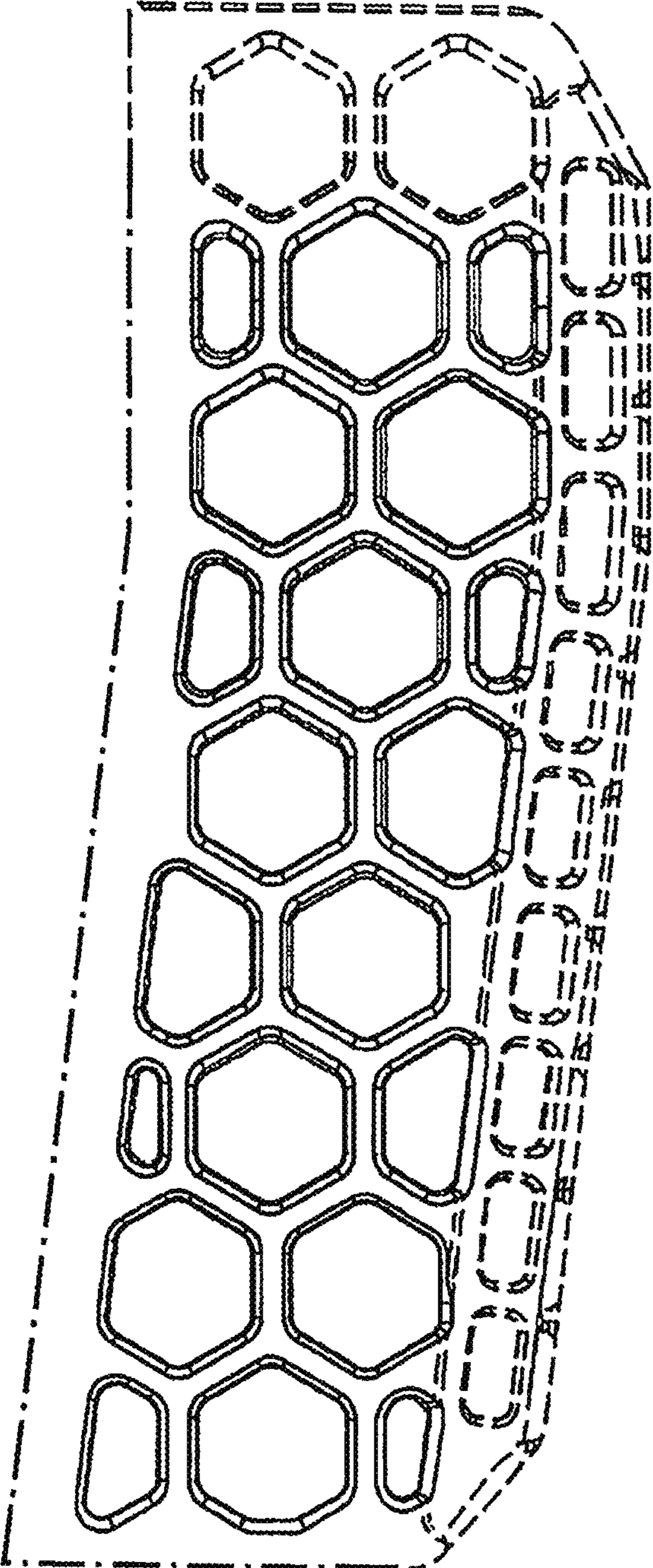

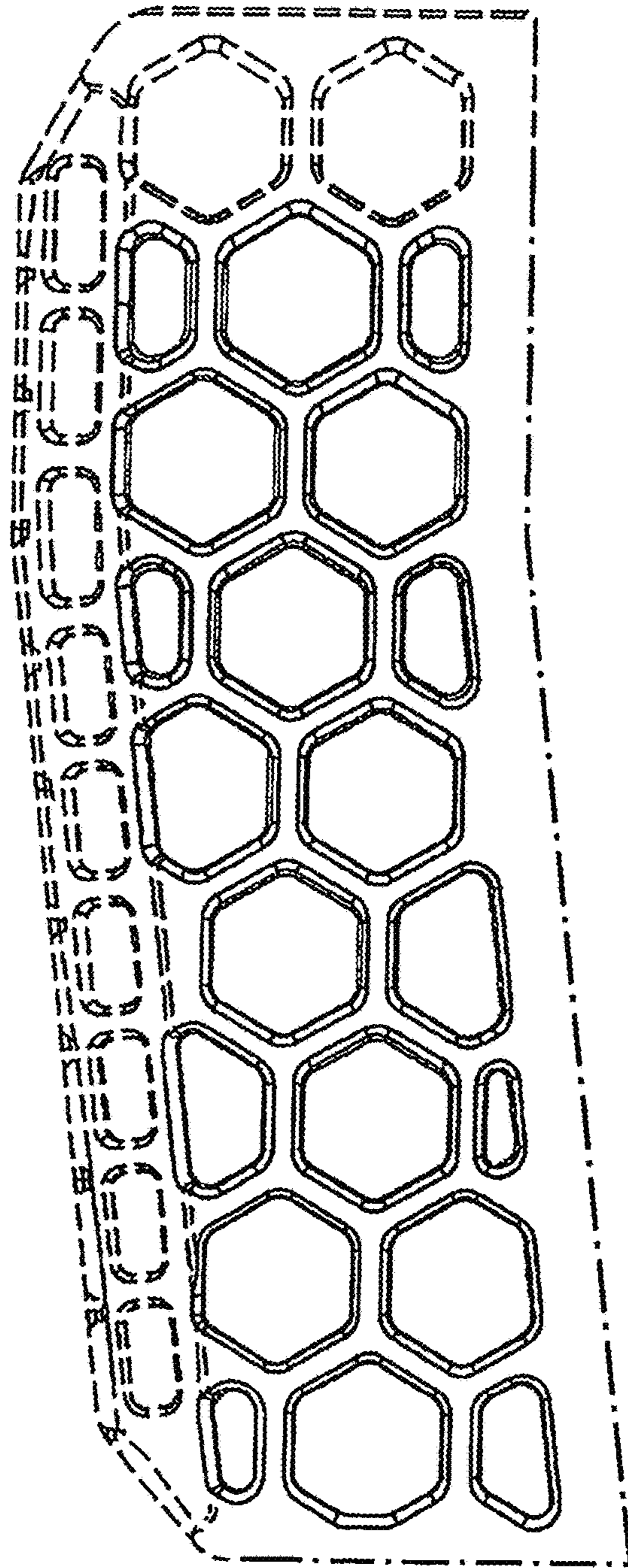
