1.8 is a sectional view taken along the vertical center of 1.2;

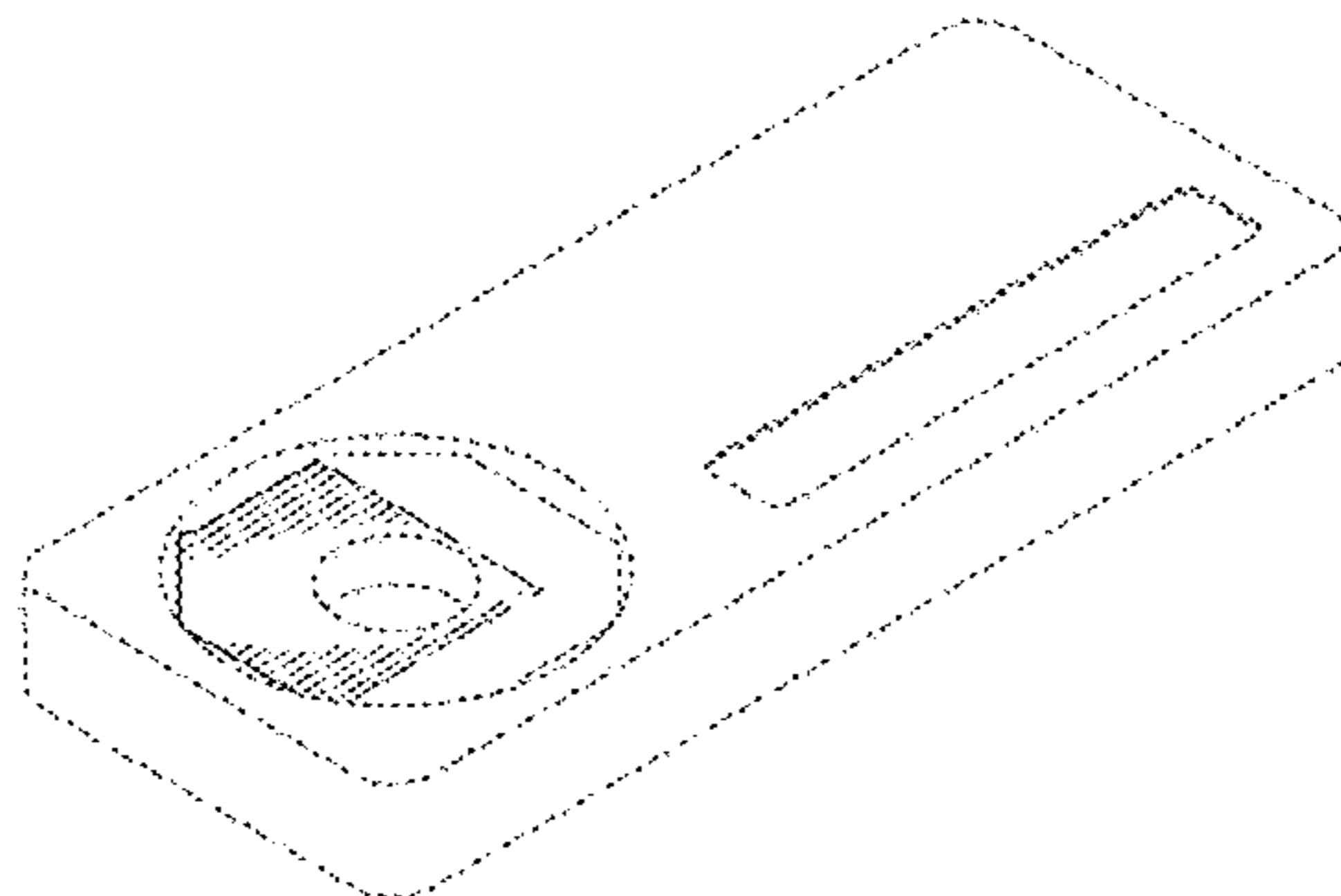
1.9 is a sectional view taken along the vertical lower portion of 1.2;

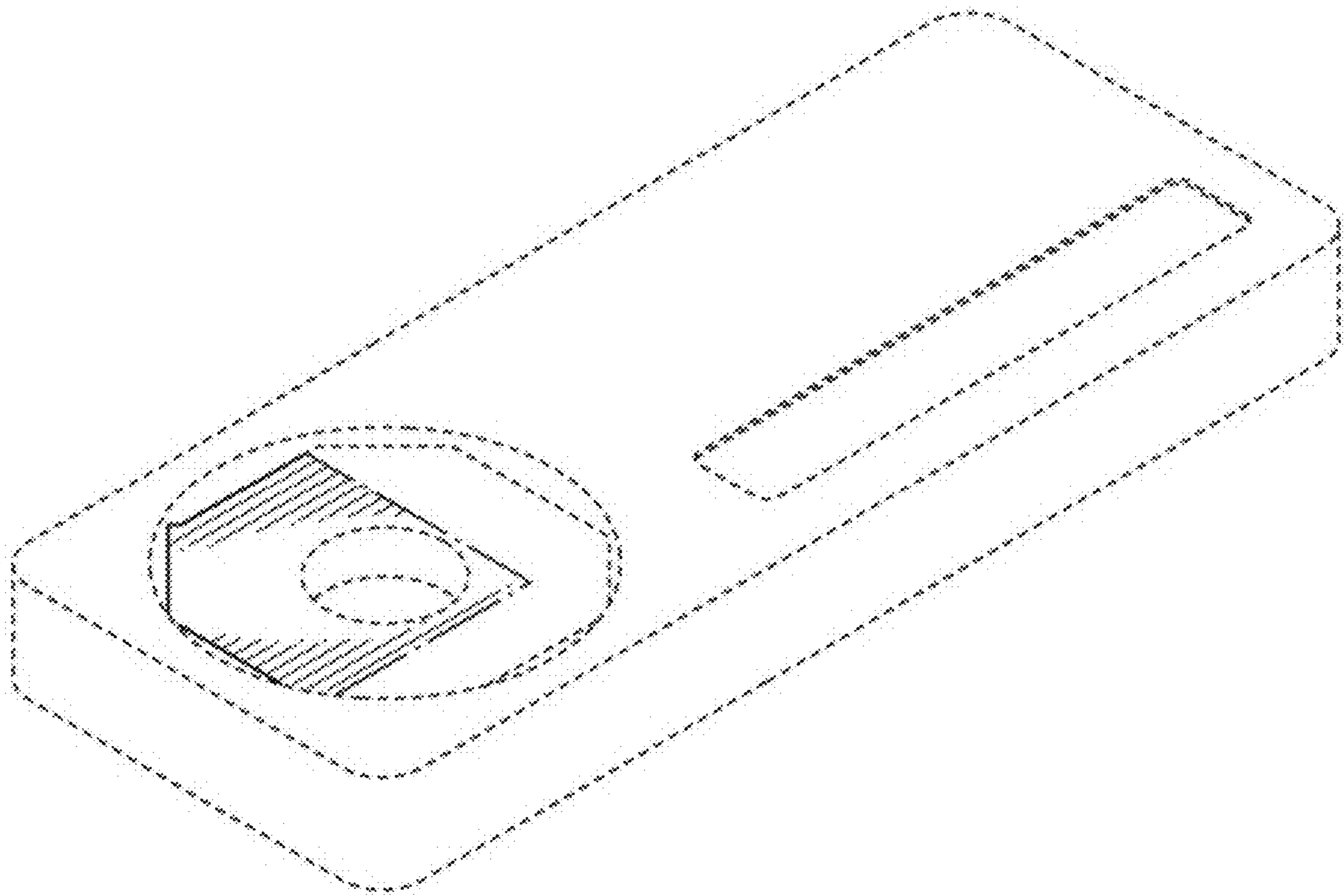

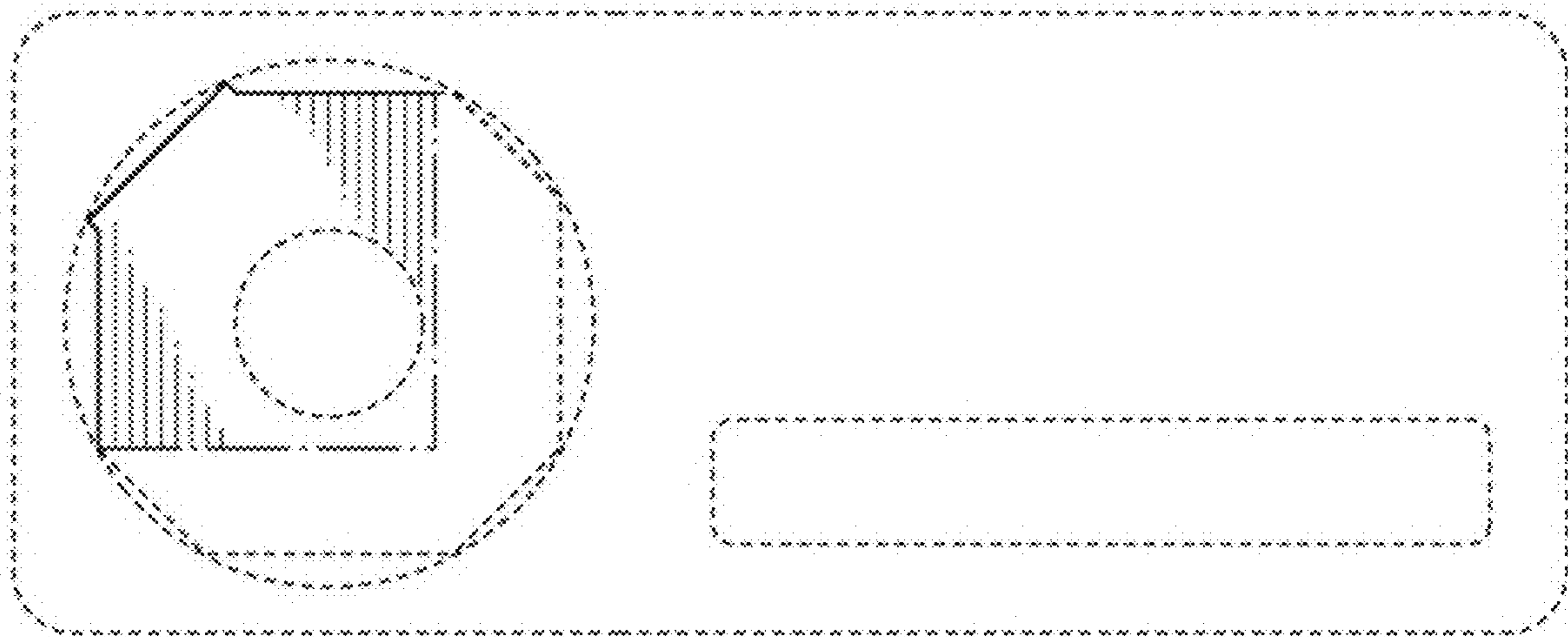

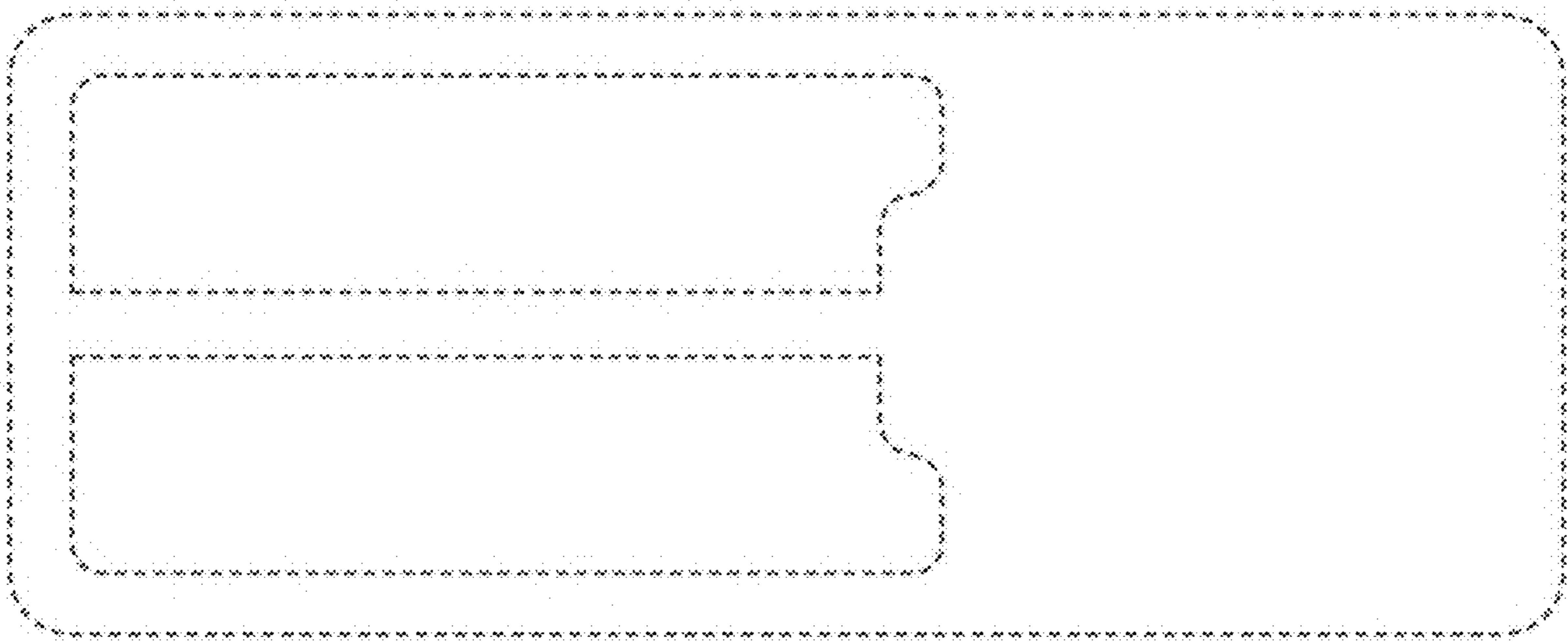

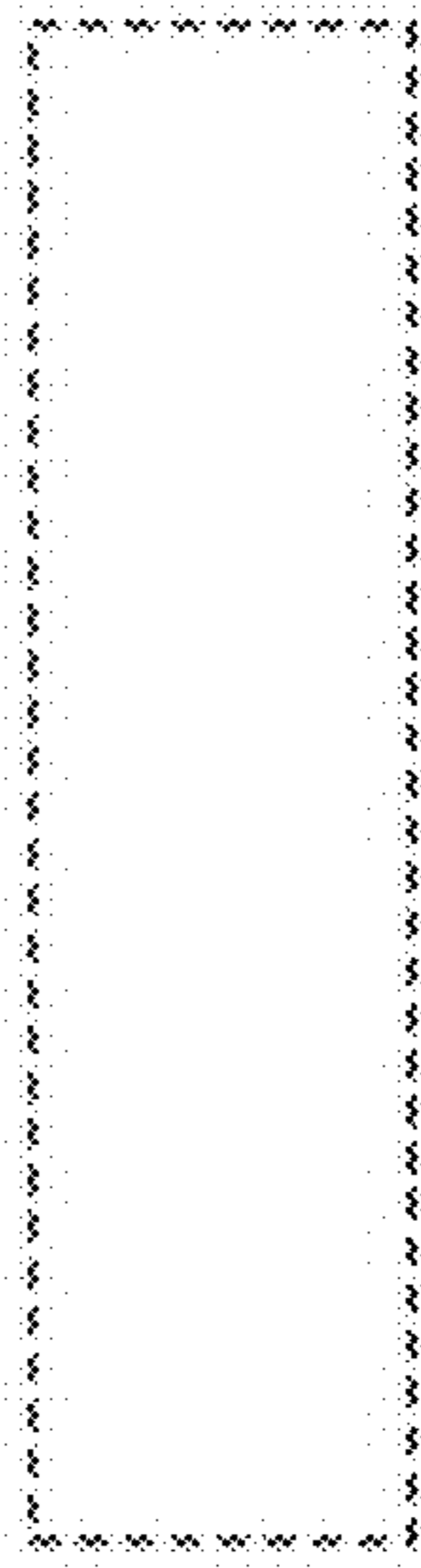

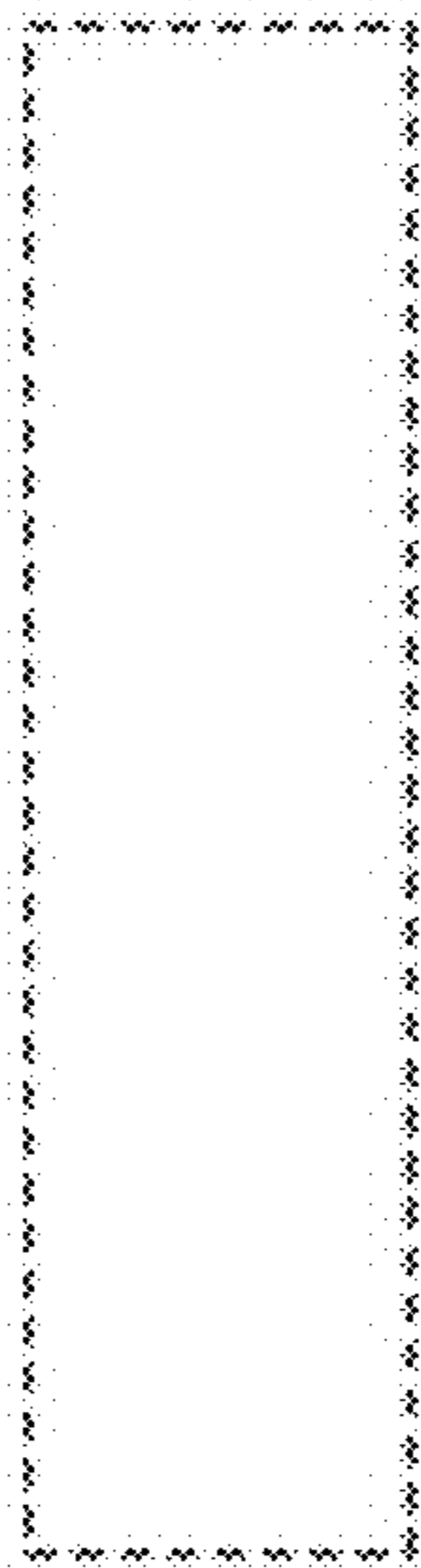

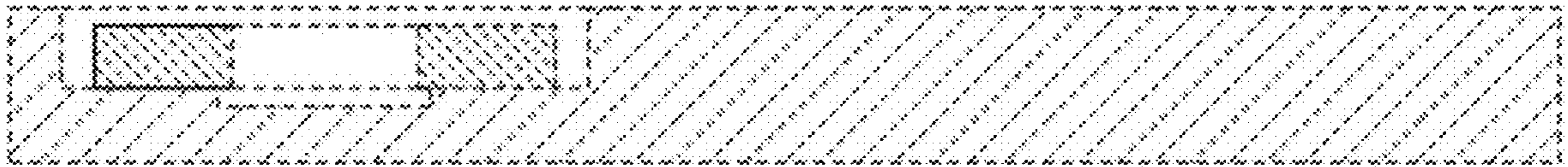

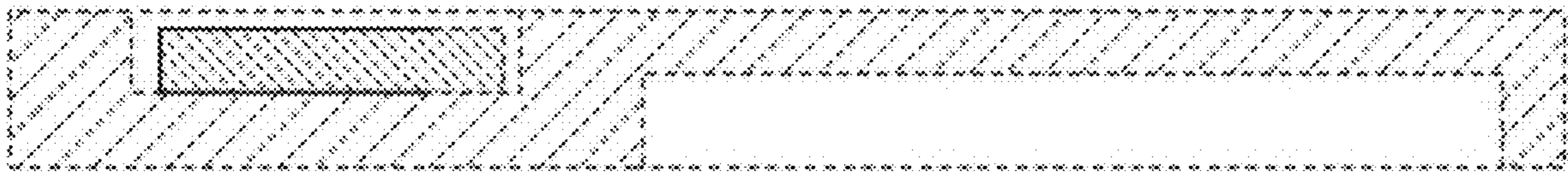

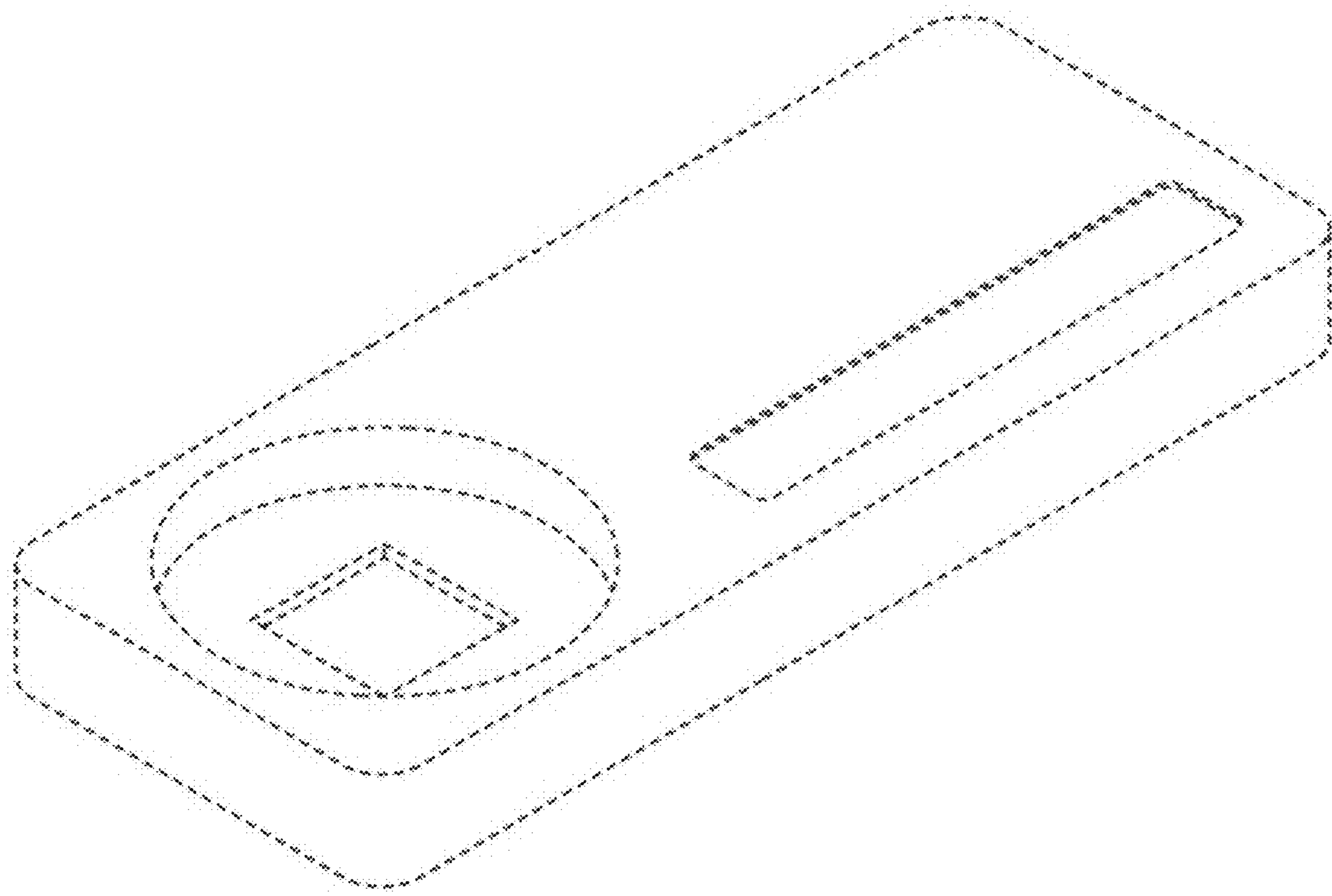
