FIG. 16 is a bottom plan view thereof.

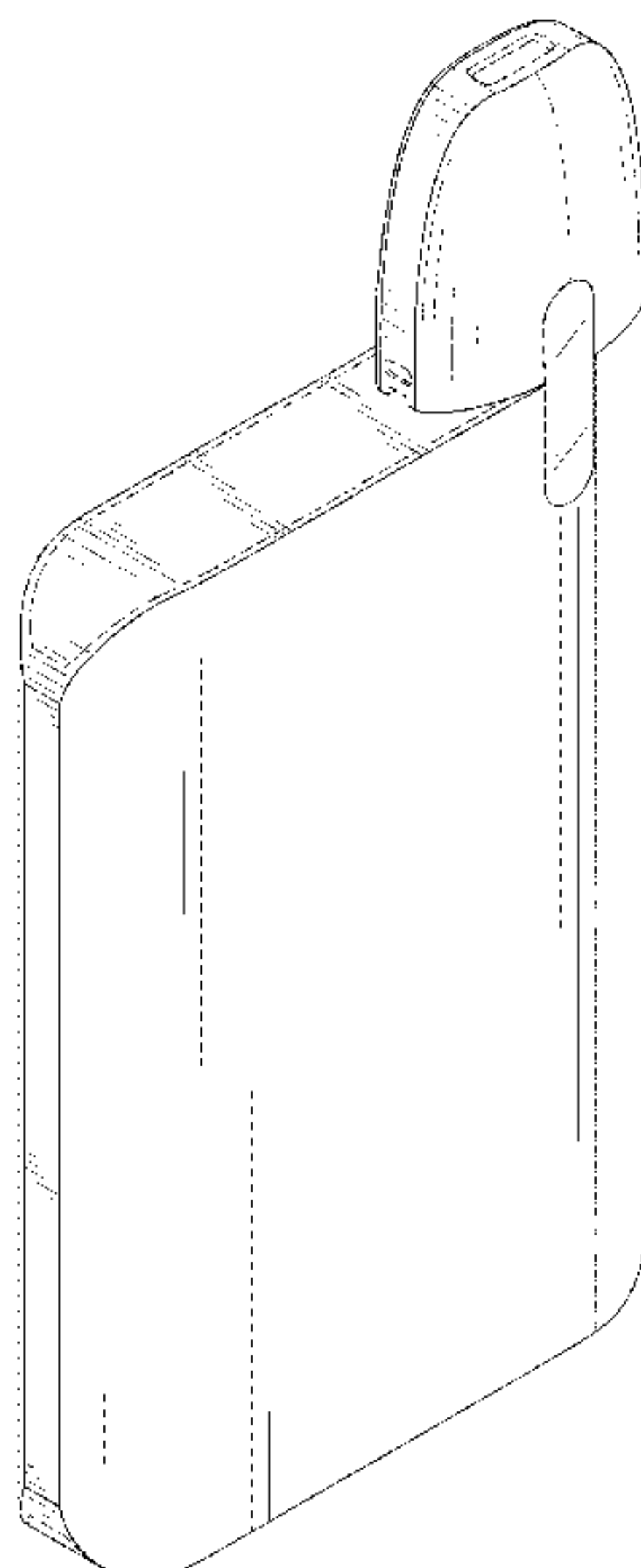
The broken lines in the drawings show portions of the electronic cigarette which form no part of the claimed design.

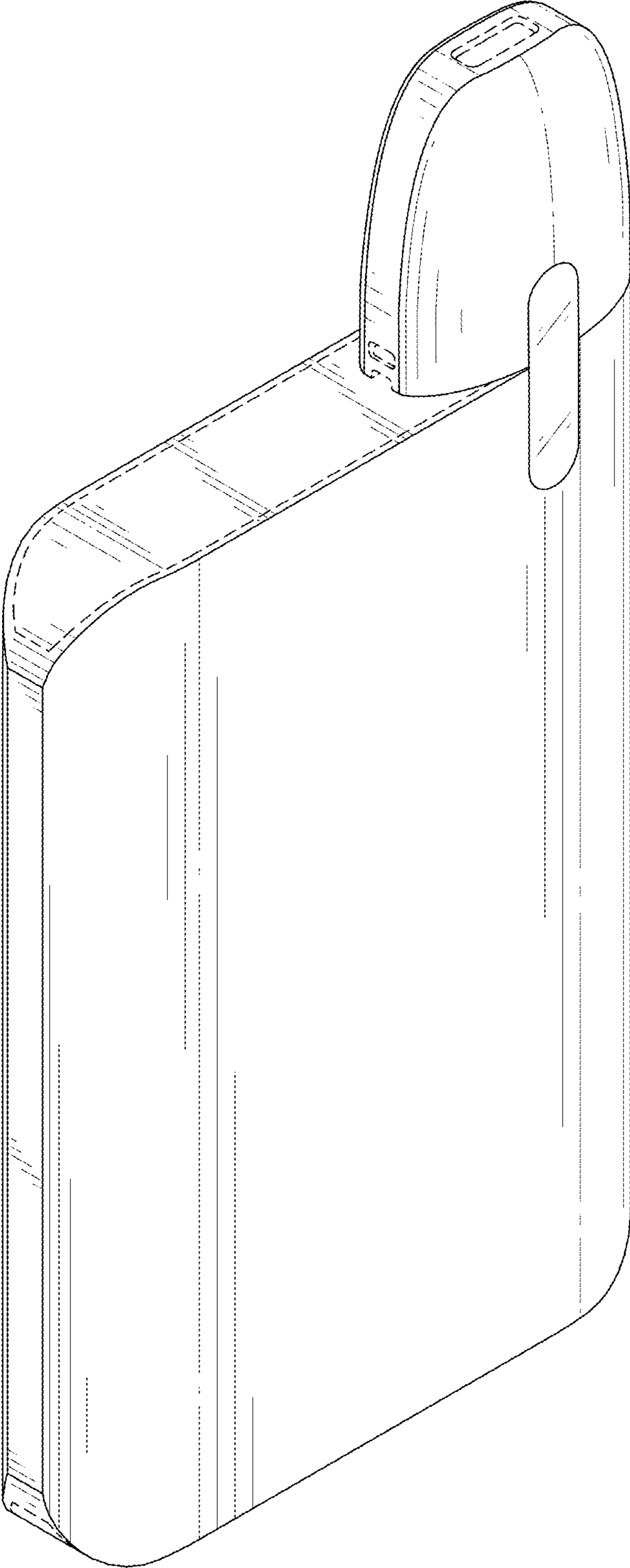

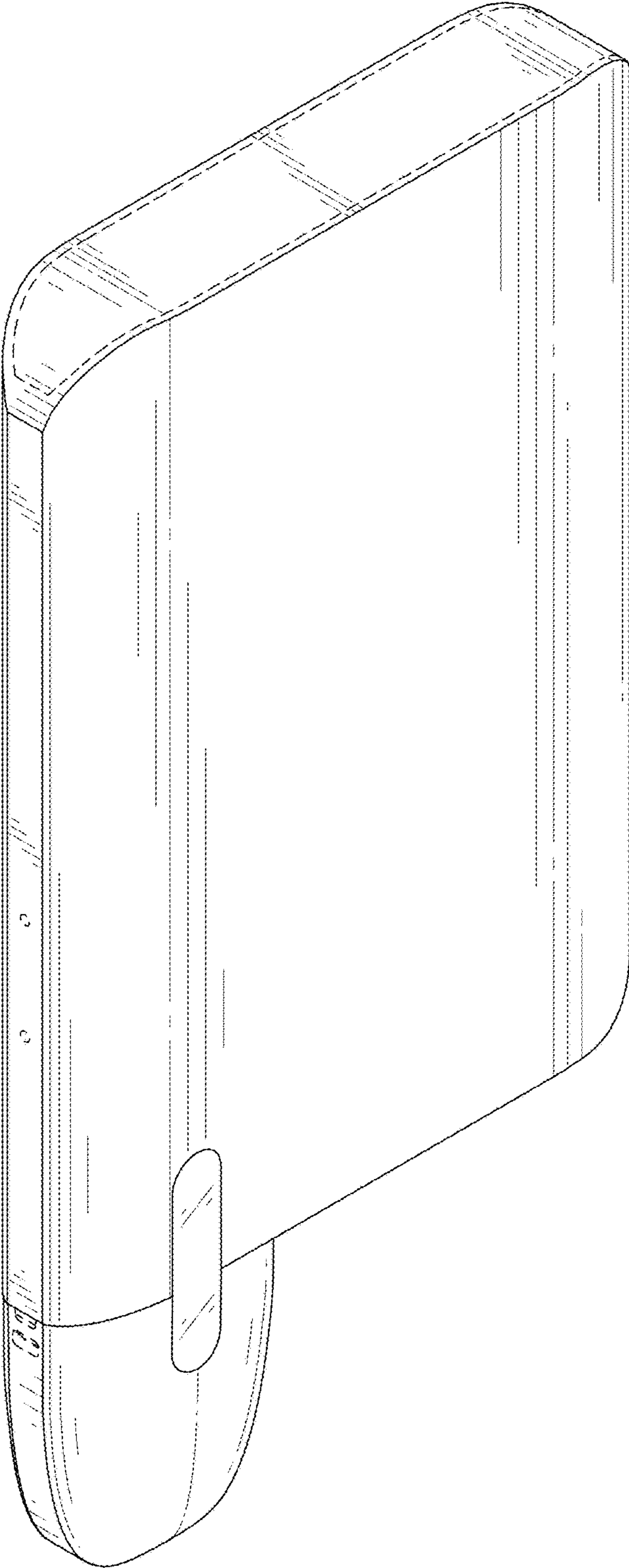

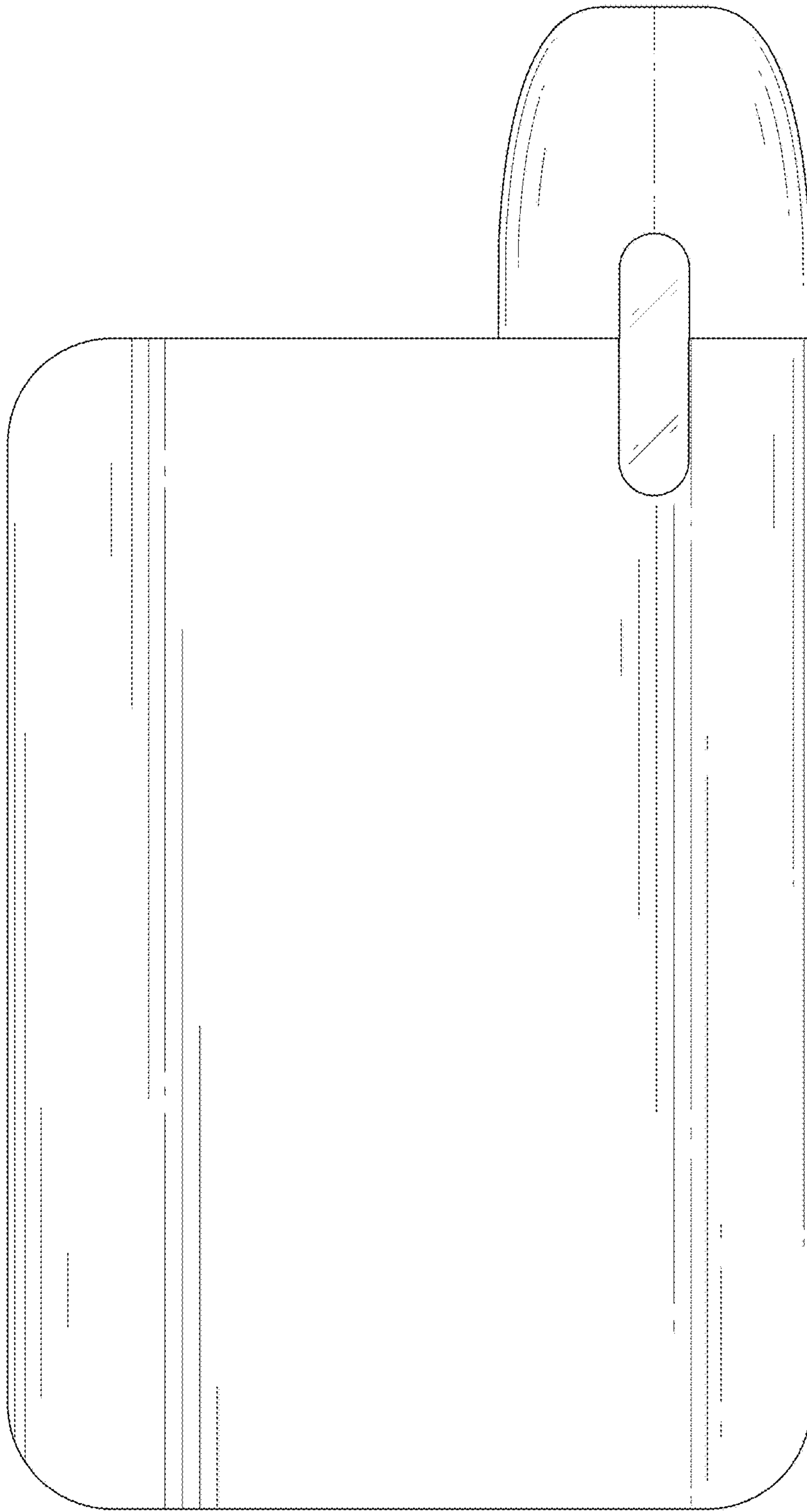

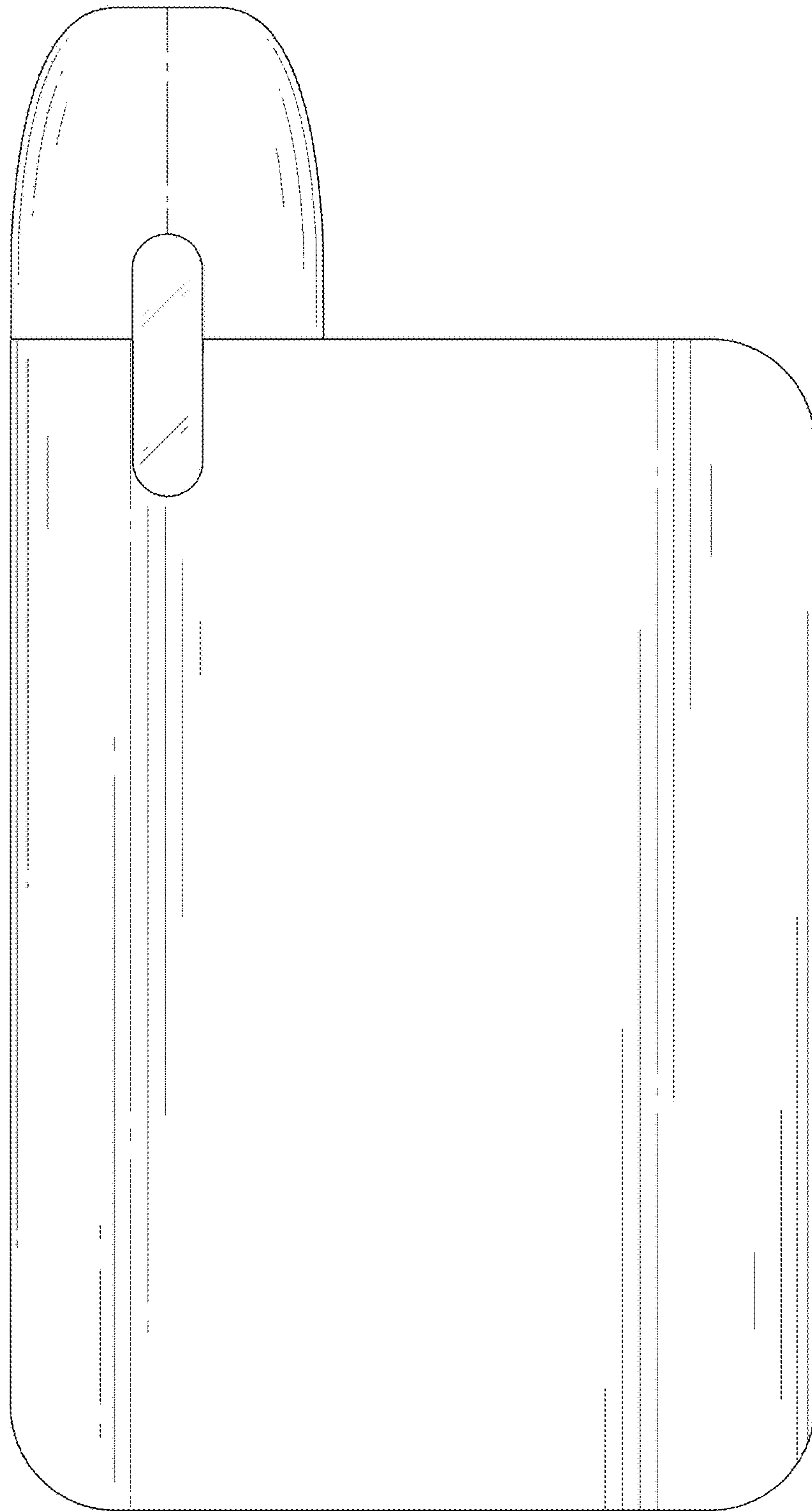

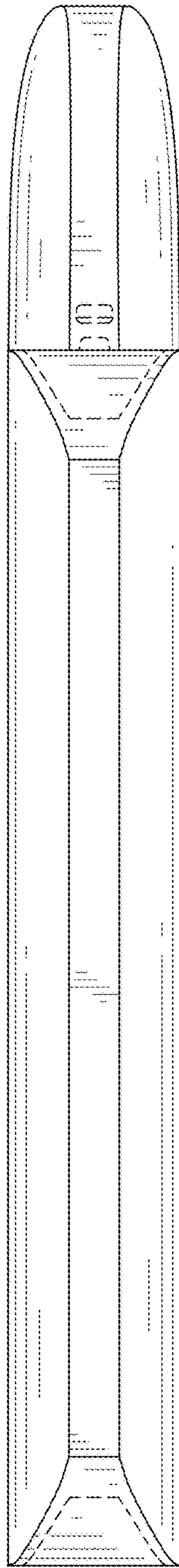

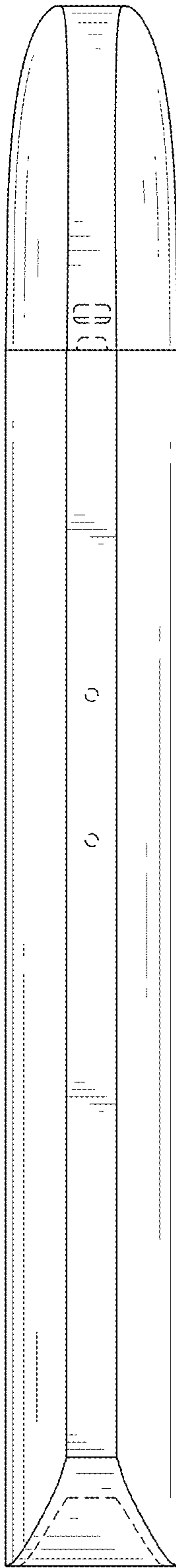

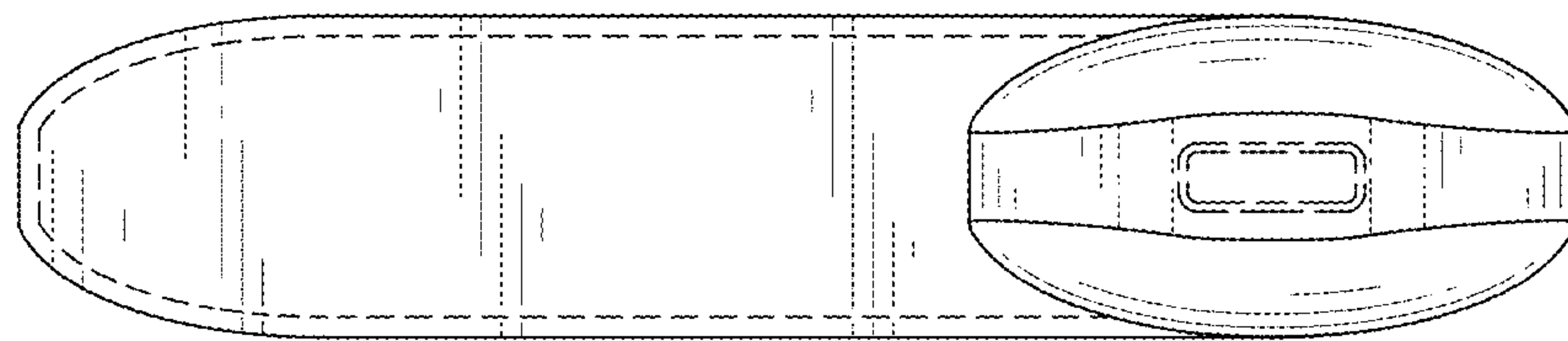

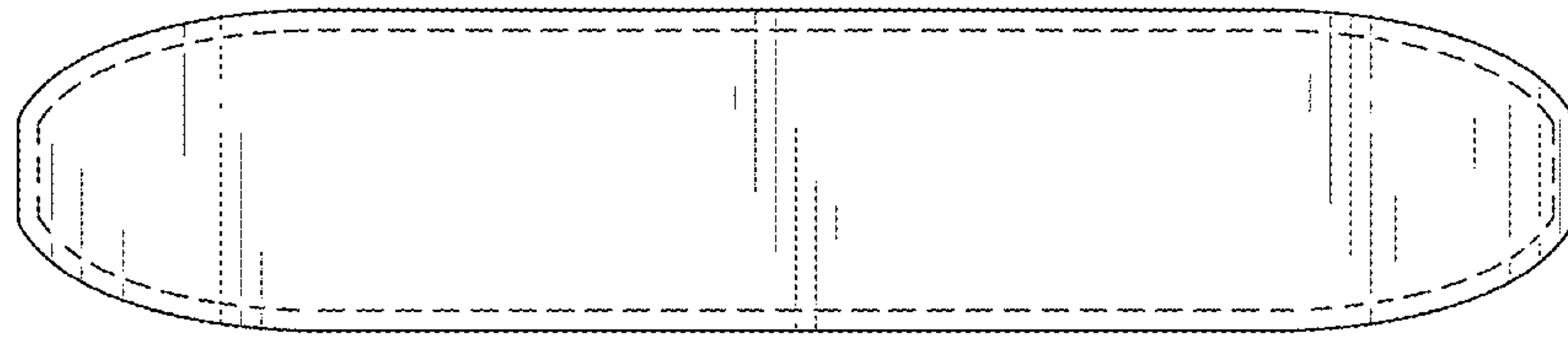

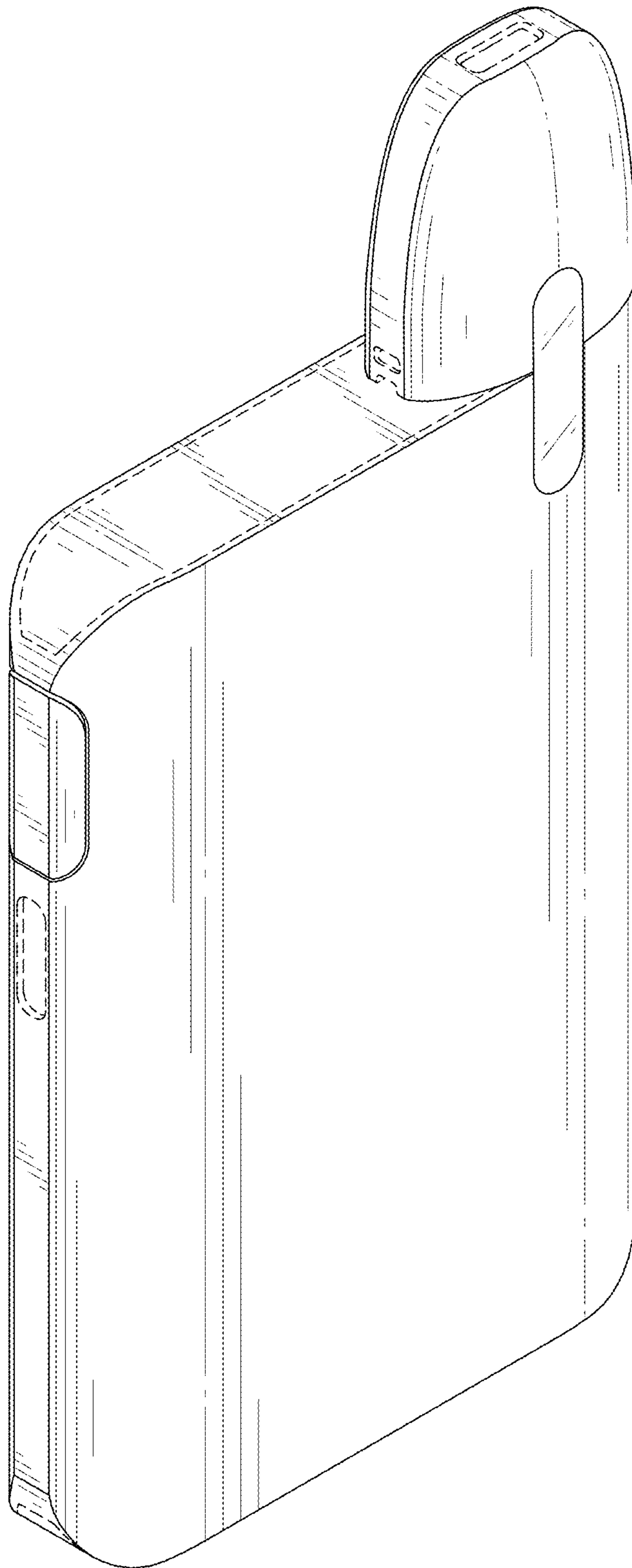

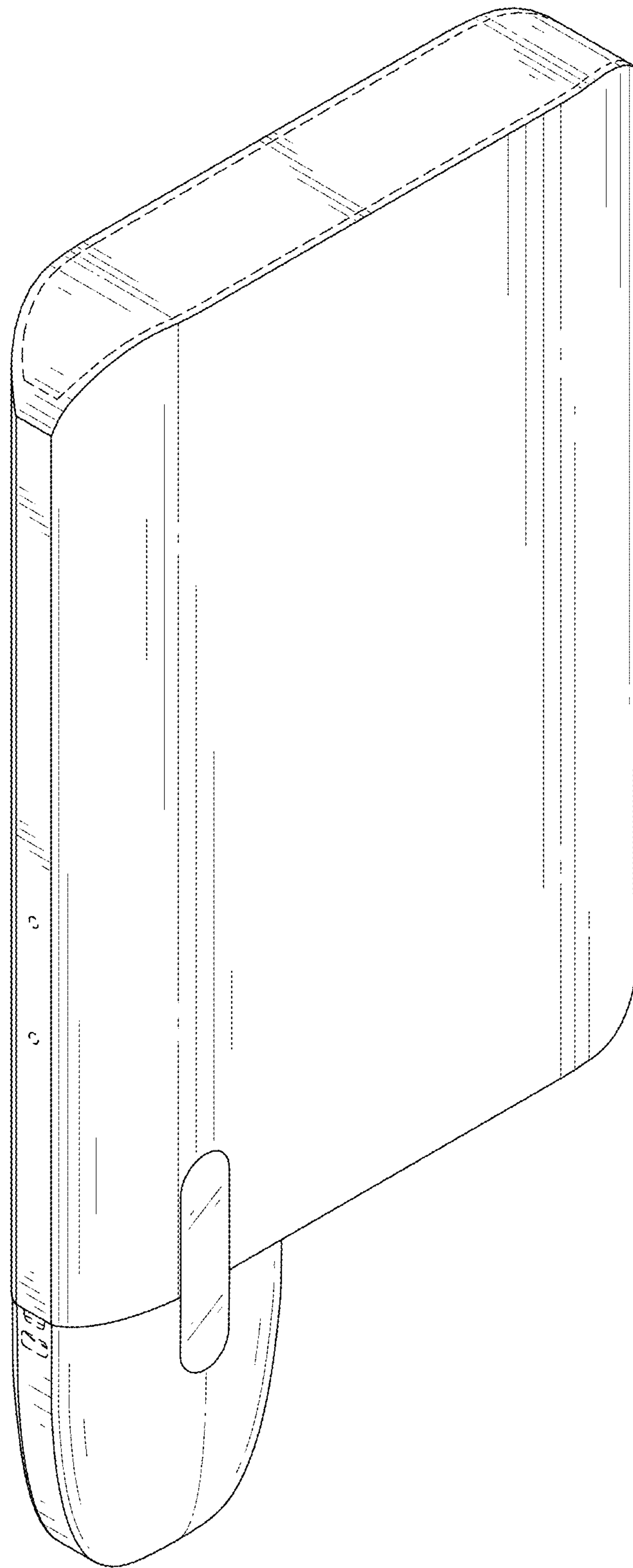

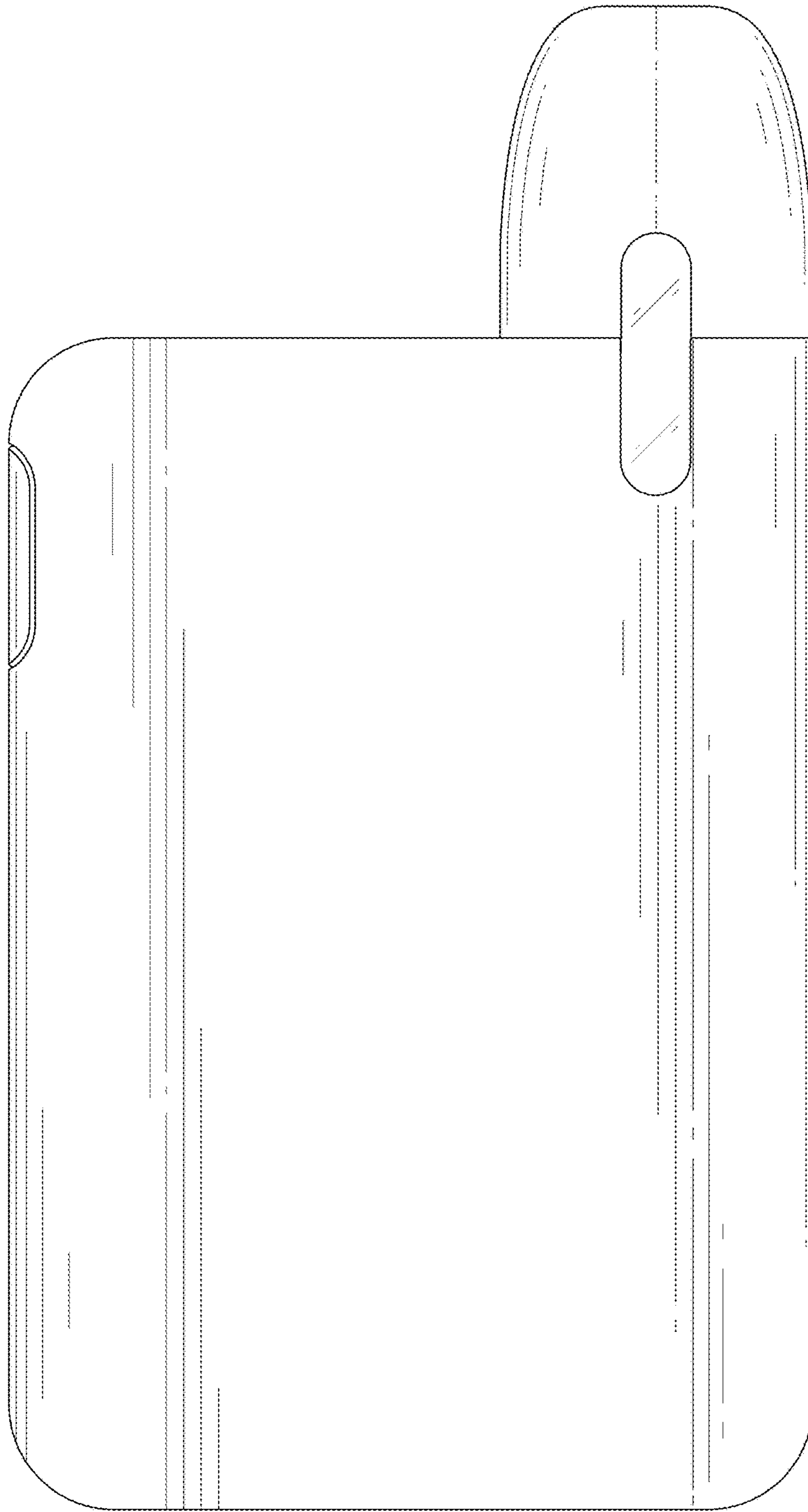

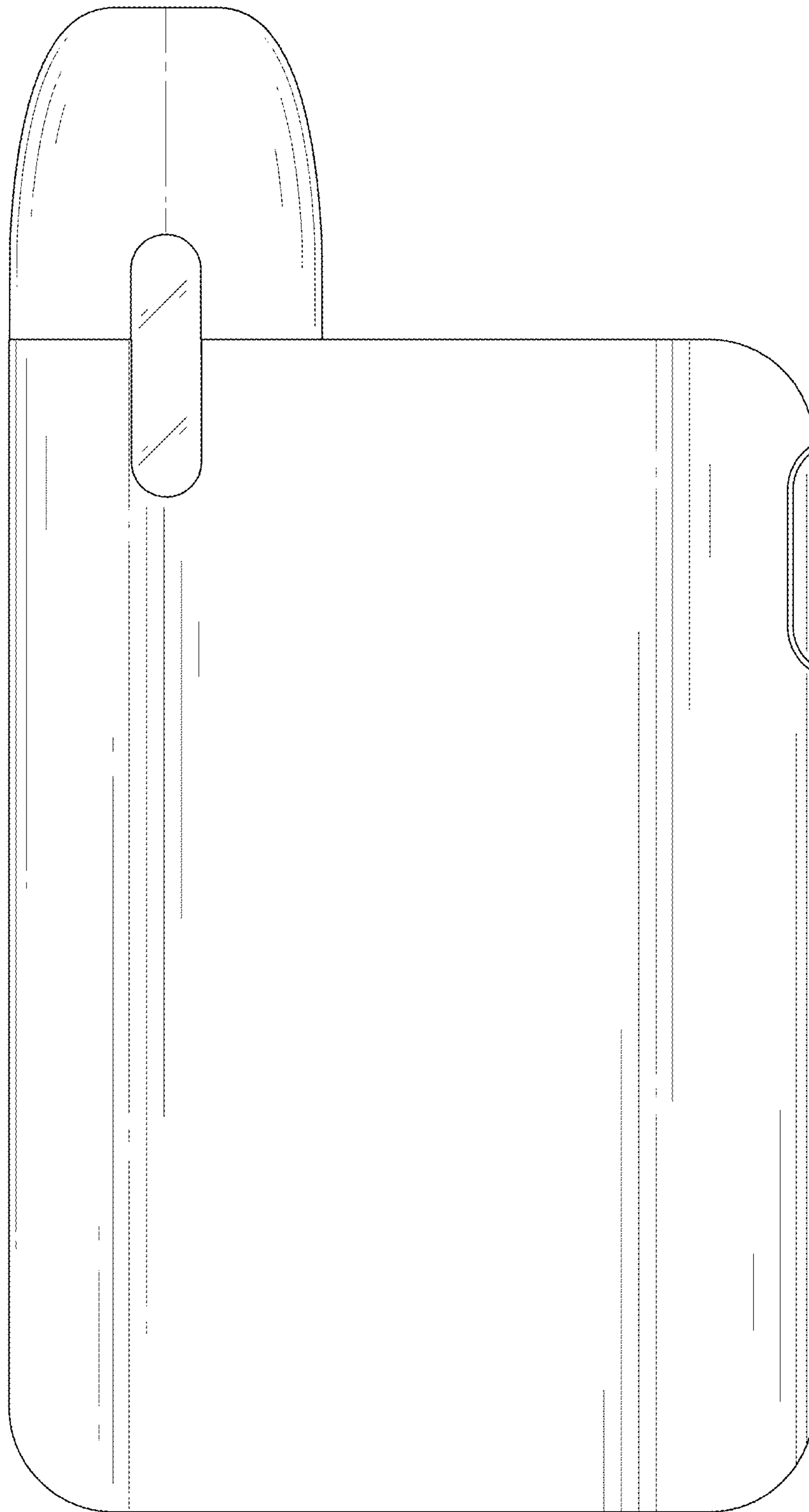

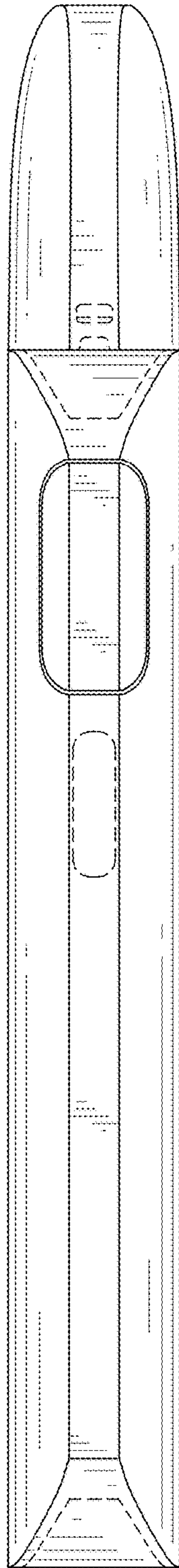

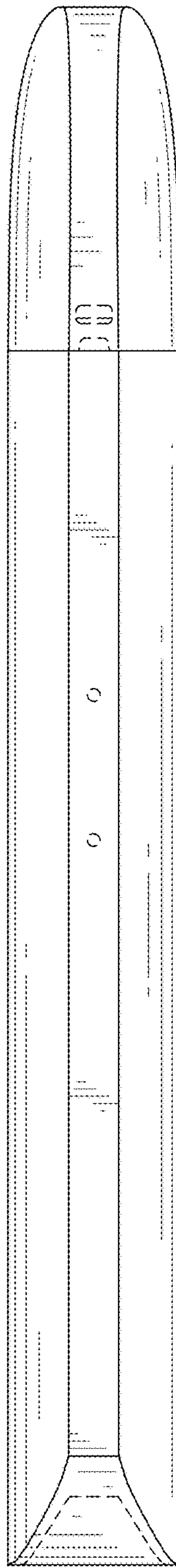

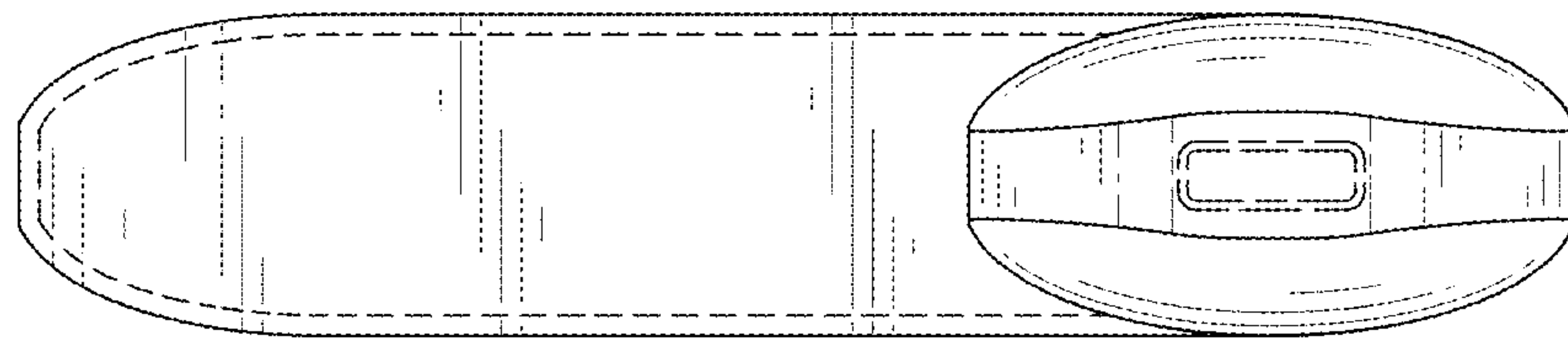

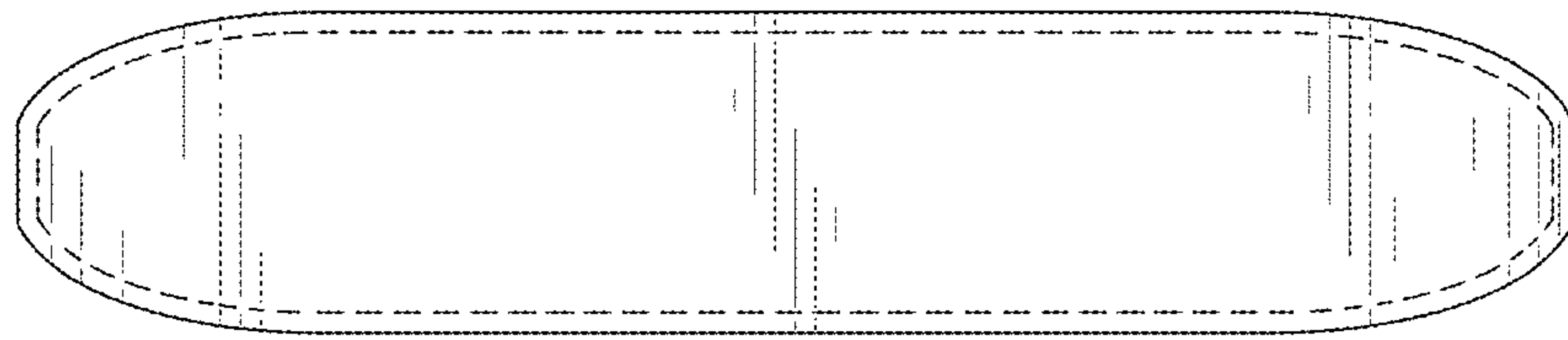
