(57) **CLAIM**

The ornamental design for a chest pad with a pocket, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a chest pad with a pocket, taken from below.

FIG. 2 is a cross-sectional view of the chest pad with a pocket taken along the line 2-2 in FIG. 1. A heatable element, which forms no part of the claimed design, is shown inside of the pocket in dashed lines.

FIG. 3 is second perspective view of the chest pad with a pocket, taken from above.

FIG. 4 is a bottom elevation view of the chest pad with a pocket.

FIG. 5 is a top elevation view of the chest pad with a pocket. A heatable element, which forms no part of the claimed design, is shown inside of the pocket in dashed lines.

FIG. 6 is a left side elevation view of the chest pad with a pocket.

FIG. 7 is a right side elevation view of the chest pad with a pocket.

FIG. 8 is a front elevation view of the chest pad with a pocket.

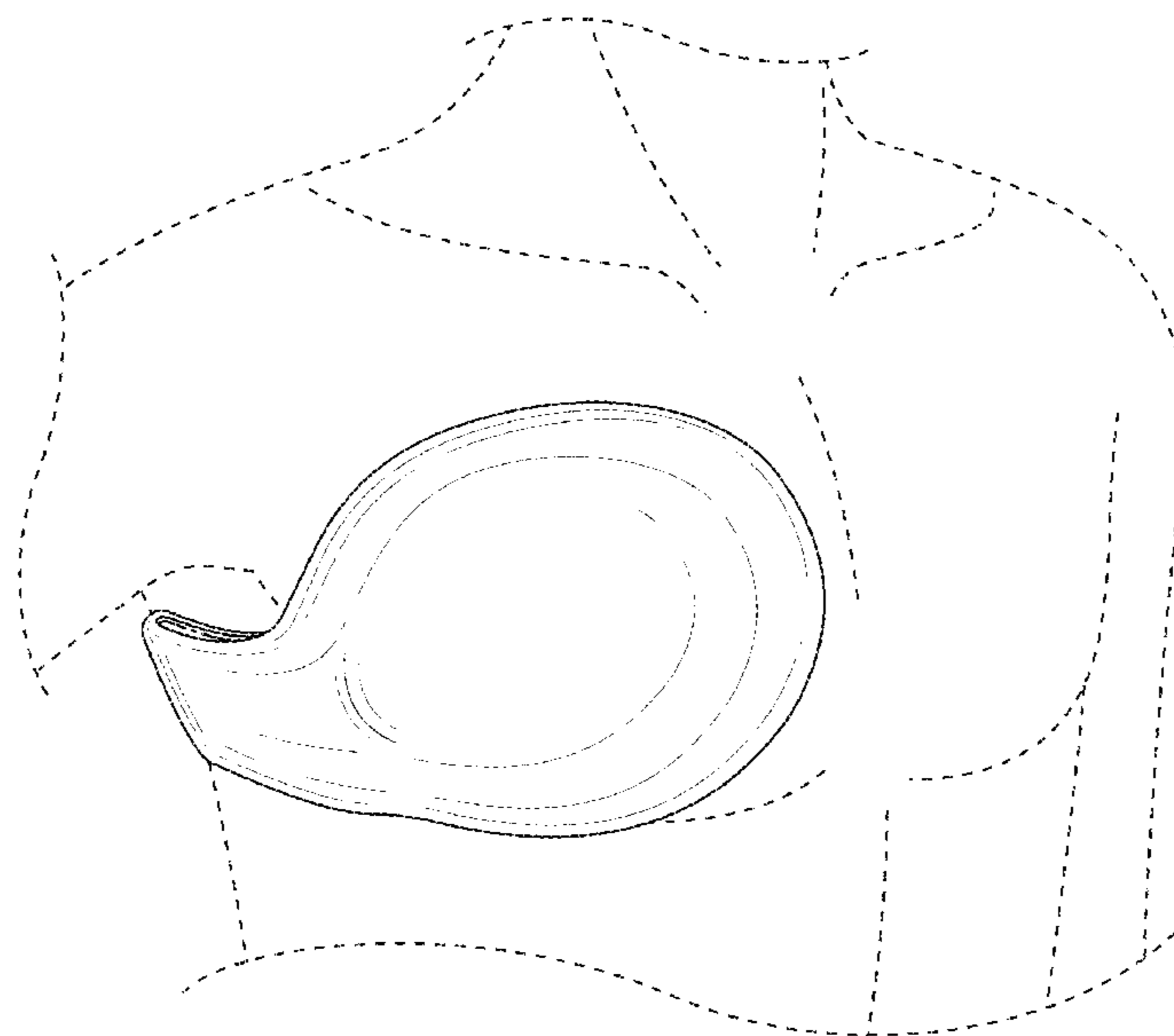
FIG. 9 is a back elevation view of the chest pad with a pocket; and,

FIG. 10 is a third perspective view of the chest pad with a pocket positioned on a subject.

The dot-dash lines in the drawings illustrate unclaimed boundaries of the chest pad with a pocket and form no part of the claimed design. The claimed design extends to the dot-dash line boundaries but does not include the boundaries or the area within the boundaries.

As described above, the dashed lines in the drawings illustrate unclaimed environment of the chest pad with a pocket and form no part of the claimed design.

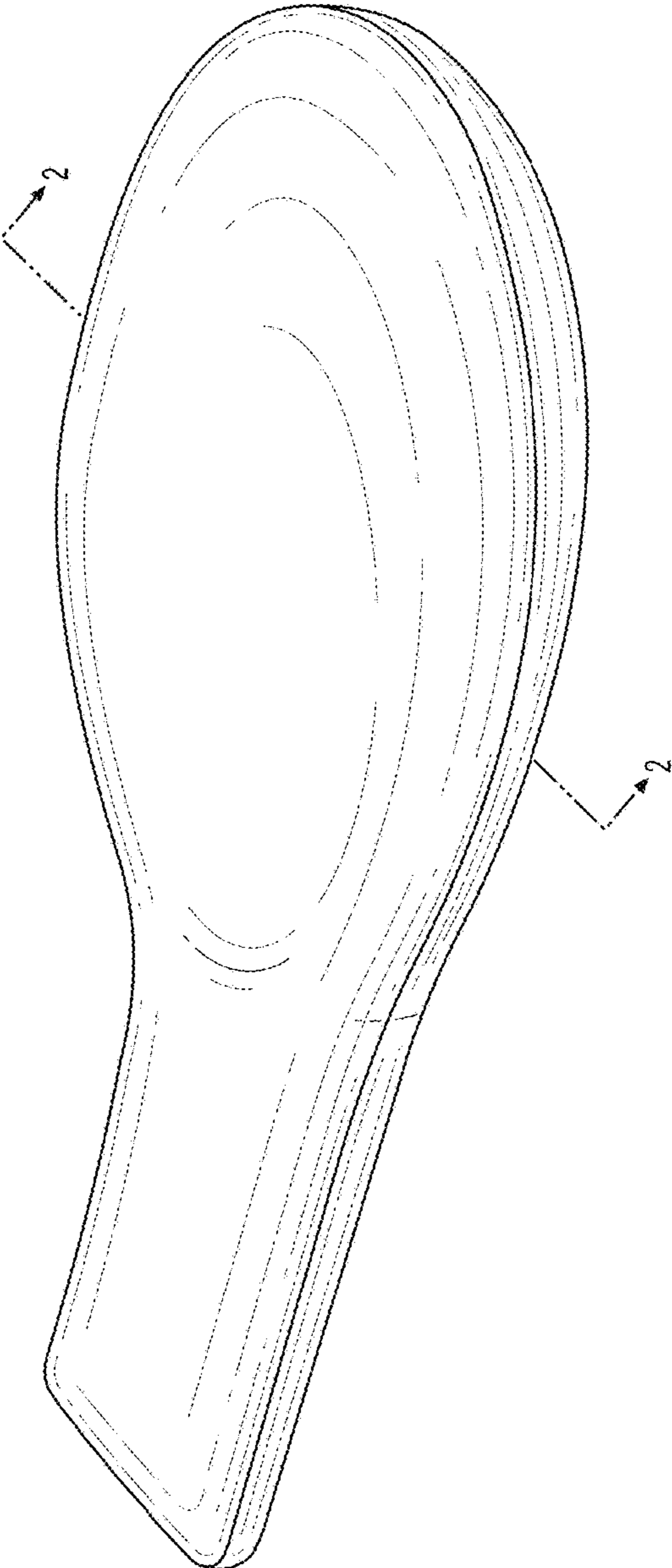

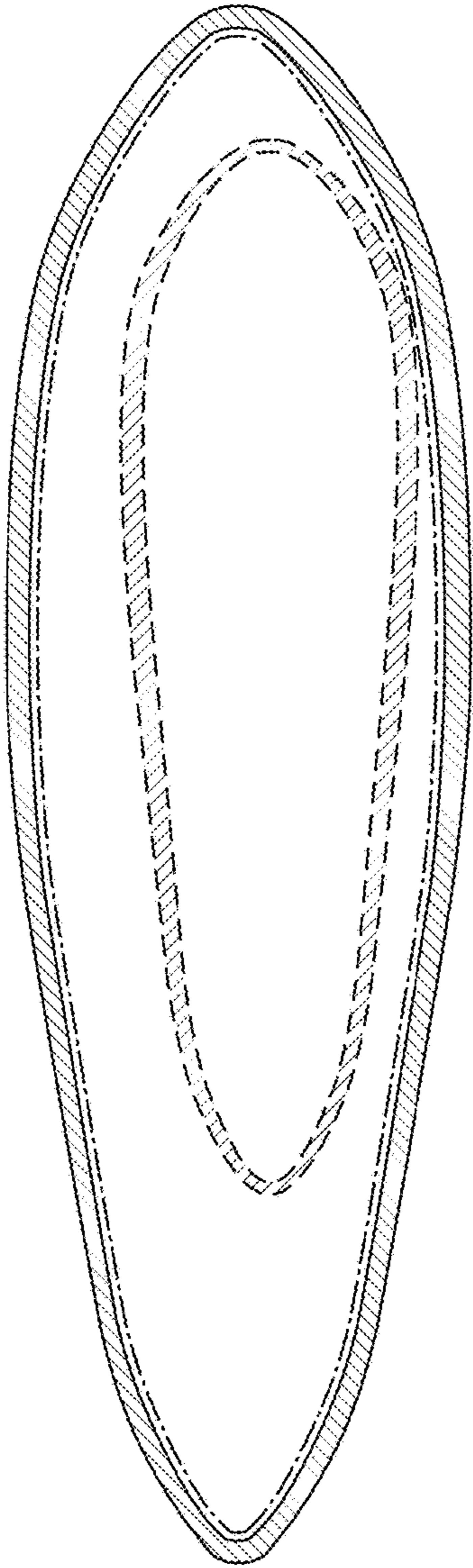

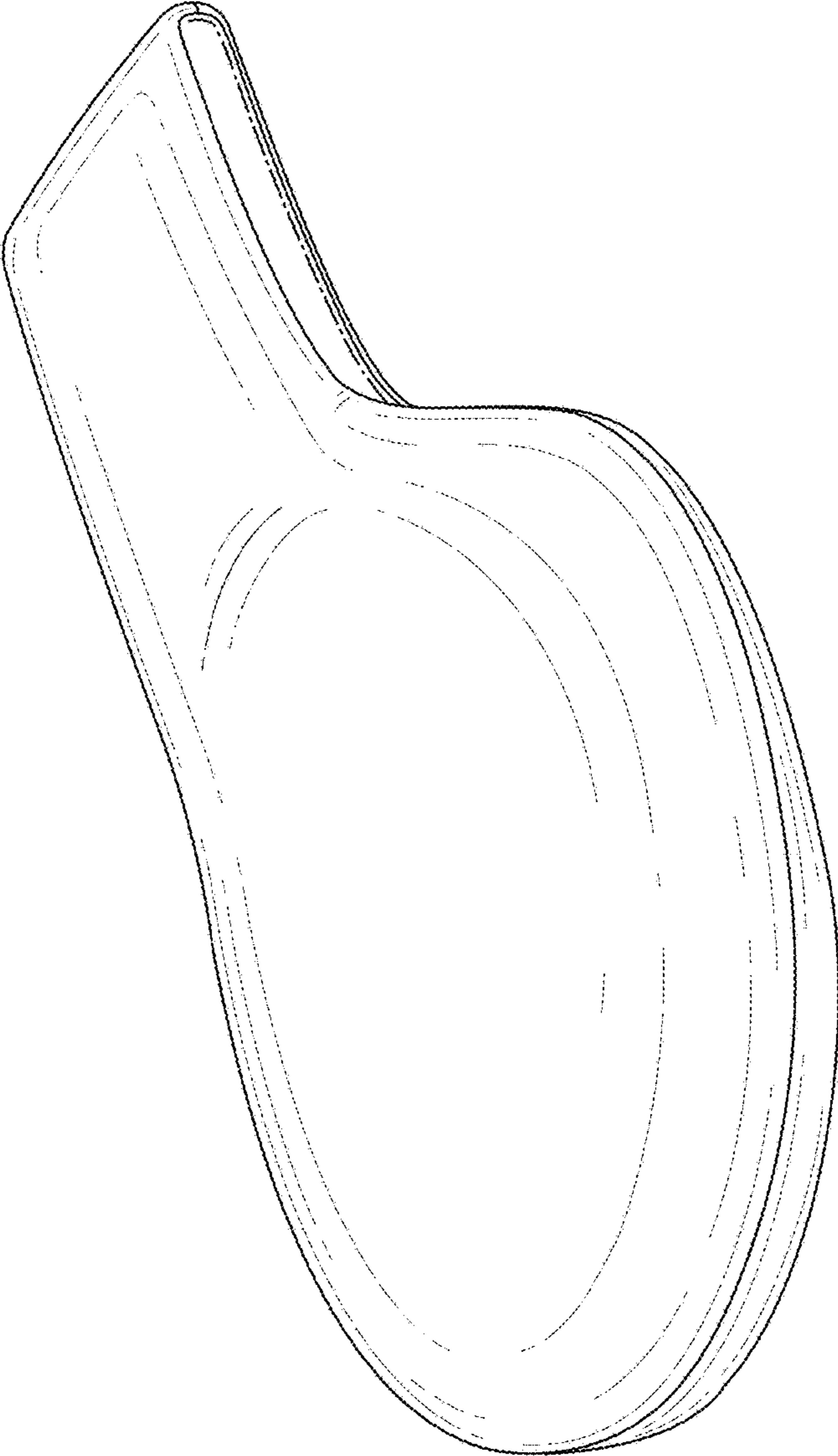

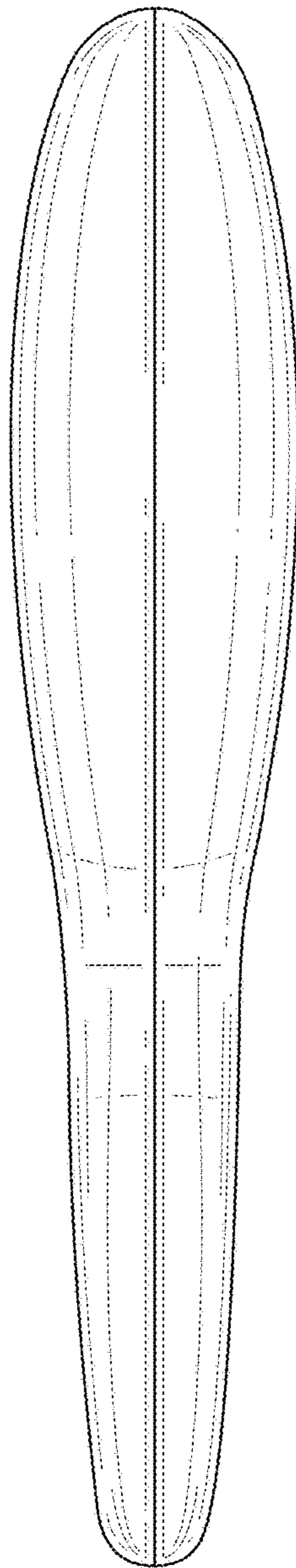

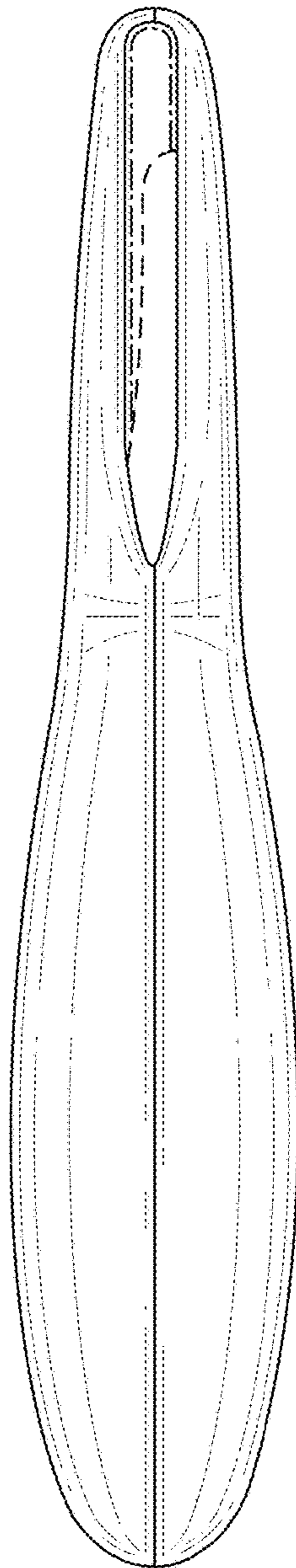

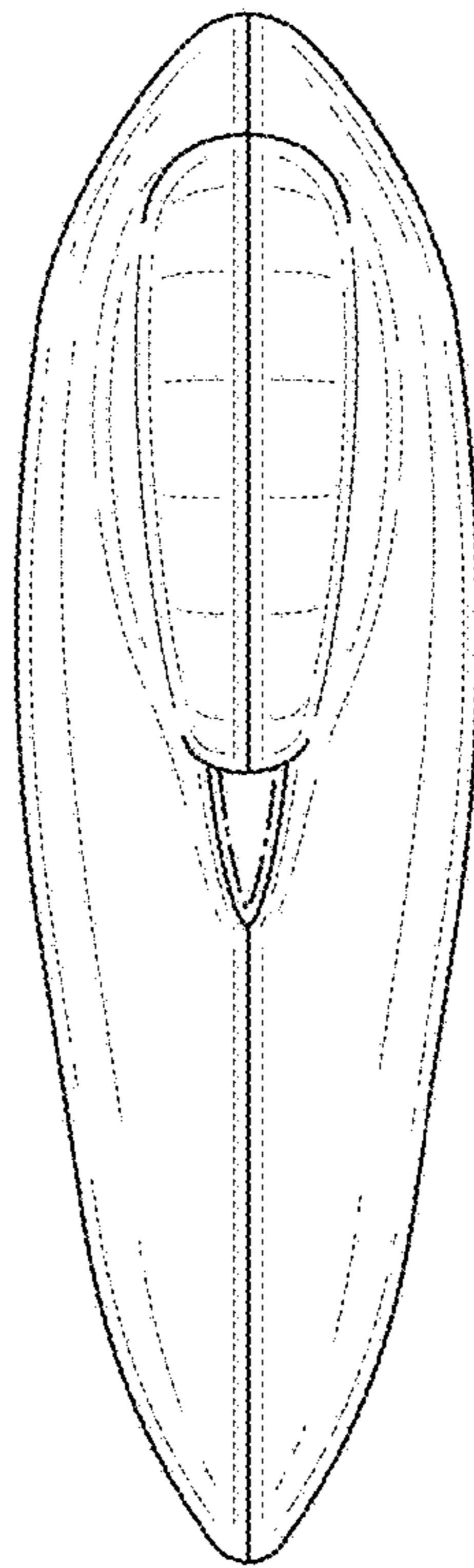

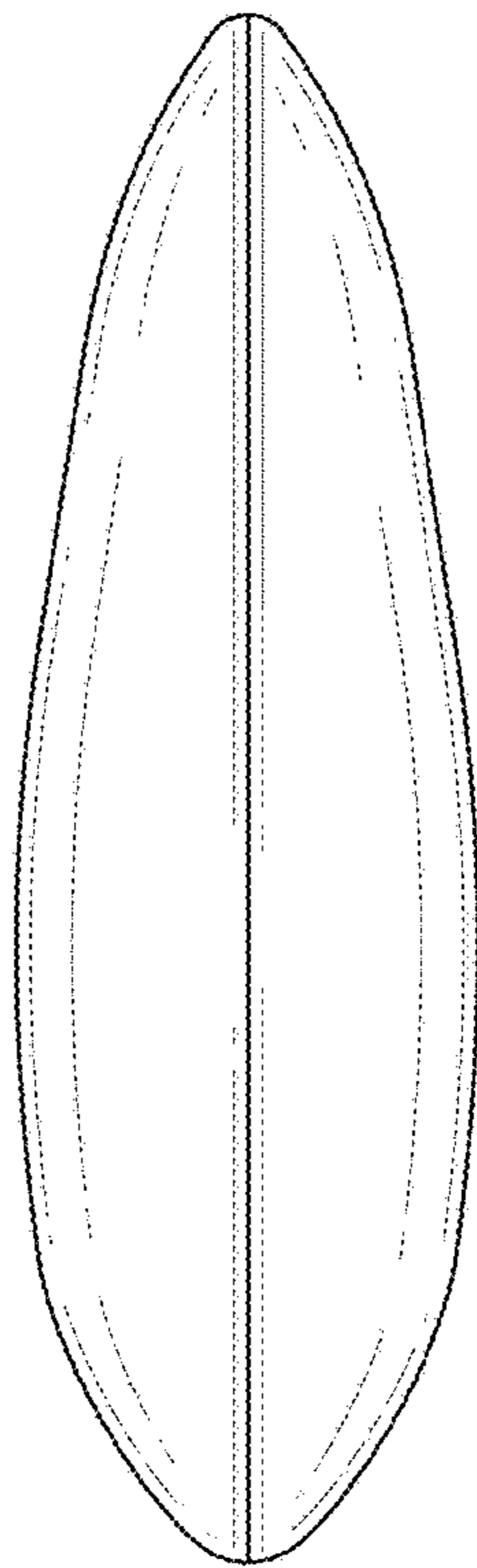

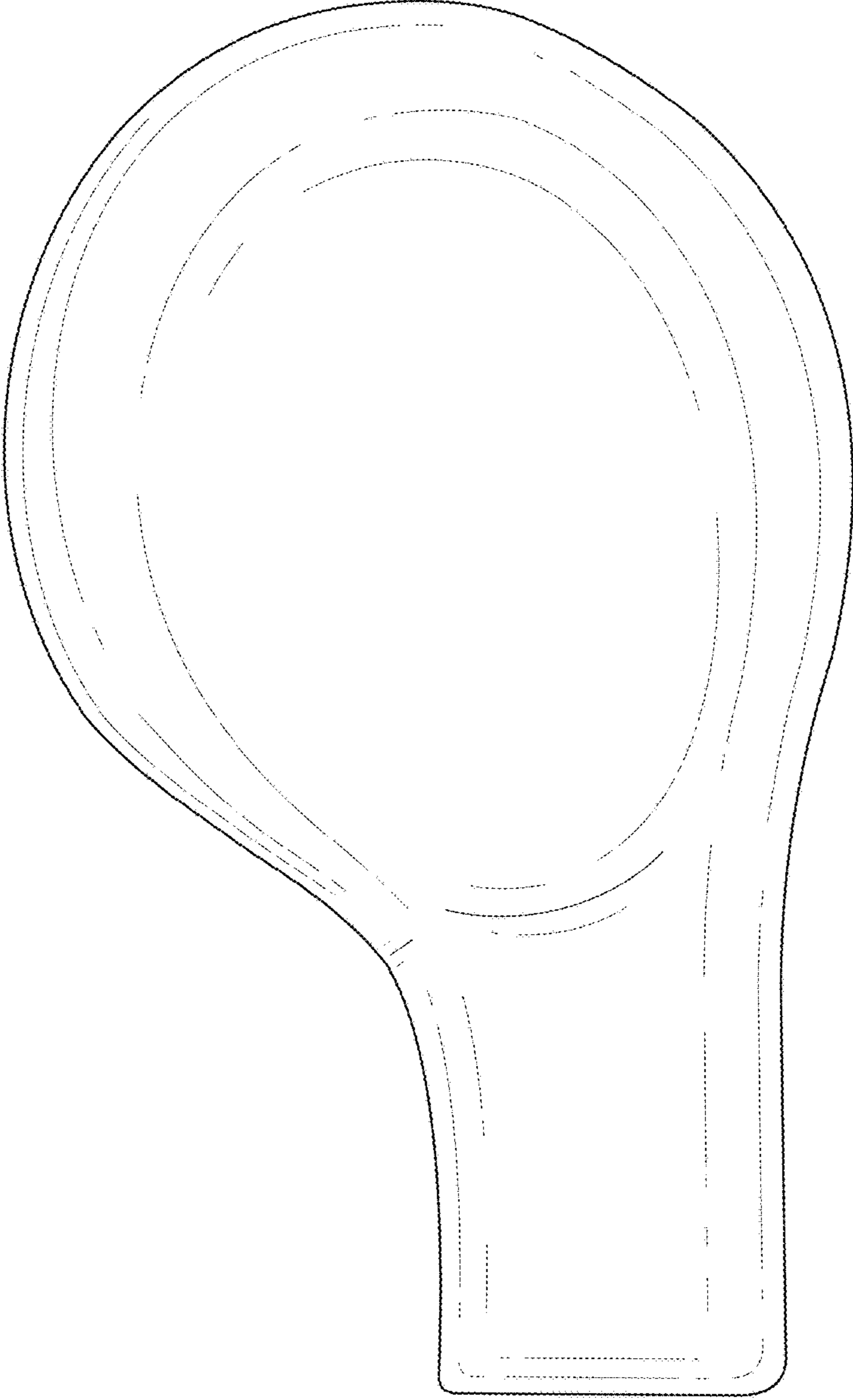

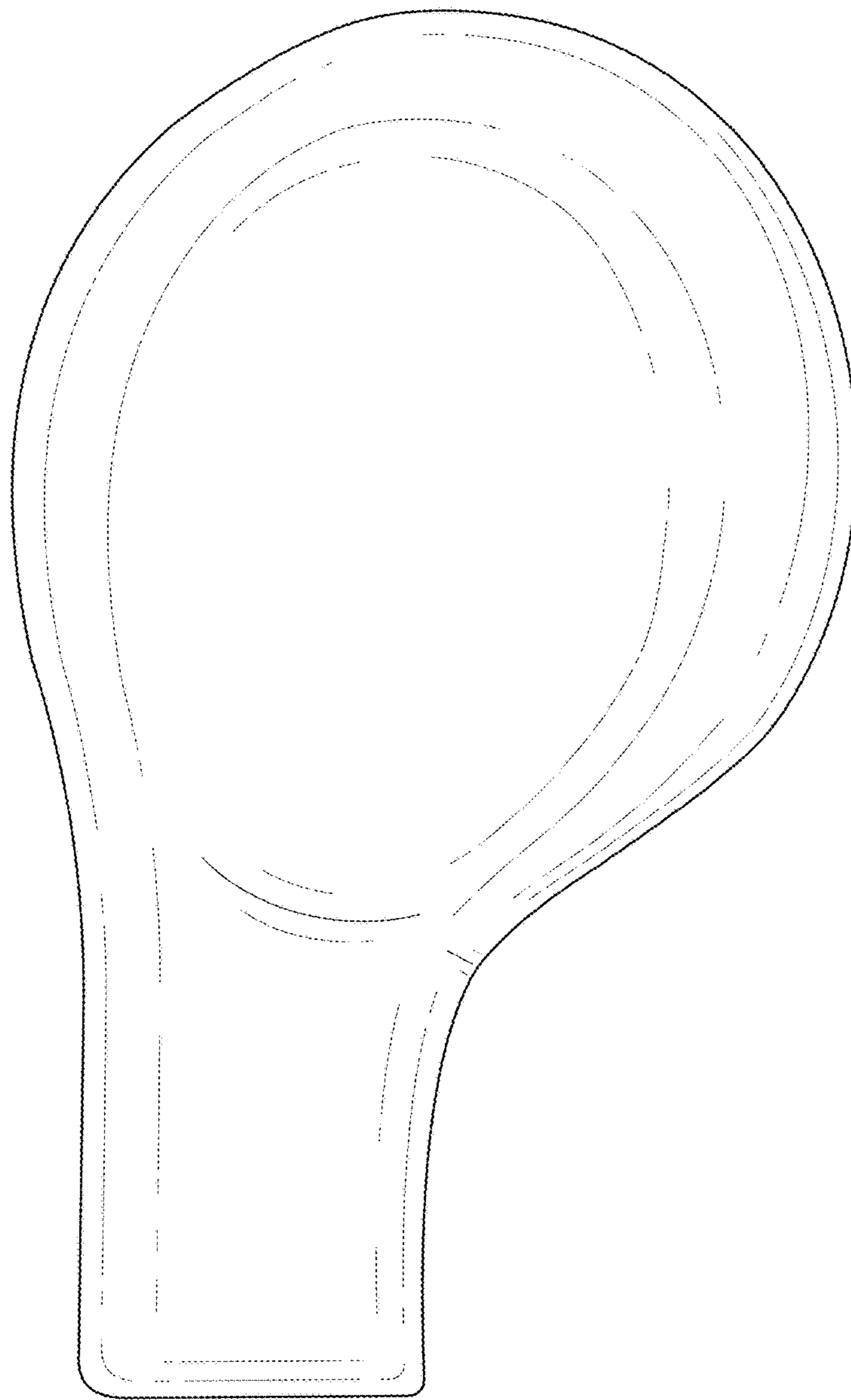

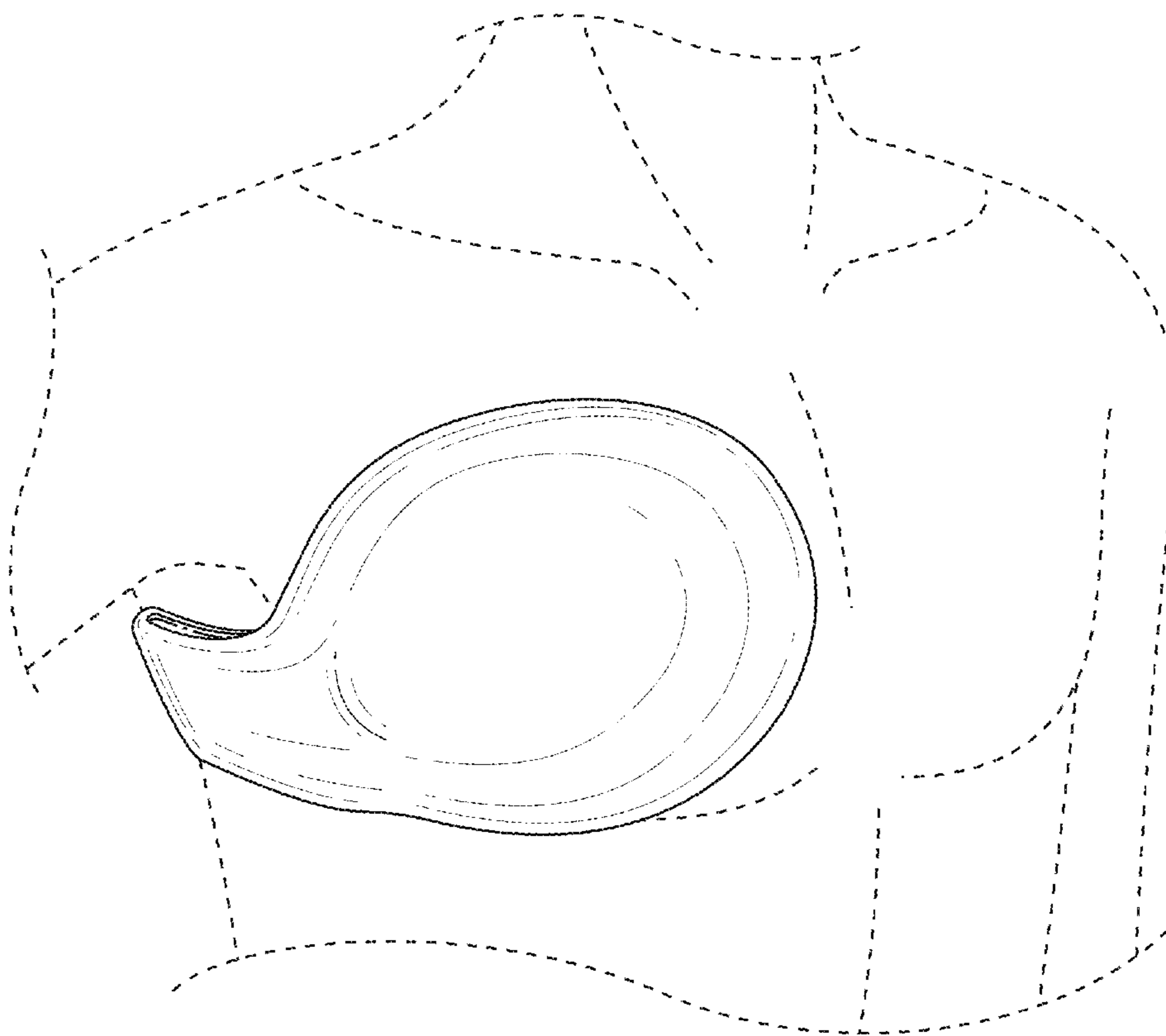
