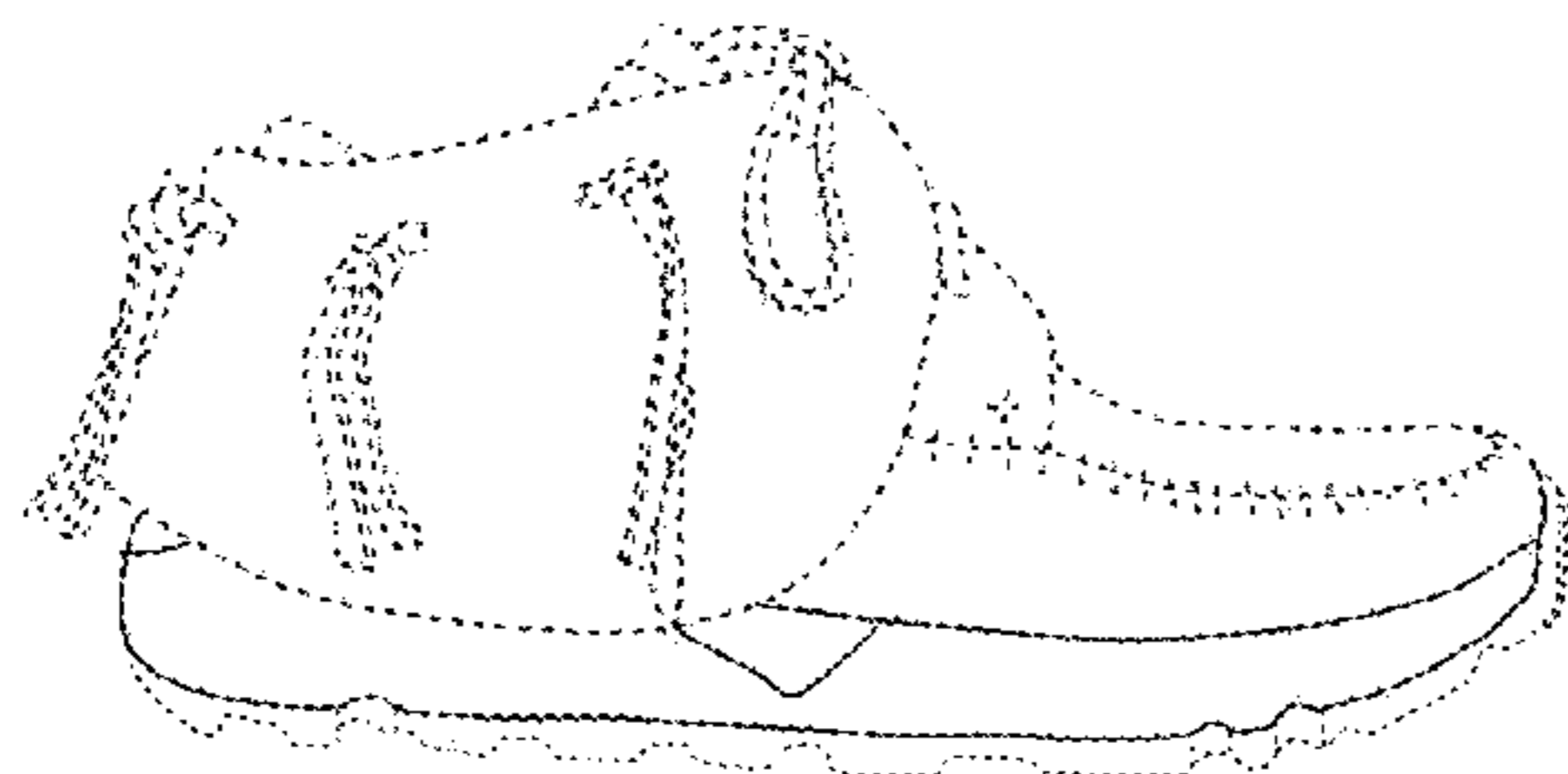
(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a shoe sole, showing my new design;
 FIG. 2 is a back view thereof;
 FIG. 3 is a top view thereof;
 FIG. 4 is a bottom view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a left side view thereof;
 FIG. 7 is a perspective view thereof; and,
 FIG. 8 is an enlarged, partial view of the front portion of FIG. 6 showing details not clearly shown in the FIG. 6 view. The broken lines depict environmental structure in the form of a shoe upper and bottom part of a shoe sole. The broken lines and structure they depict form no part of the claimed design. There are also broken lines in the FIG. 8 view that indicate the location of where the enlarged, partial view is cut off from the larger full view, and these broken lines also form no part of the claimed design.

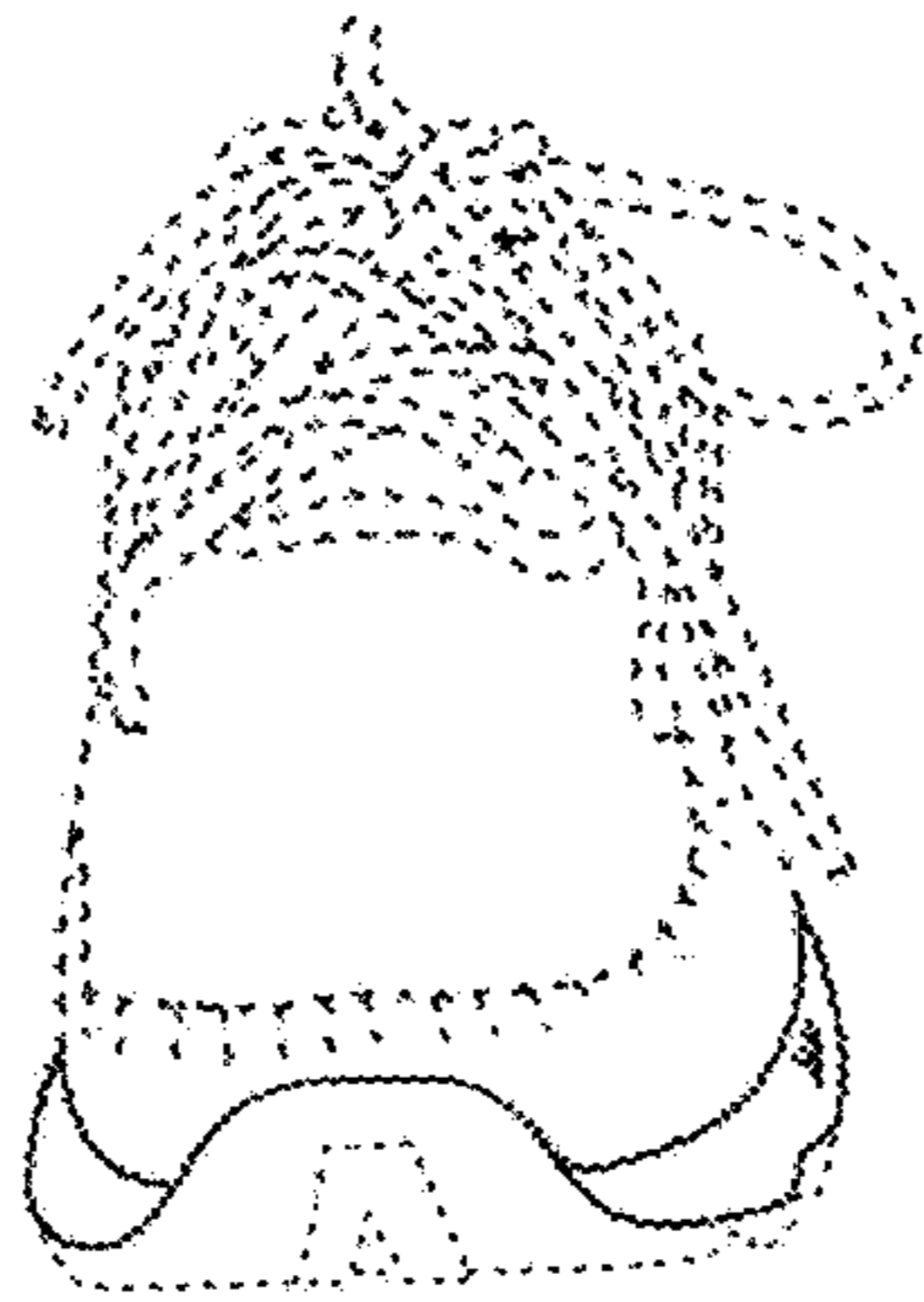

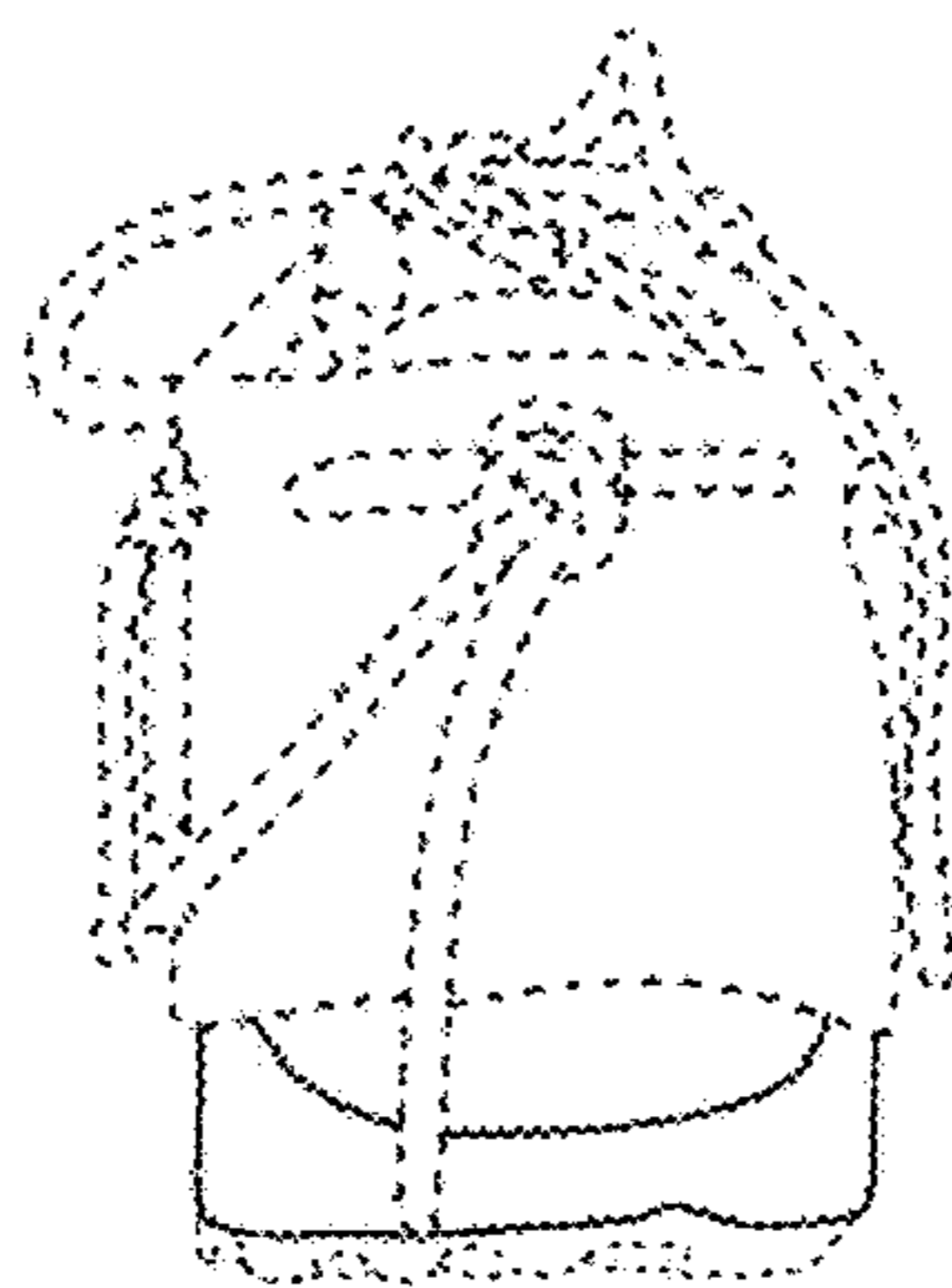

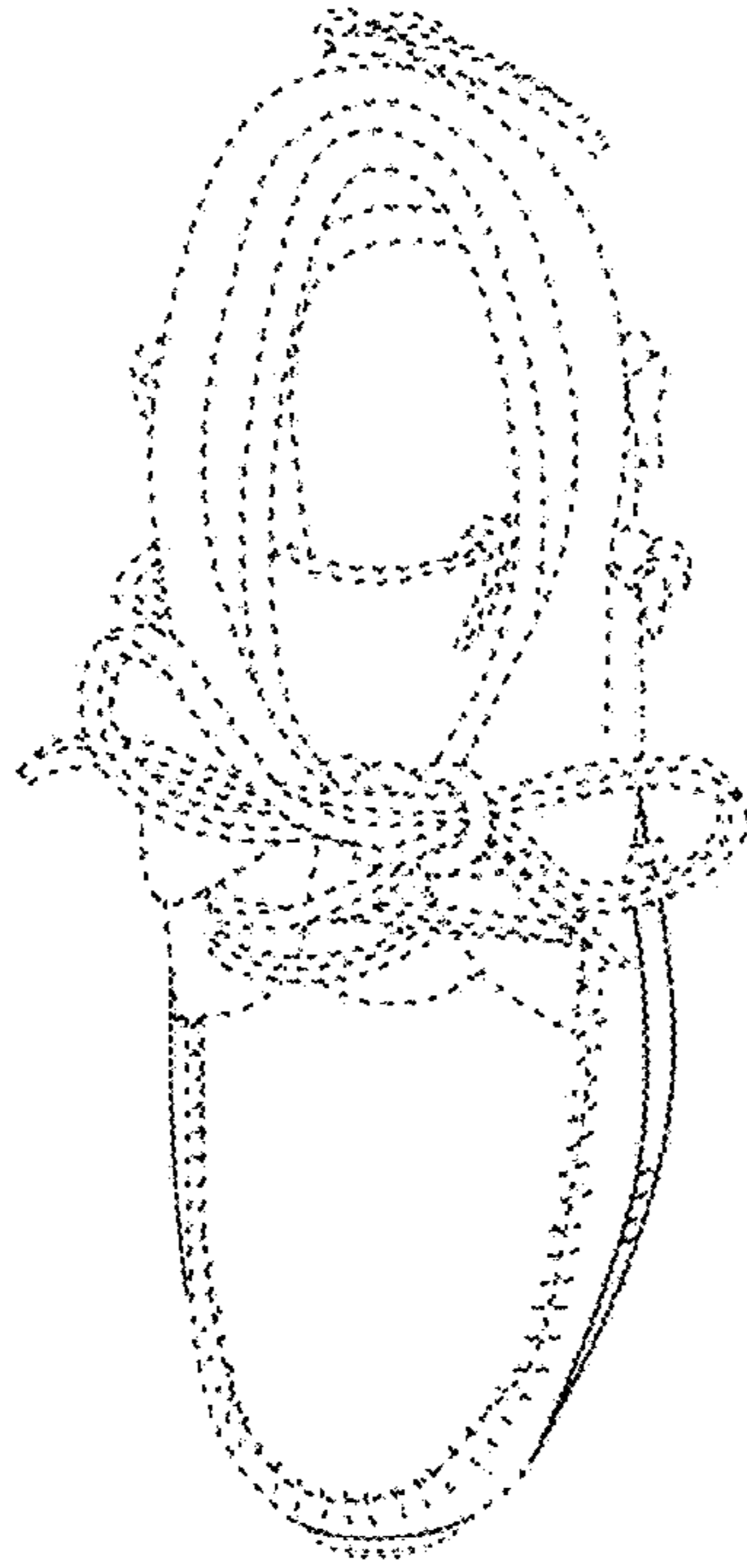

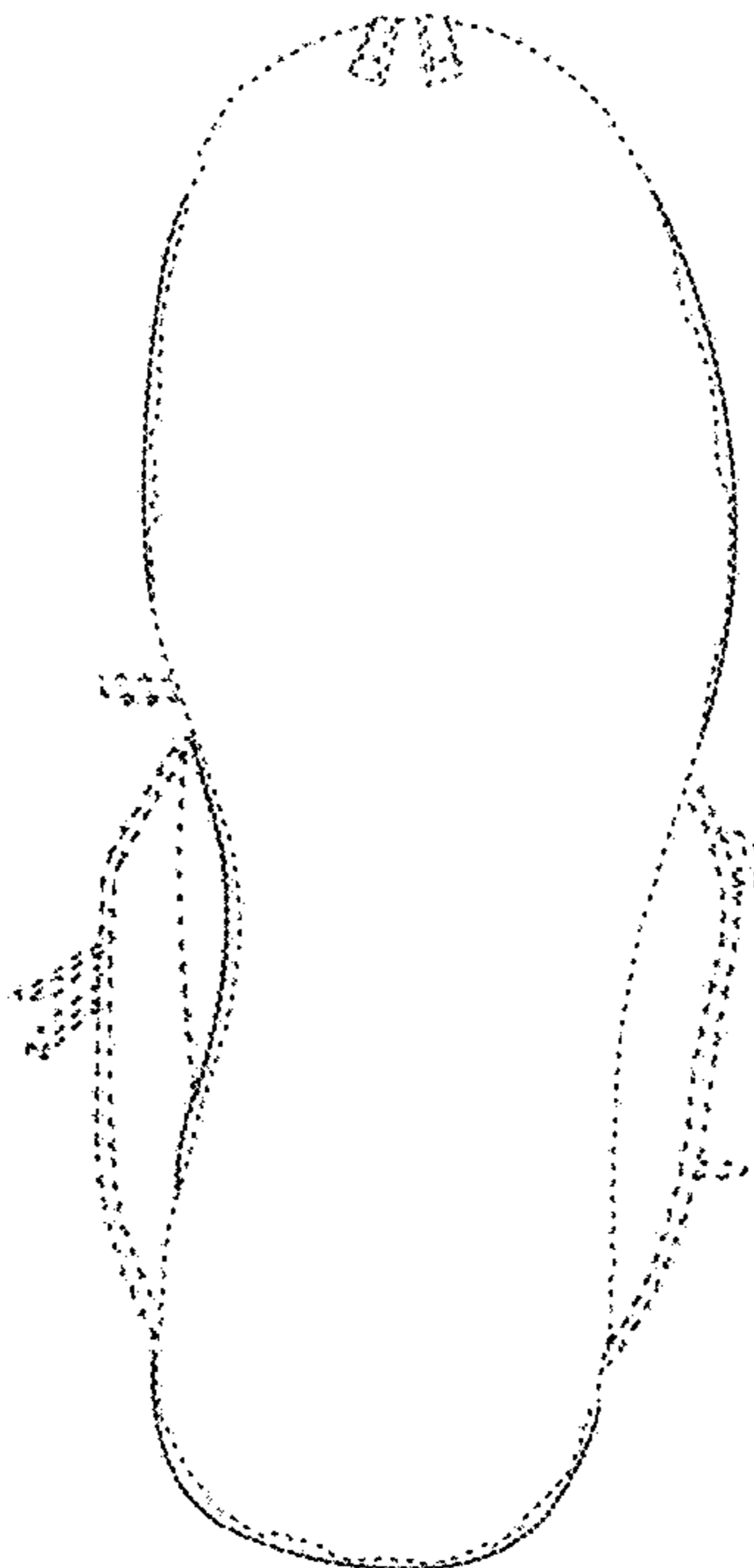

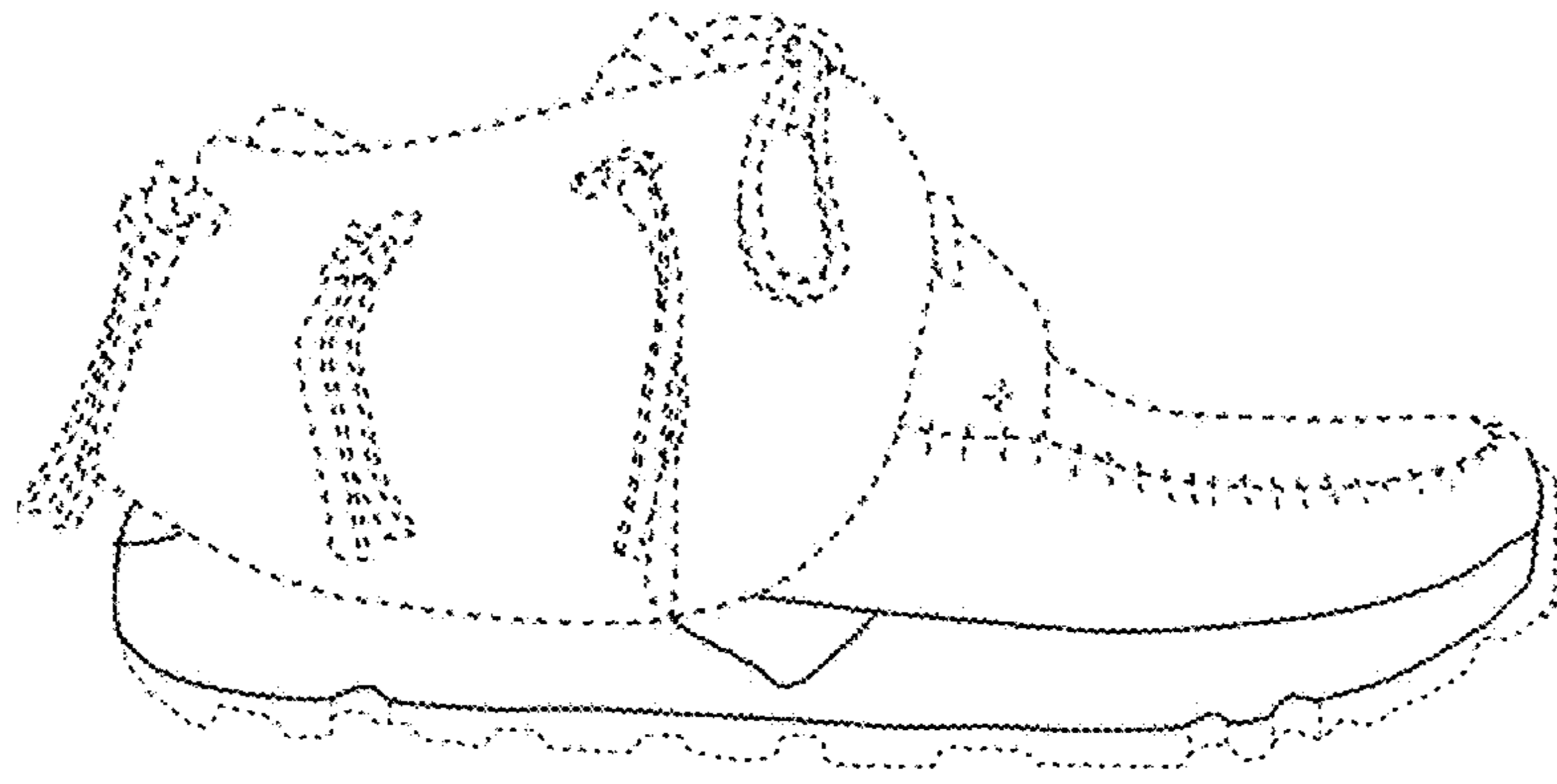

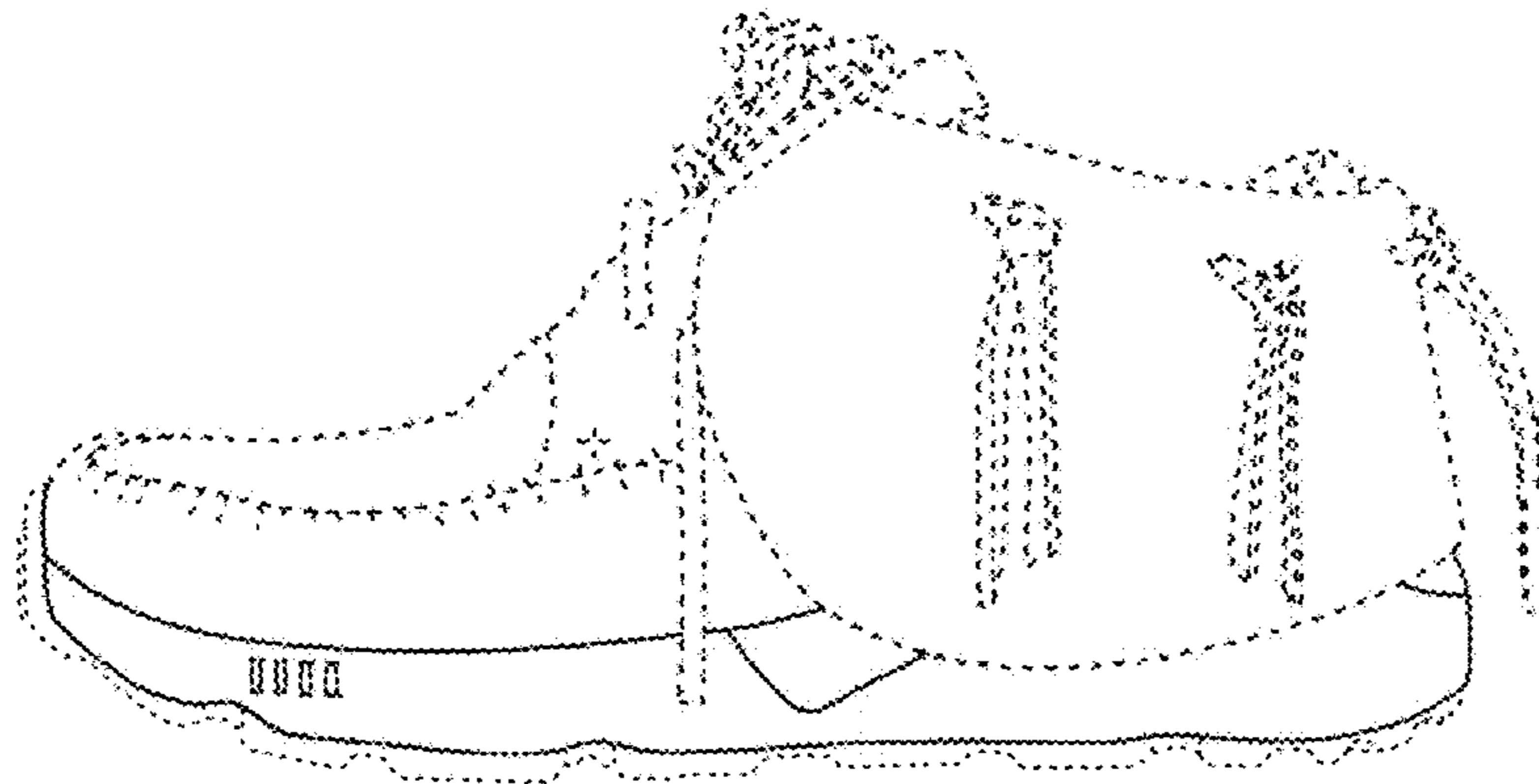

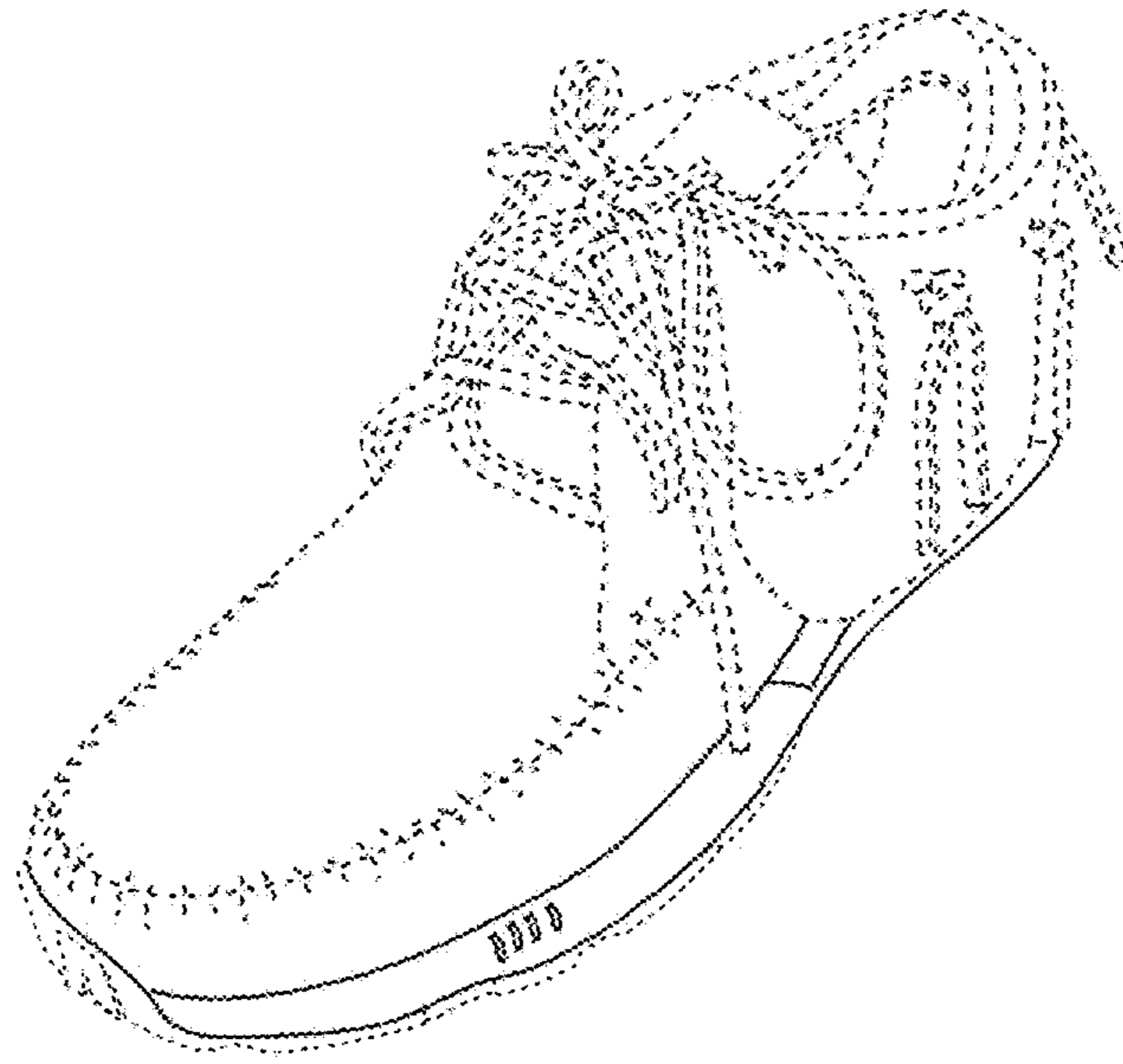
