(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front lateral perspective view of an embodiment of a shoe.

FIG. 2 is a front medial perspective view of the shoe of FIG. 1.

FIG. 3 is a lateral side view of the shoe of FIG. 1.

FIG. 4 is a medial side view of the shoe of FIG. 1.

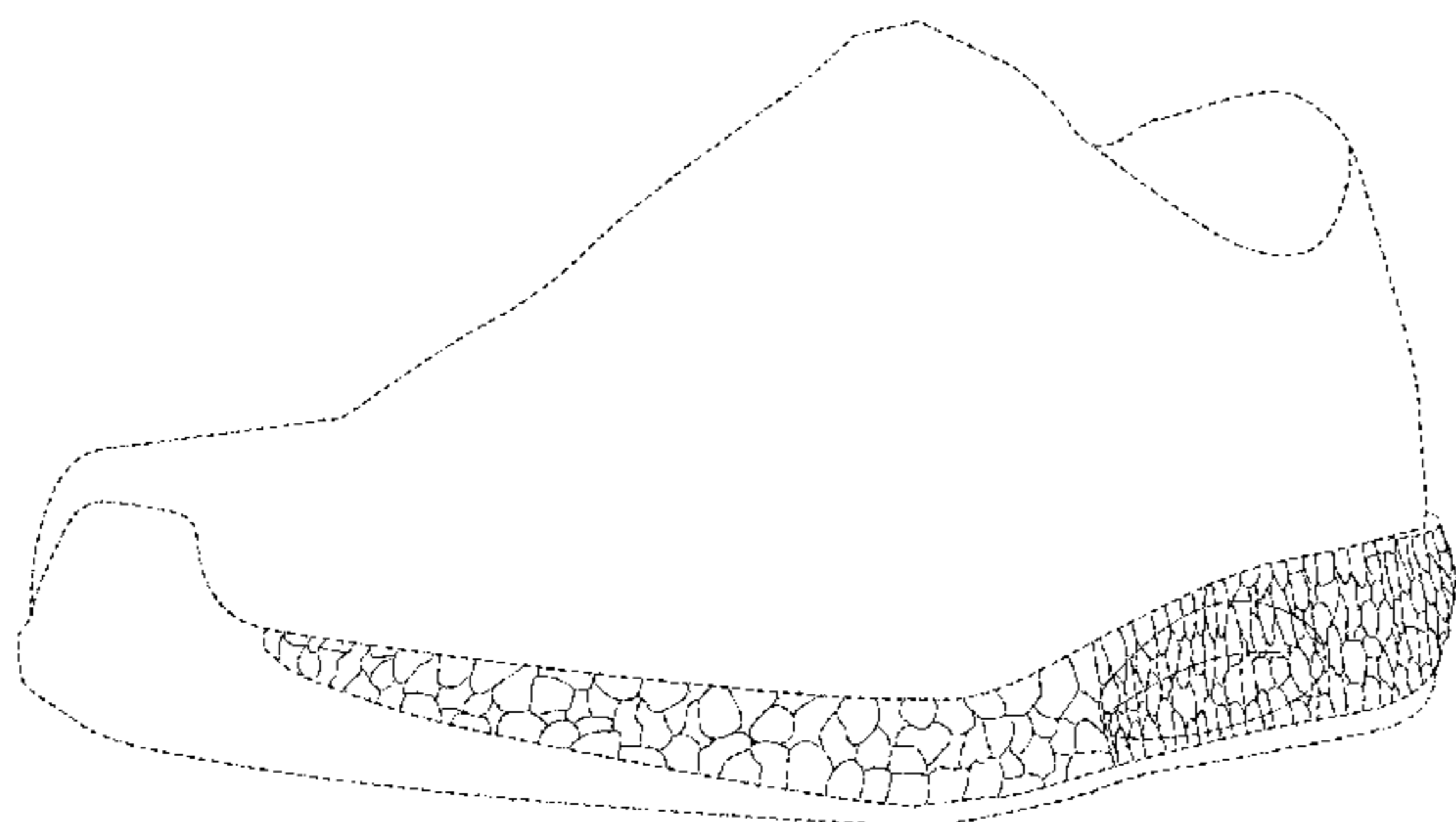
FIG. 5 is a rear view of the shoe of FIG. 1.

FIG. 6 is an enlarged view of the portion of the shoe labeled 6 in FIG. 3; and,

FIG. 7 is an enlarged view of the portion of the shoe labeled 7 in FIG. 4.

The dash-dot broken lines represent an unclaimed boundary of the claimed design. The broken lines show unclaimed subject matter only and form no part of the claimed design. The stippled surface shading in the partial views of the portions of the midsole in FIGS. 6 and 7 represent the three-dimensional appearance of the claimed portions of the pattern. The stippled surface shading of the claimed portions of the pattern in FIGS. 6 and 7 were omitted from the larger views in FIGS. 1-5 of the shoe for clarity of illustration.

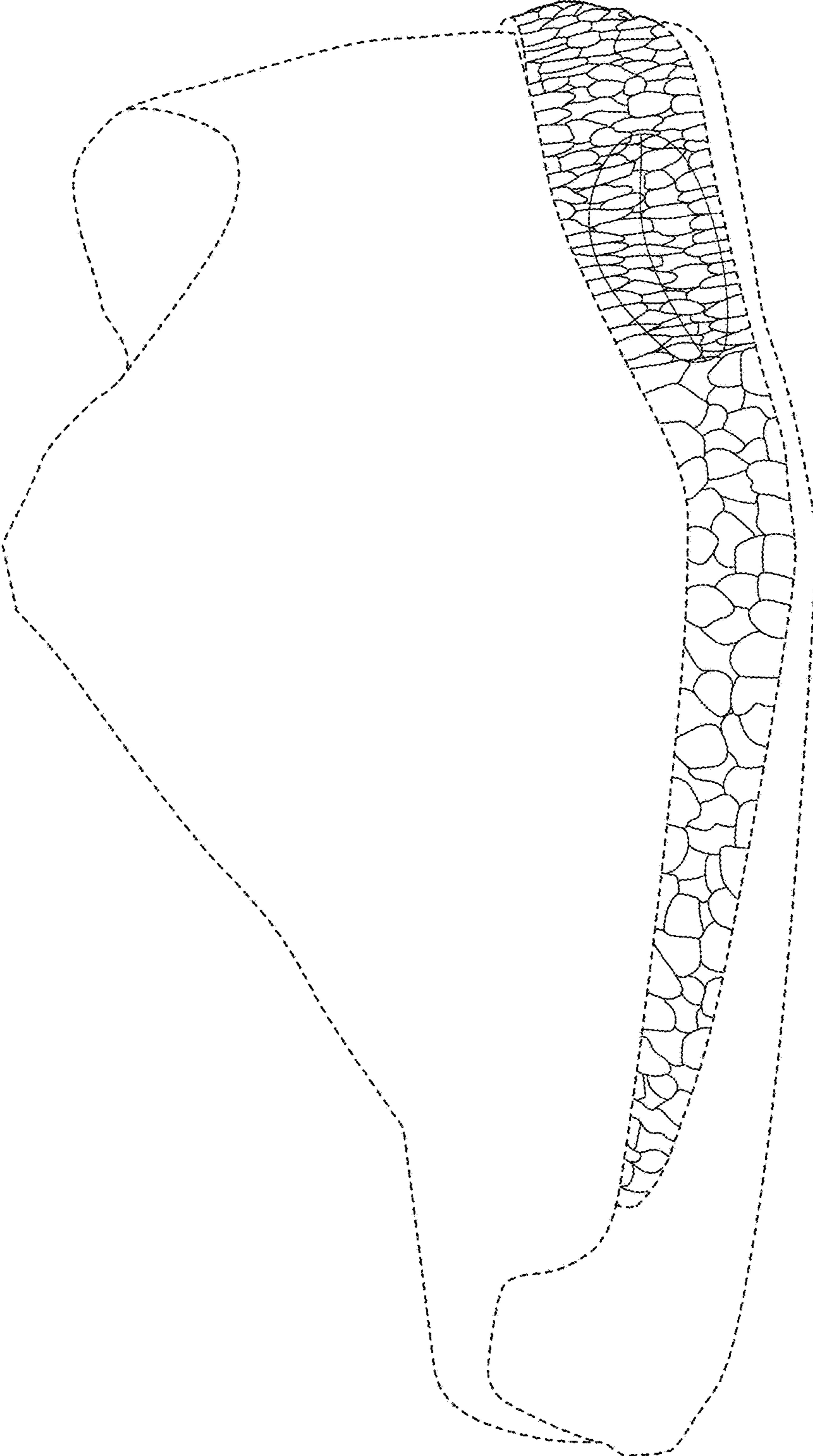

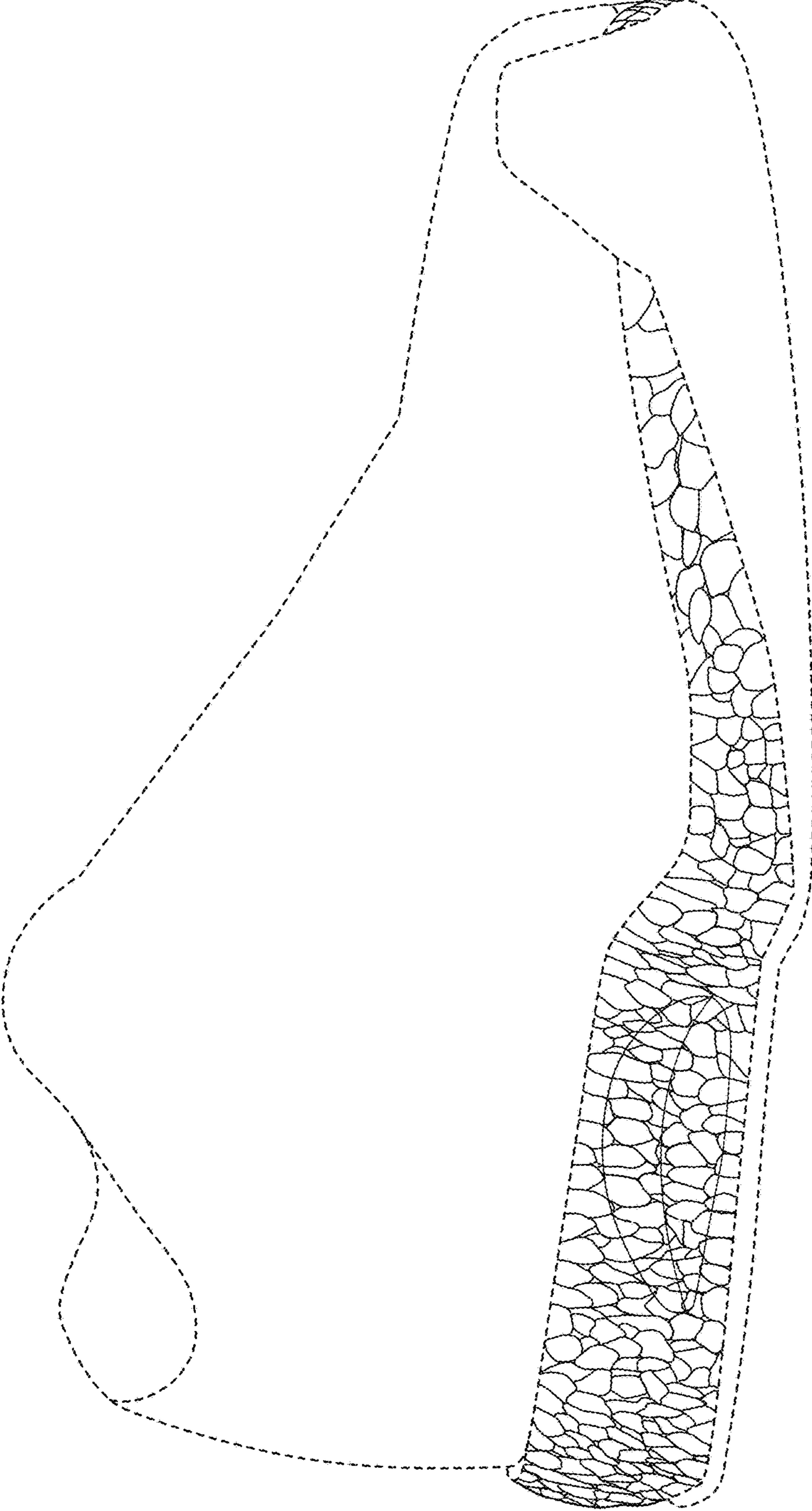

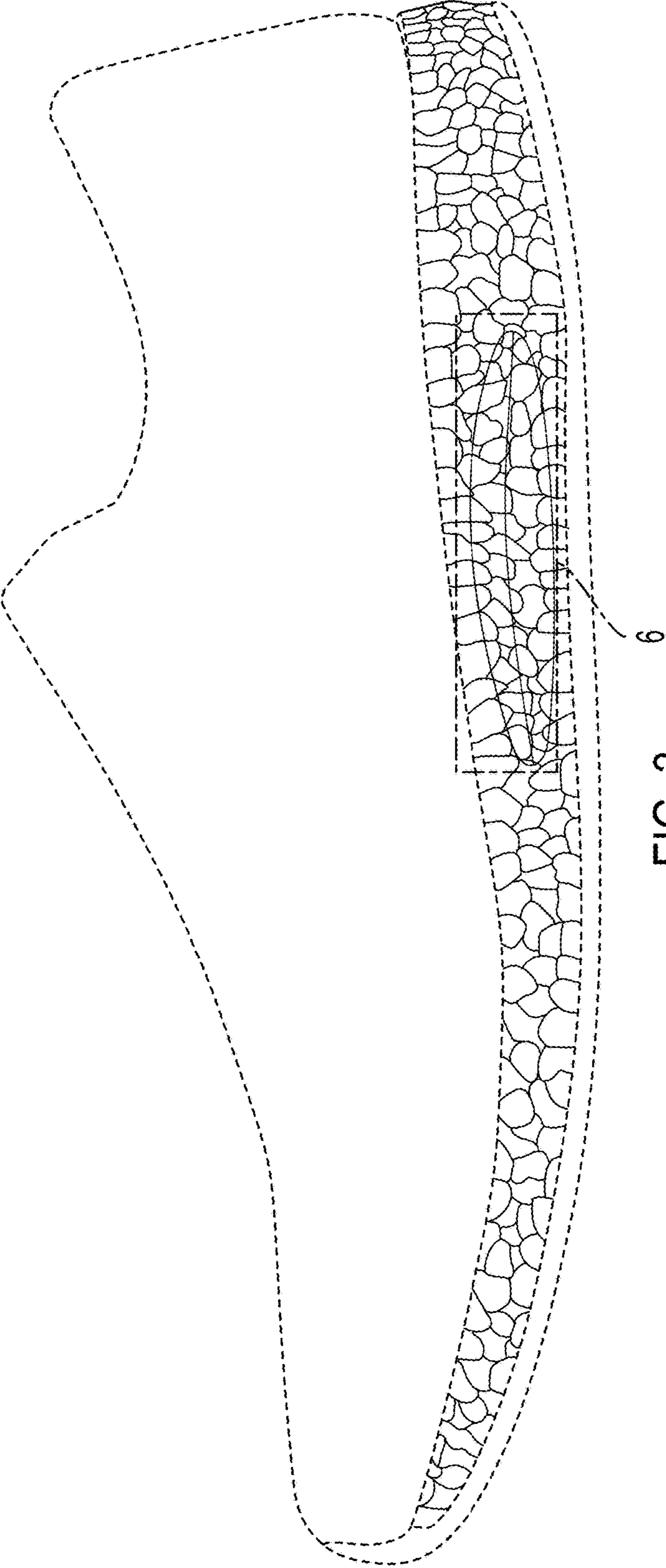

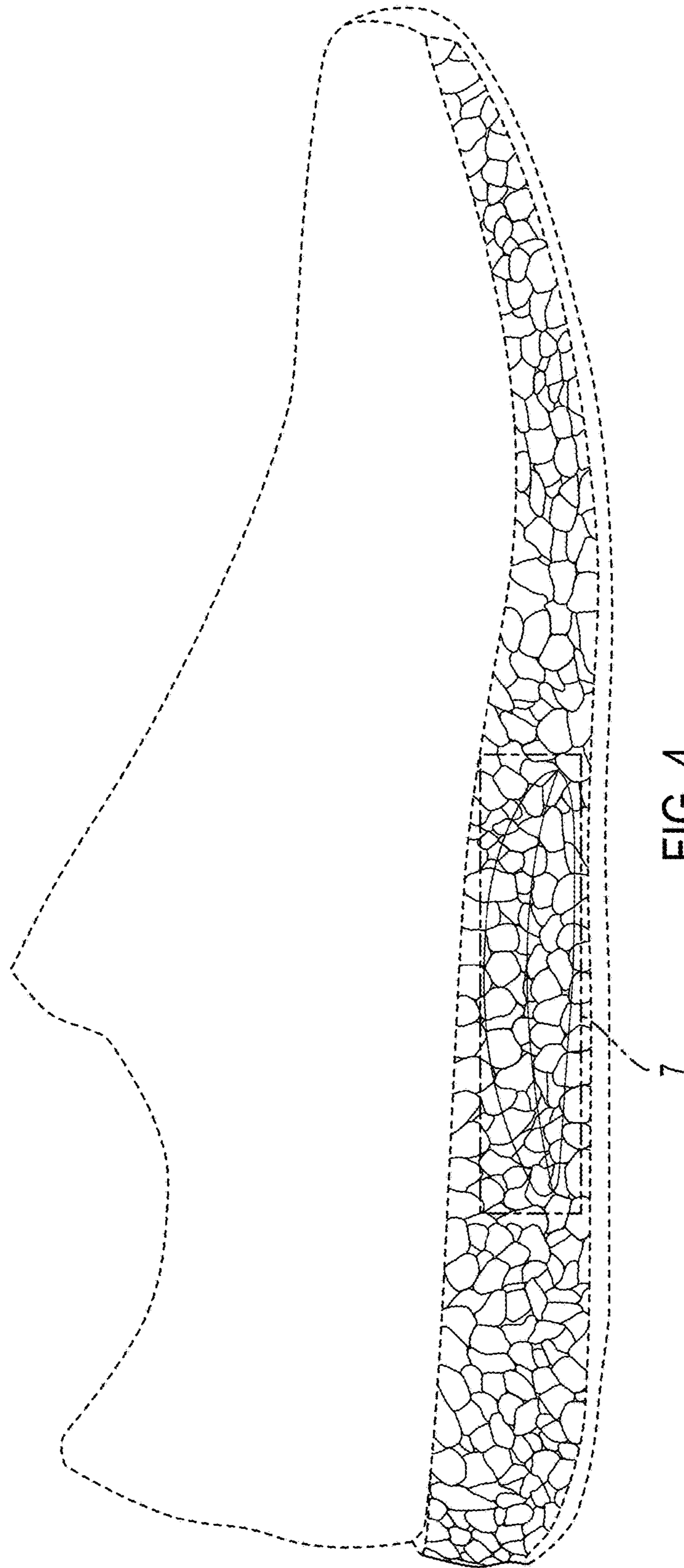

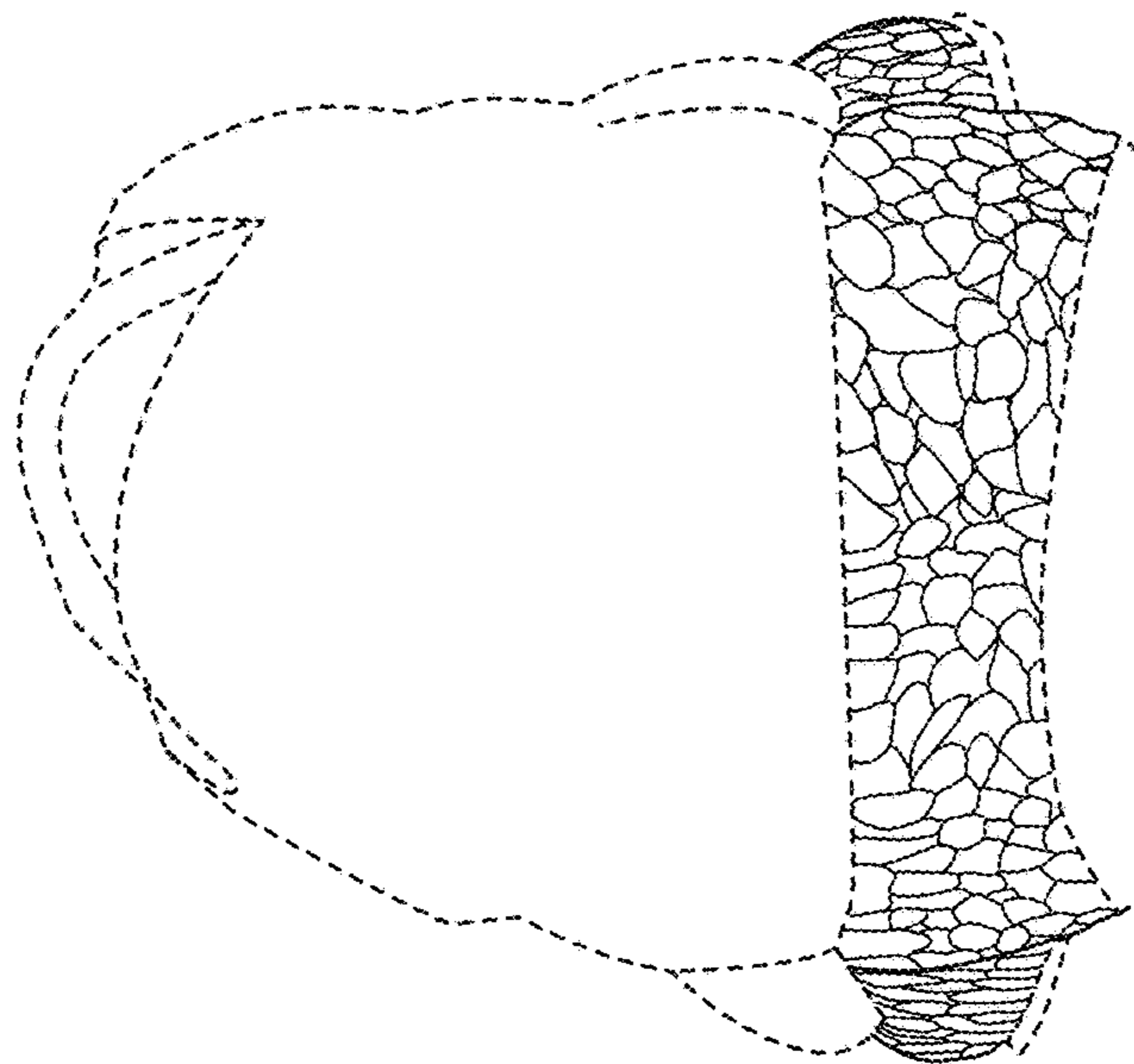

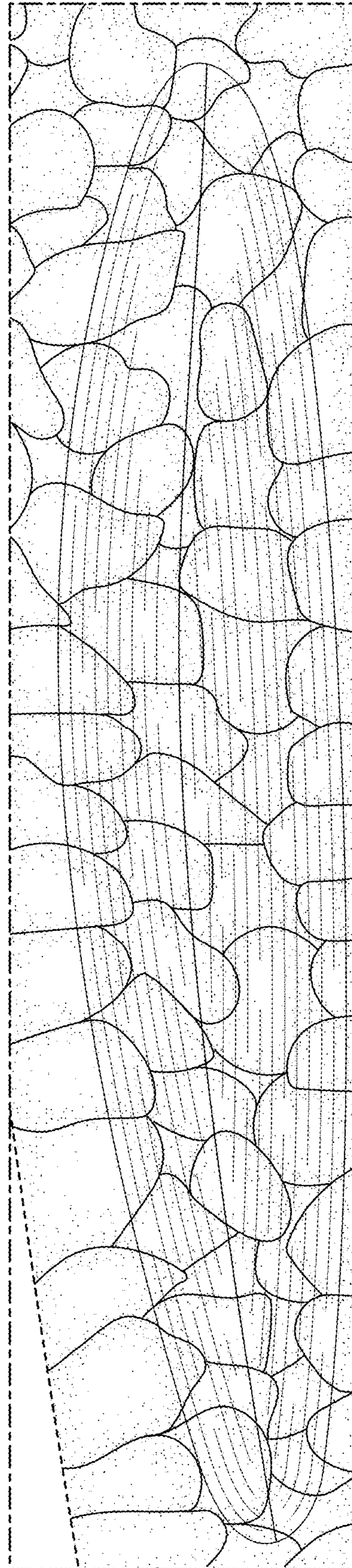

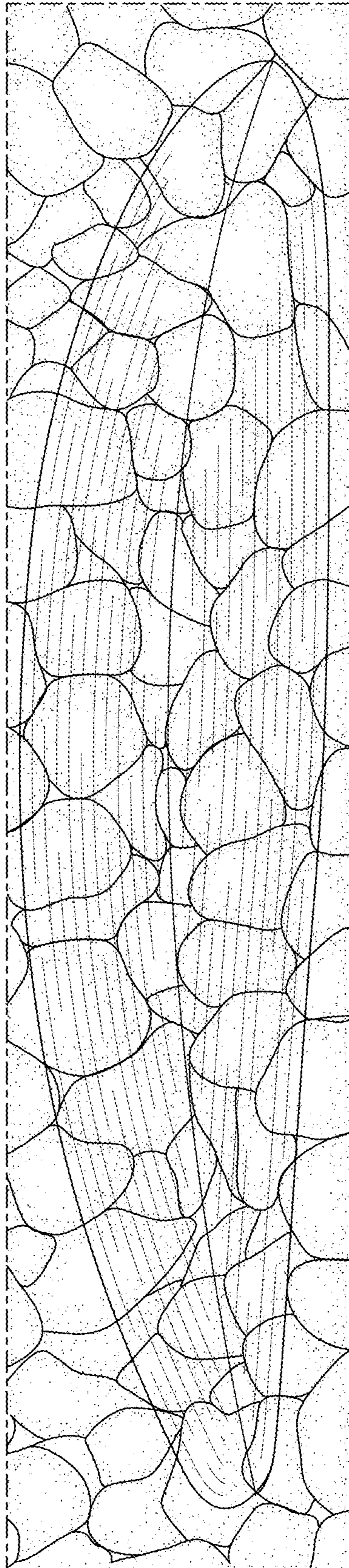
