(57) **CLAIM**

The ornamental design for a basket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a new design for a basket; FIG. 2 is a front elevational view thereof; the rear elevational view being identical to FIG. 2; FIG. 3 is a side elevational view thereof; the other side elevational view being identical to FIG. 3; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof. The parts delineated in dashed lines form no part of the claimed design.

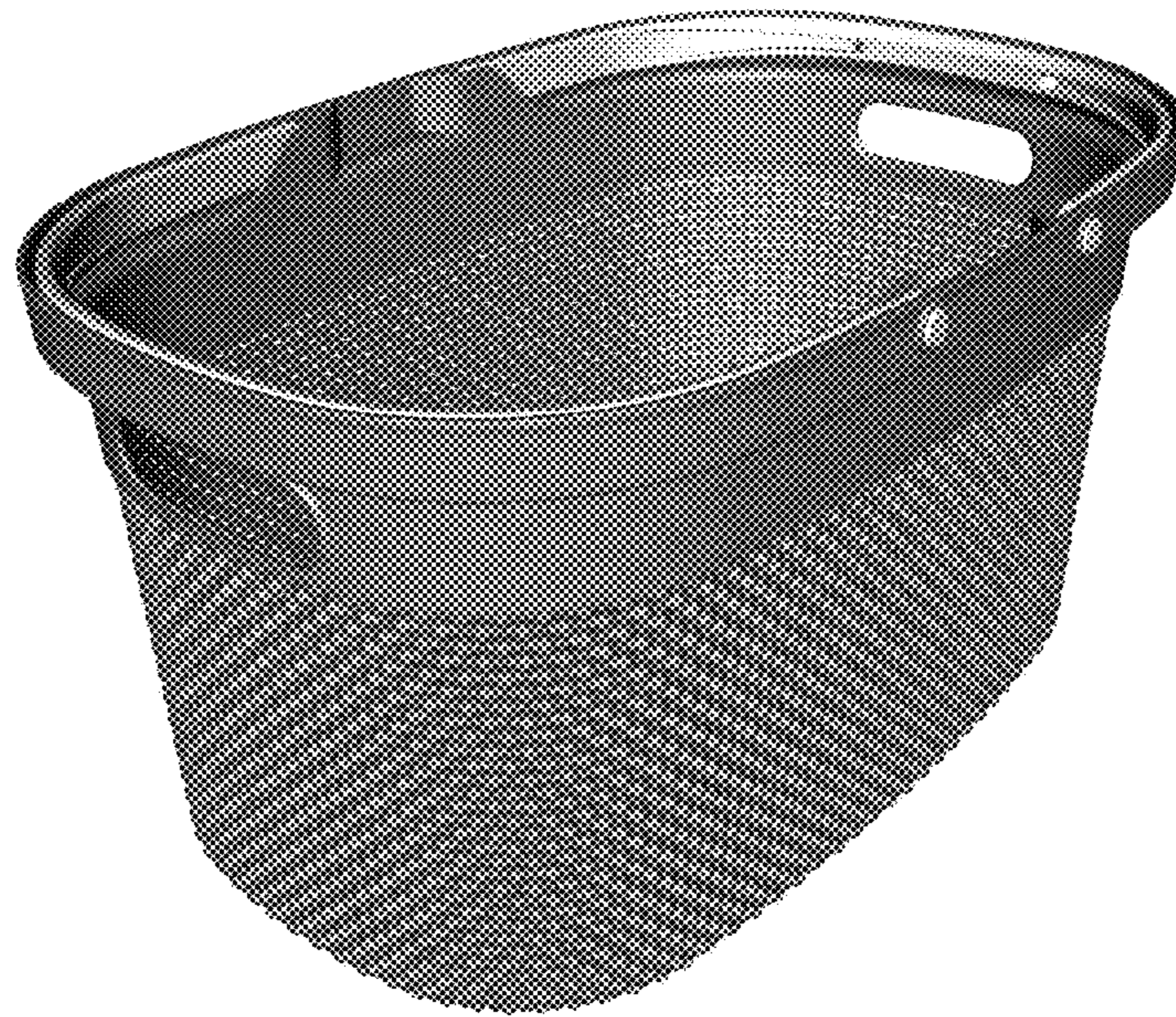

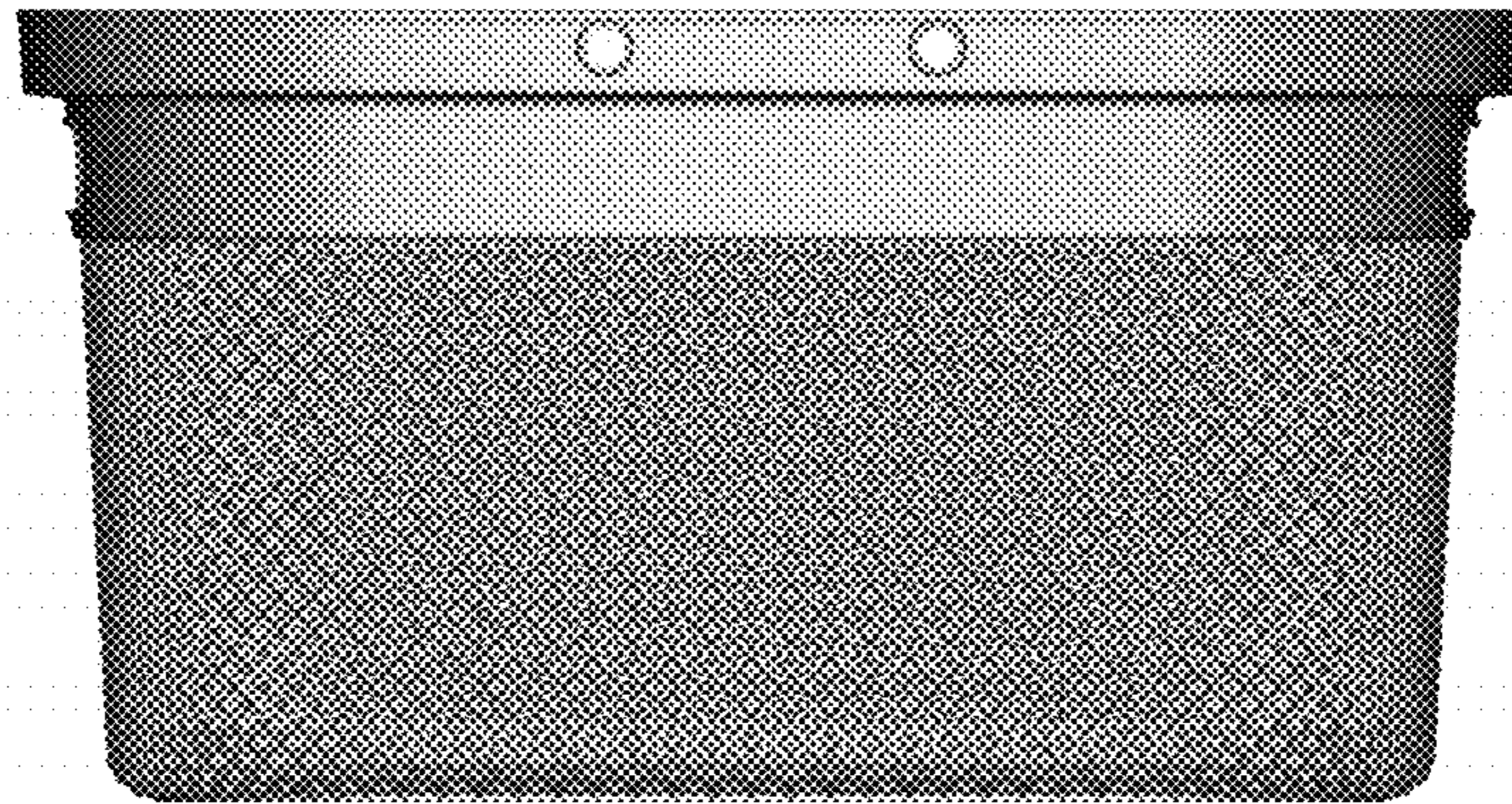

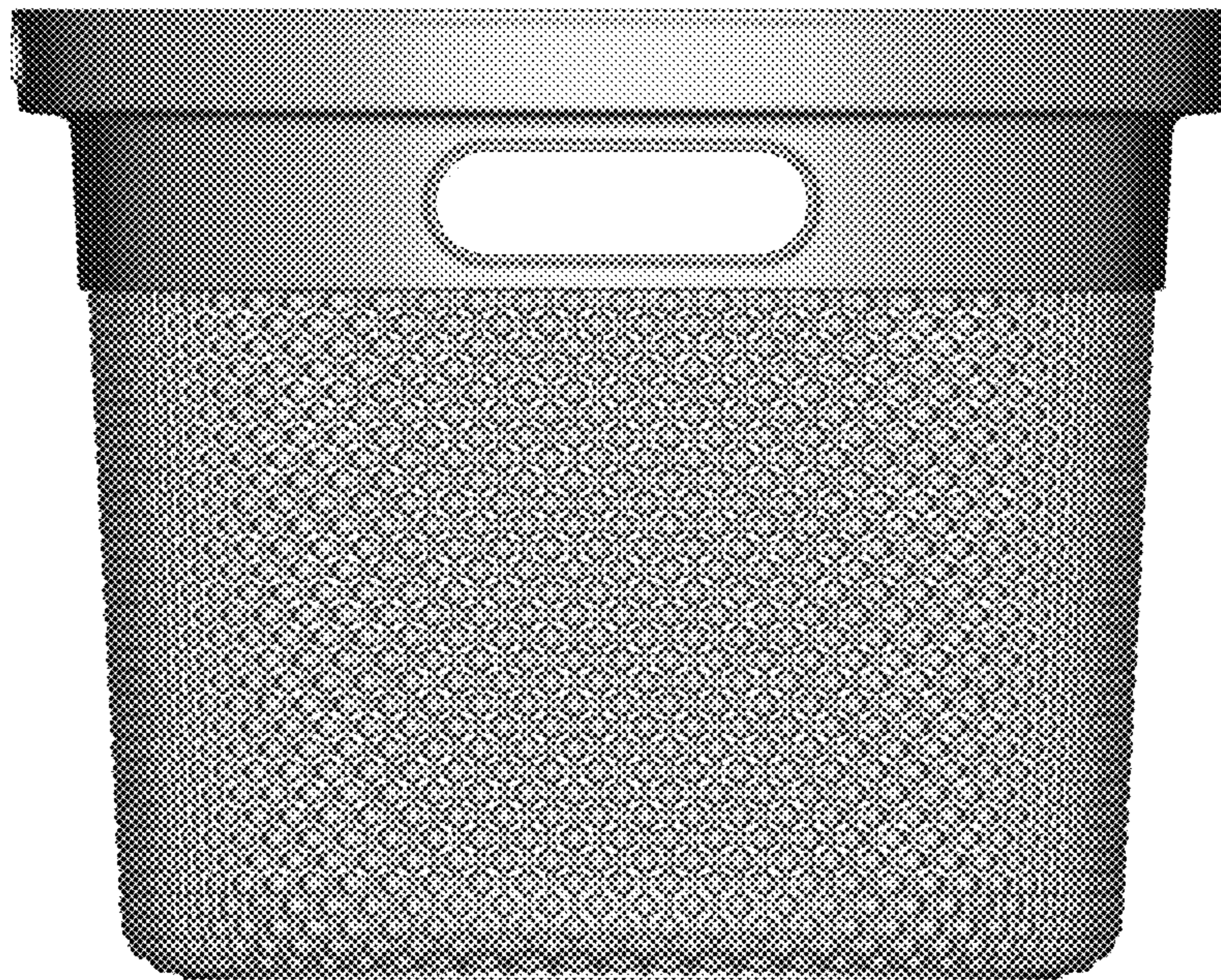

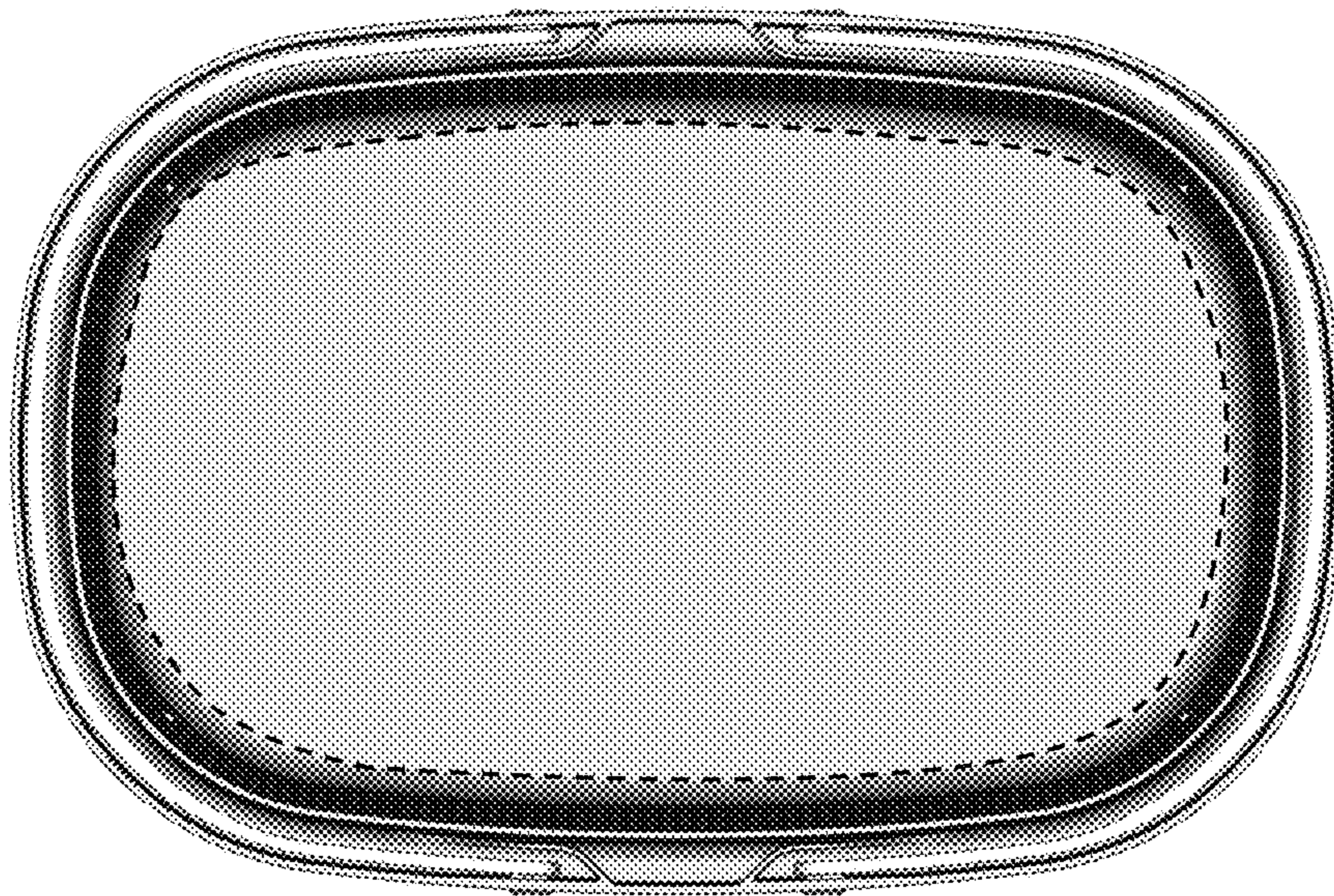

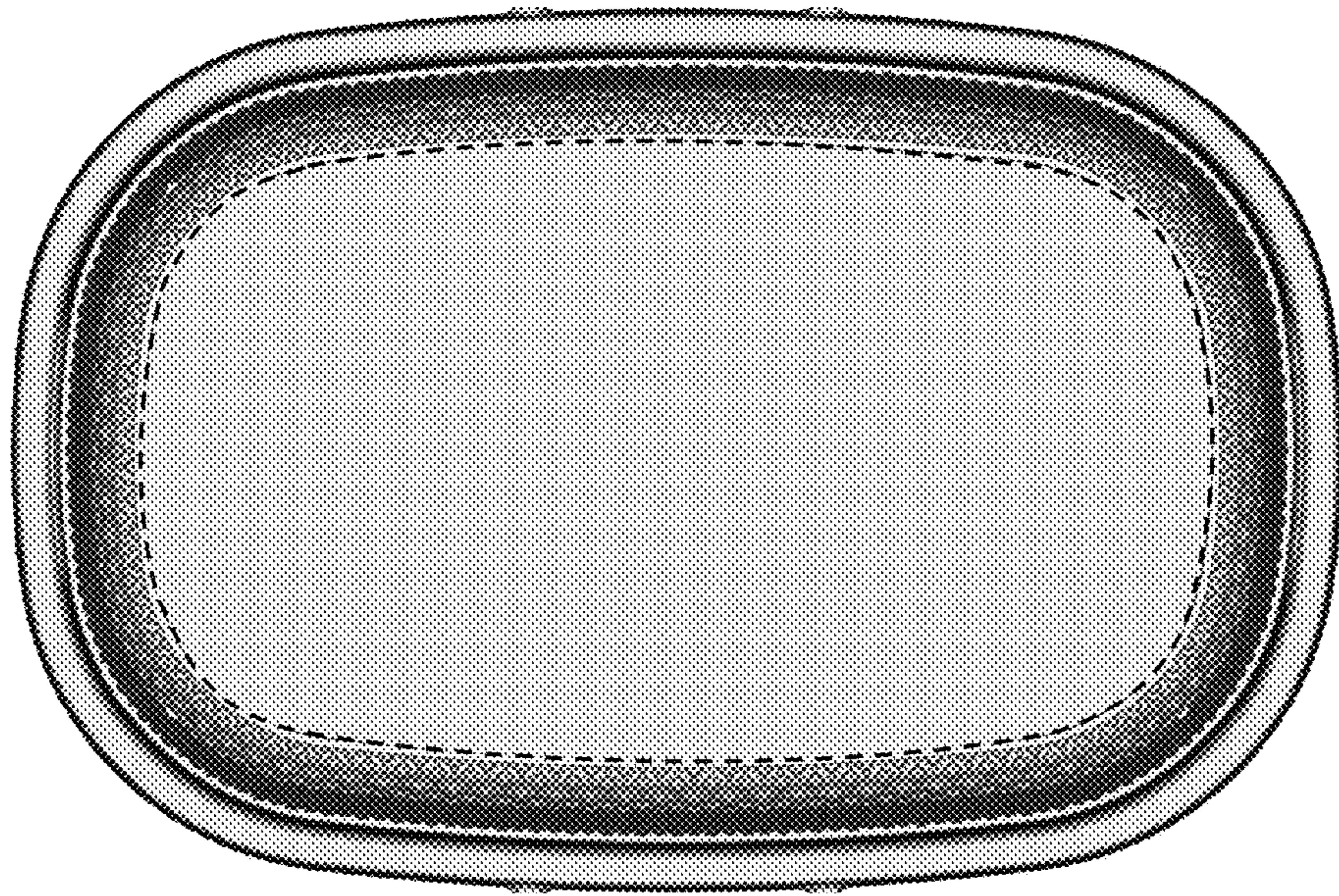
