The ornamental design for tableware pattern, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tableware pattern of the present invention; and, FIG. 2 is a front elevational view of the tableware pattern of FIG. 1.

Evenly broken lines indicate portions of the tableware pattern and form no part of the claimed design. Dash-dot-dash lines define the bounds of the claimed design and form no part thereof.

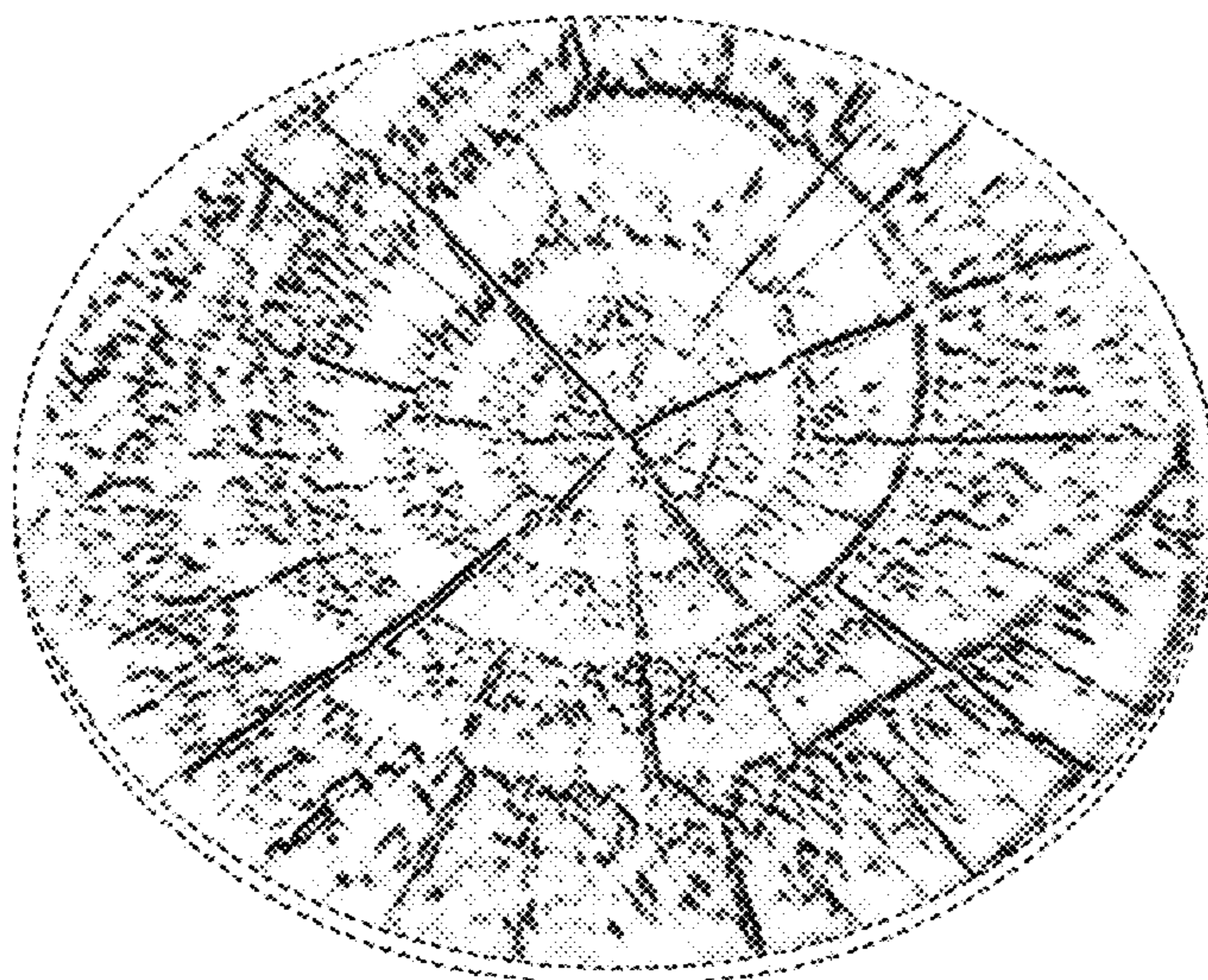
