(57) **CLAIM**

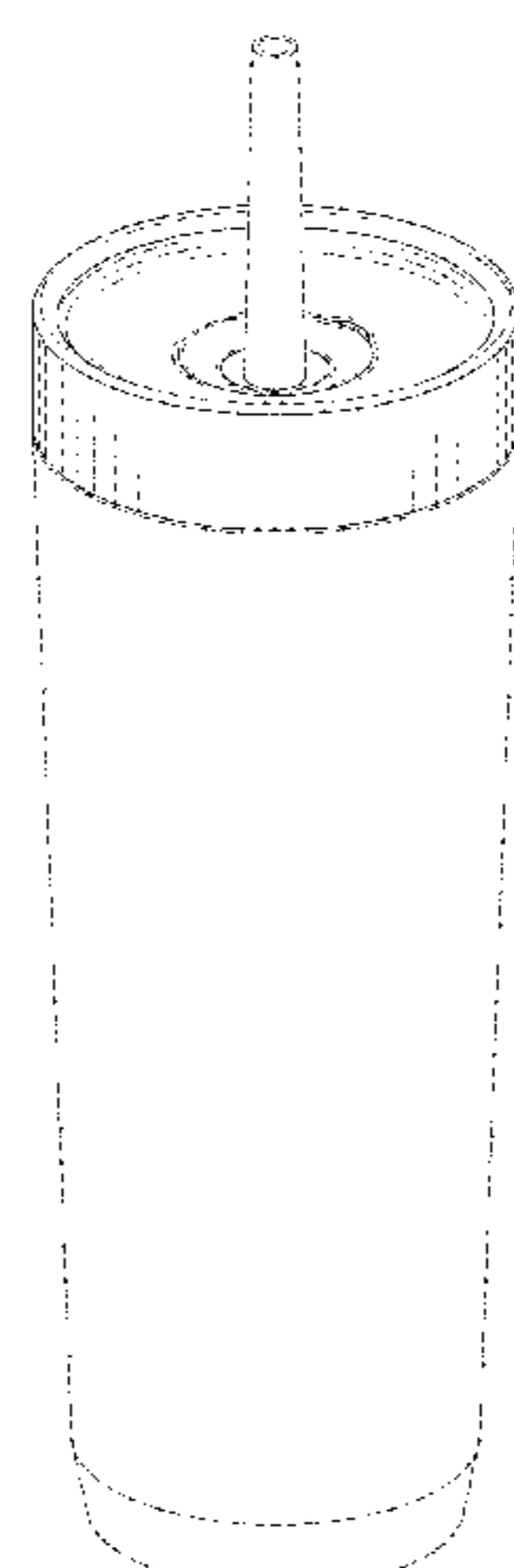
The ornamental design for a lid for a beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a top, right front perspective view of a lid for a beverage container of the present invention;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines illustrating a beverage container and straw depict environment to show the lid for a beverage container in a position of use and form no part of the claimed design.

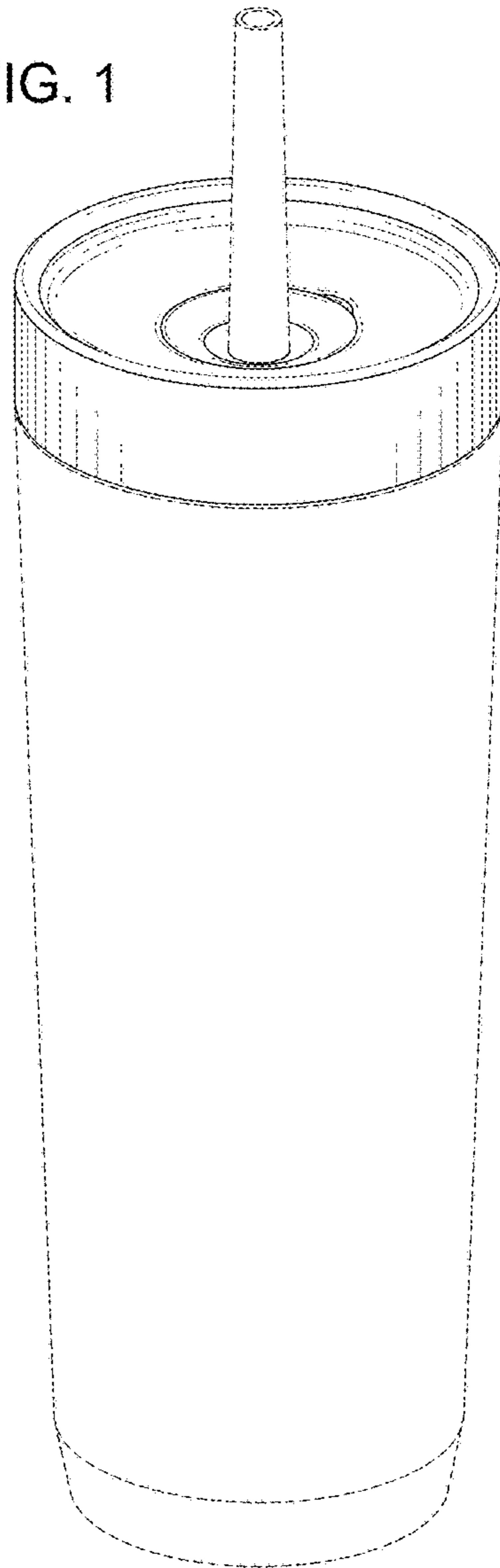

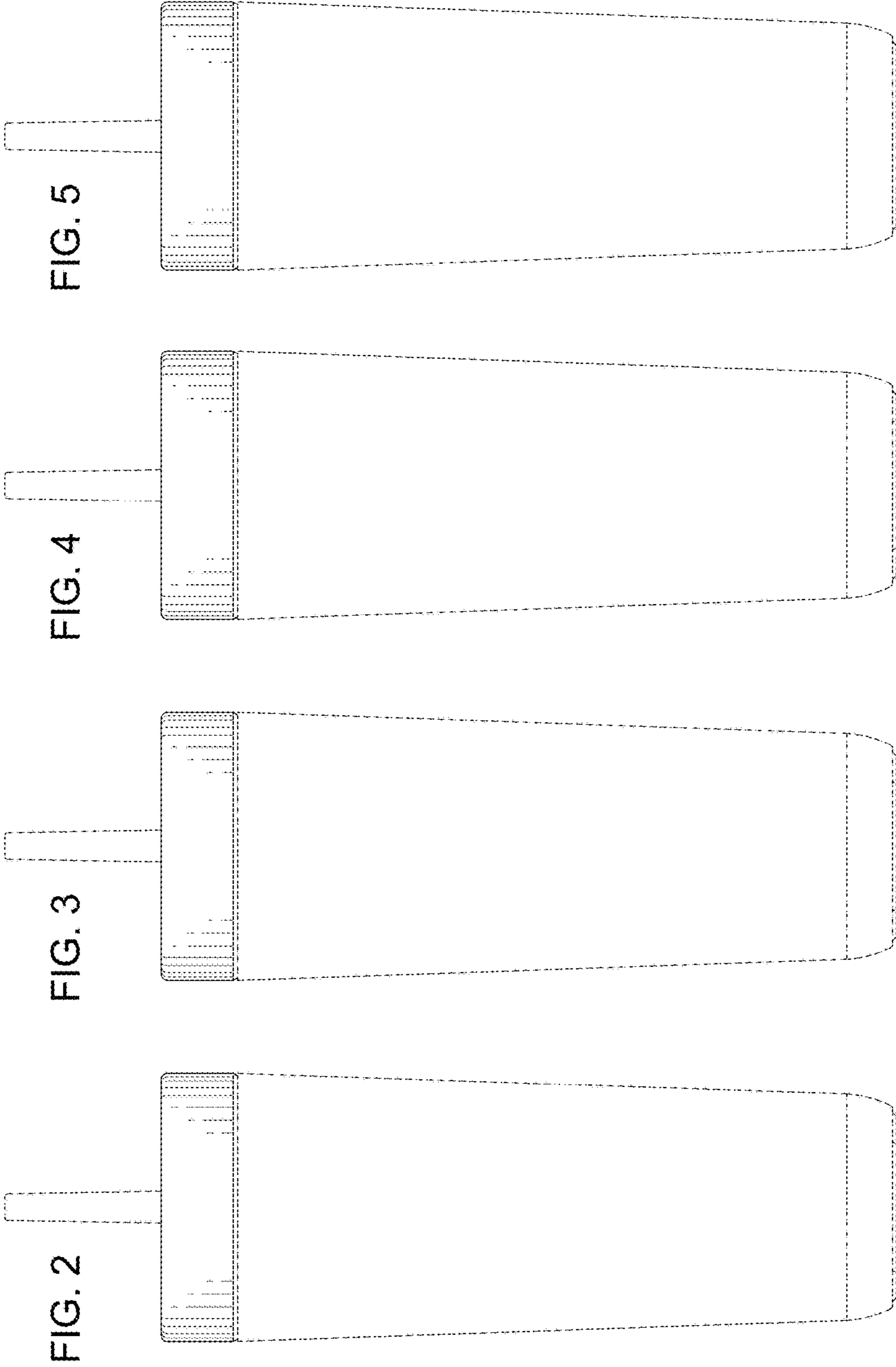

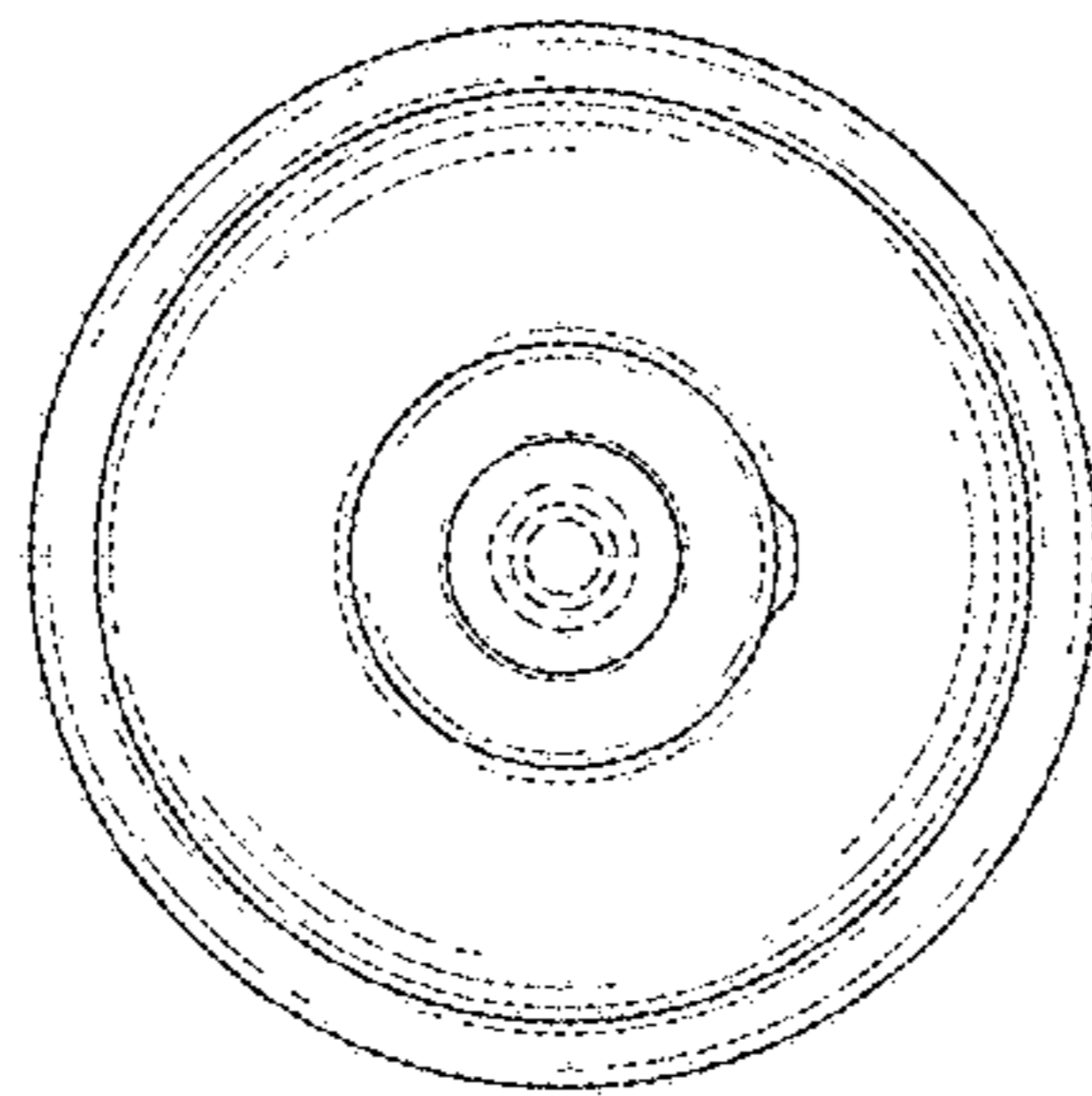
