(57) **CLAIM**

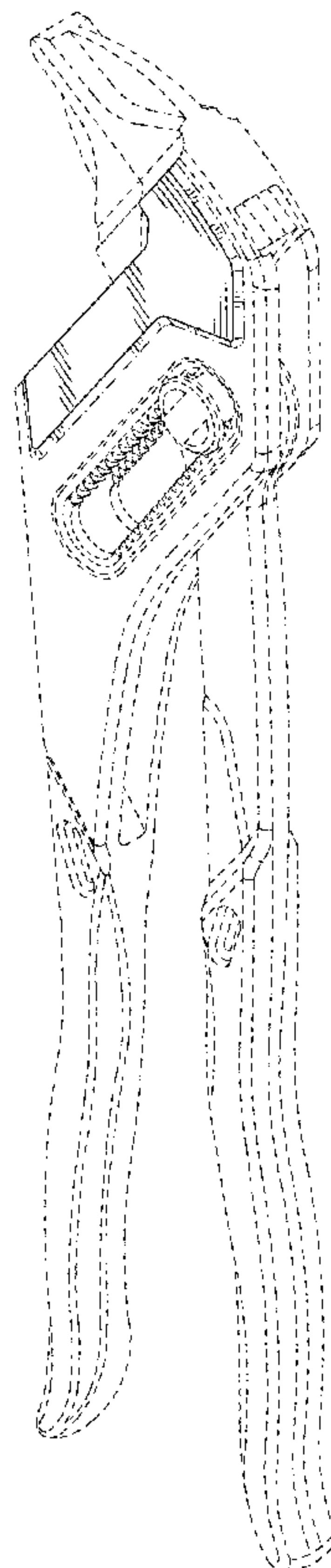
I claim the ornamental design for a pliers, as shown and described.

DESCRIPTION

FIG. 1 is a right, front, and top perspective view of a pliers showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof; and,
 FIG. 8 is a left, front, and top perspective view.
 The broken lines in the drawings illustrate portions of the pliers which form no part of the claimed design.
 The dot-dashed line in the figures defines the boundary of the claimed design and forms no part thereof.

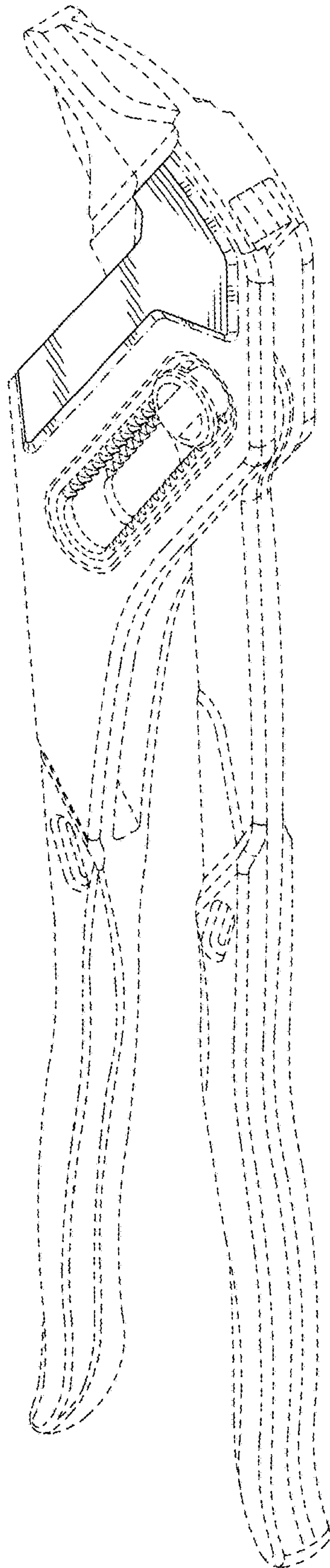

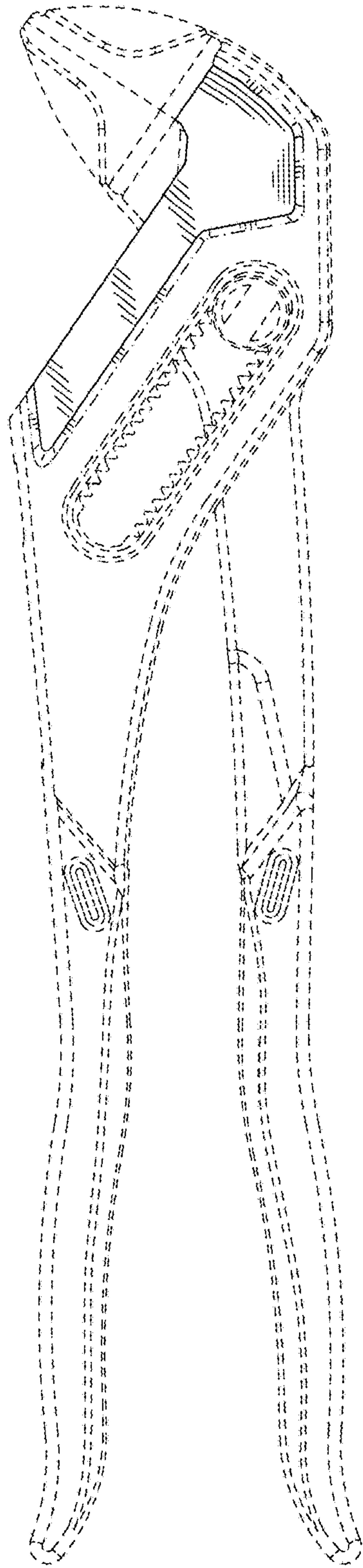

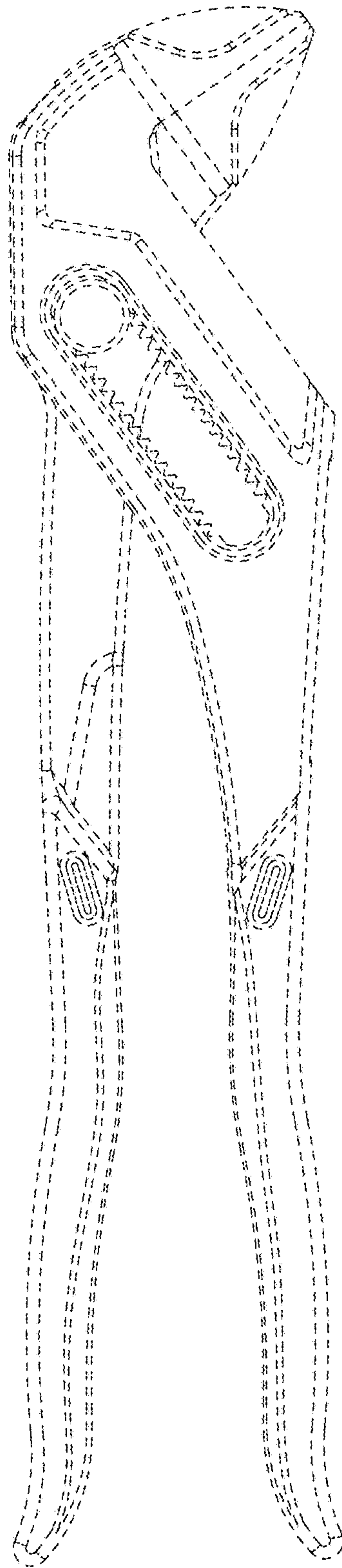

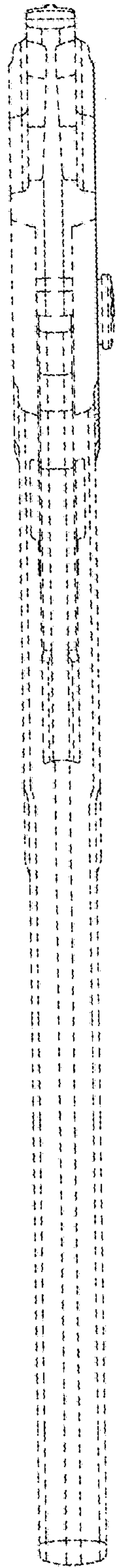

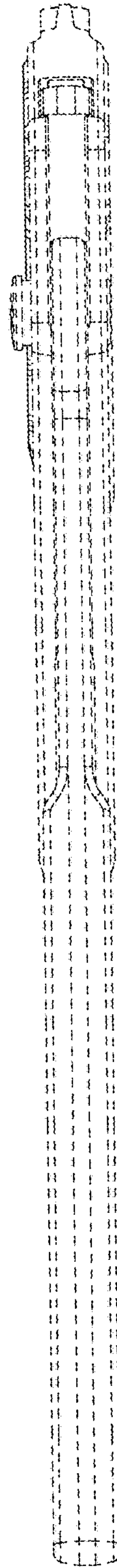

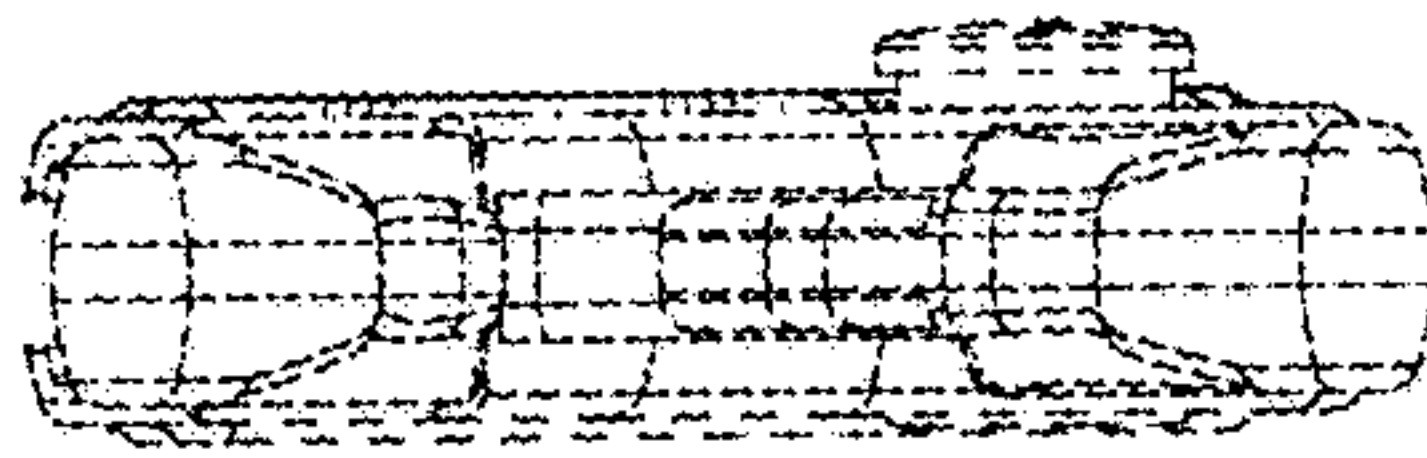

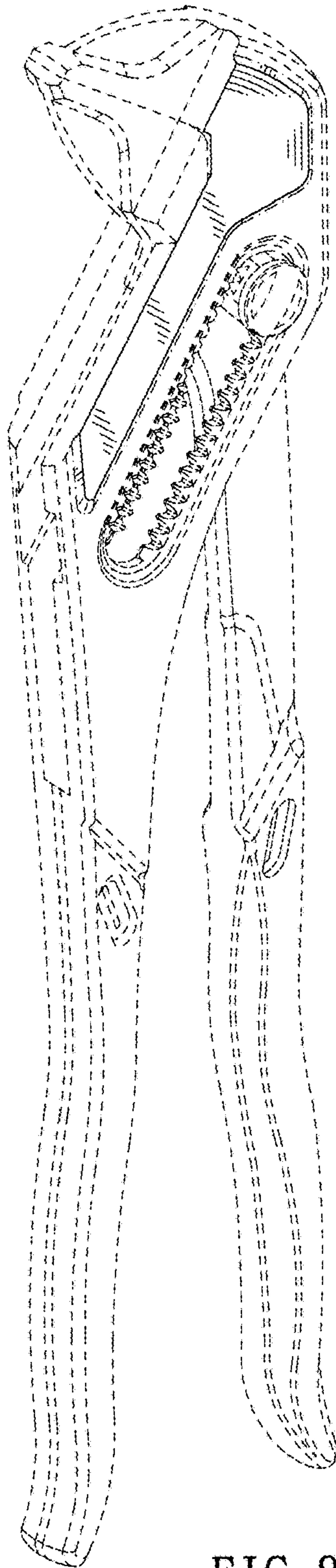
