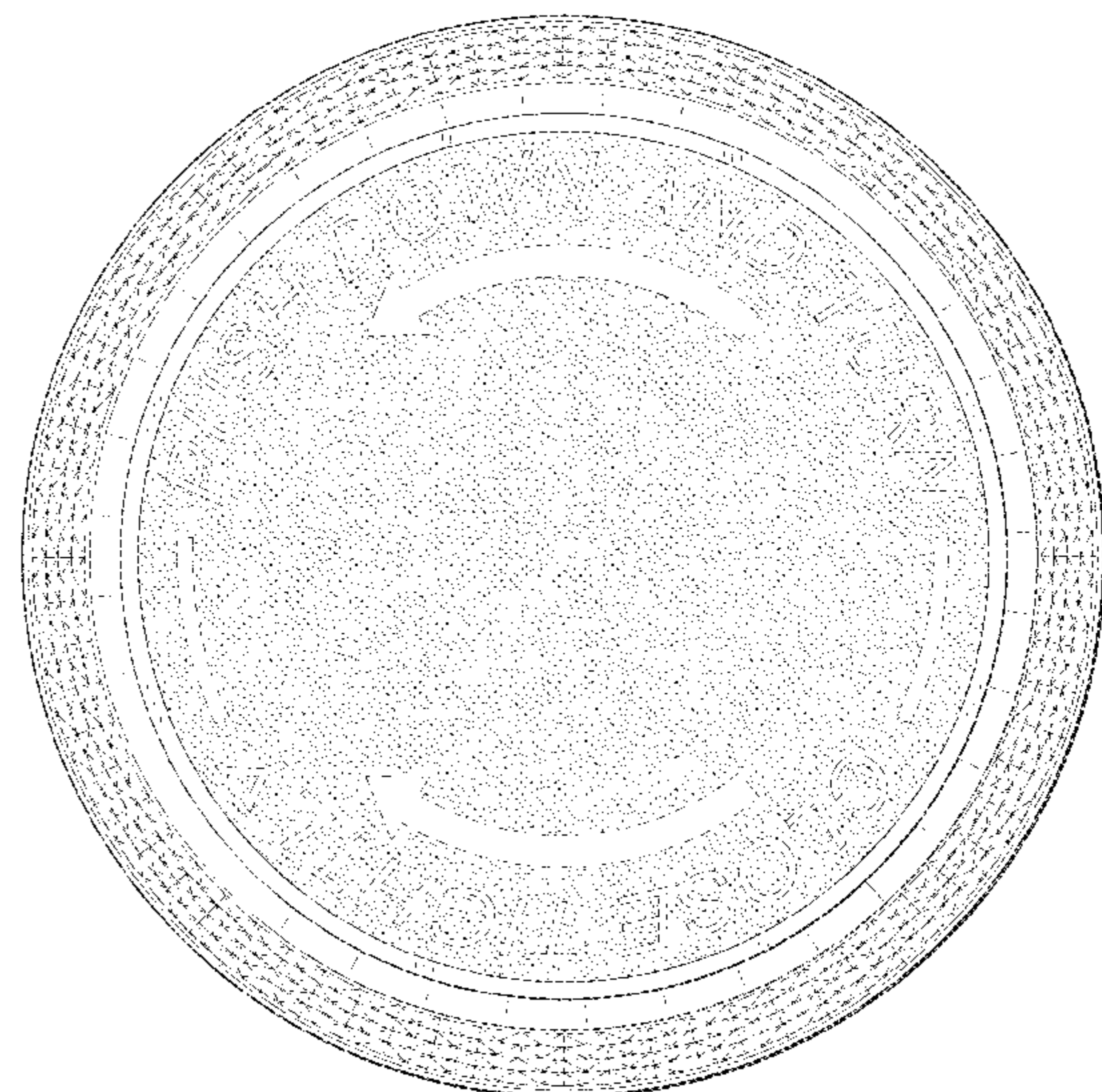
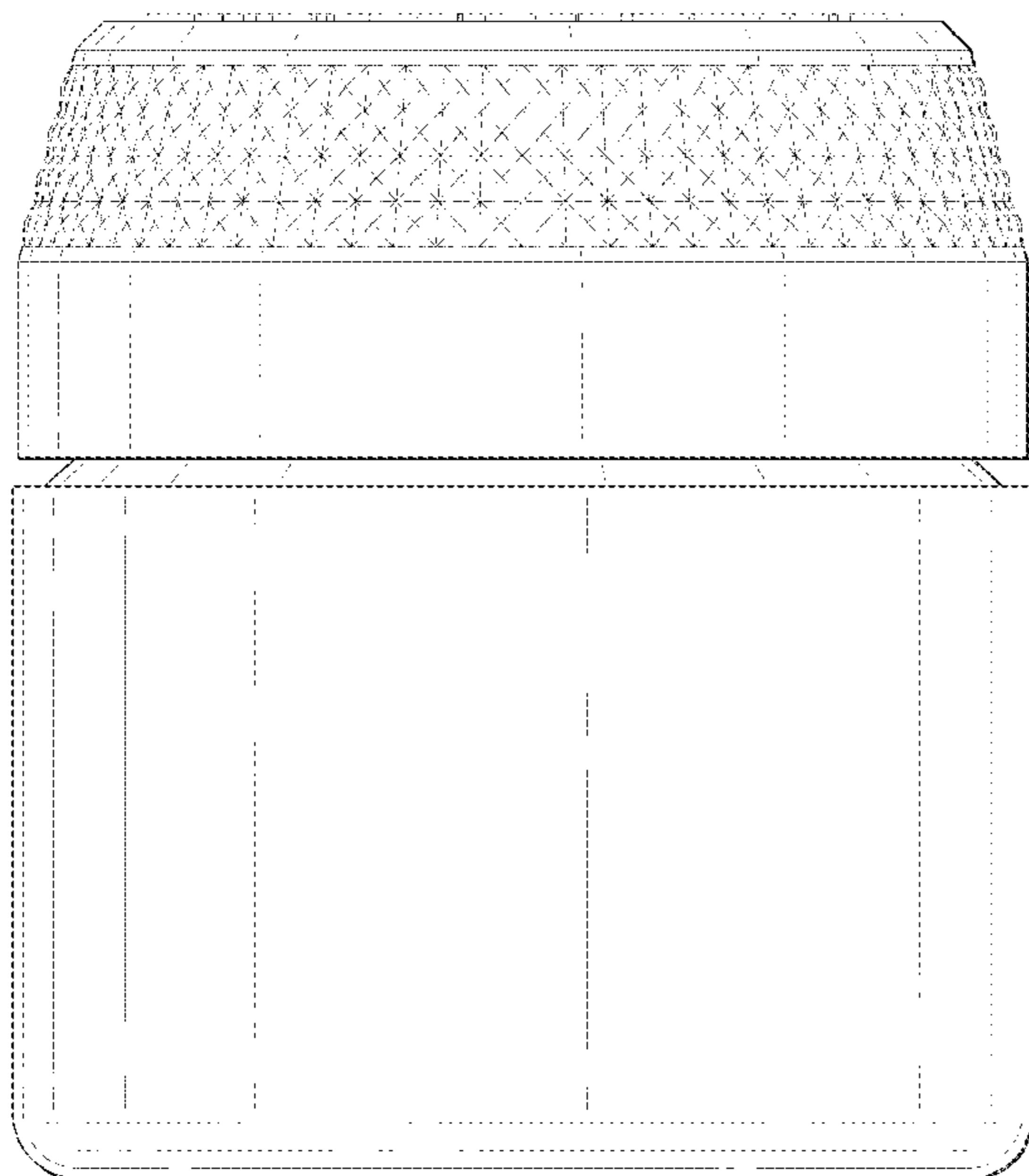
The ornamental design for an over the counter medicinal container, as shown and described.

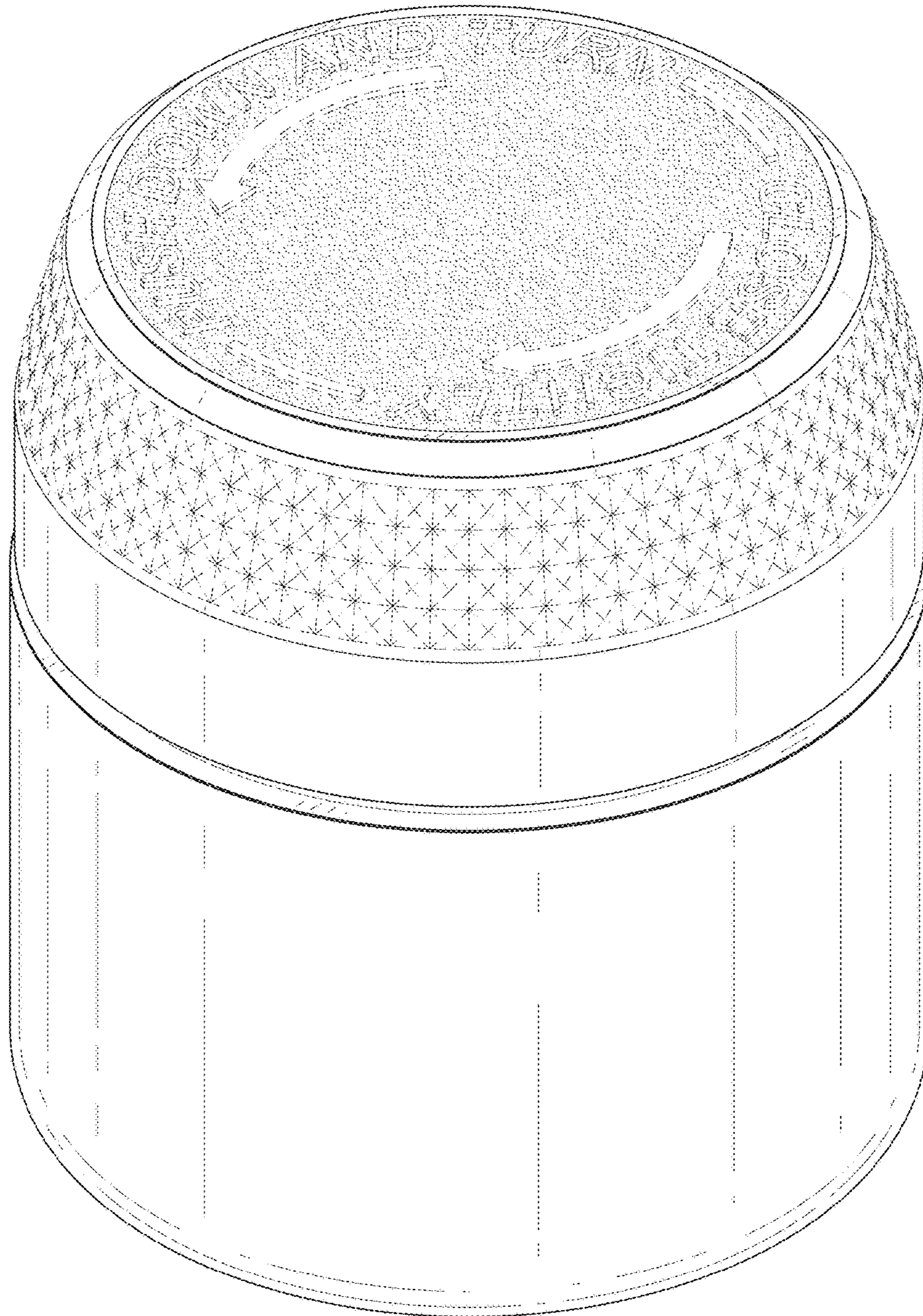

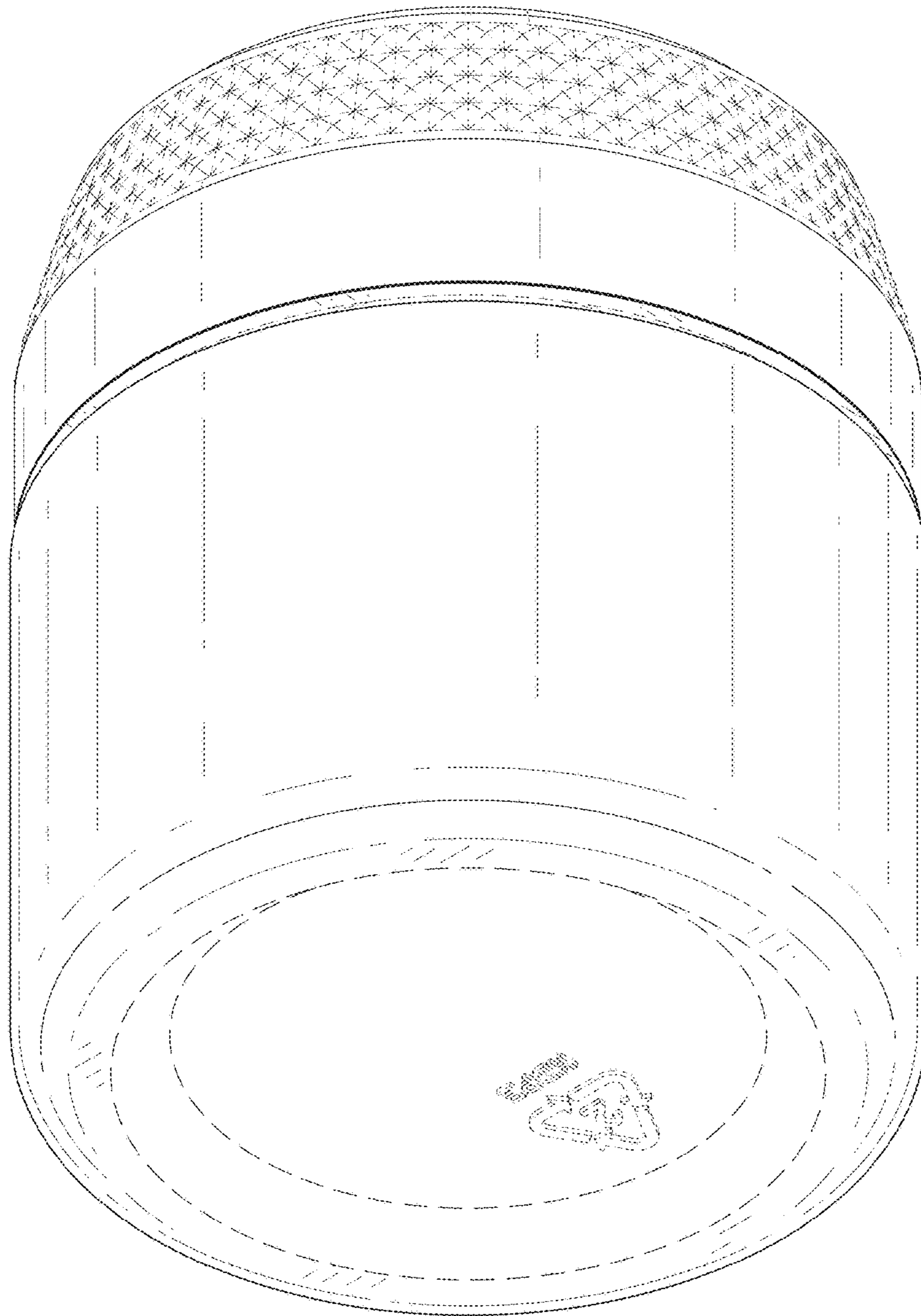

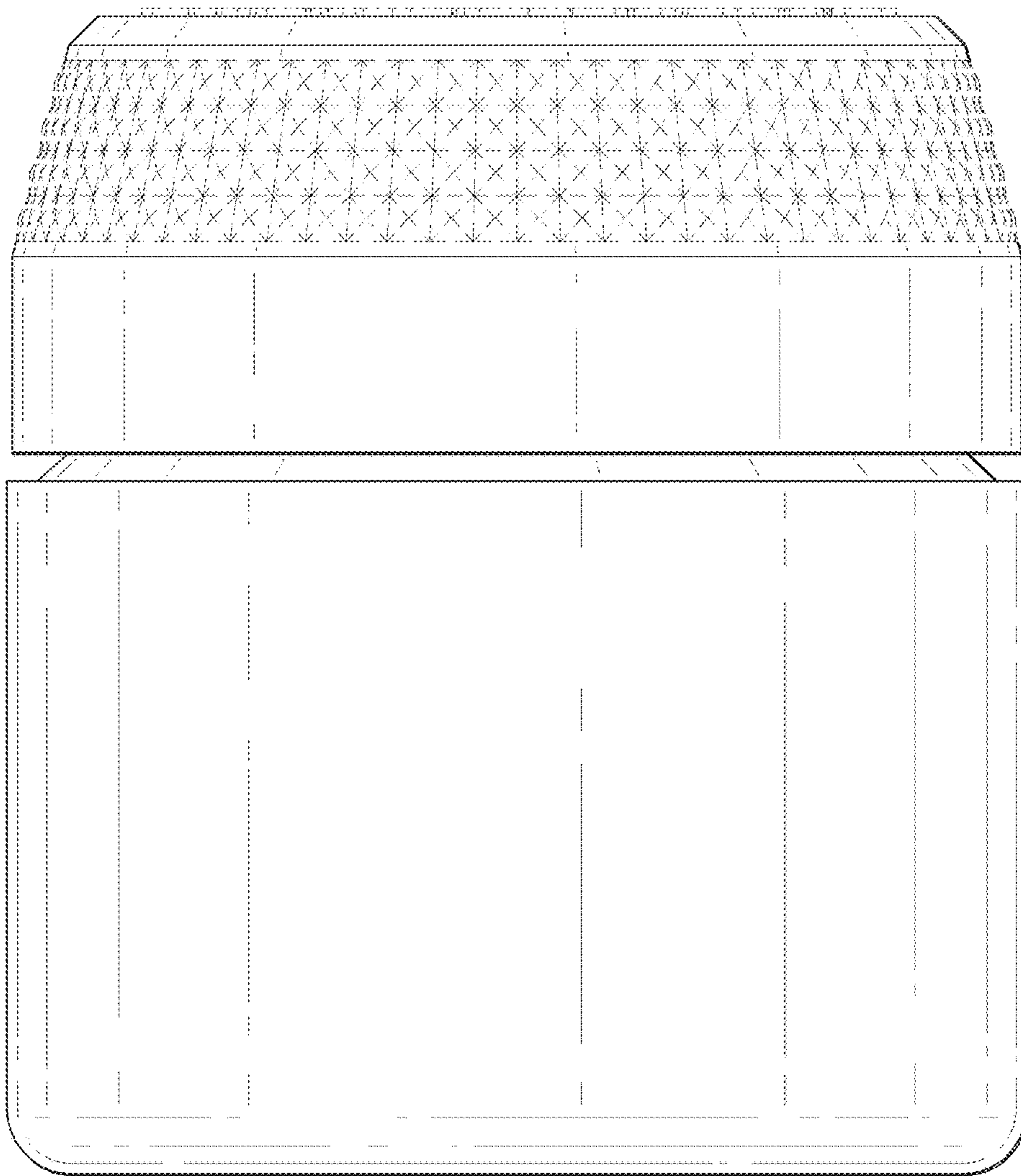

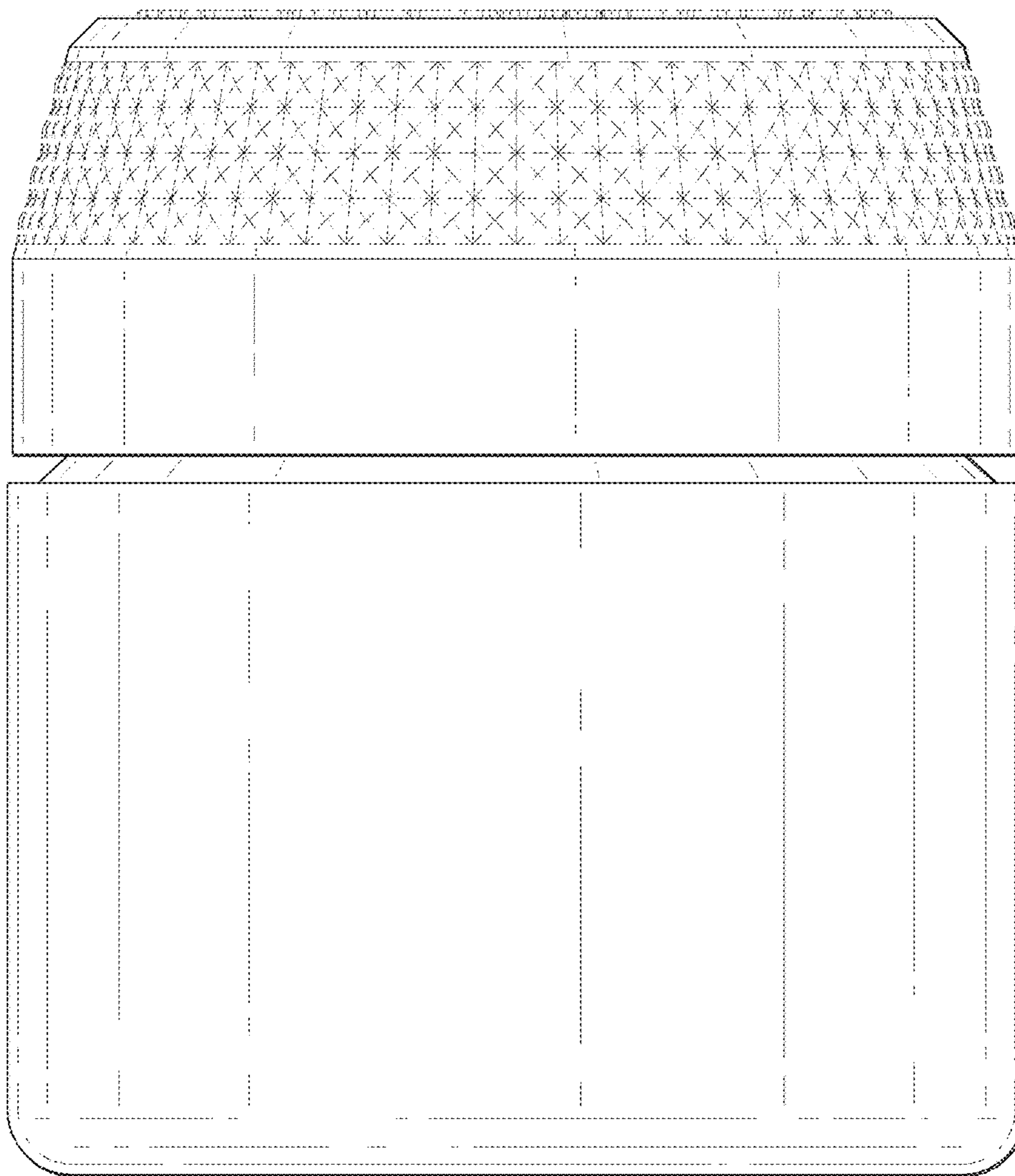

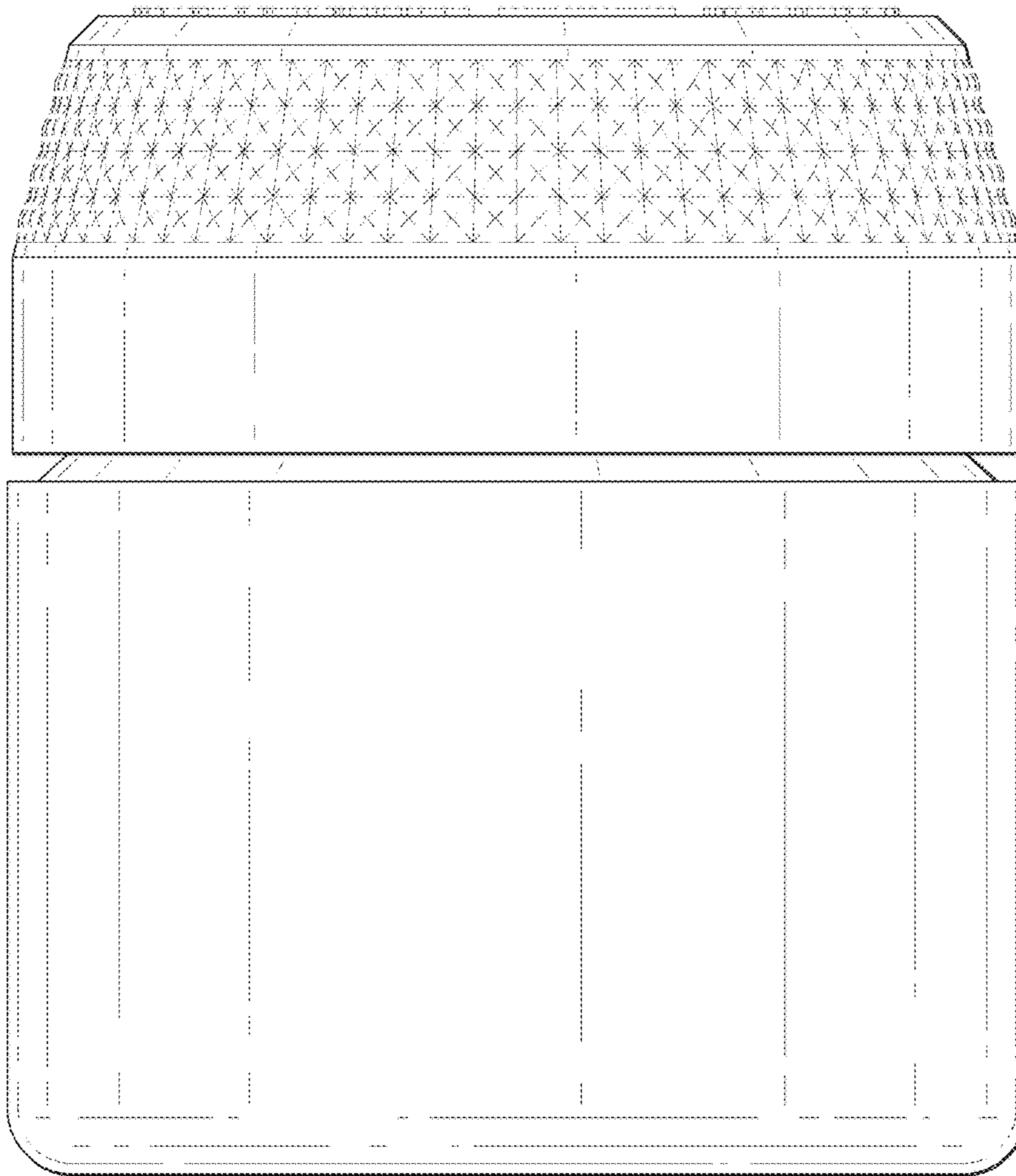

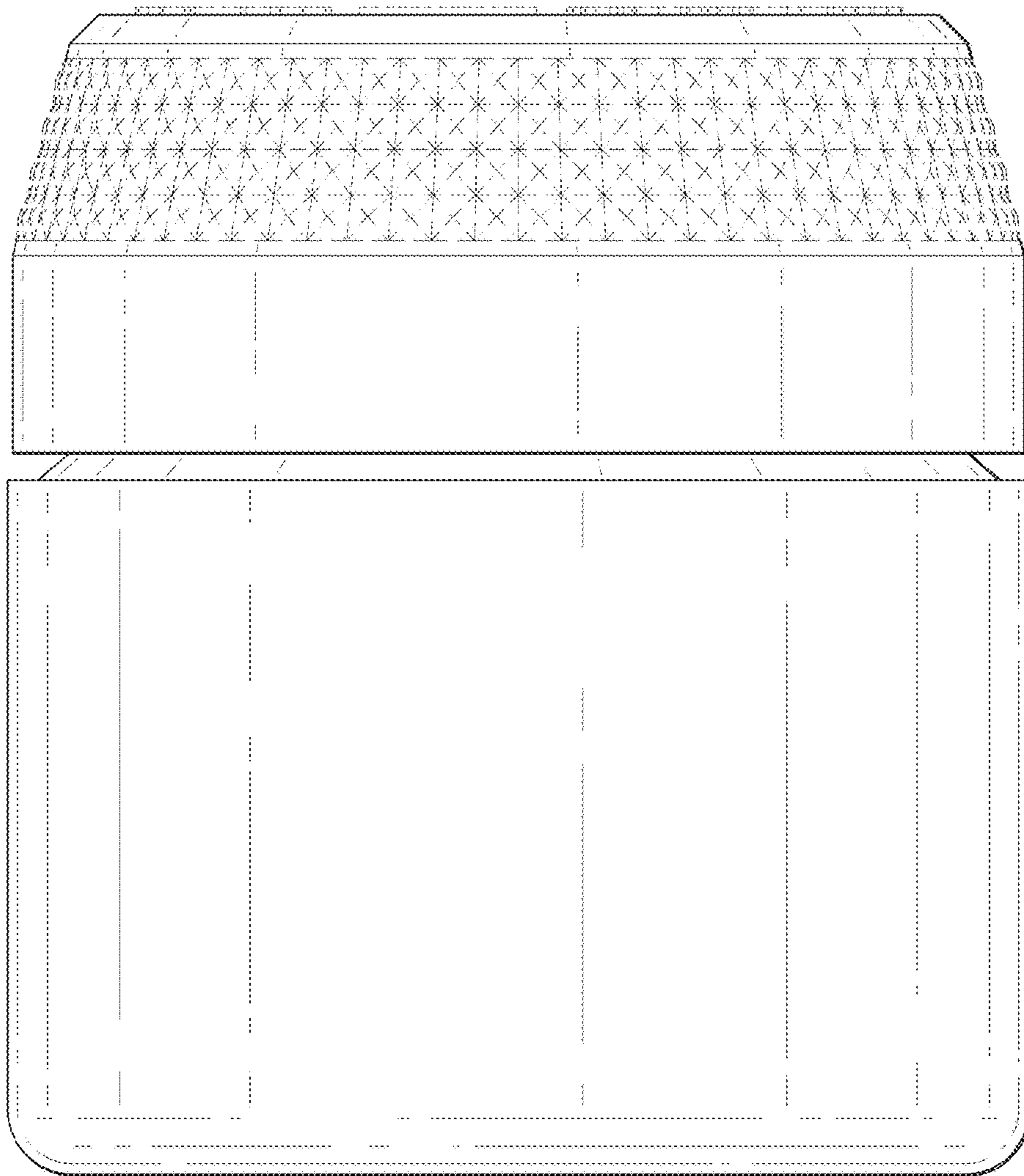

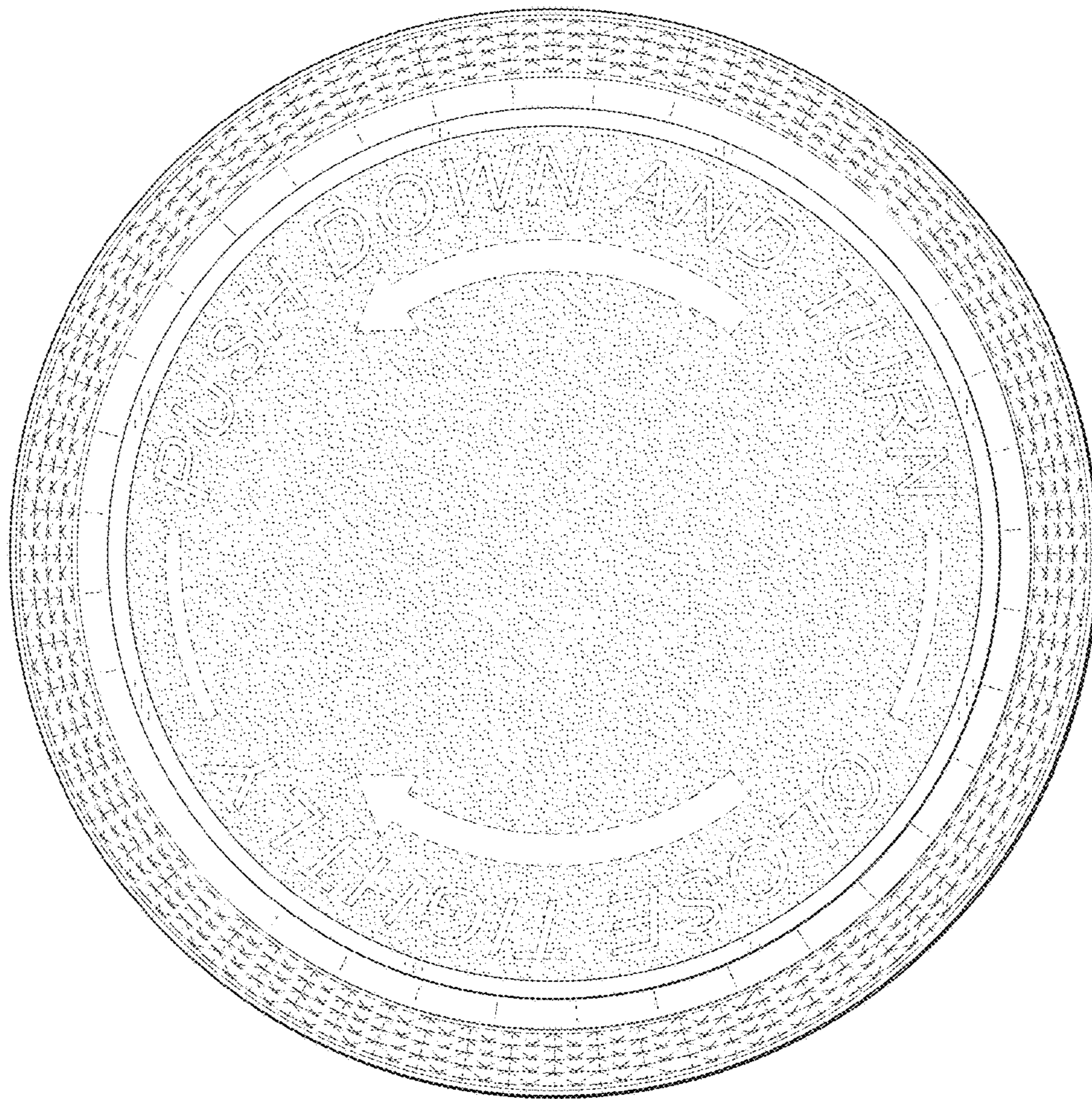

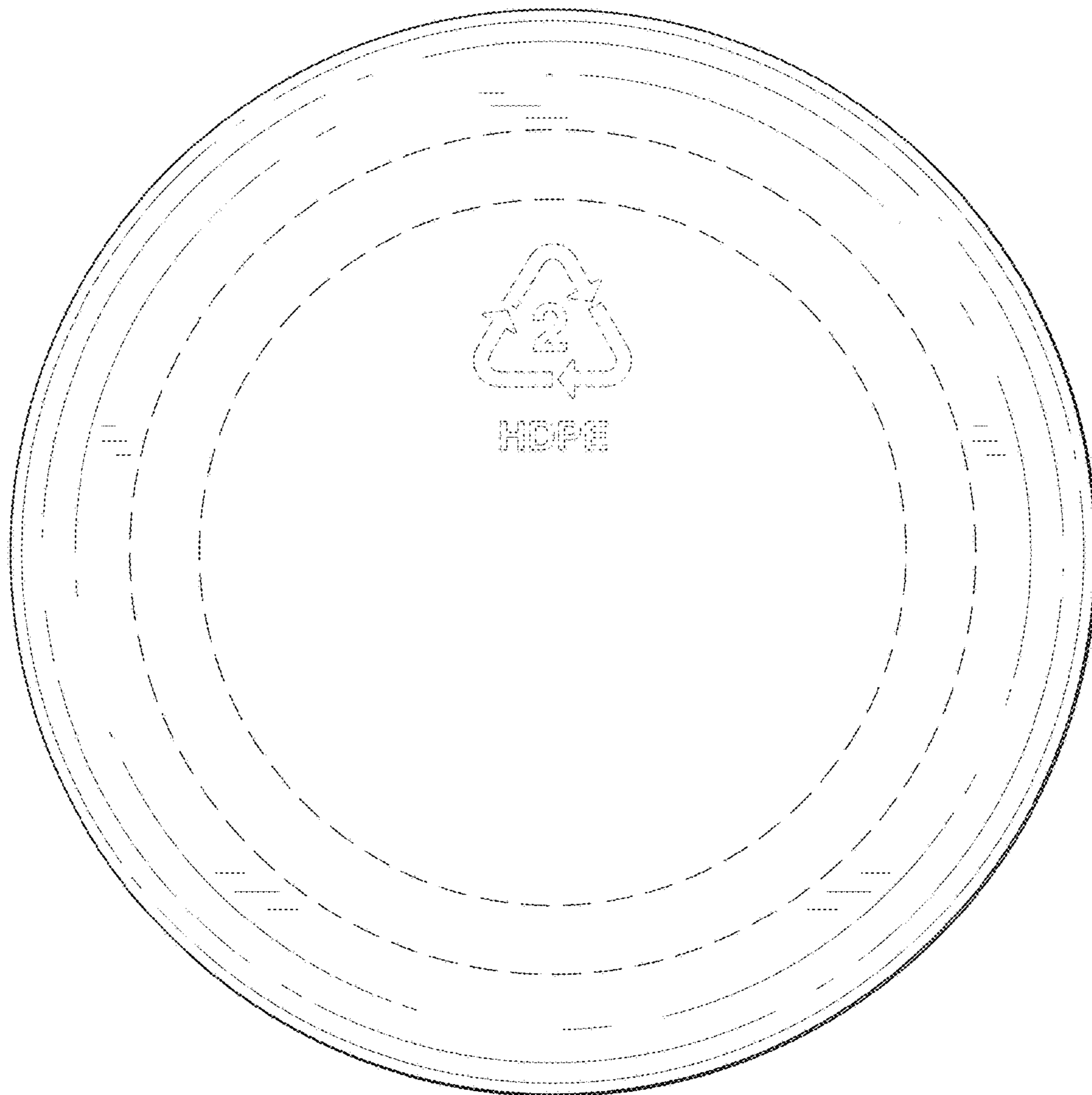
