(57) **CLAIM**

The ornamental design for a cosmetic vessel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cosmetic vessel according to the present invention.

FIG. 2 is a front view of the cosmetic vessel of FIG. 1.

FIG. 3 is a rear view of the cosmetic vessel of FIG. 1.

FIG. 4 is a left side view of the cosmetic vessel of FIG. 1.

FIG. 5 is a right side view of the cosmetic vessel of FIG. 1; and,

FIG. 6 is a top view of the cosmetic vessel of FIG. 1.

A bottom view is omitted since it does not contain ornamental features.

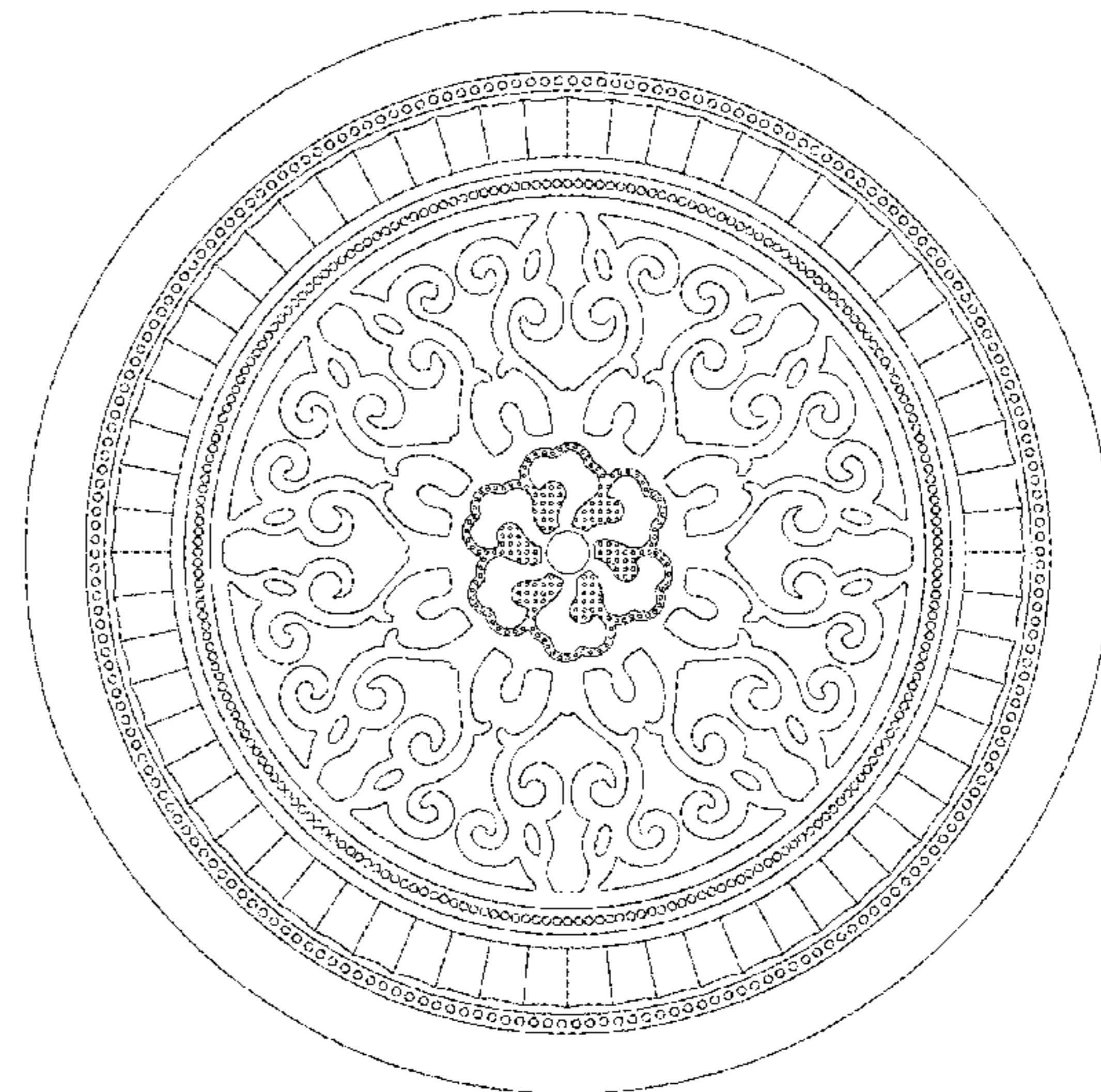
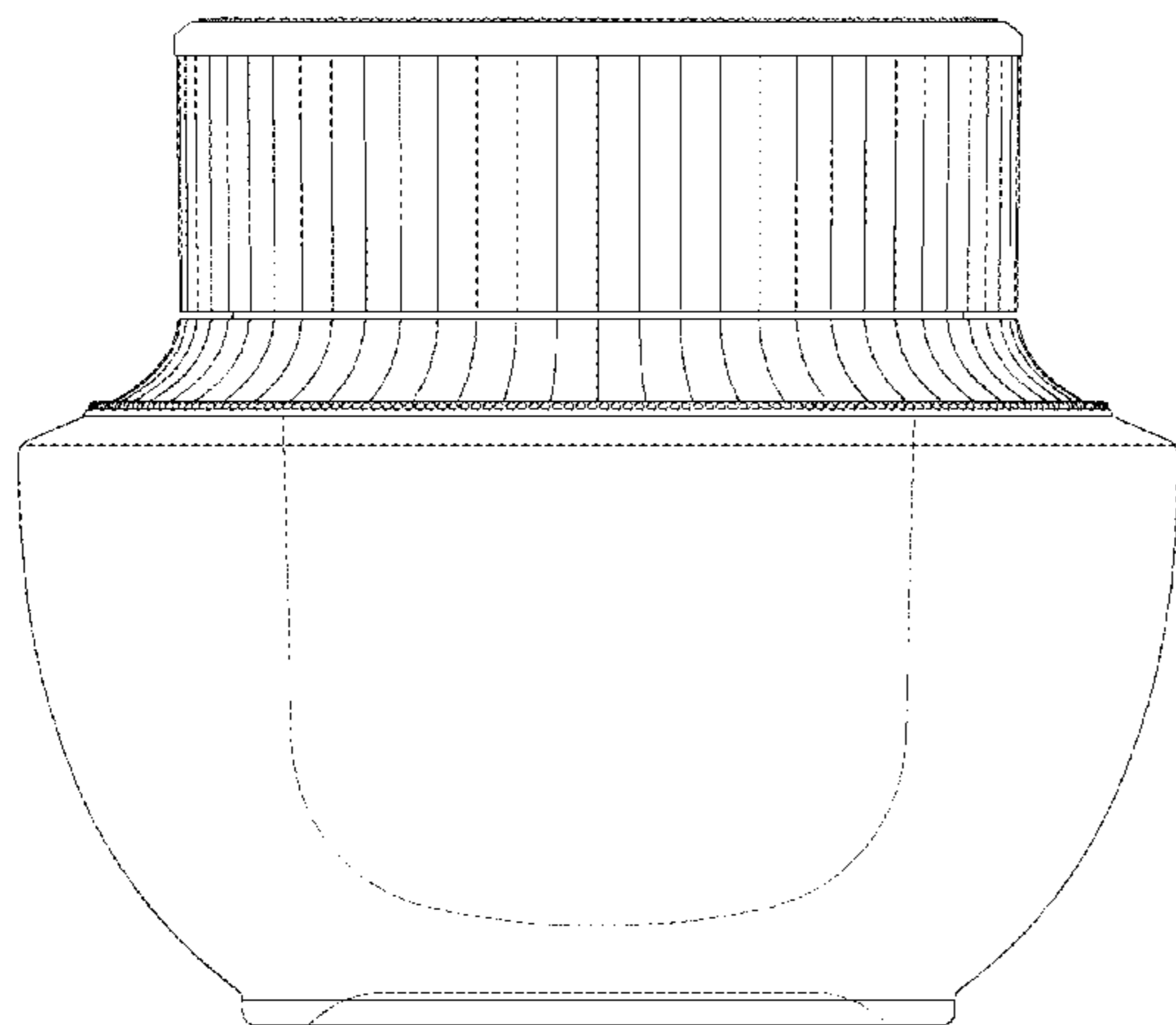

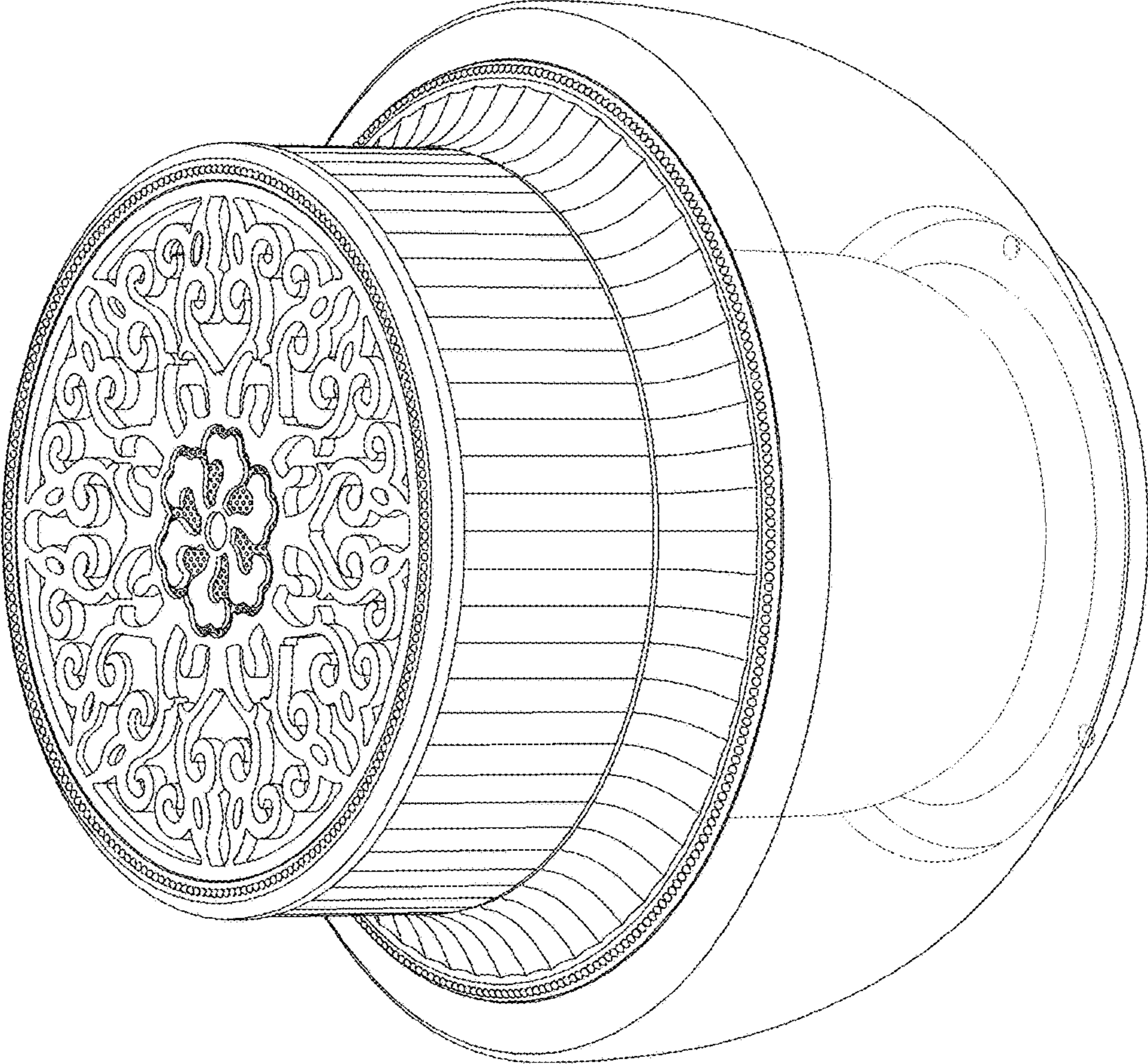

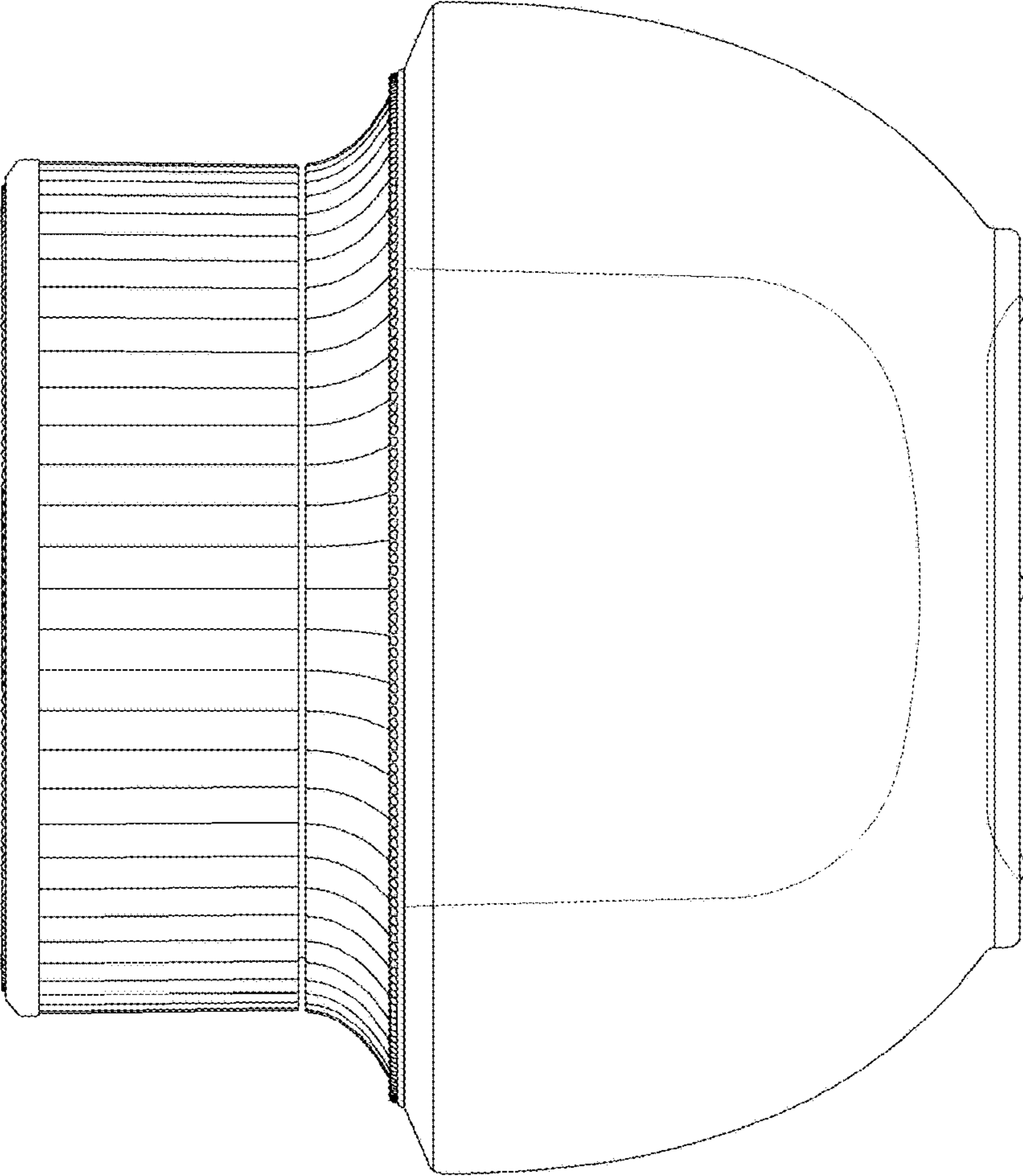

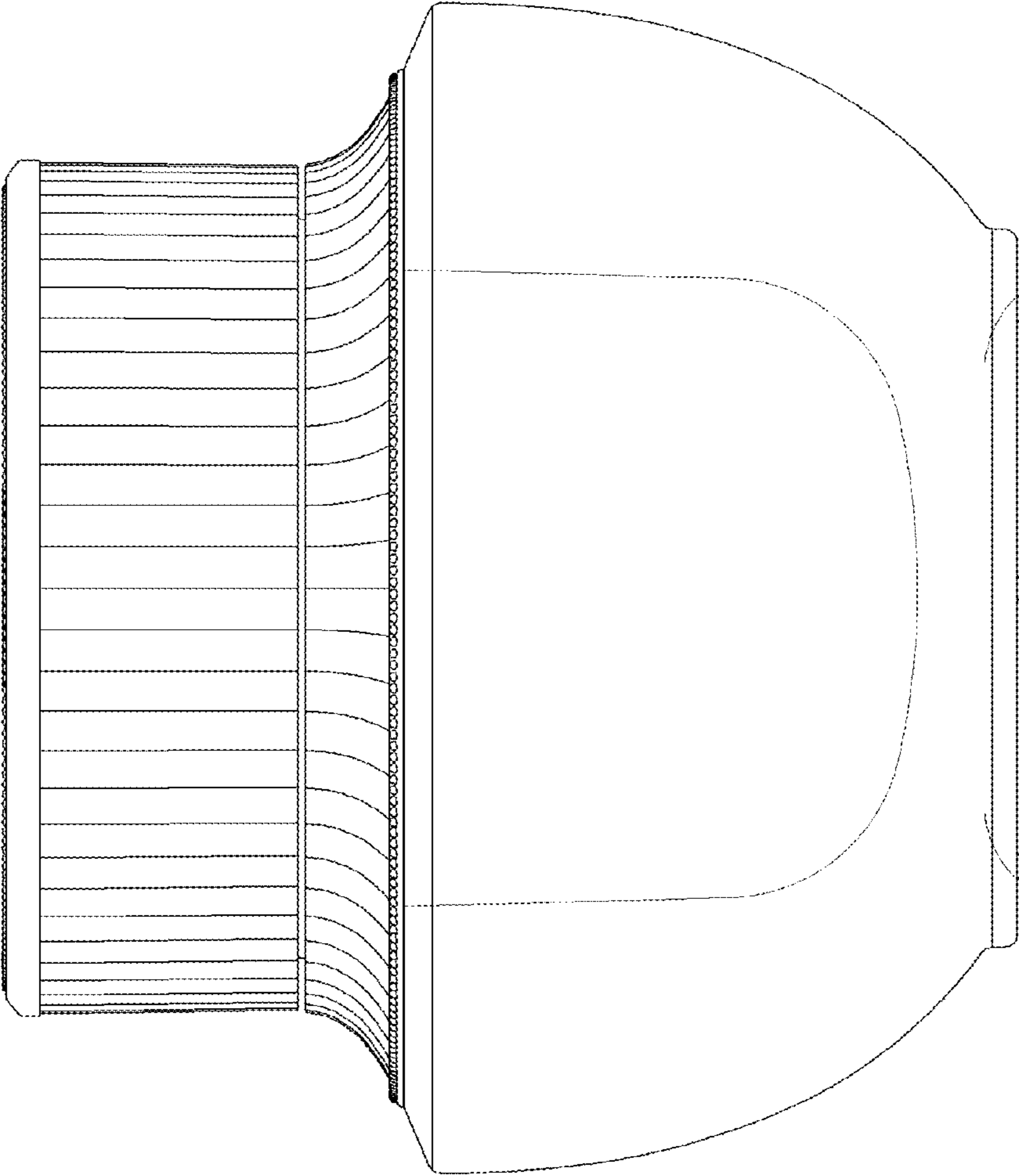

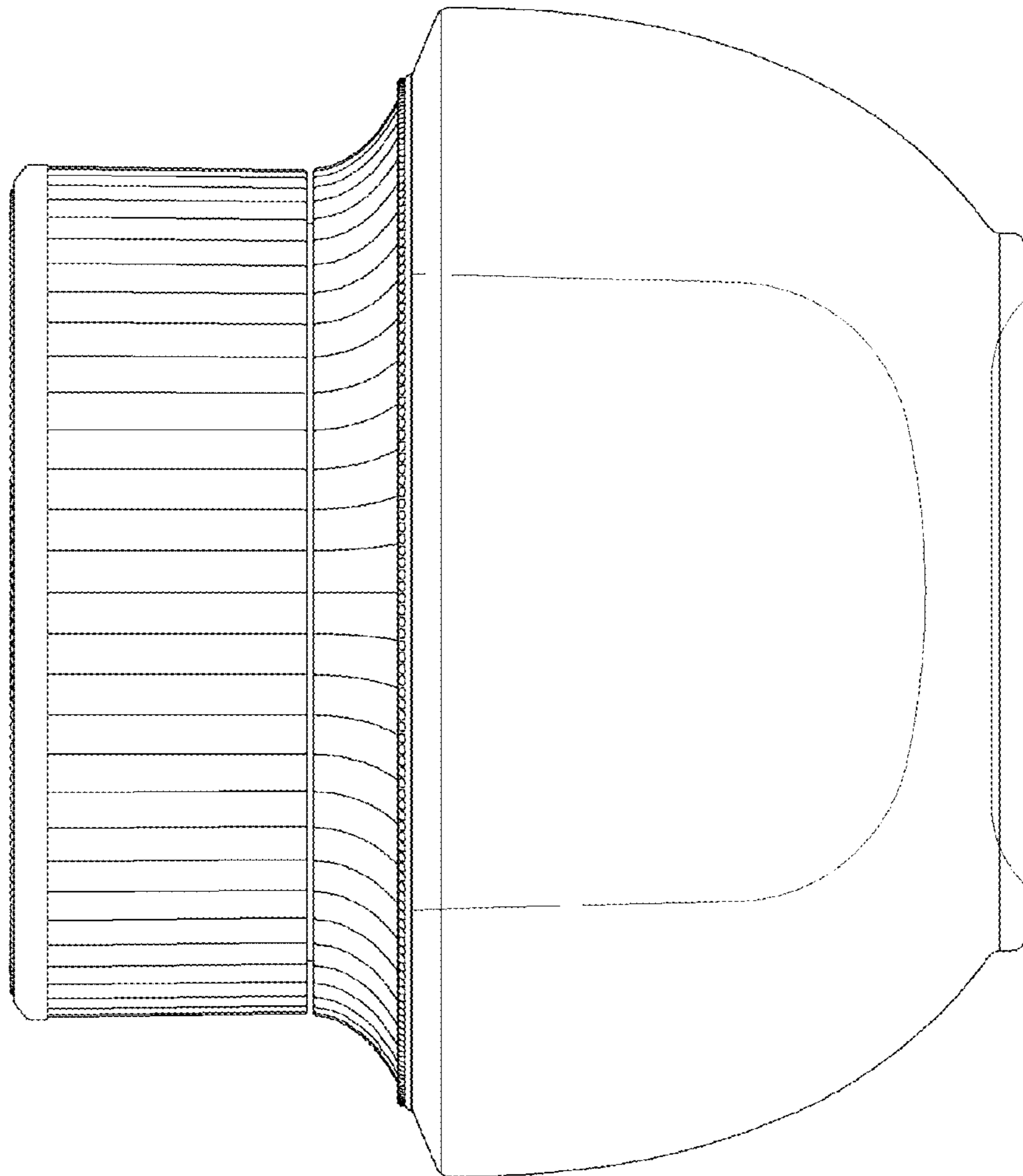

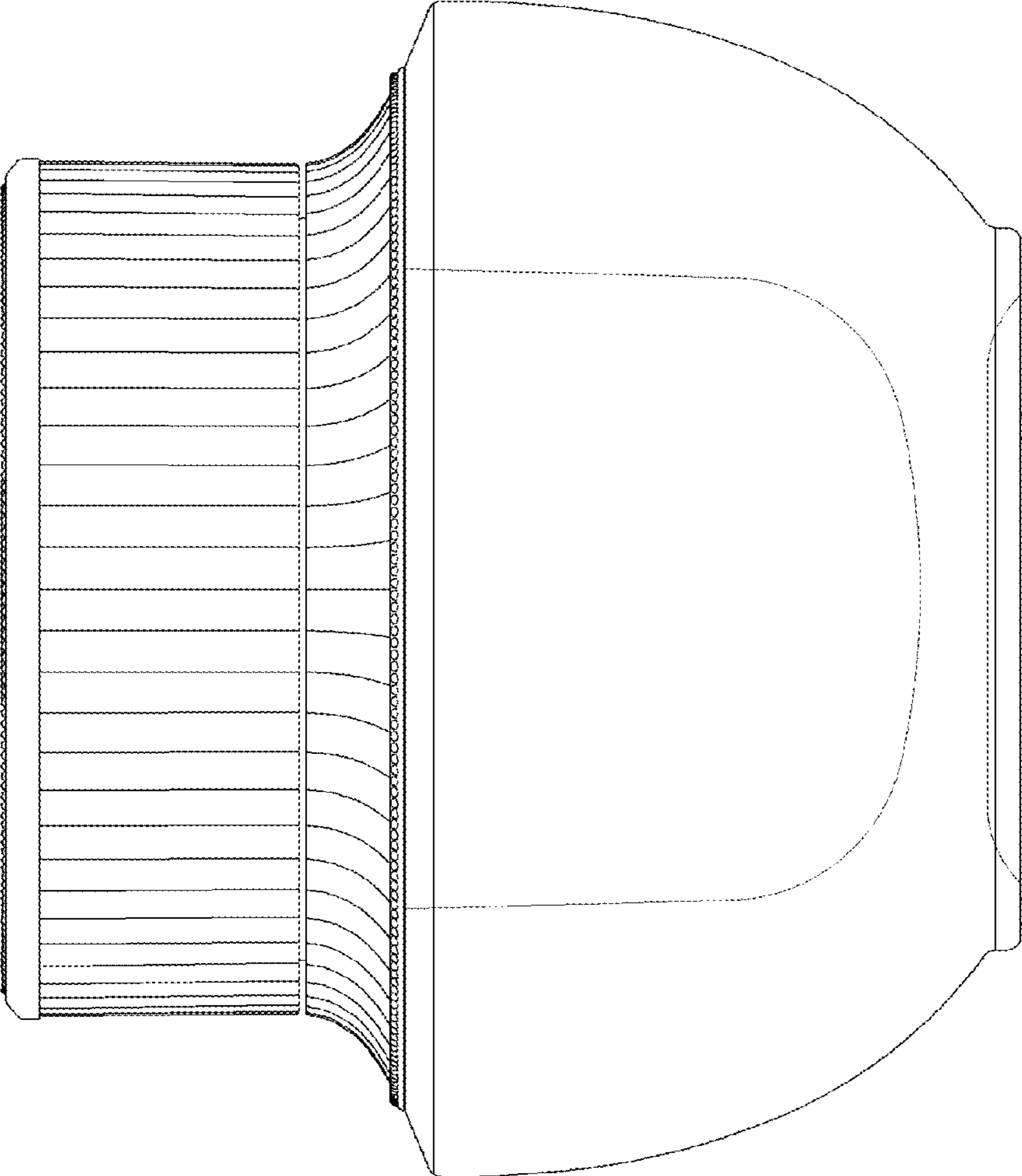
