FIG. 25 is a left side view thereof;

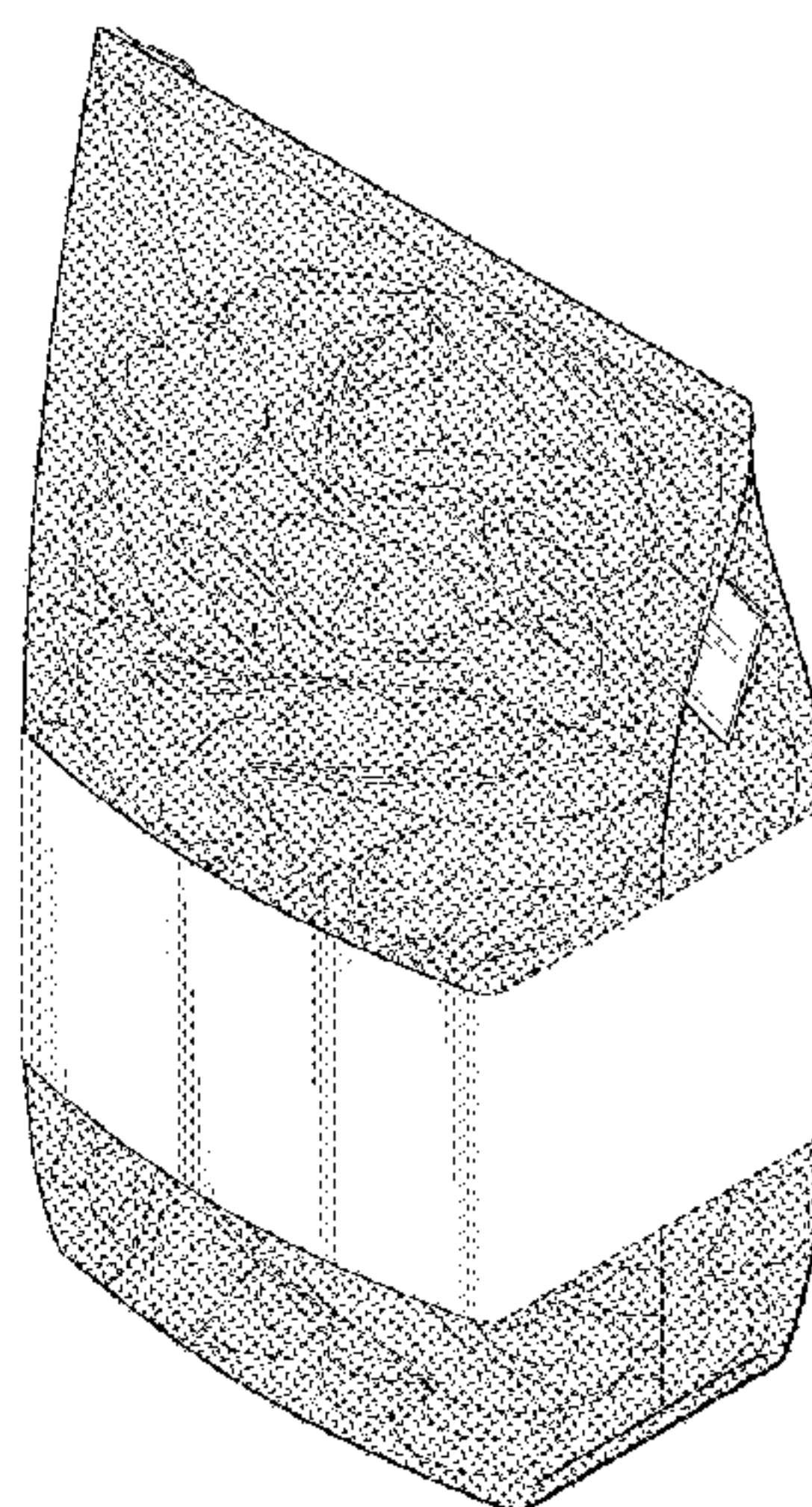
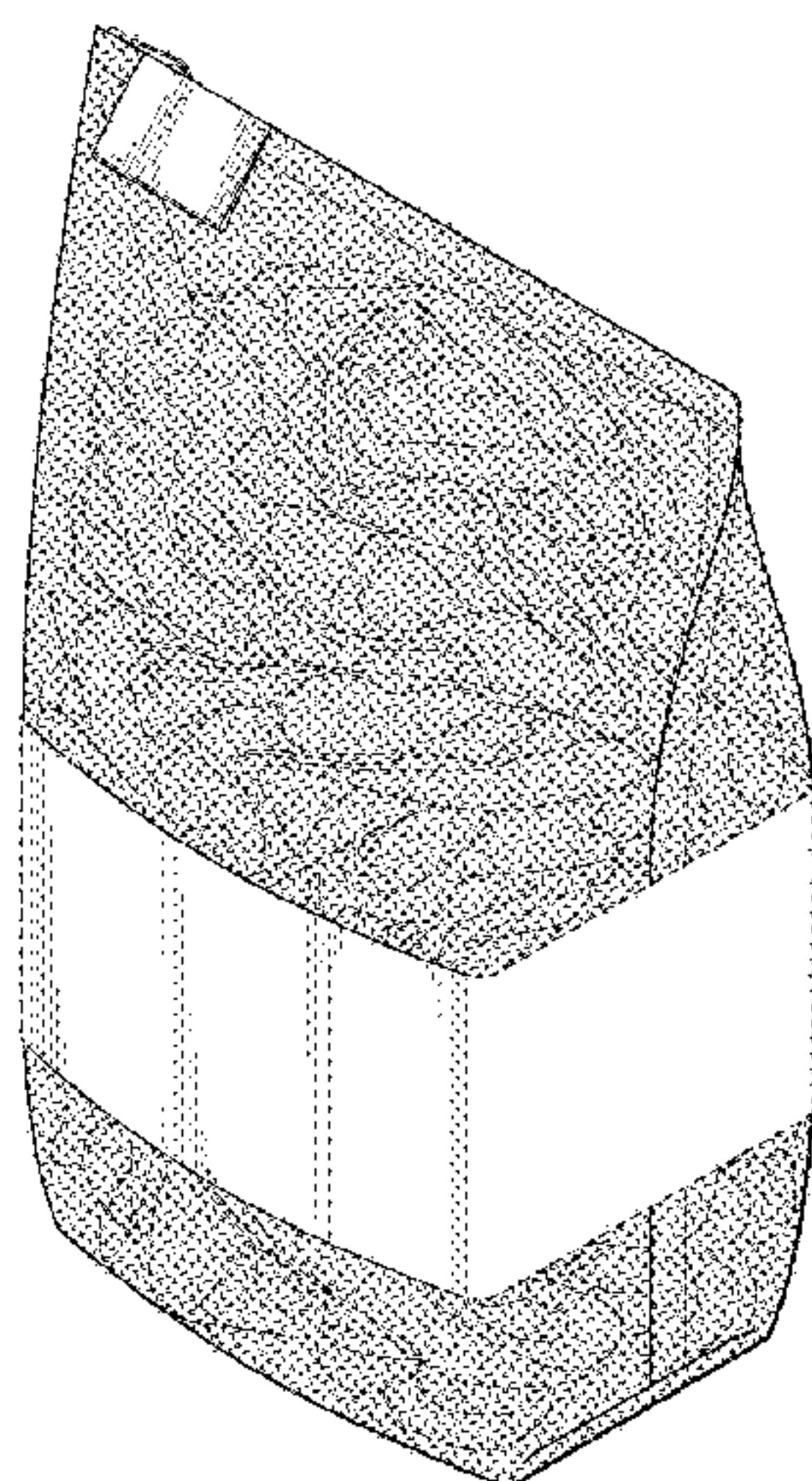
FIG. 26 is a rear view thereof;

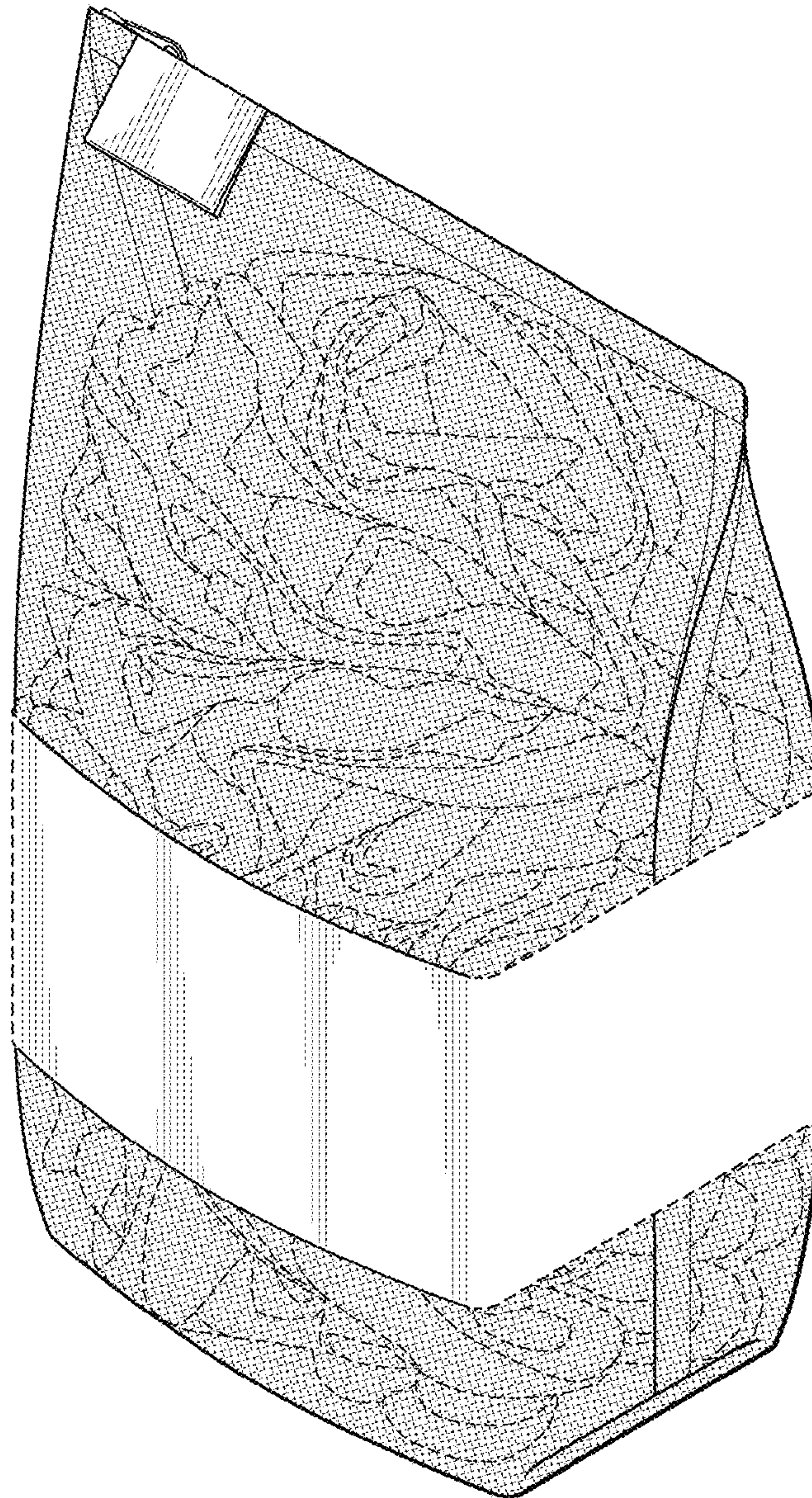

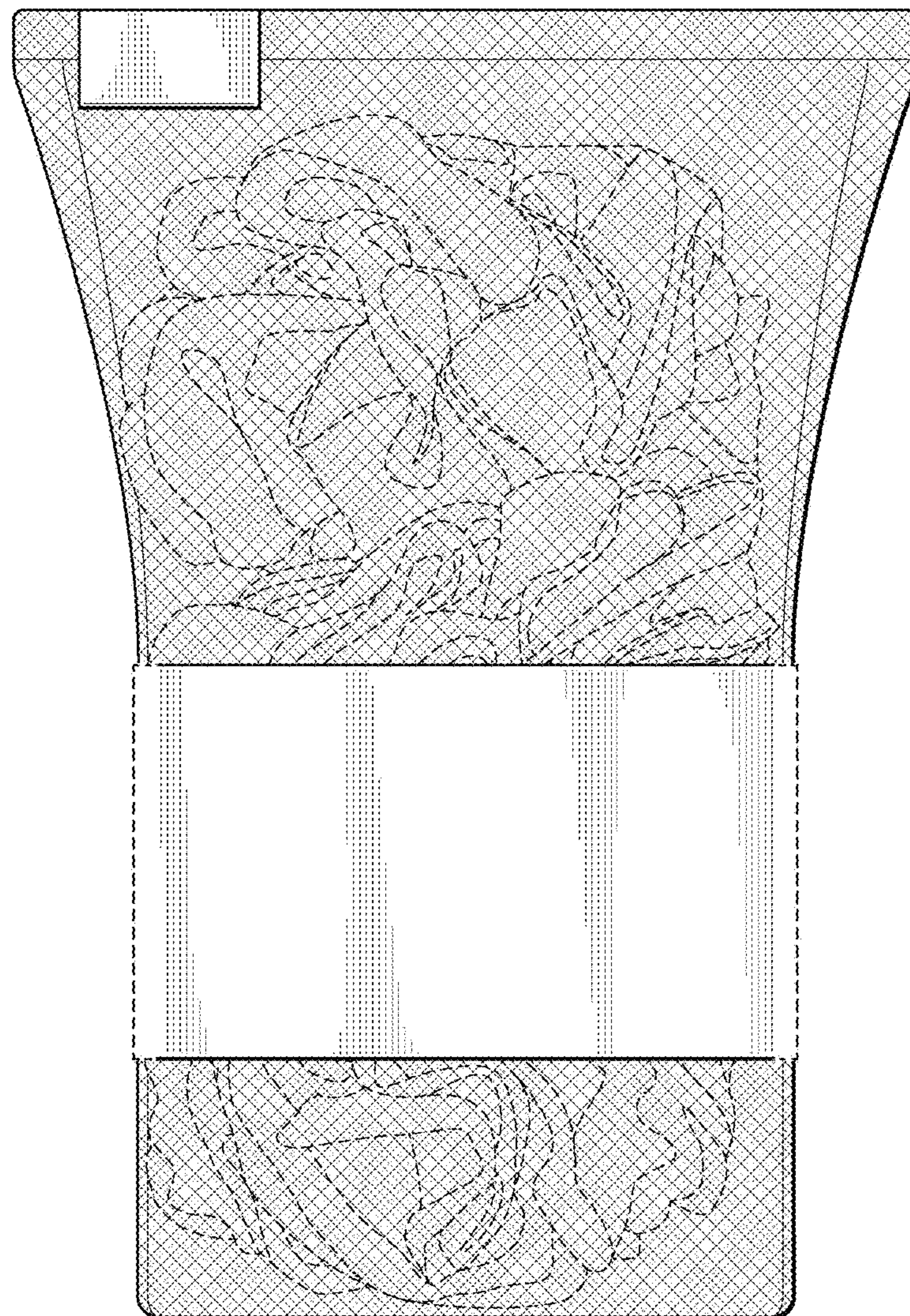

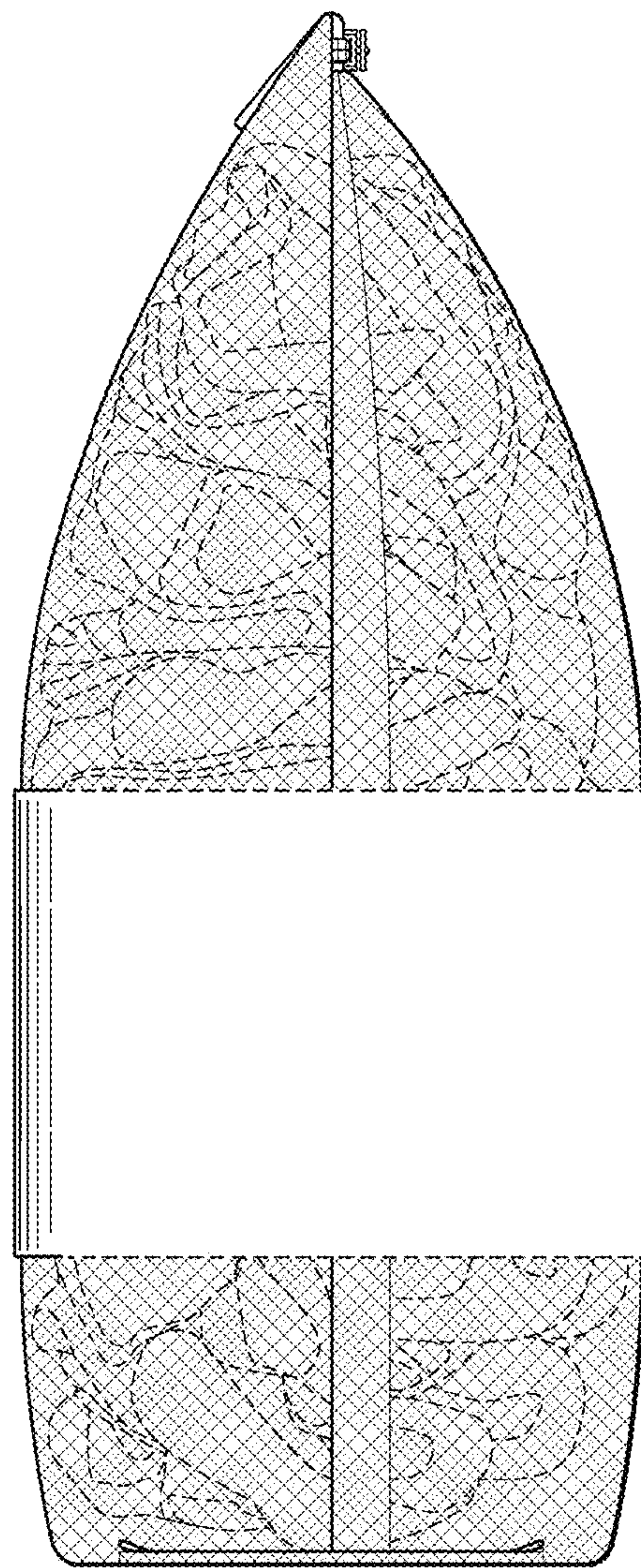

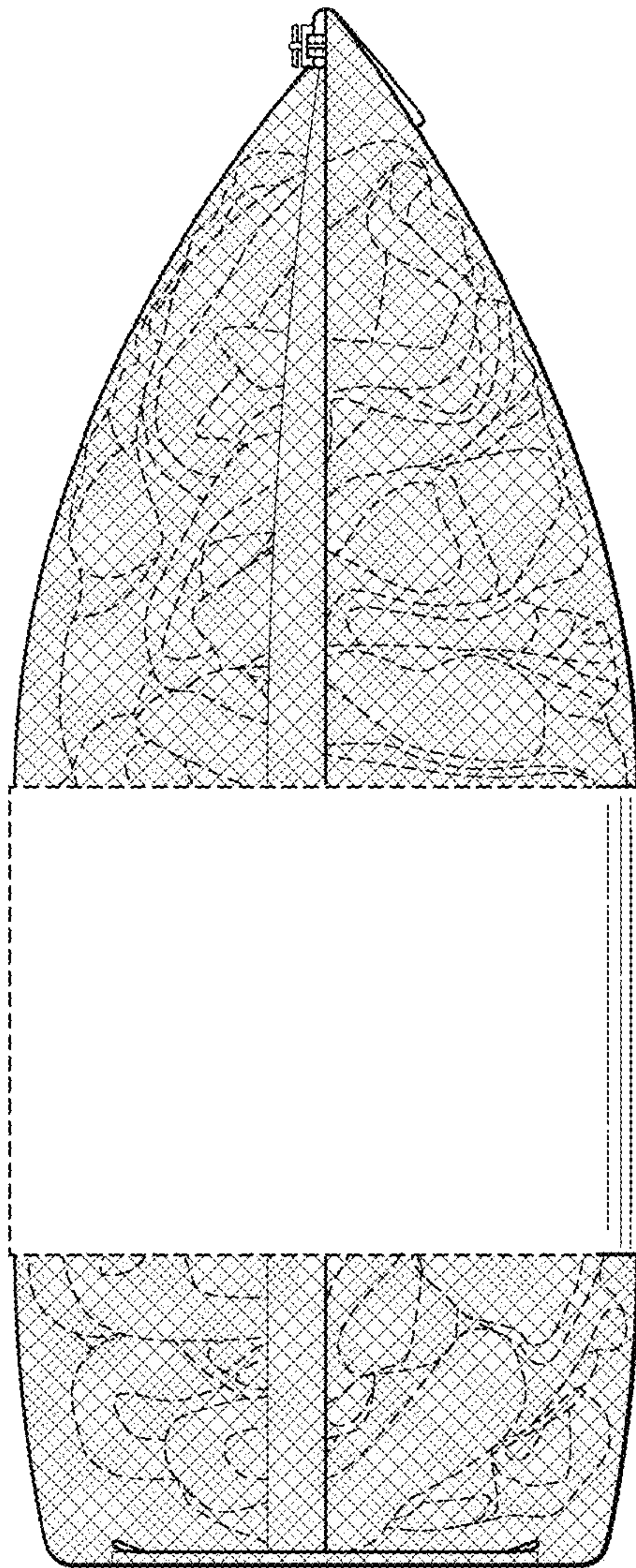

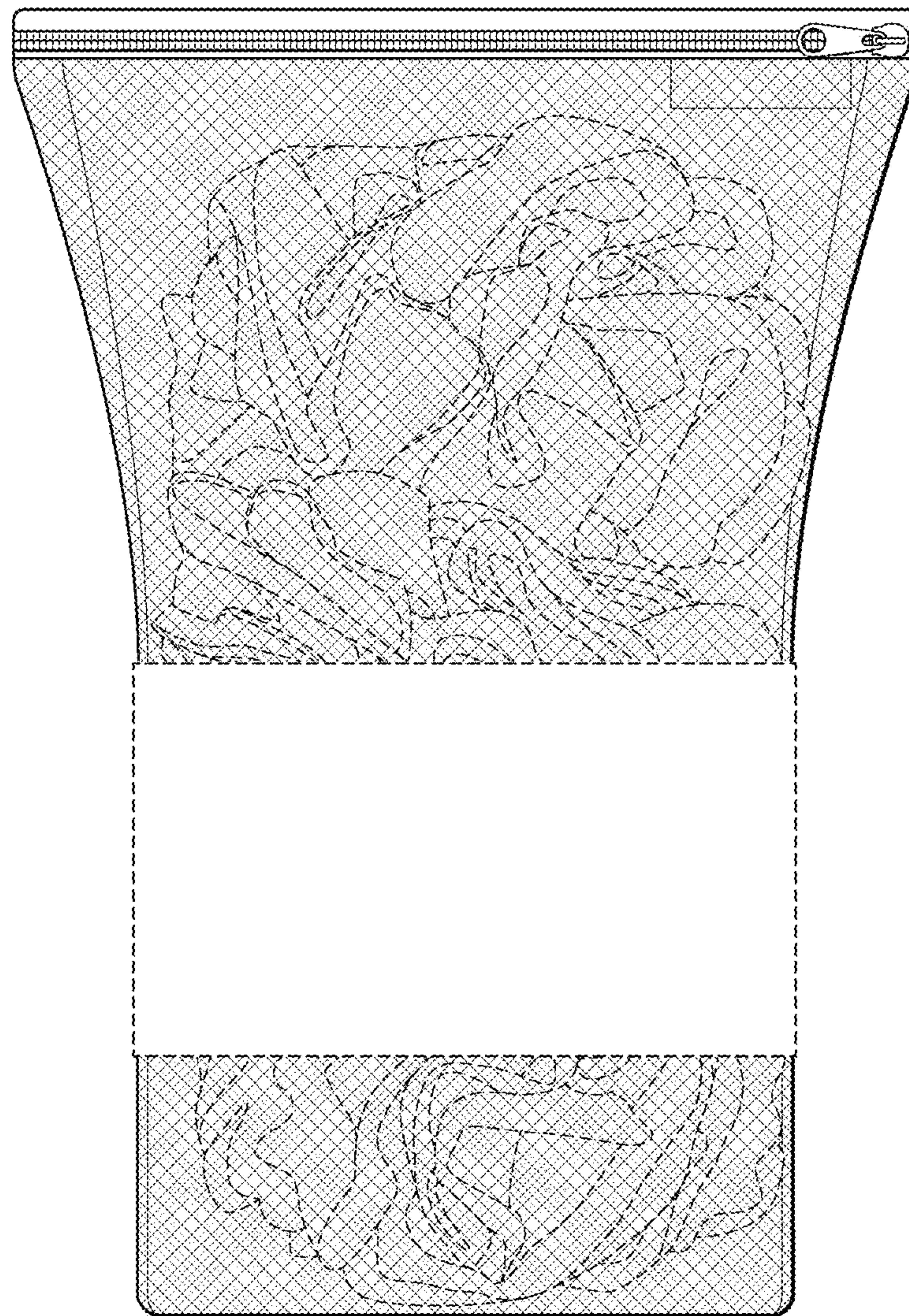

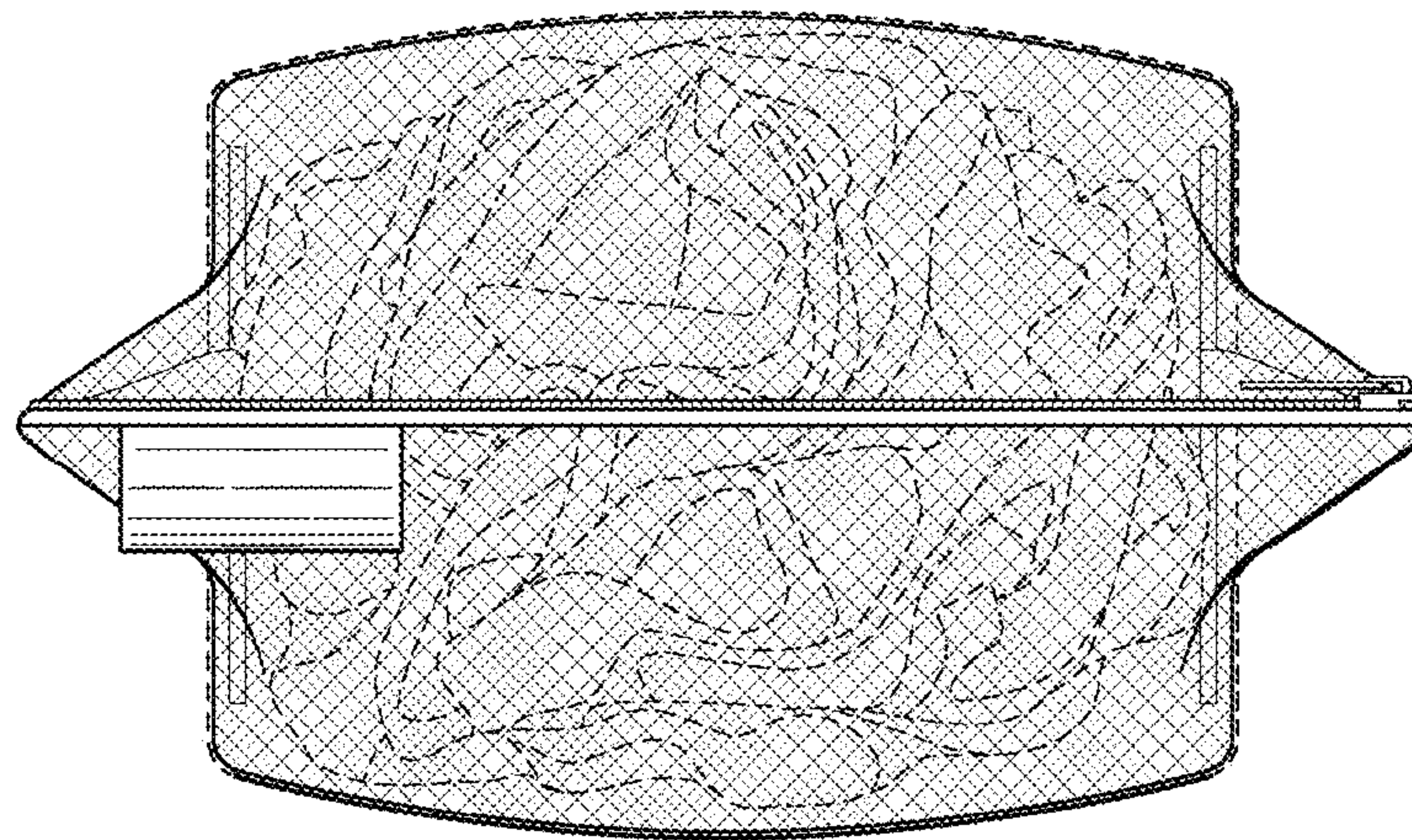

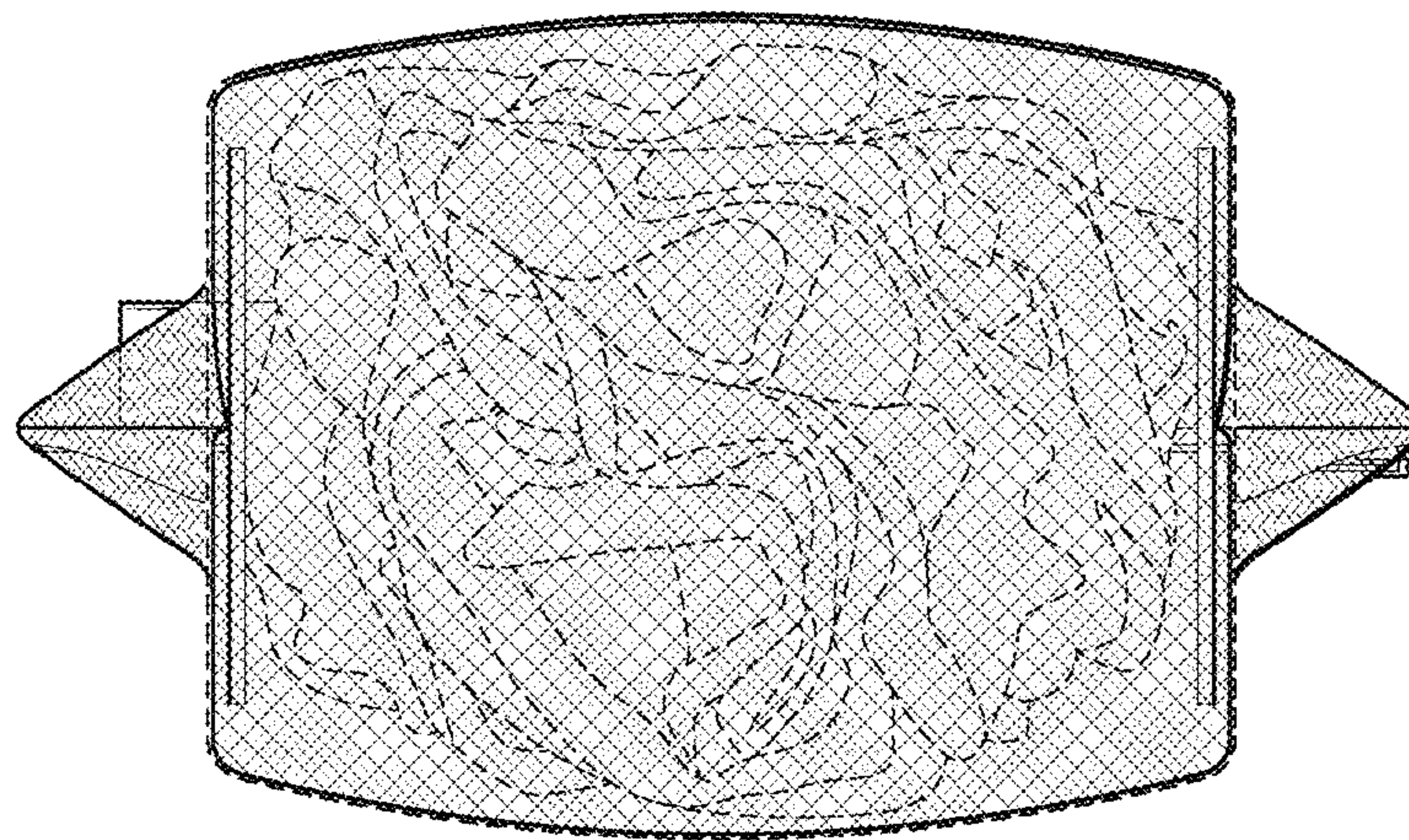

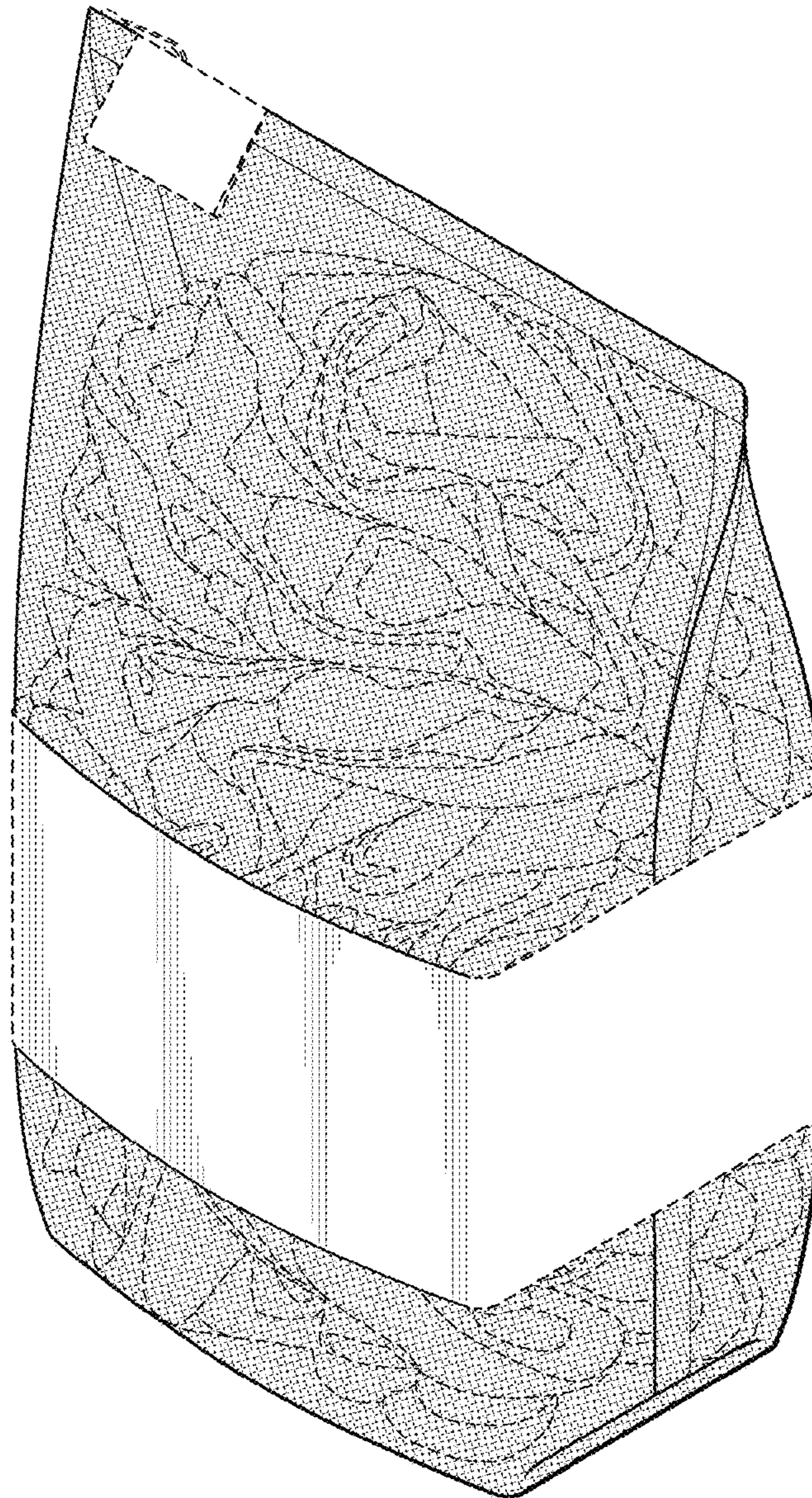

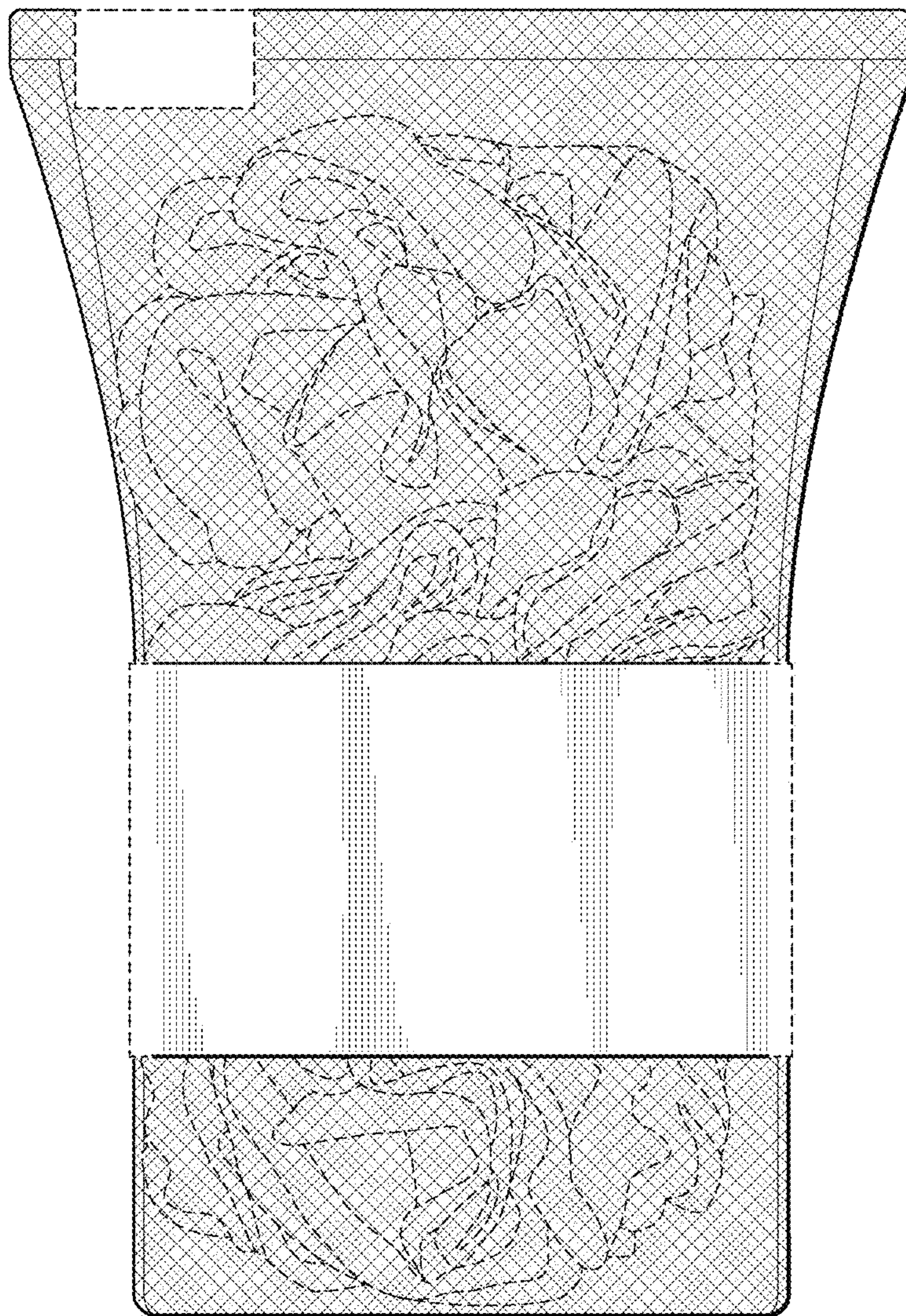

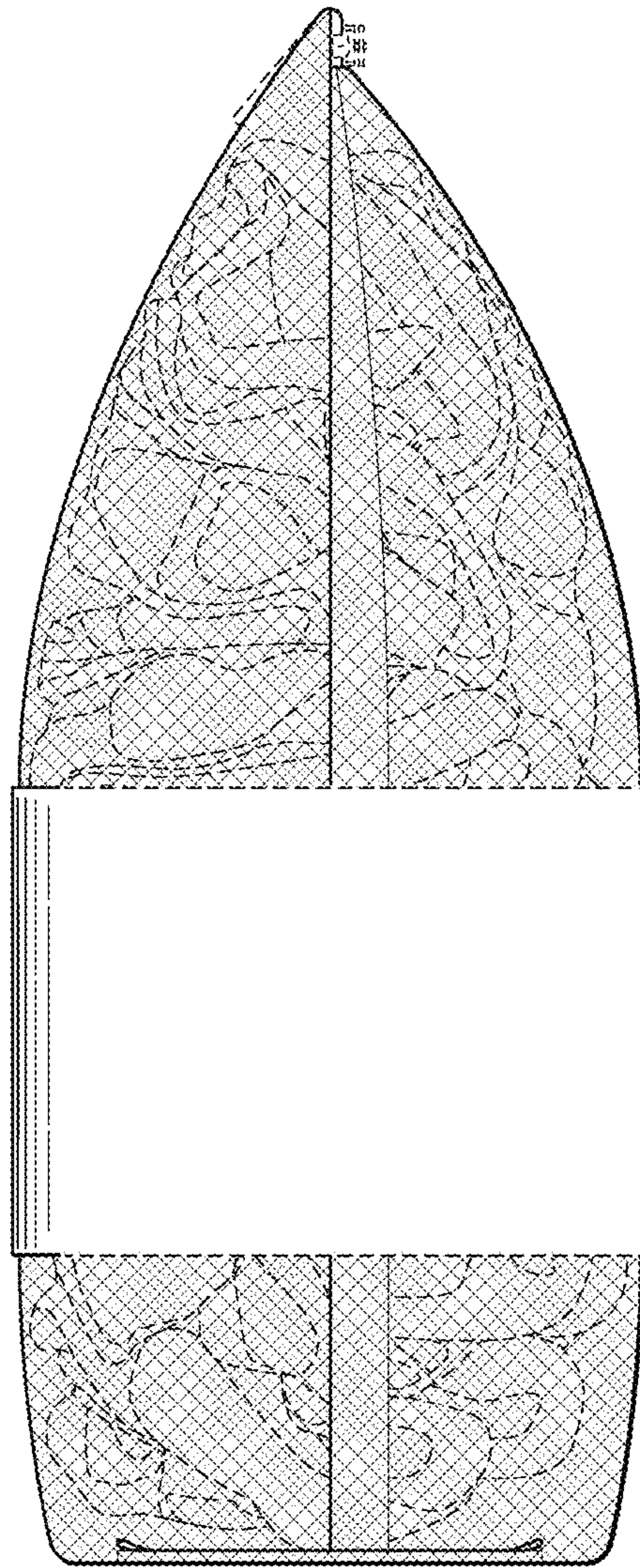

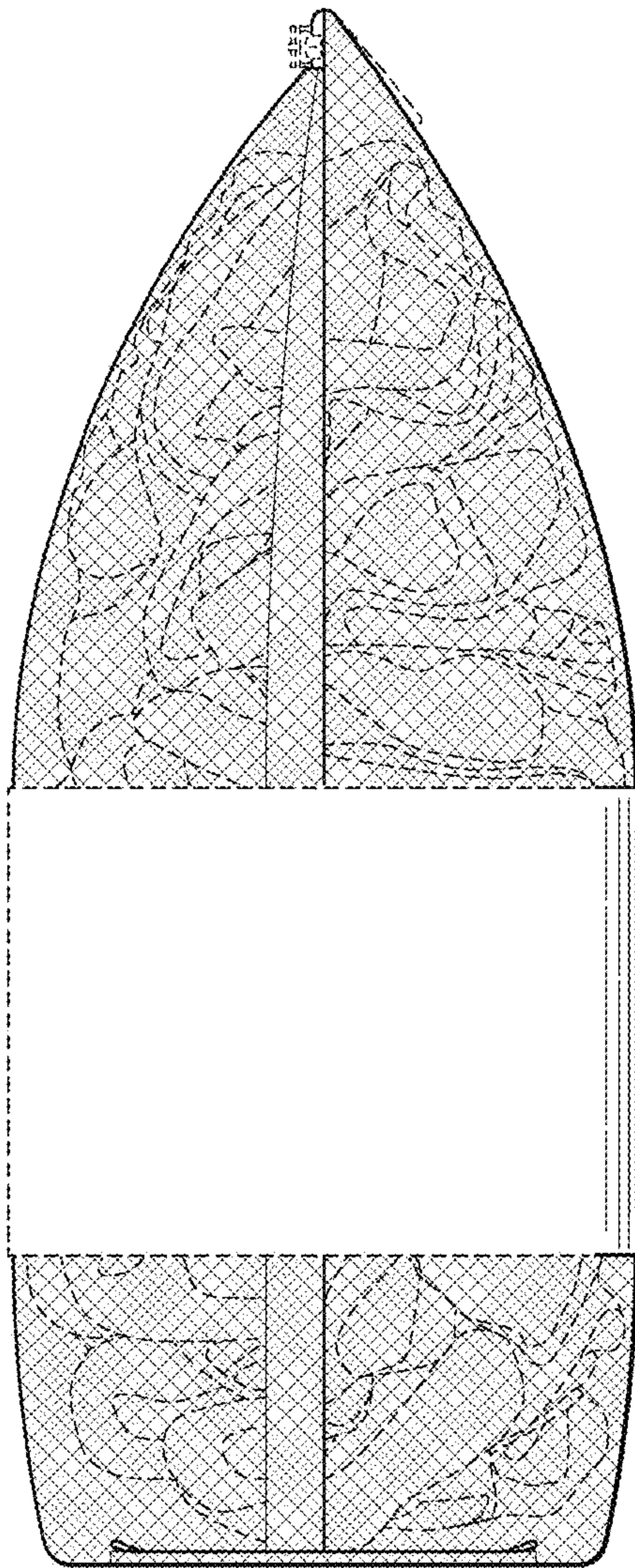

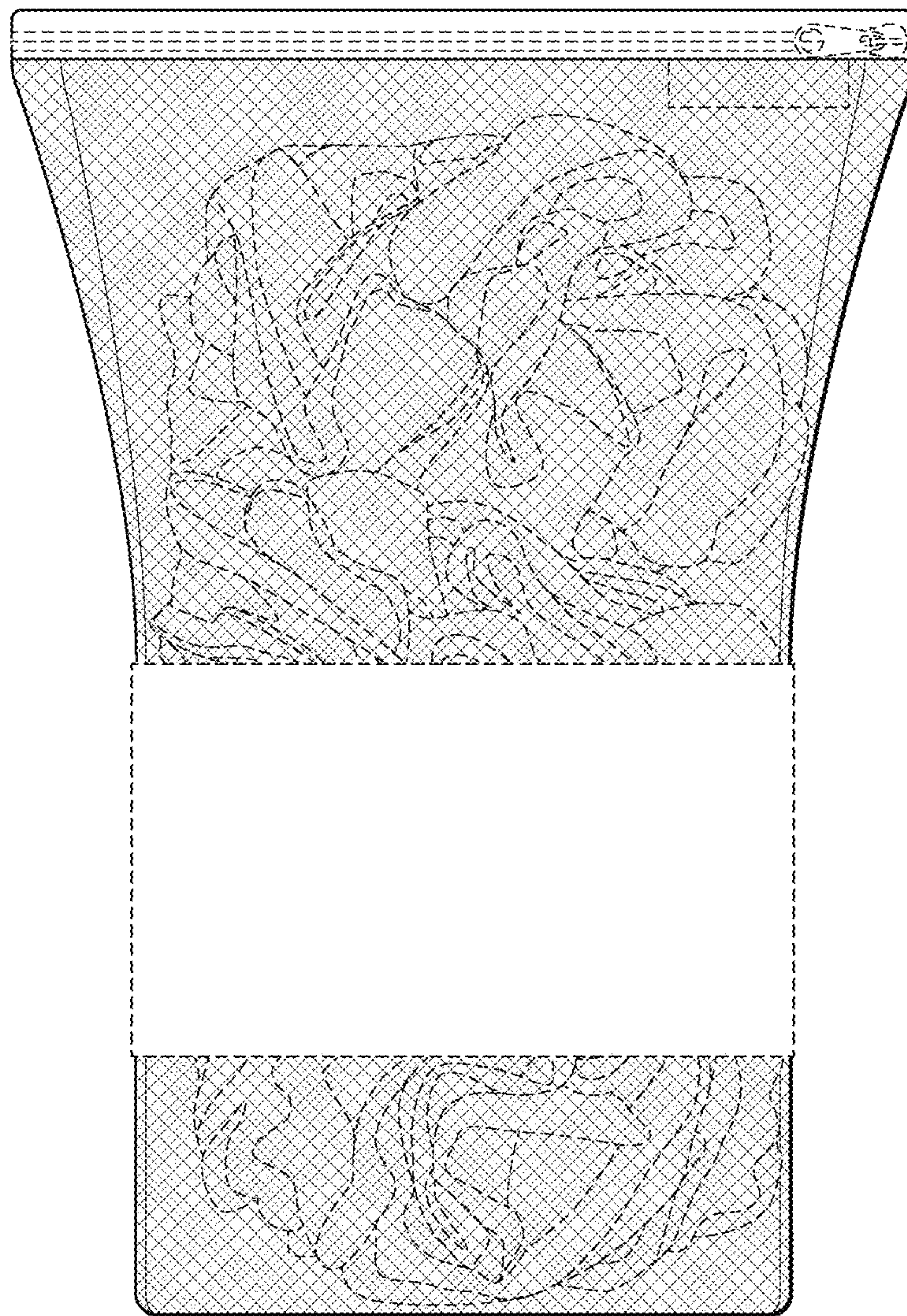

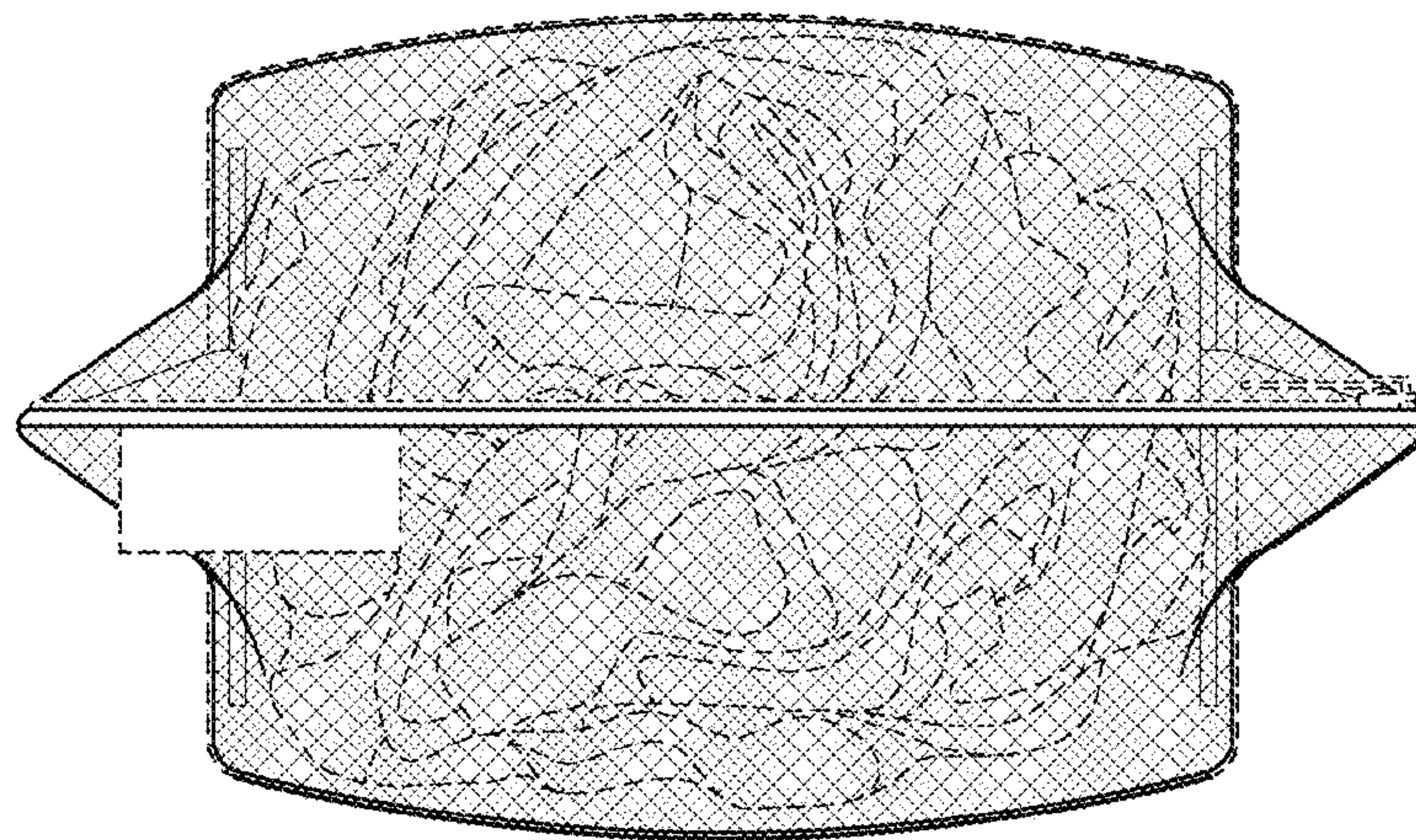

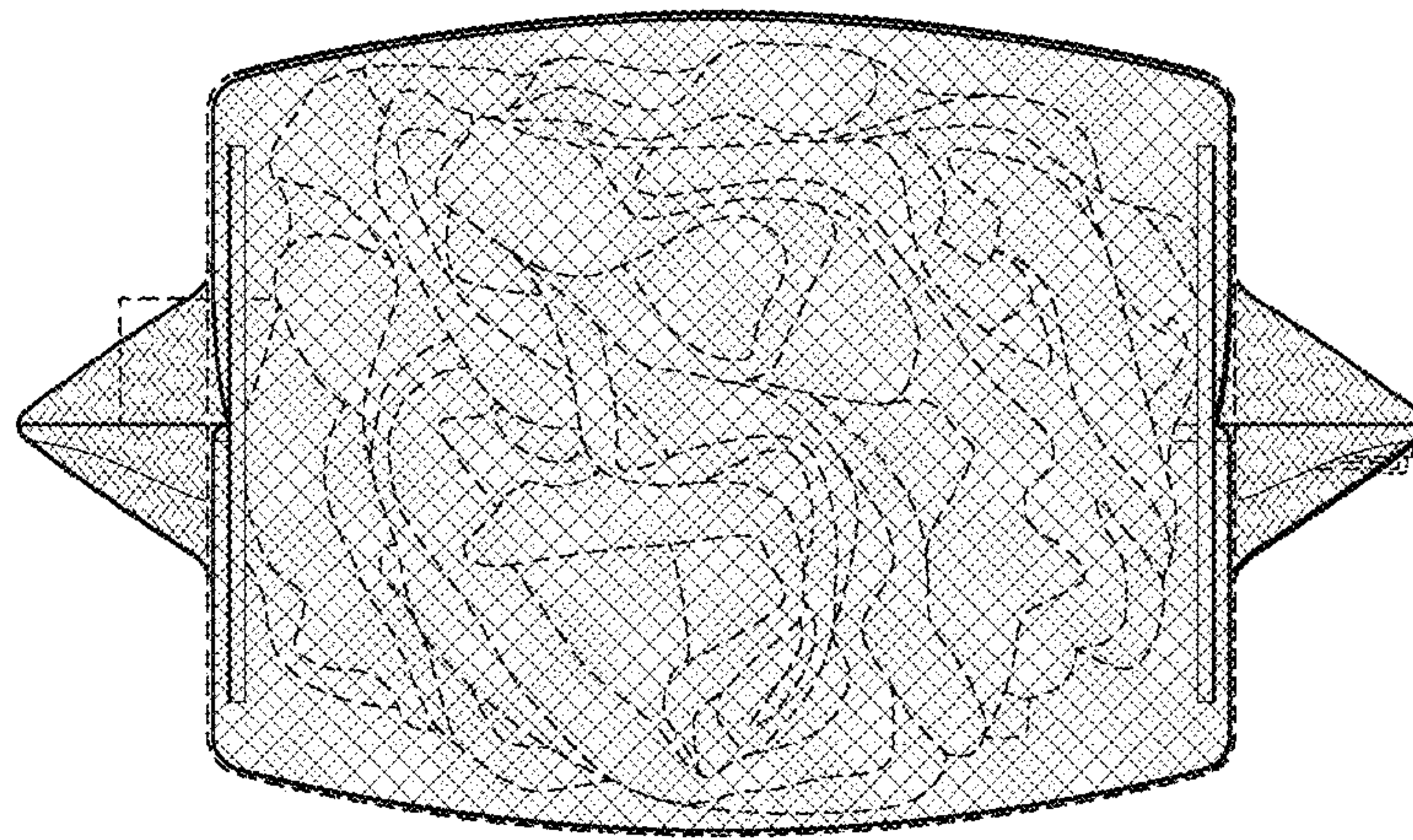

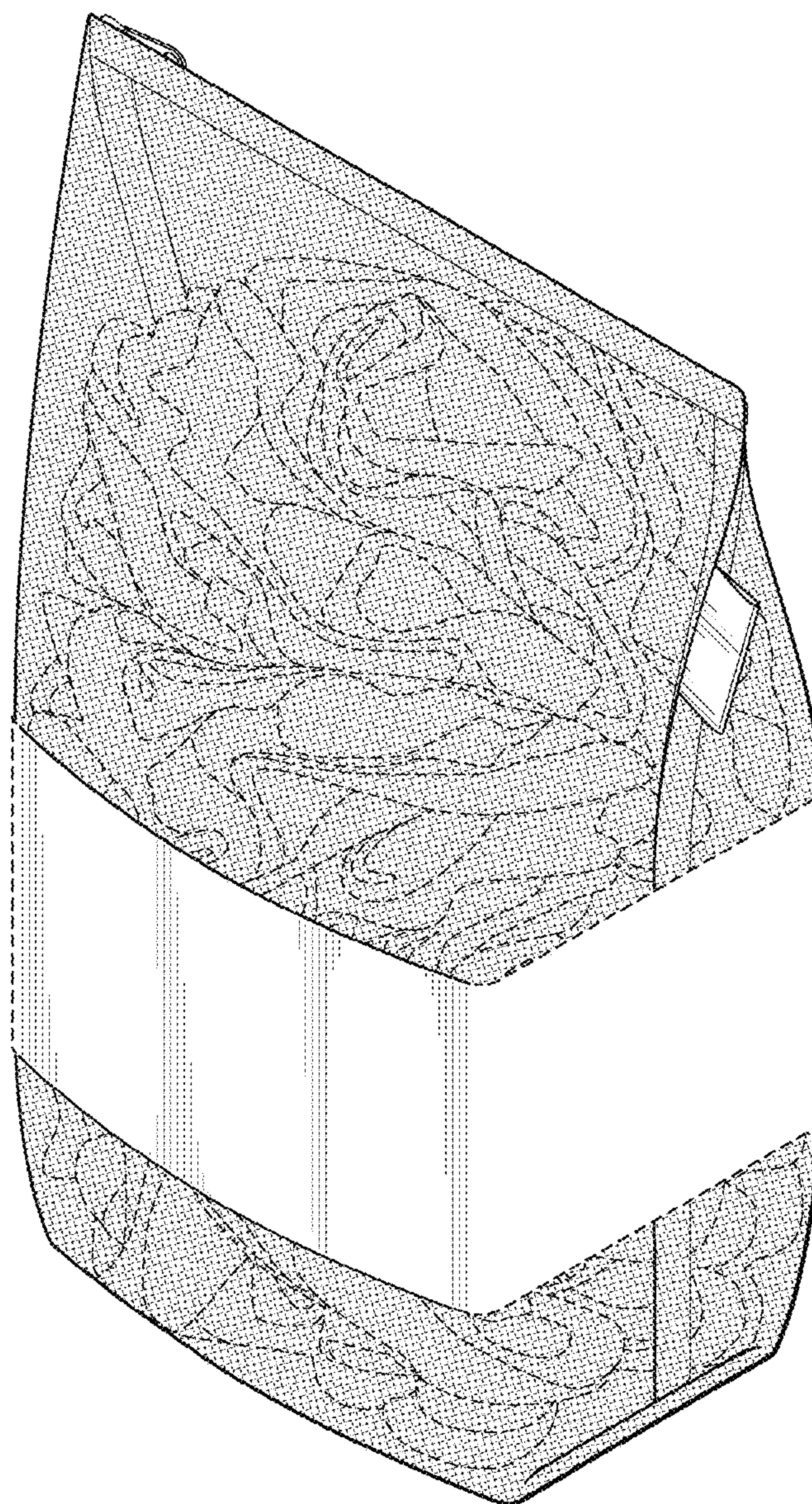

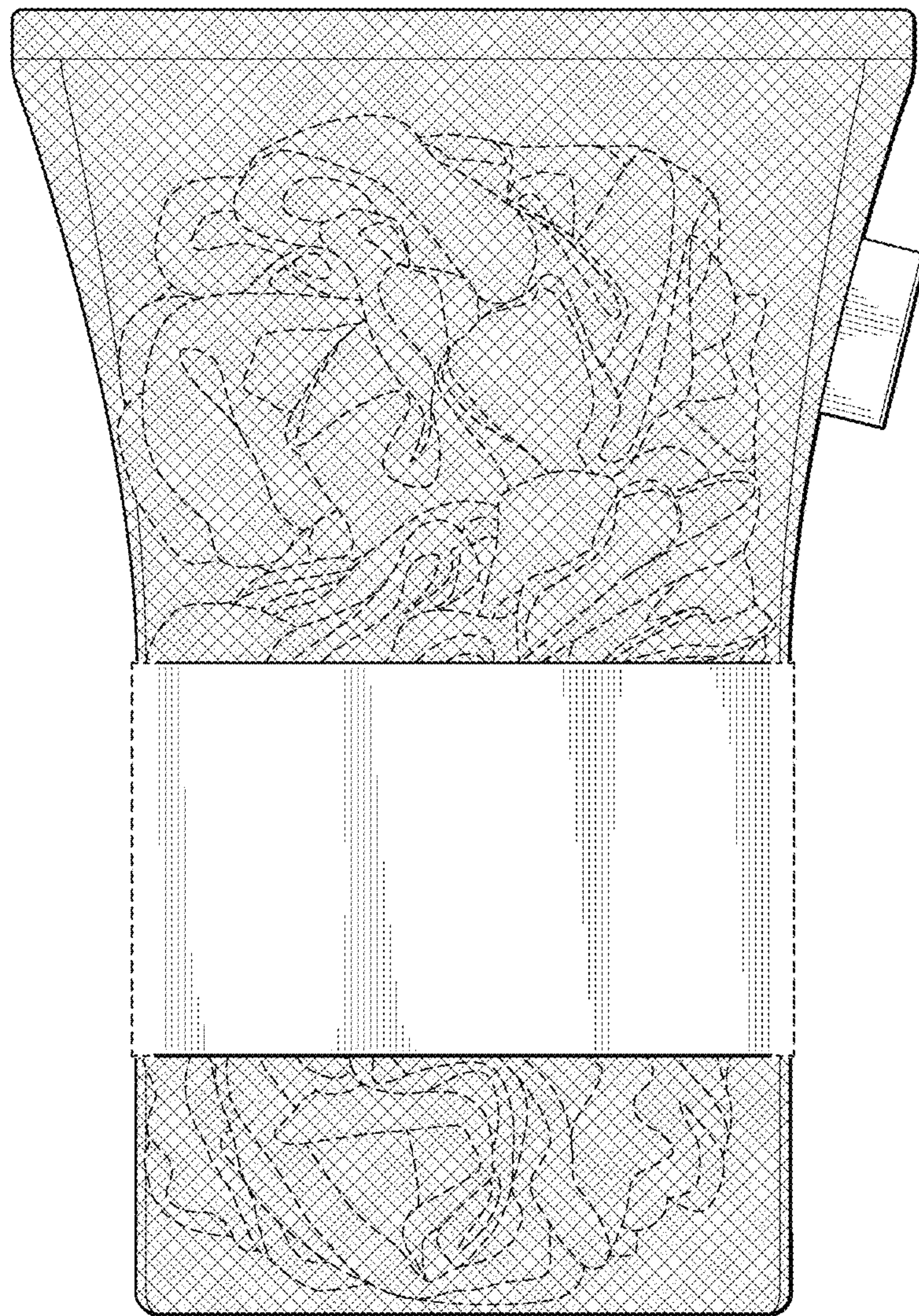

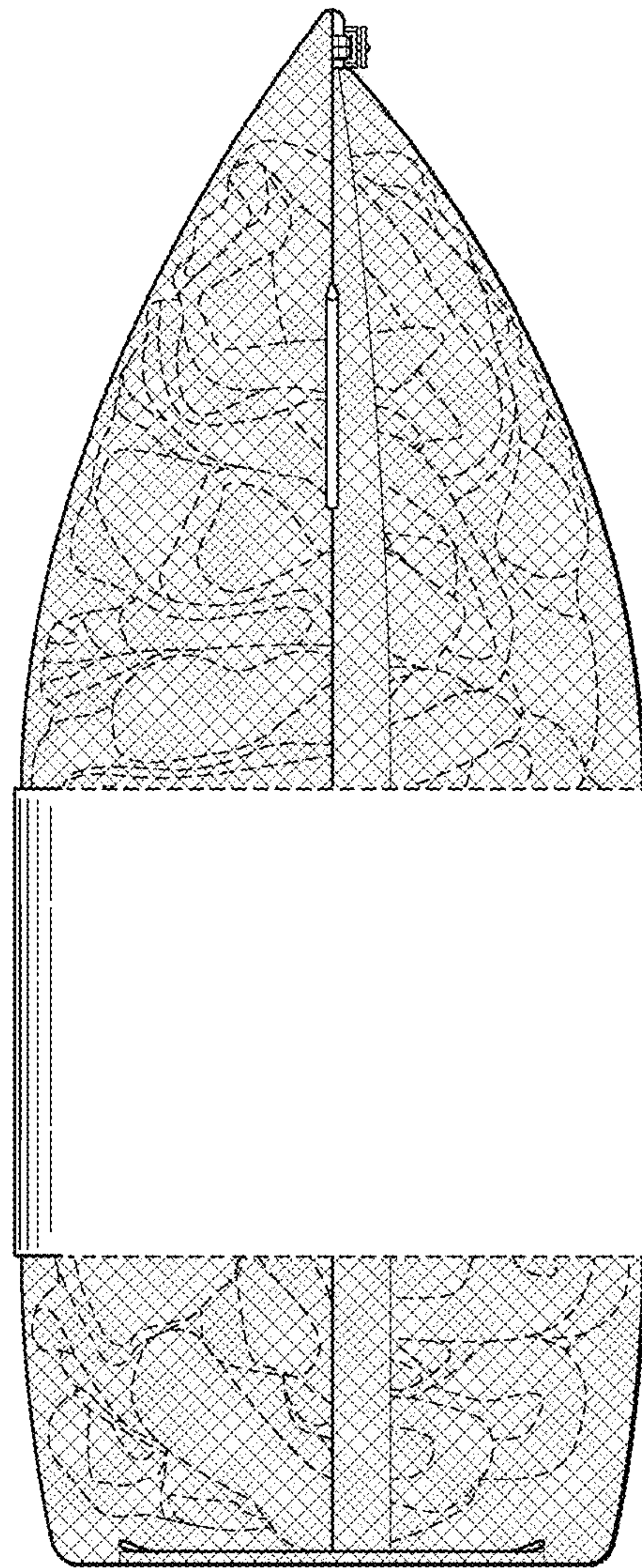

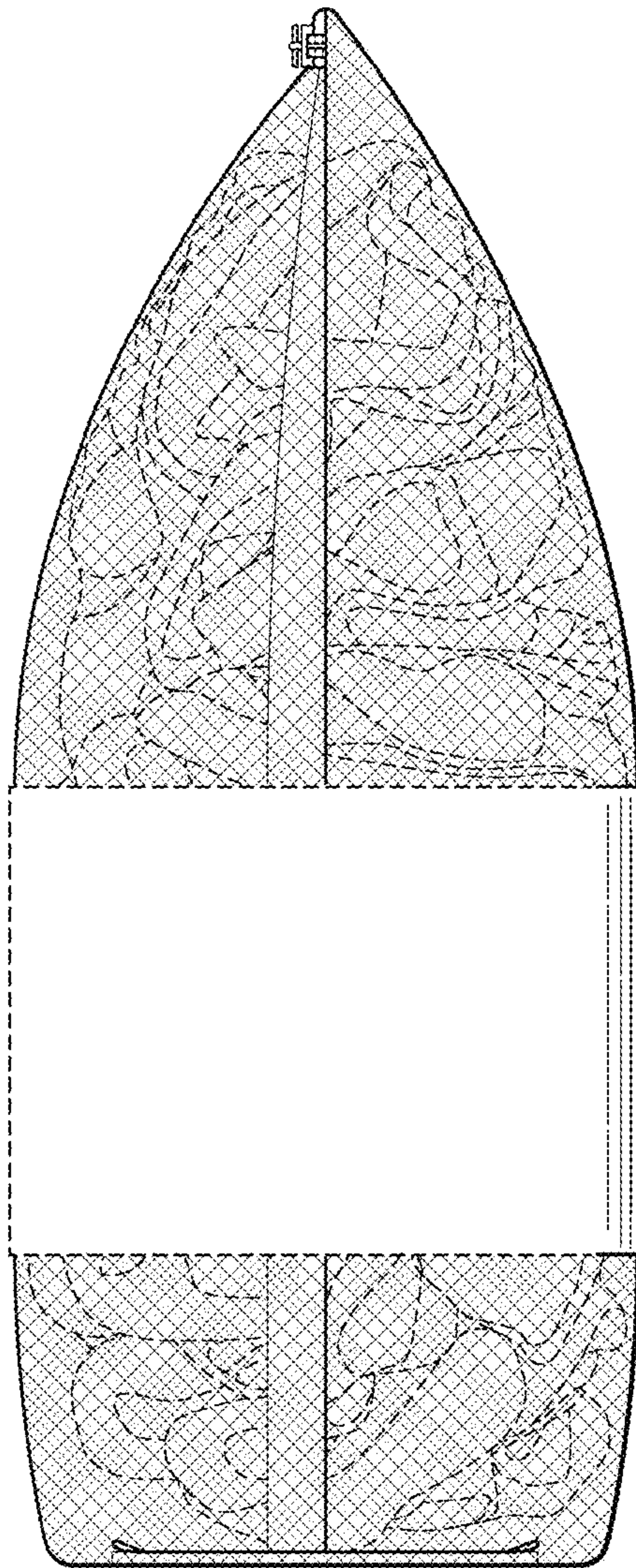

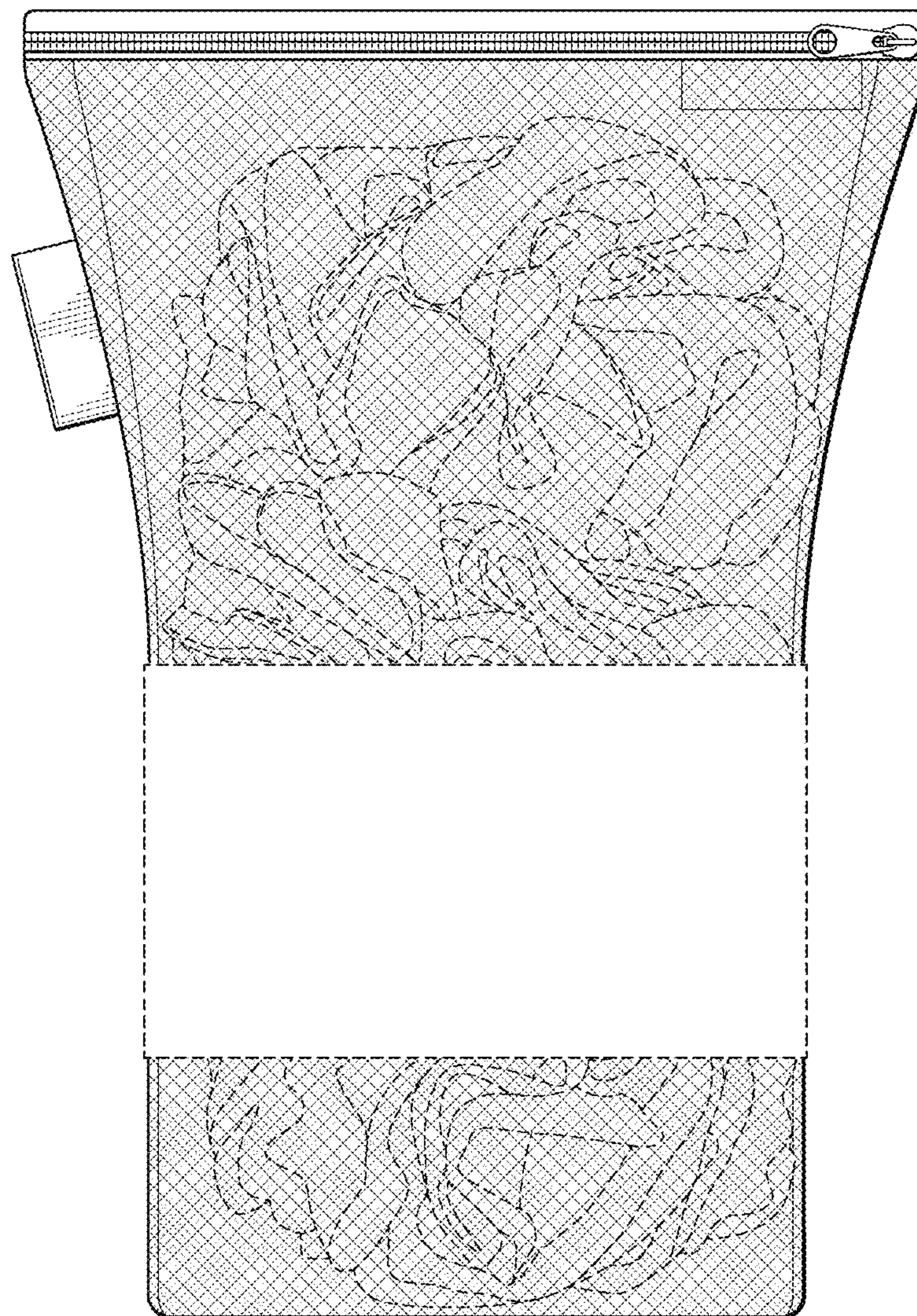

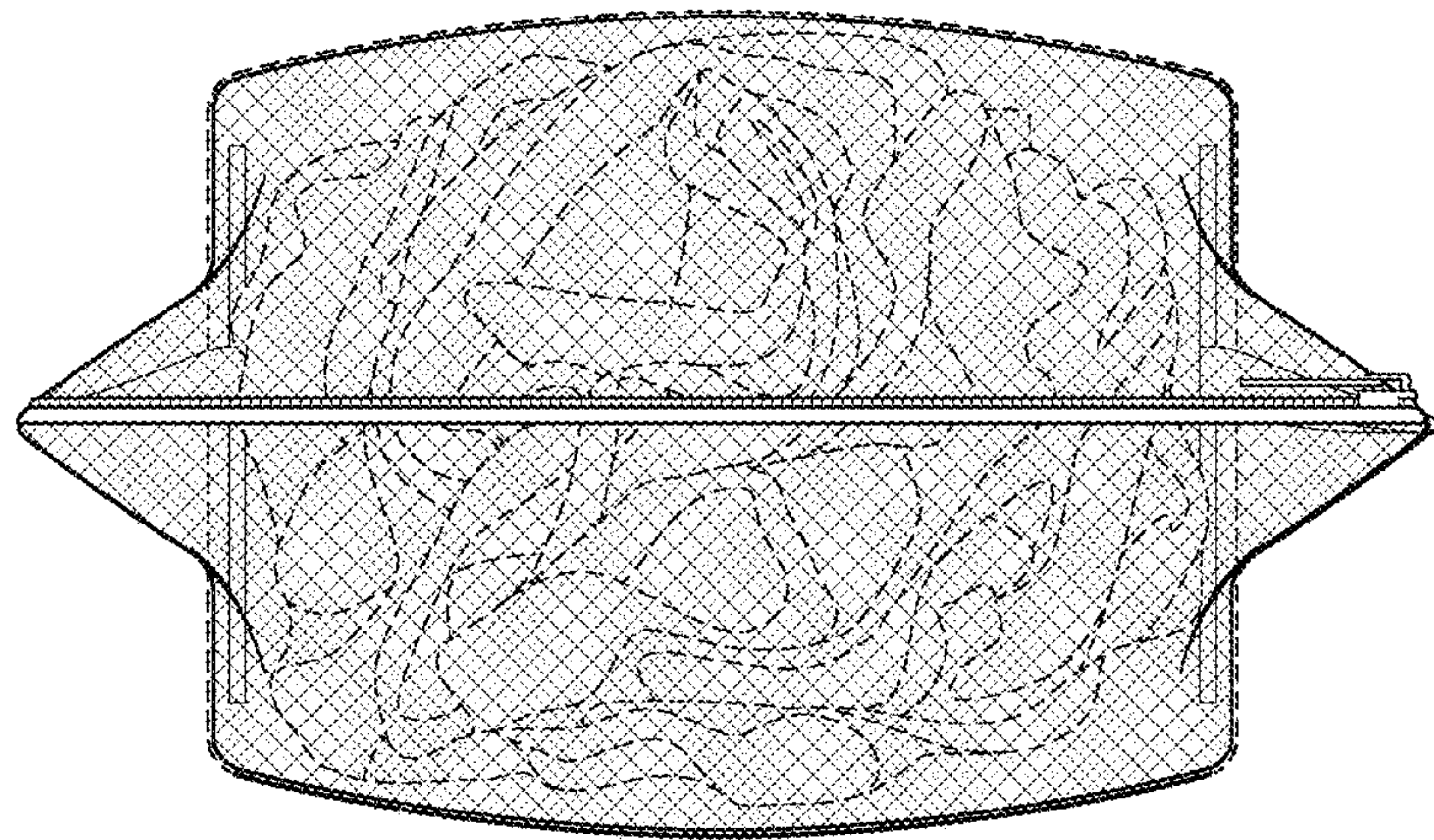

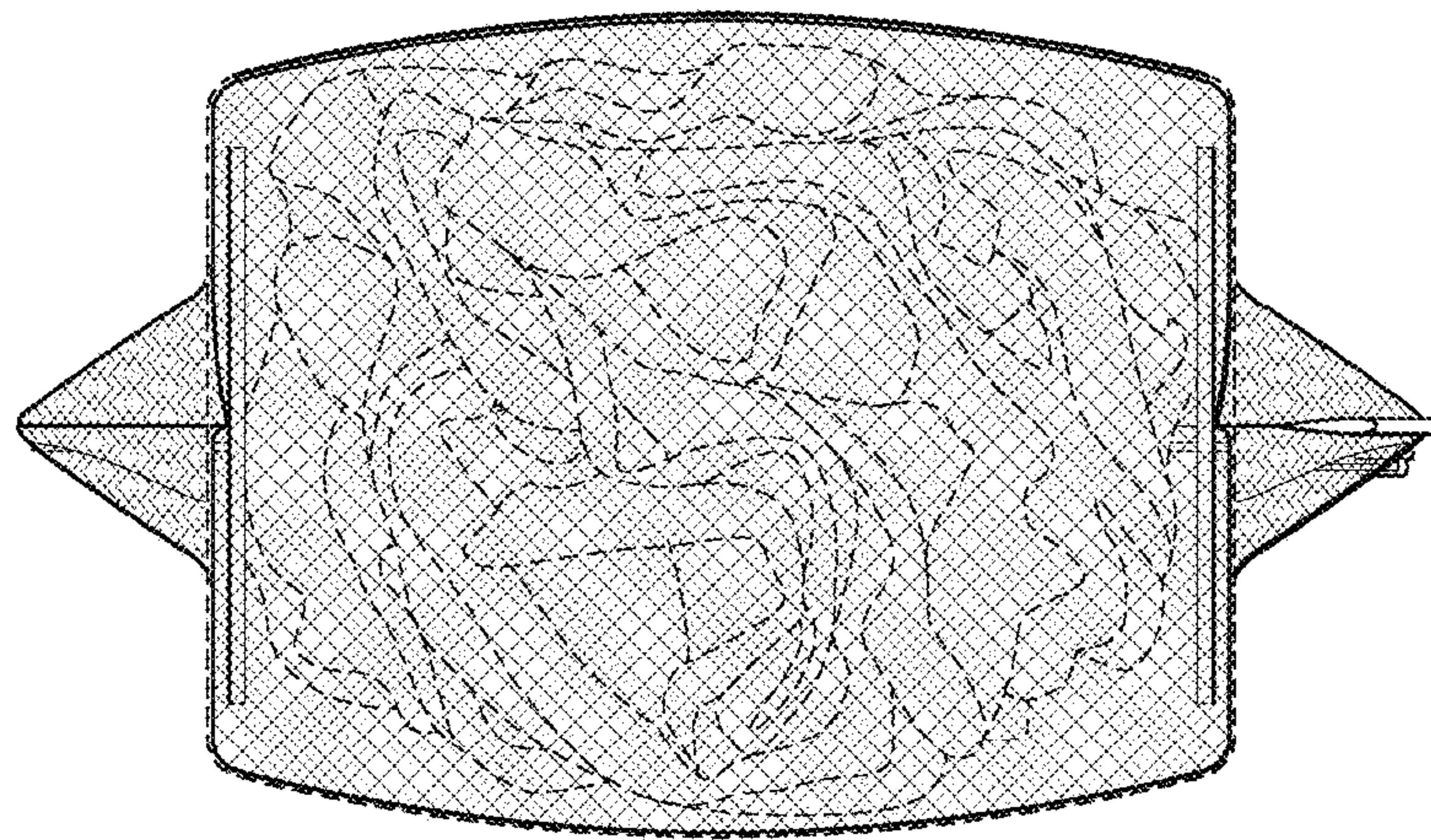

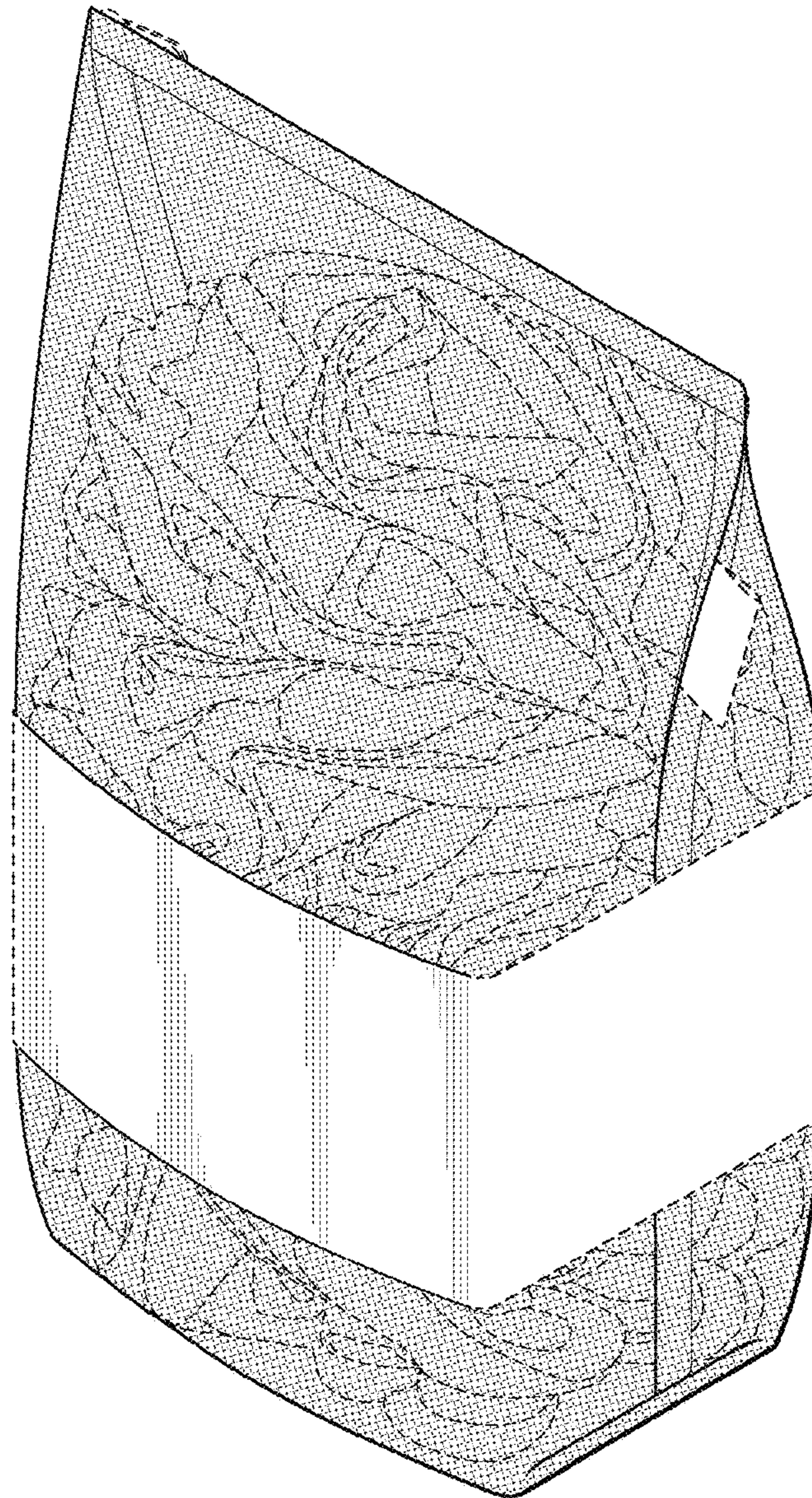

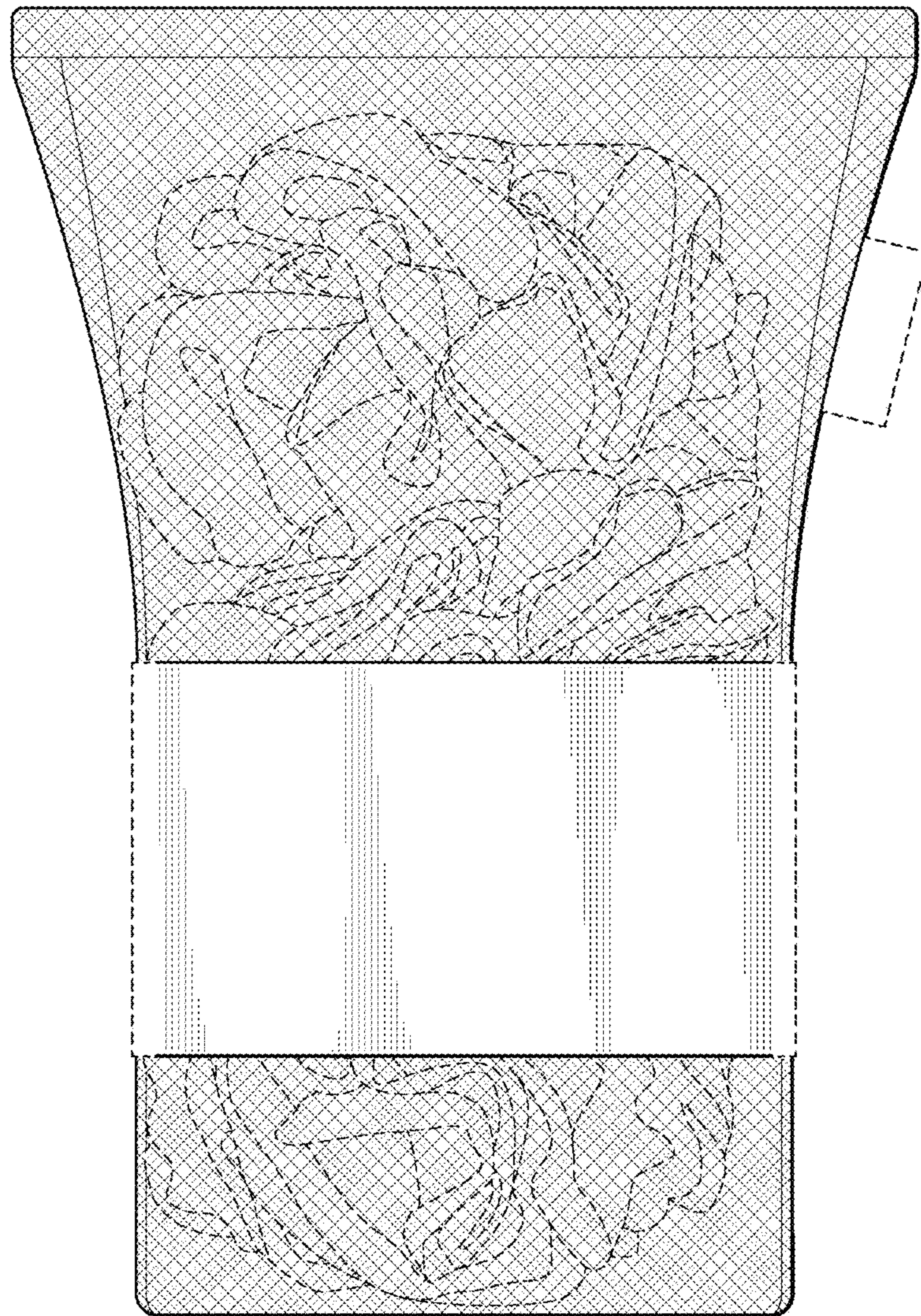

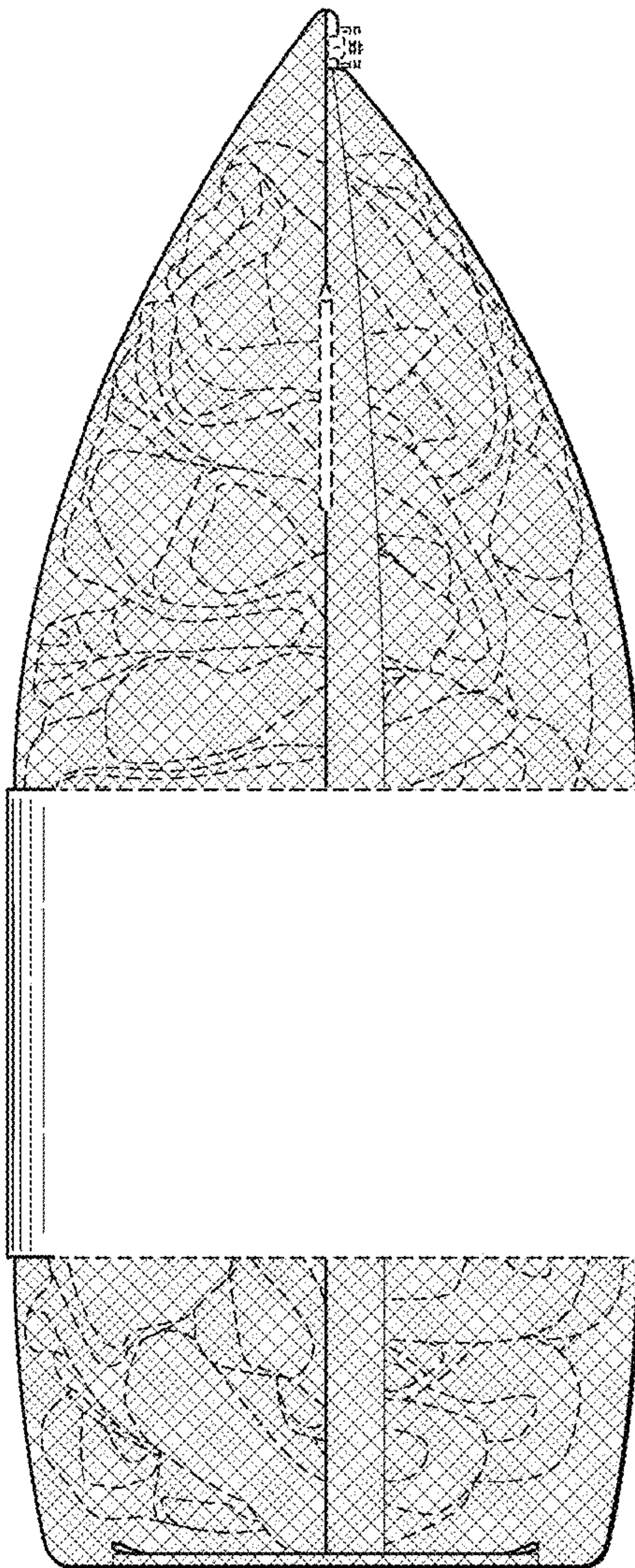

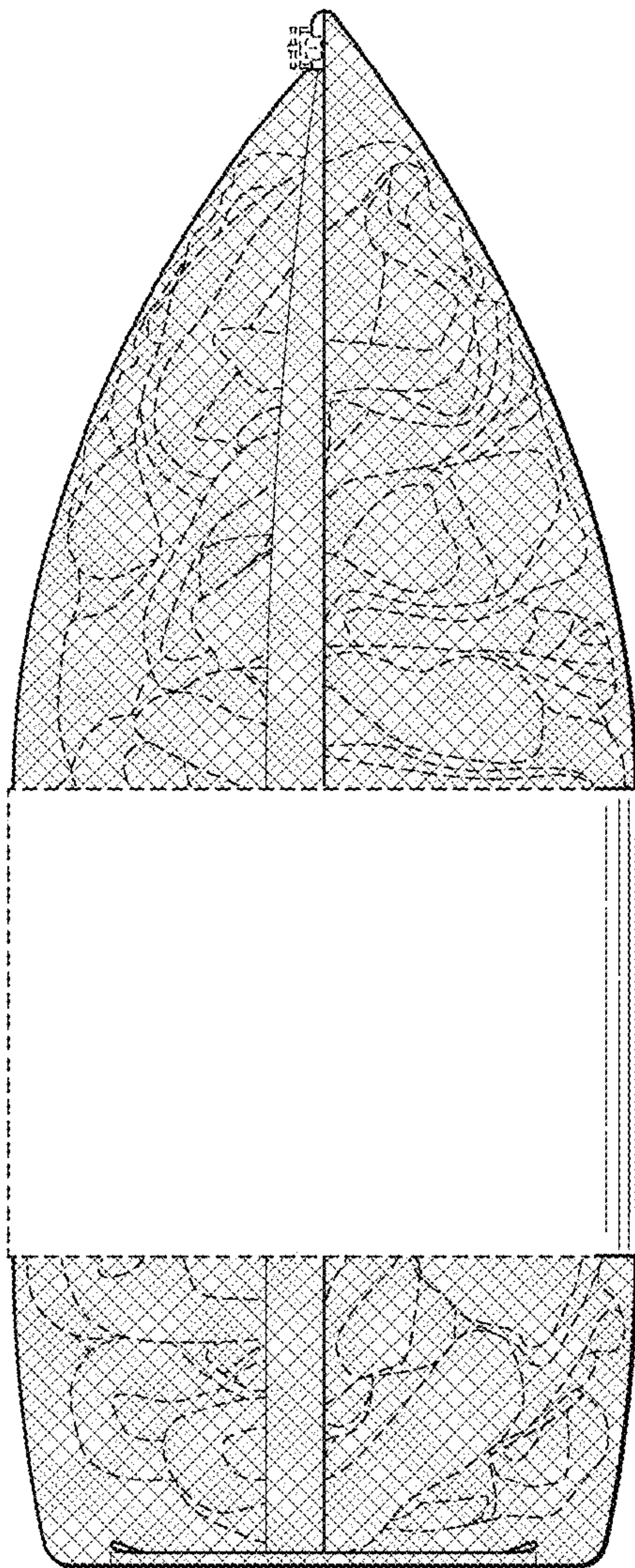

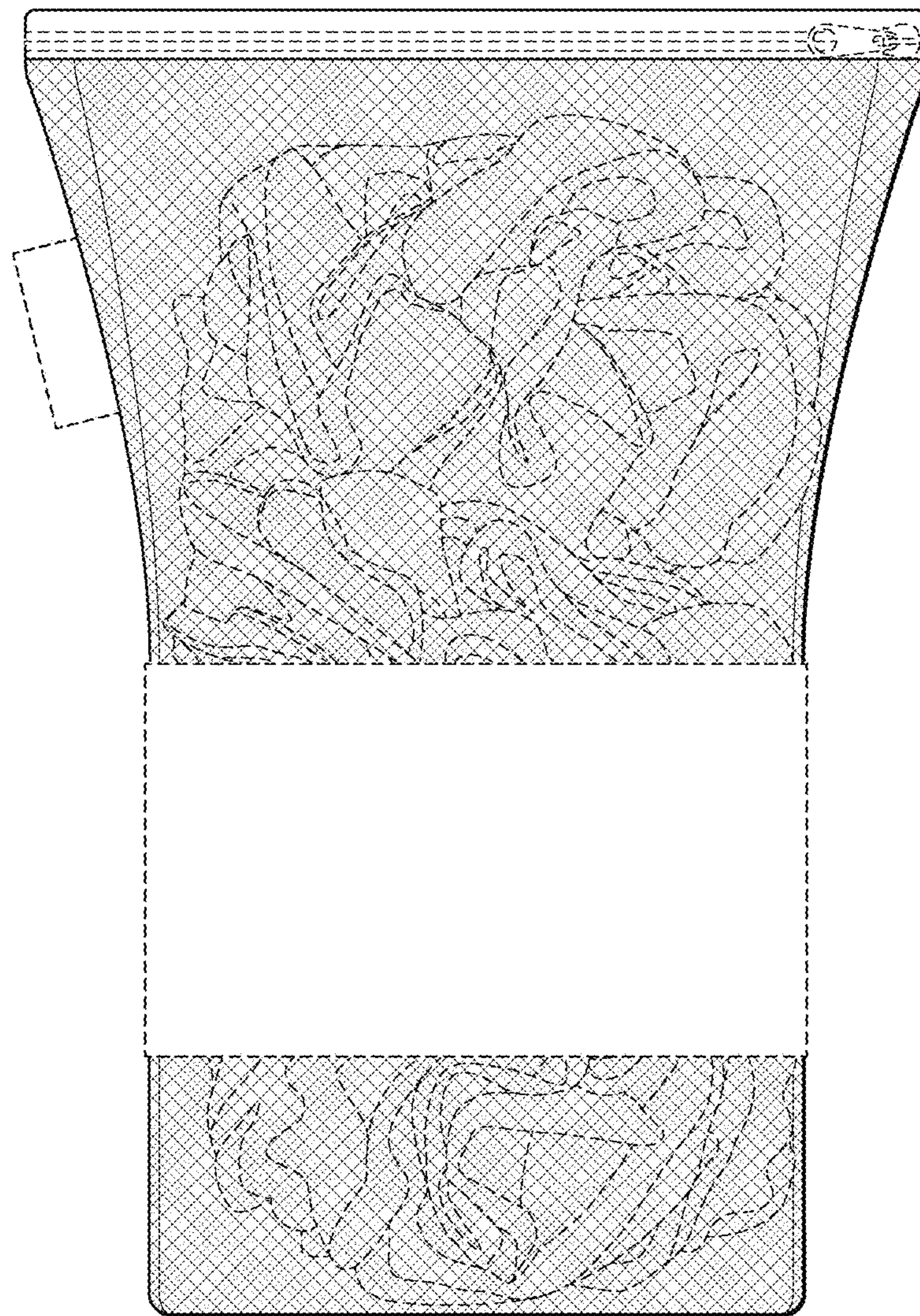

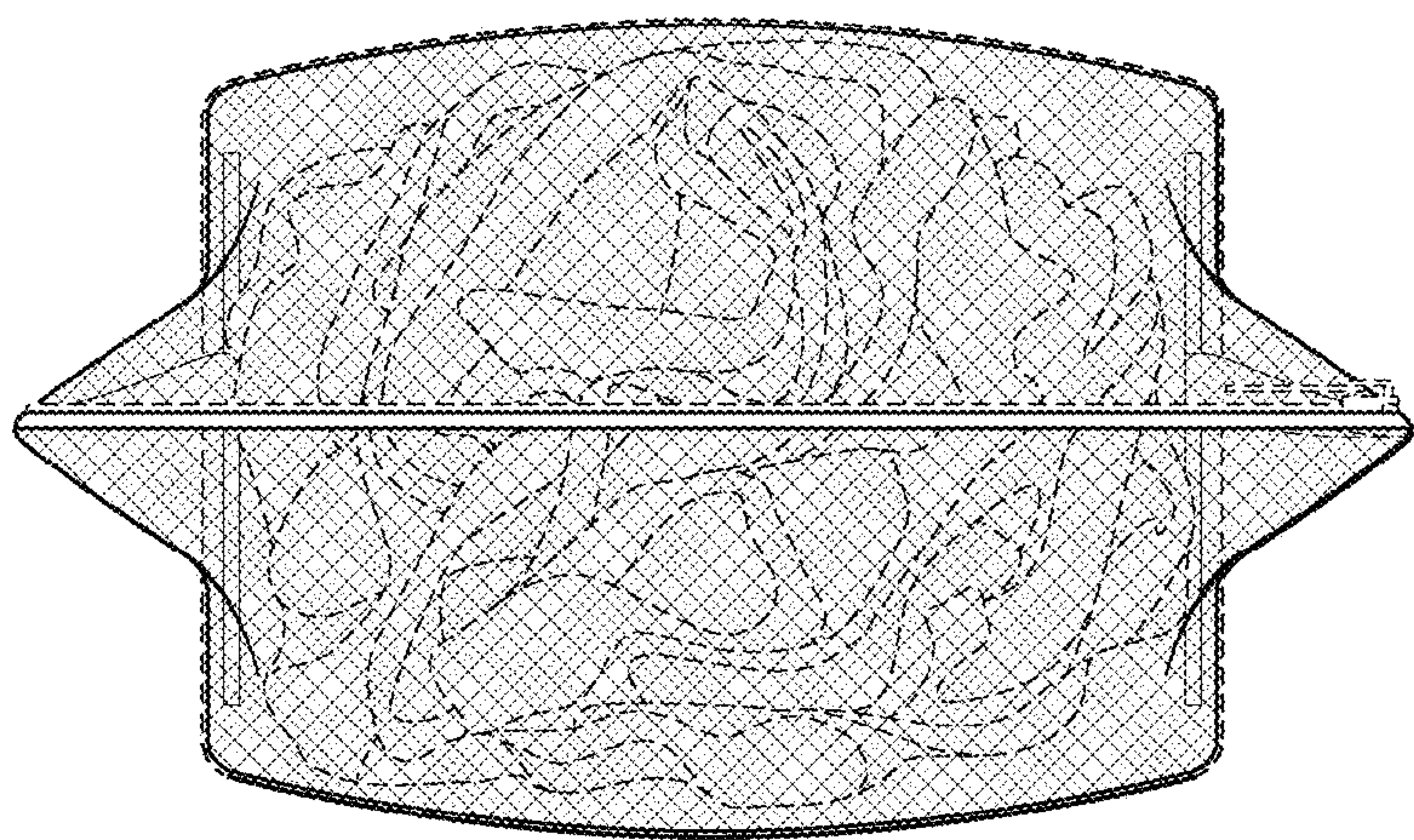

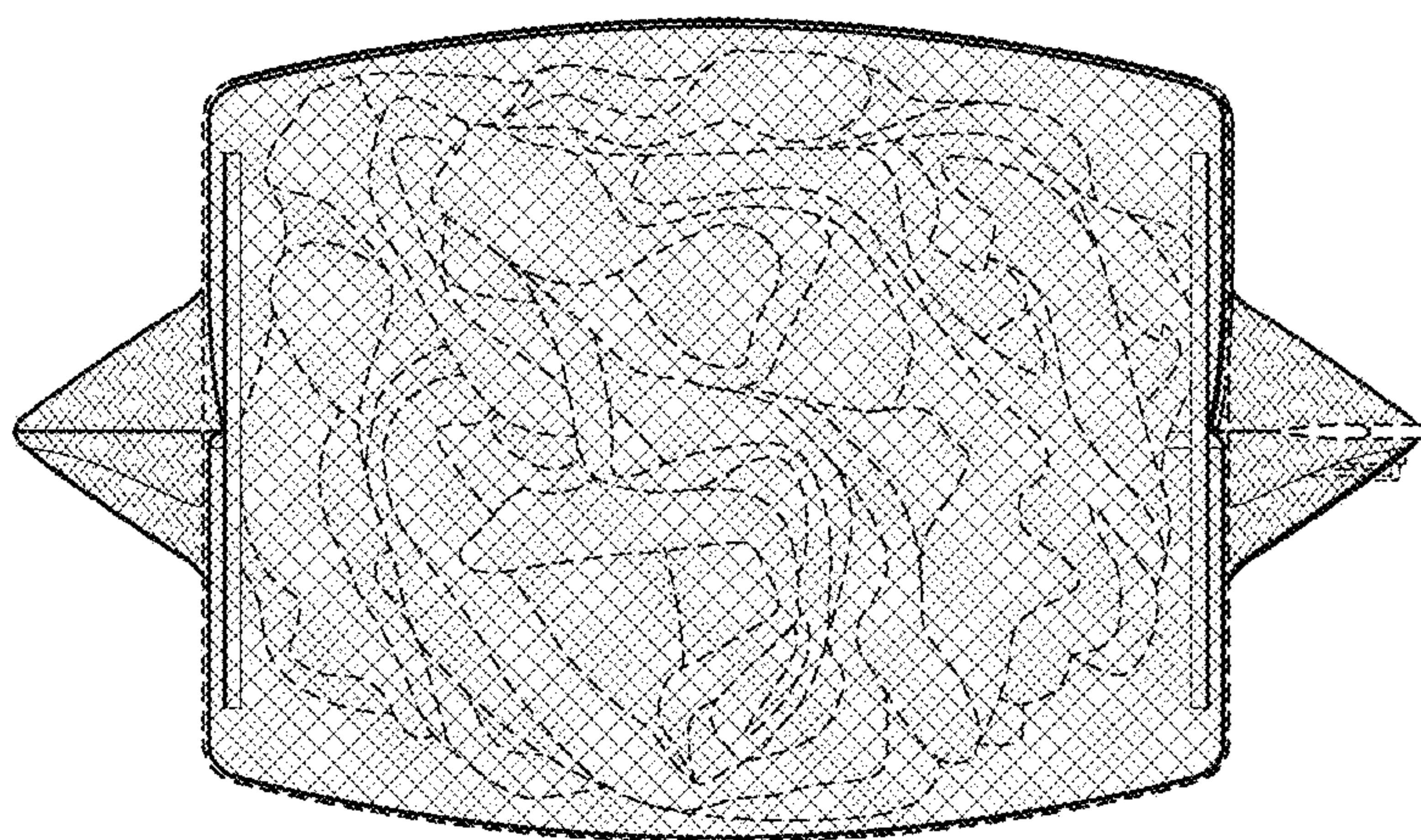
