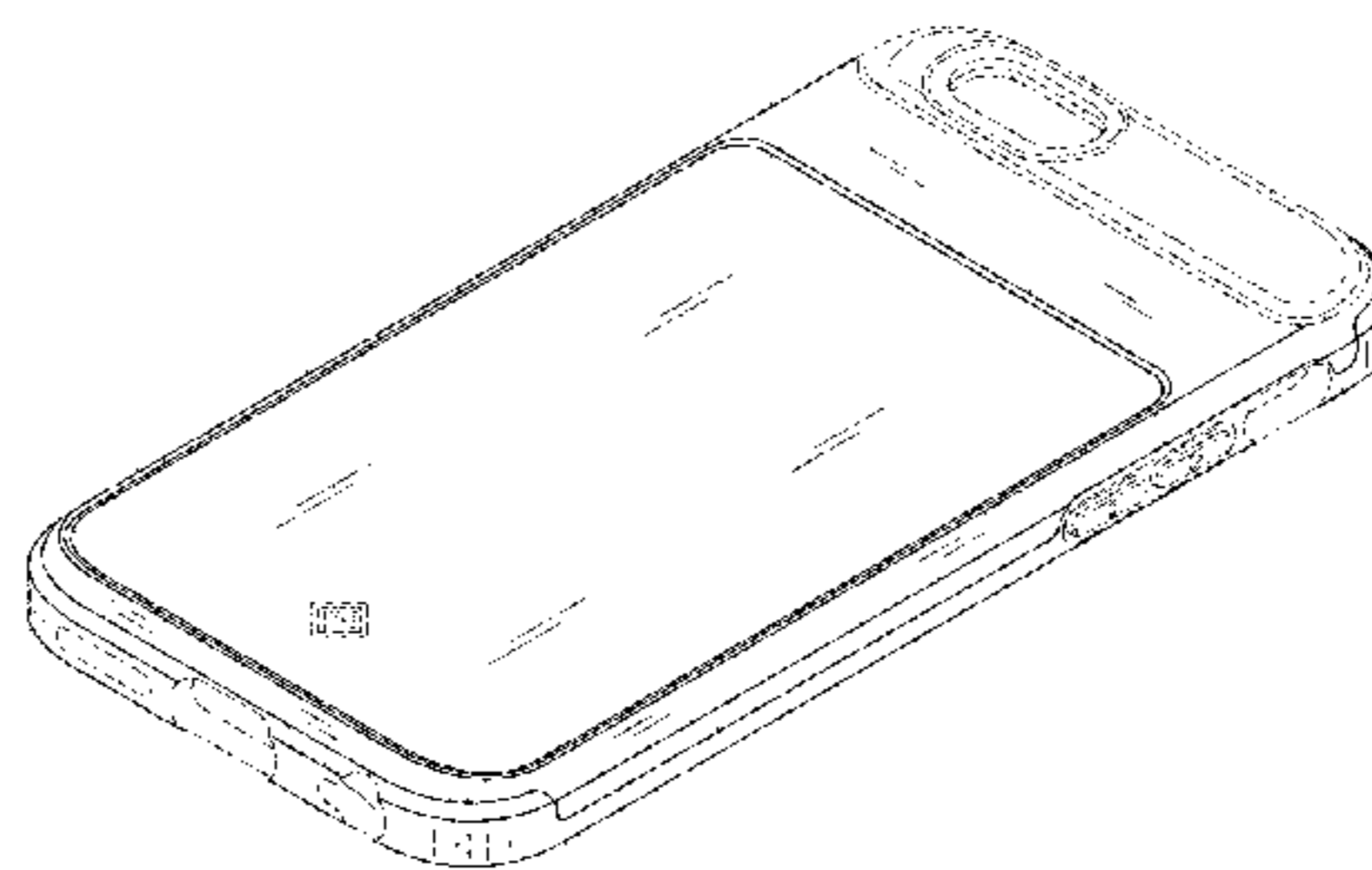
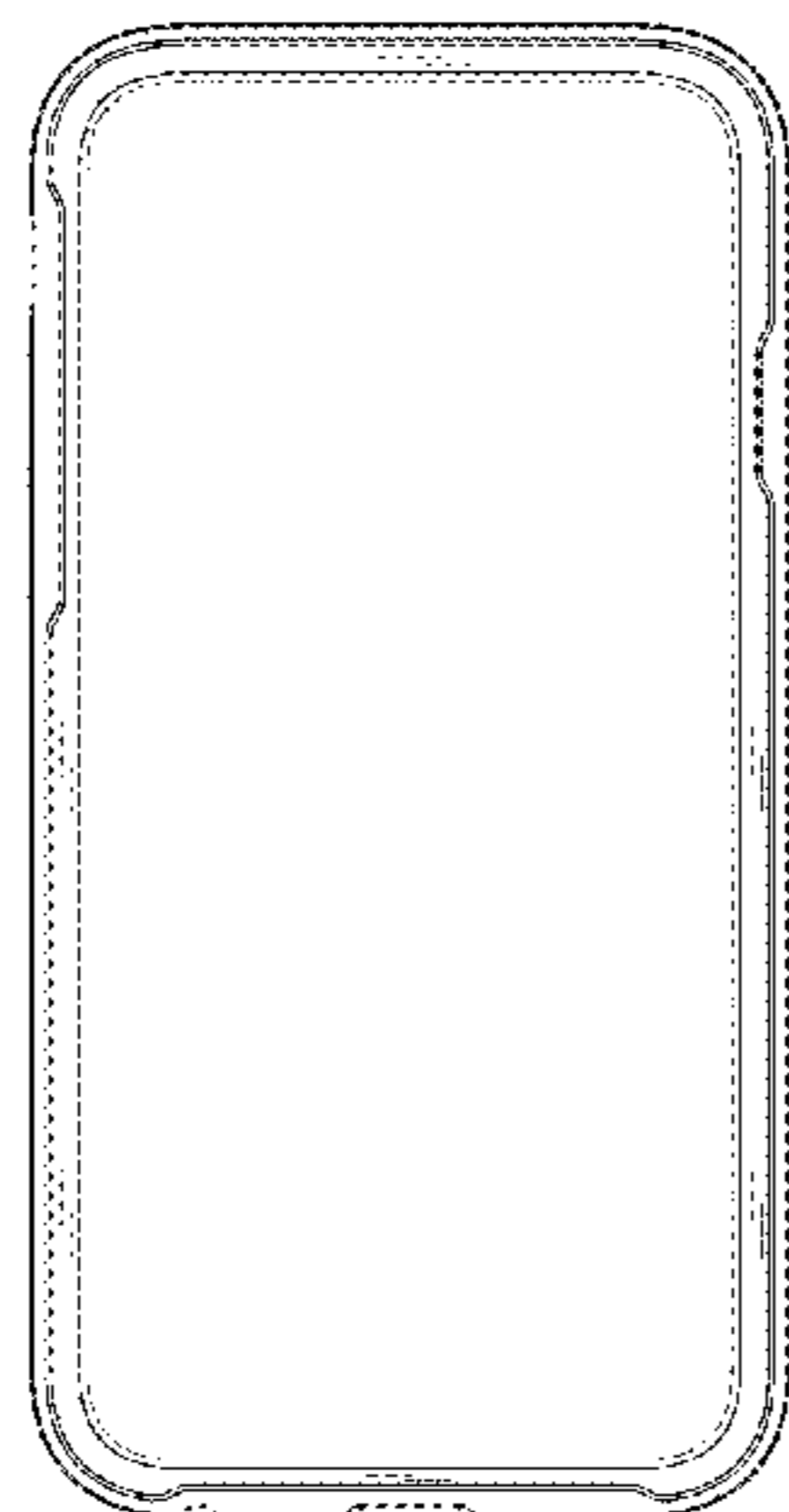
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an illustration of a front view of a phone case showing our new design;  
FIG. 2 is a back view thereof;

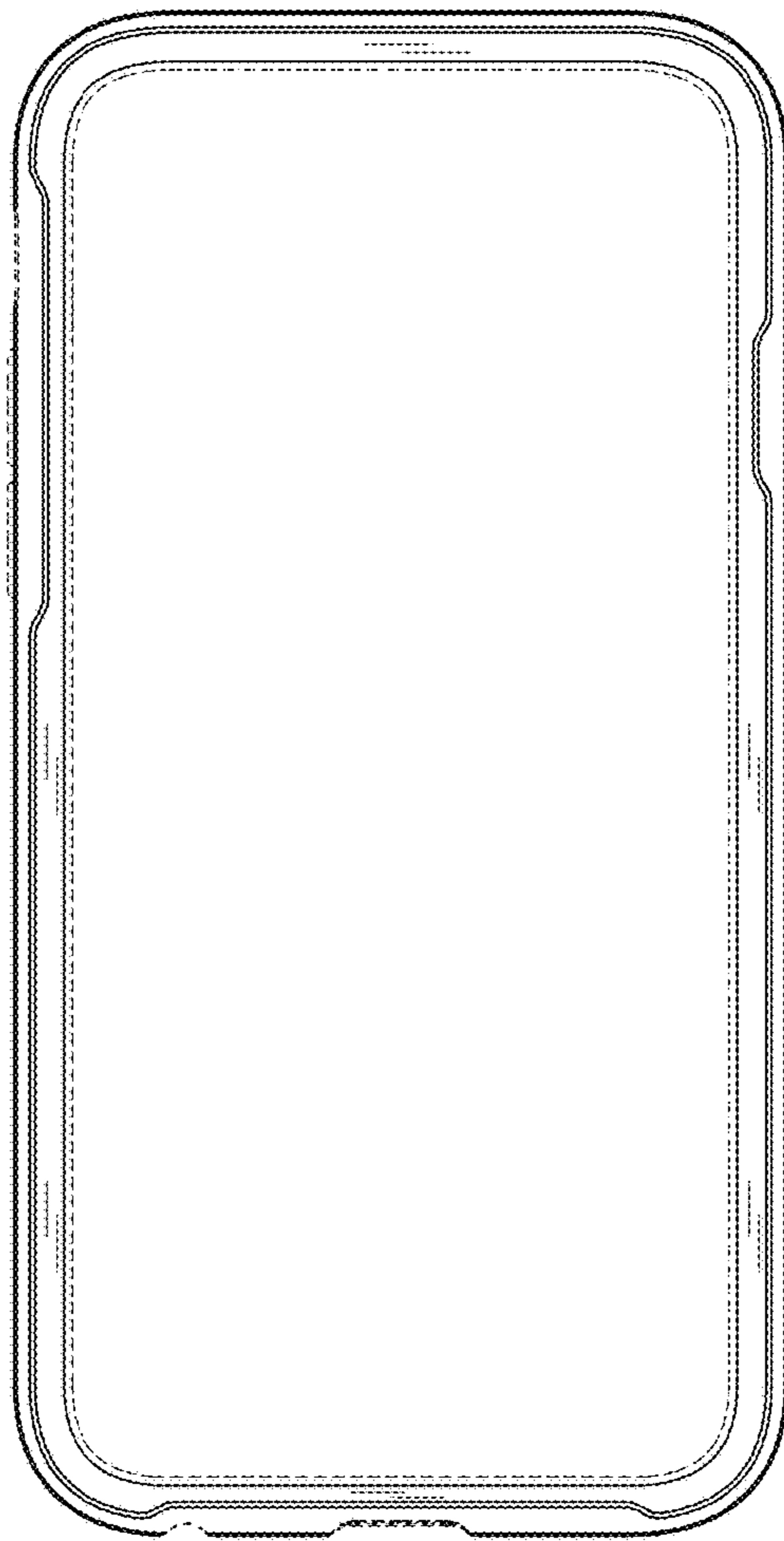

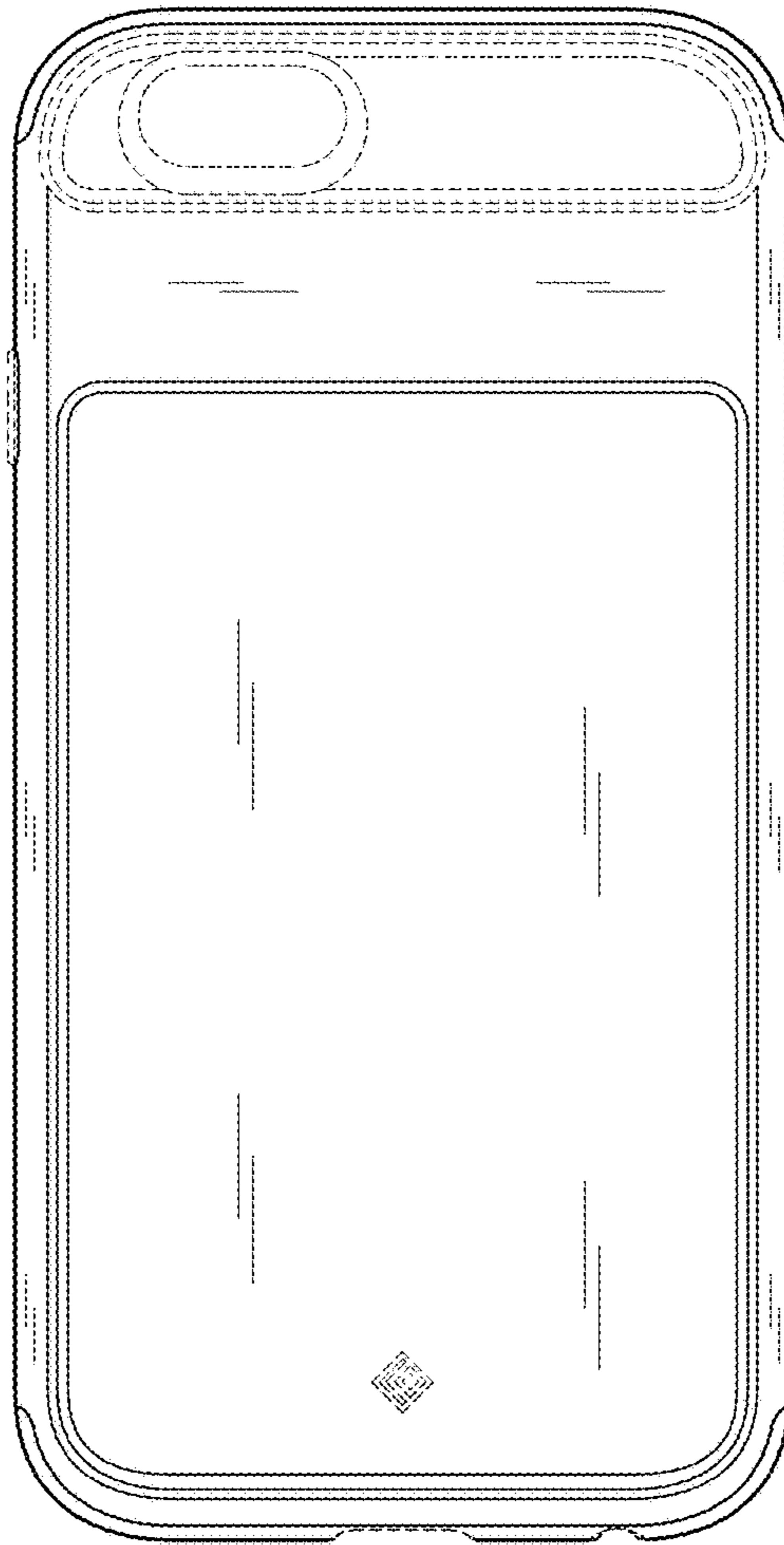

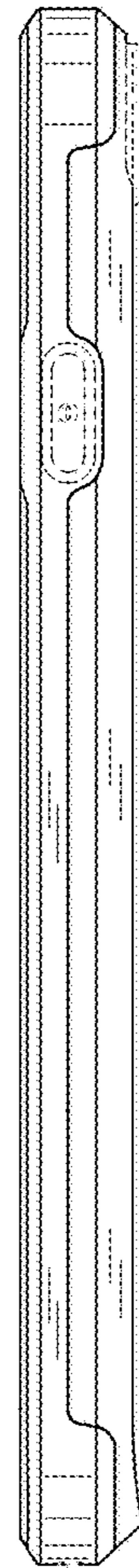
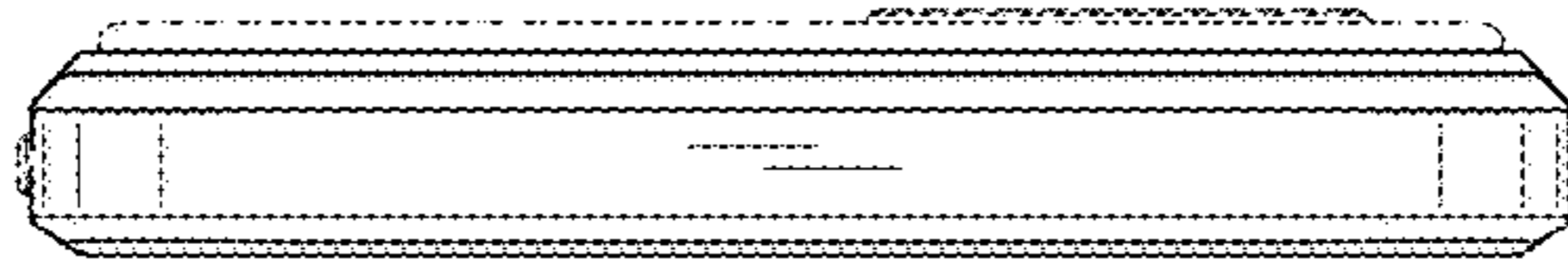
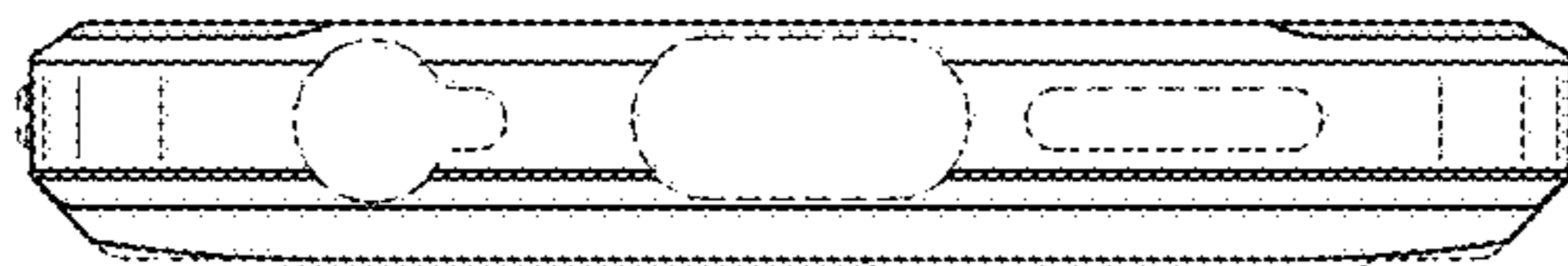

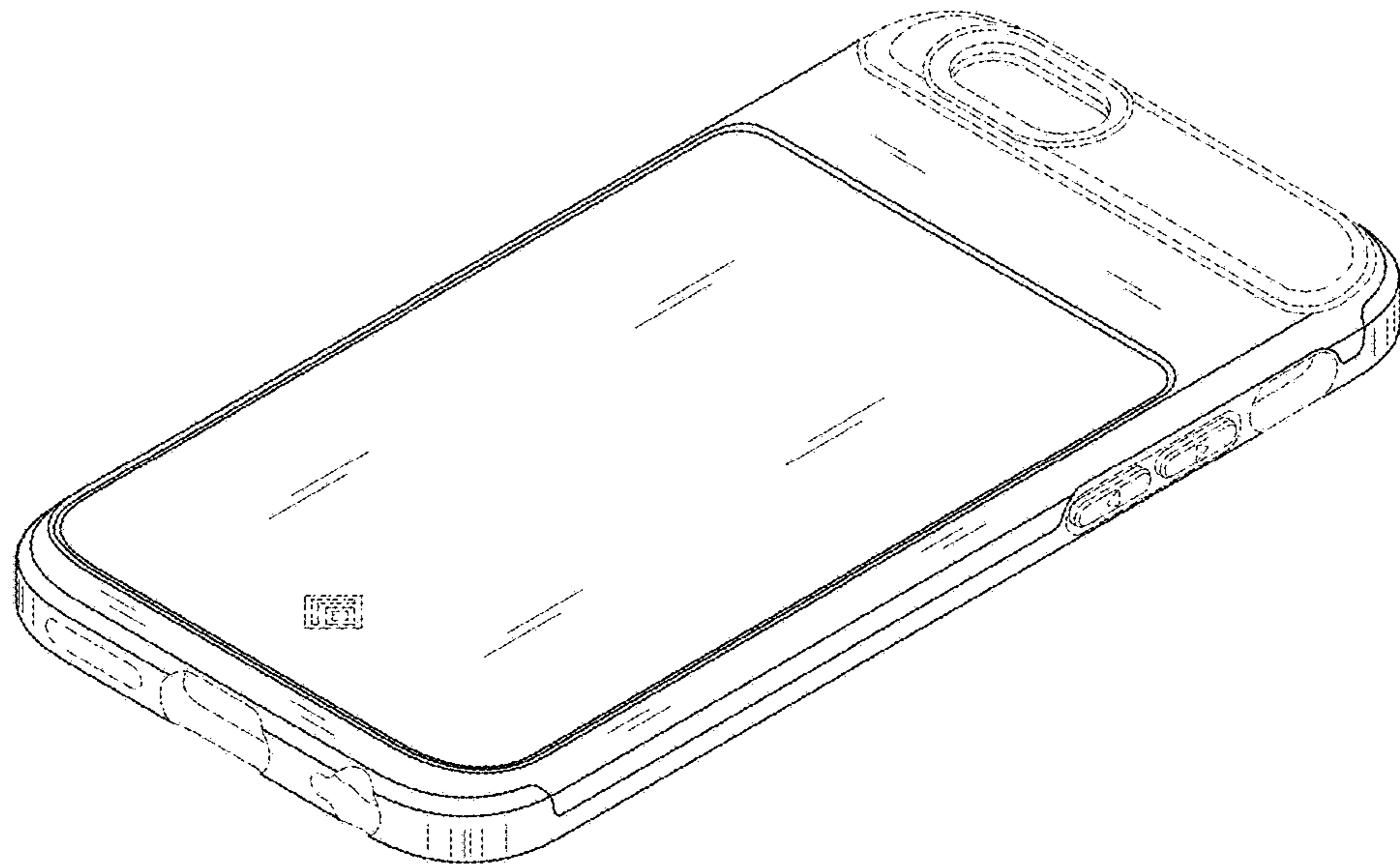
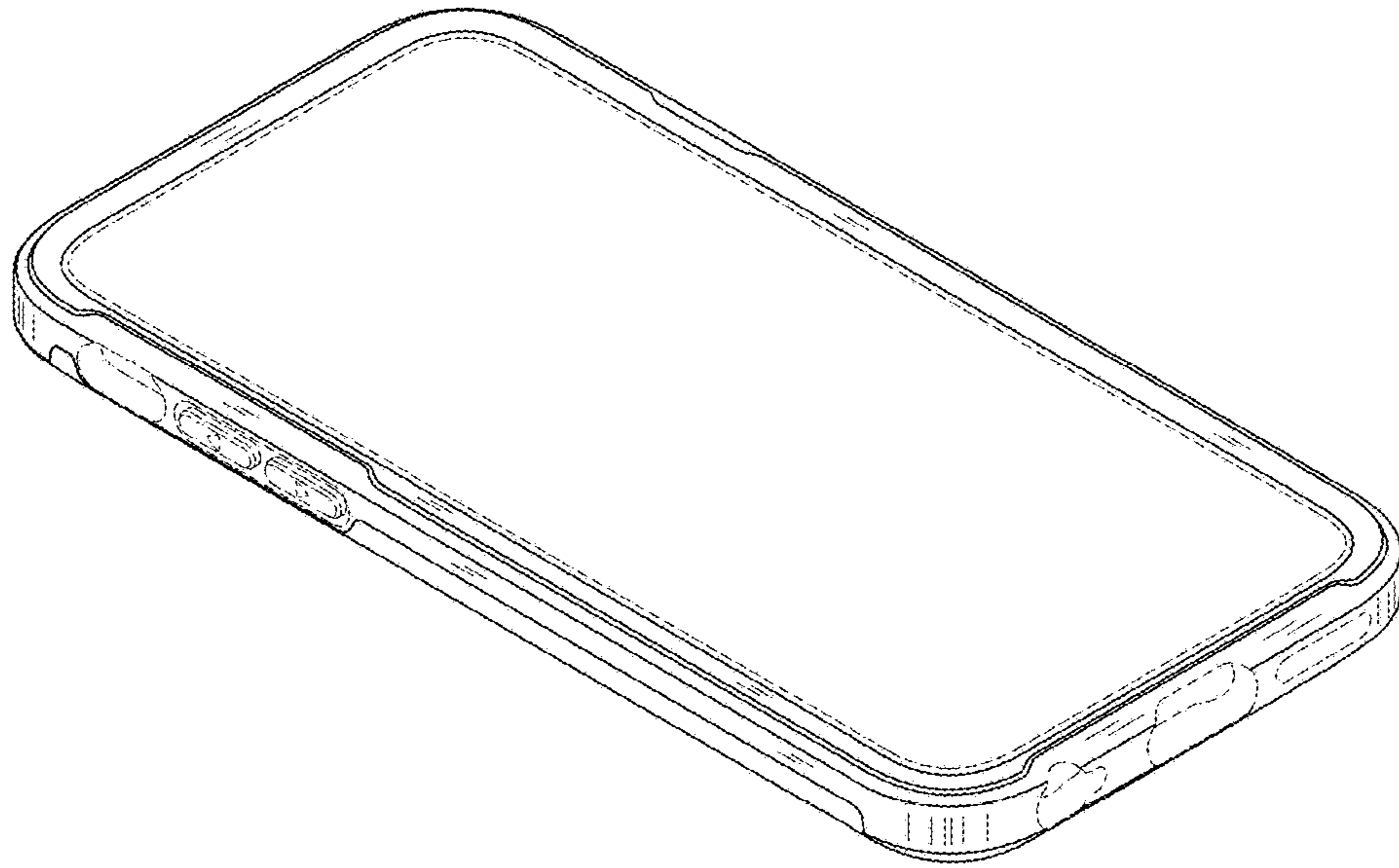
