FIG. 6 is a bottom view thereof.

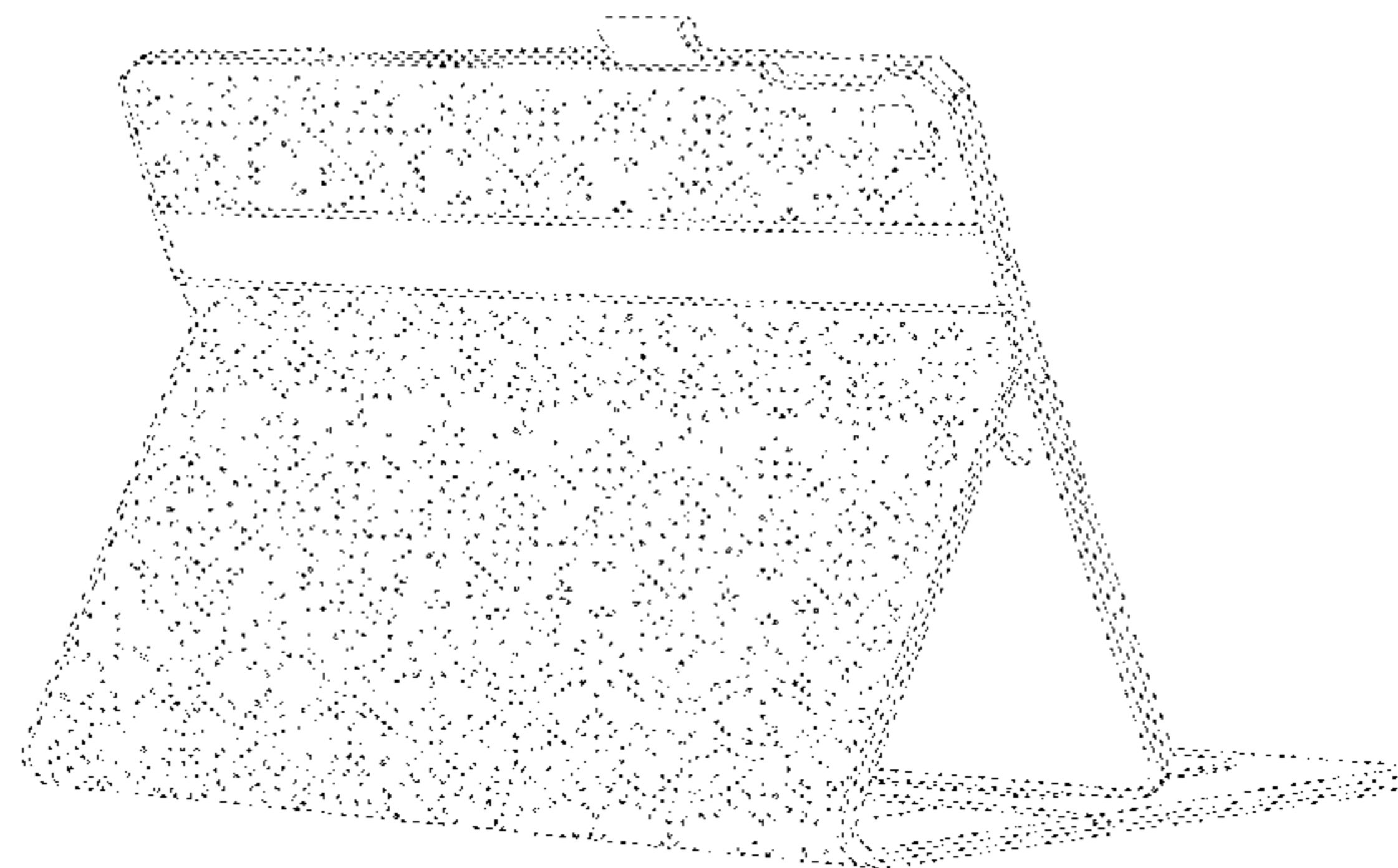
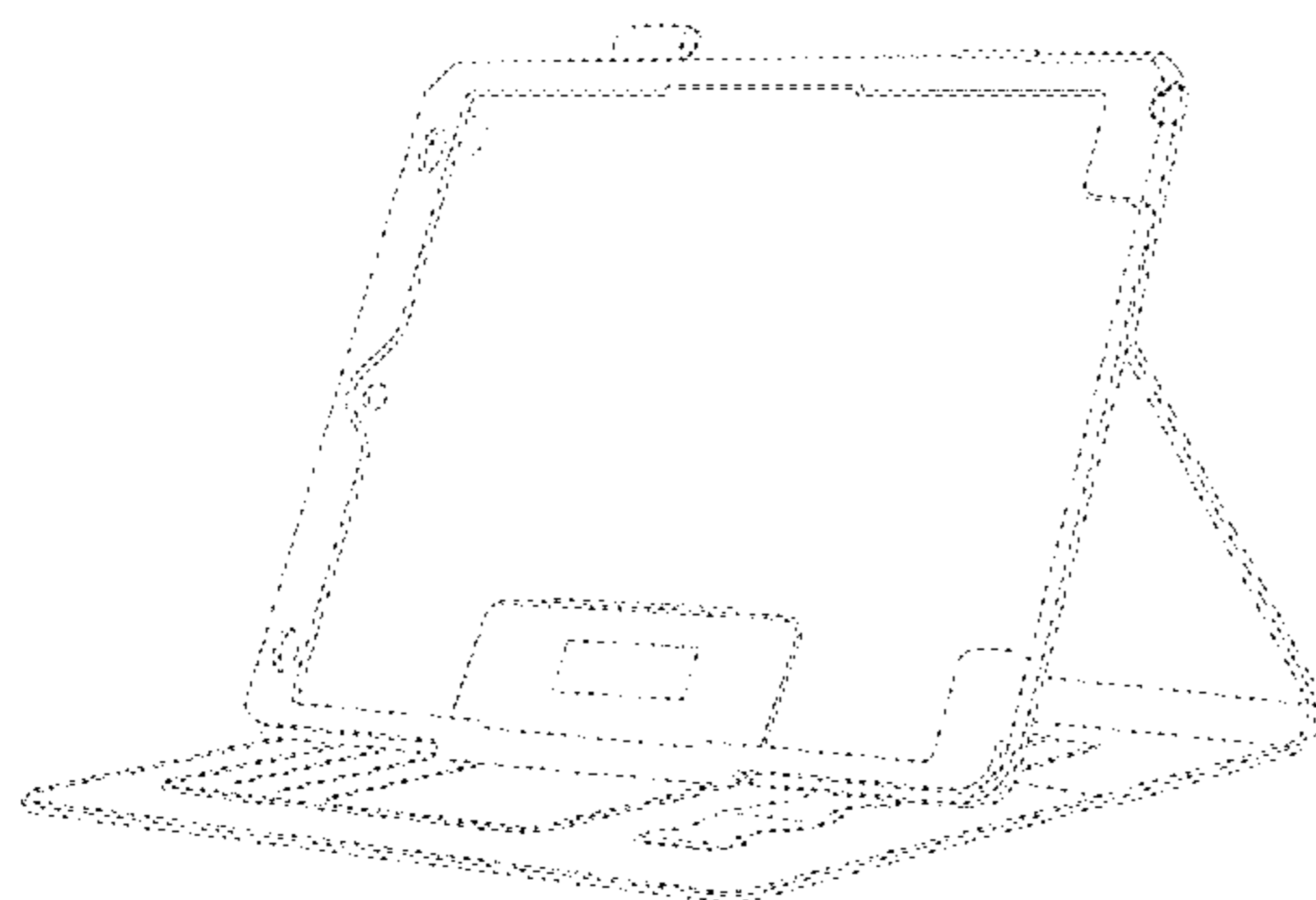
FIG. 7 is a flatten expanded view of the interior of the protective case for electronic product of the present invention.

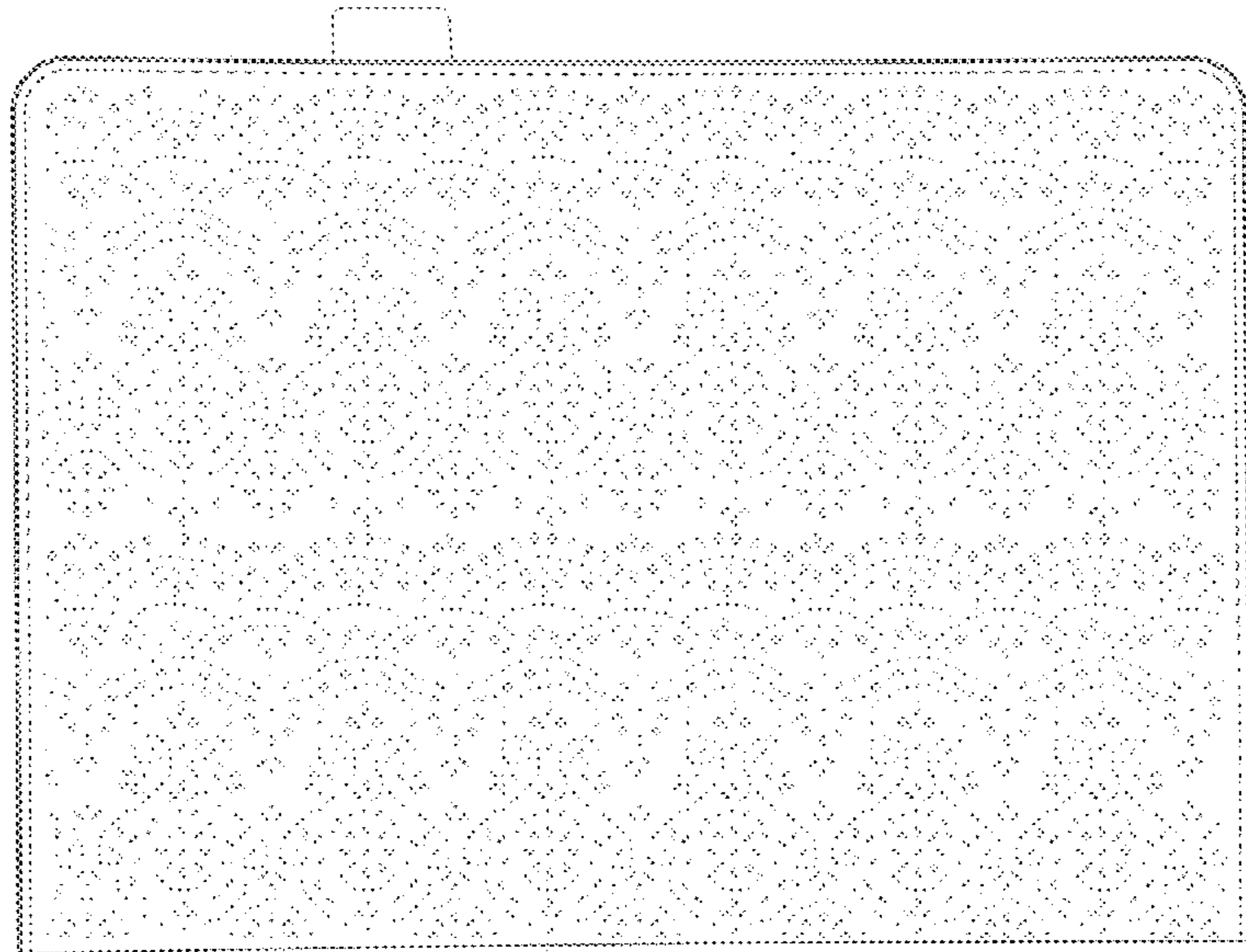

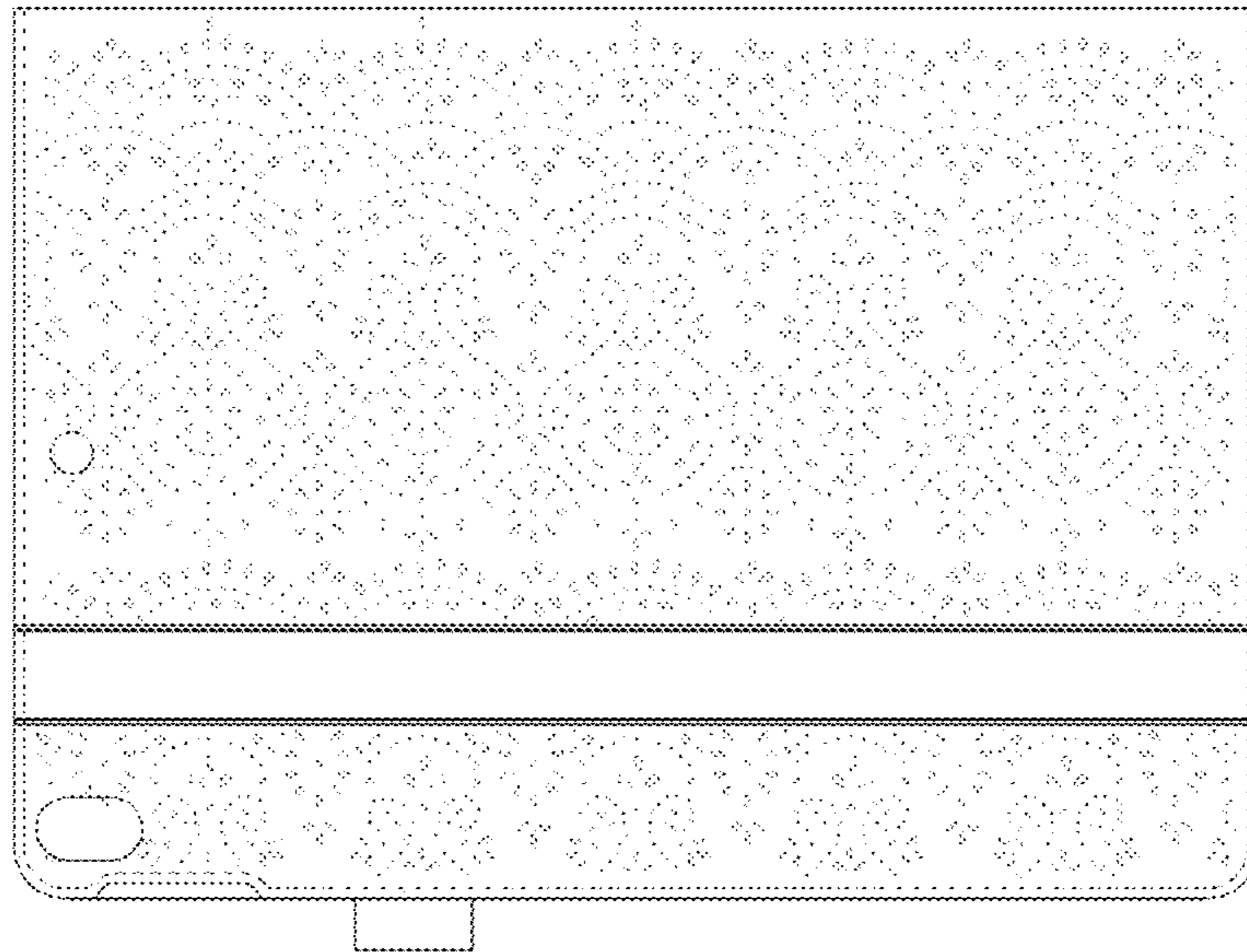

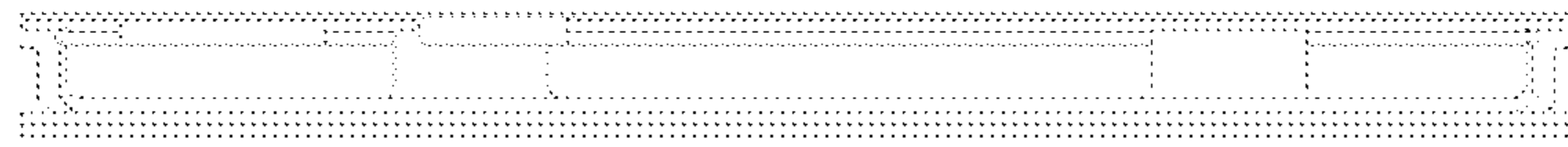

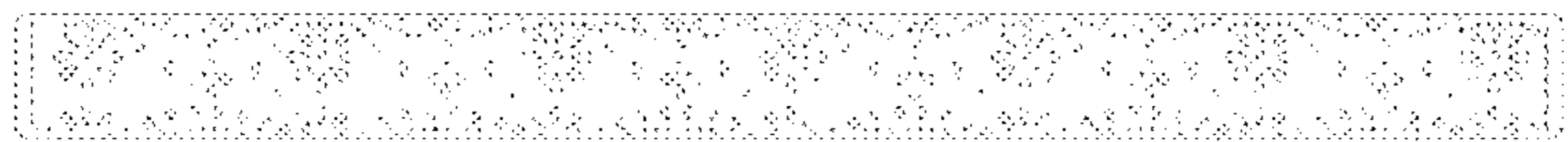

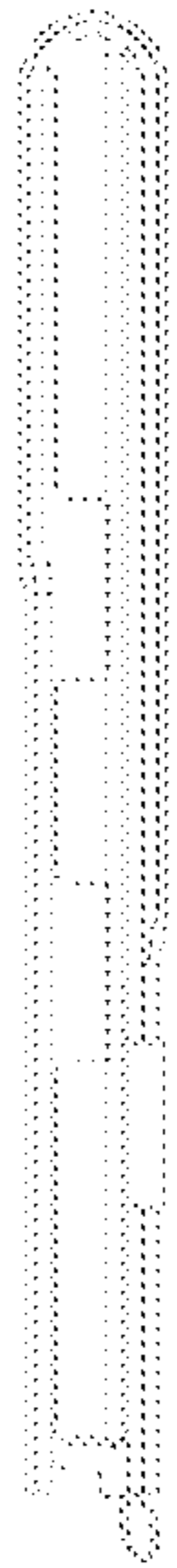

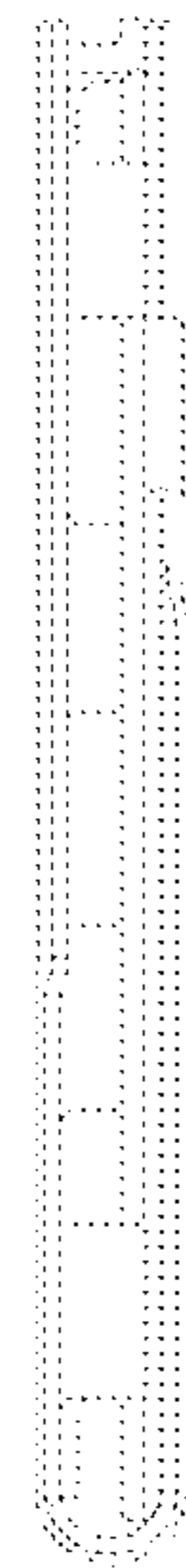

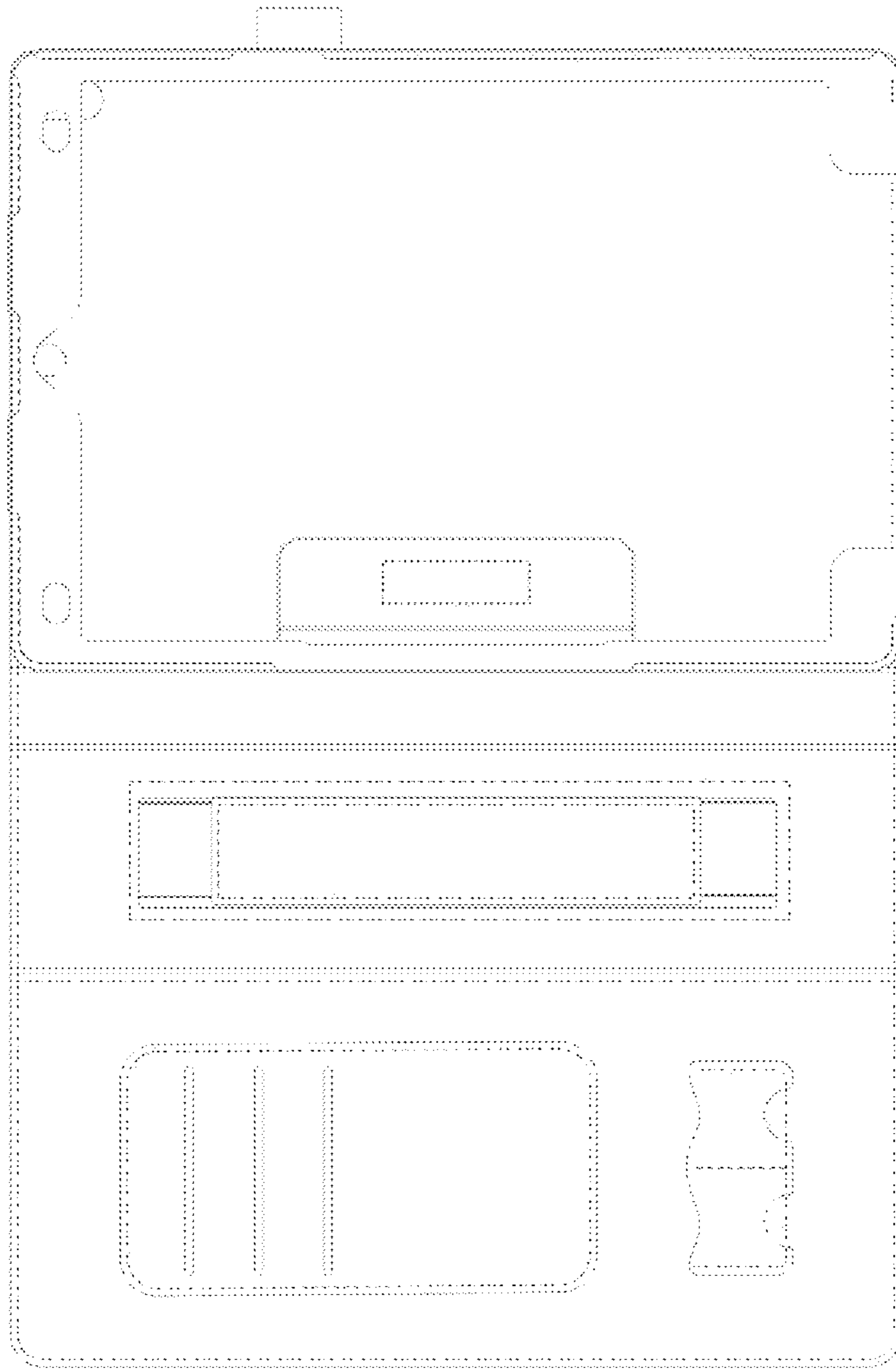

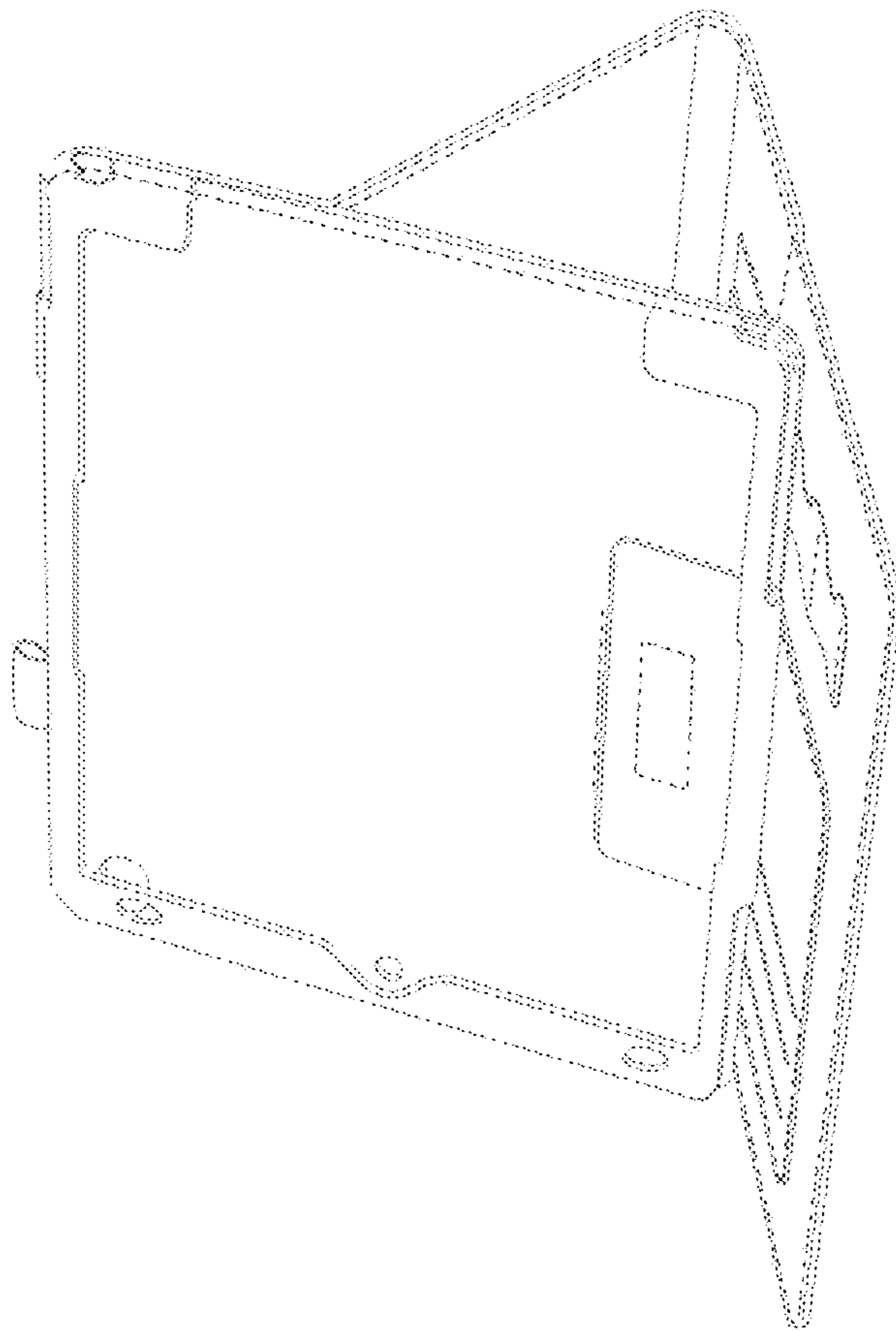

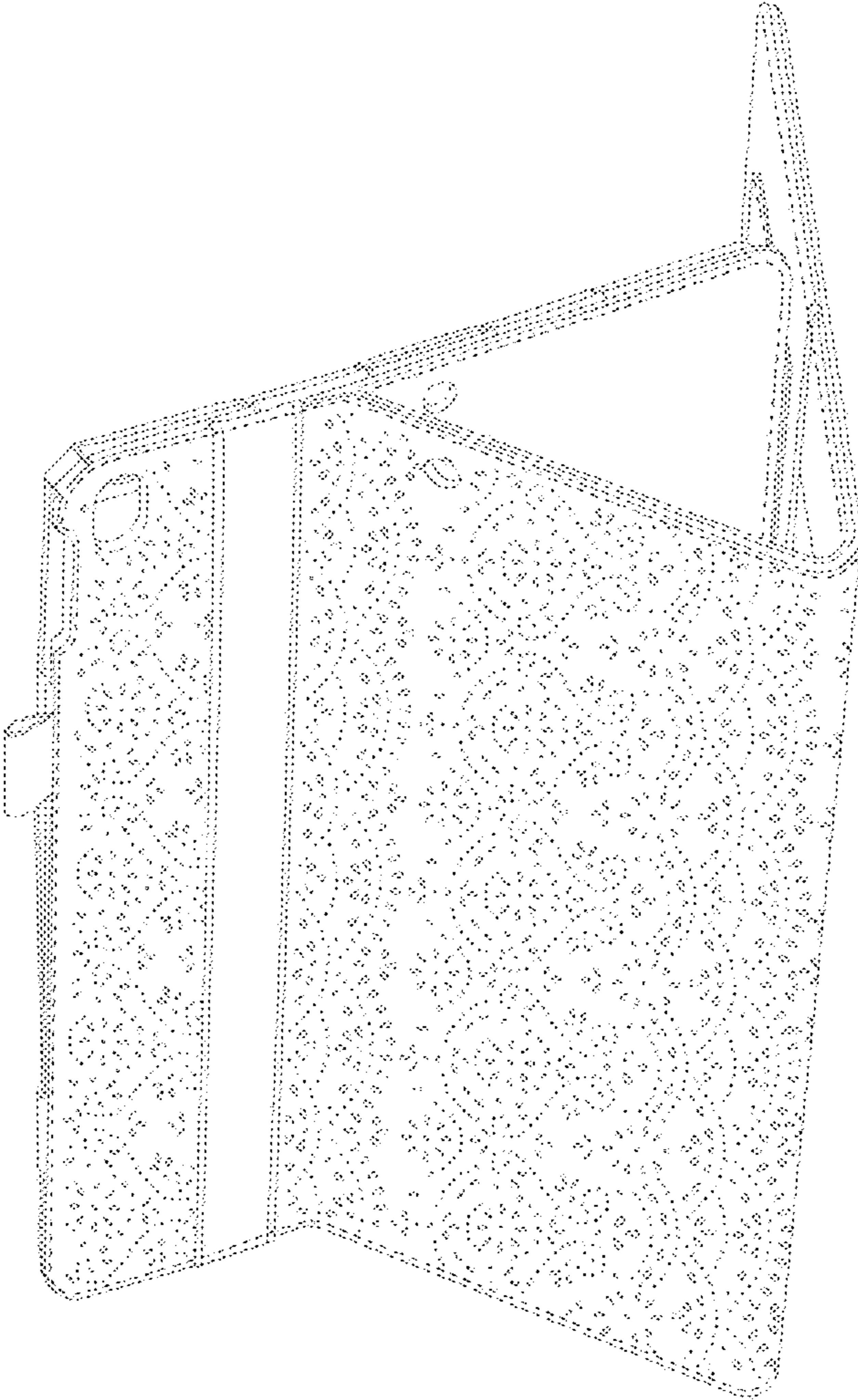
