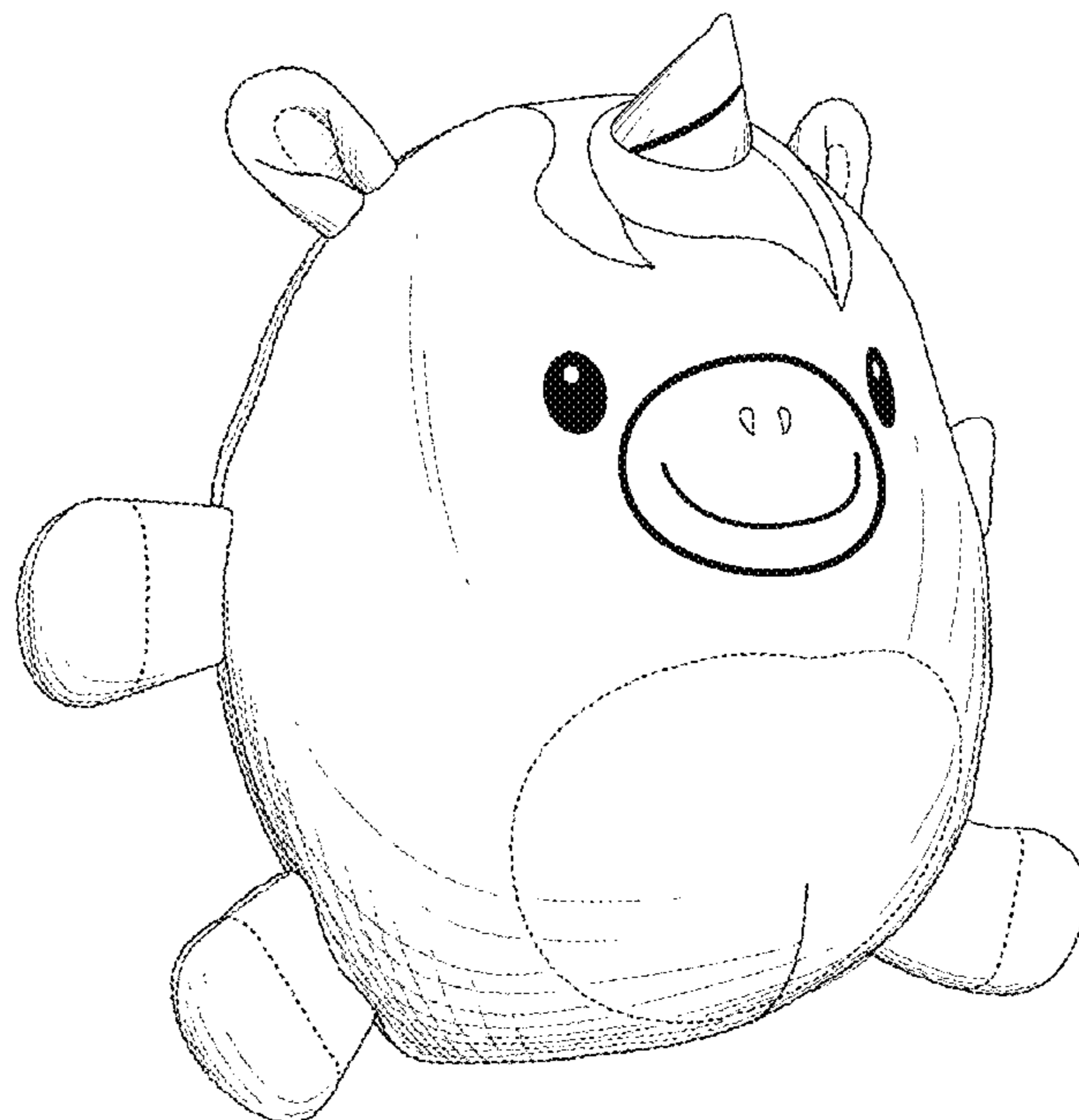
(57) **CLAIM**

I claim the ornamental design for a plush unicorn, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a plush unicorn; FIG. 2 is a front view of the plush unicorn of FIG. 1; FIG. 3 is a rear view of the plush unicorn of FIG. 1; FIG. 4 is a right side view of the plush unicorn of FIG. 1; FIG. 5 is a left side view of the plush unicorn of FIG. 1; FIG. 6 is a top view of the plush unicorn of FIG. 1; and, FIG. 7 is a bottom view of the plush unicorn of FIG. 1. The broken lines in the drawings illustrate portions of the plush unicorn that form no part of the claimed design.

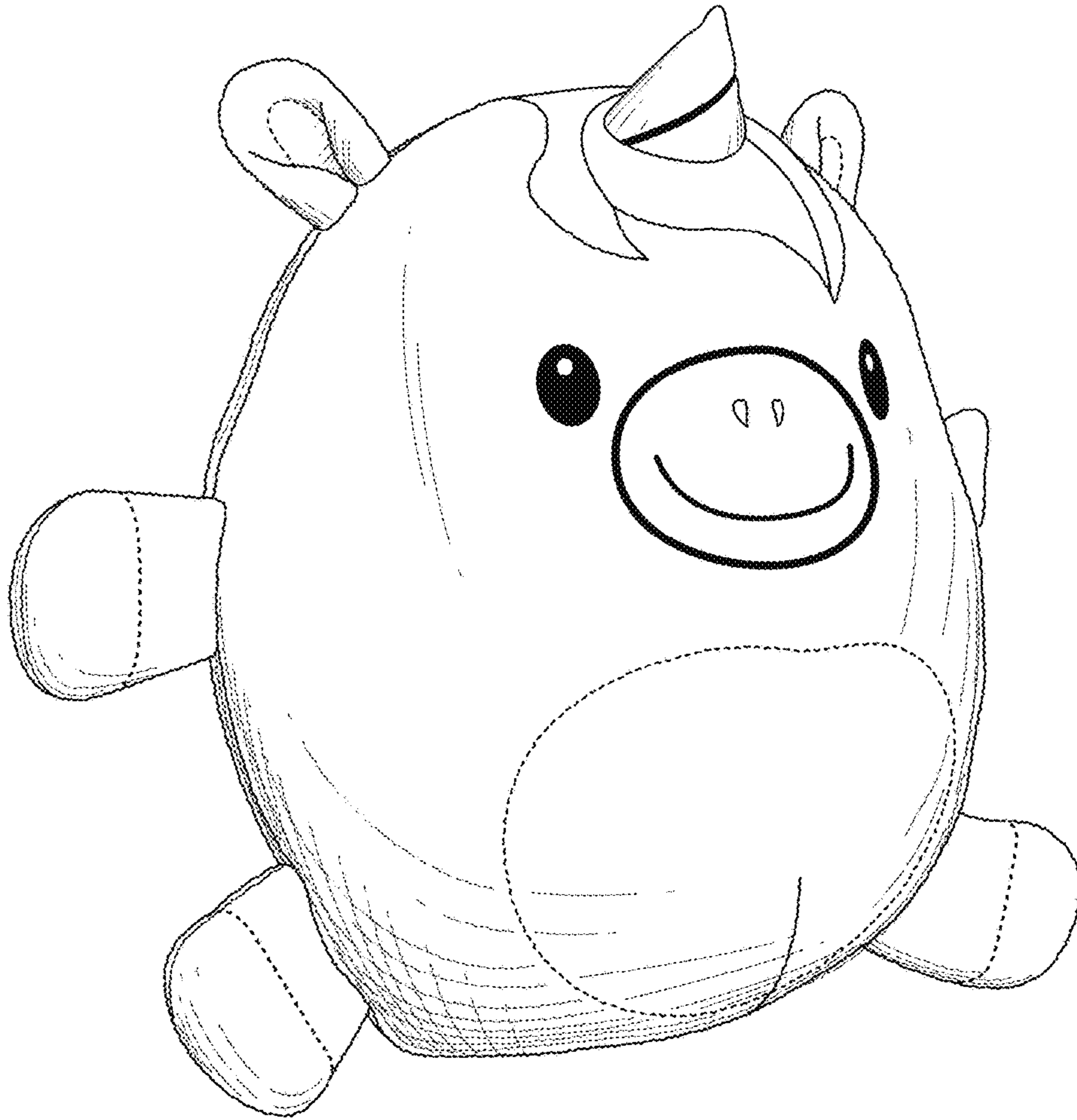

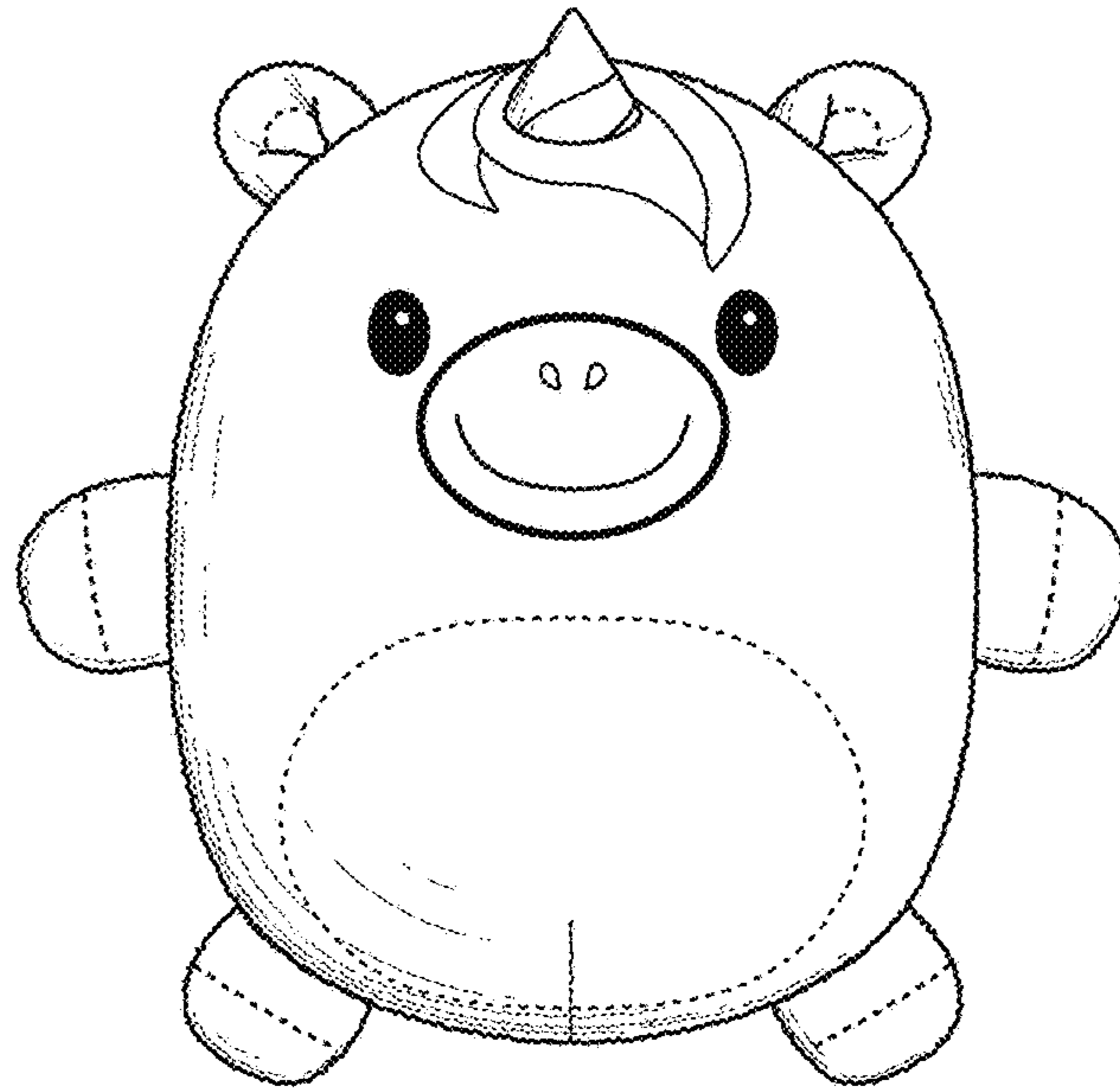

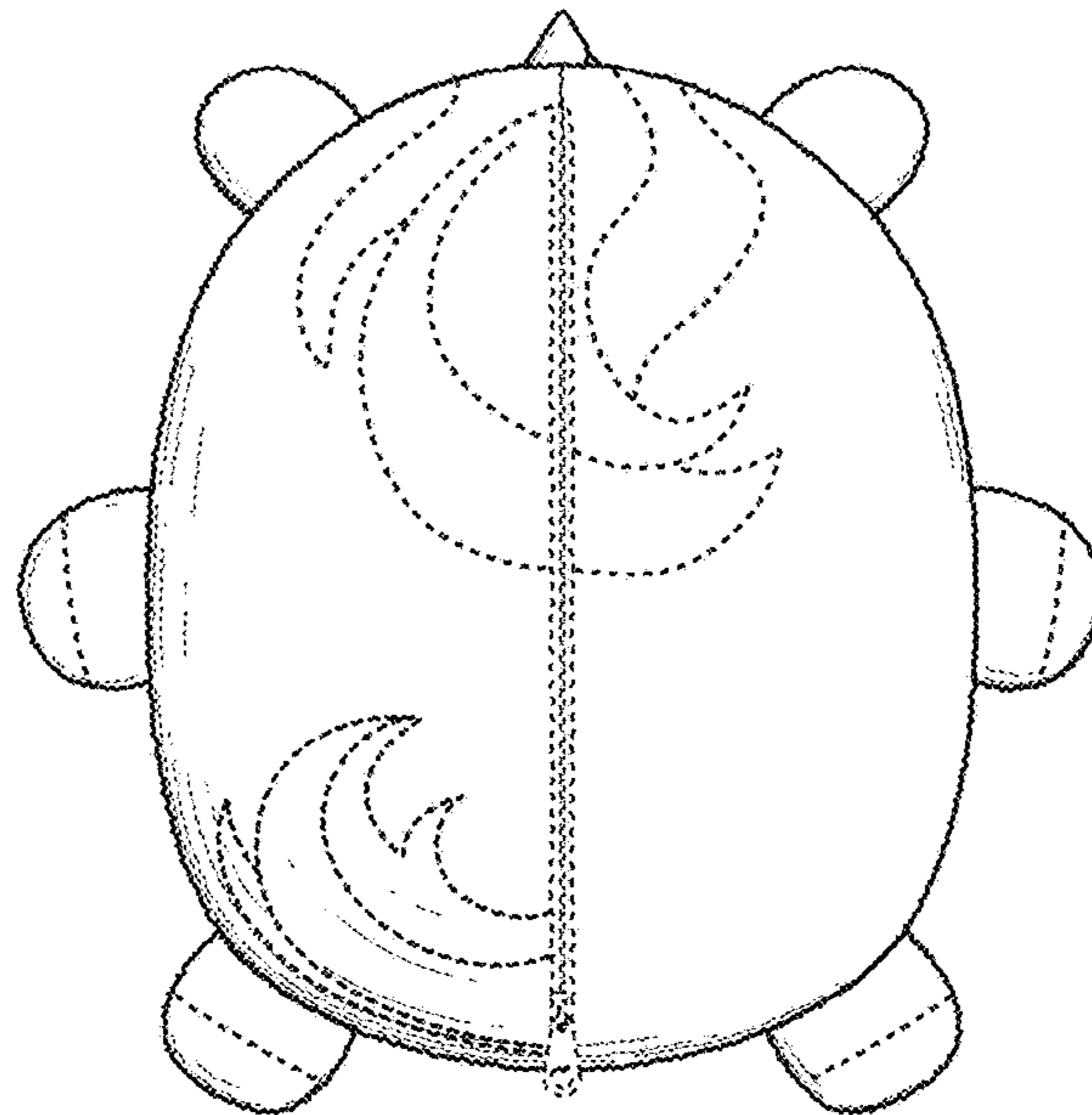

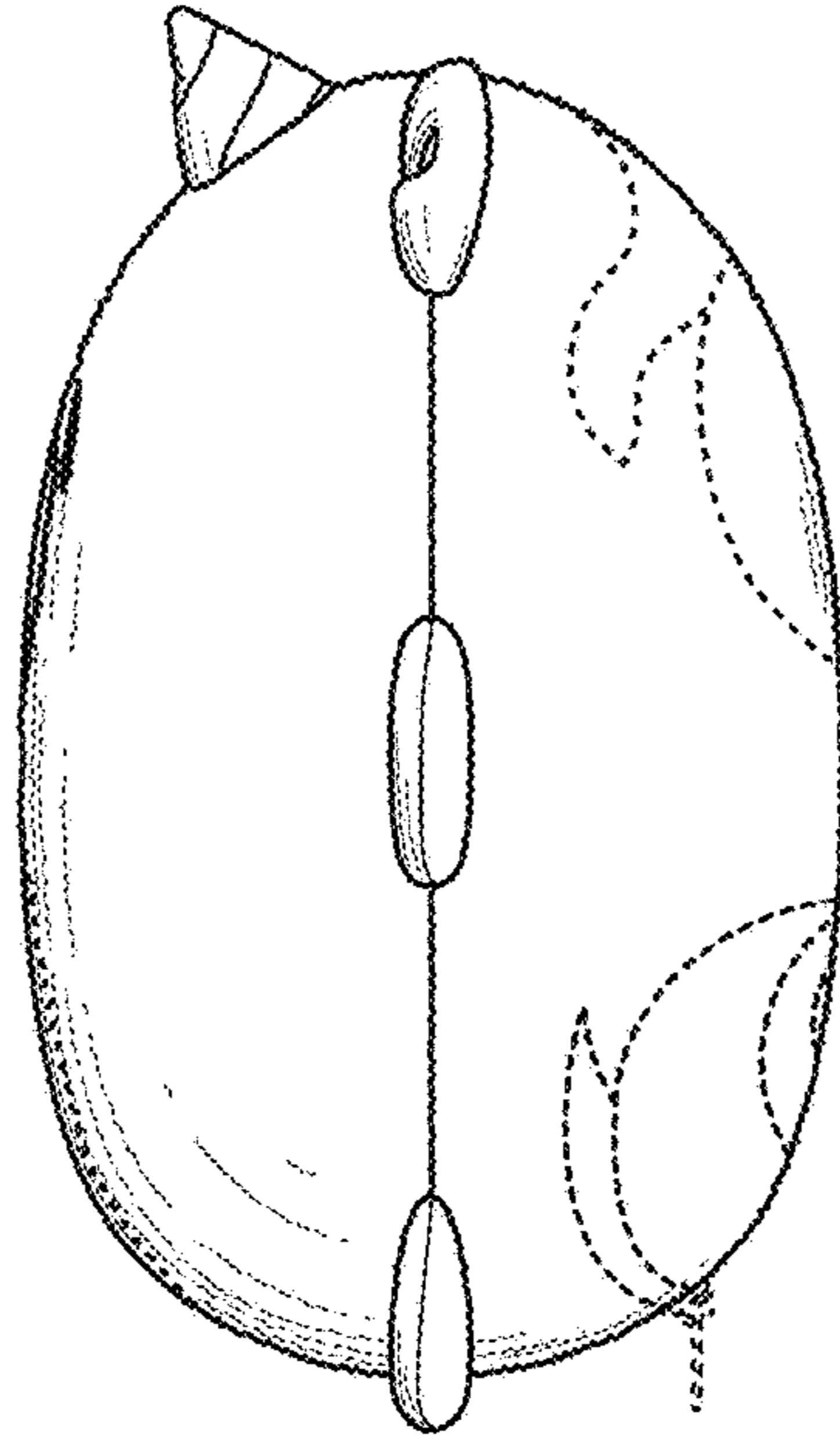

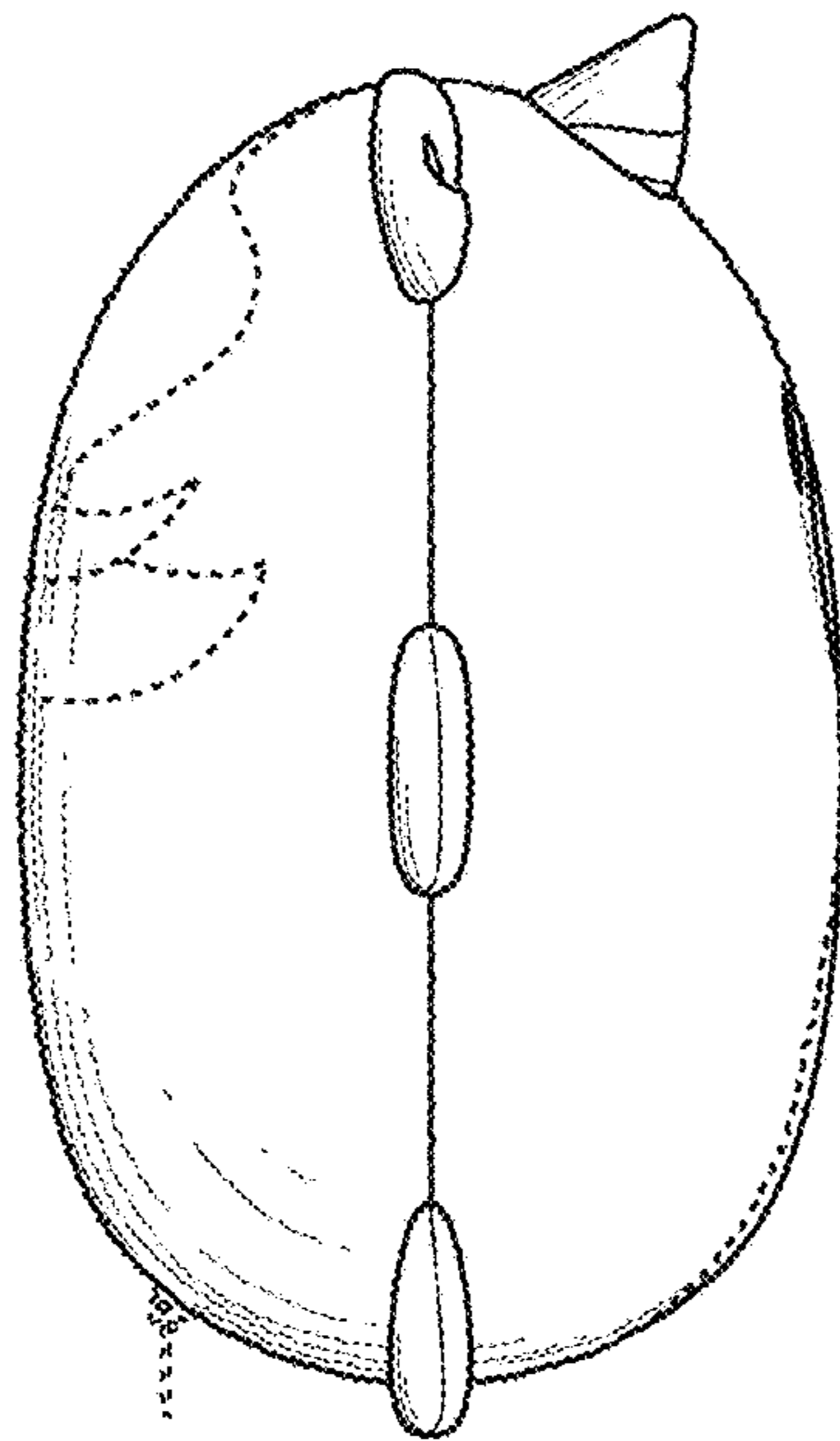

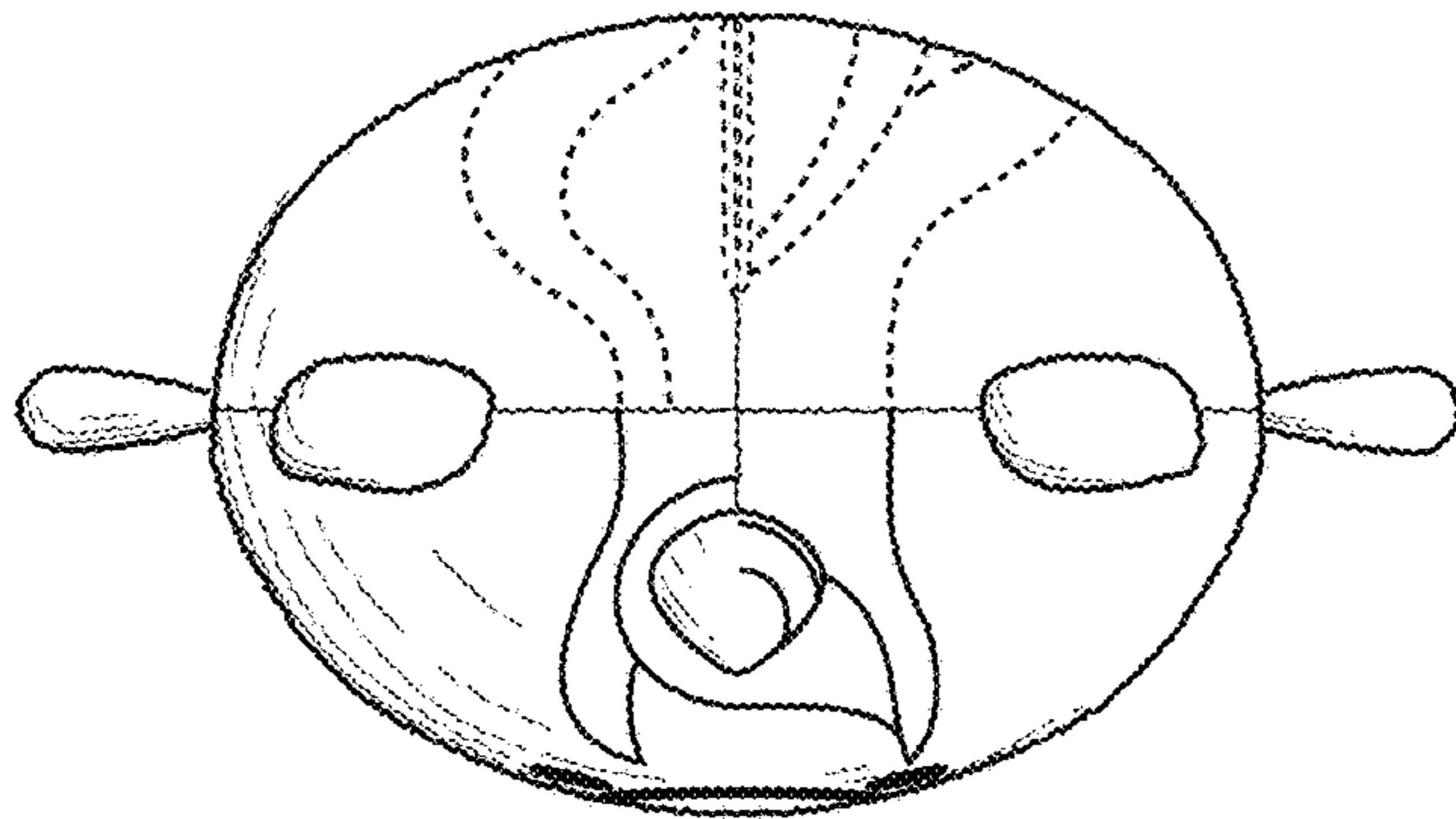

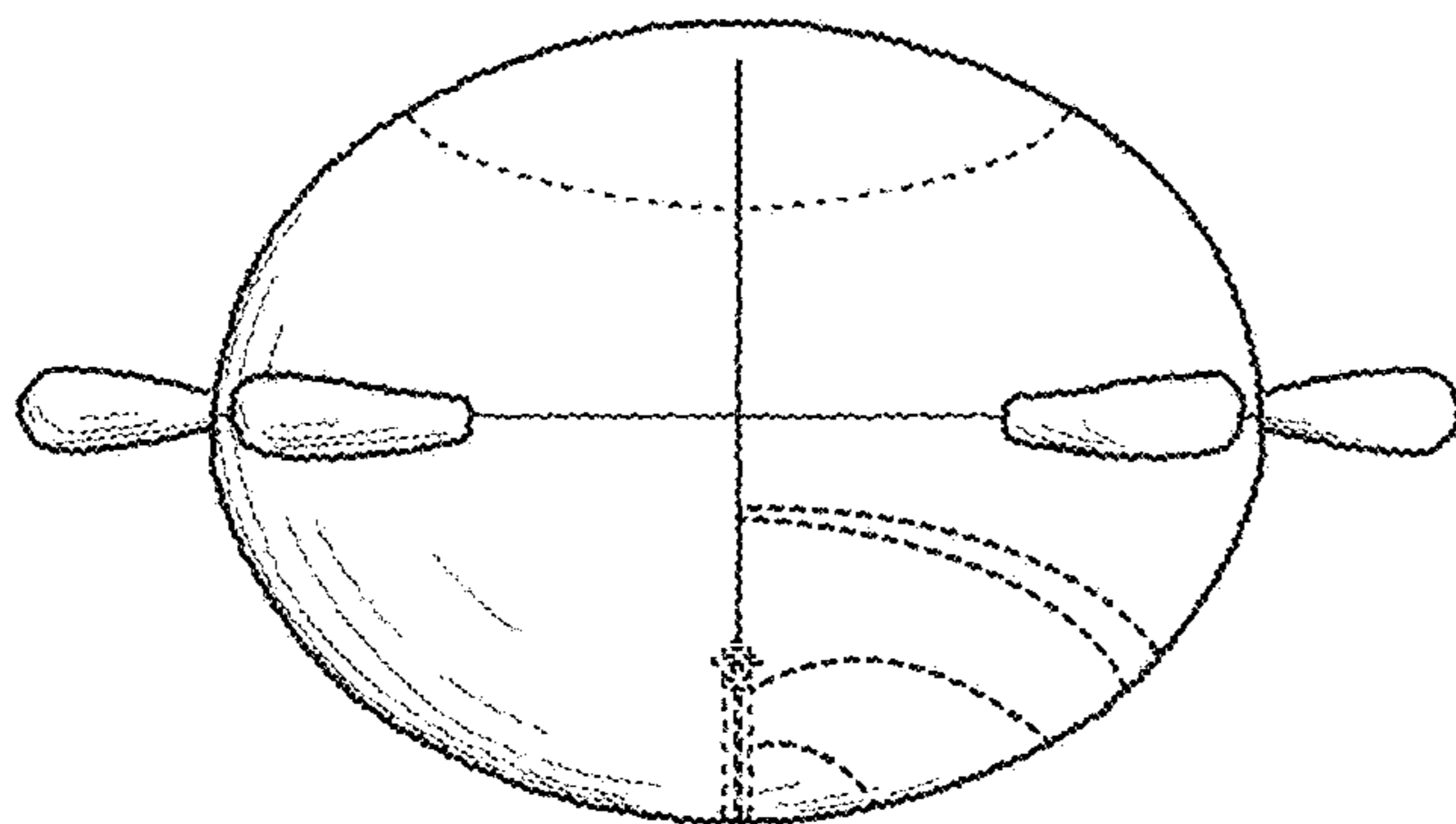
