with the invention.

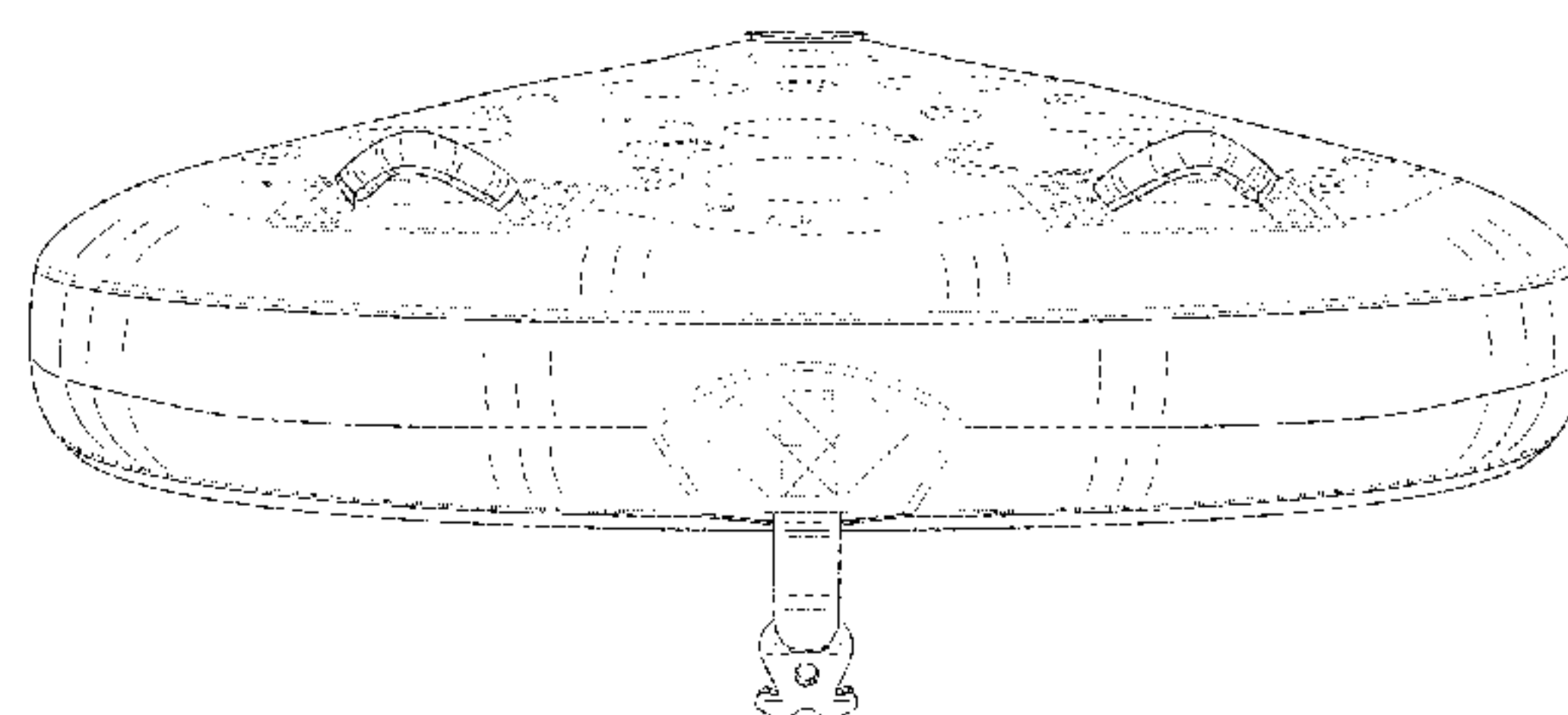
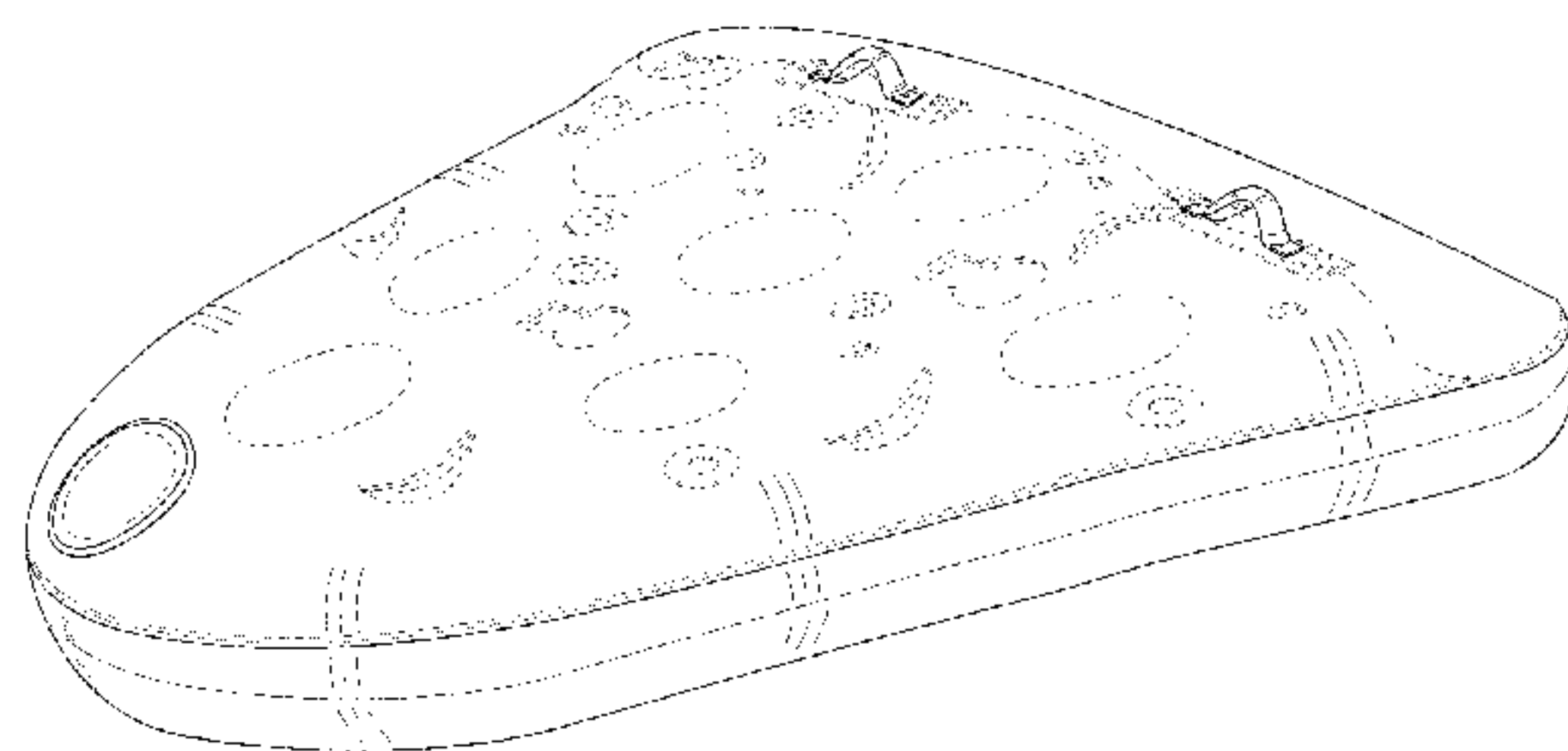
FIG. 5 is a second side view of the pizza float in accordance

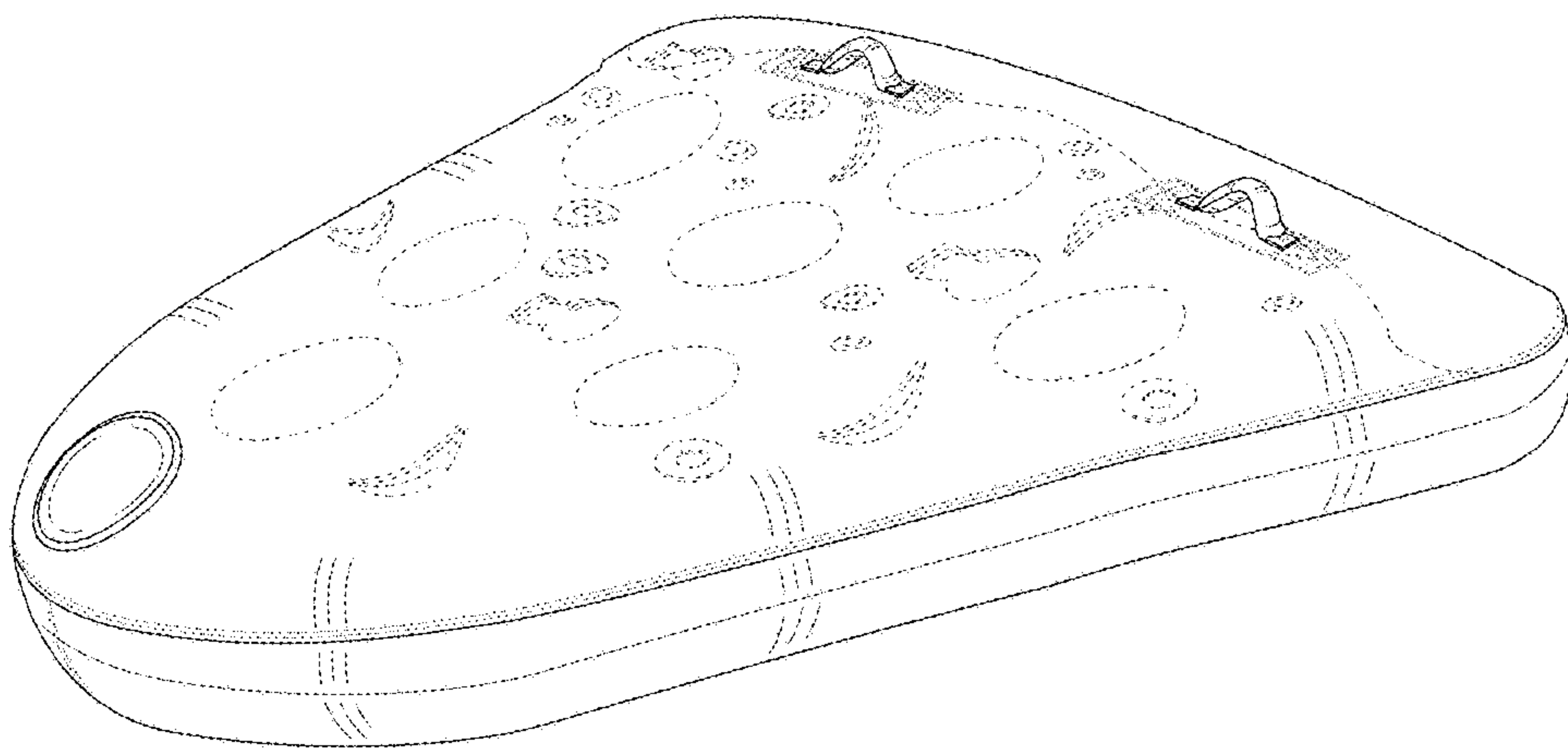

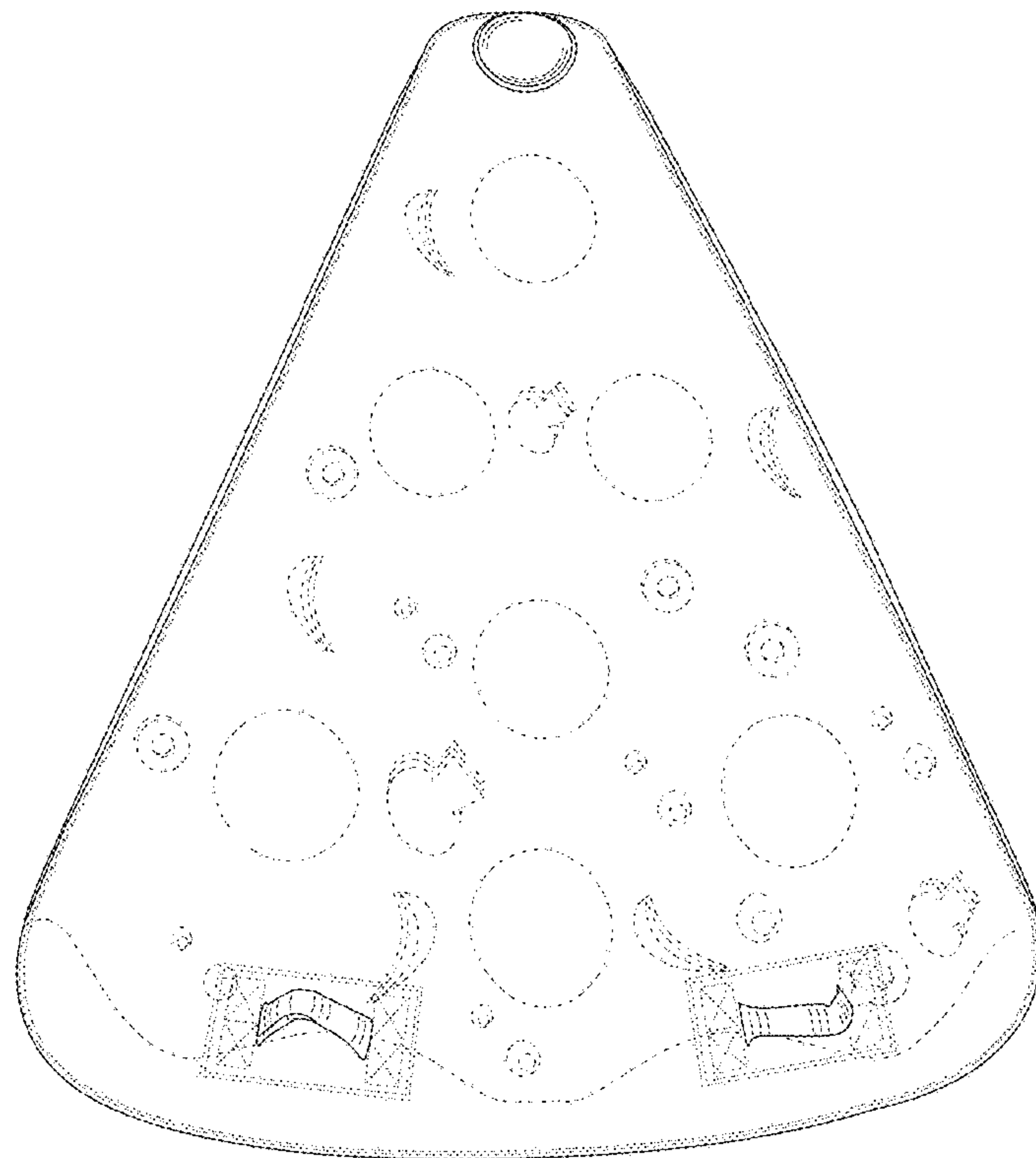

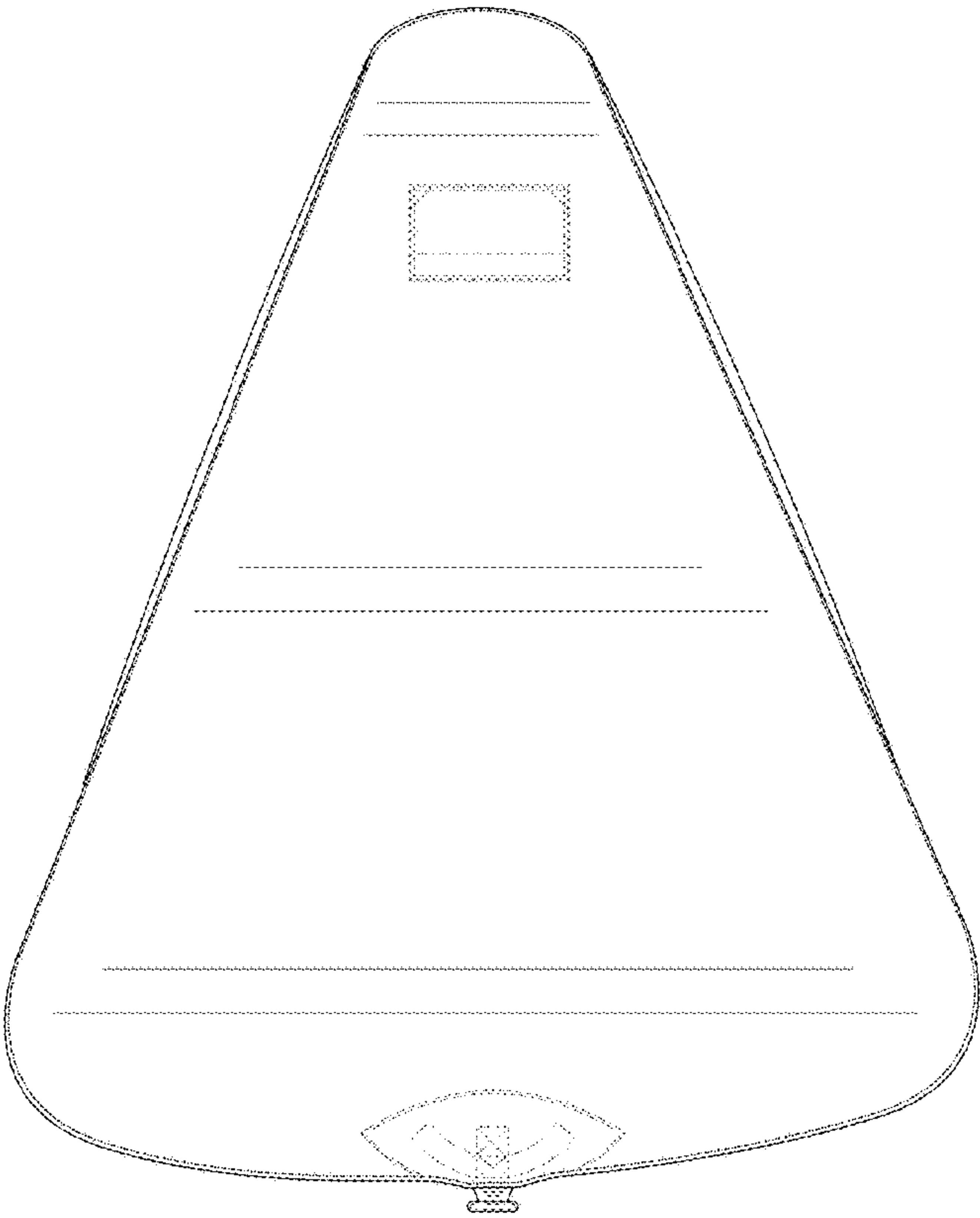

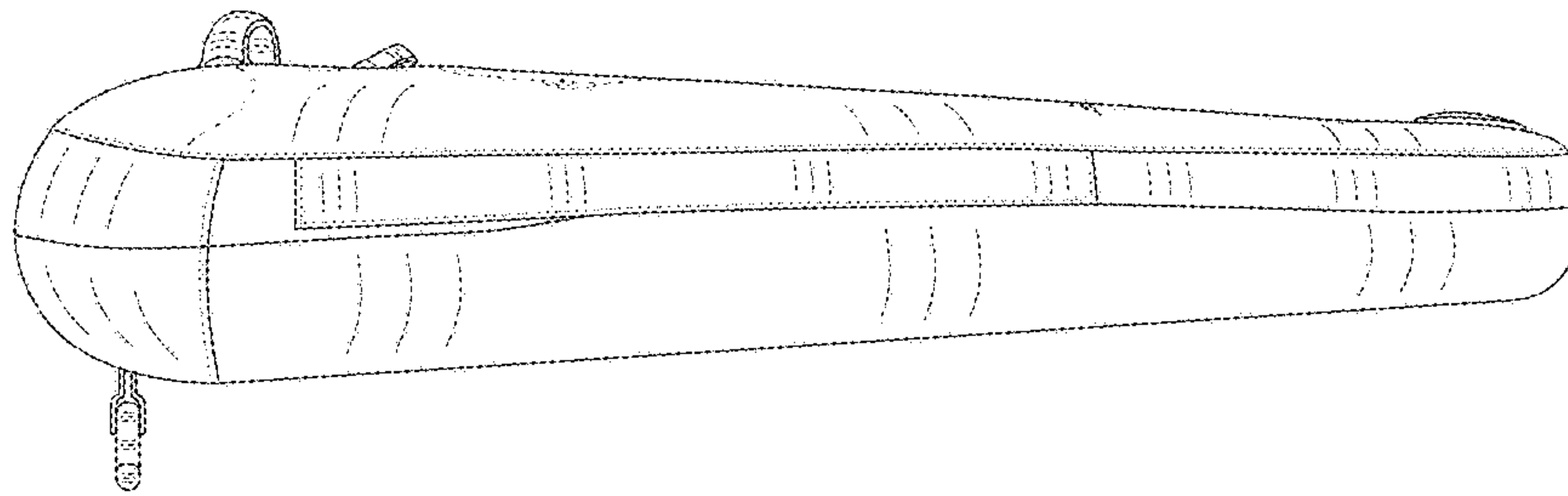

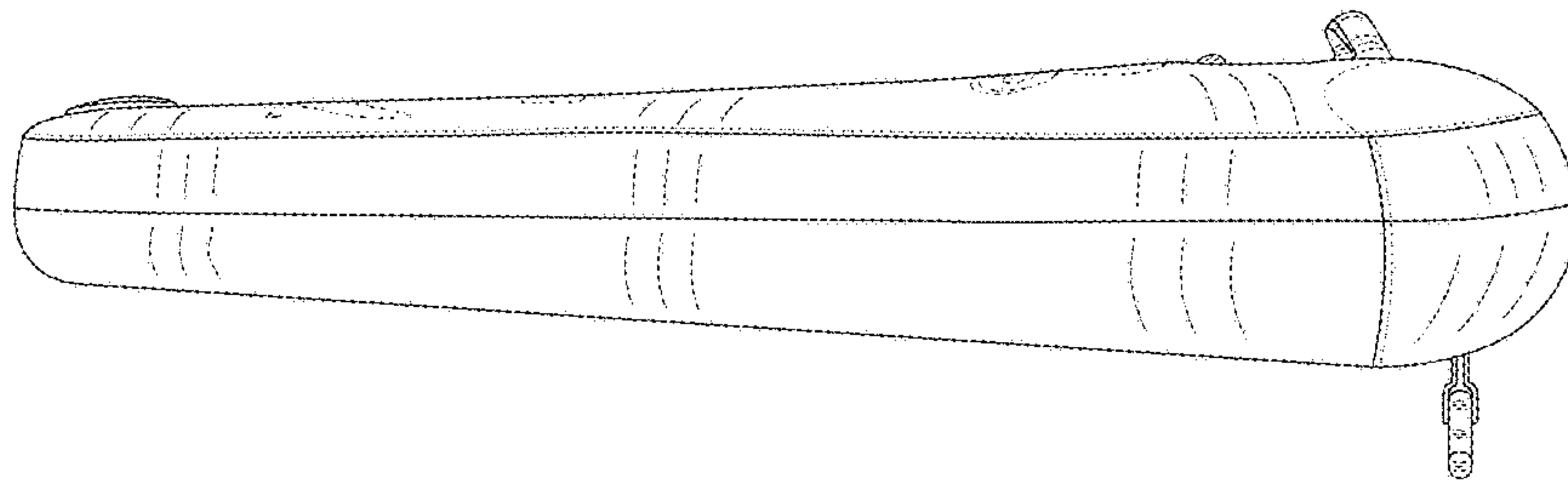

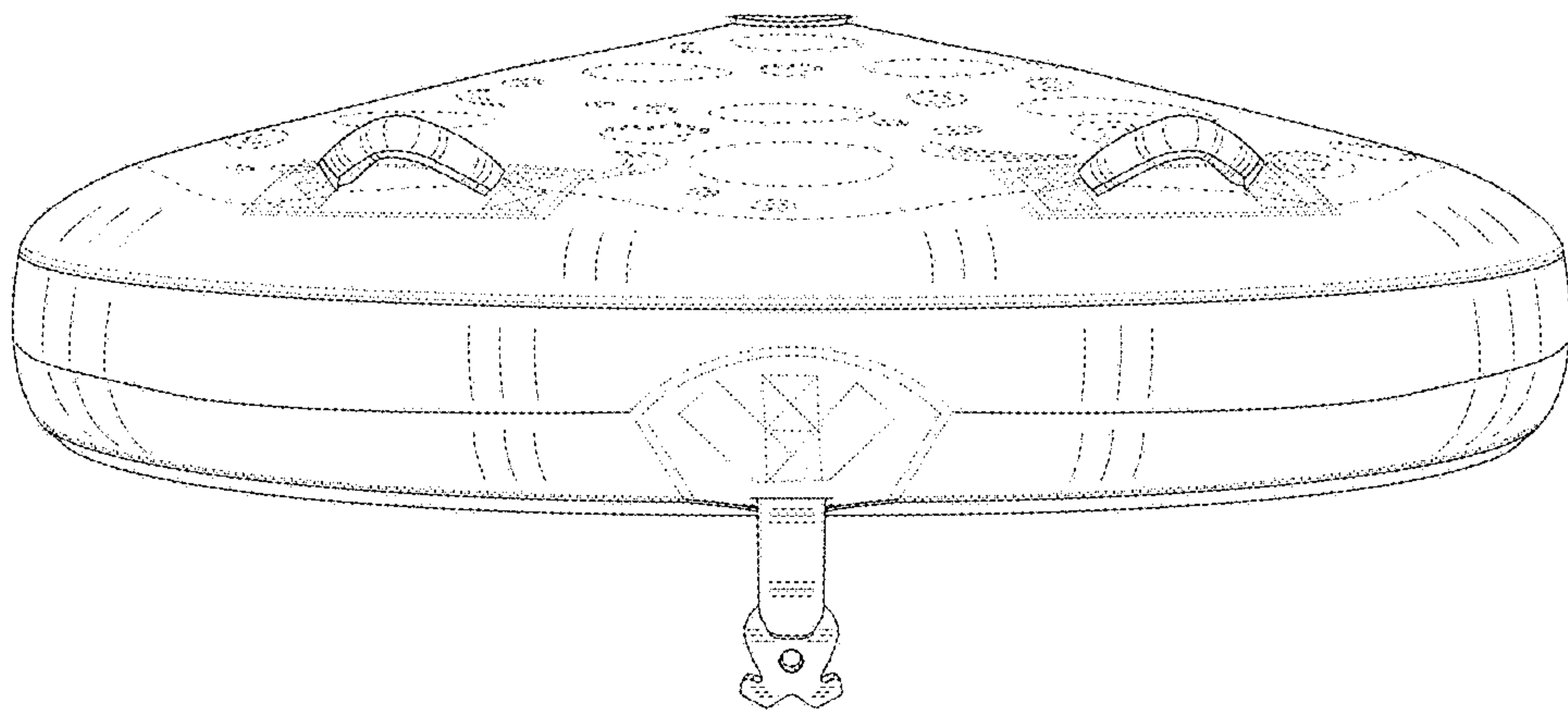

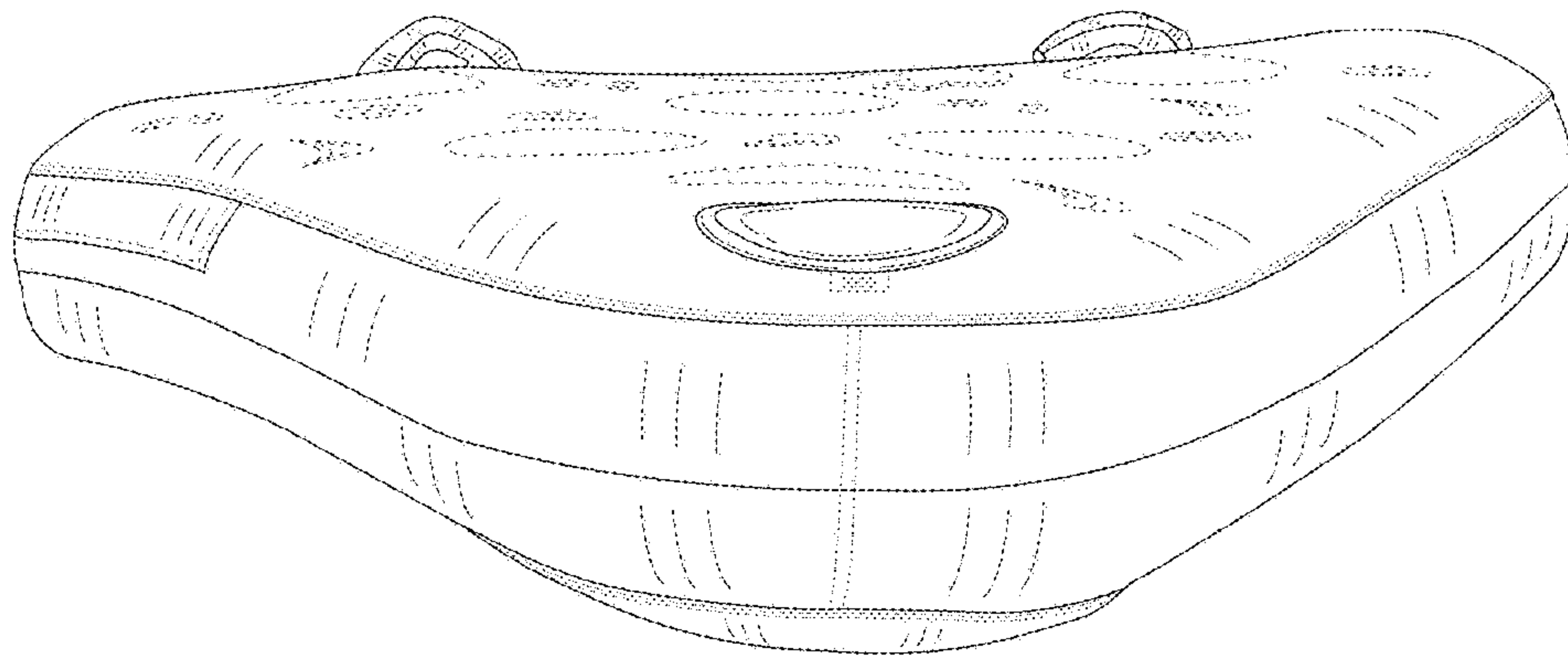
