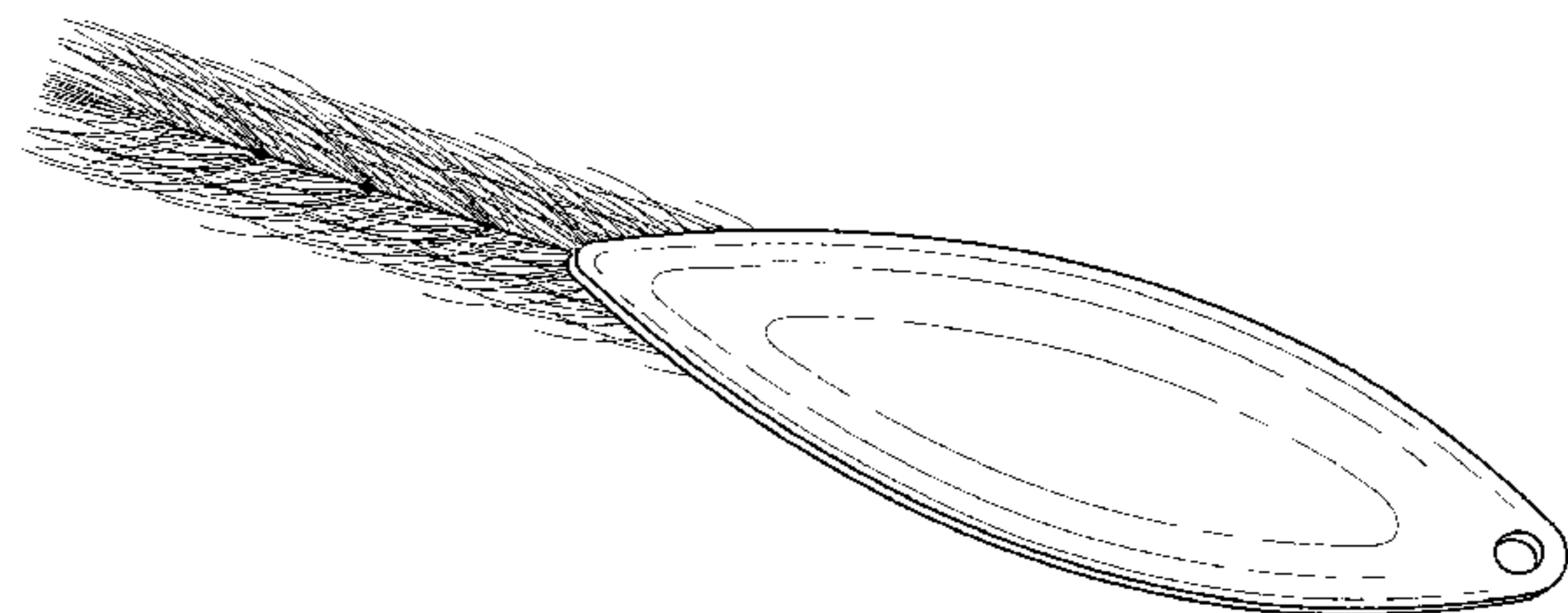
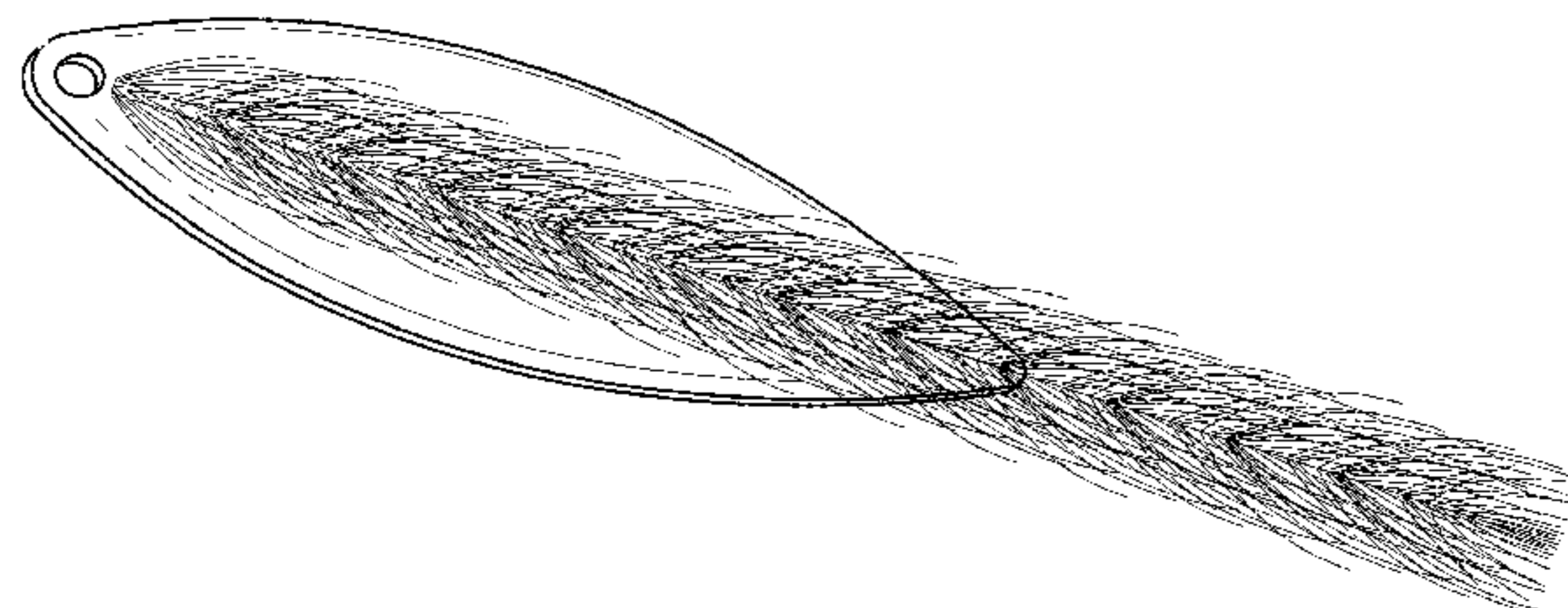


FIG. 8 is a rear elevation view of the fishing lure of the present invention.

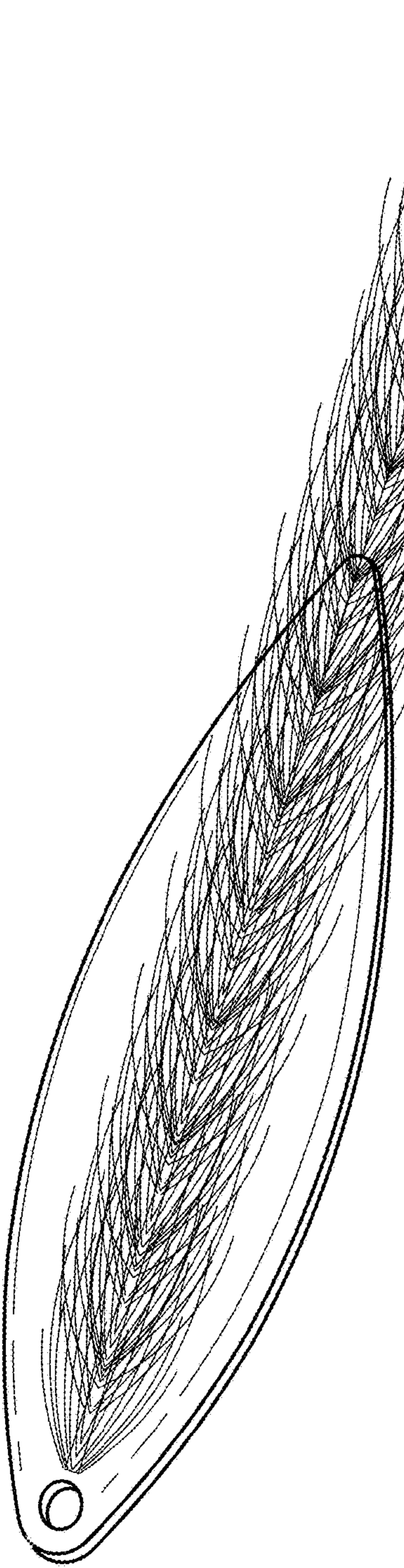

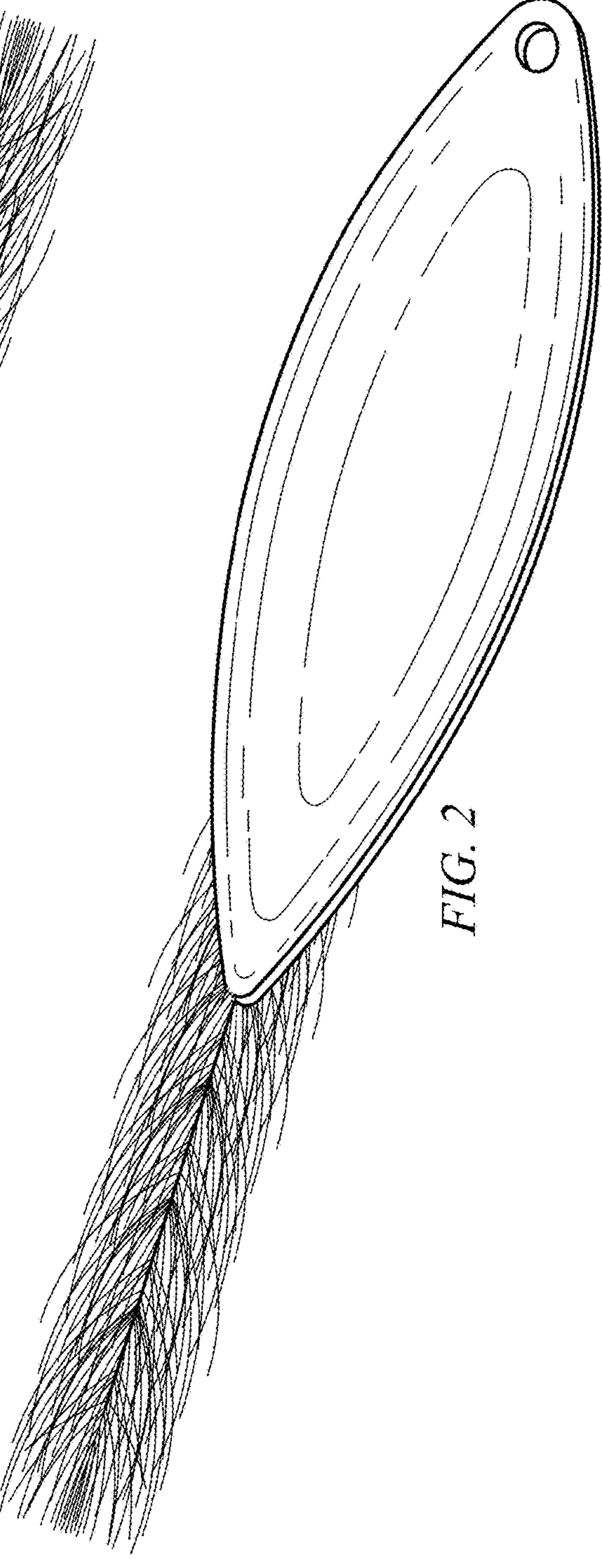

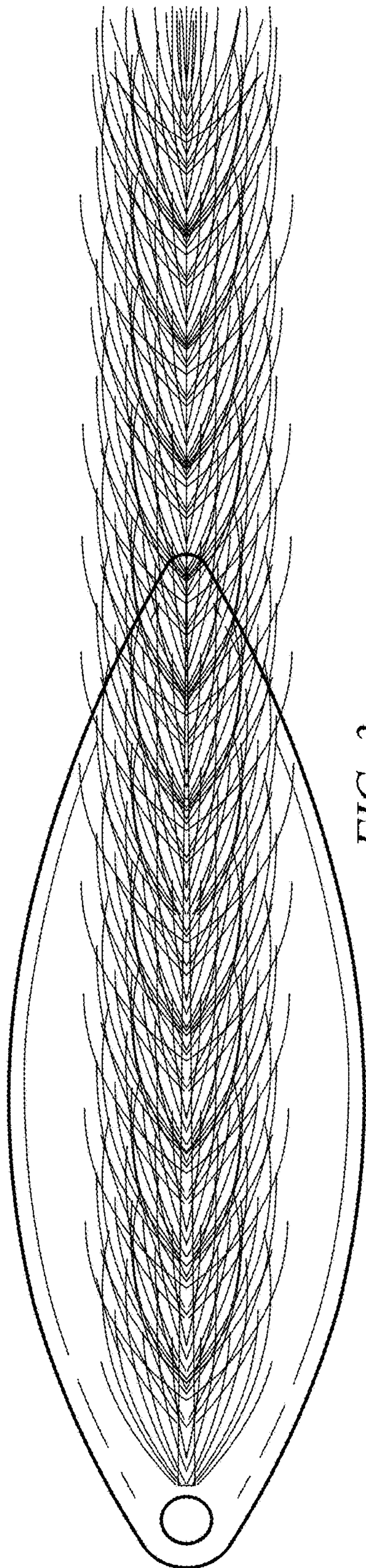

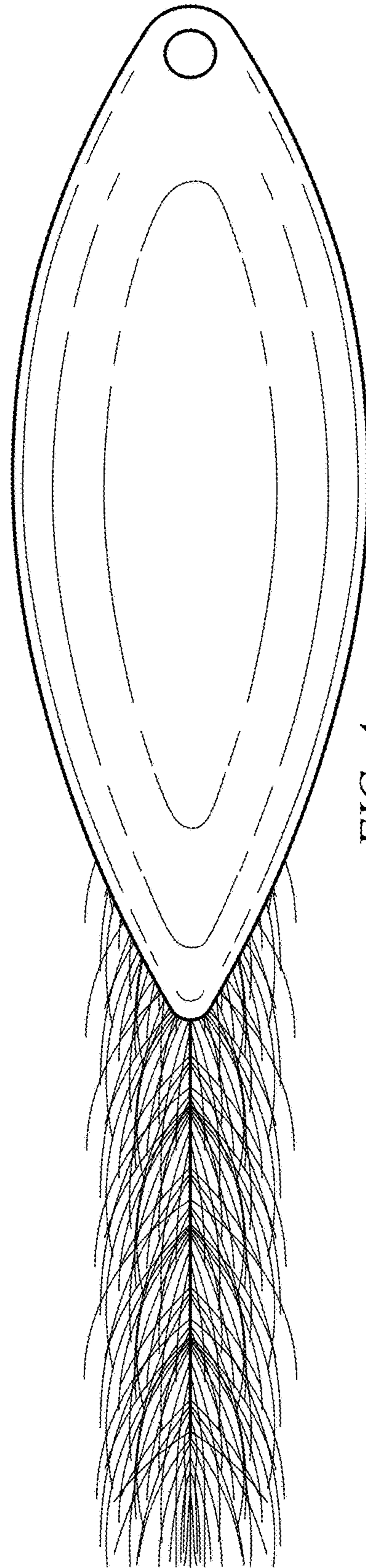


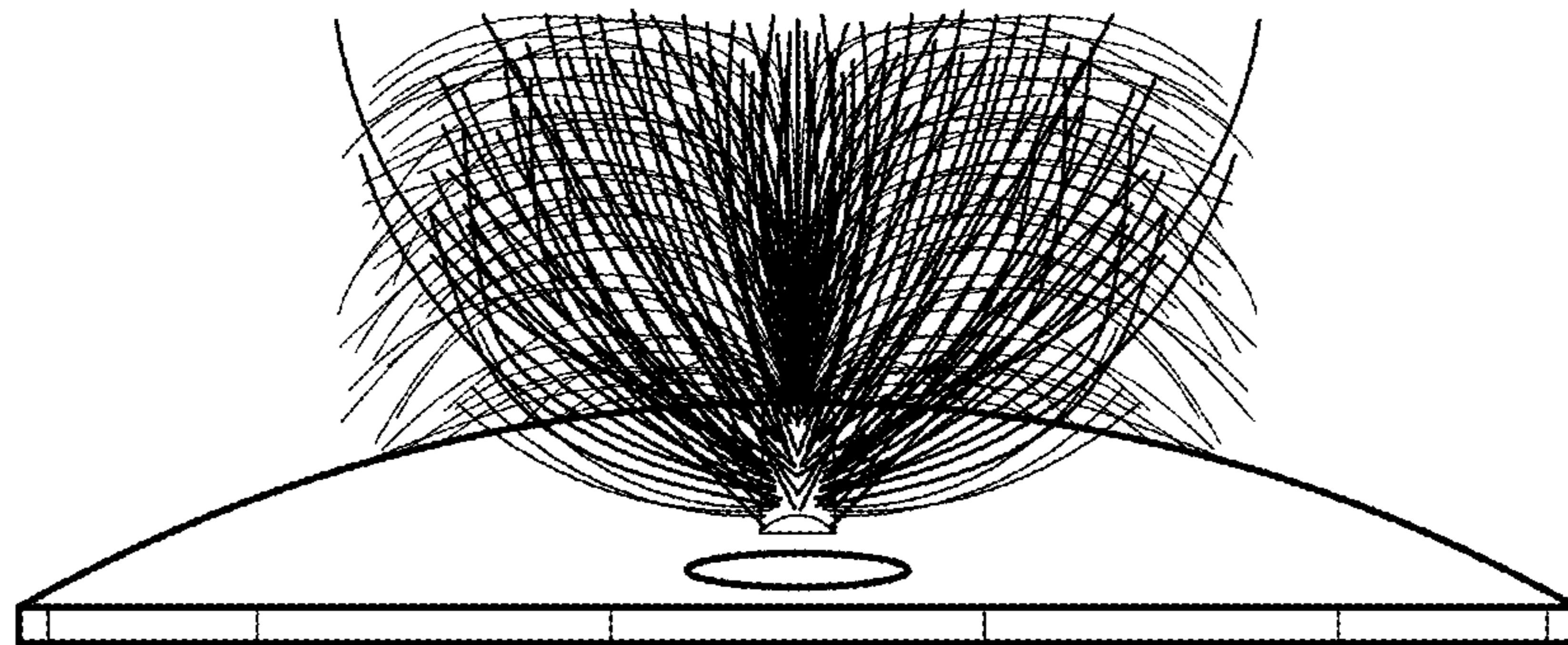

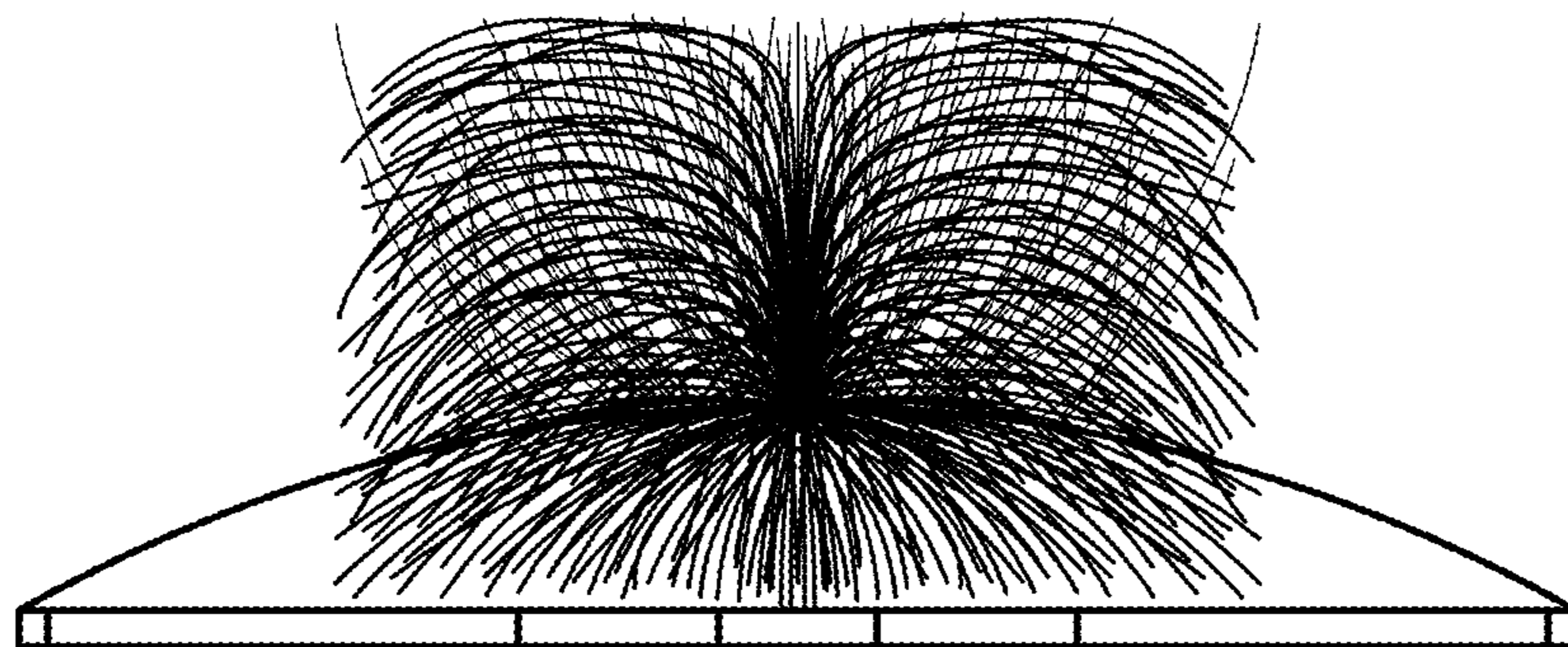
