We claim the ornamental design for a fishing gutting scissors, as shown and described.

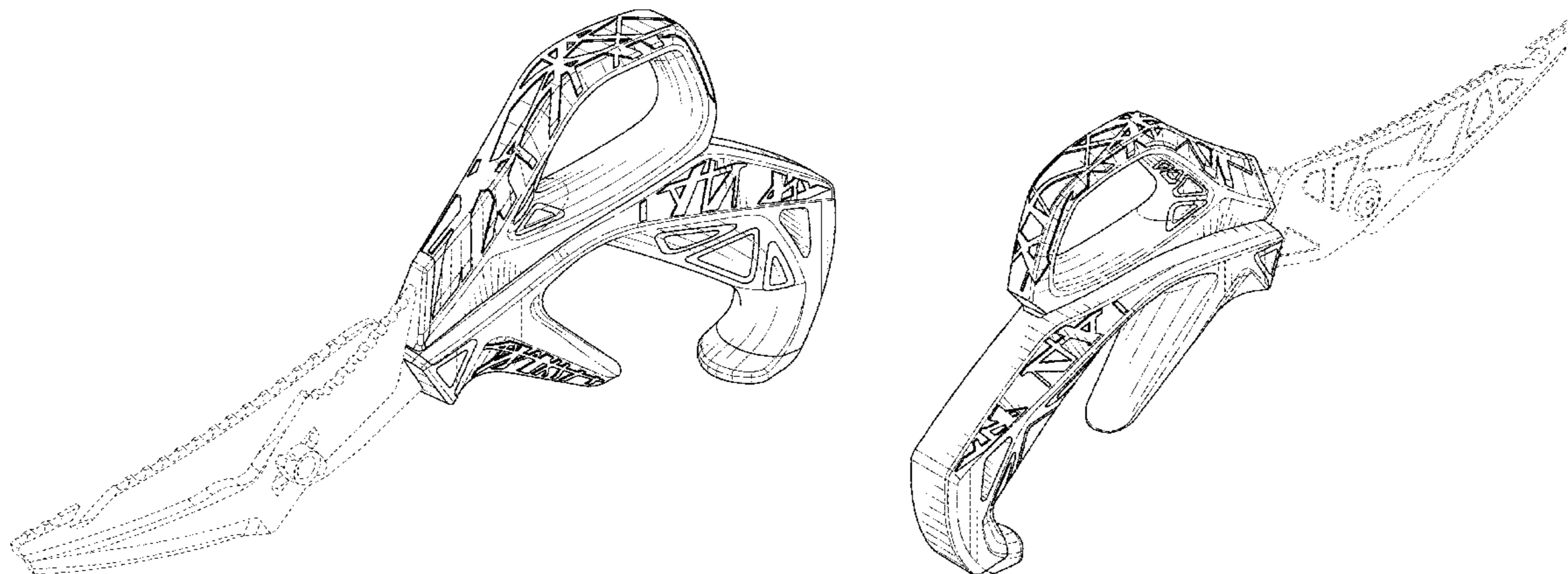
DESCRIPTION

FIG. 1 is a front perspective view from above of the fishing gutting scissors showing my new design;
 FIG. 2 is a left side view of the claimed design of FIG. 1;
 FIG. 3 is a right side view of the claimed design of FIG. 1;
 FIG. 4 is a front view of the claimed design of FIG. 1;
 FIG. 5 is a rear view of the claimed design of FIG. 1;
 FIG. 6 is a top view of the claimed design of FIG. 1;
 FIG. 7 is a bottom view of the claimed design of FIG. 1; and,
 FIG. 8 is a rear perspective view from above of the claimed design of FIG. 1.

The broken lines in the drawings depict portions of the fishing gutting scissors that form no part of the claimed design. The broken lines formed by equal length dashes depict portions of the fishing gutting scissors that are not included in the claim.

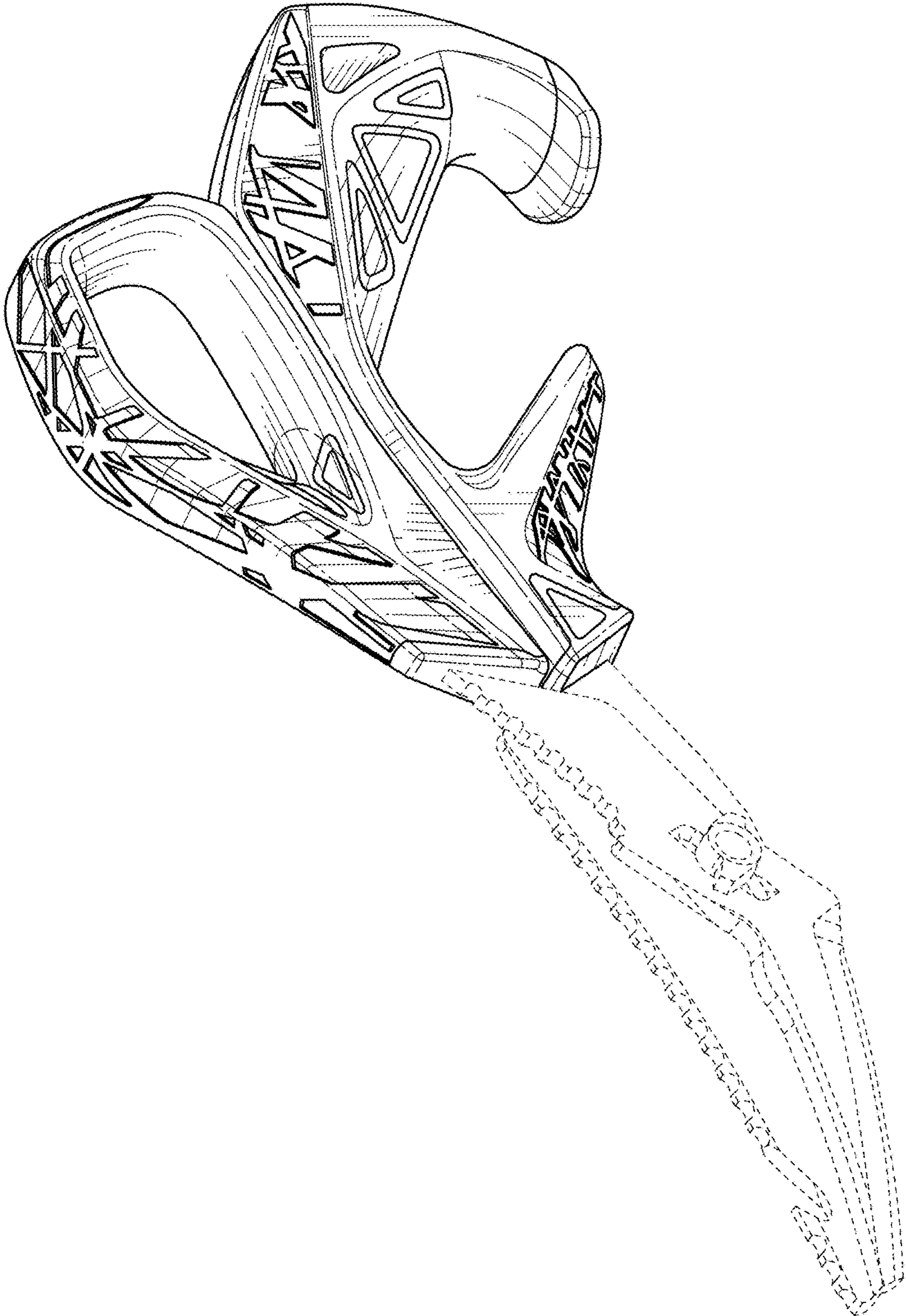

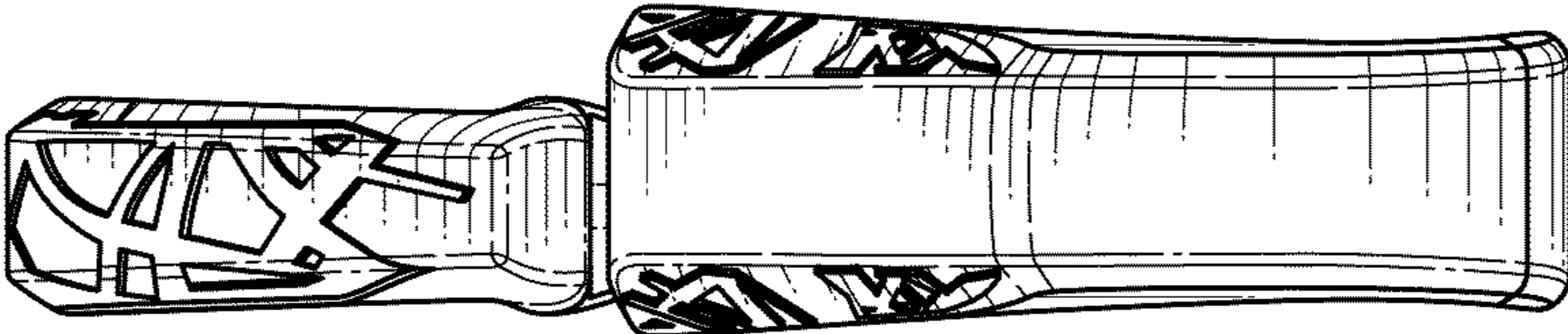

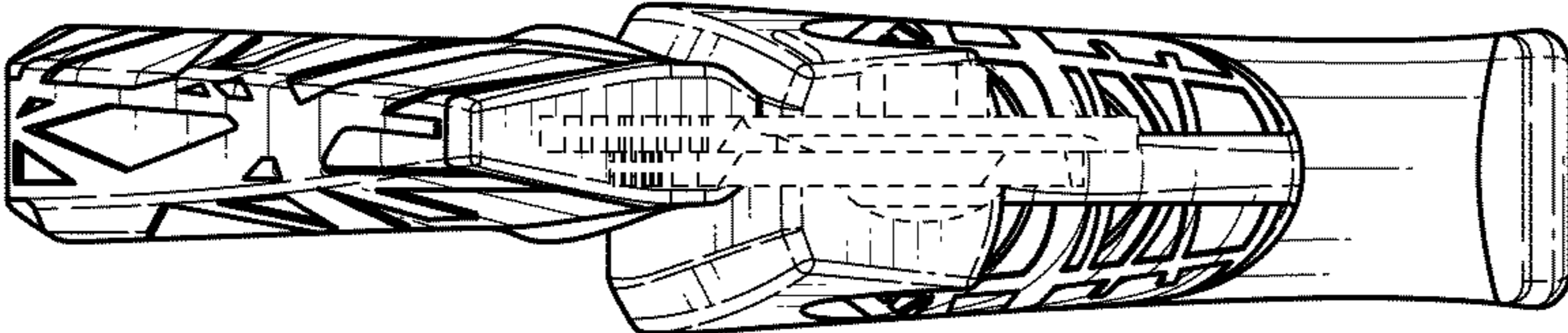

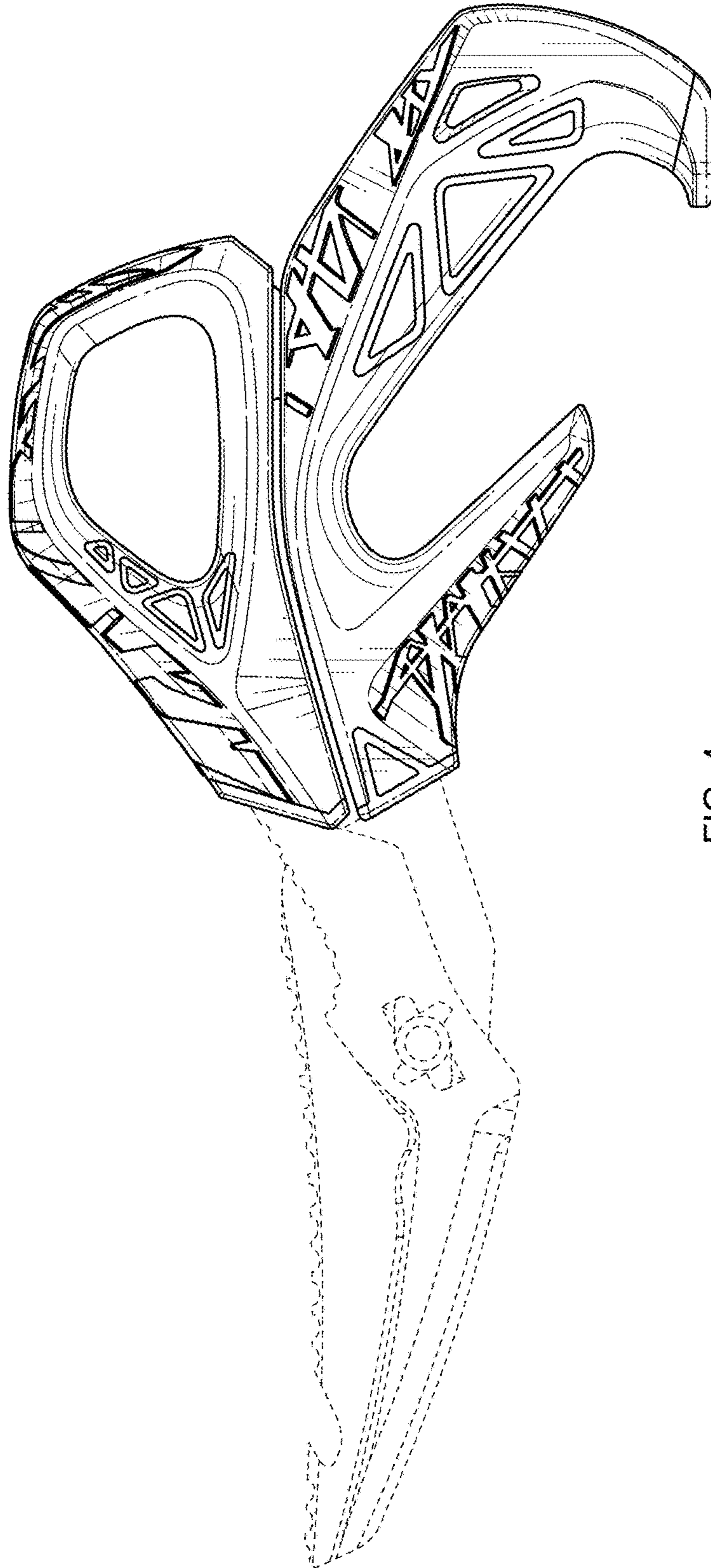

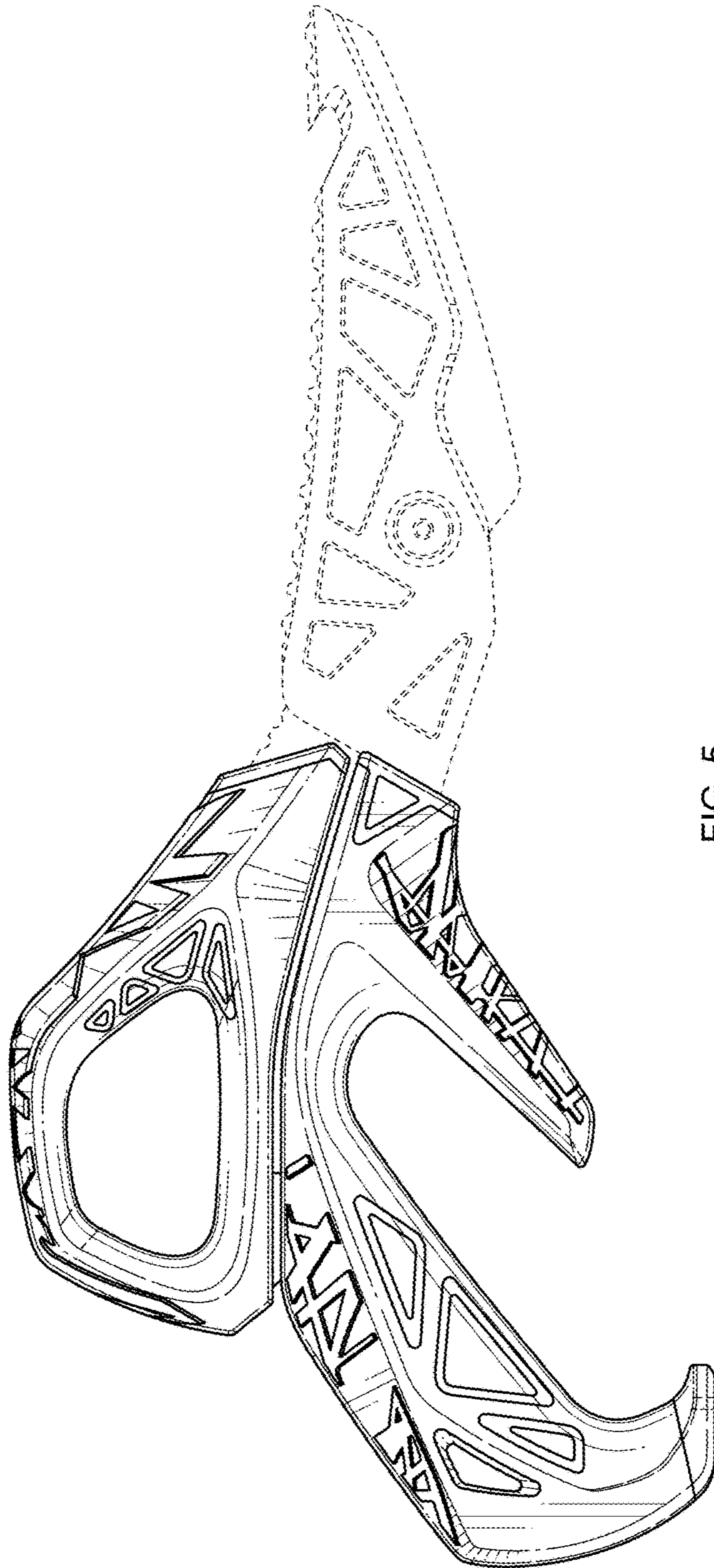

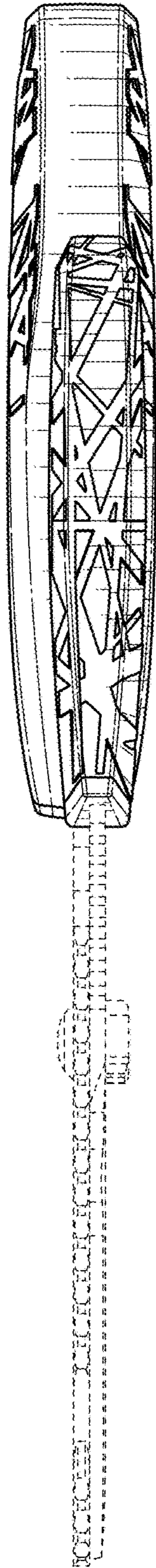

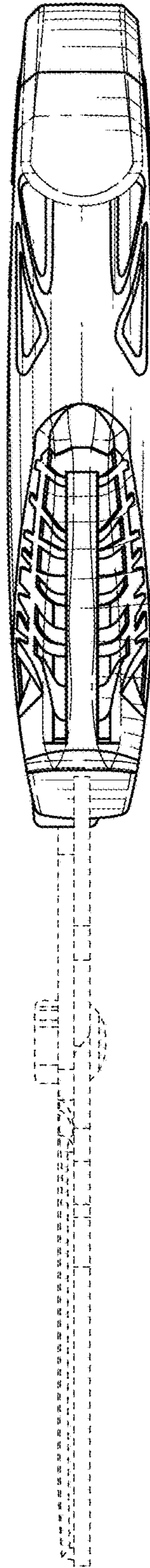

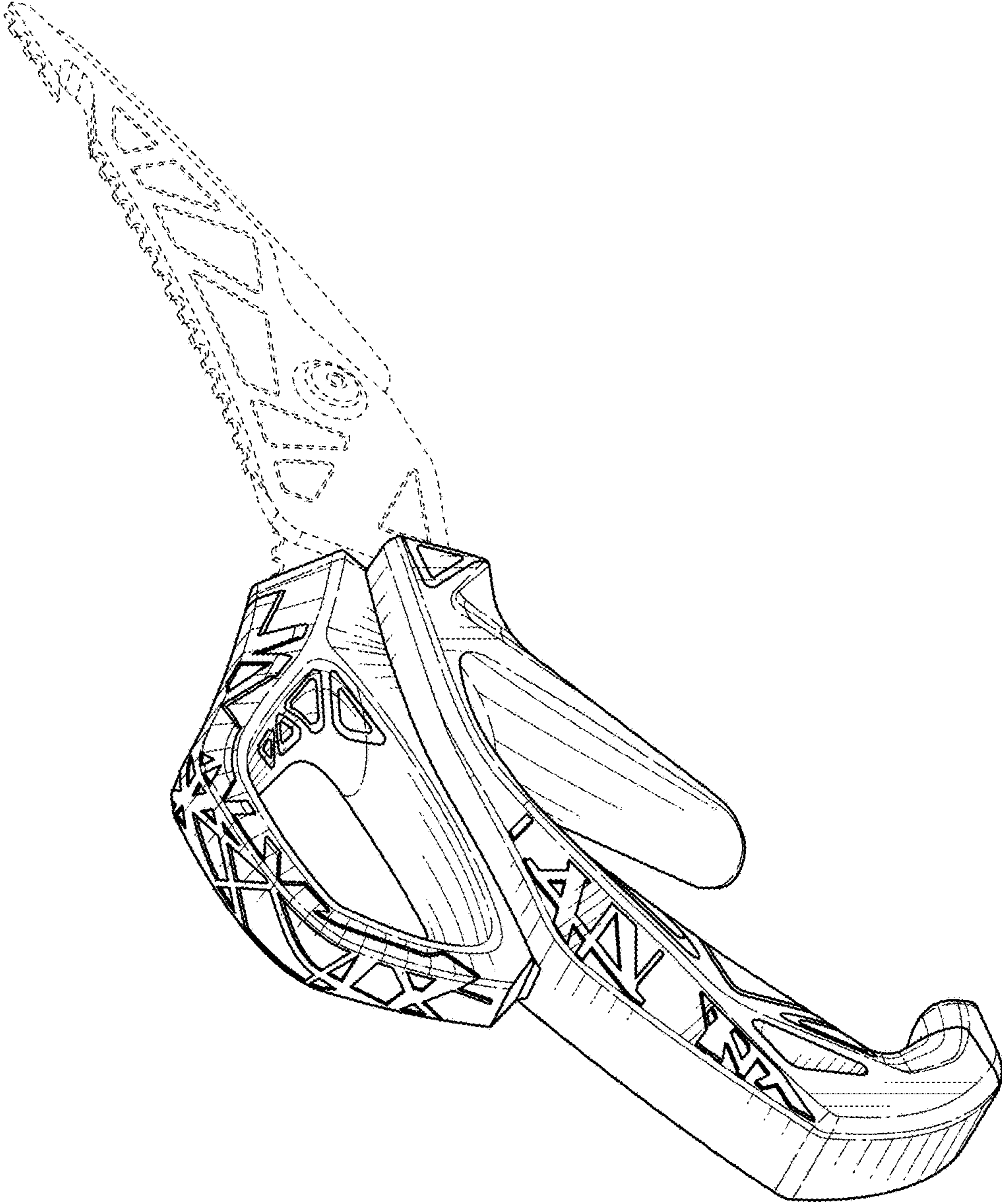
