The bottom of the claim in Fig. 1.7 inside the solid line forms no part of the claim.

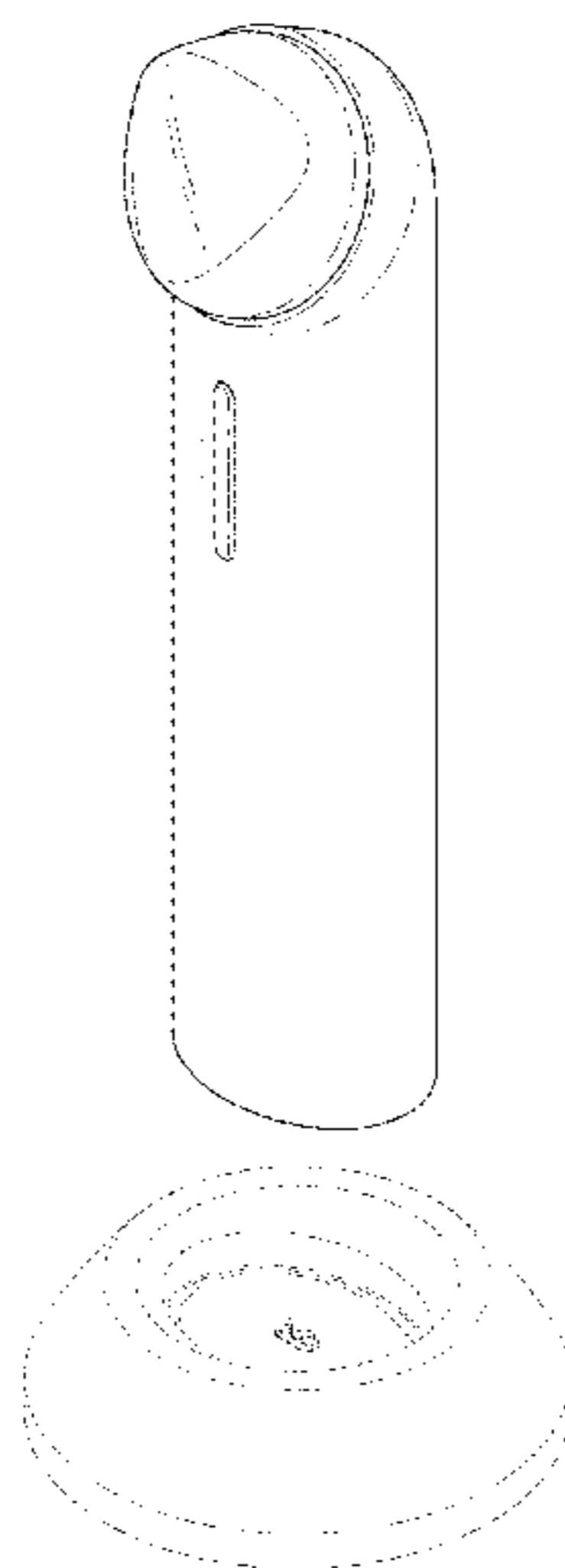

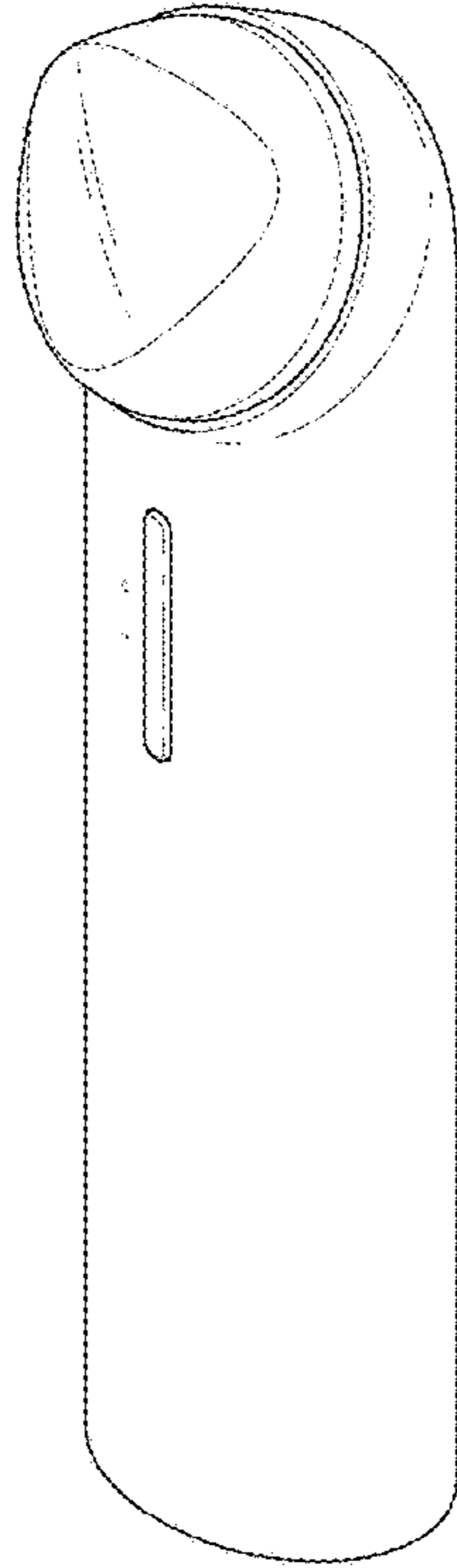

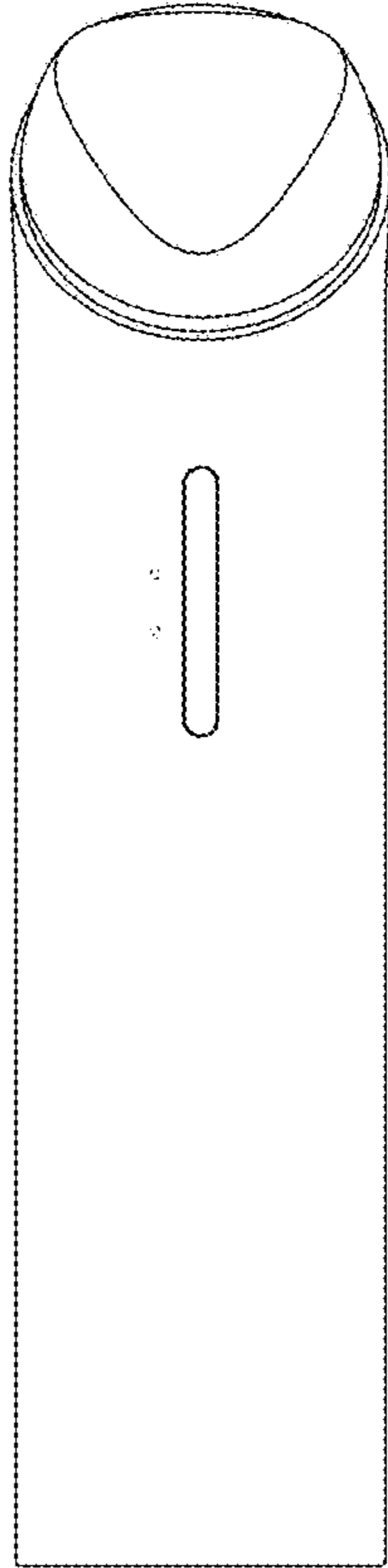

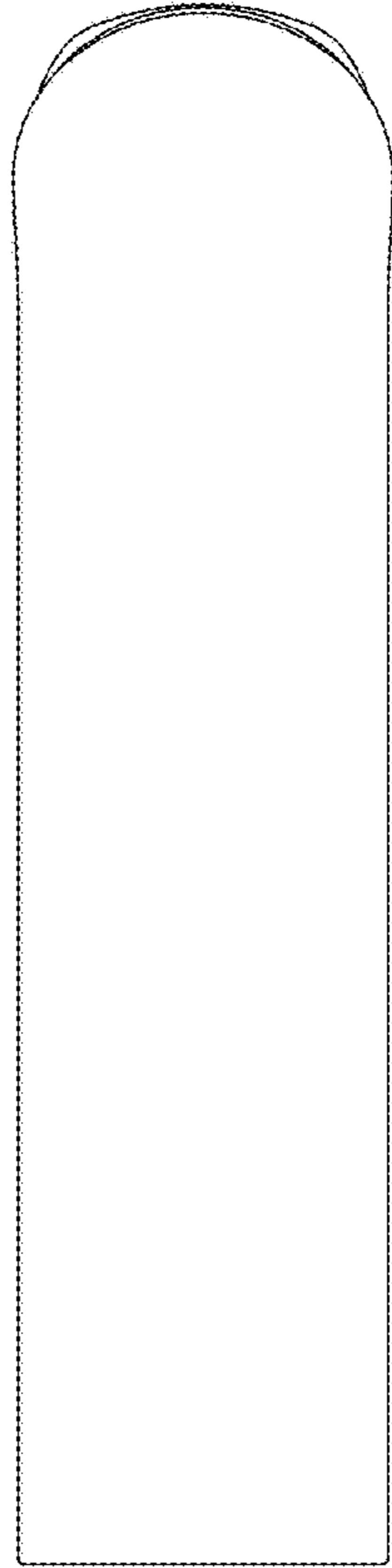

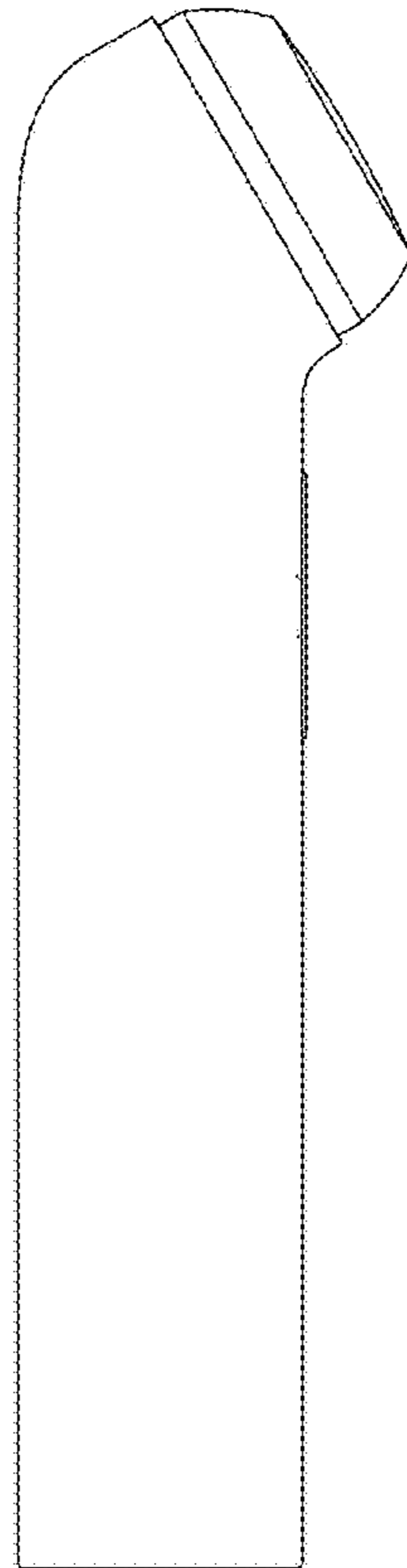

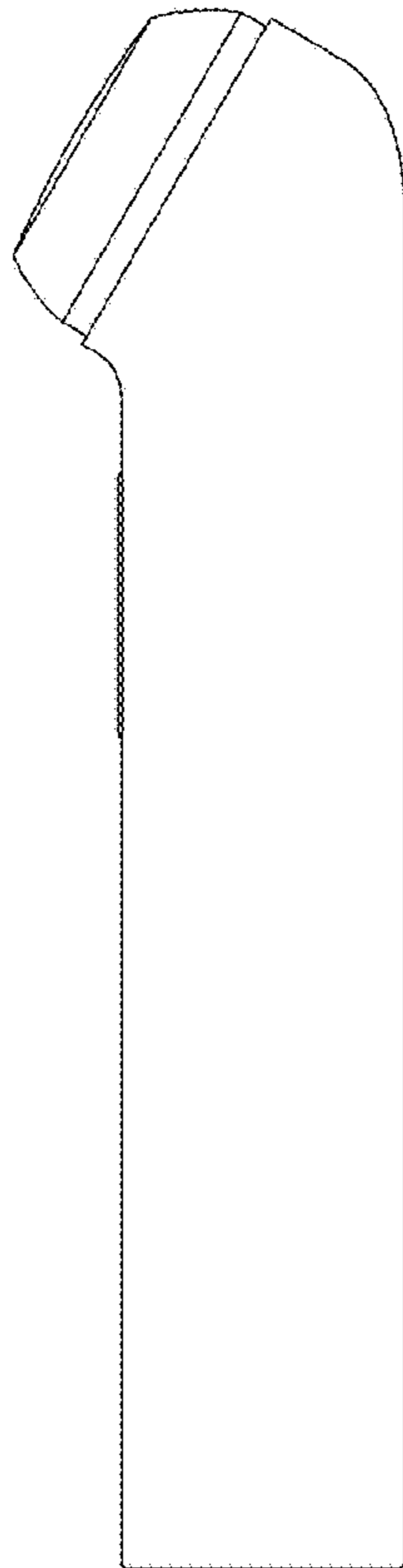

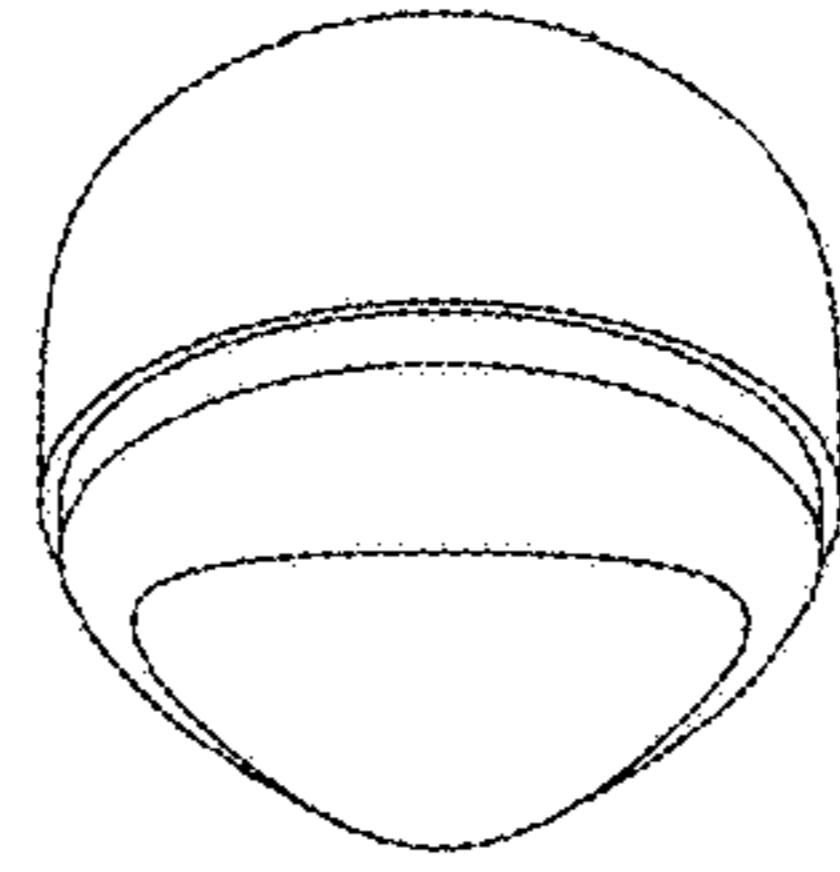

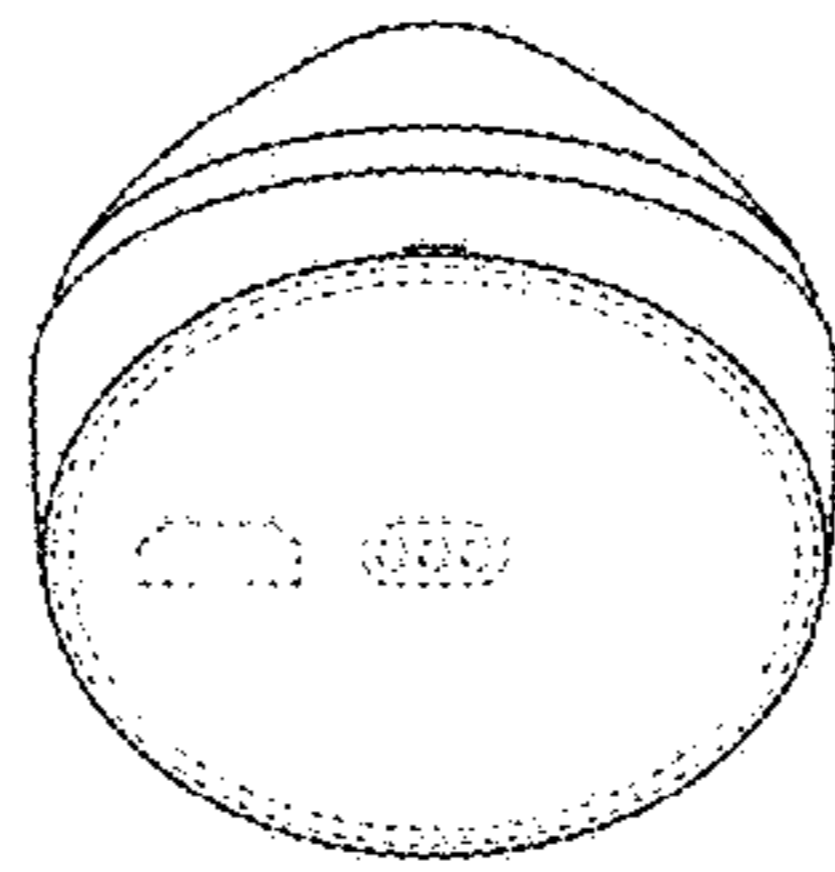
