FIG. 4 is a third side elevational view thereof;

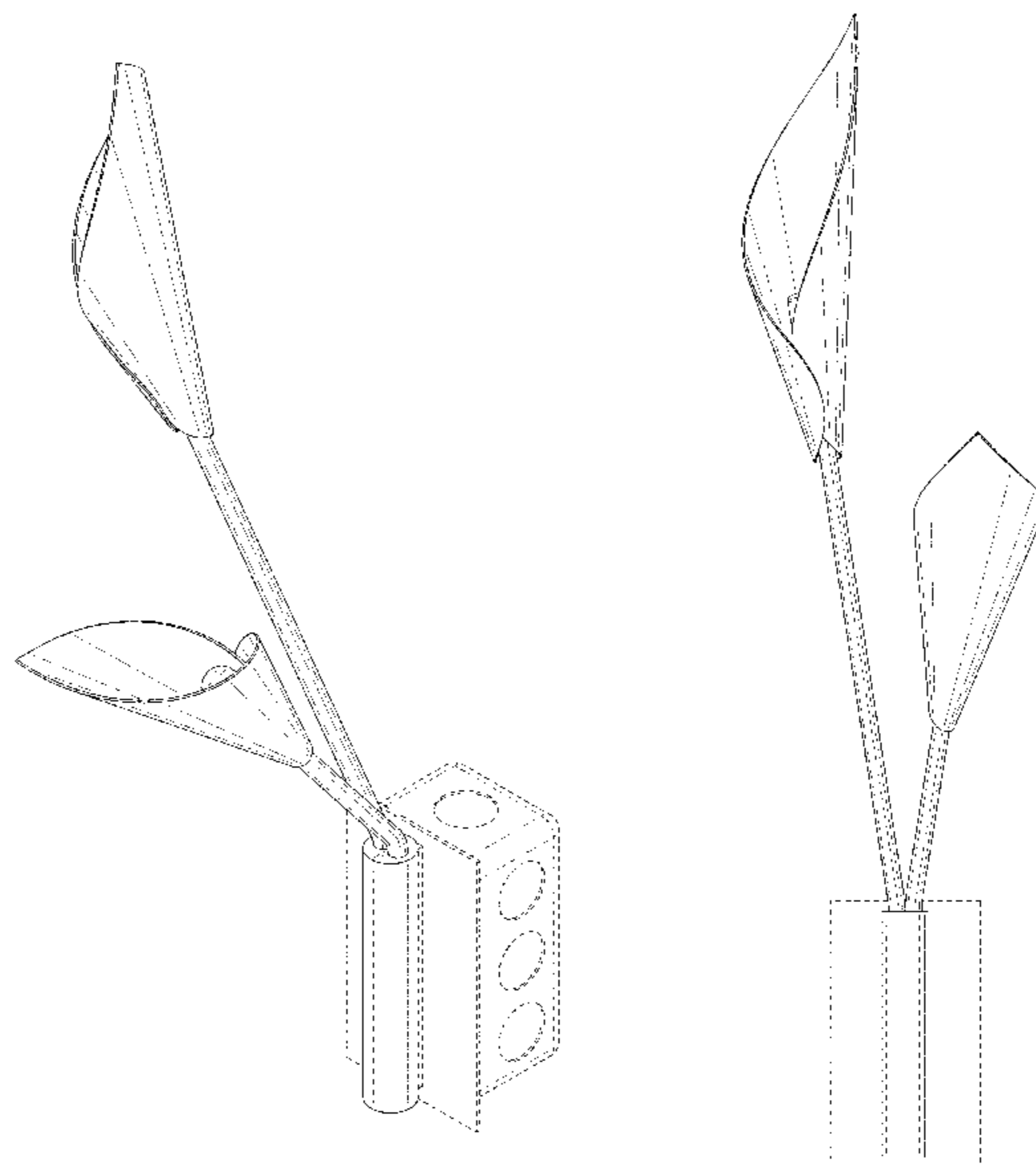
FIG. 5 is a fourth side elevational view thereof;

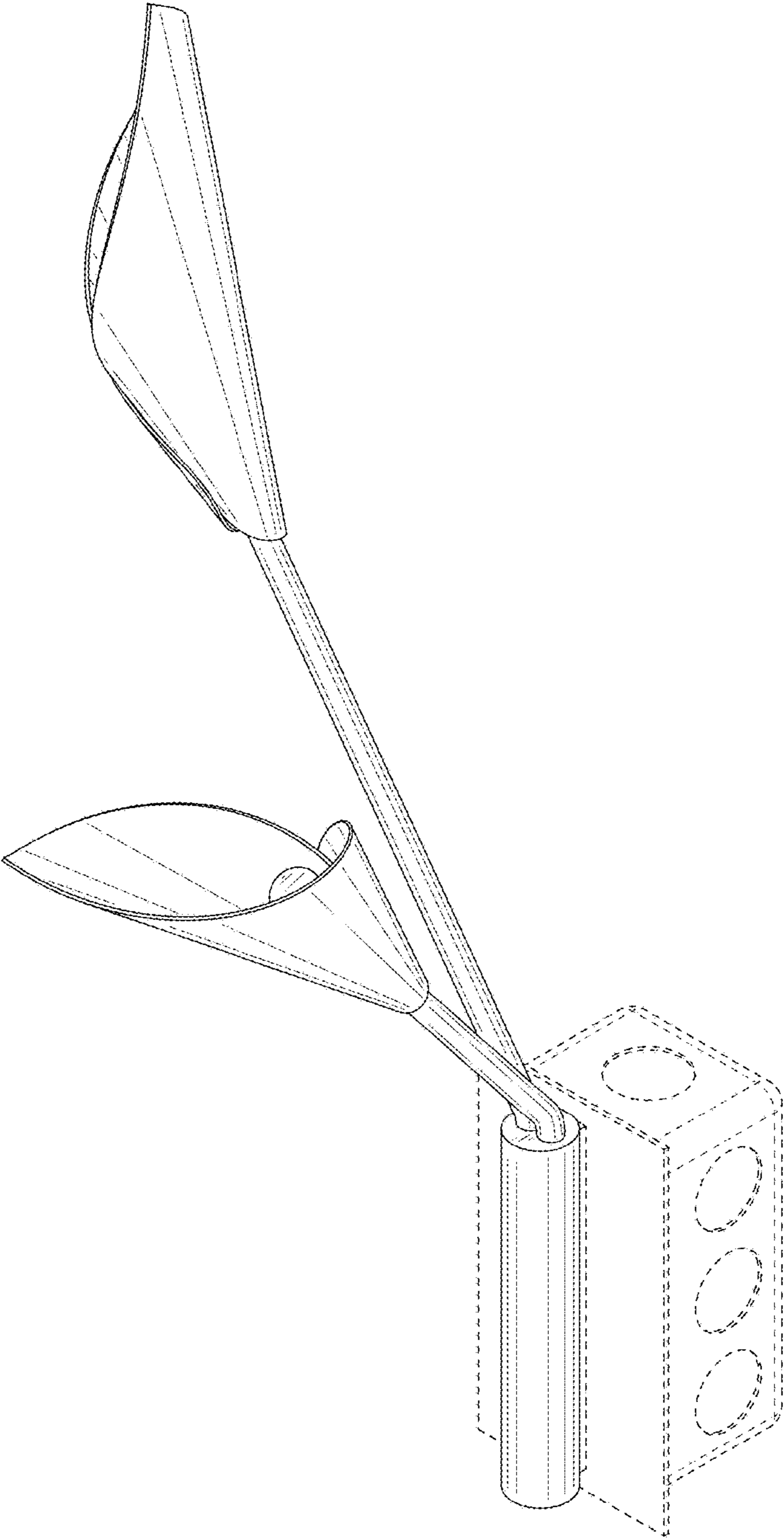

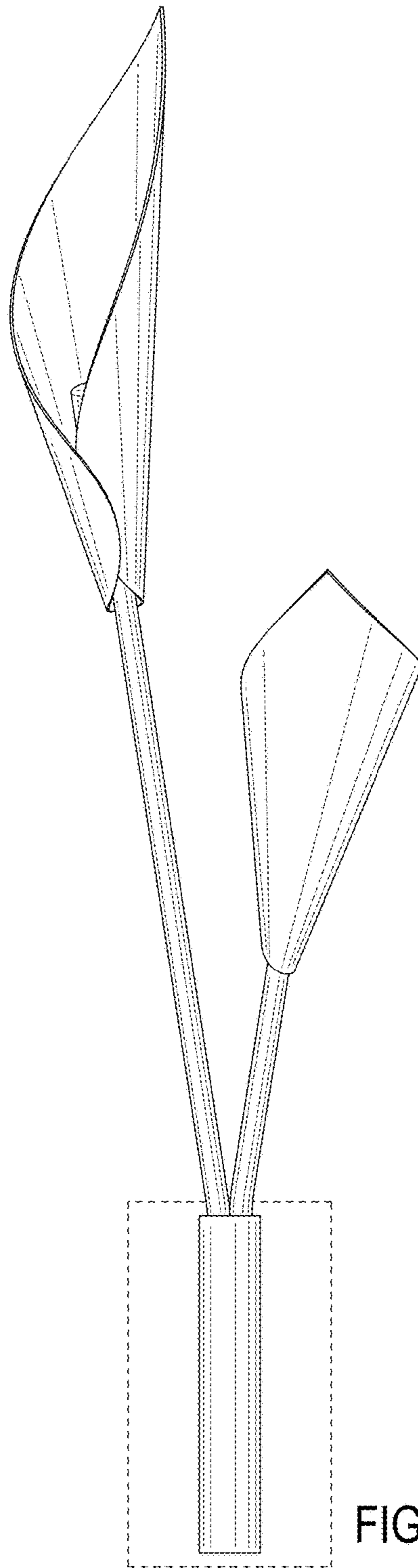

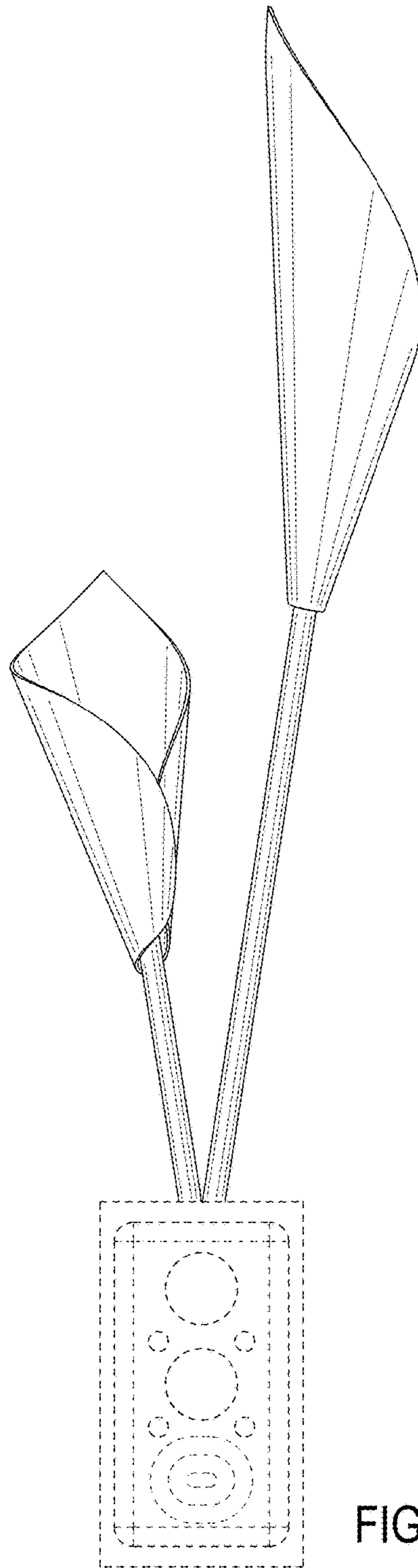
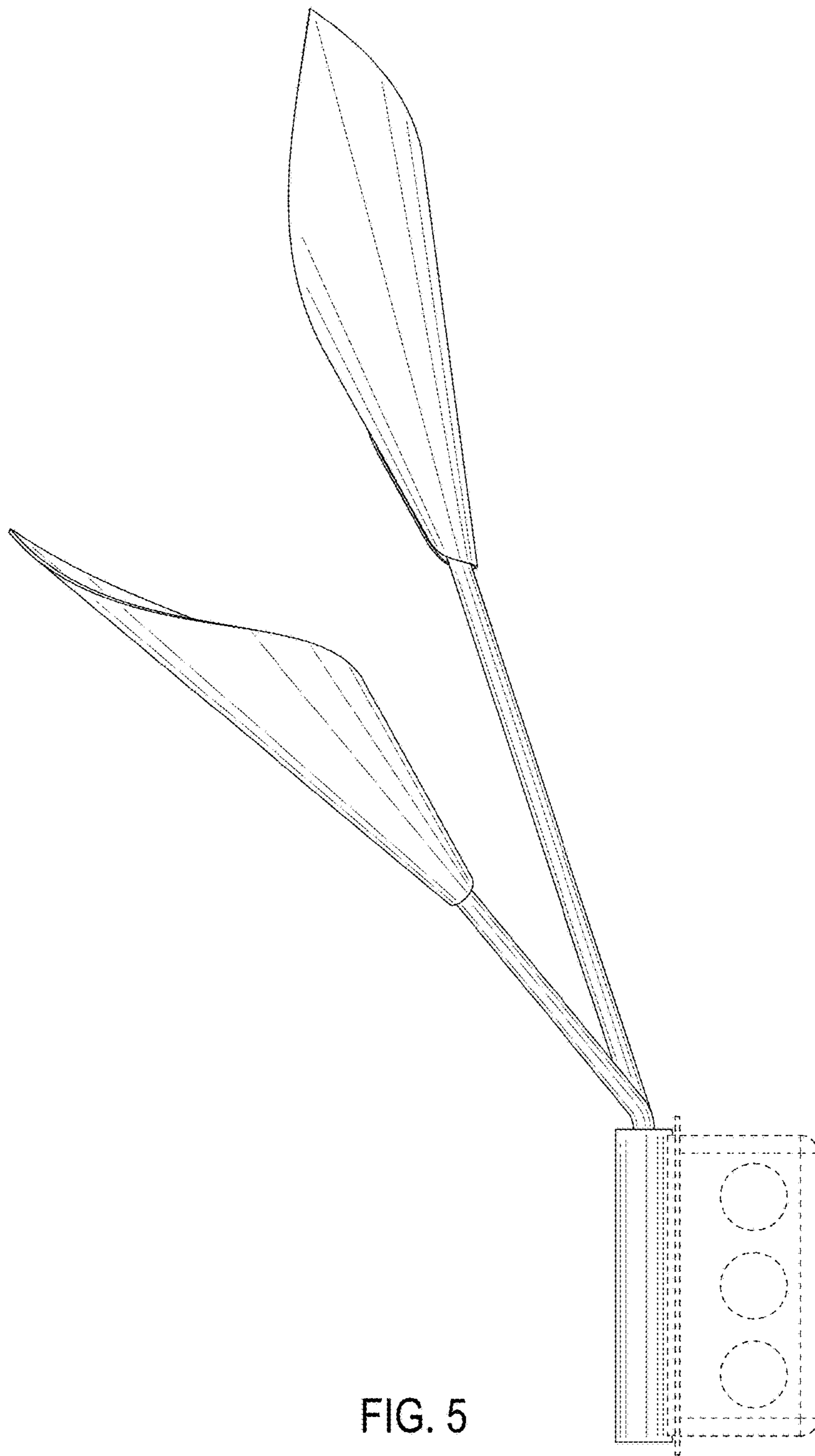

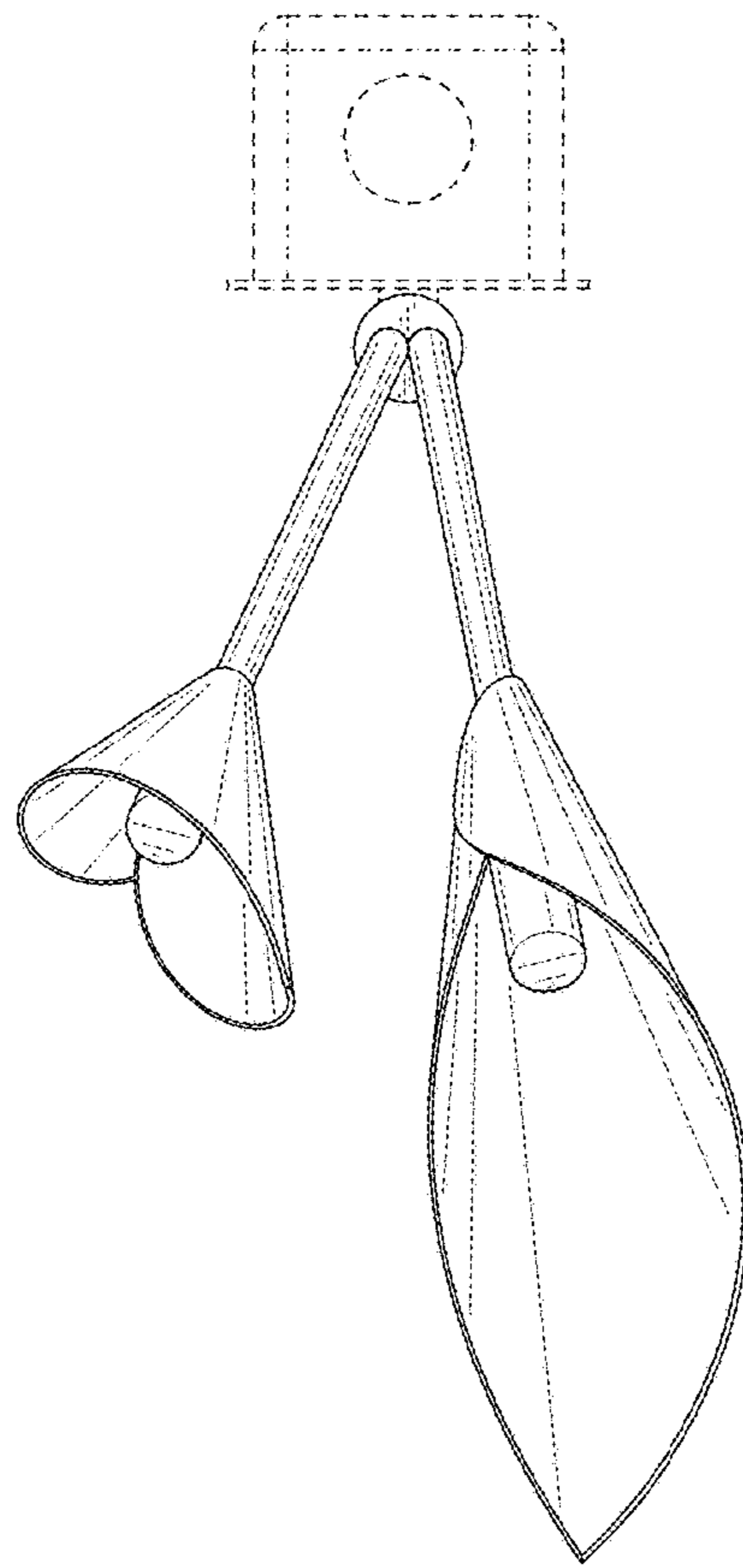

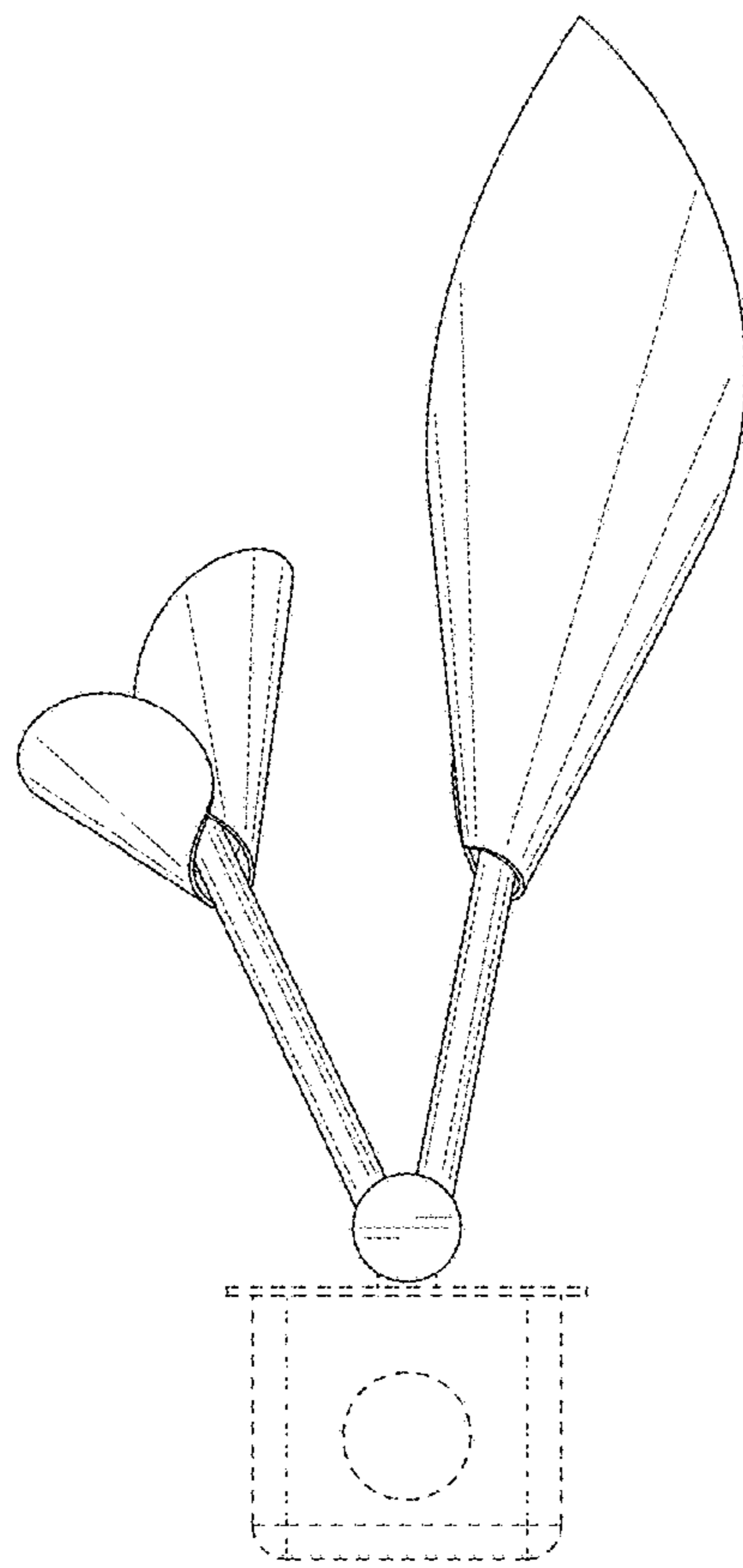
