FIG. 1 is a bottom perspective view of a glove showing my new design;

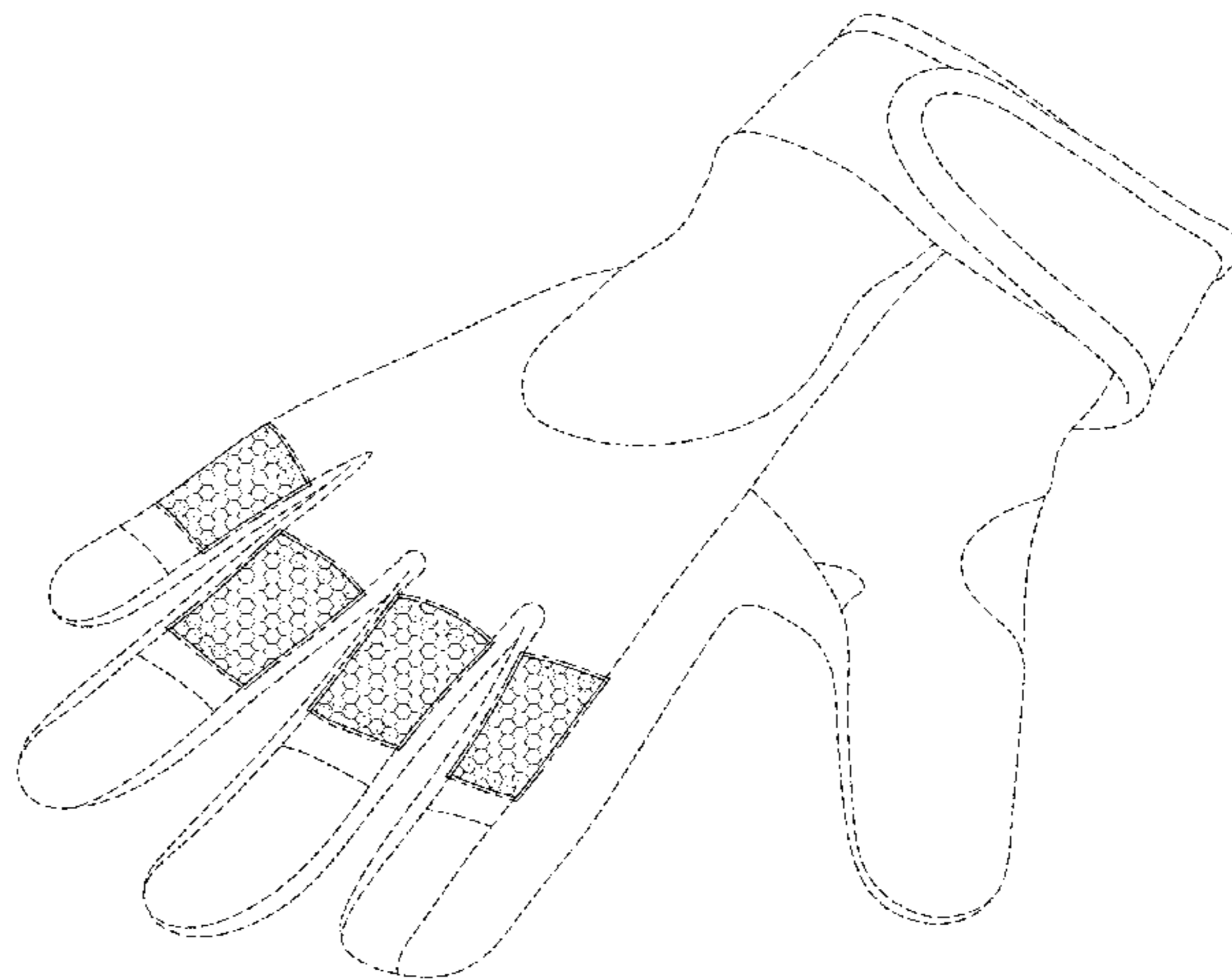
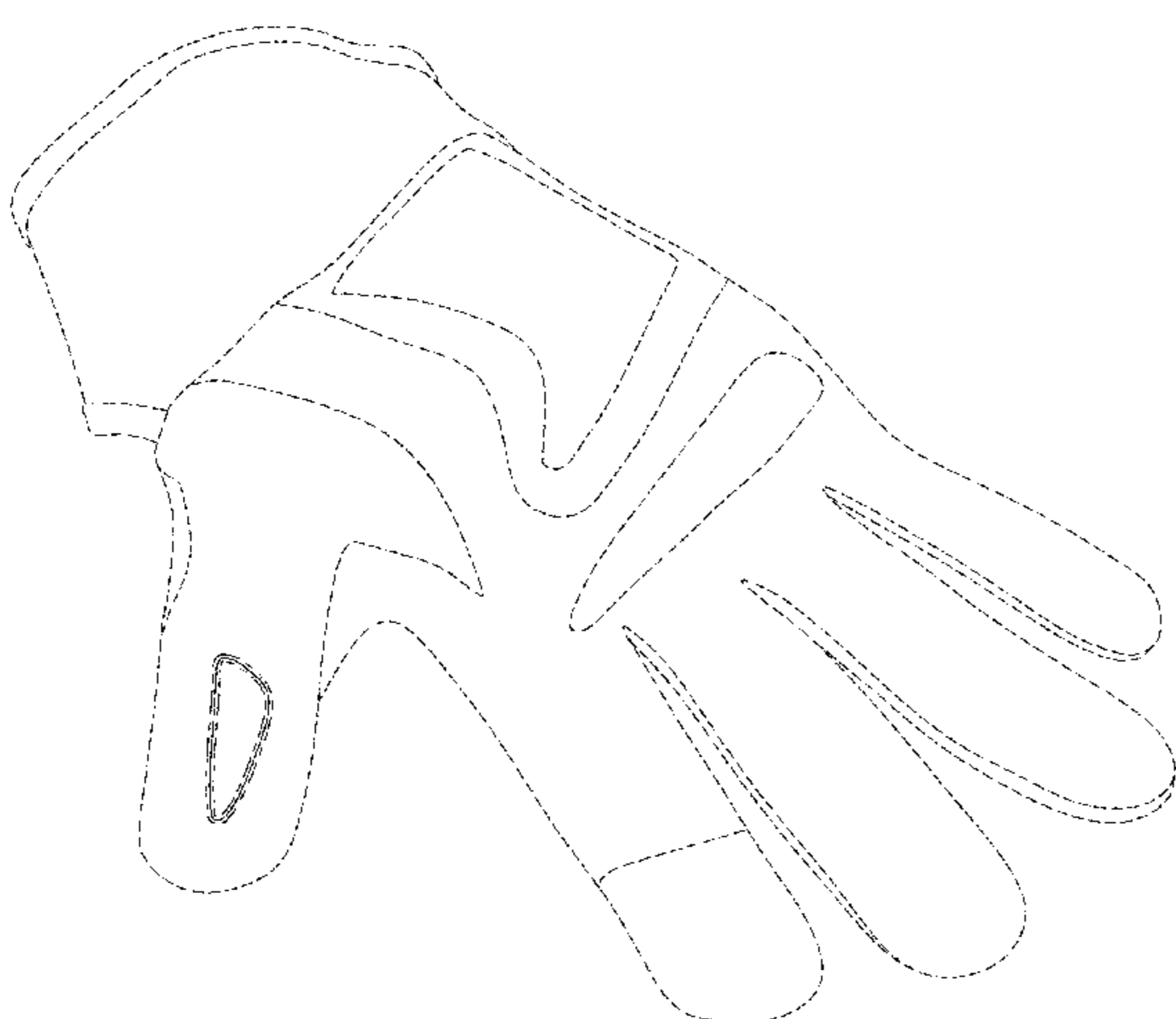
FIG. 2 is a bottom plan view thereof;

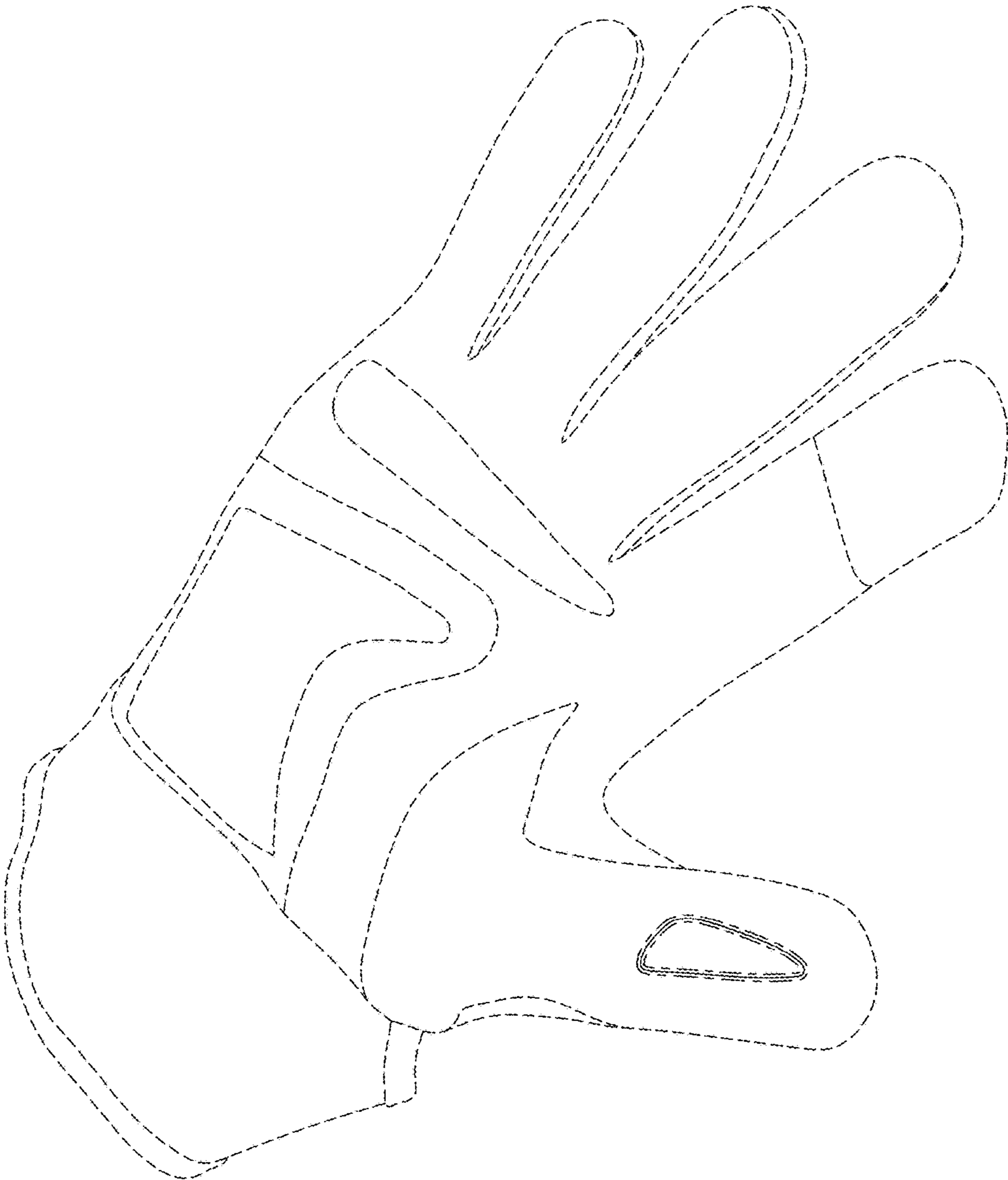

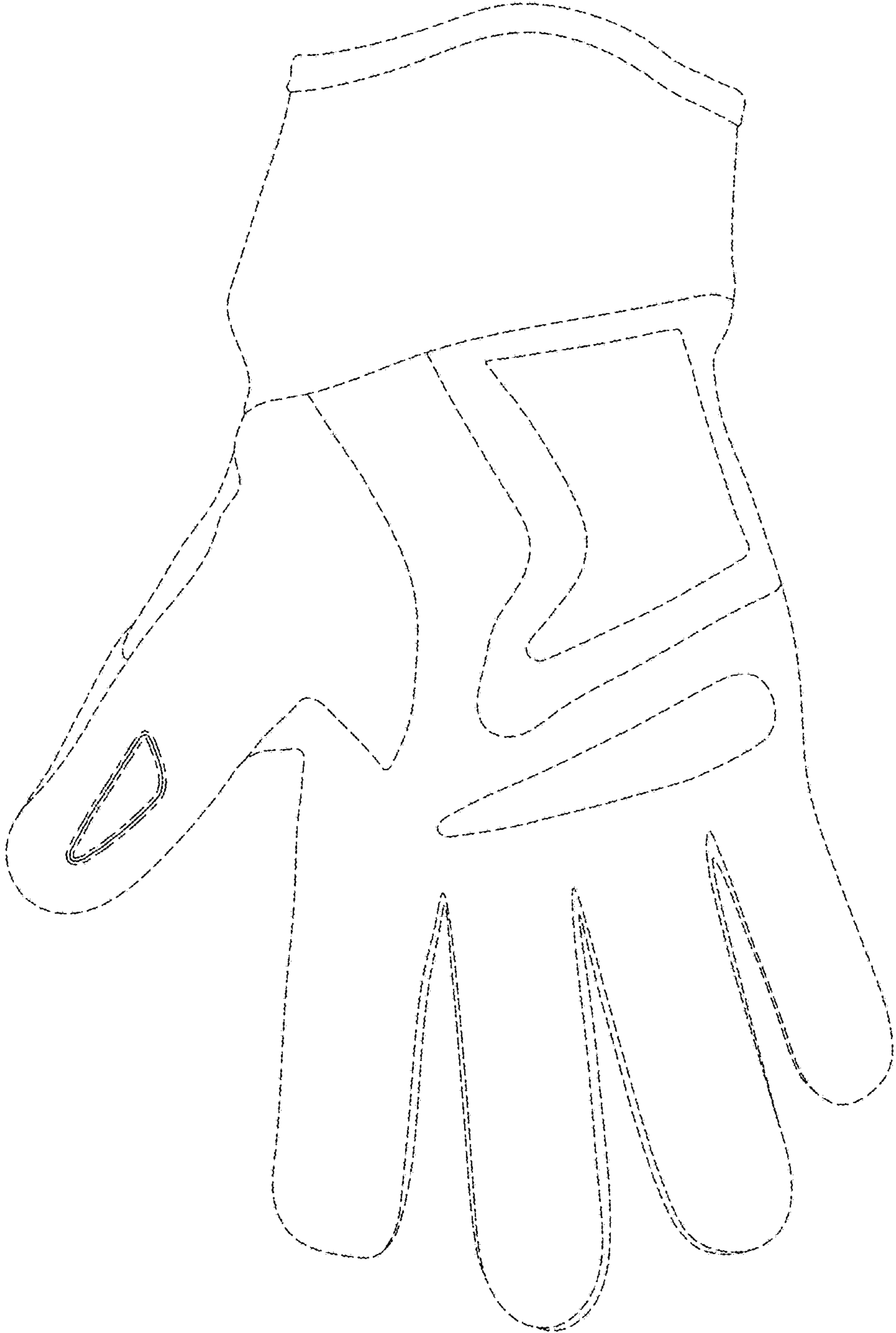

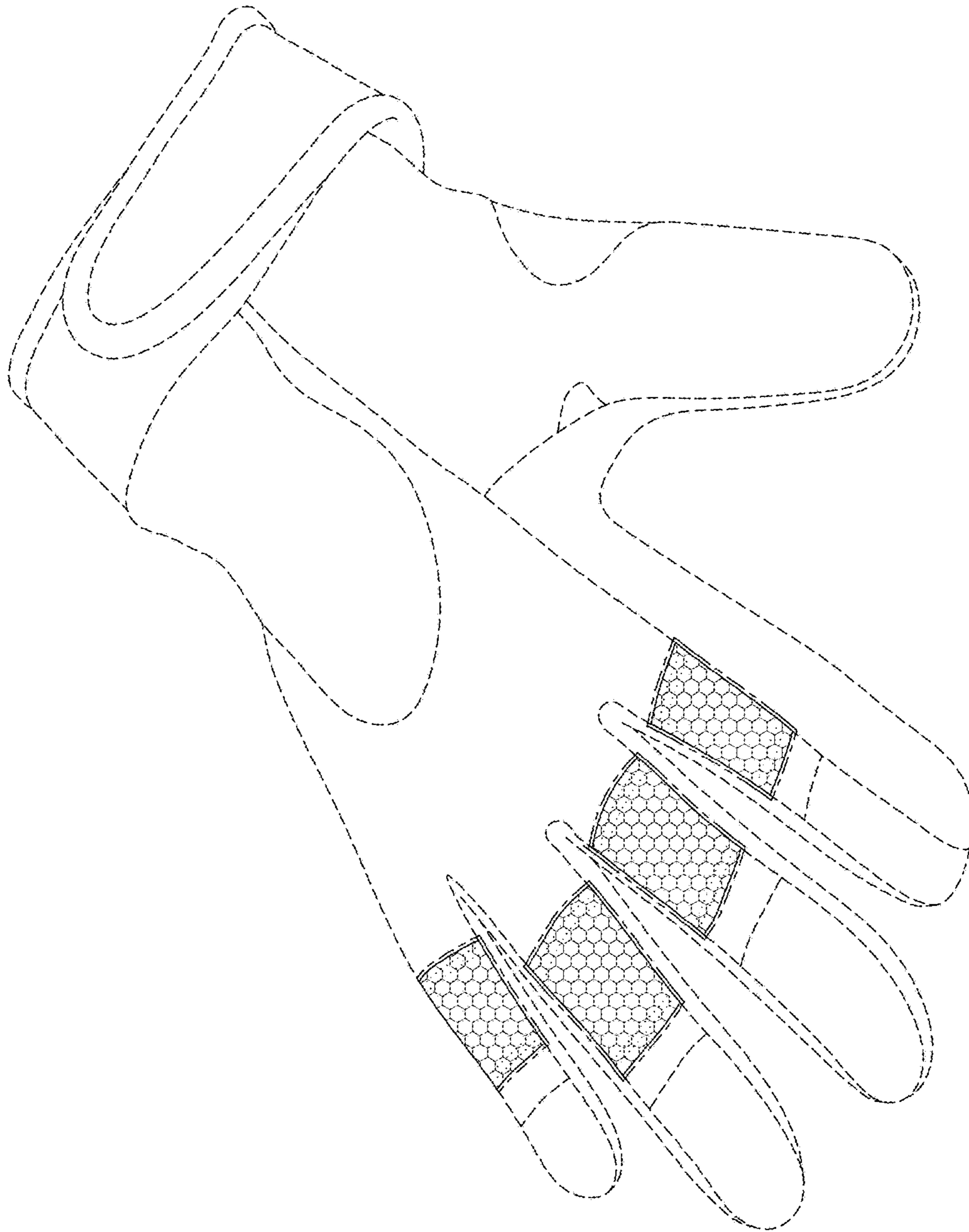

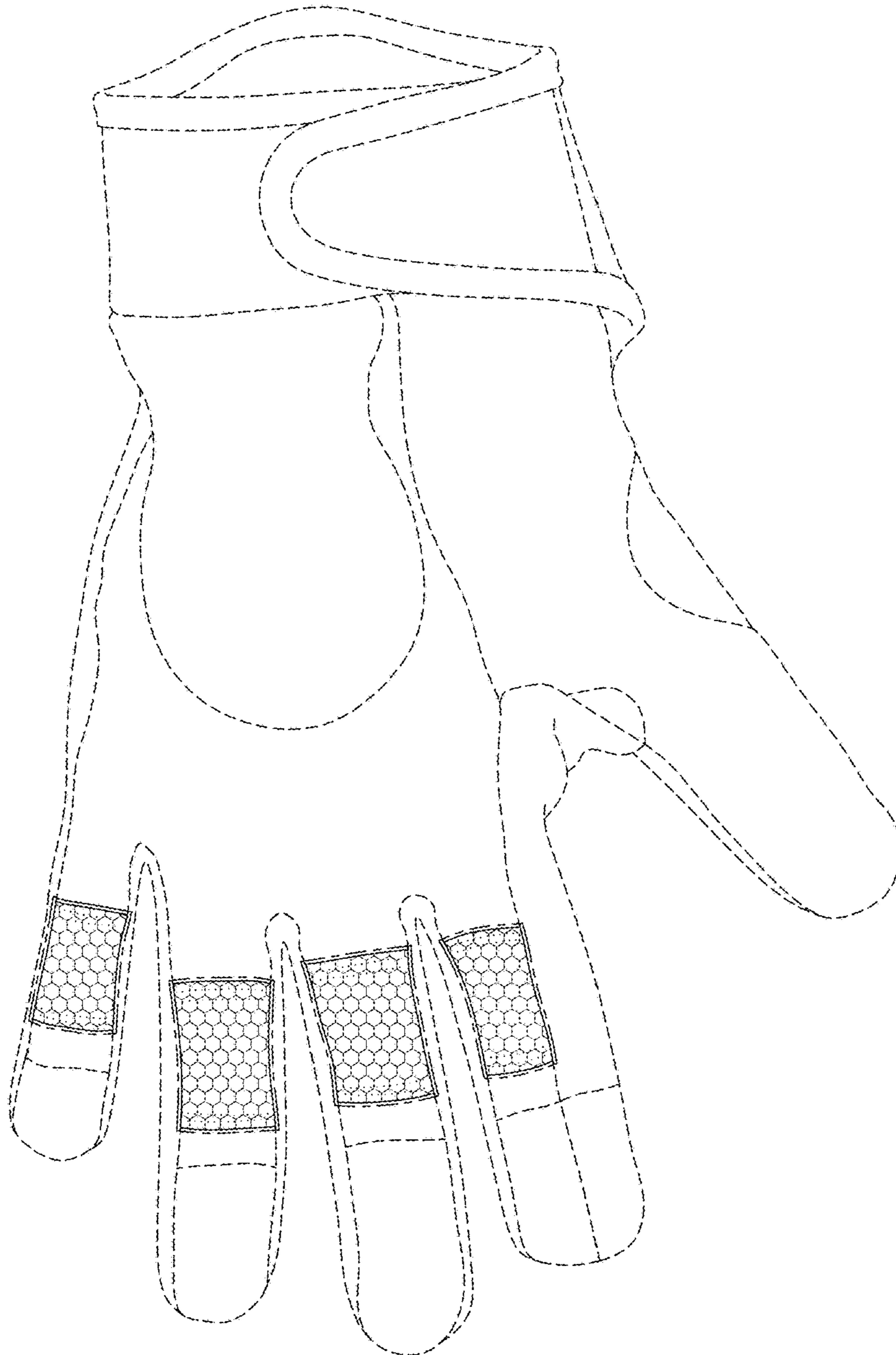
