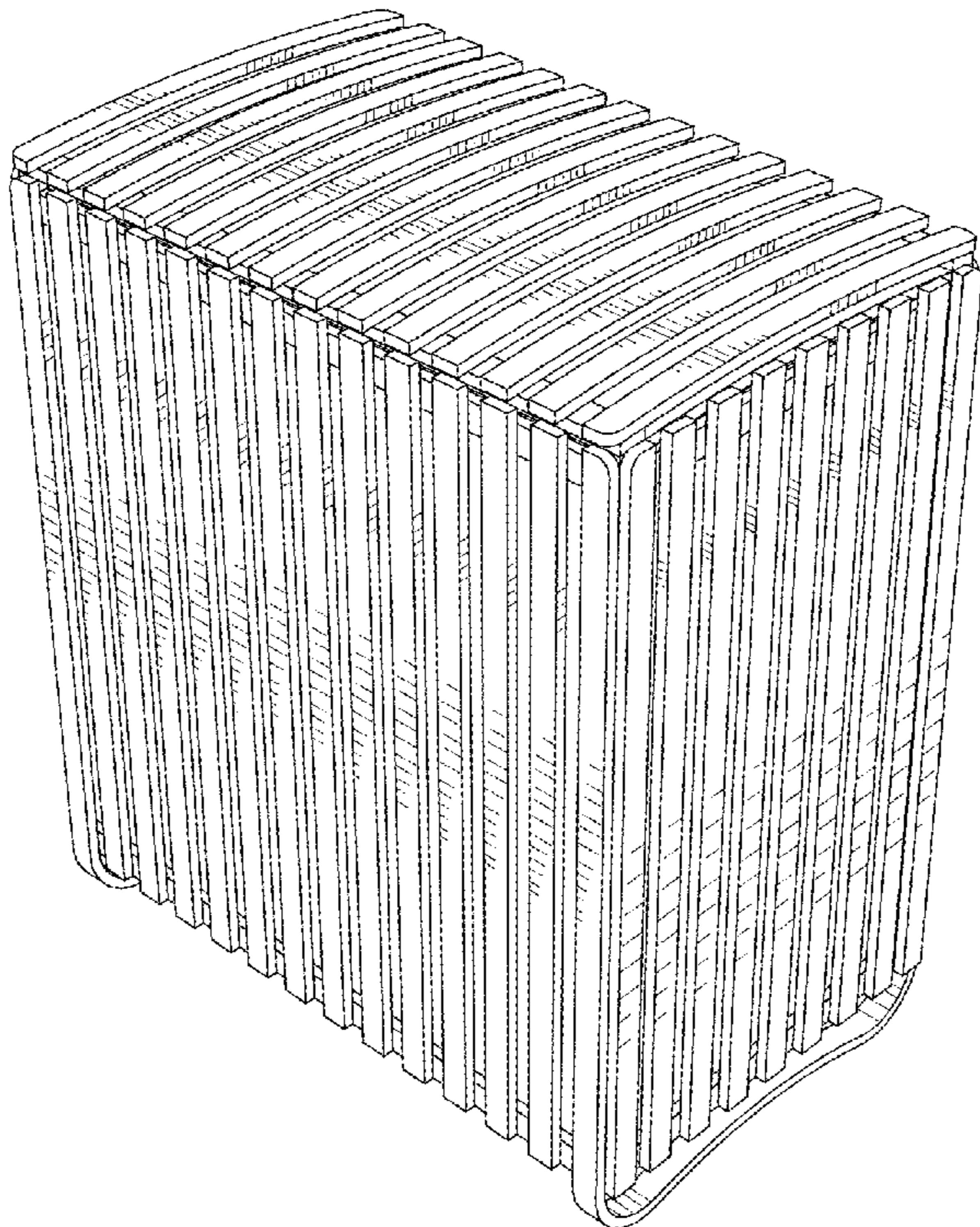

DESCRIPTION
FIG. 1 is a front perspective view of a laundry basket showing my new design;

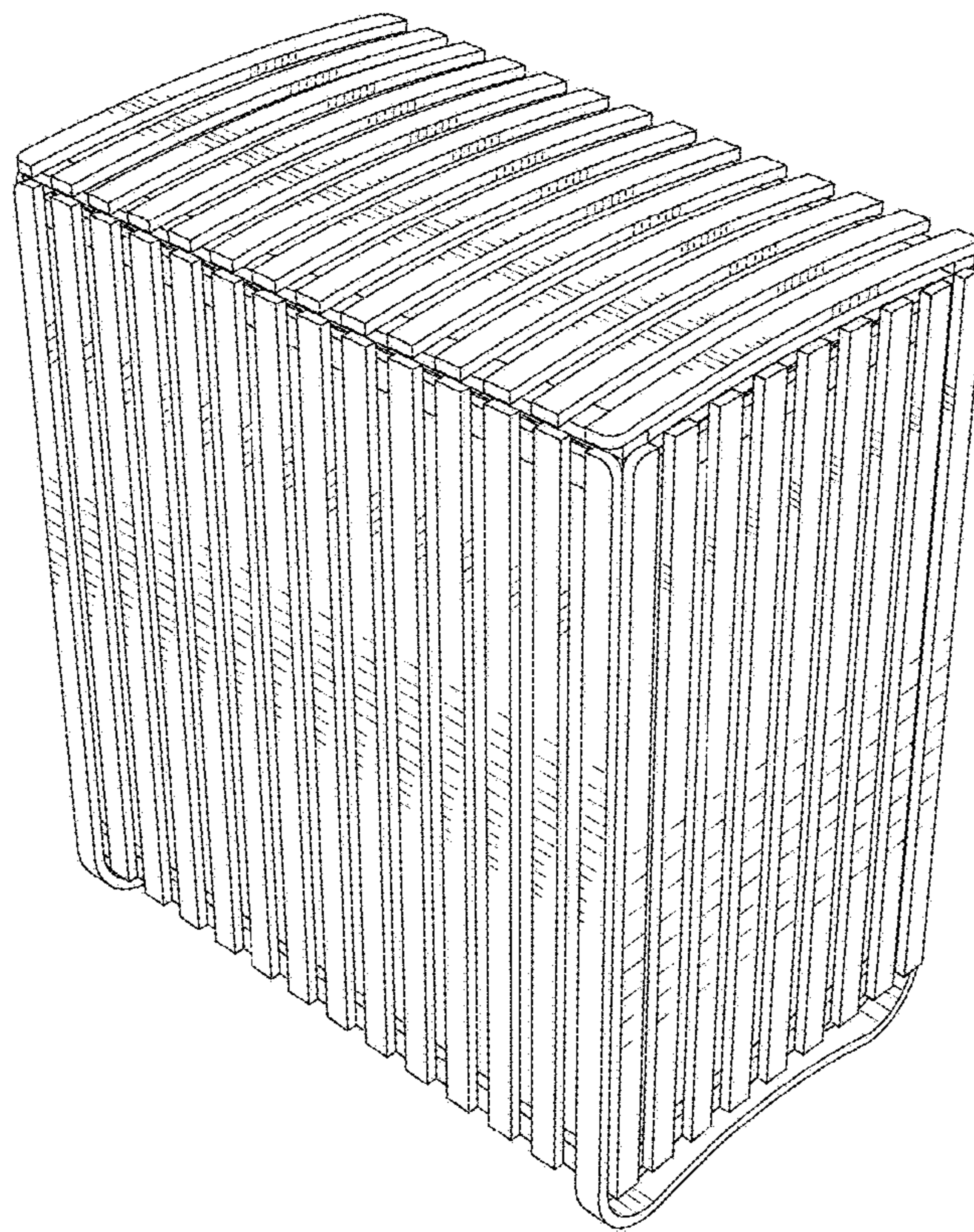

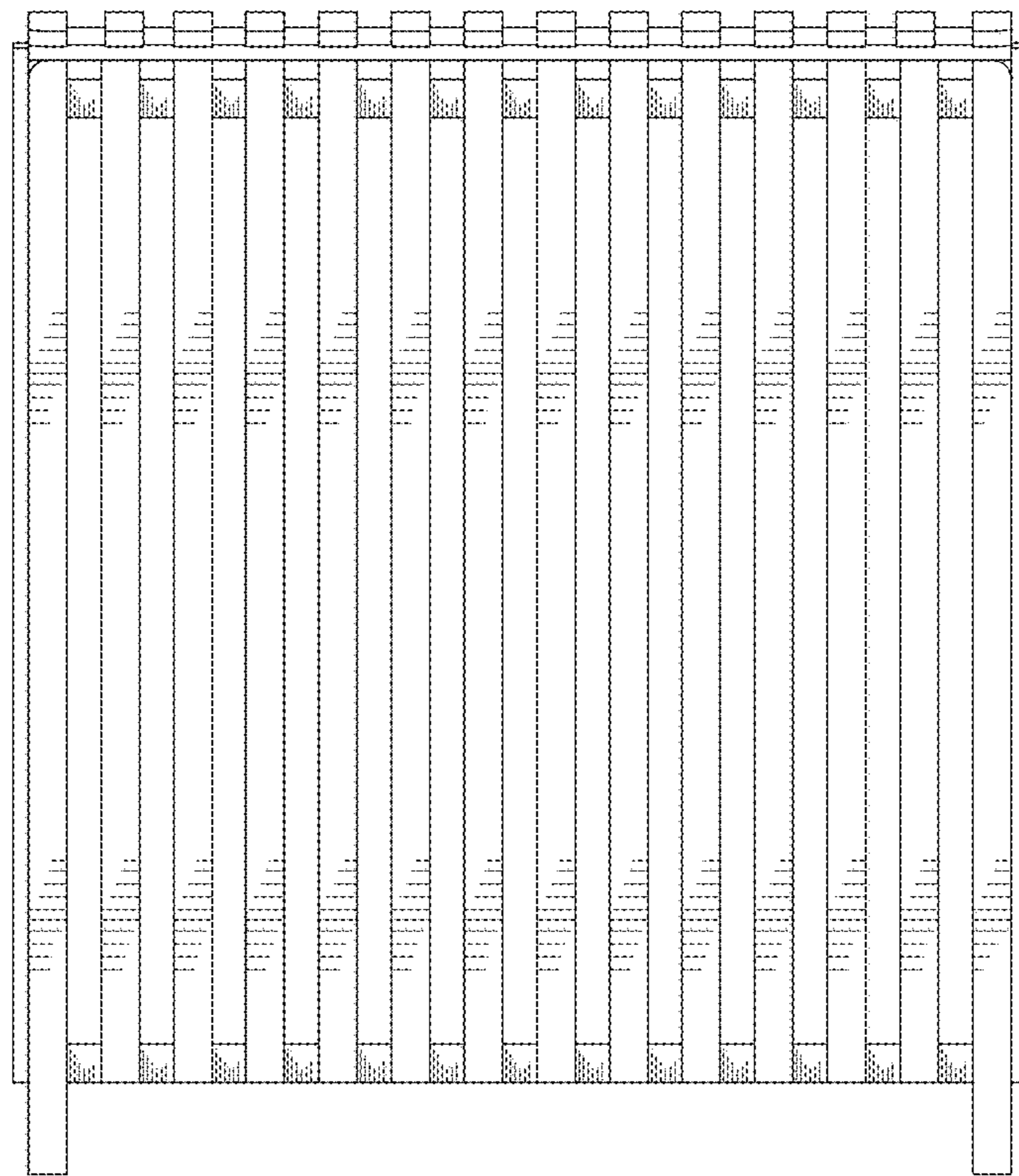

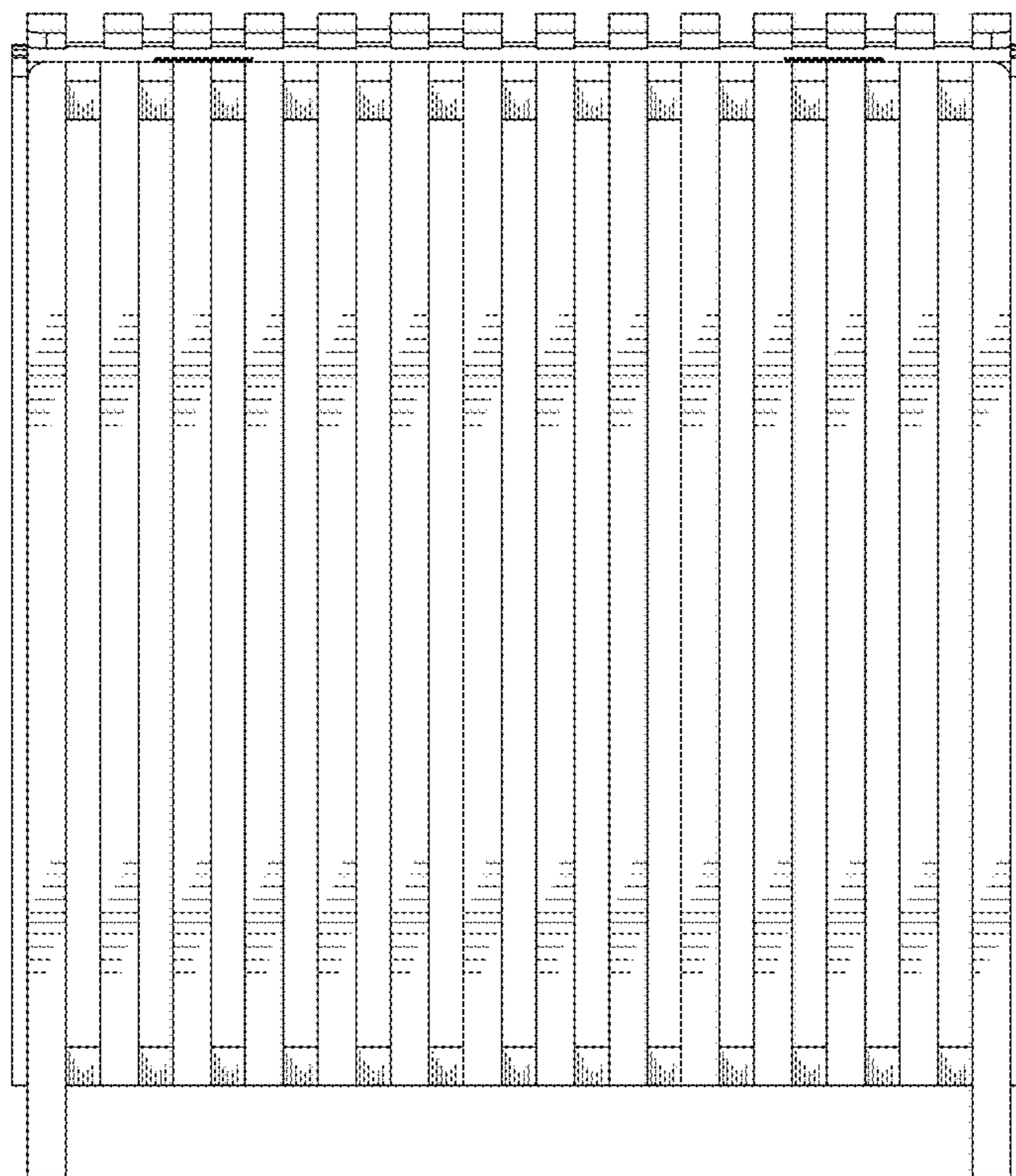

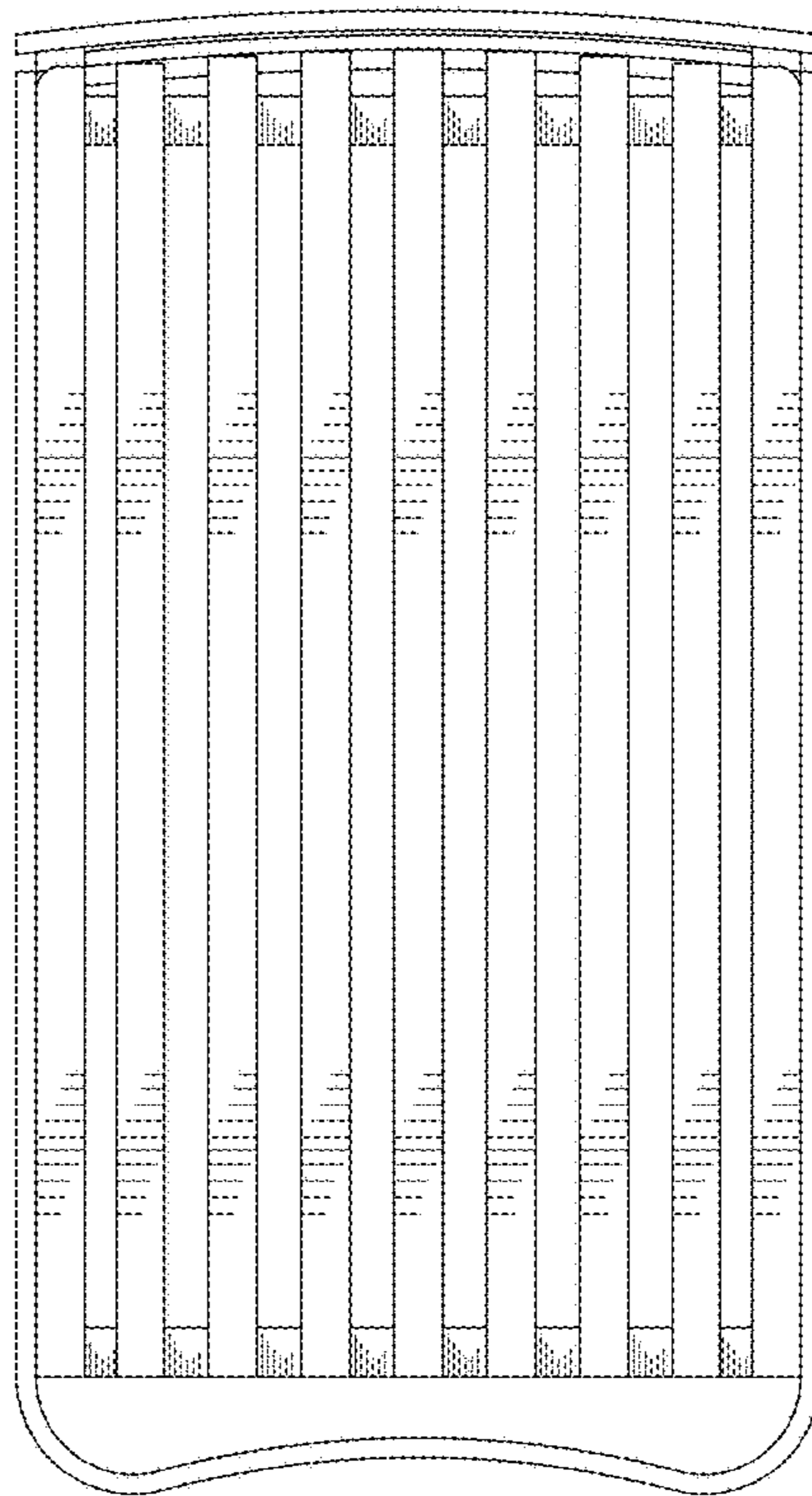

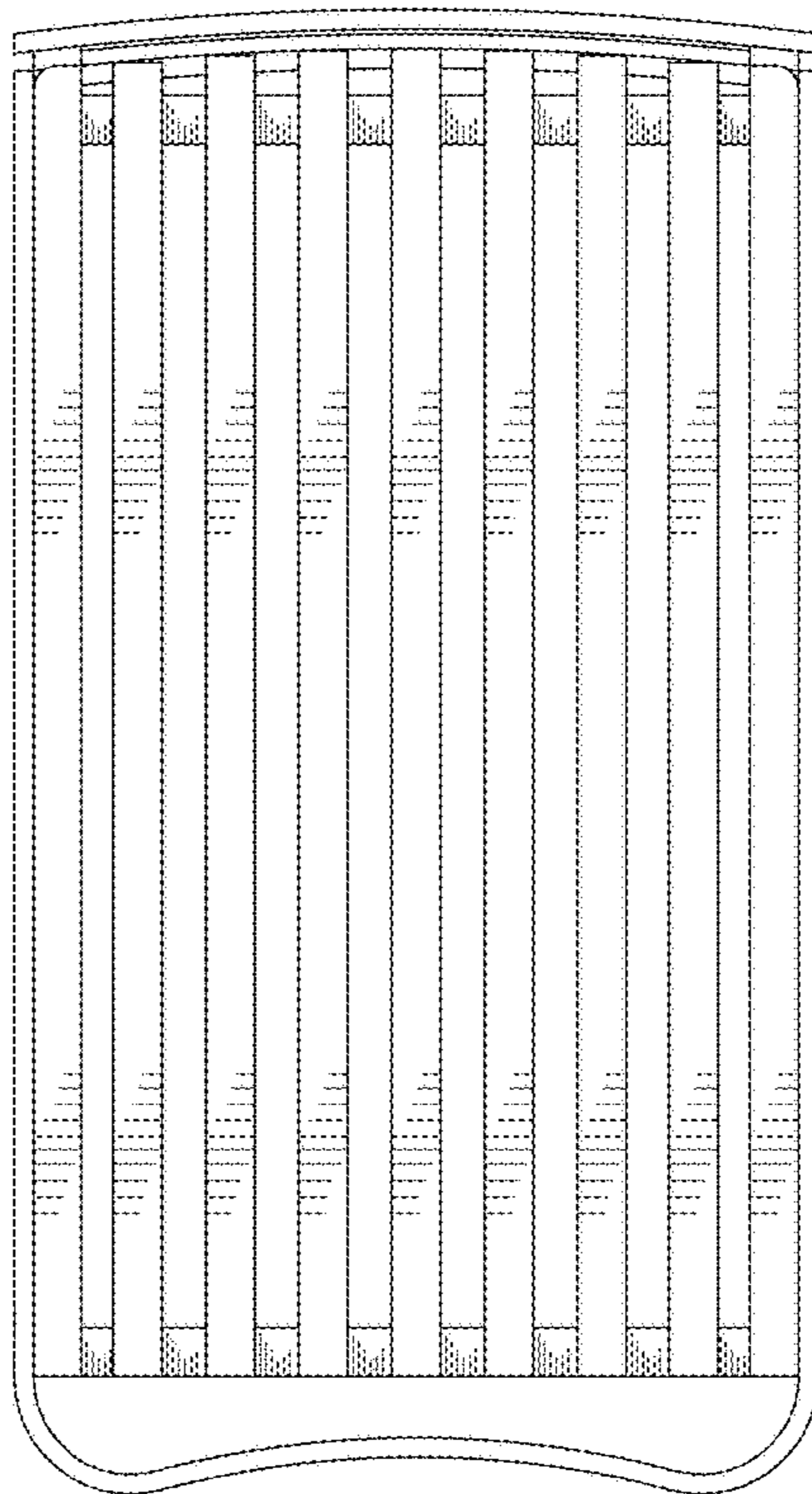

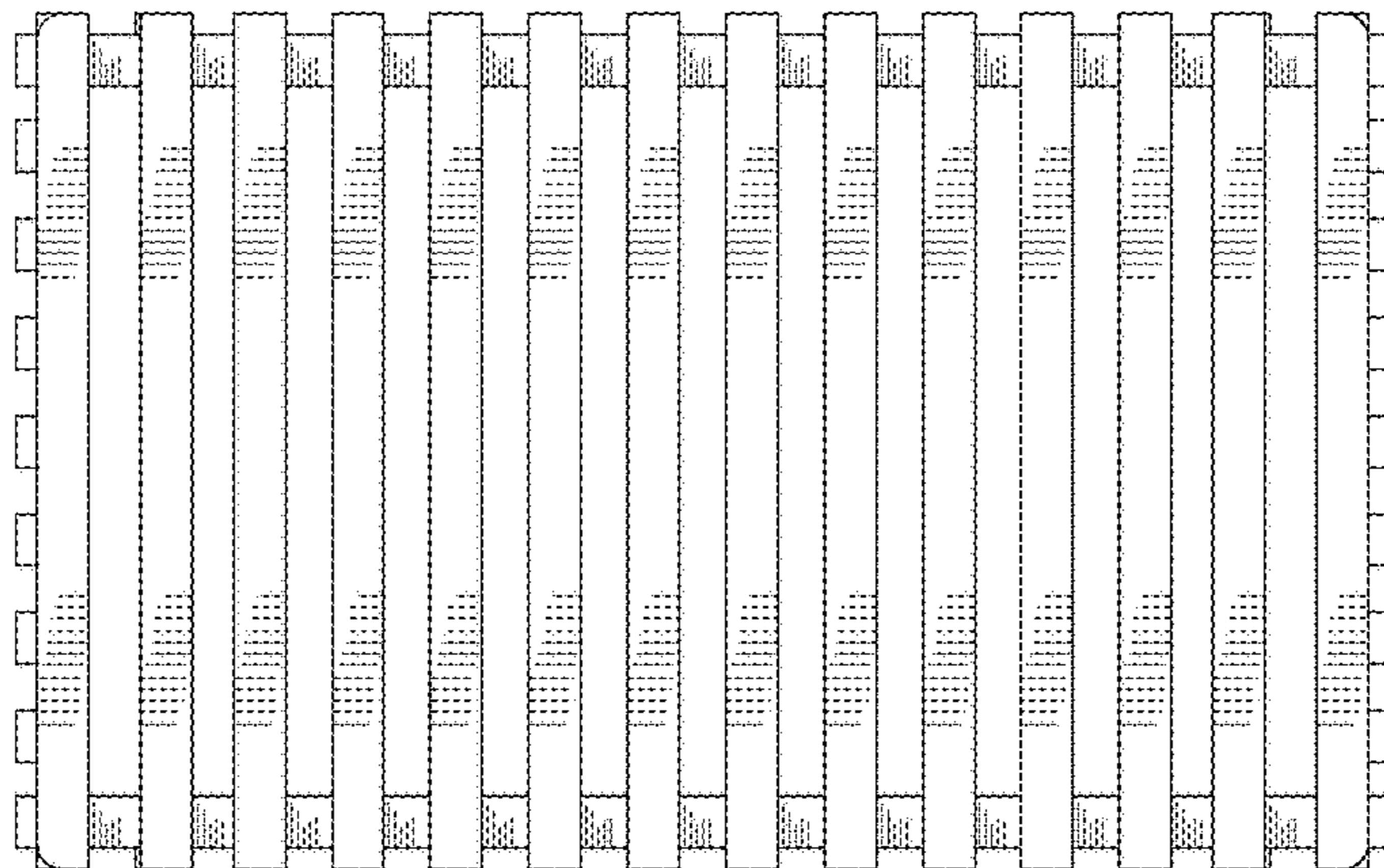

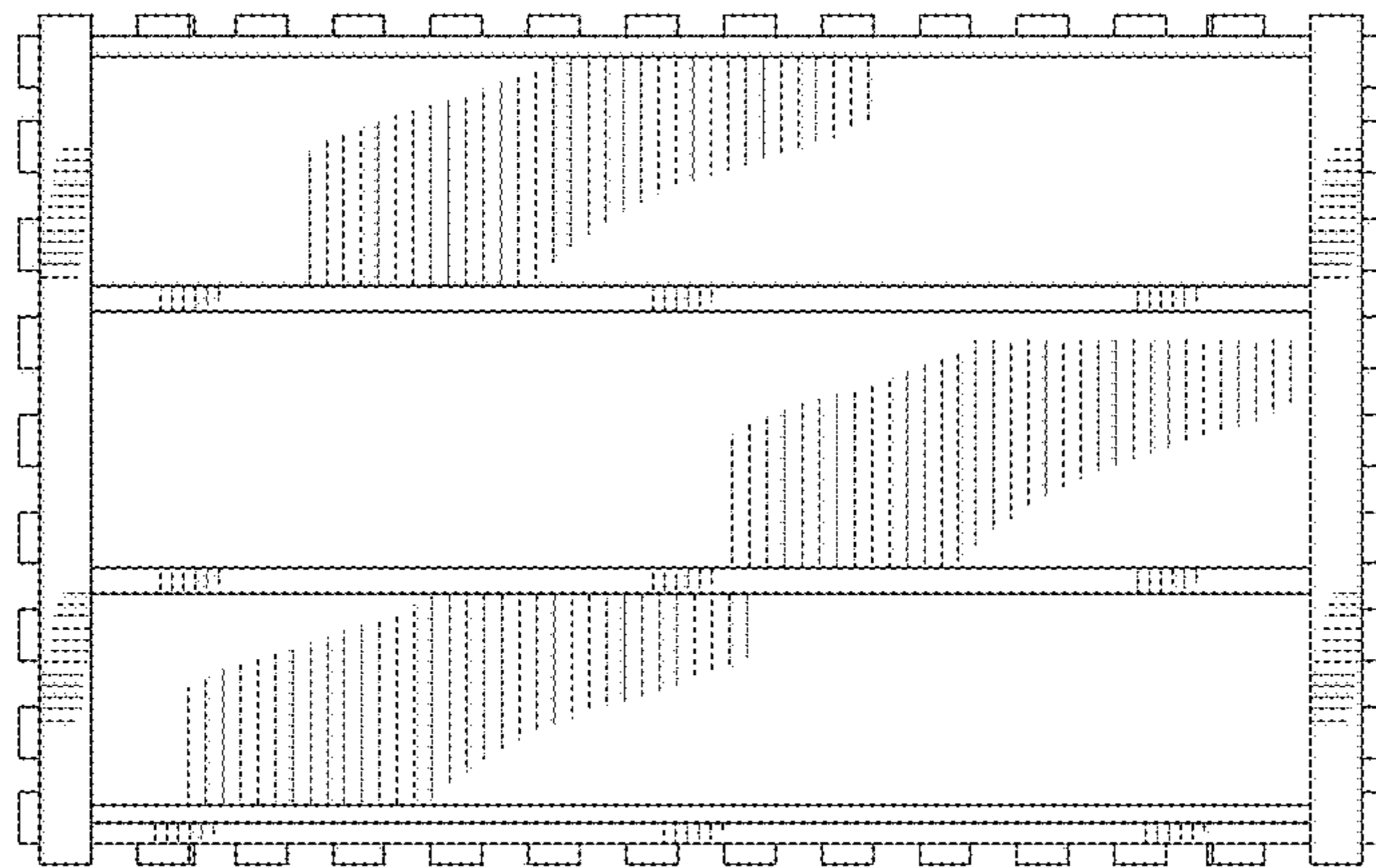

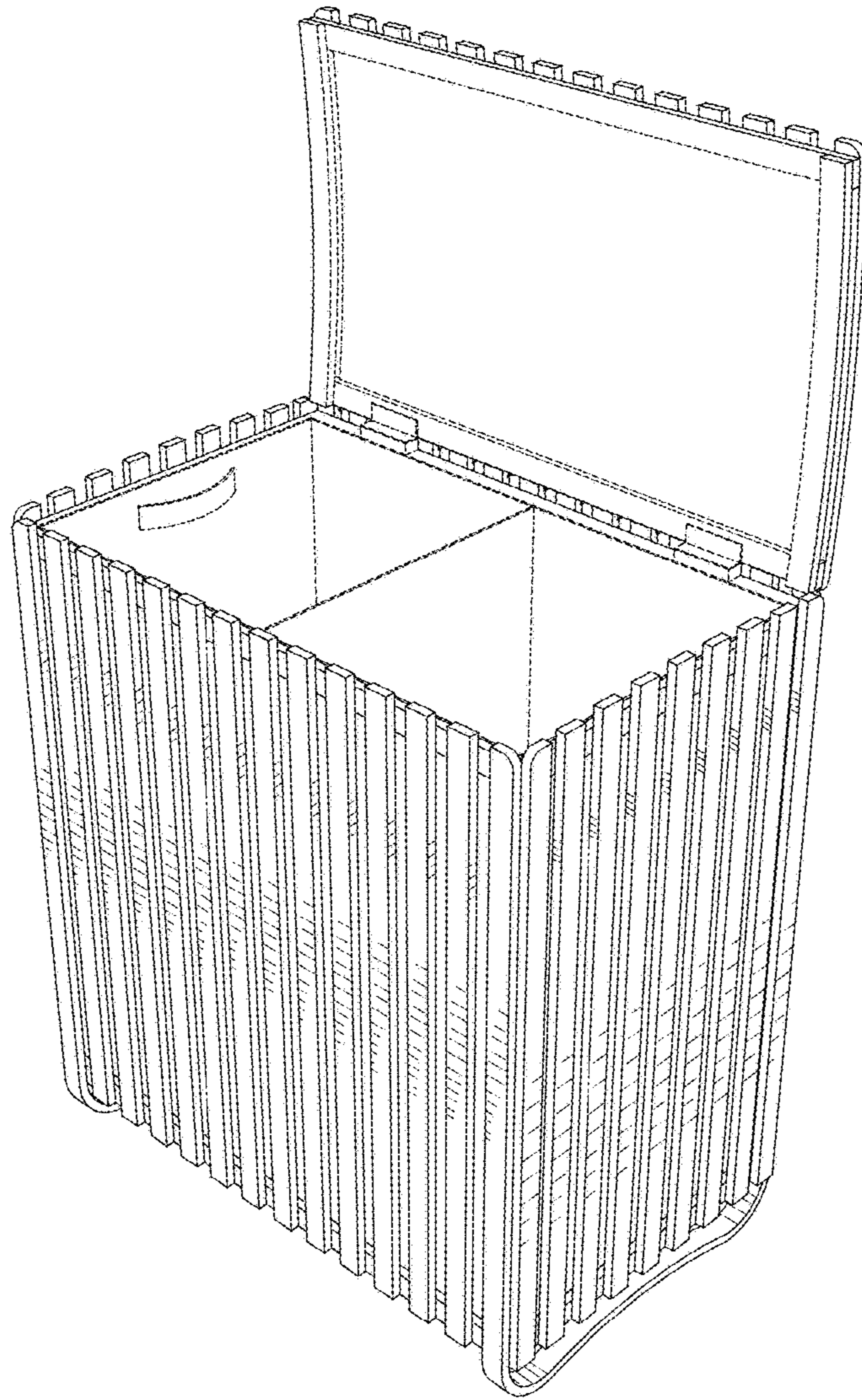

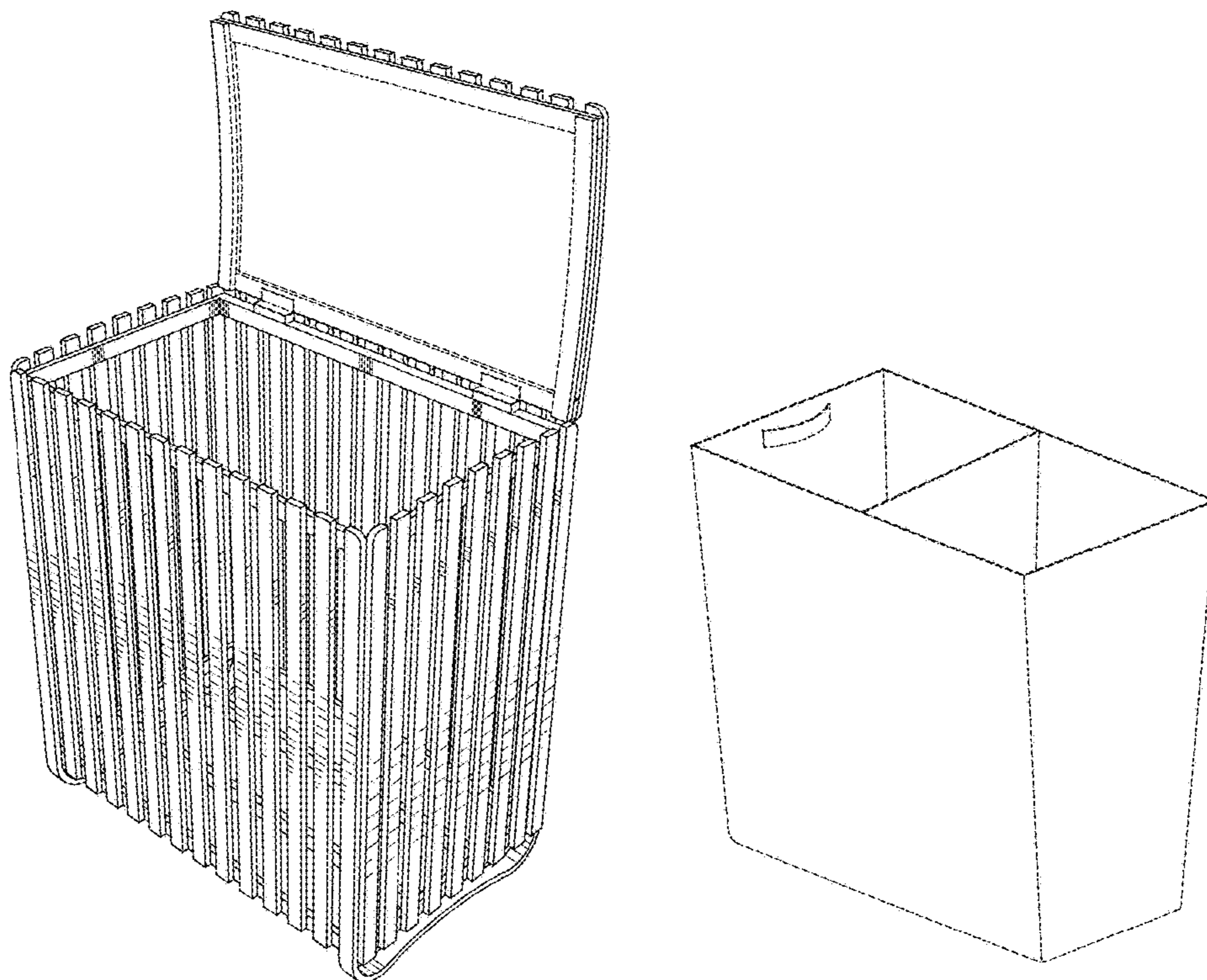
