**DESCRIPTION**

FIG. 1 is a front perspective view of apparel, showing my new design.  
FIG. 2 is a front view of the apparel of FIG. 1.  
FIG. 3 is a front perspective view of an alternative embodiment of apparel of the present invention.  
FIG. 4 is a front view of the apparel of FIG. 3; and,  
FIG. 5 is a rear view of the apparel of FIG. 3.  
The short-short broken lines in FIGS. 1-5 represent stitching.

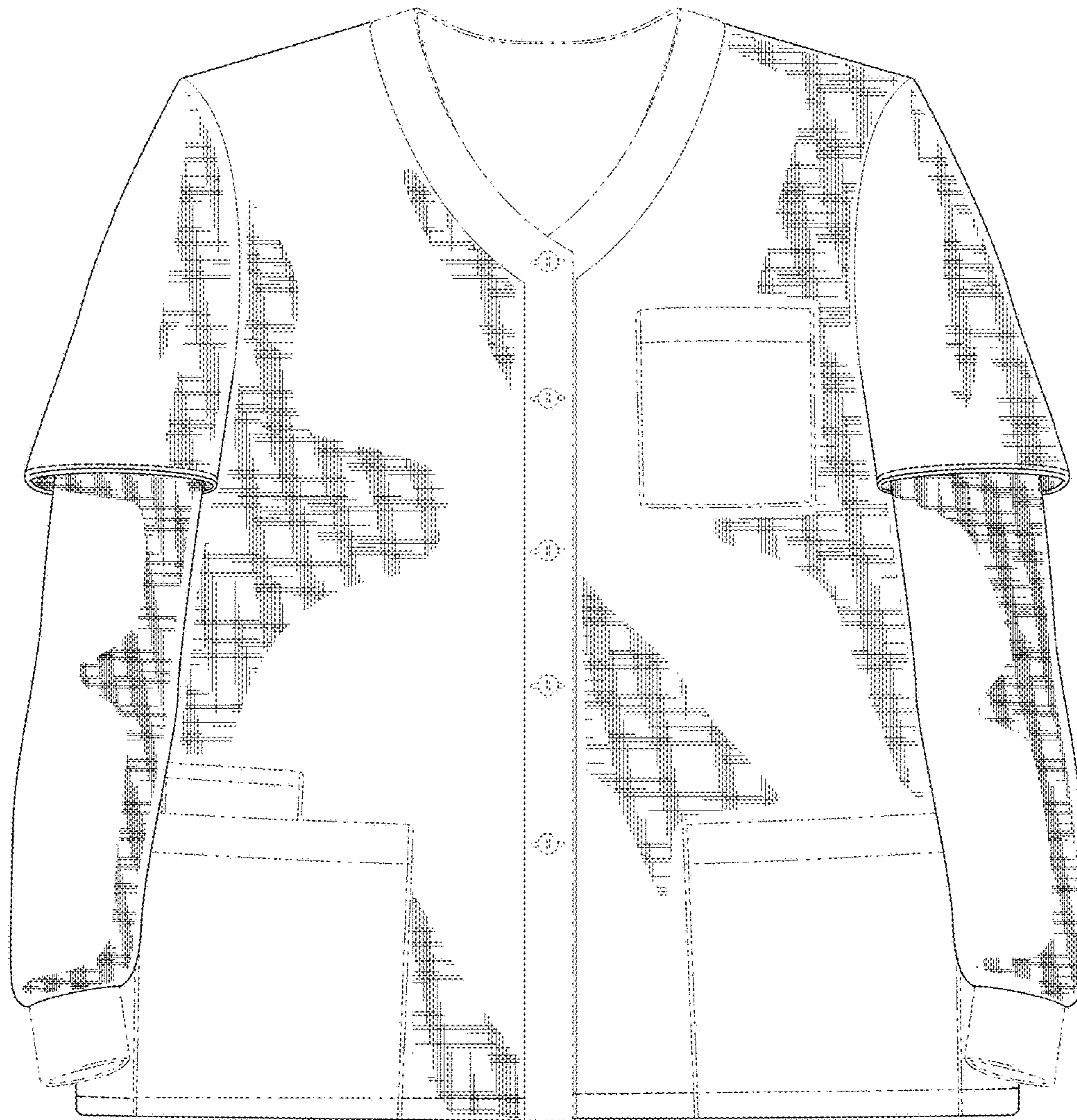

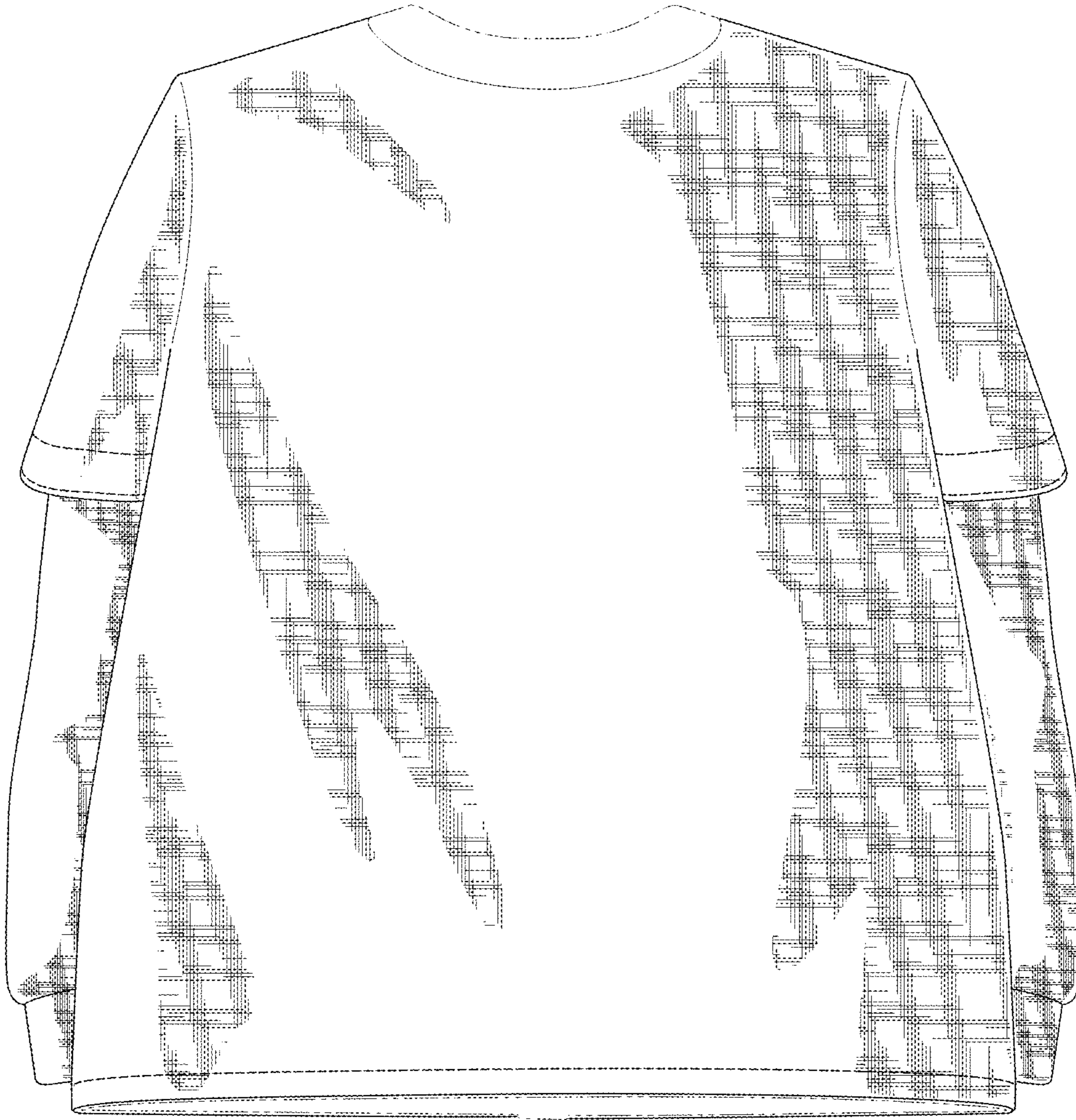
