The ornamental design for a shirt with different colored sleeves, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shirt having a left cap sleeve and no right sleeve and a right border, showing my new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a front elevational view thereof;

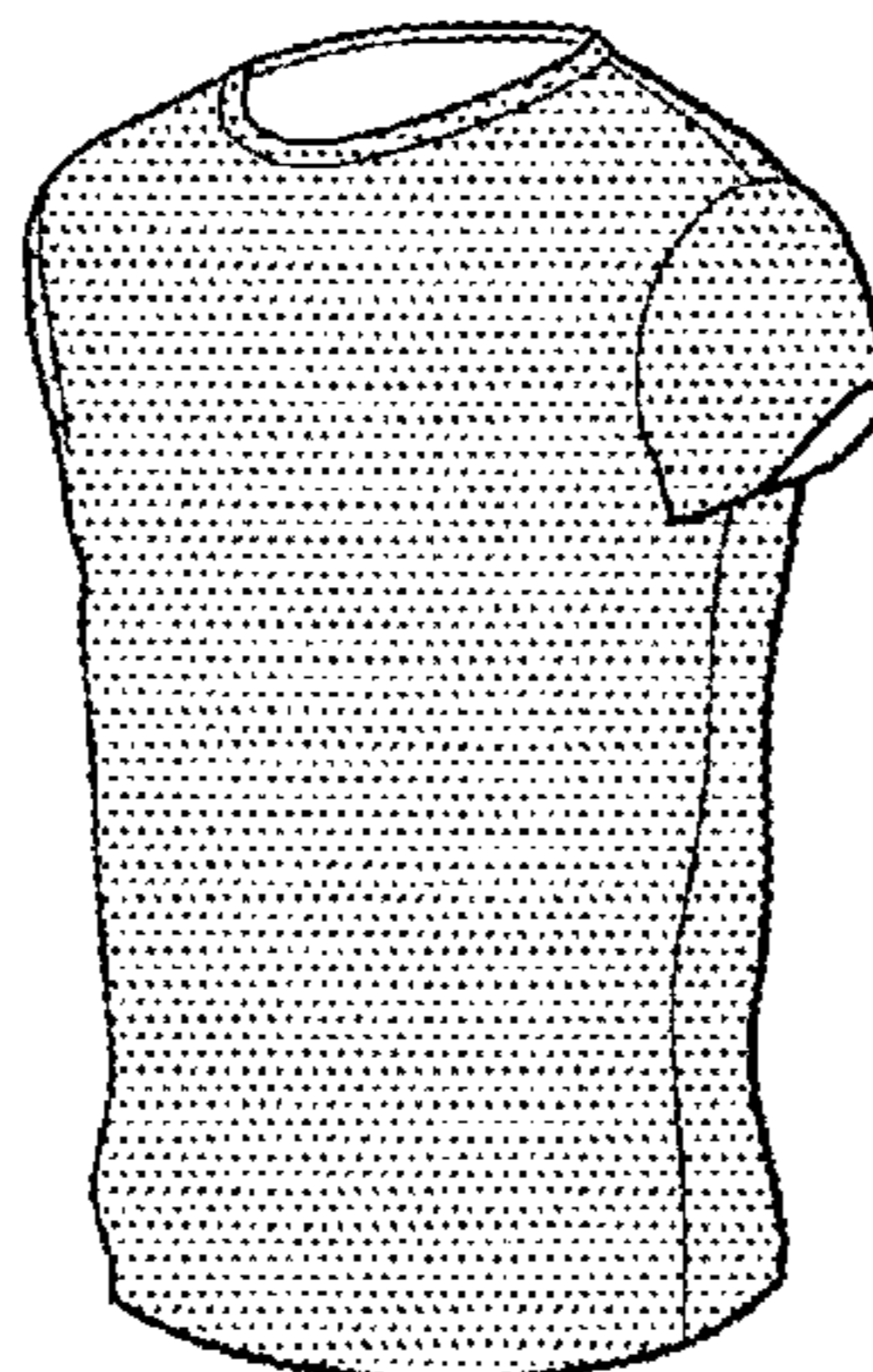
FIG. 6 is a rear elevational view thereof;

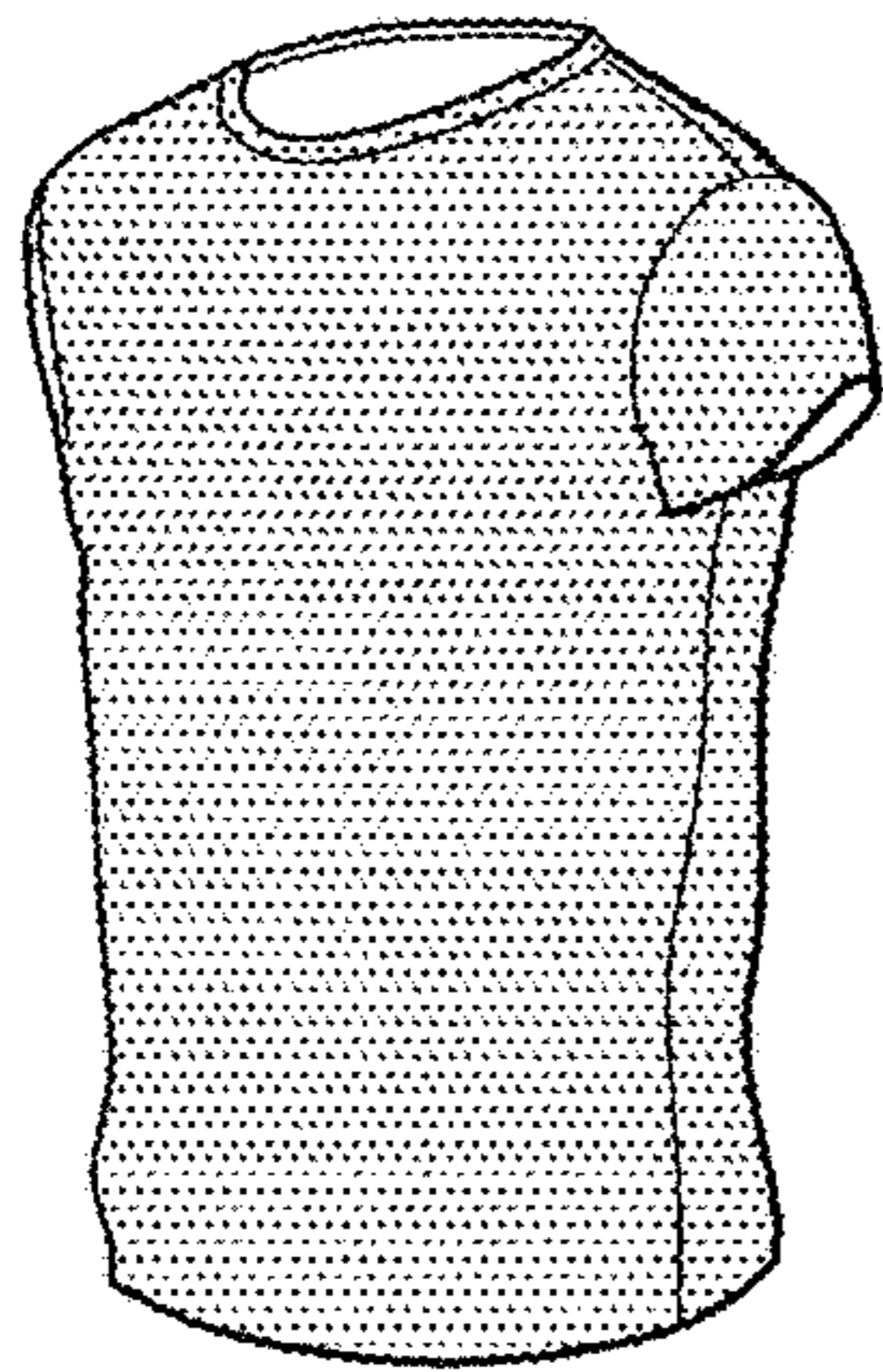

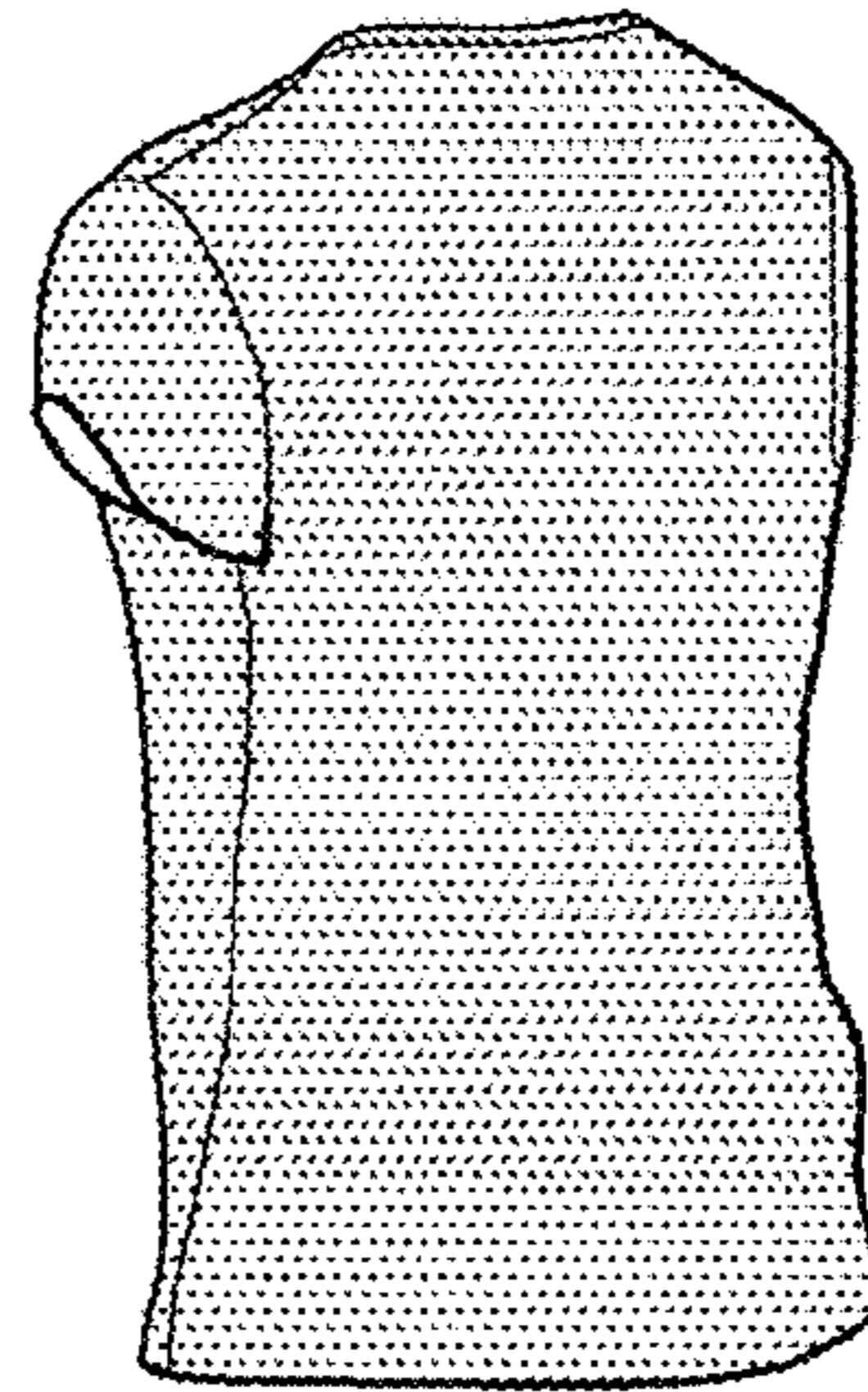

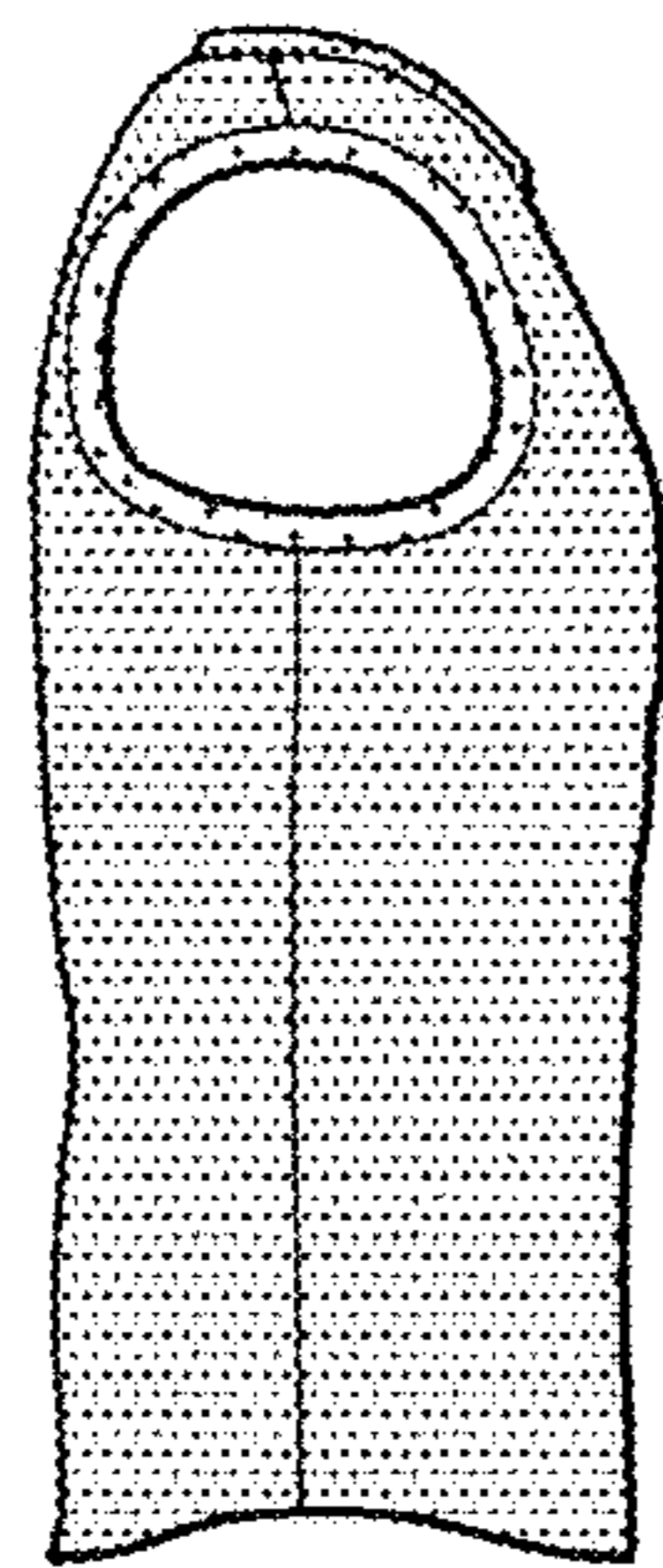

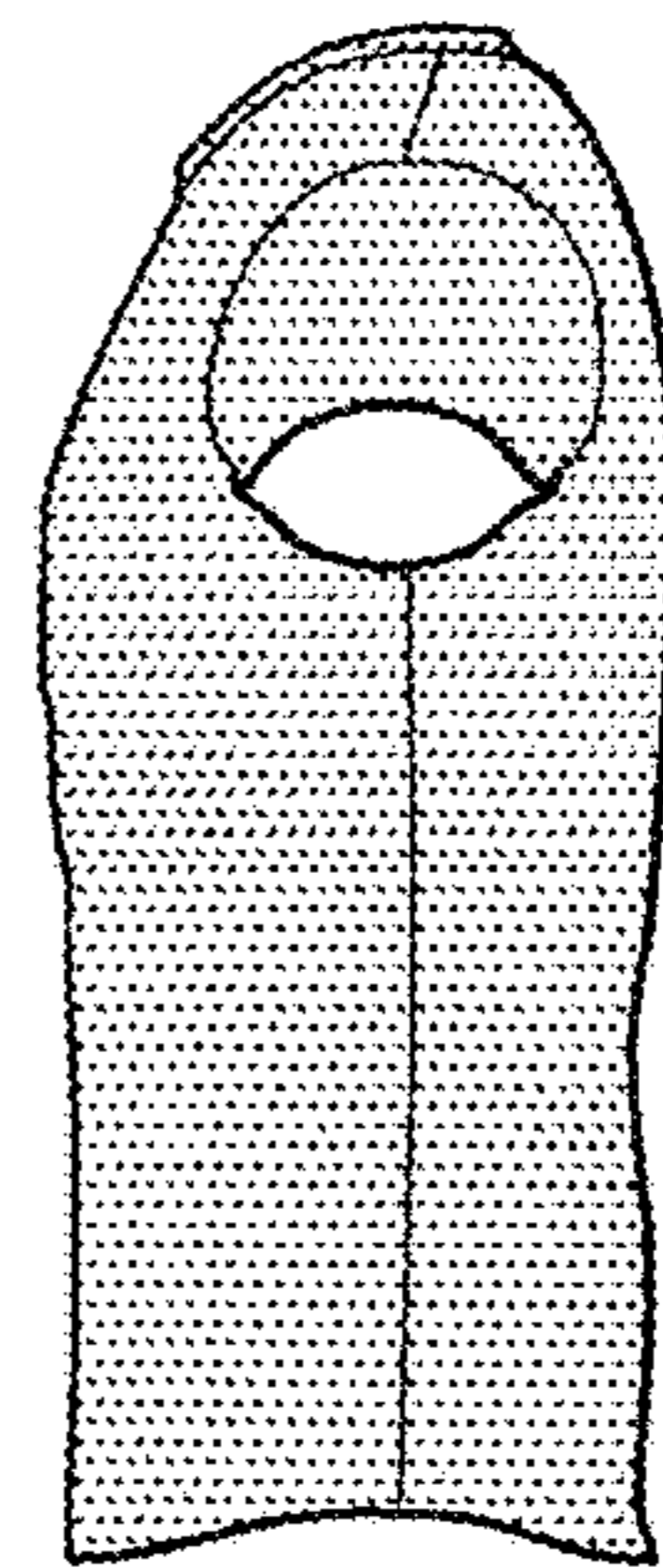

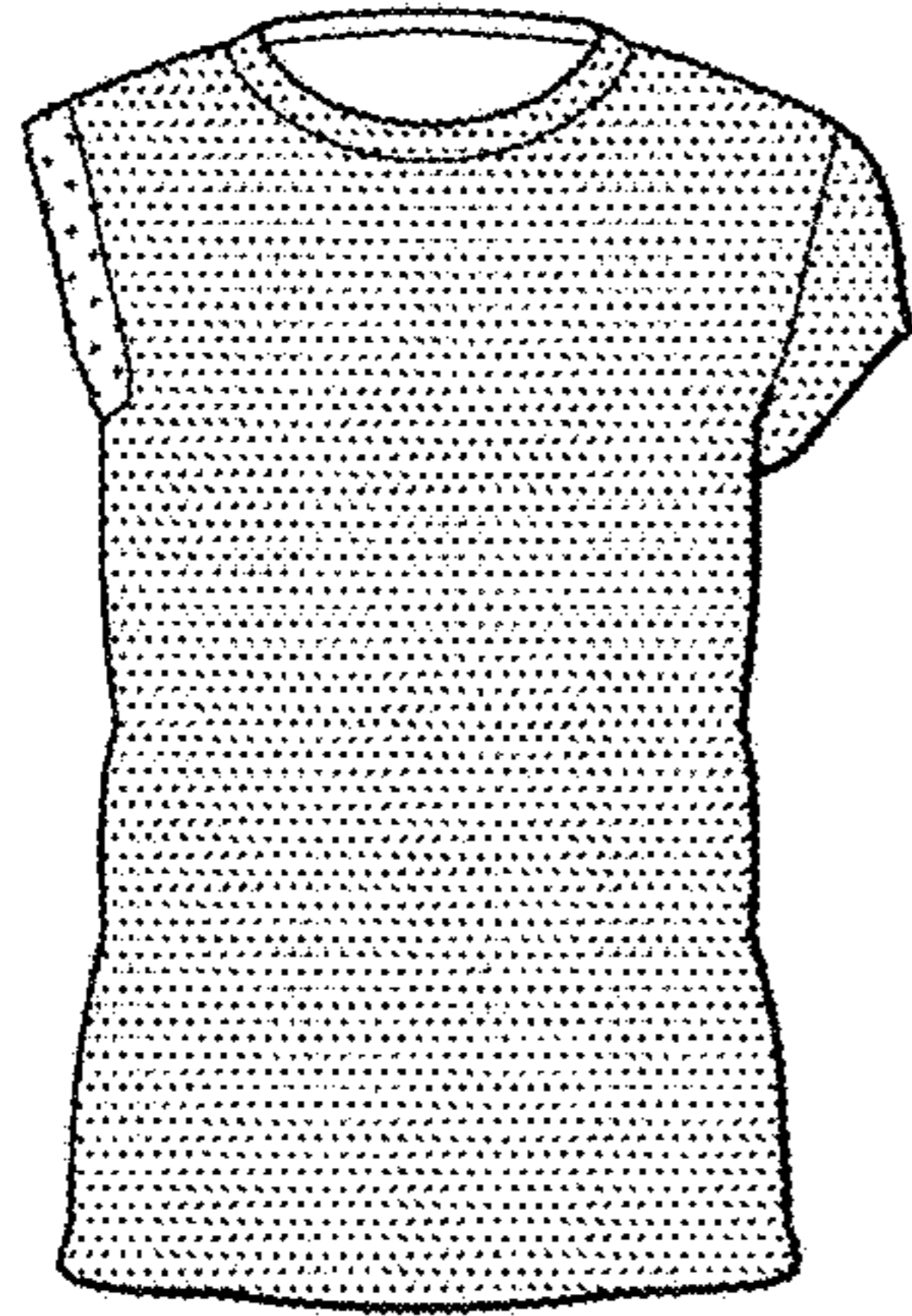

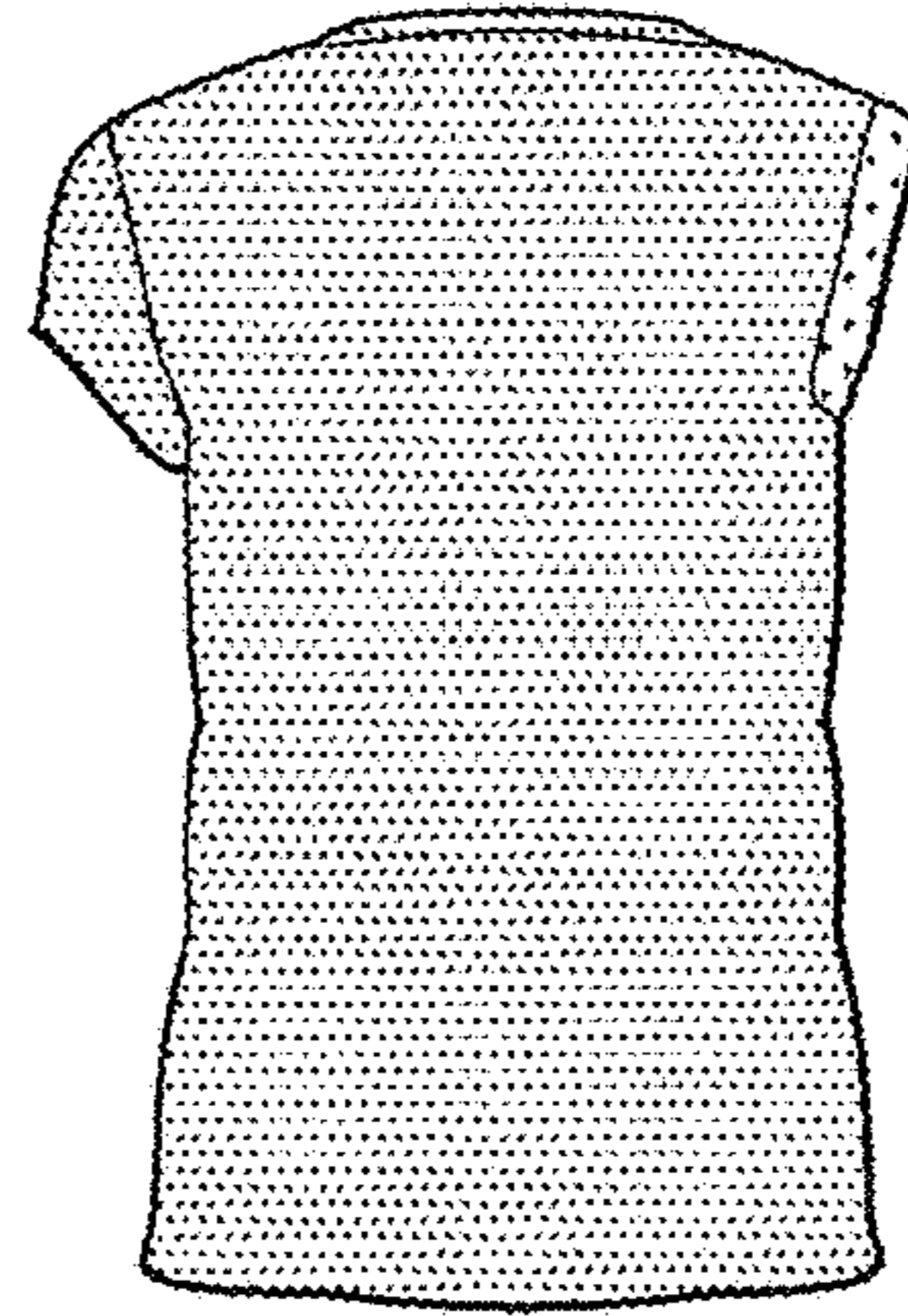

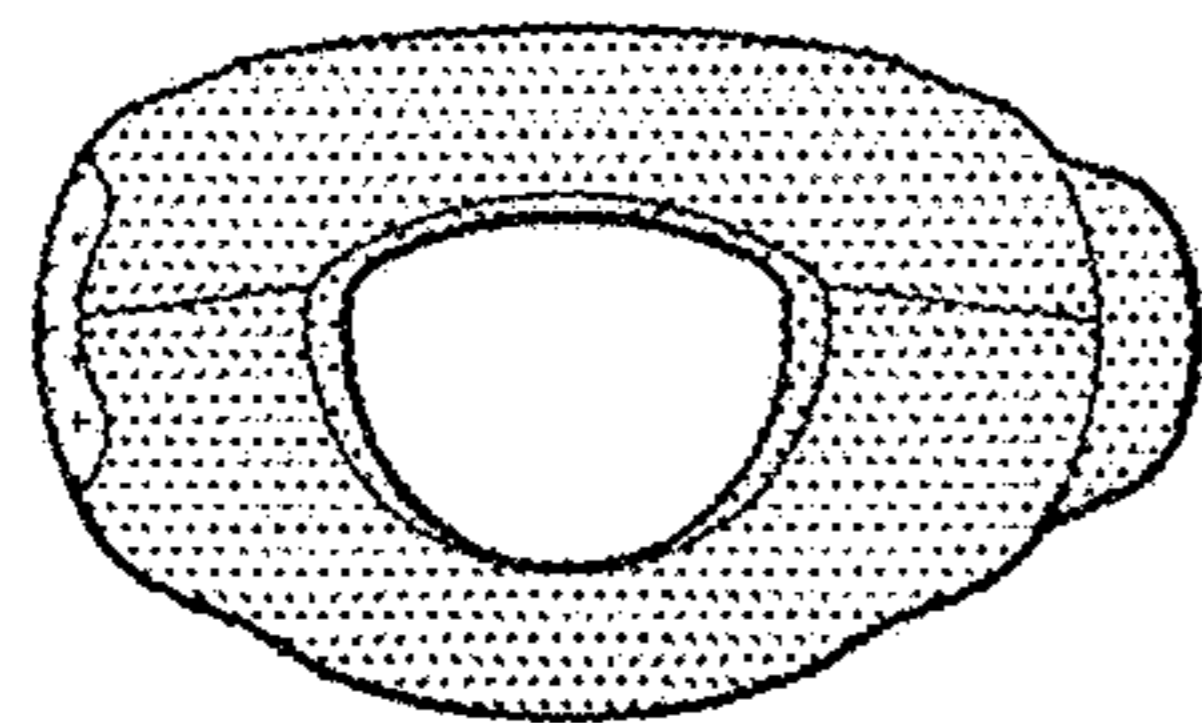

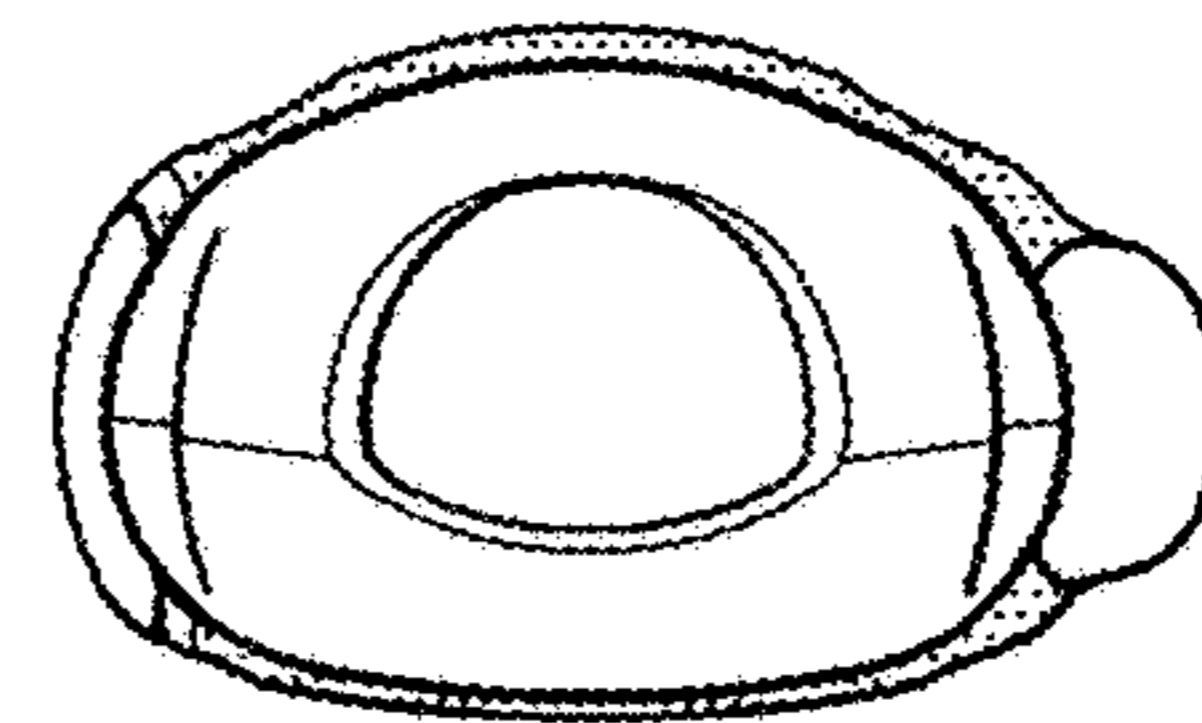
