DESCRIPTION

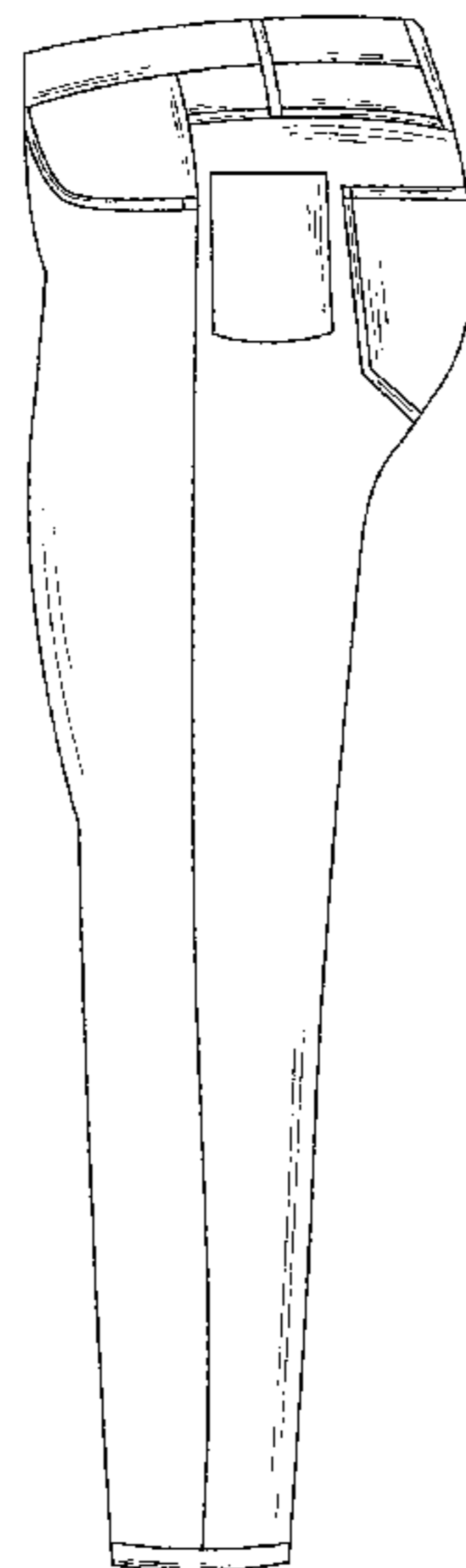

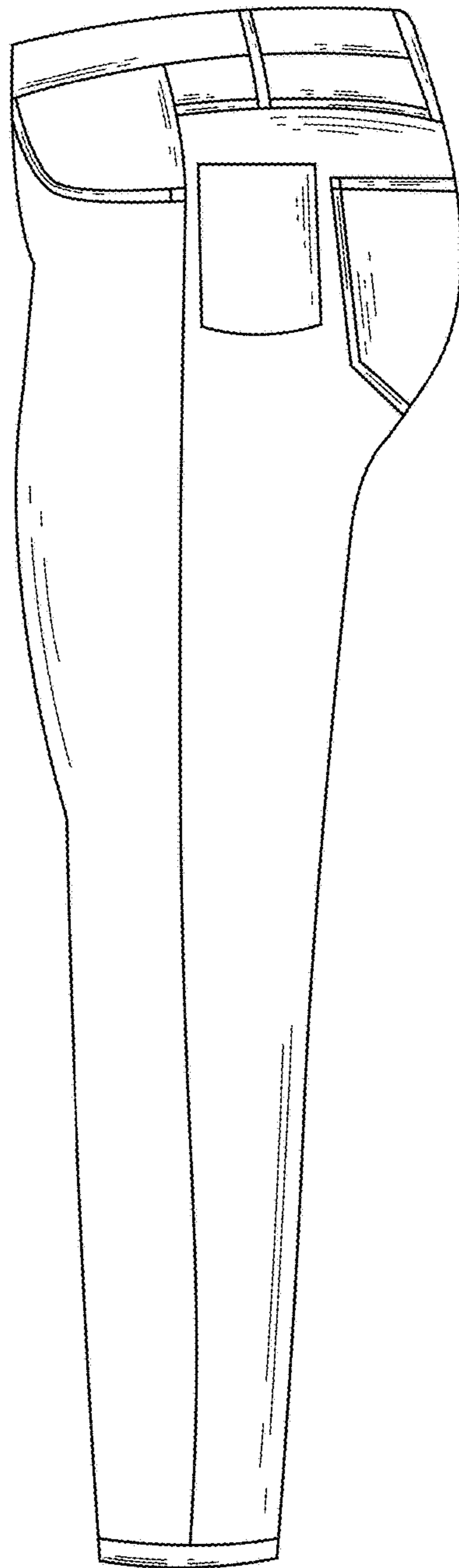

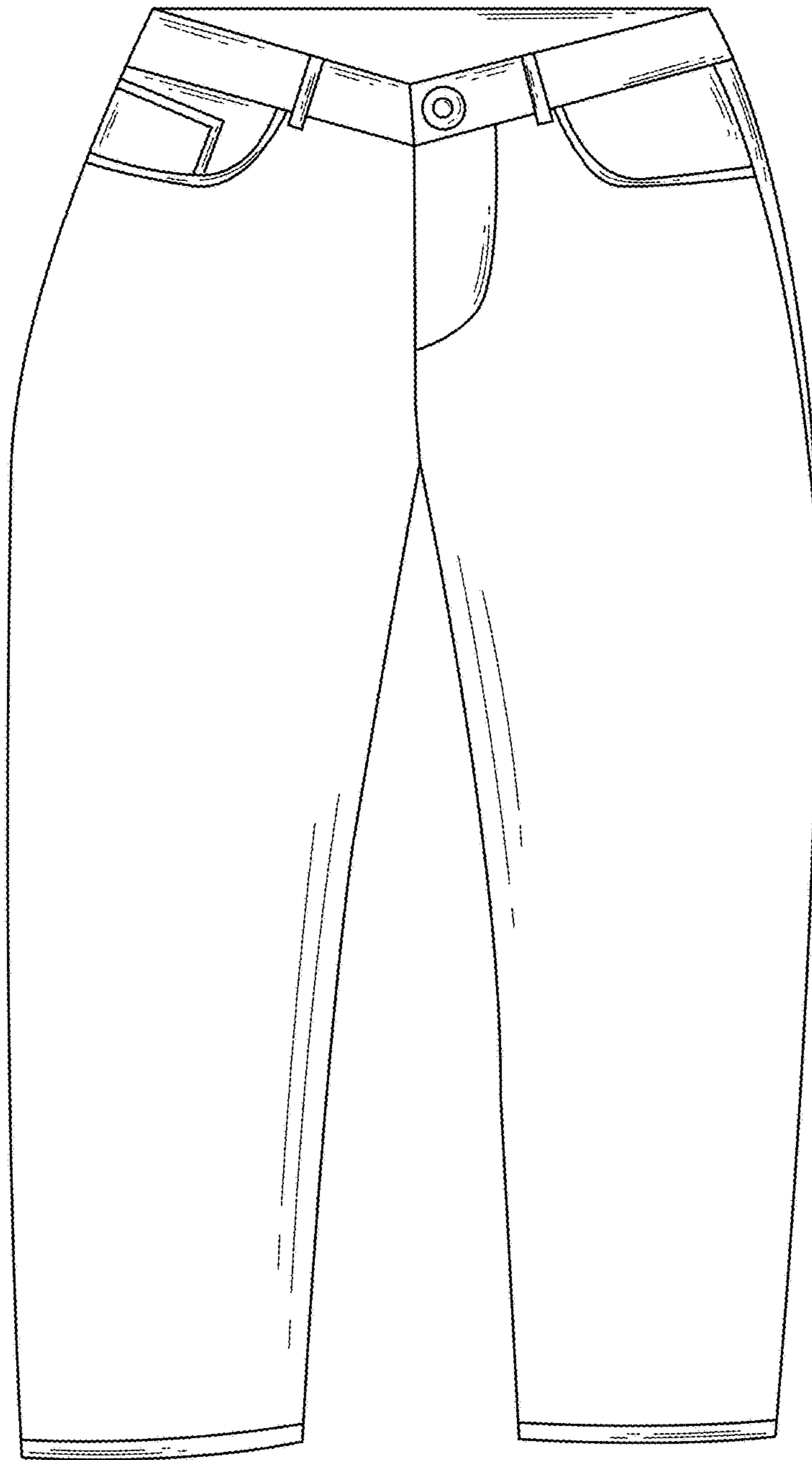

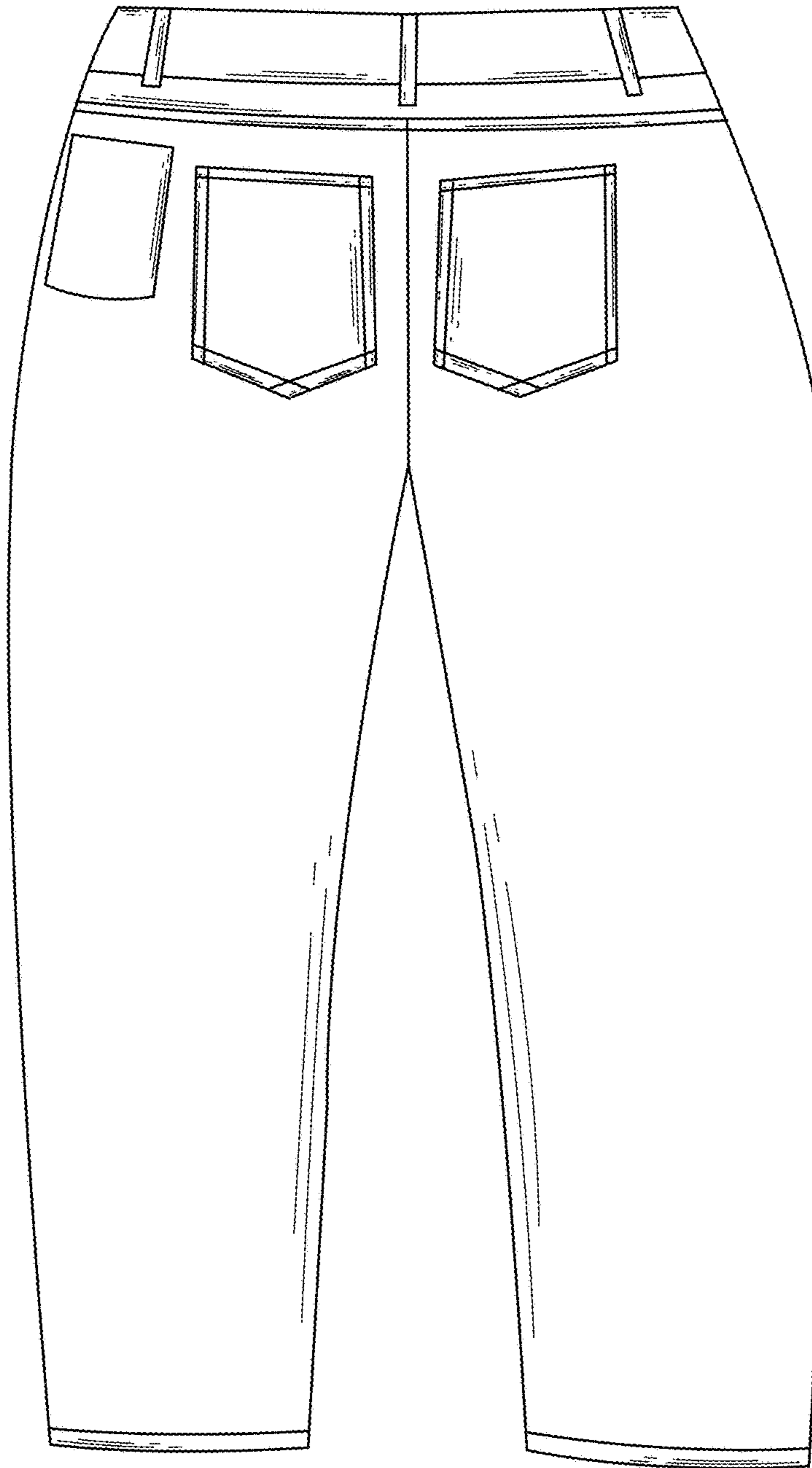

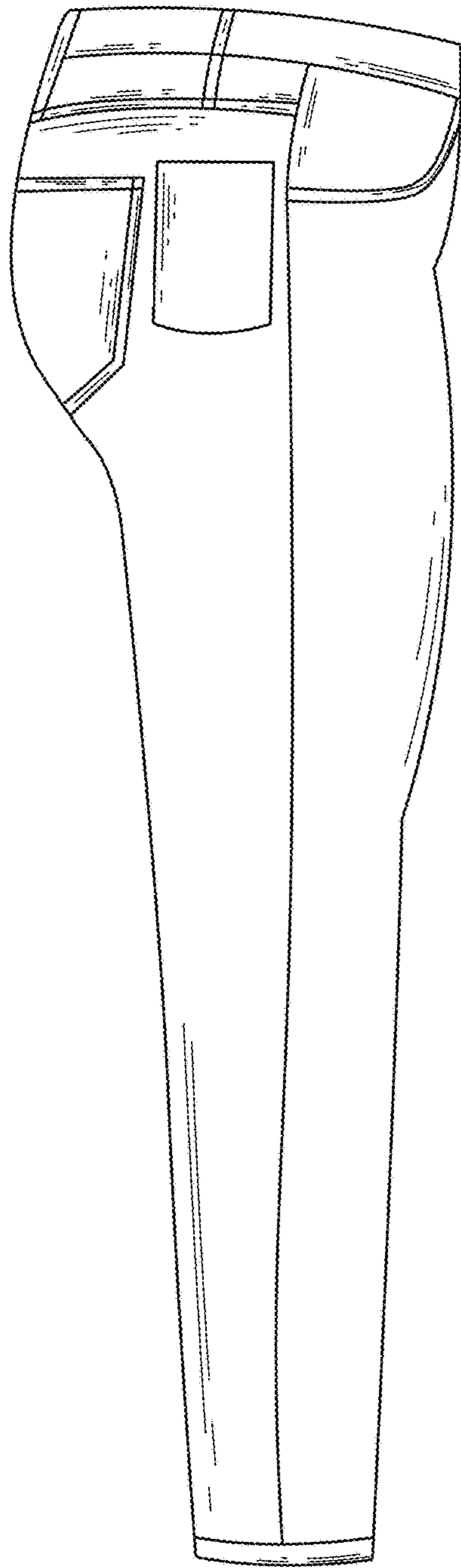

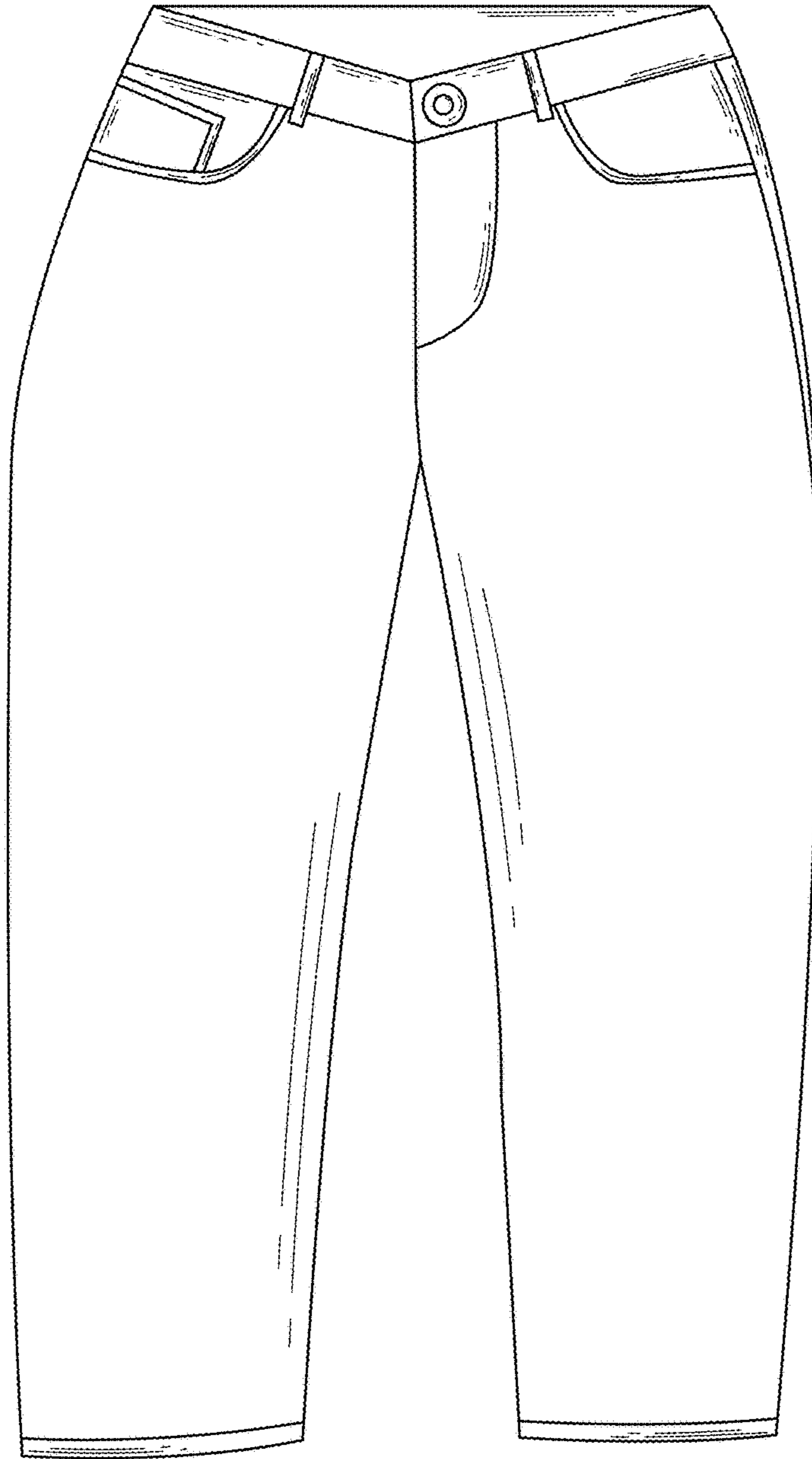

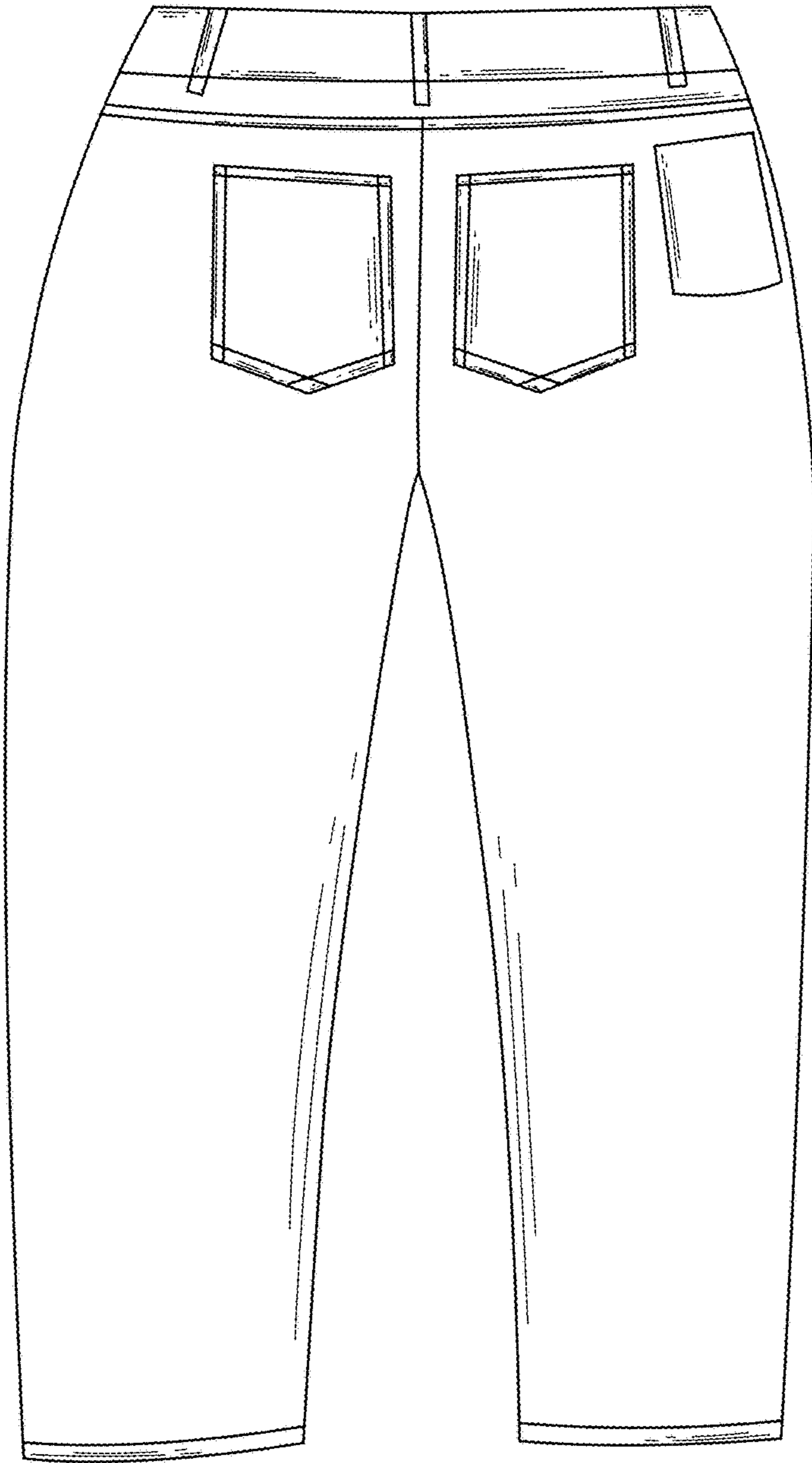

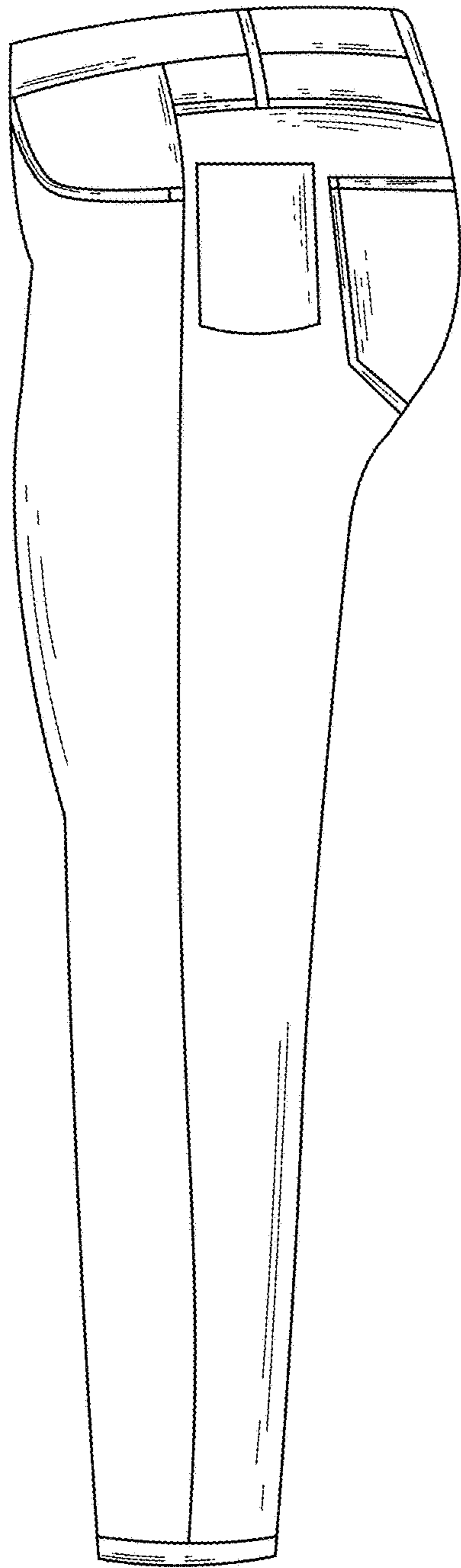

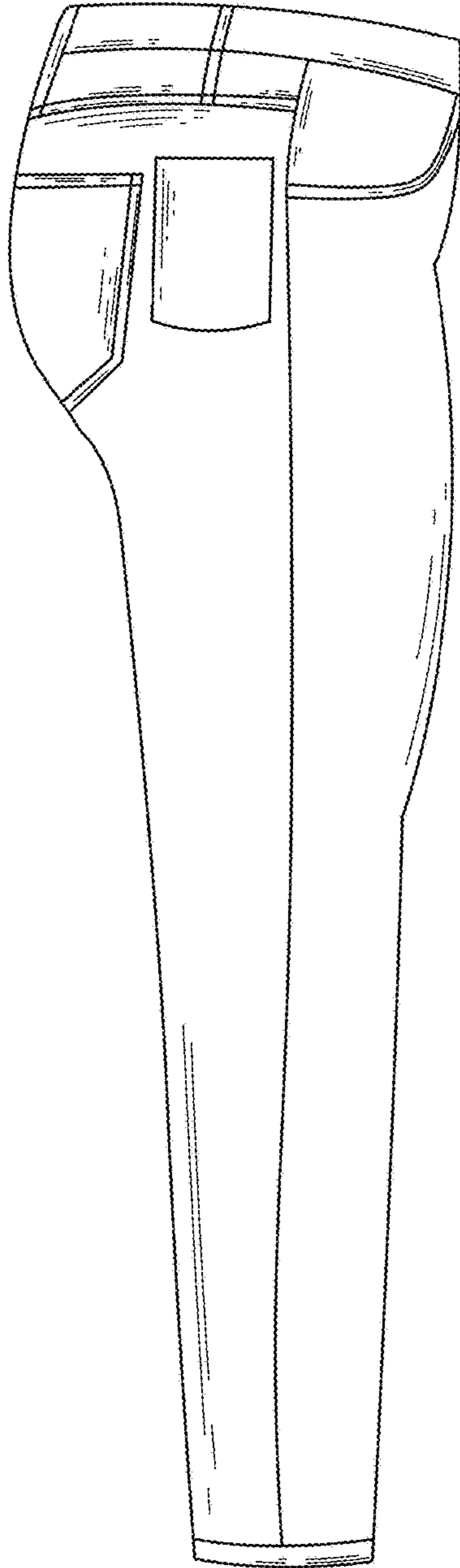

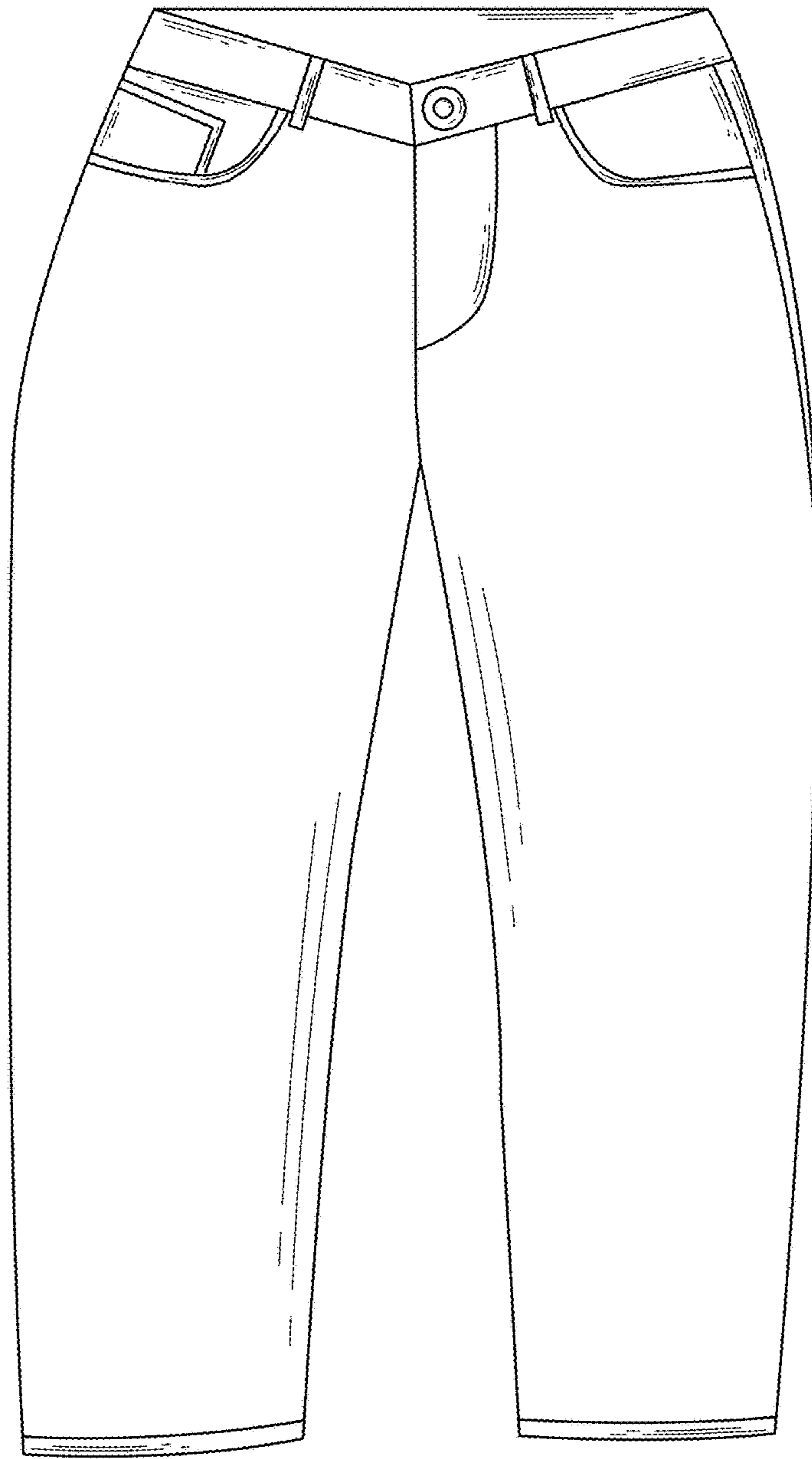

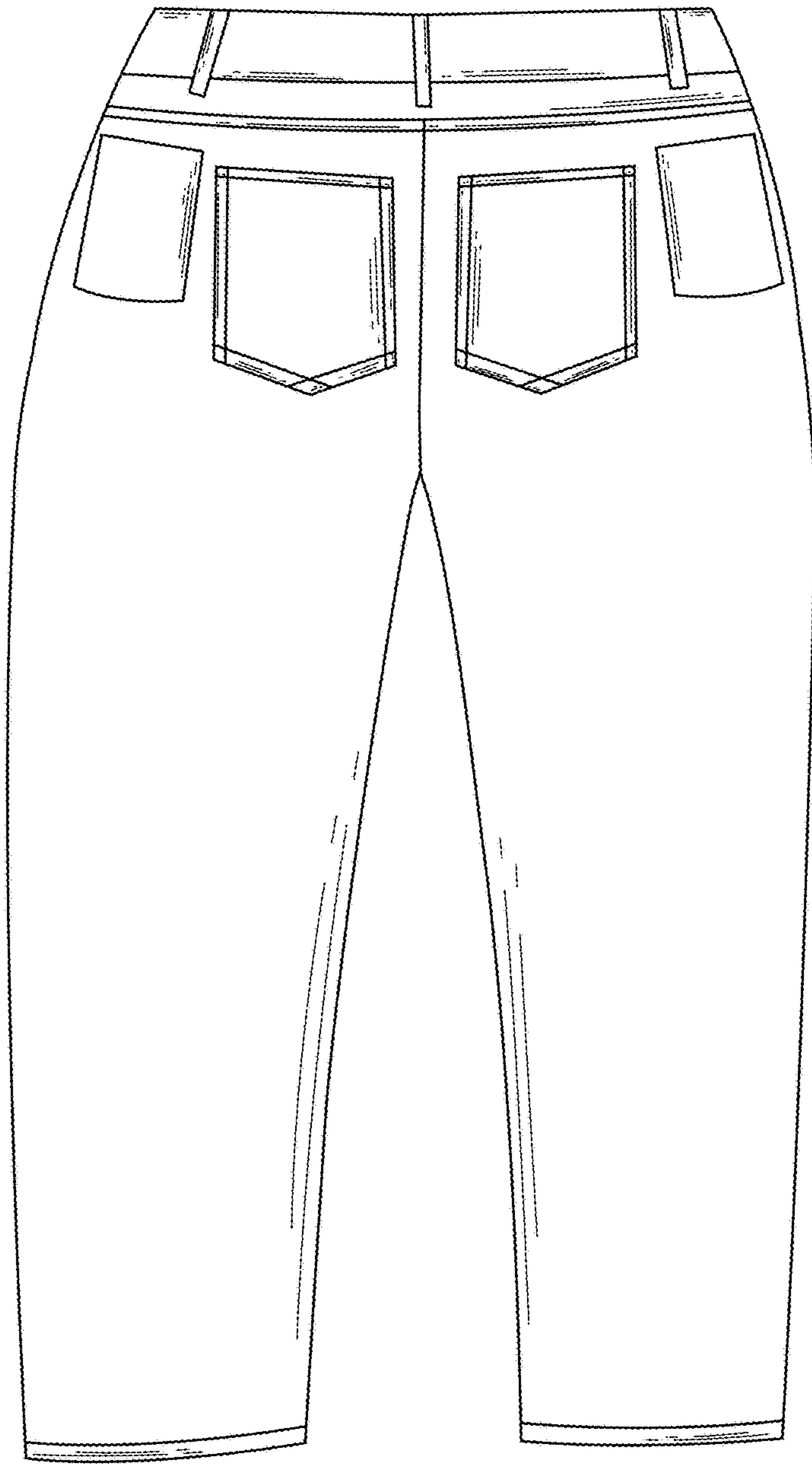
