**DESCRIPTION**

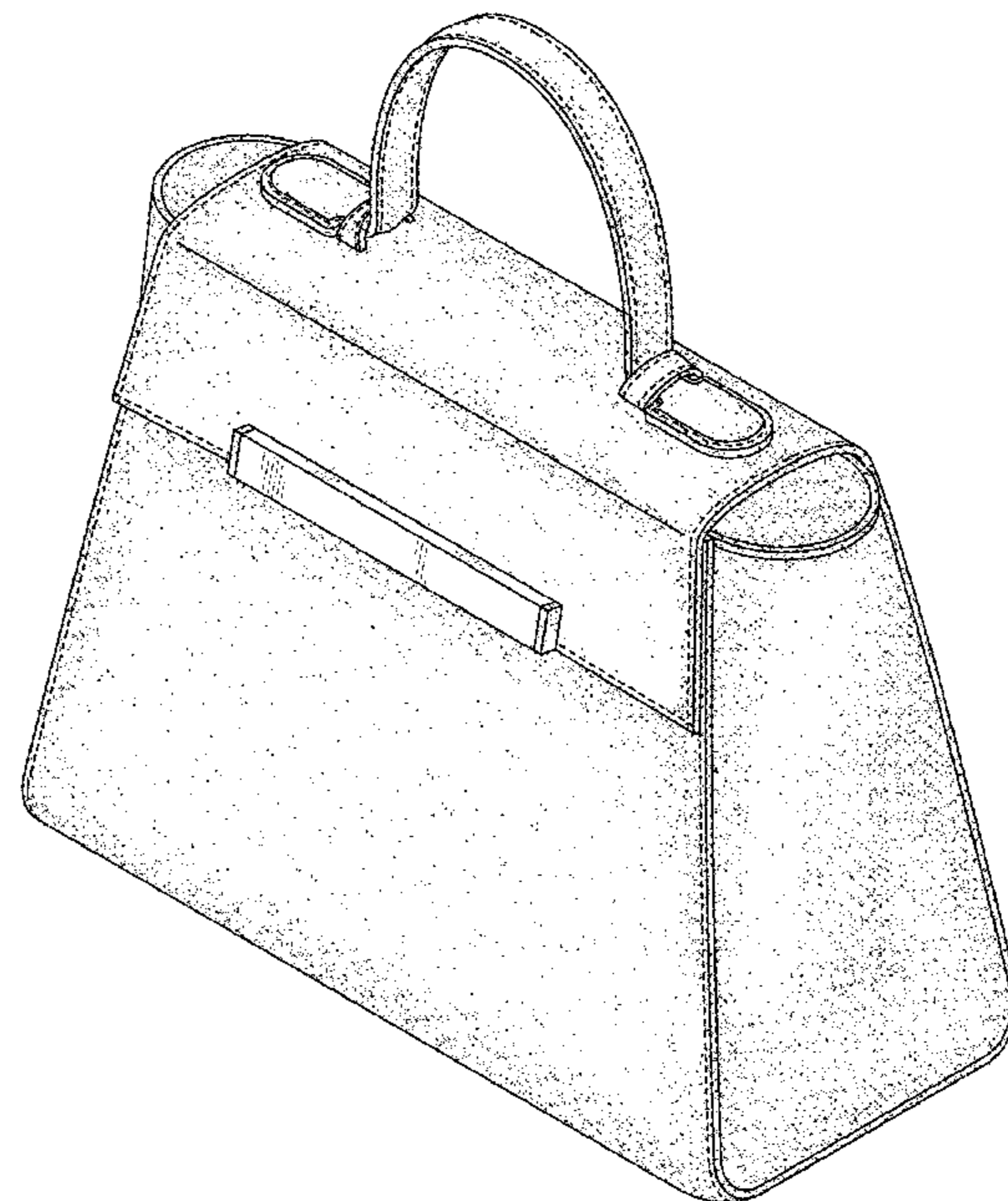

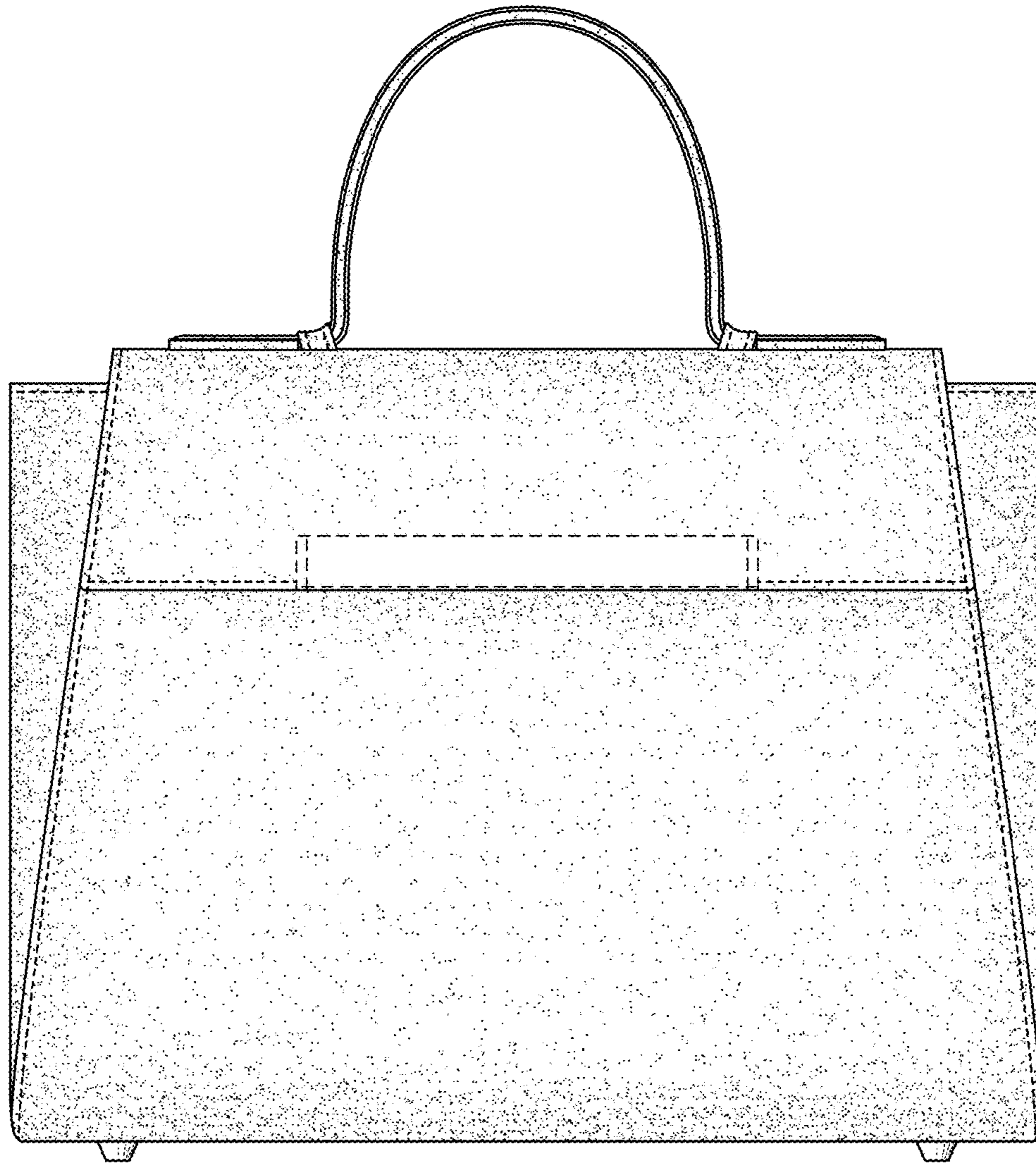

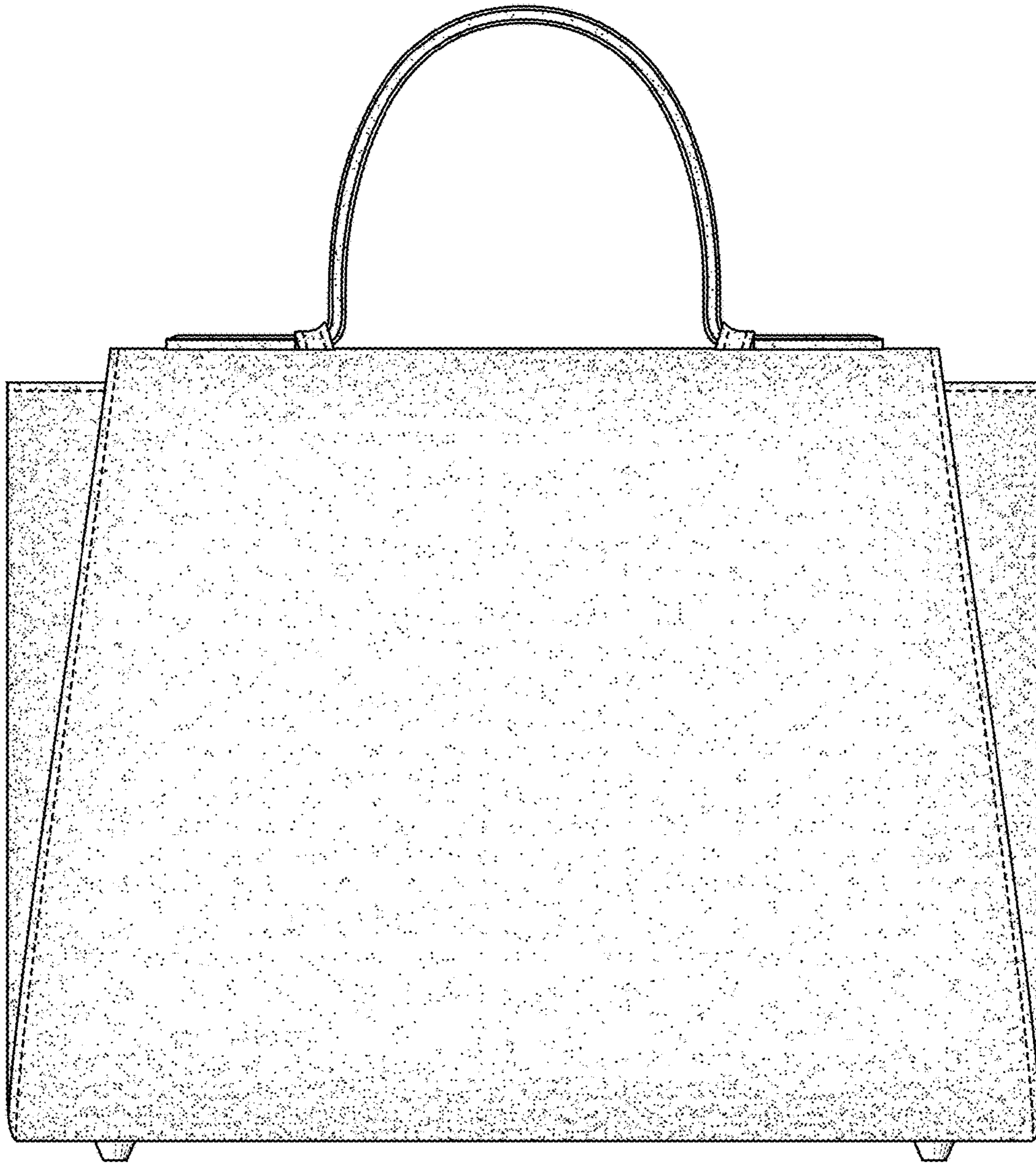

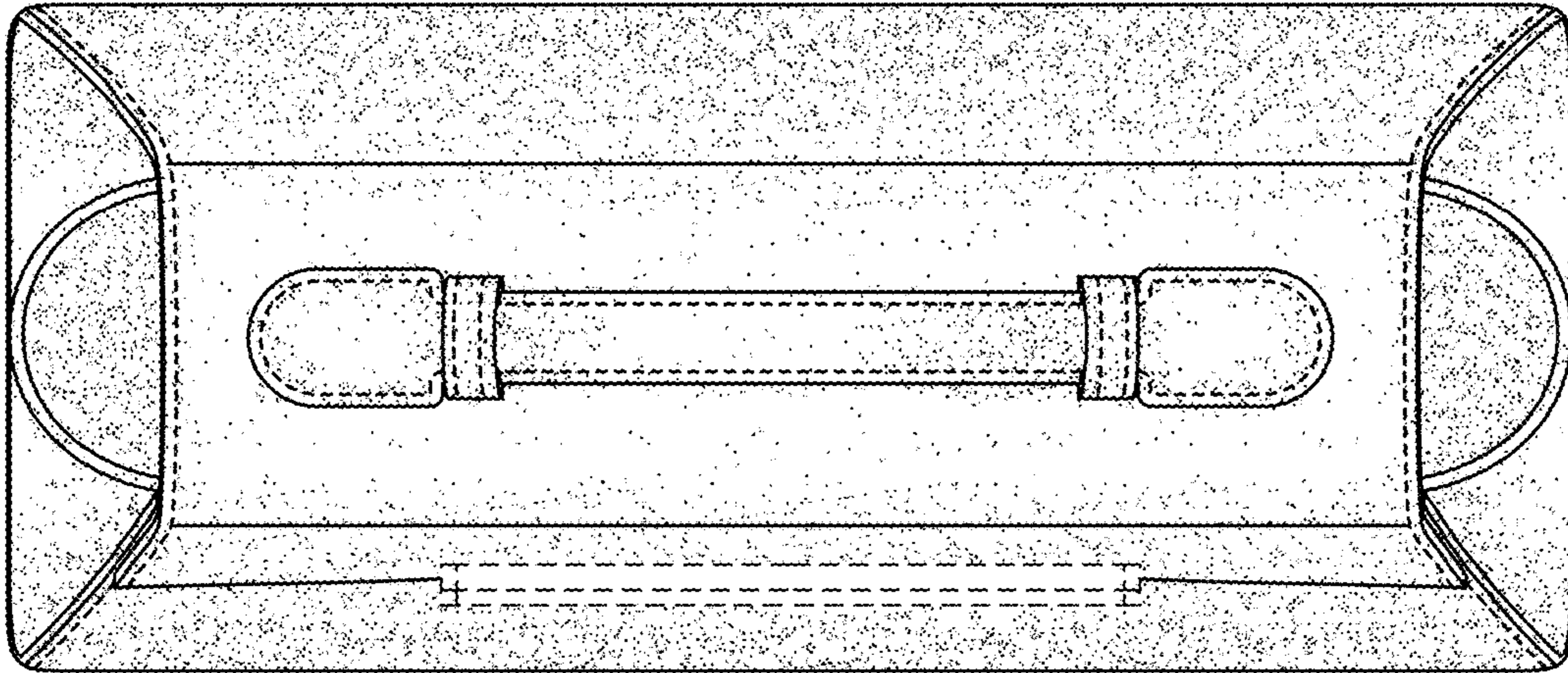

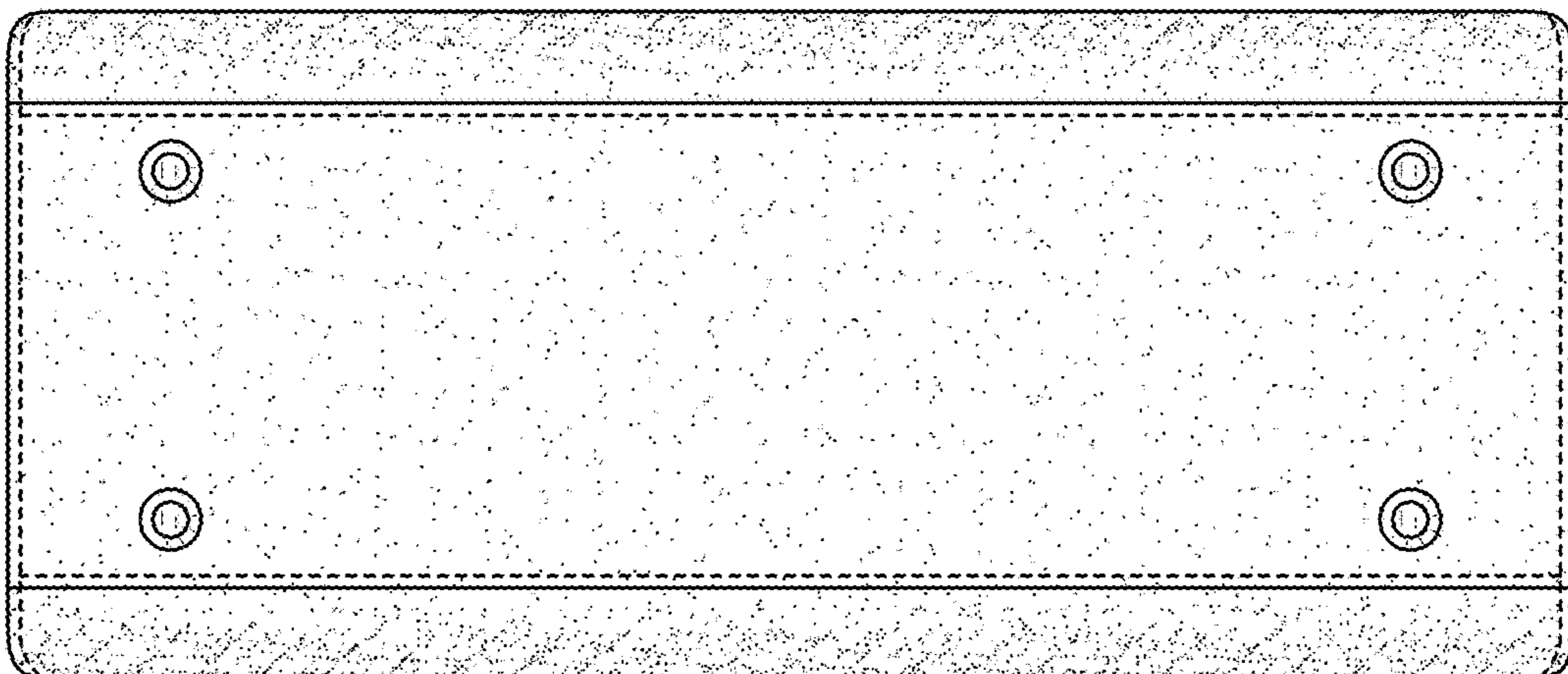

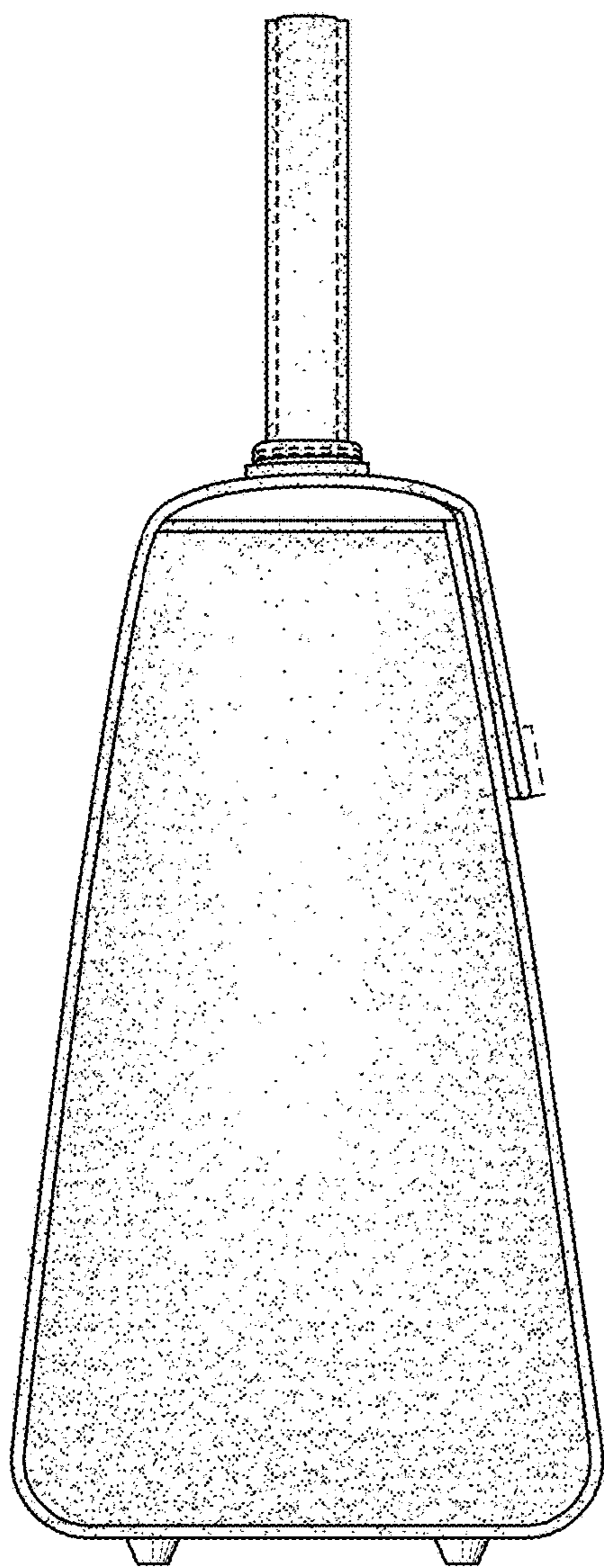

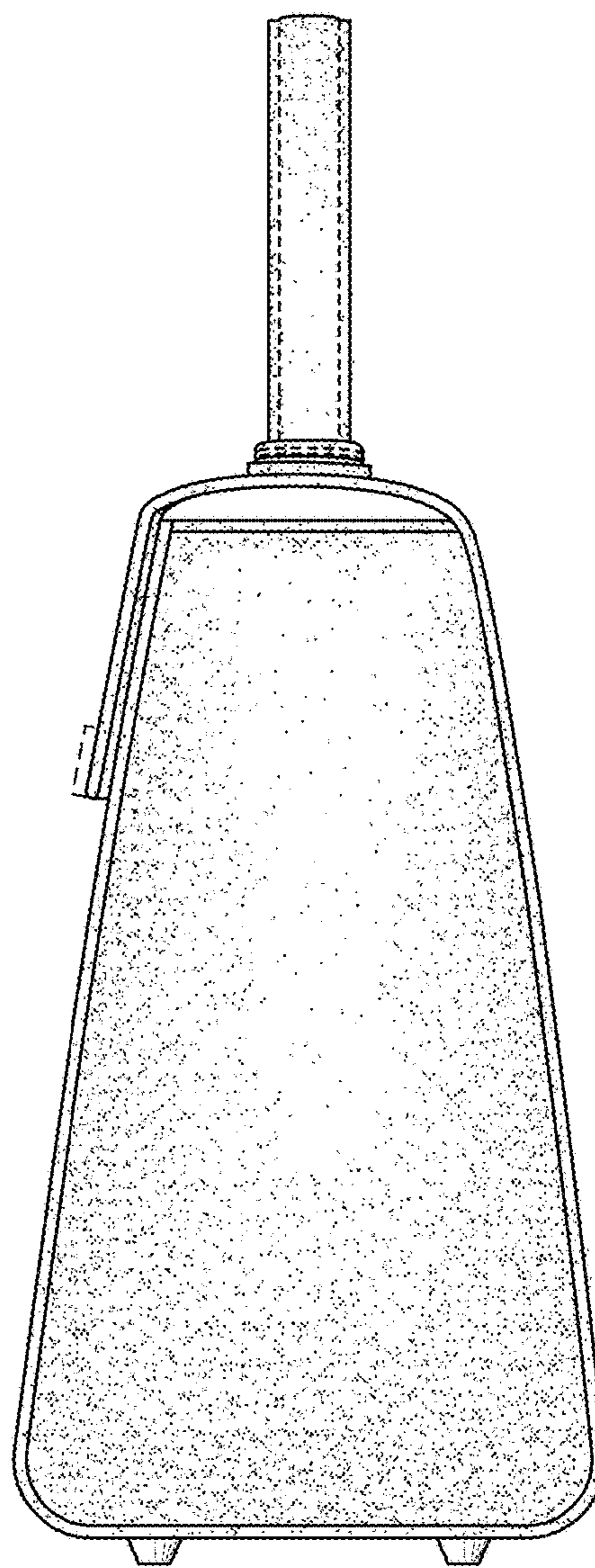

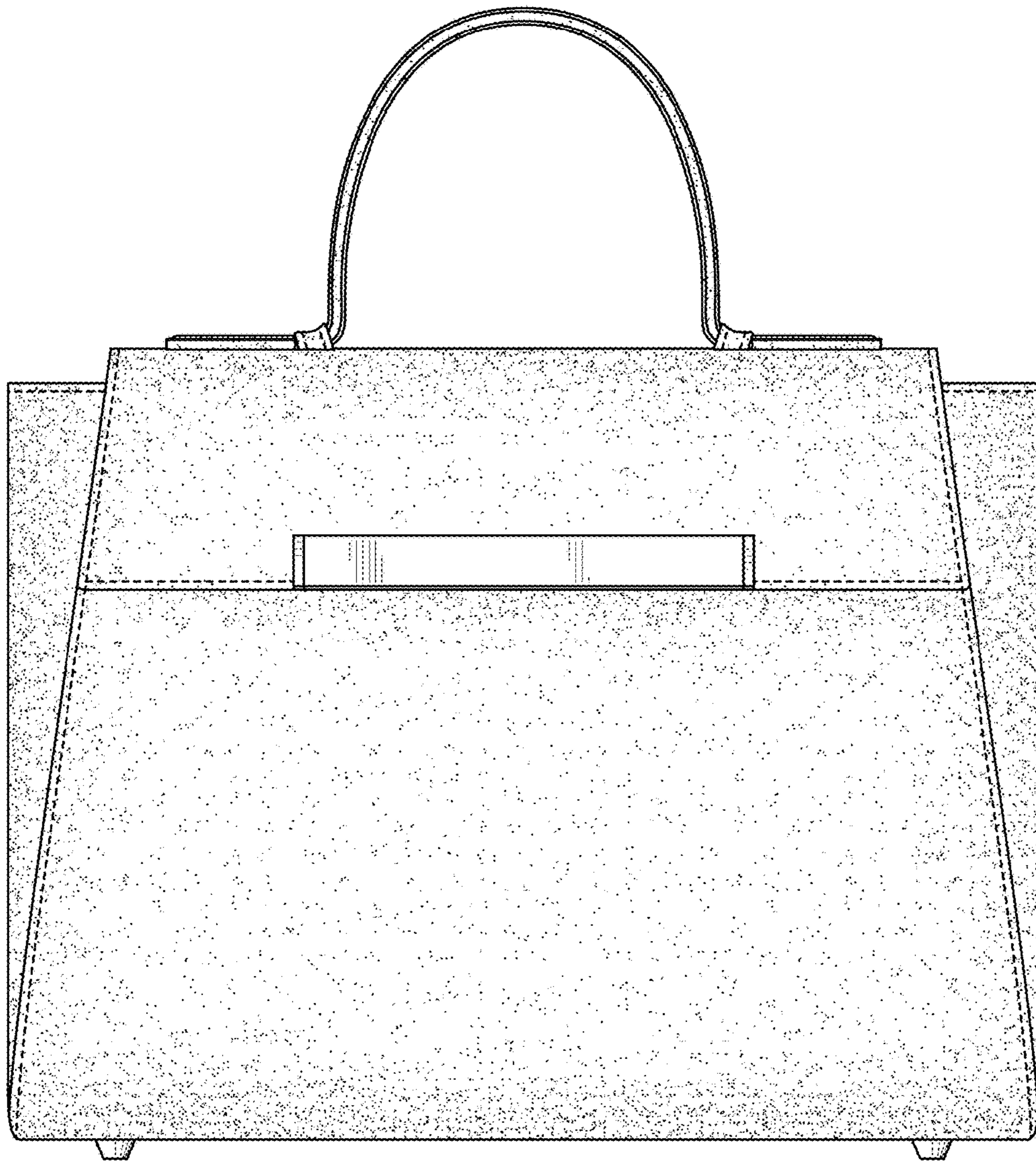

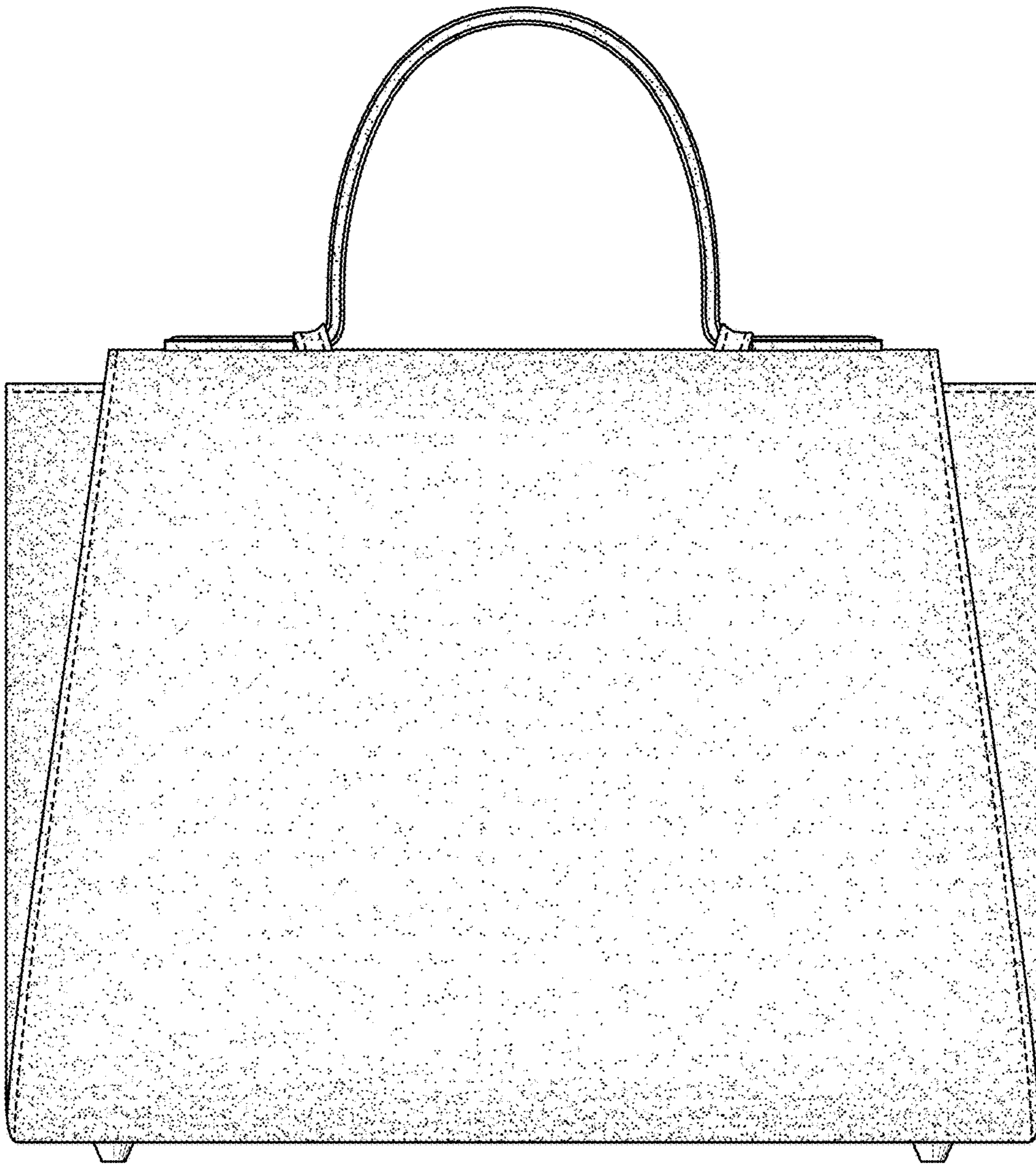

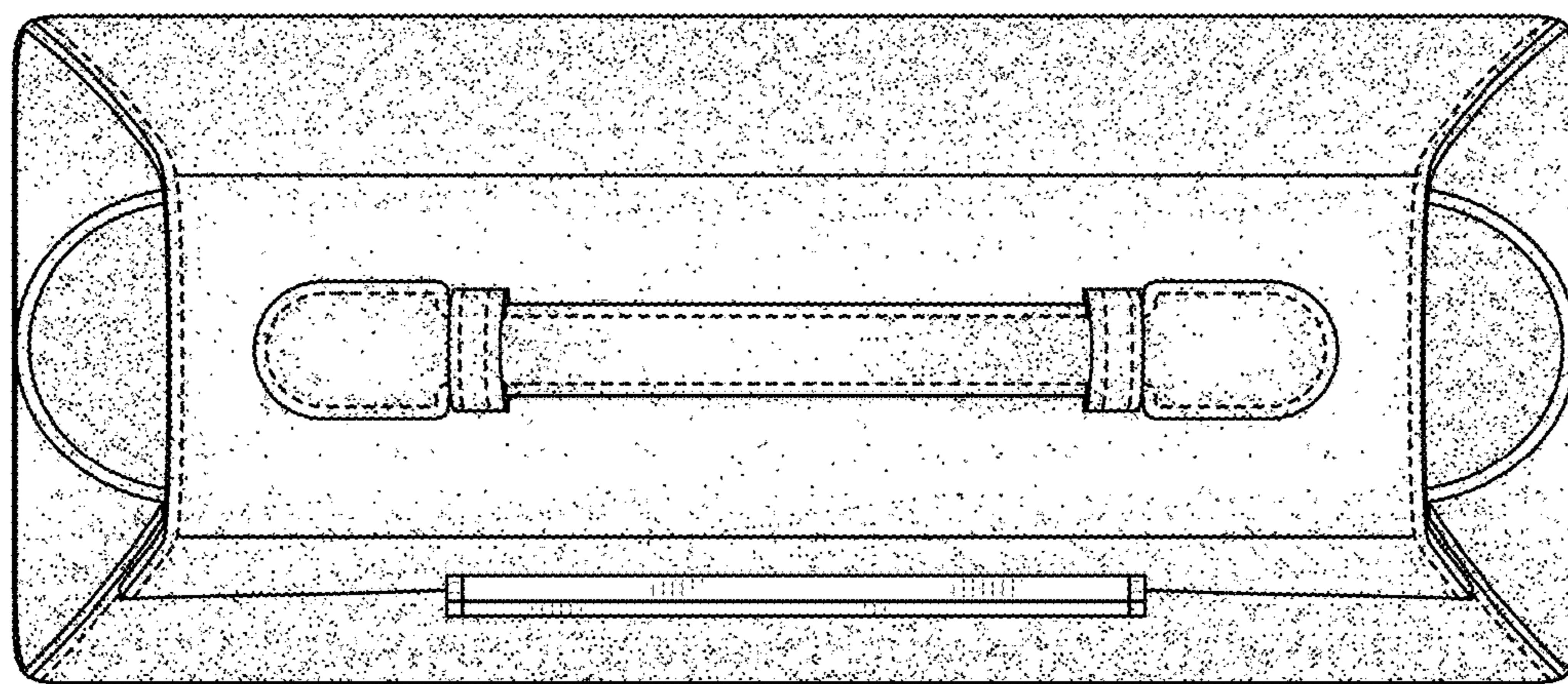

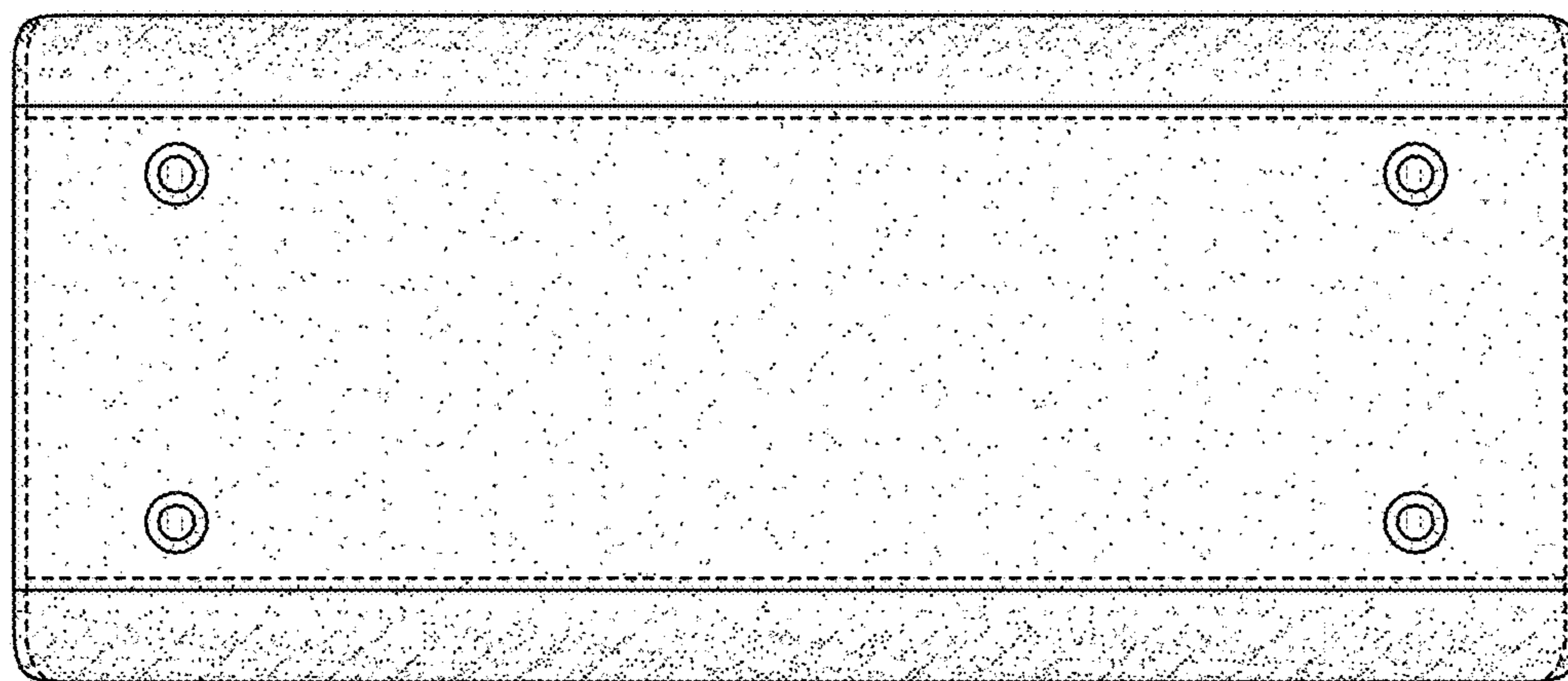

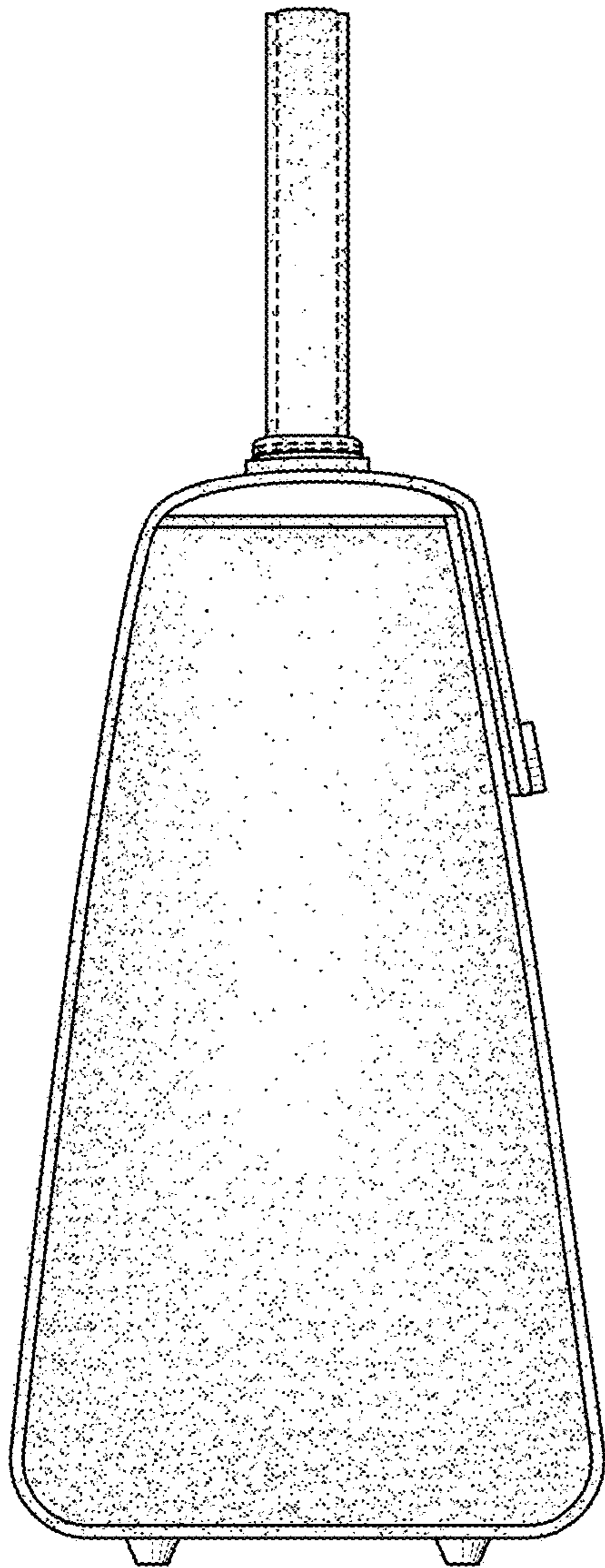

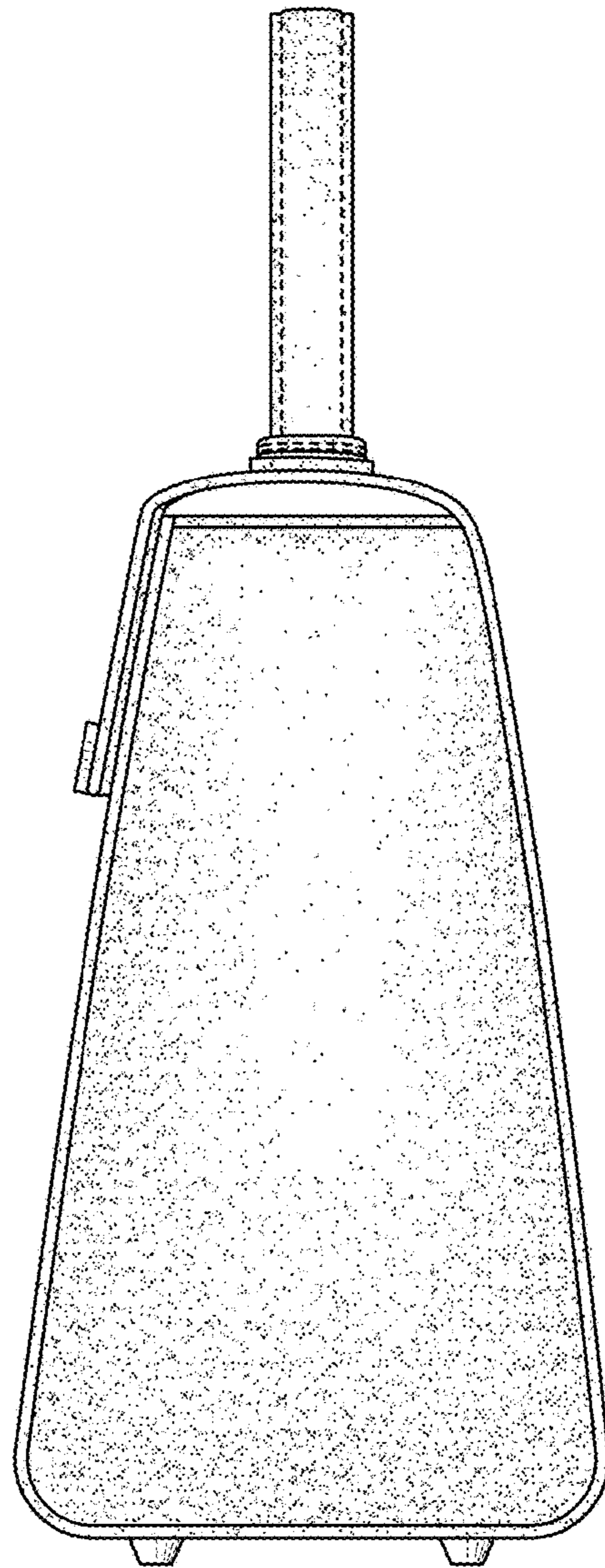
