FIG. 3 is a back side view of the chair seat;

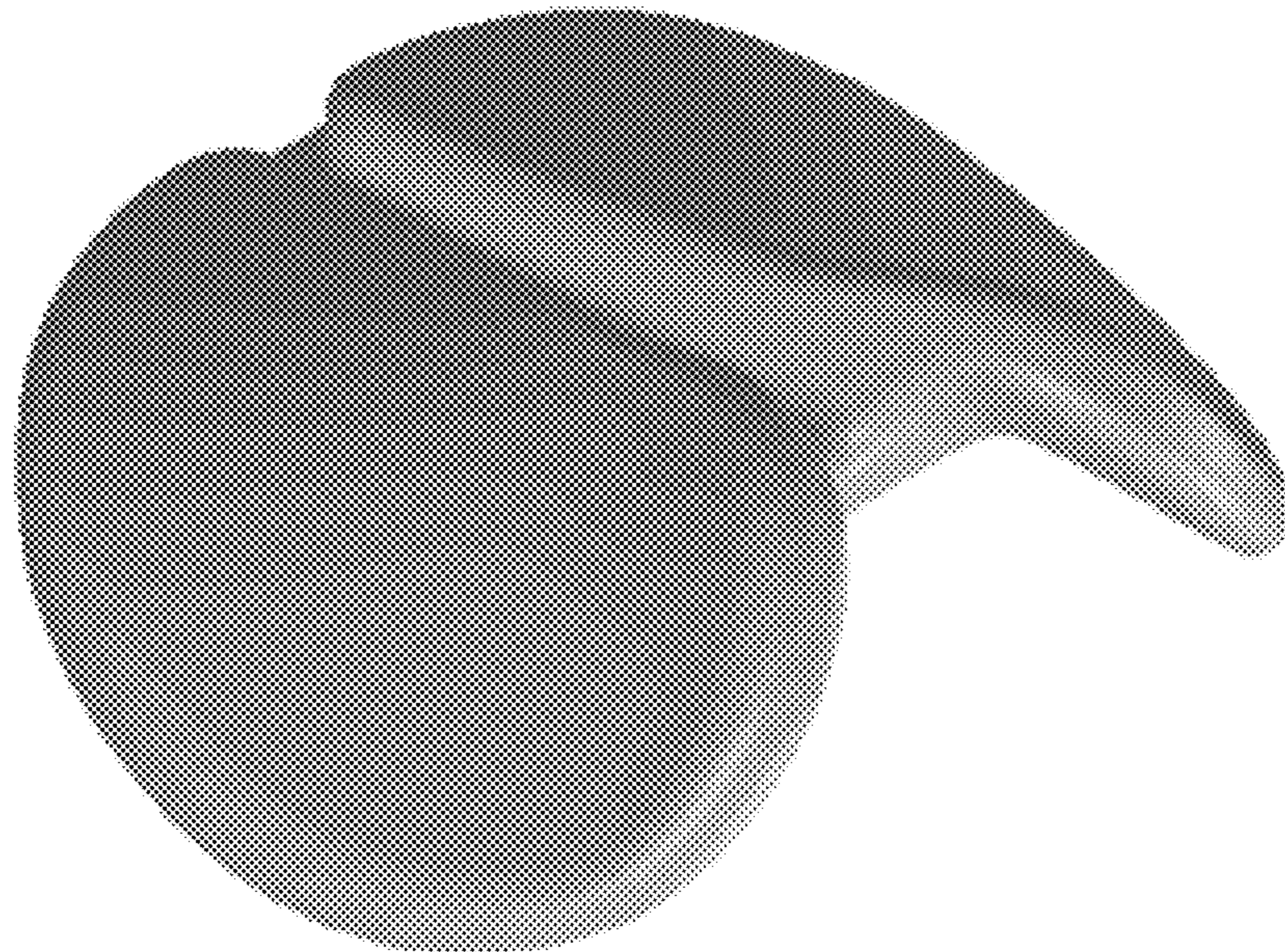
FIG. 4 is a front side view of the chair seat;

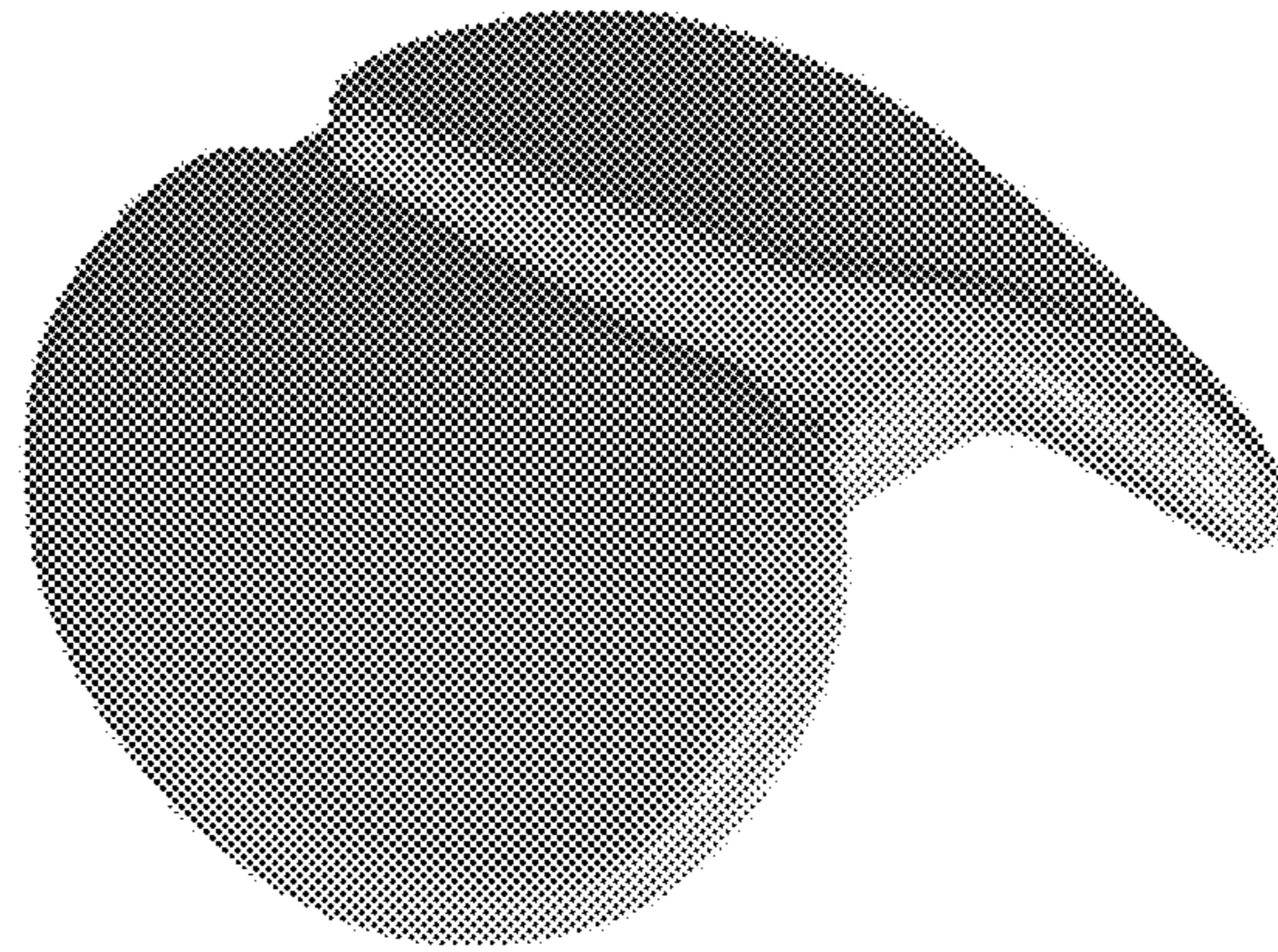

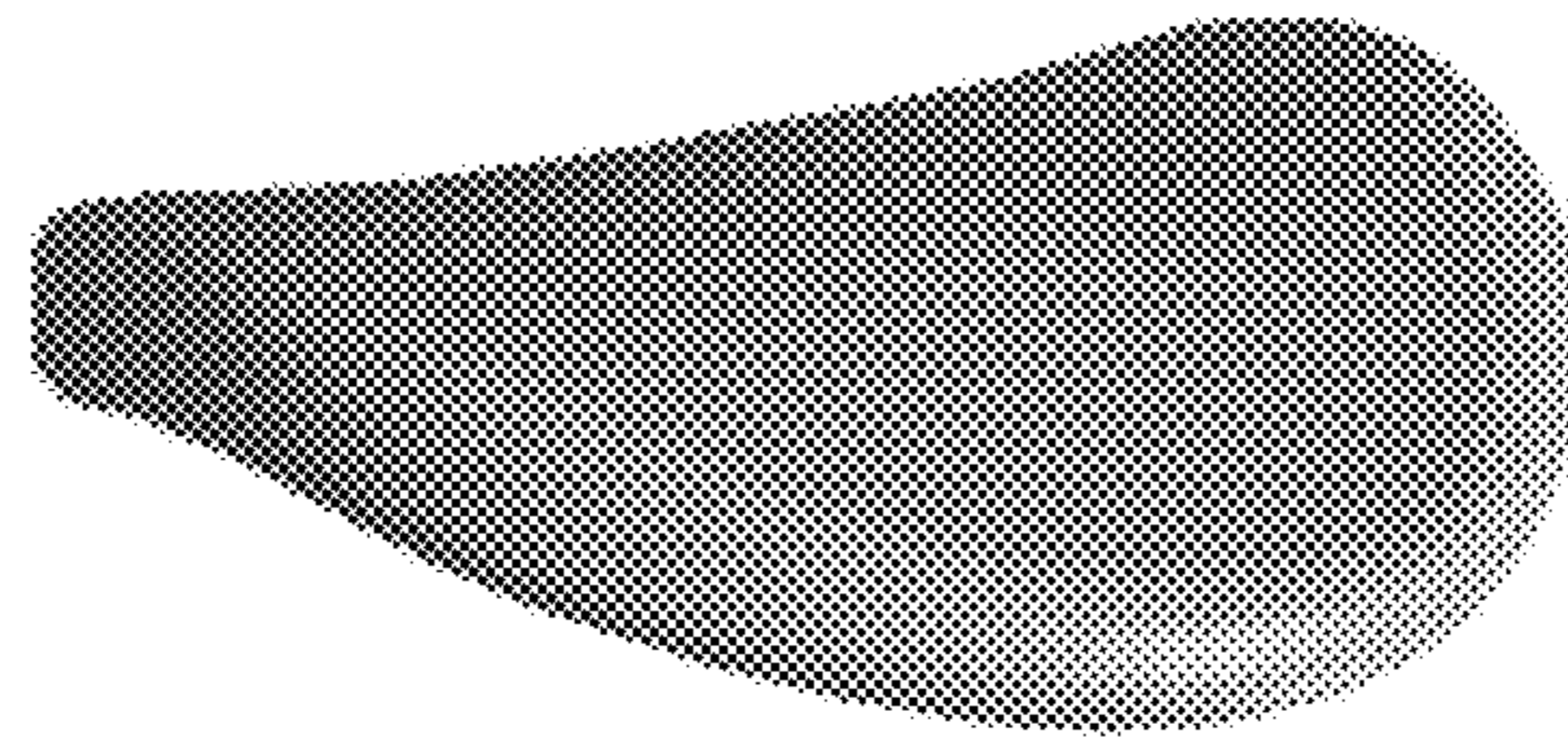

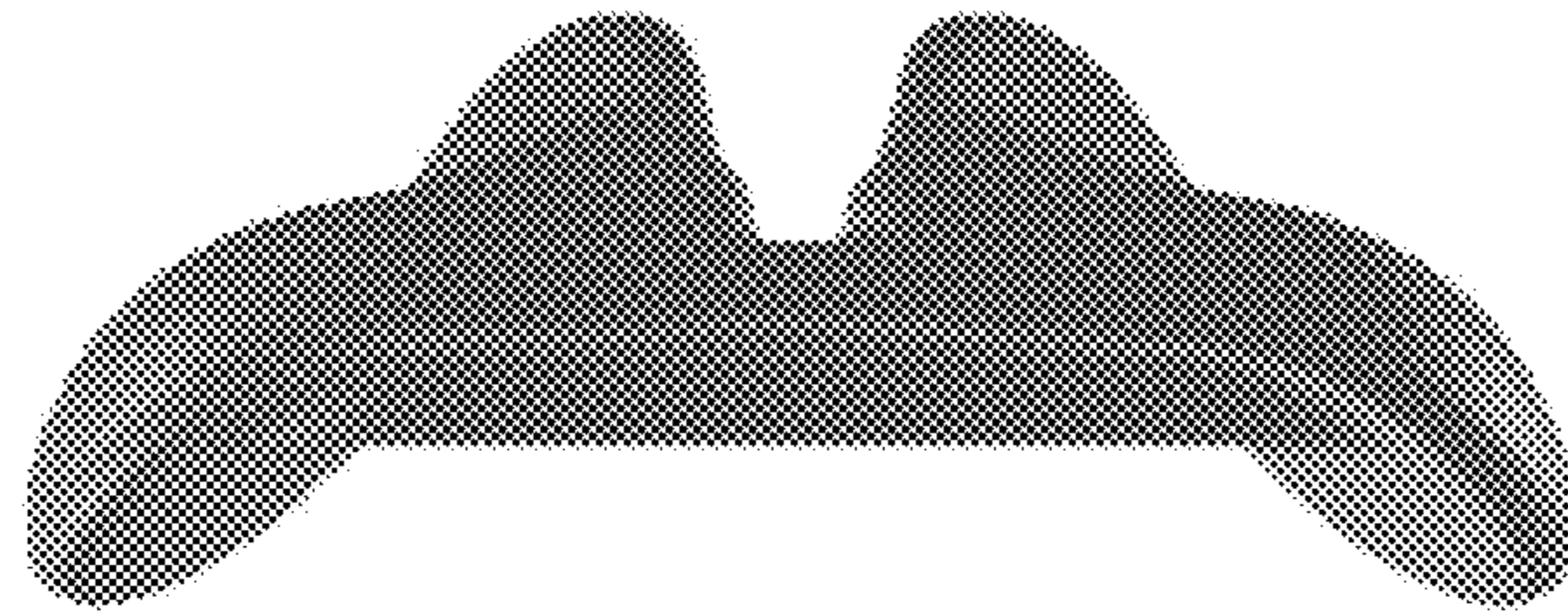

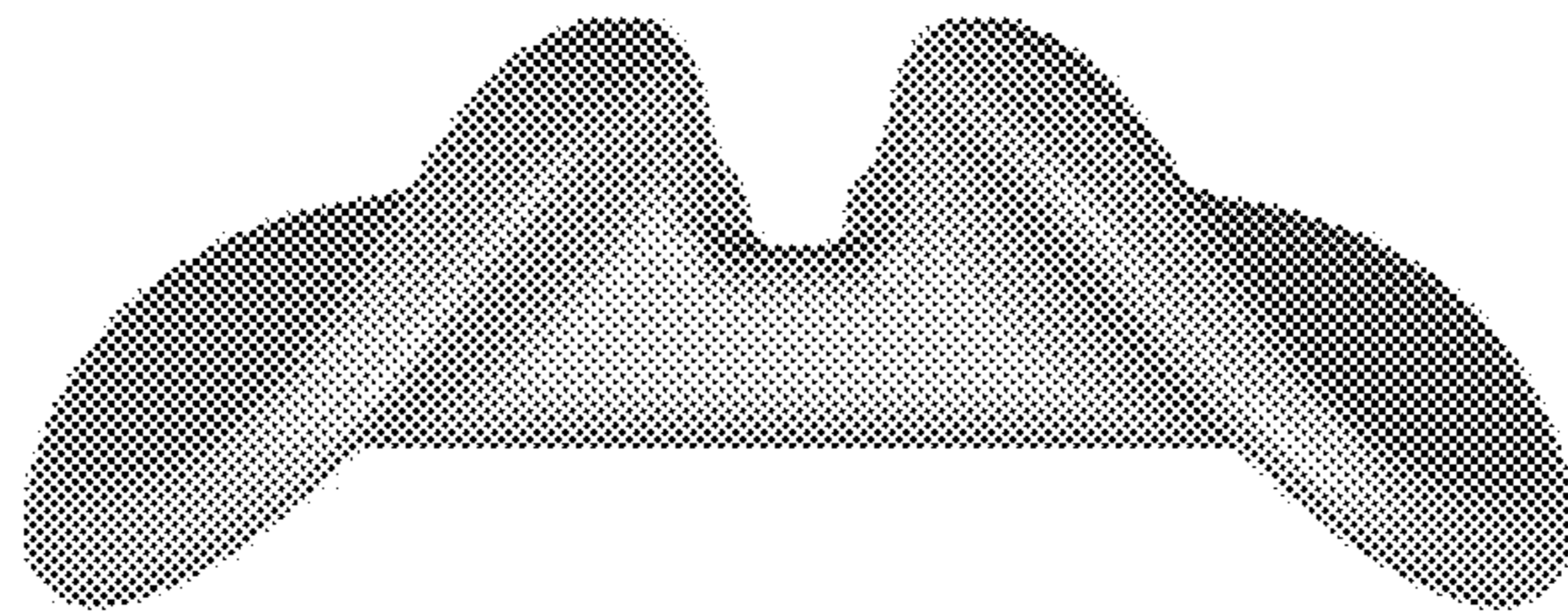

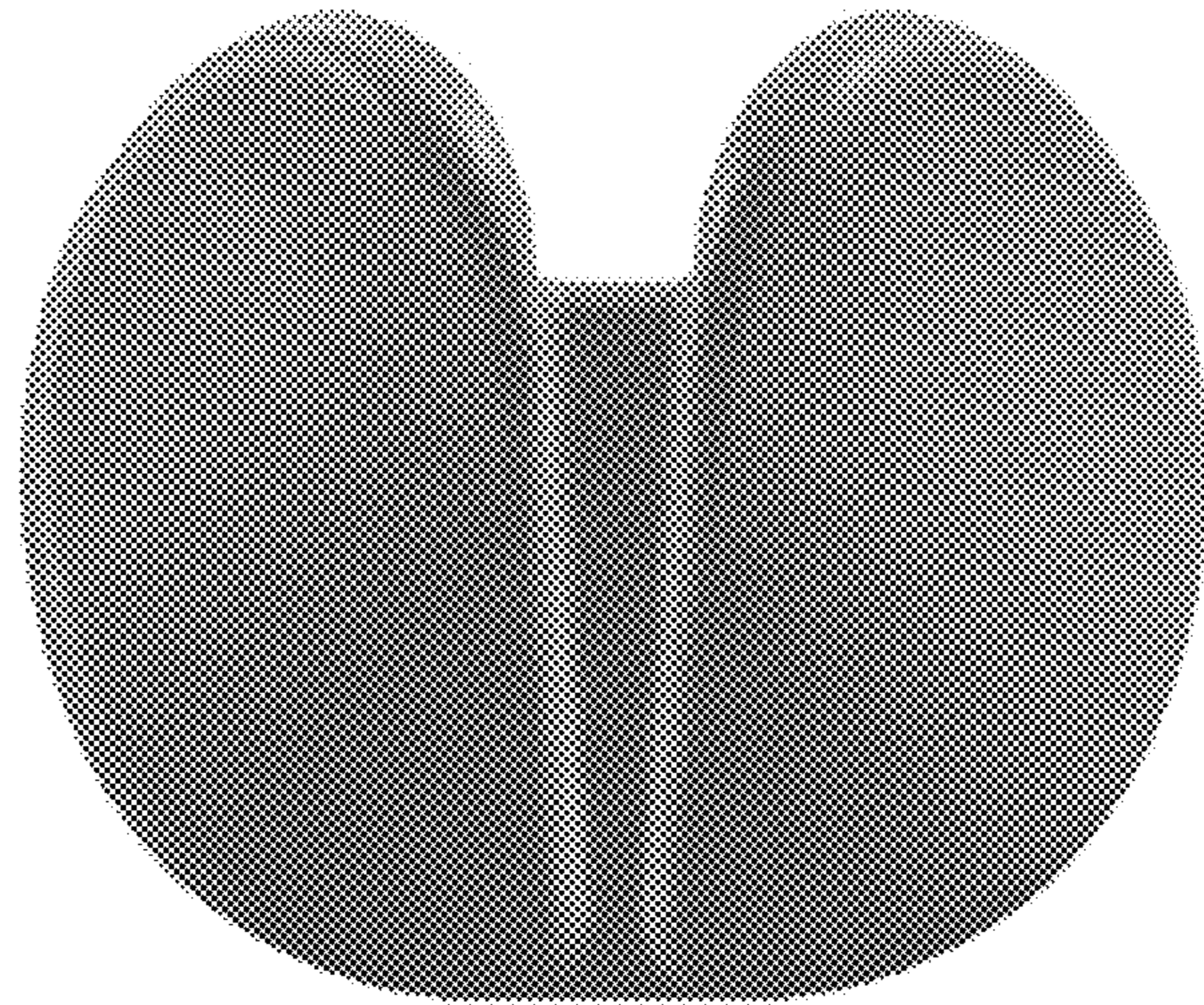

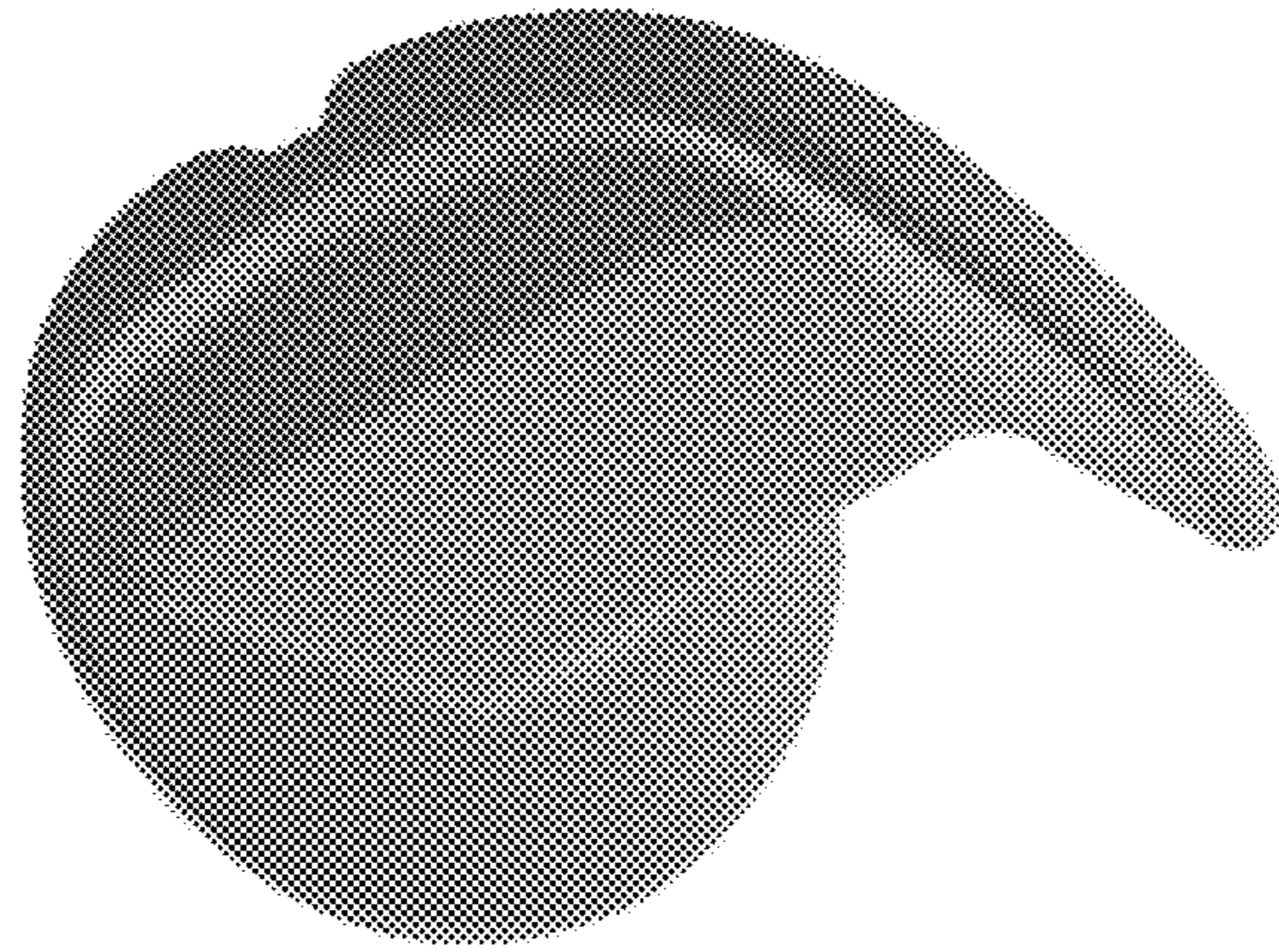

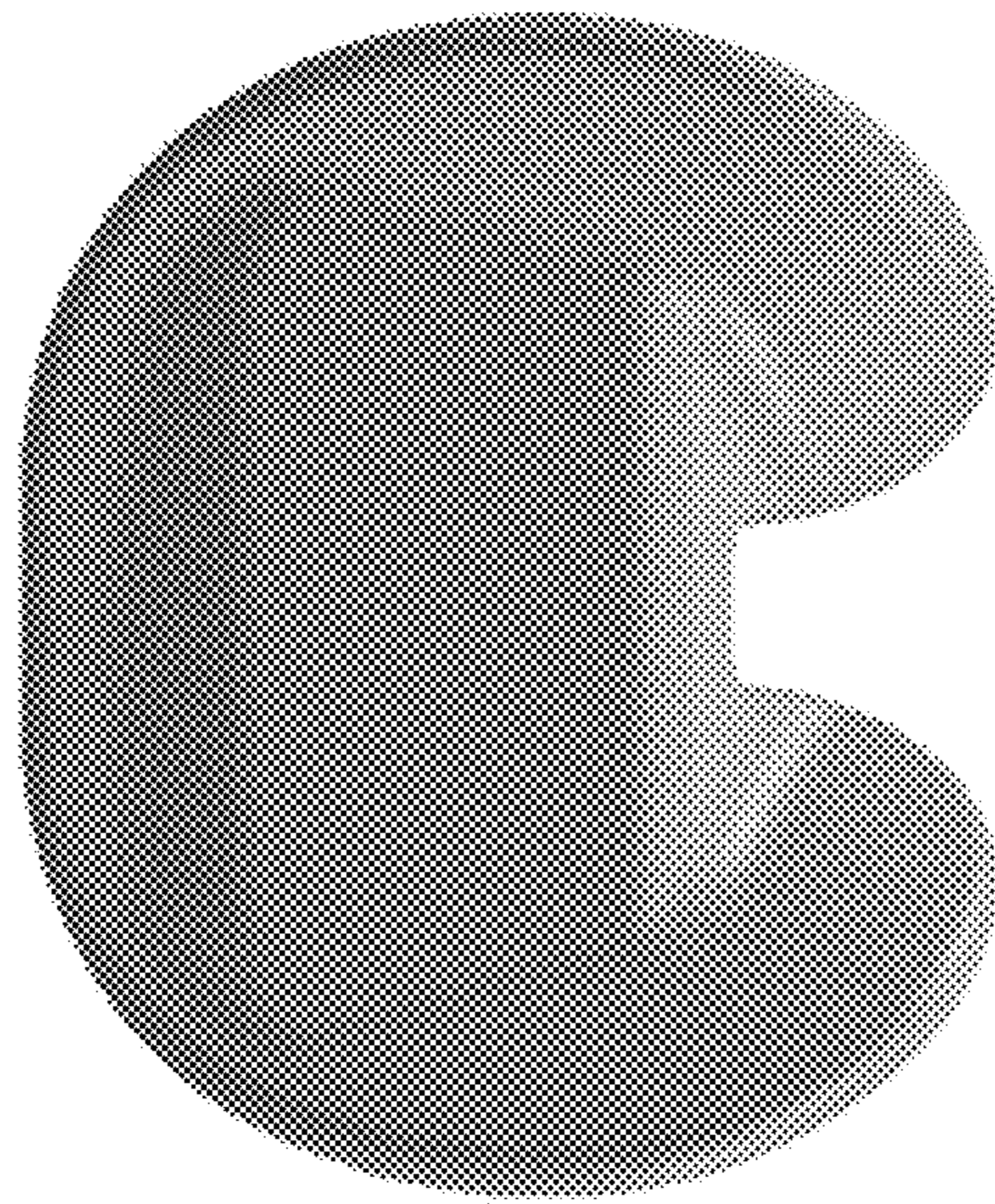
