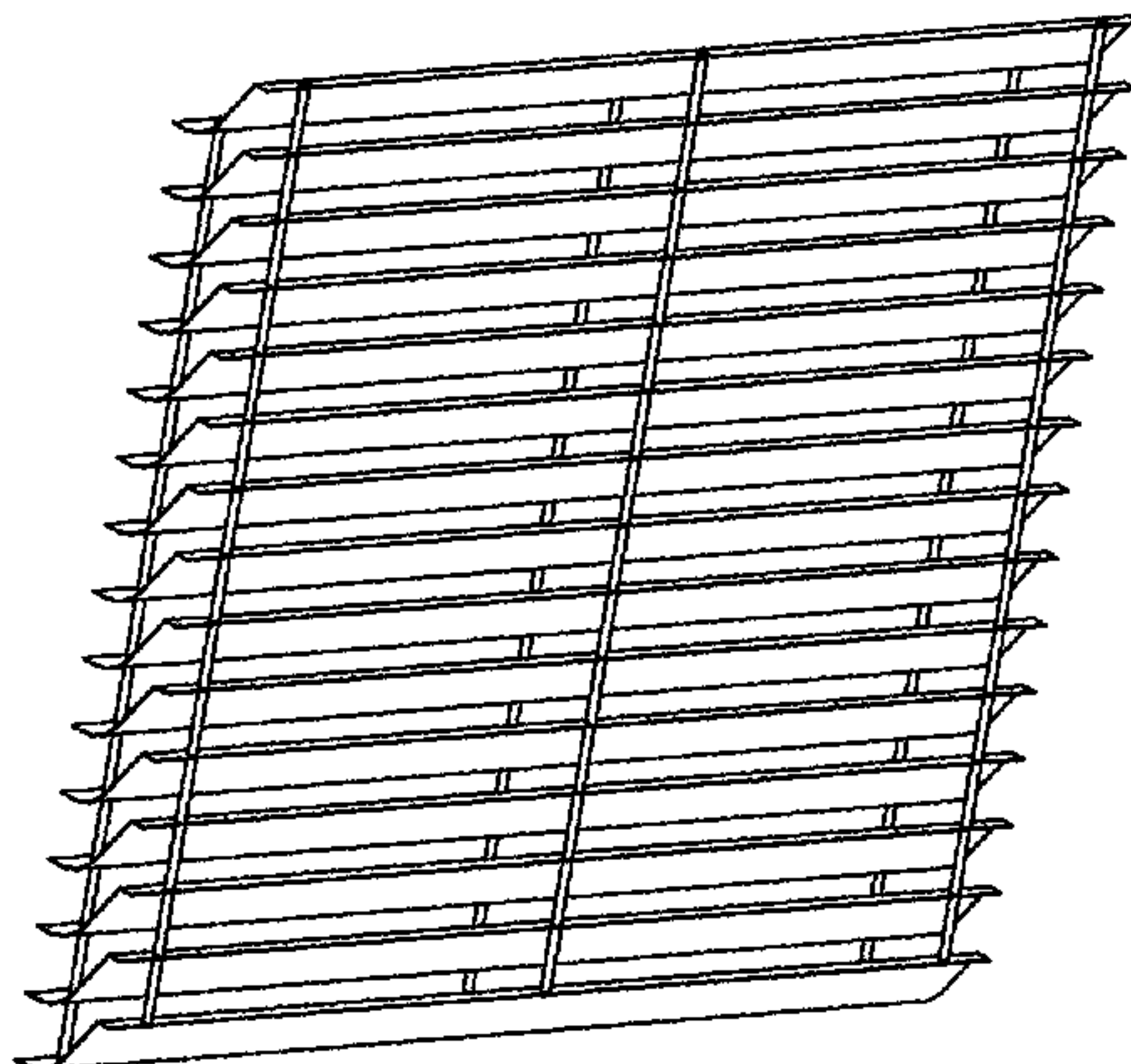
**CLAIM**

I claim the ornamental design for a shade apparatus for  
broiler poultry house, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shade apparatus for a  
broiler poultry house according to the invention;

FIG. 3 is a front elevation view thereof;

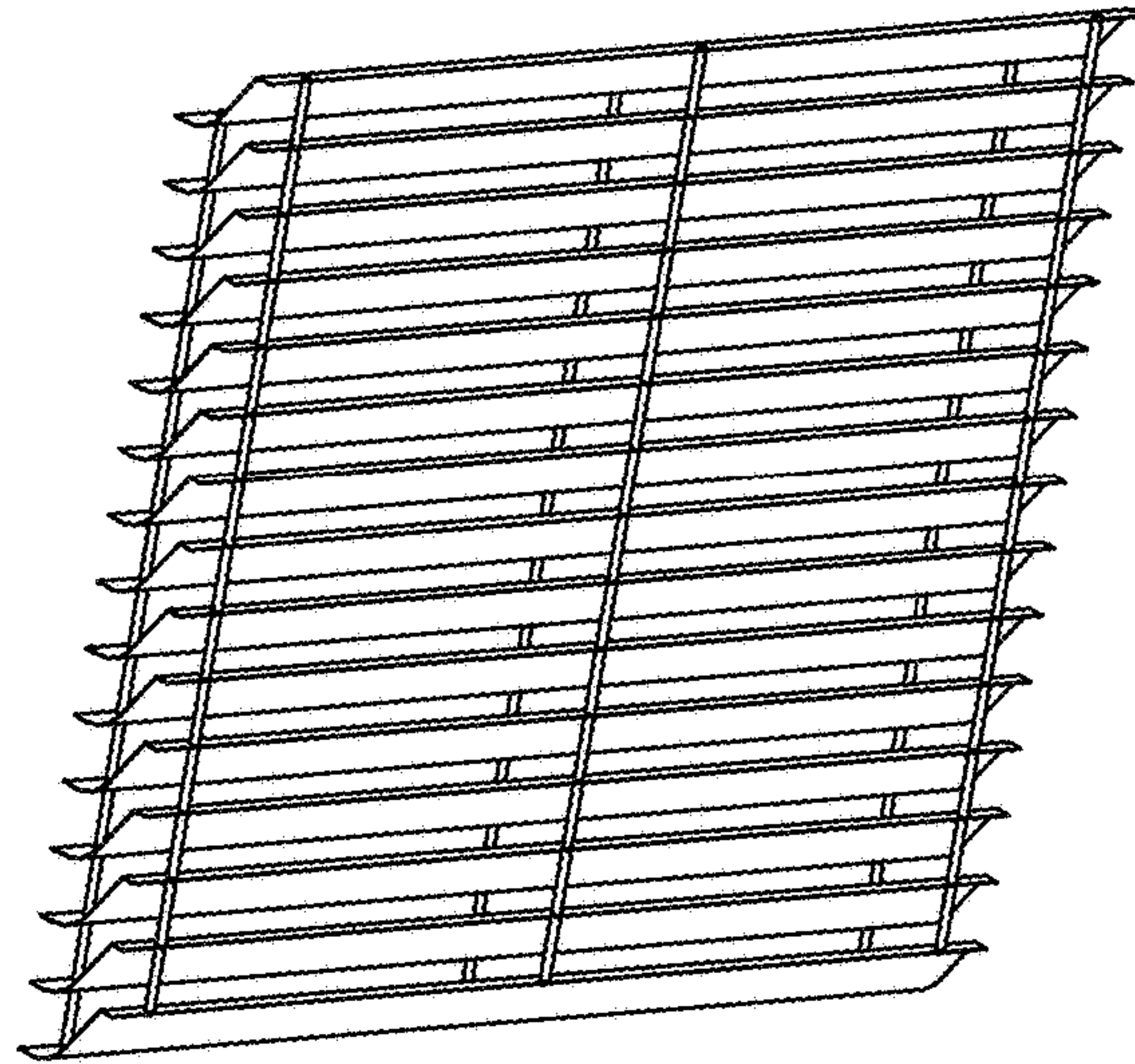

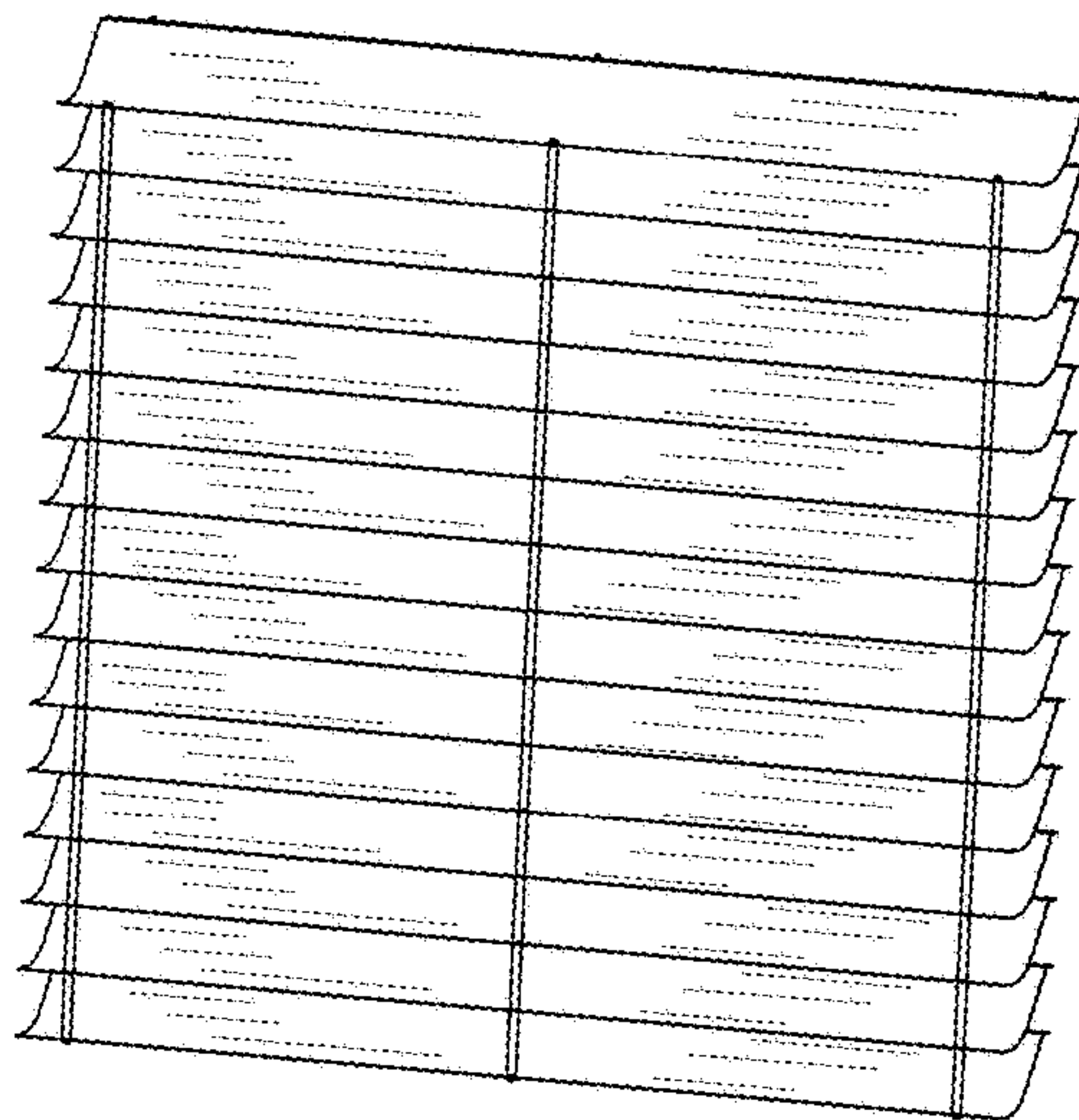

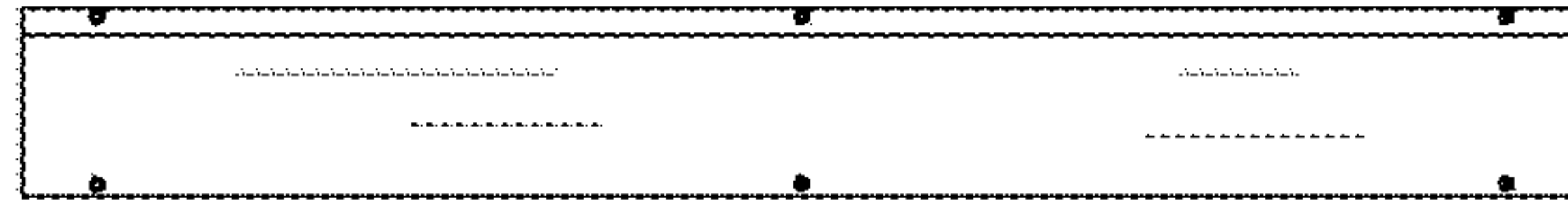

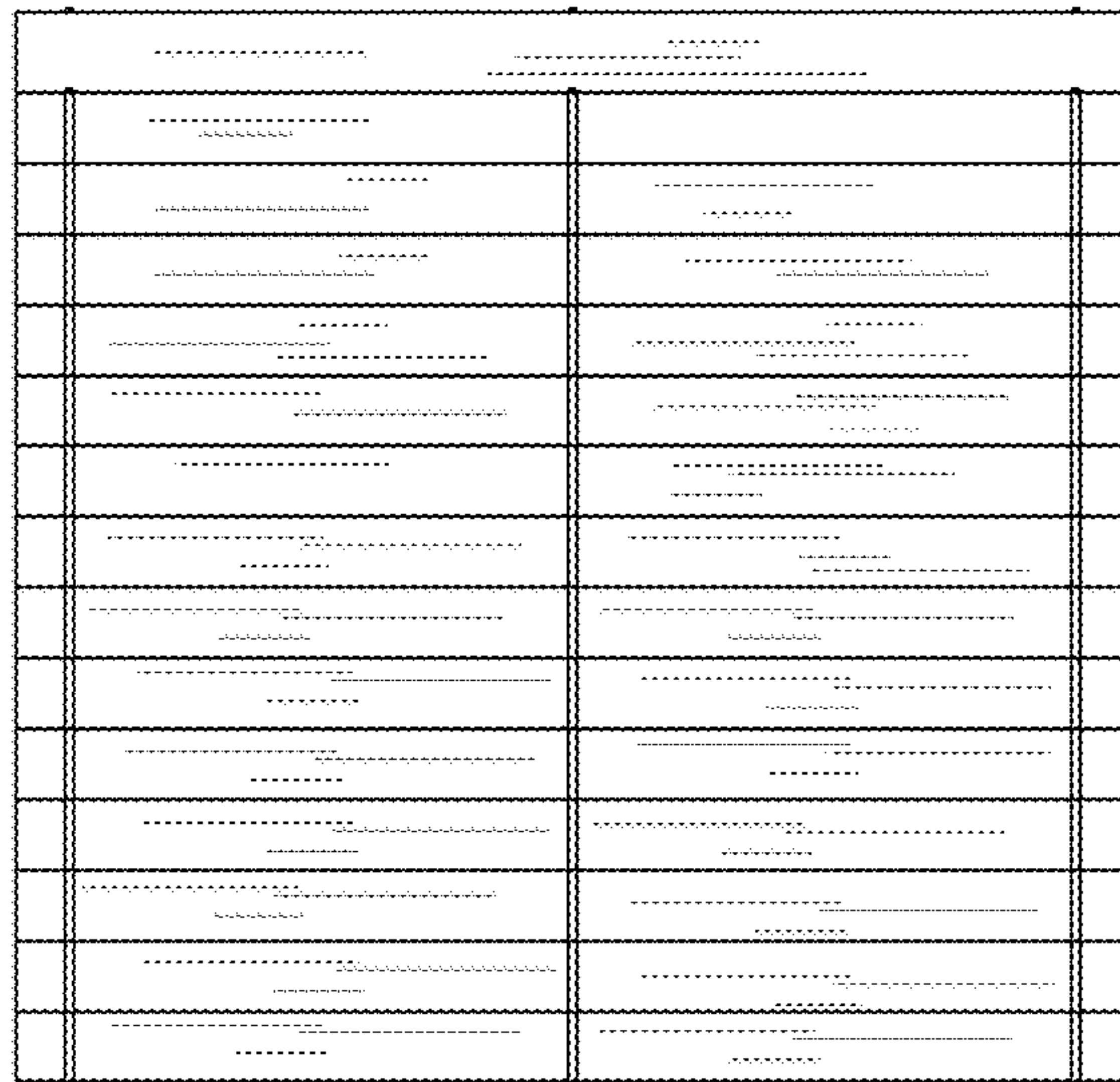

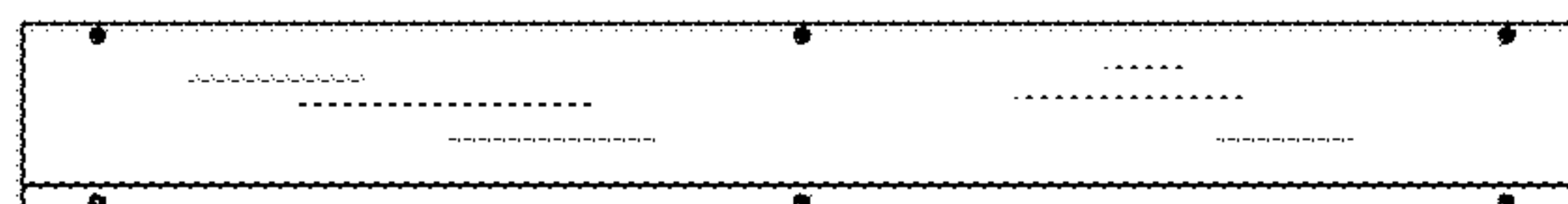

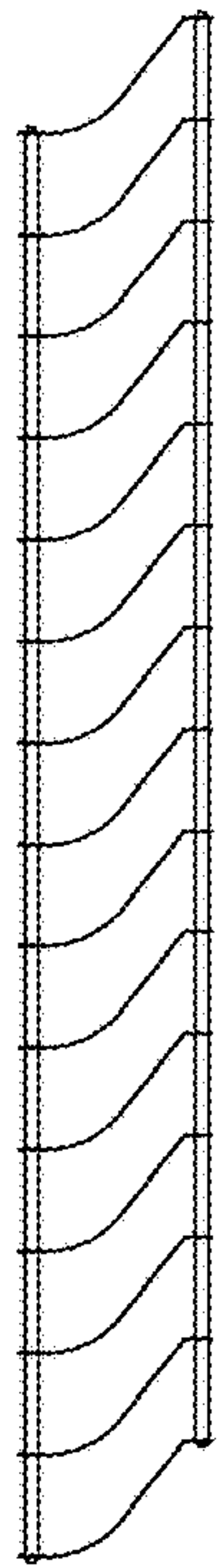

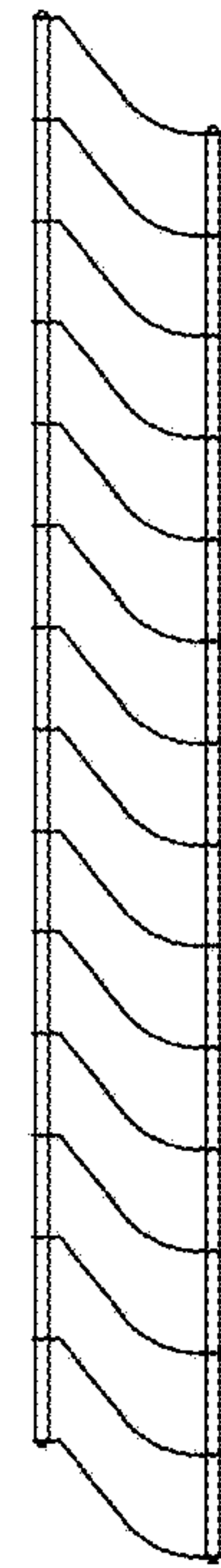
