(57) **CLAIM**

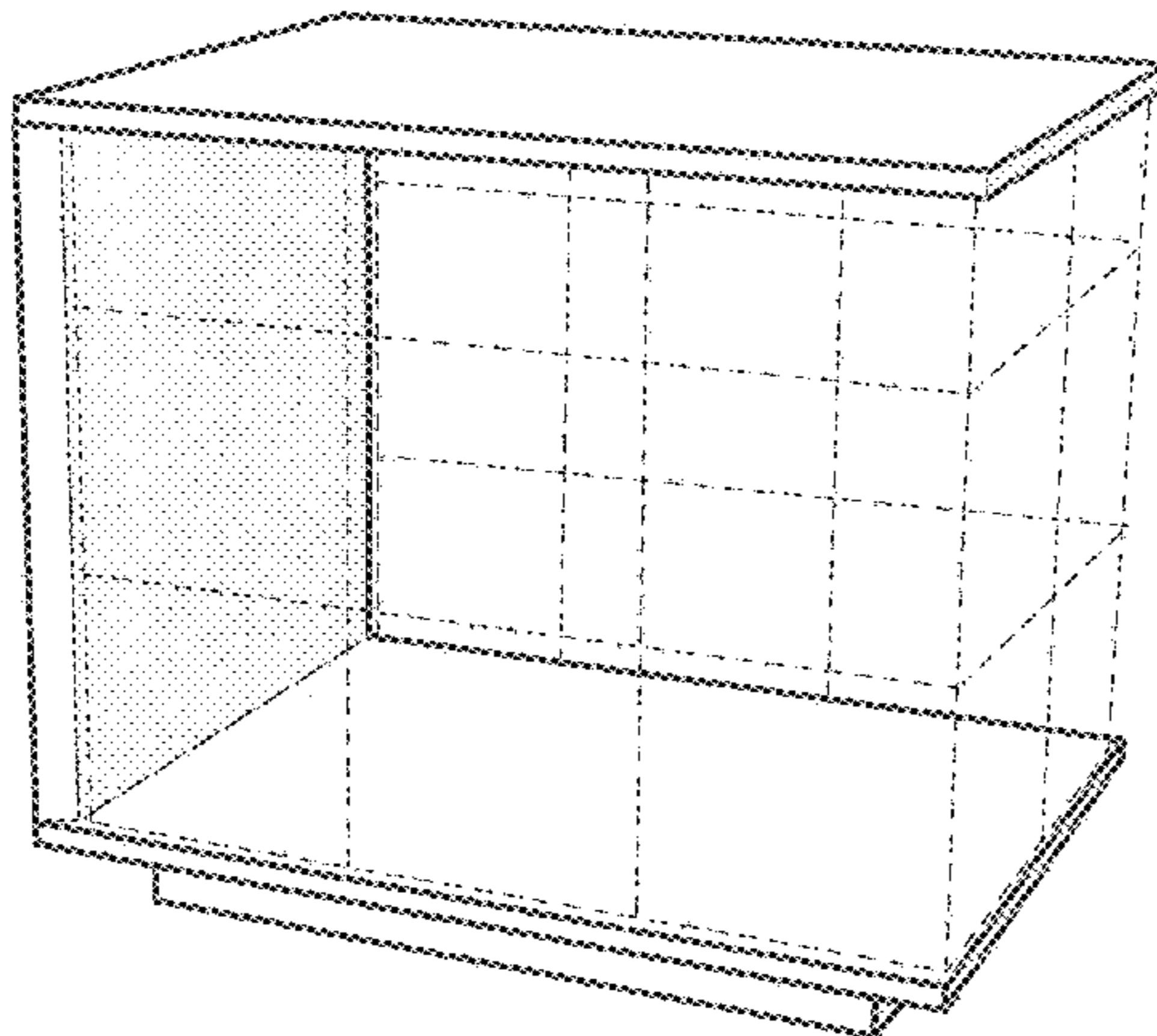
The ornamental design for a furniture and animal crate assembly, as shown and described.

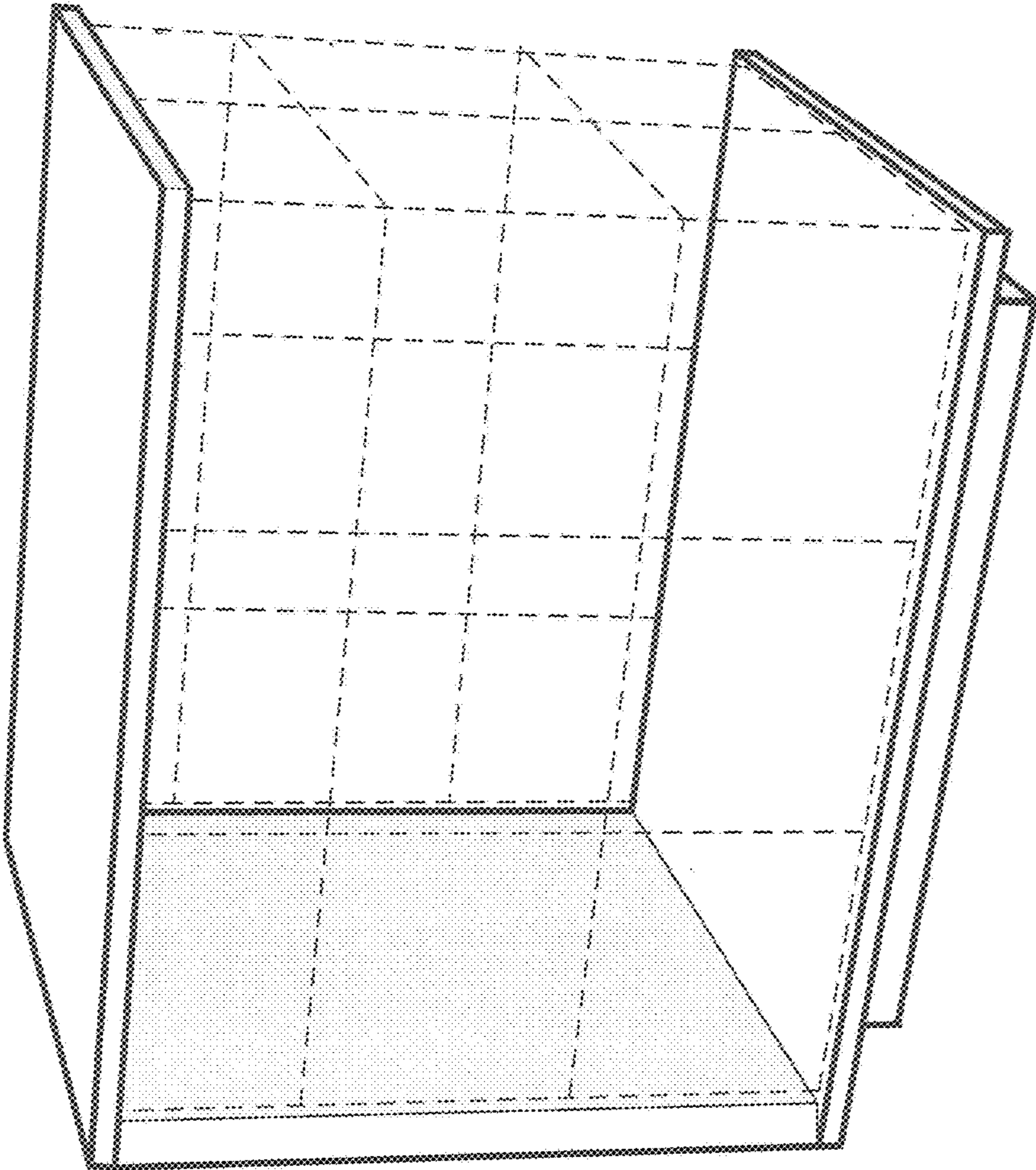

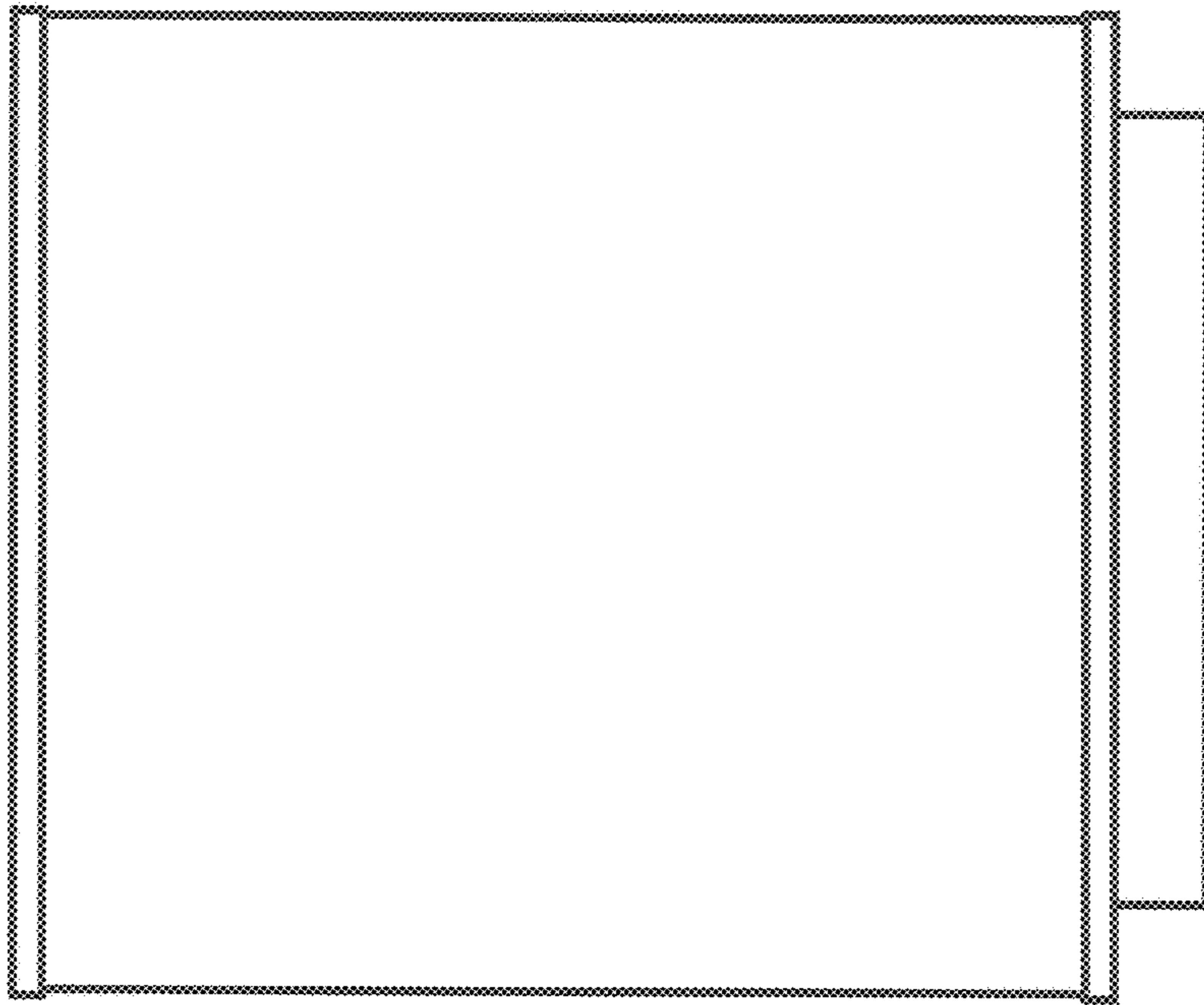

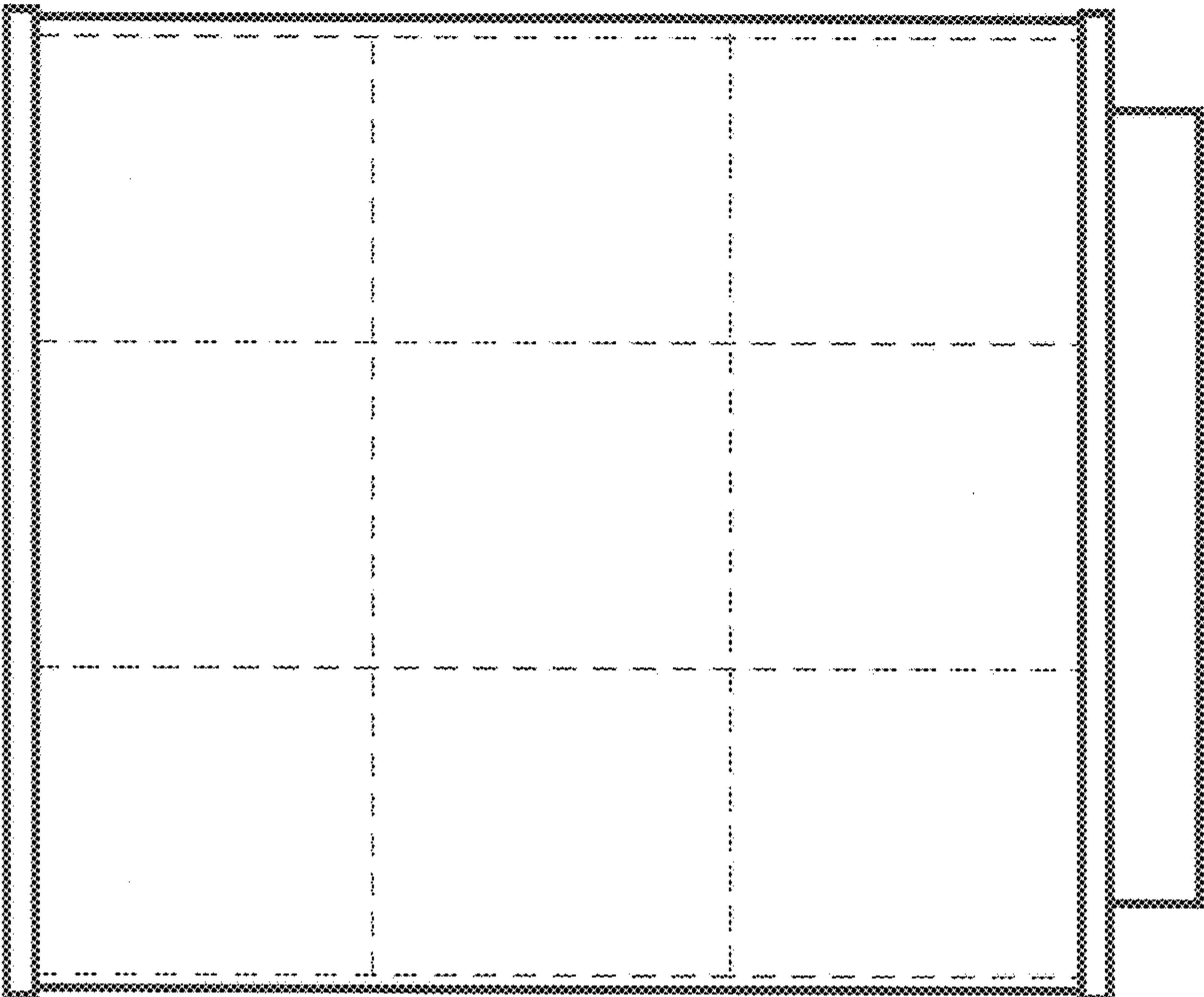

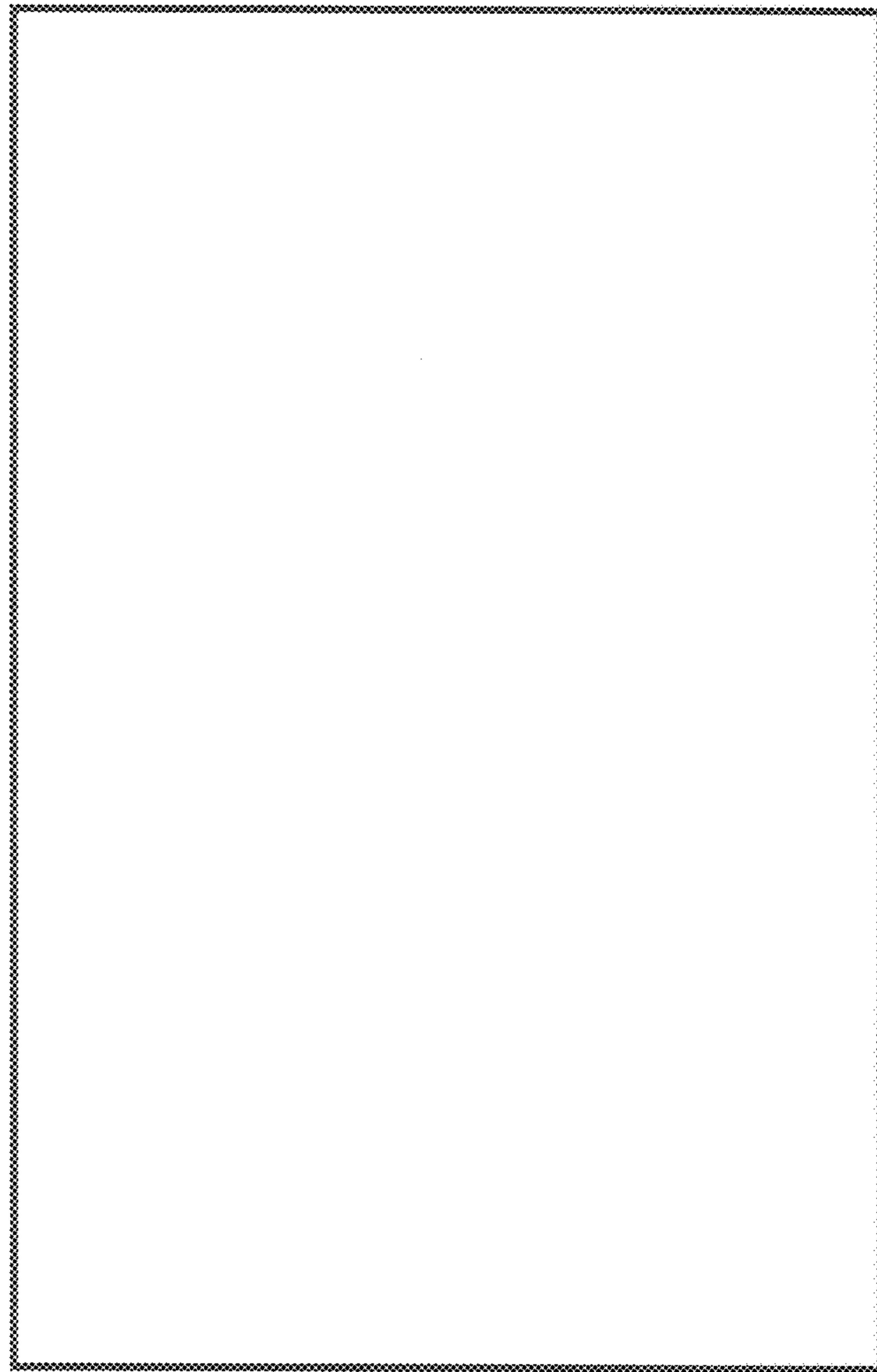

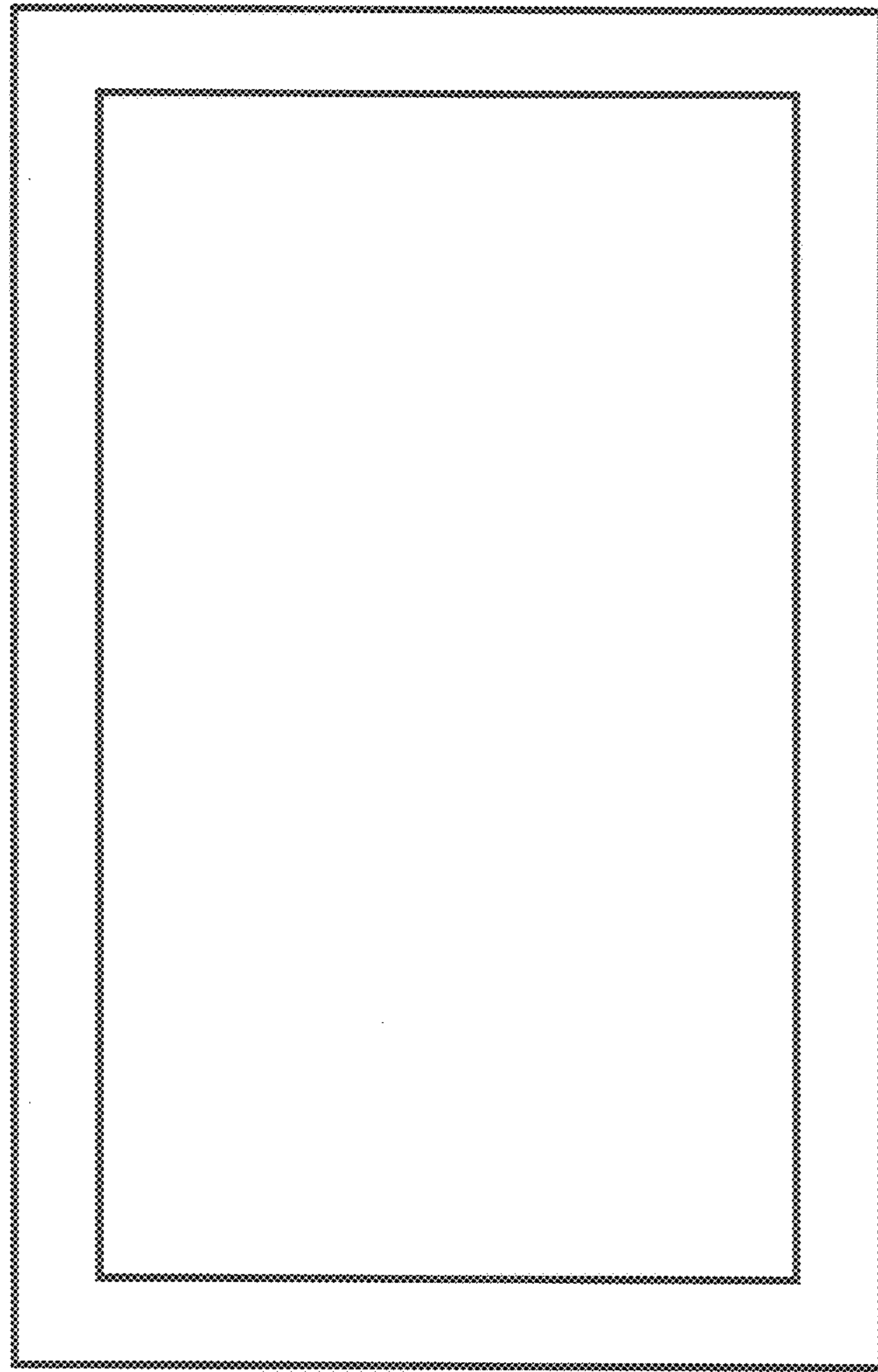

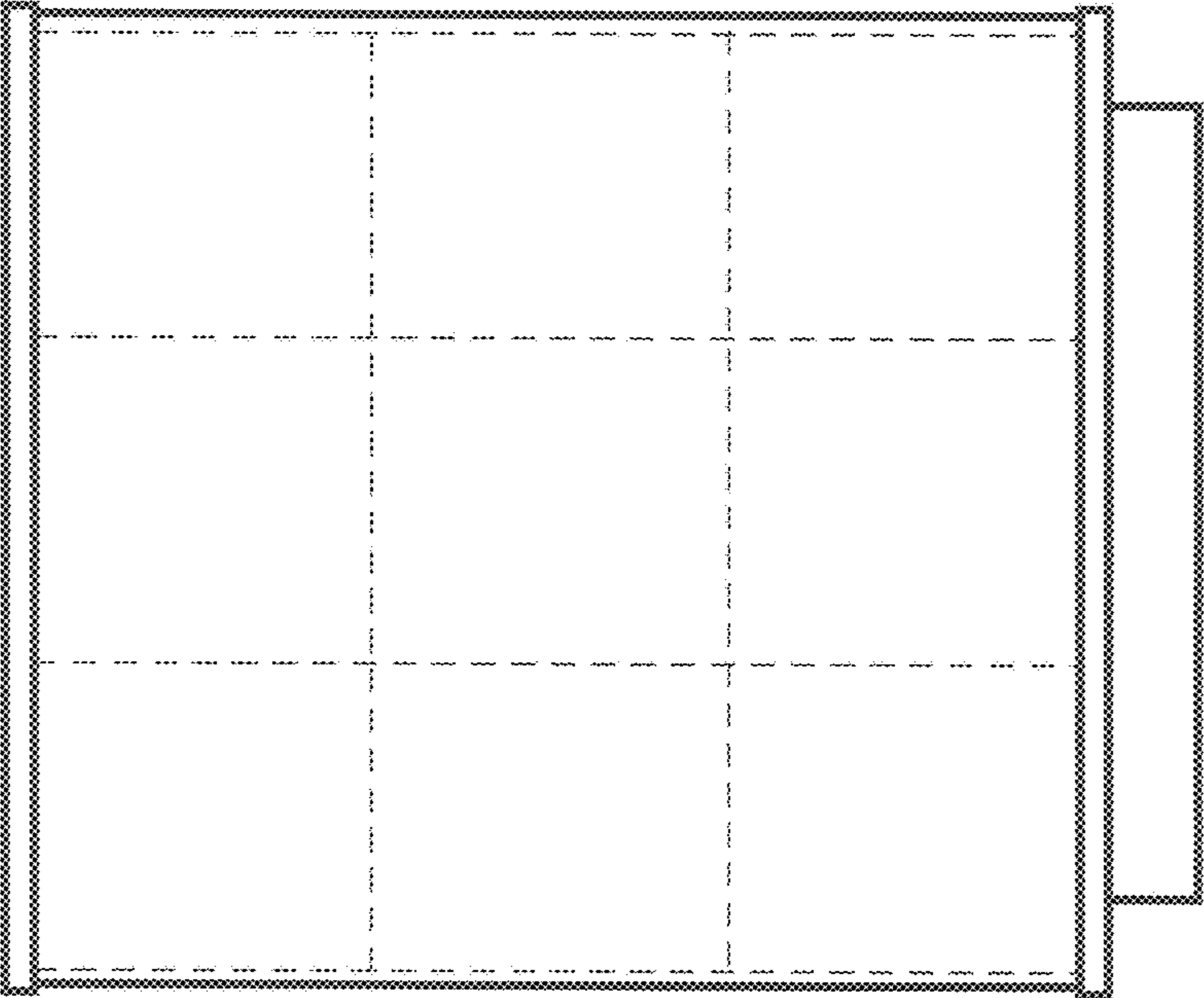

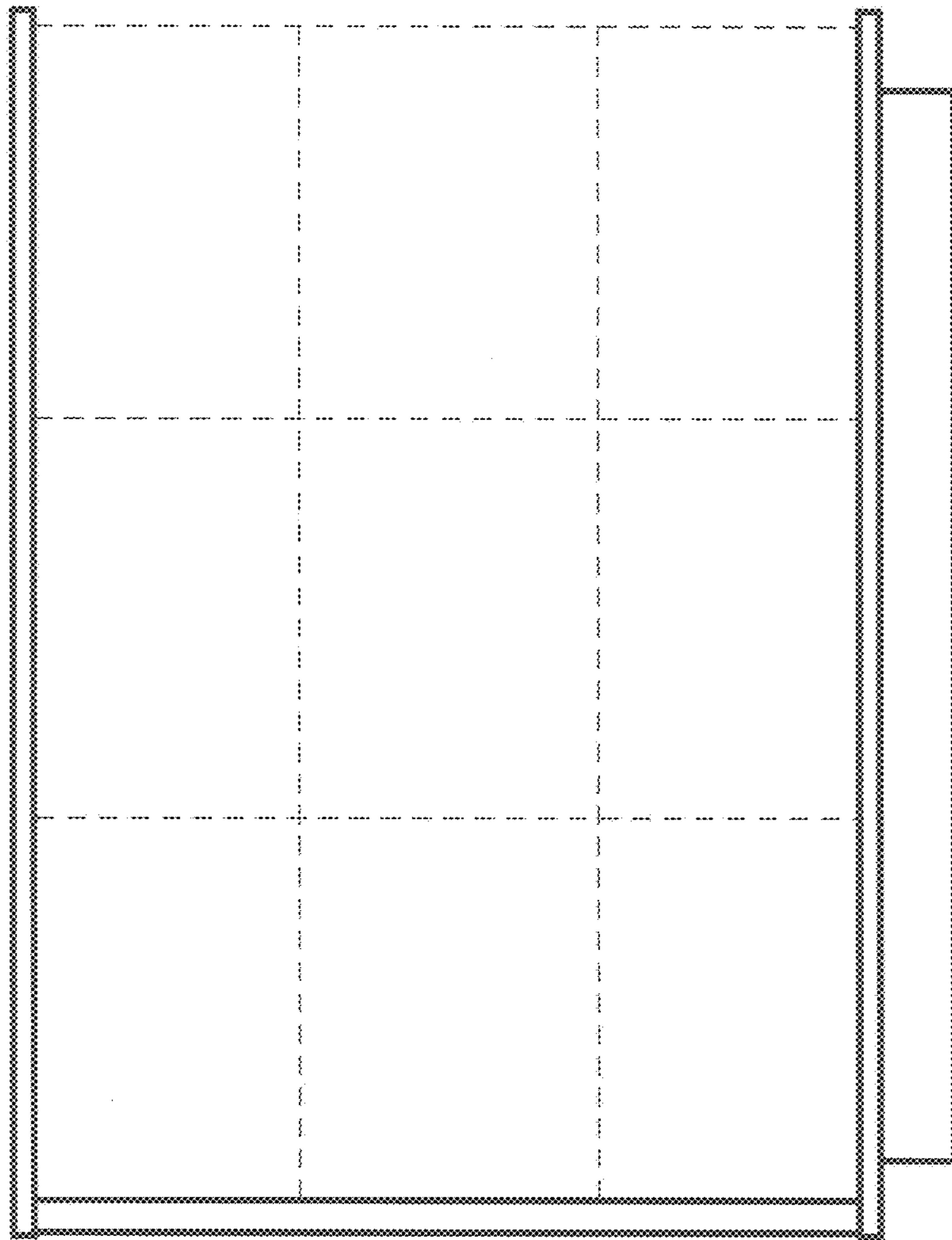
