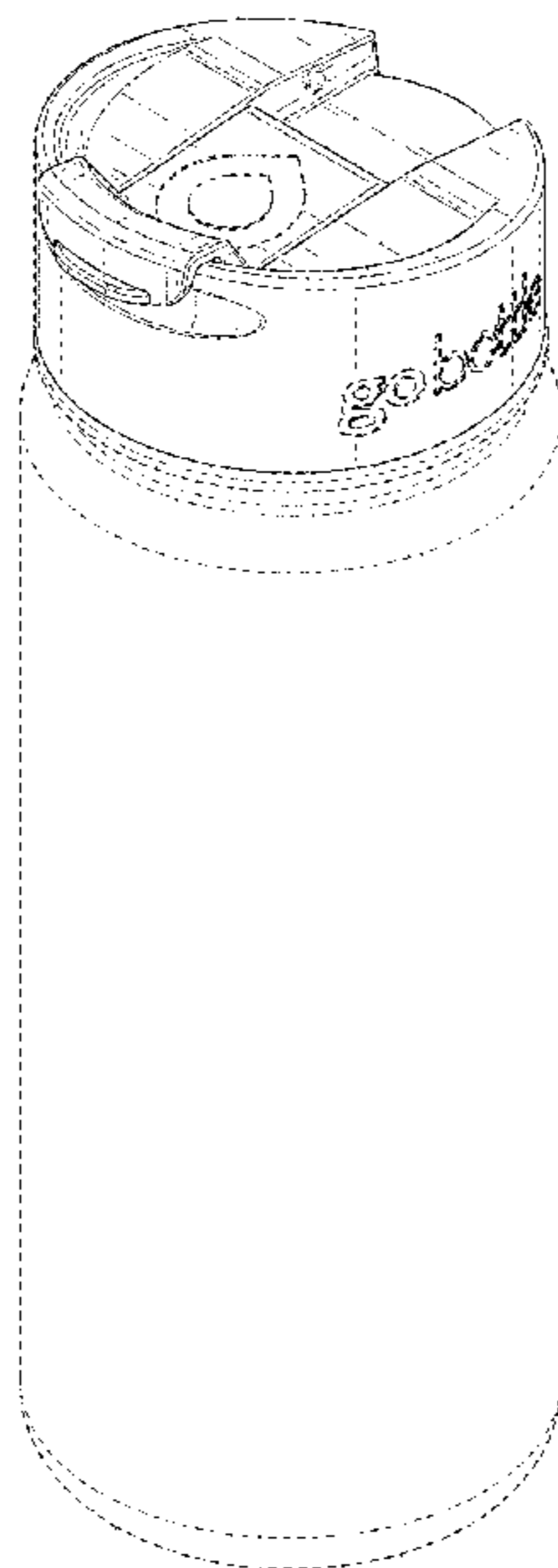
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top, right perspective view of a lid for a container showing my new design;
FIG. 2 is a front view thereof;

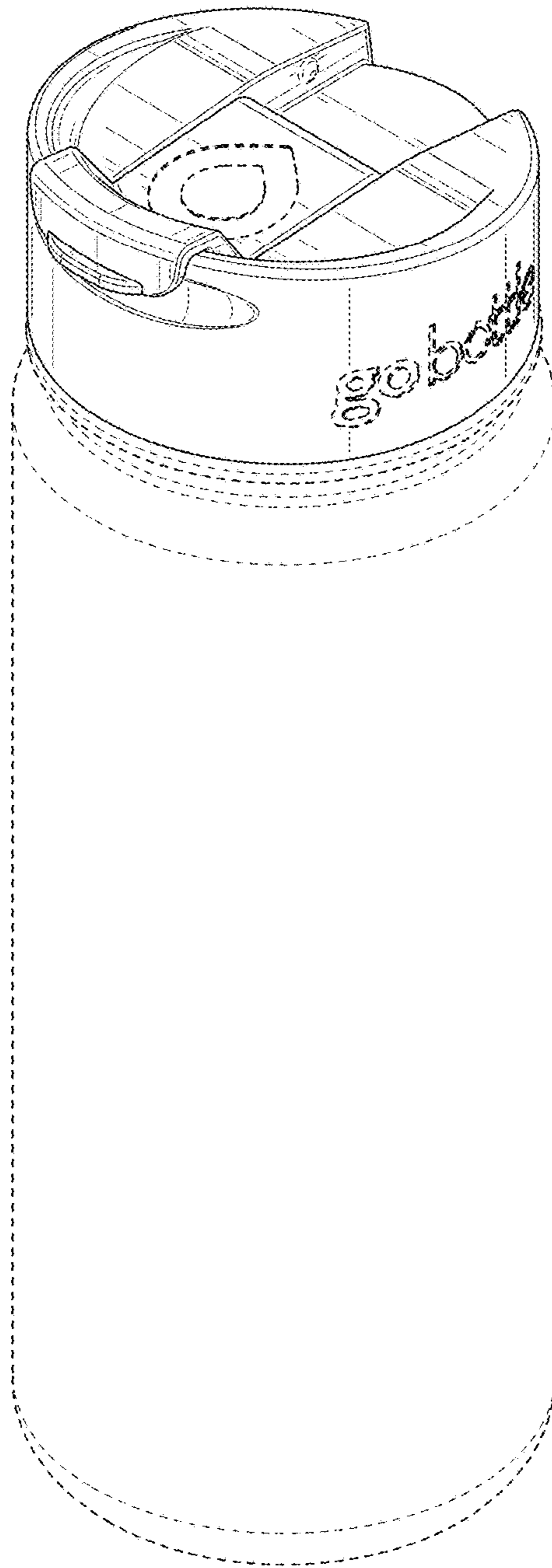

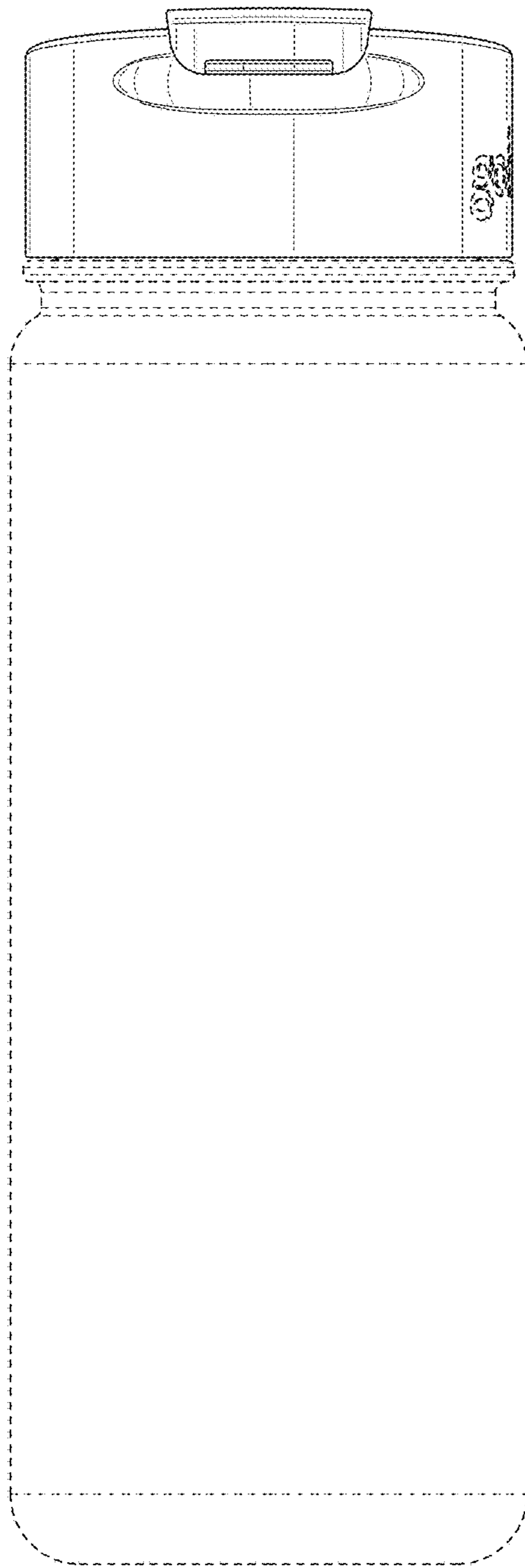

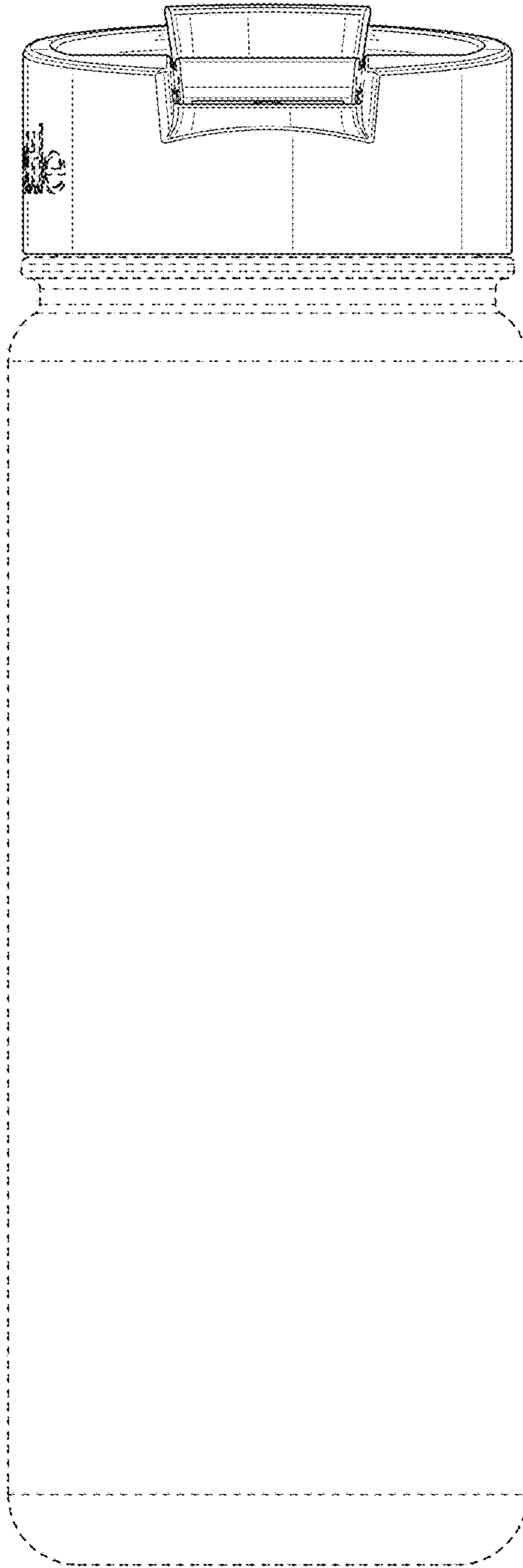

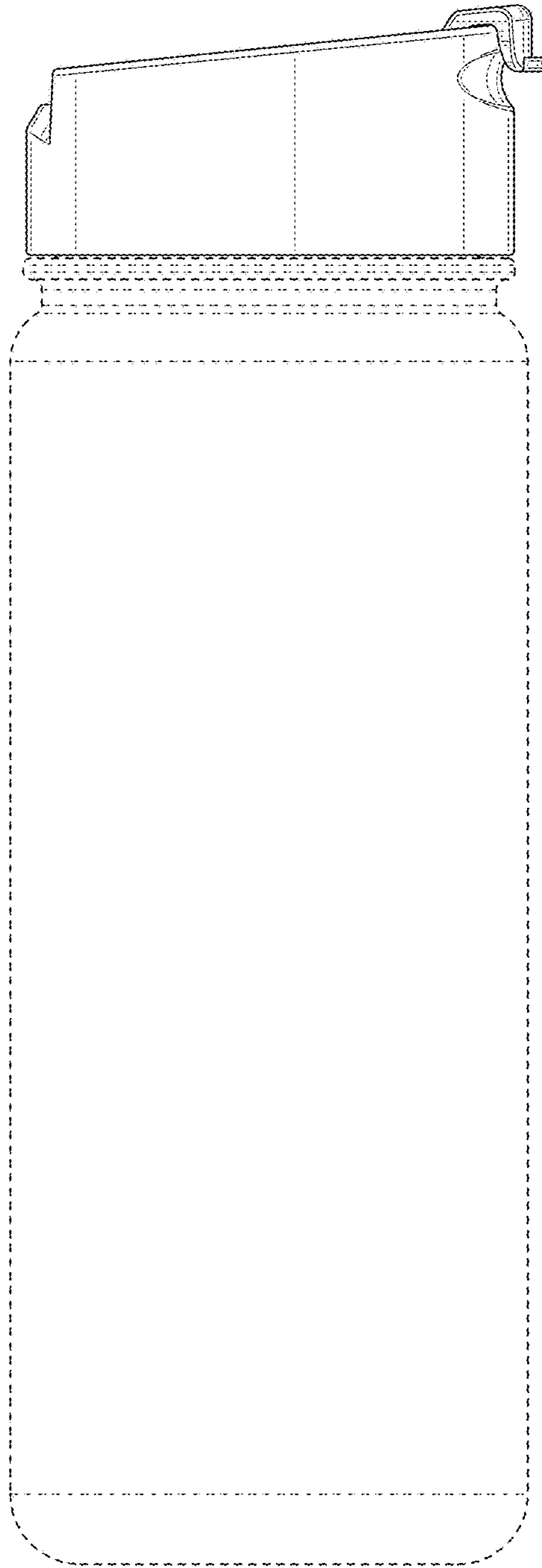

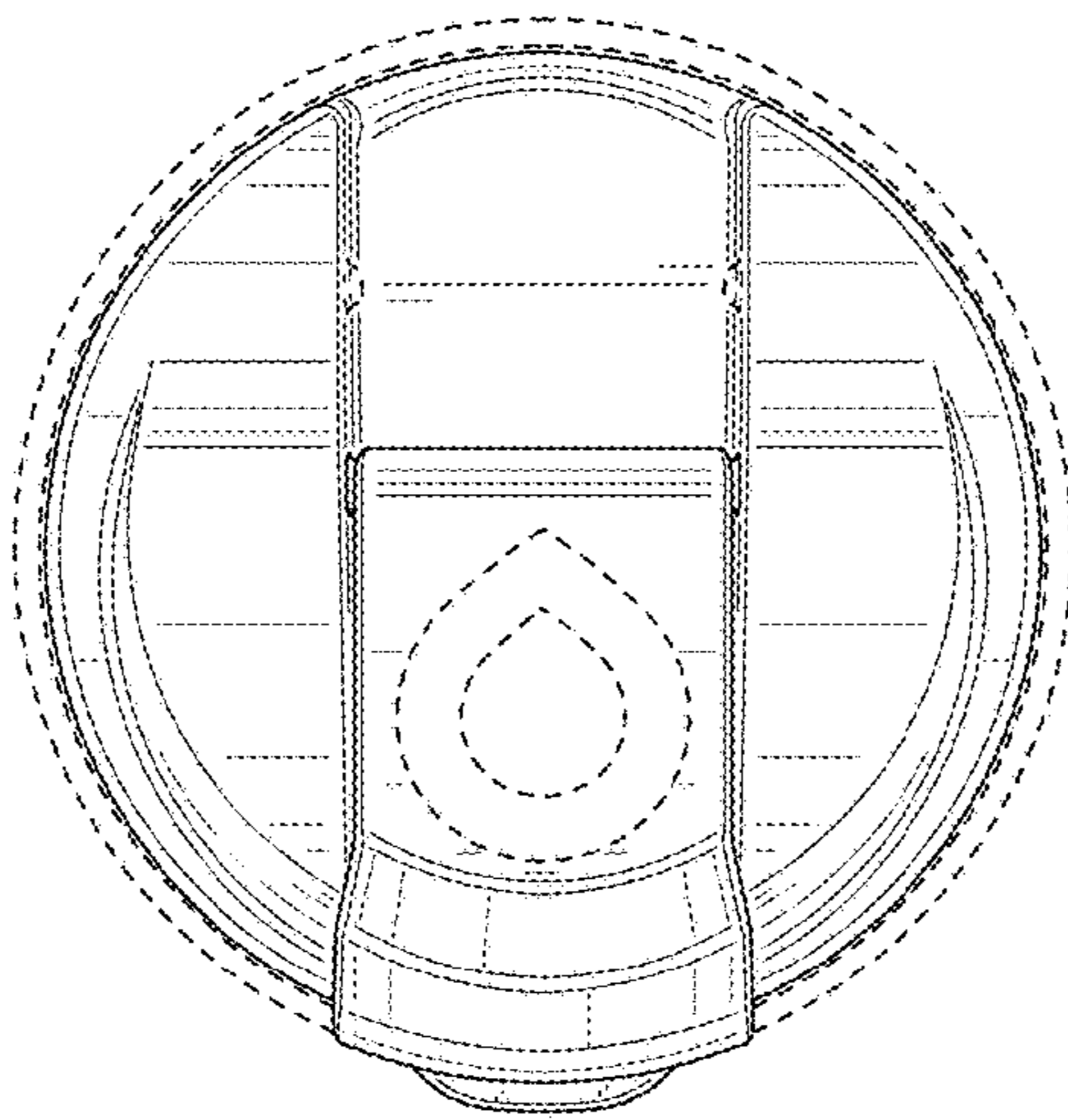

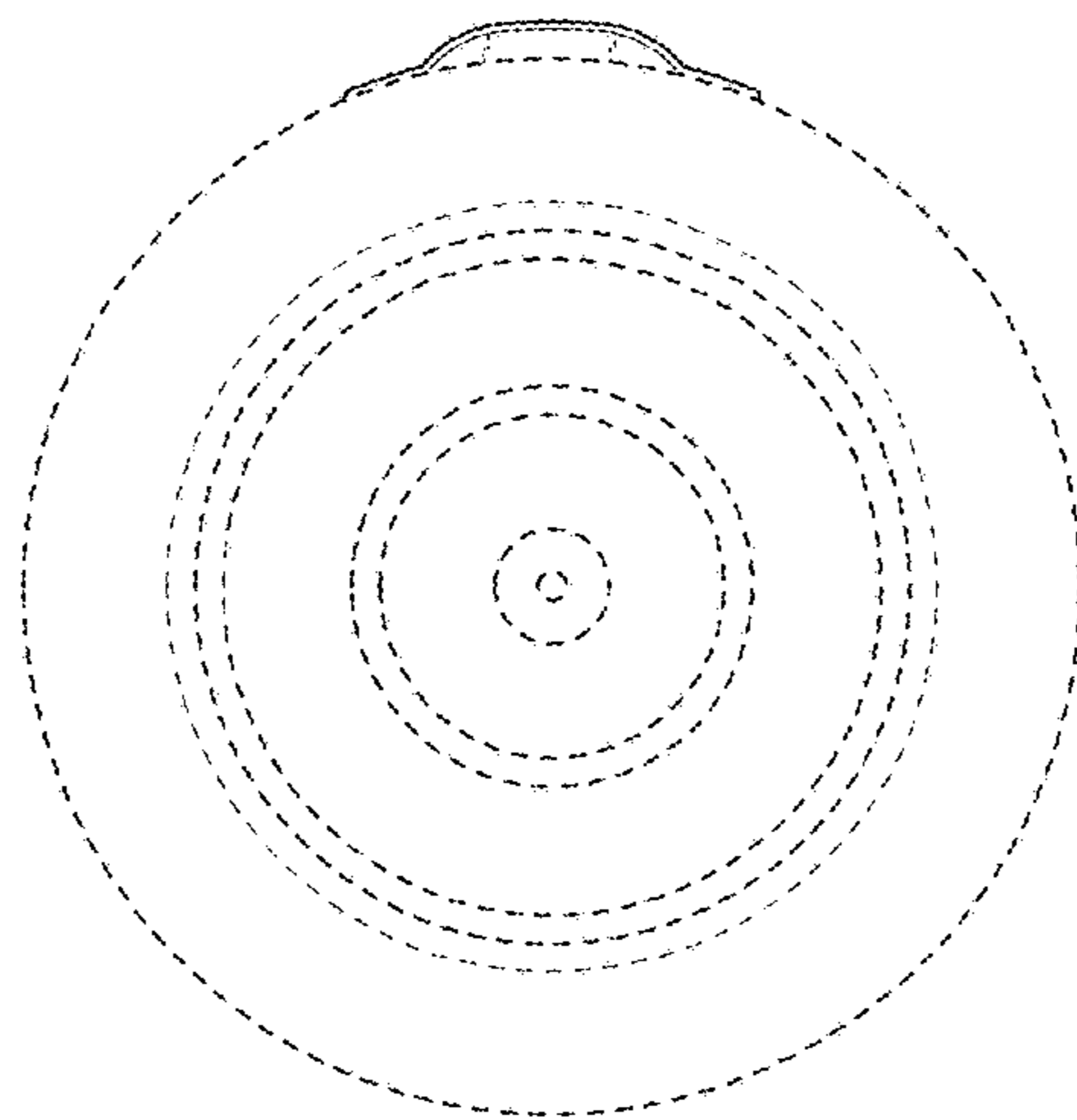
