FIG. 4 is a top view of the container wheel without the attachment assembly, for clarity of disclosure;

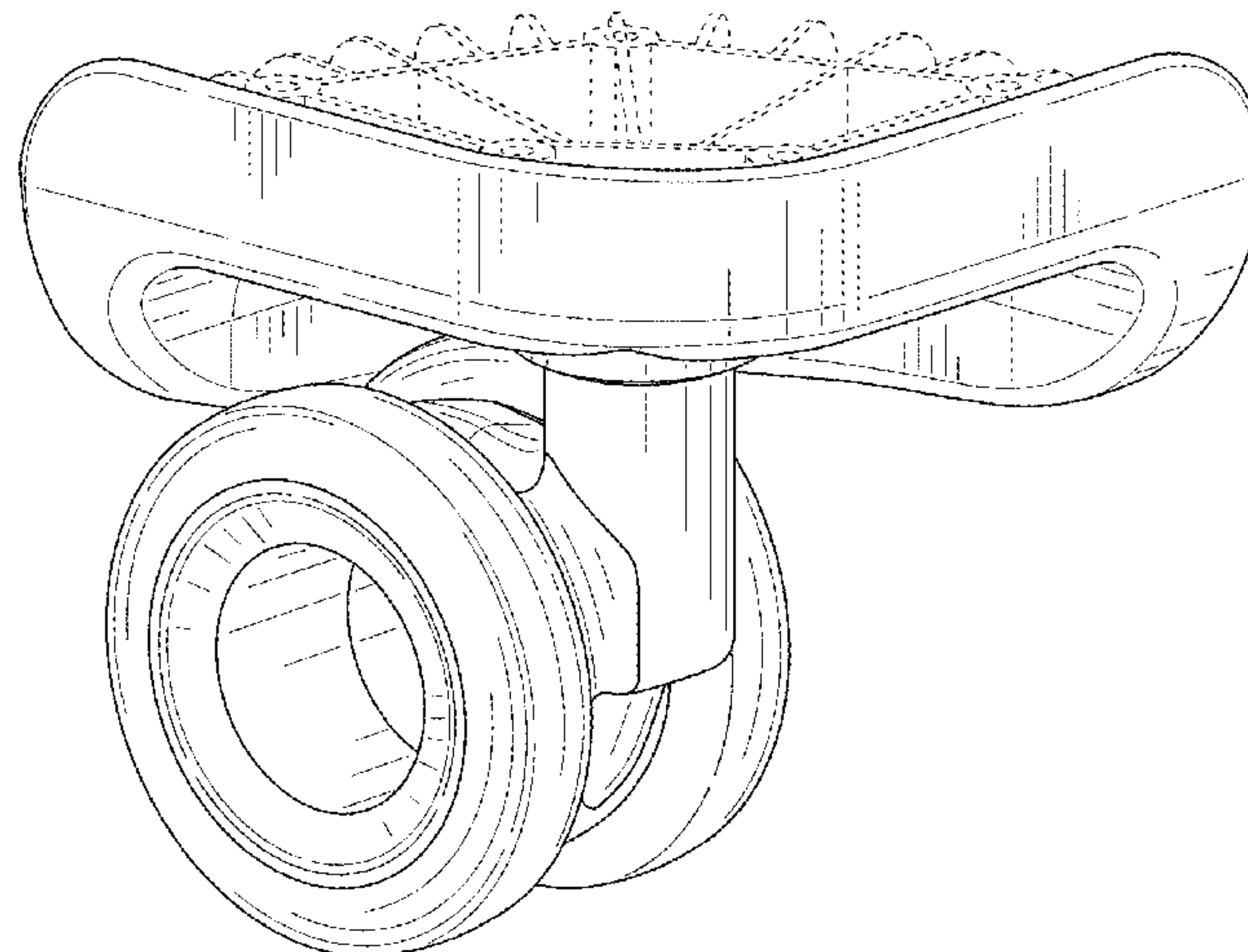
FIG. 5 is a top perspective view of the container wheel in an environment of use.

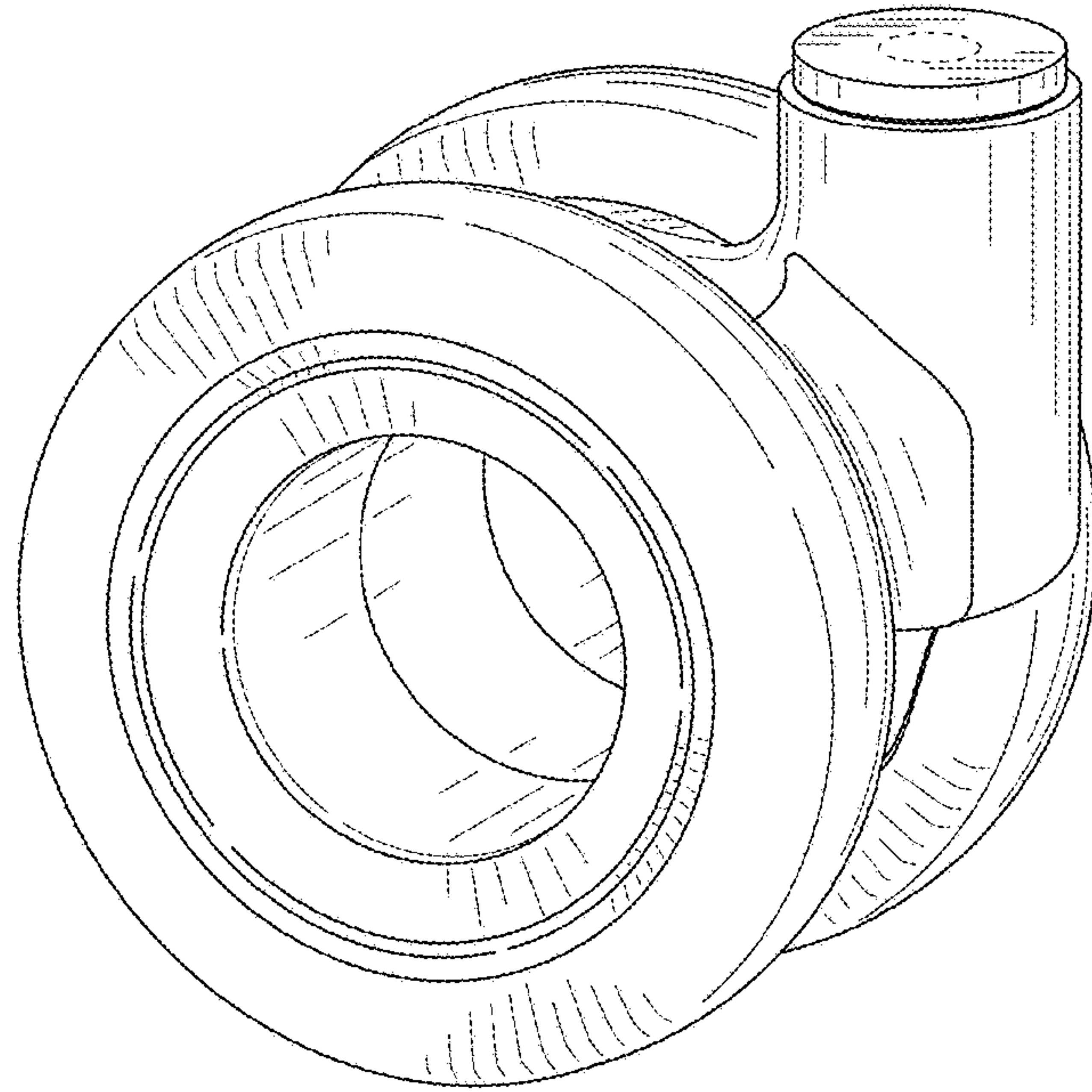

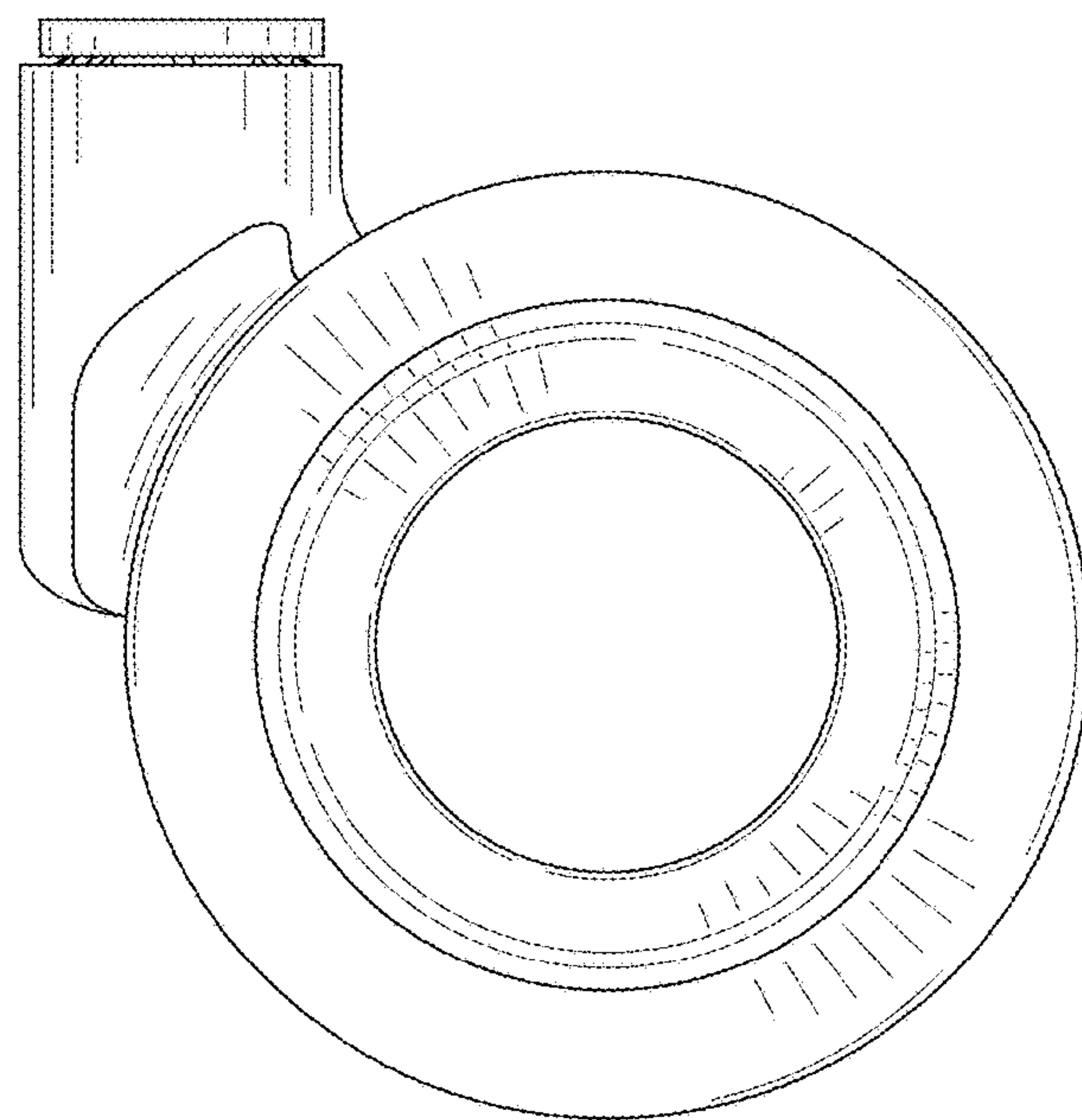

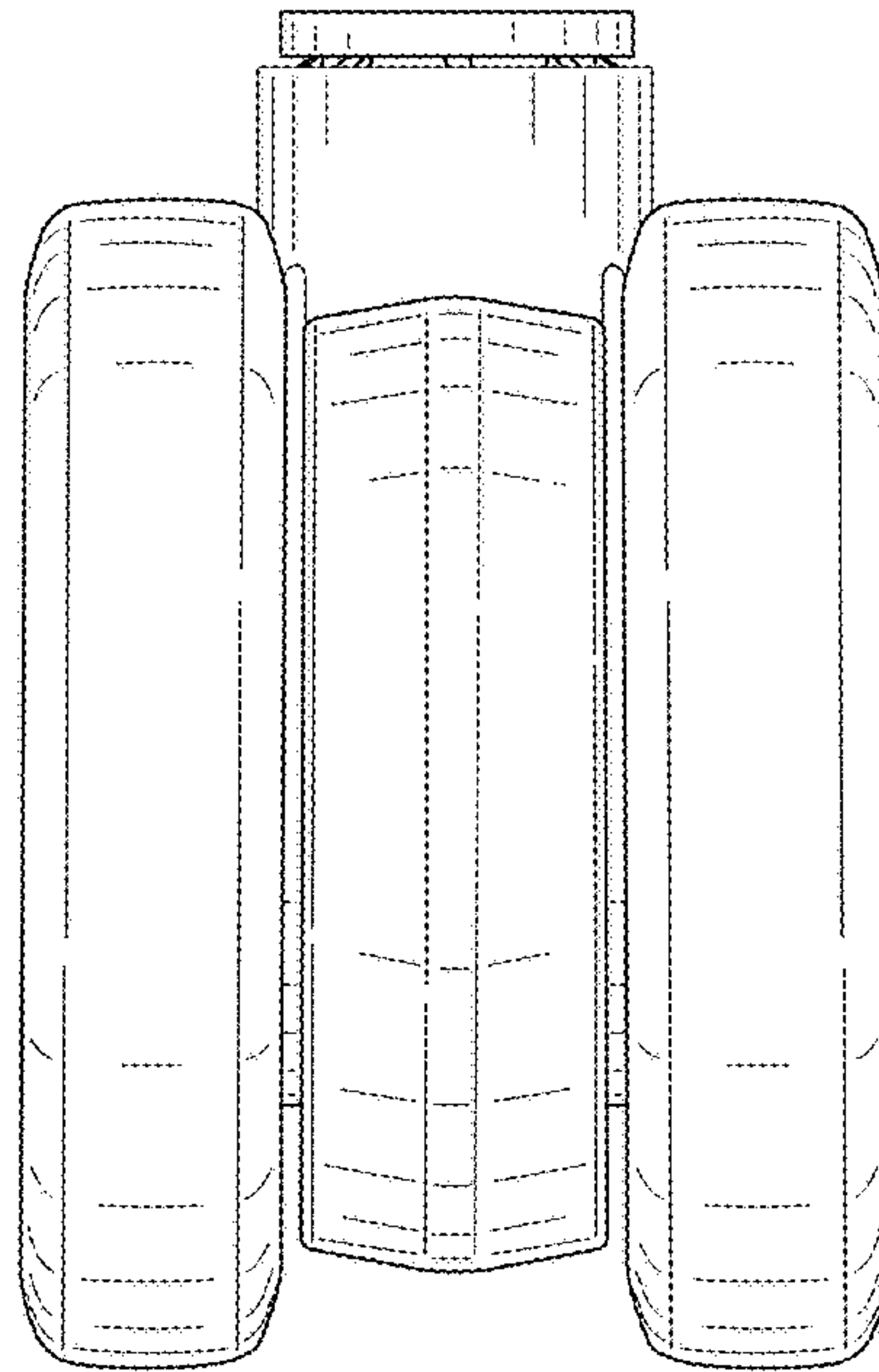

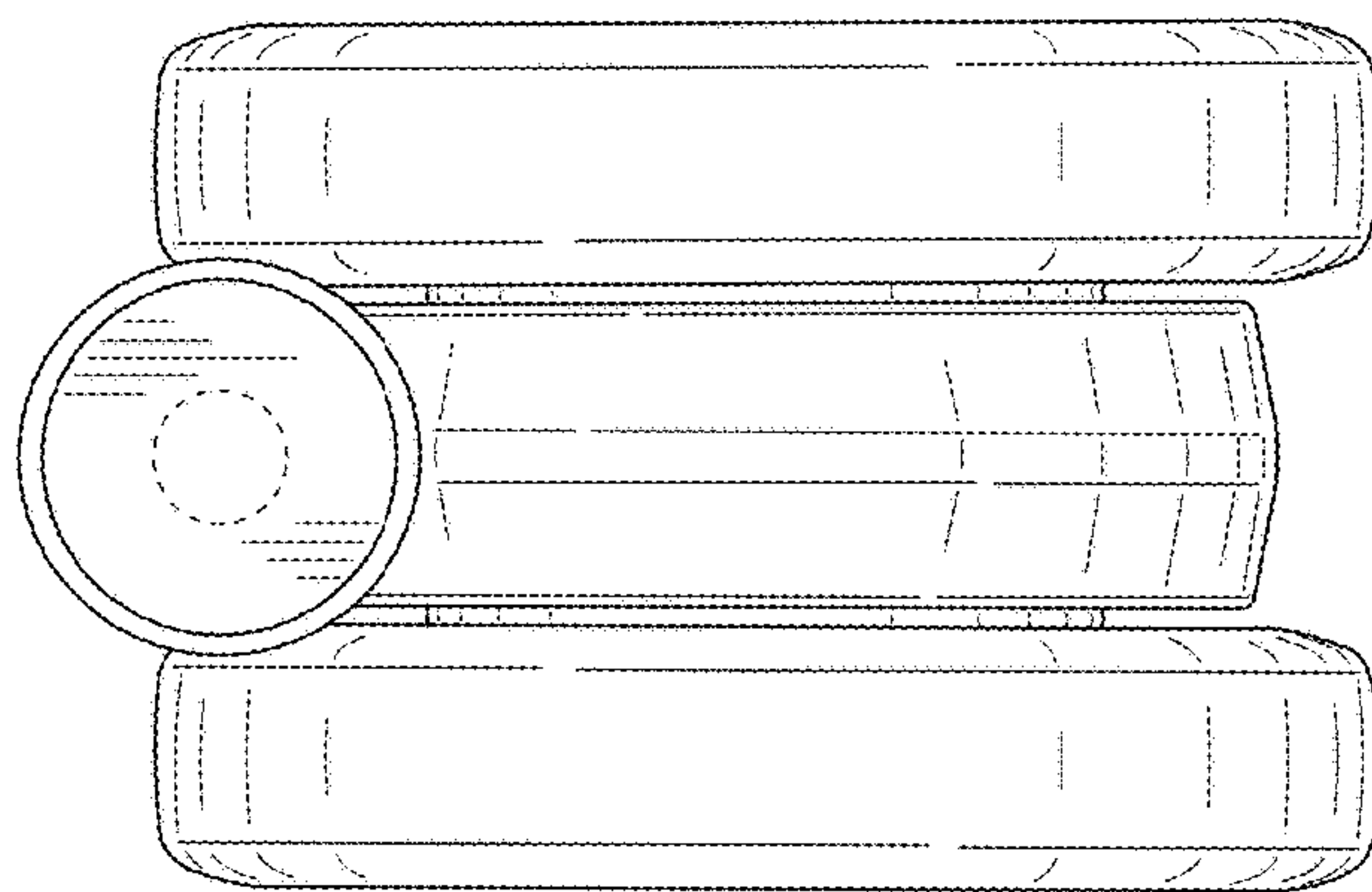

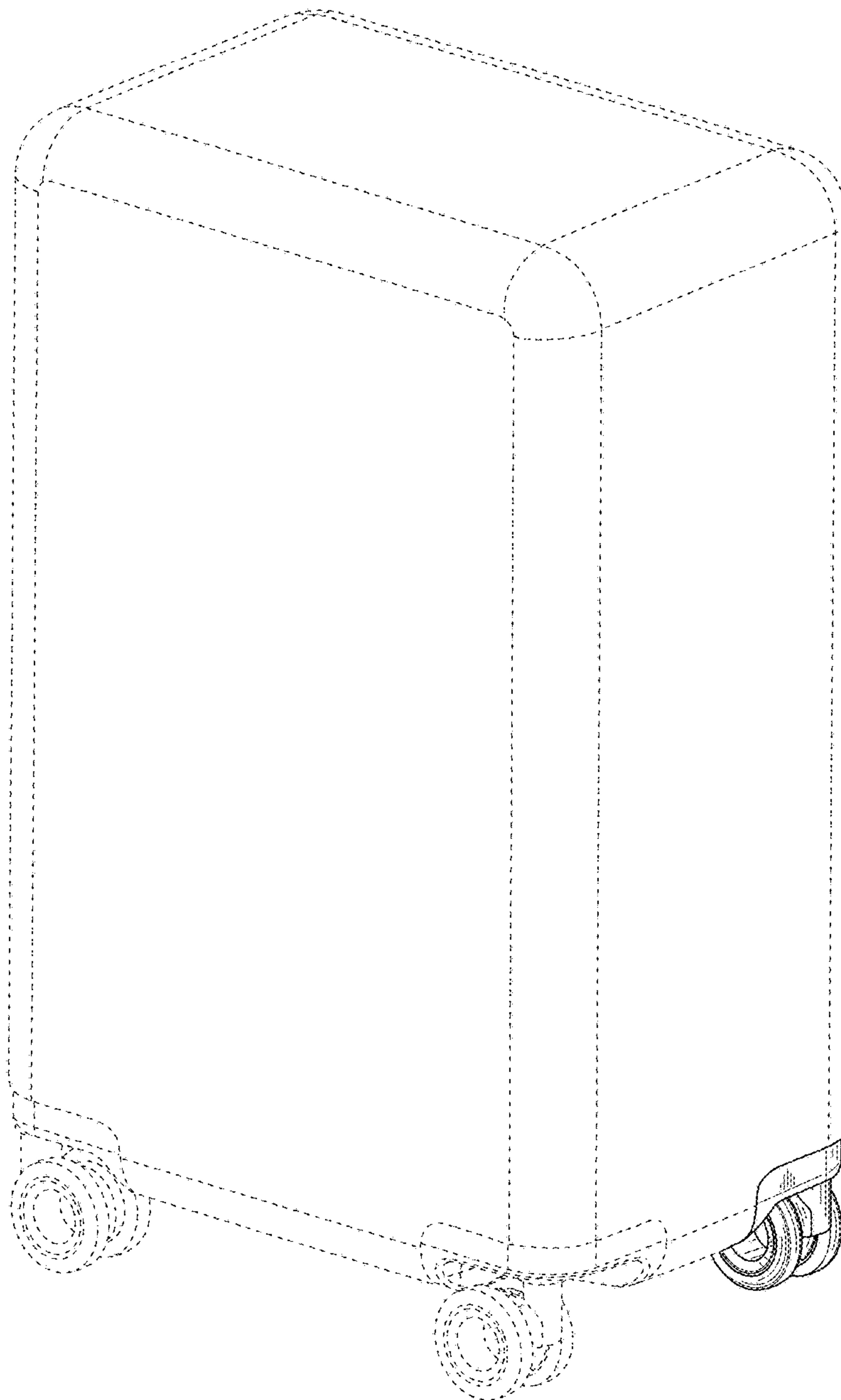

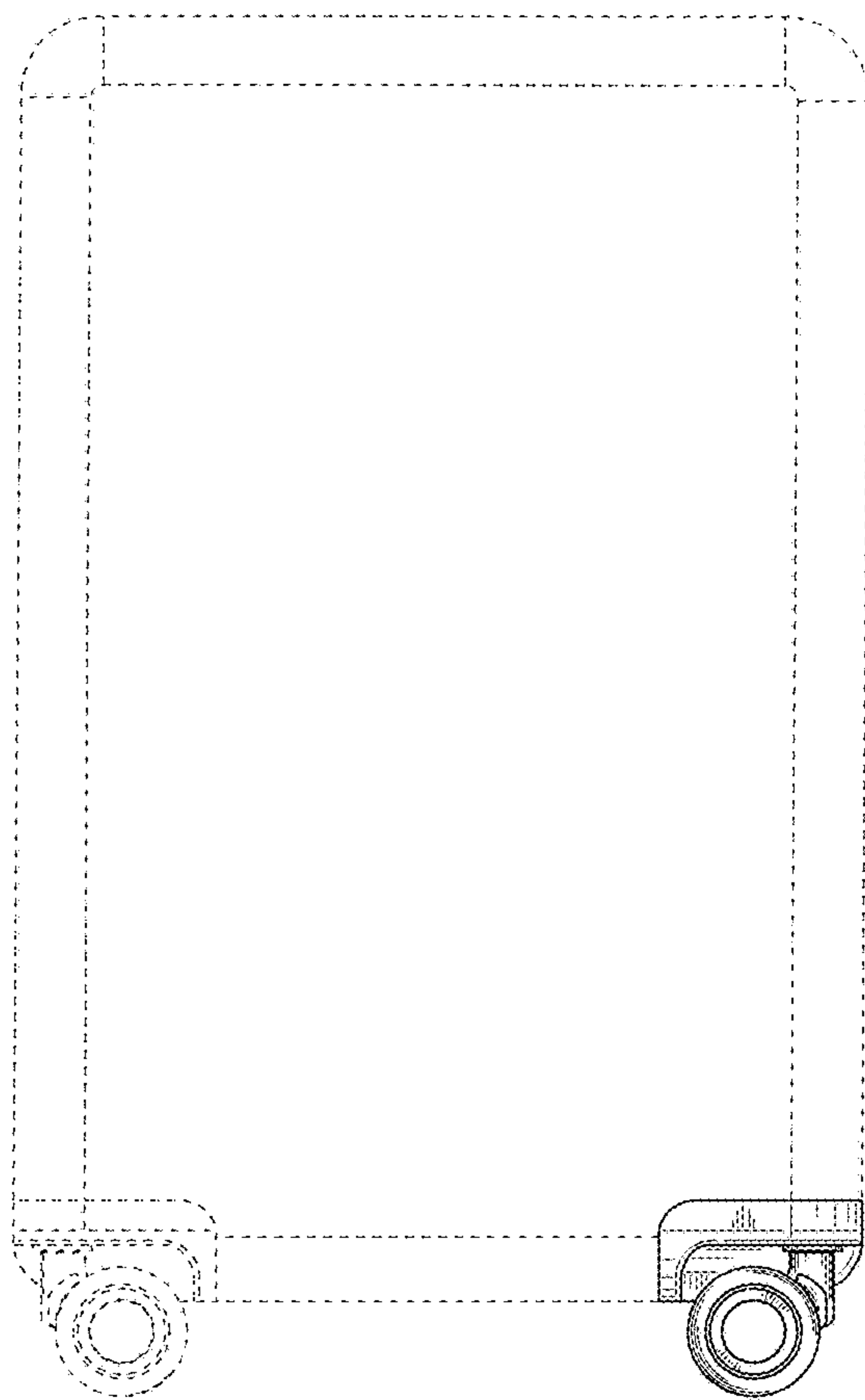

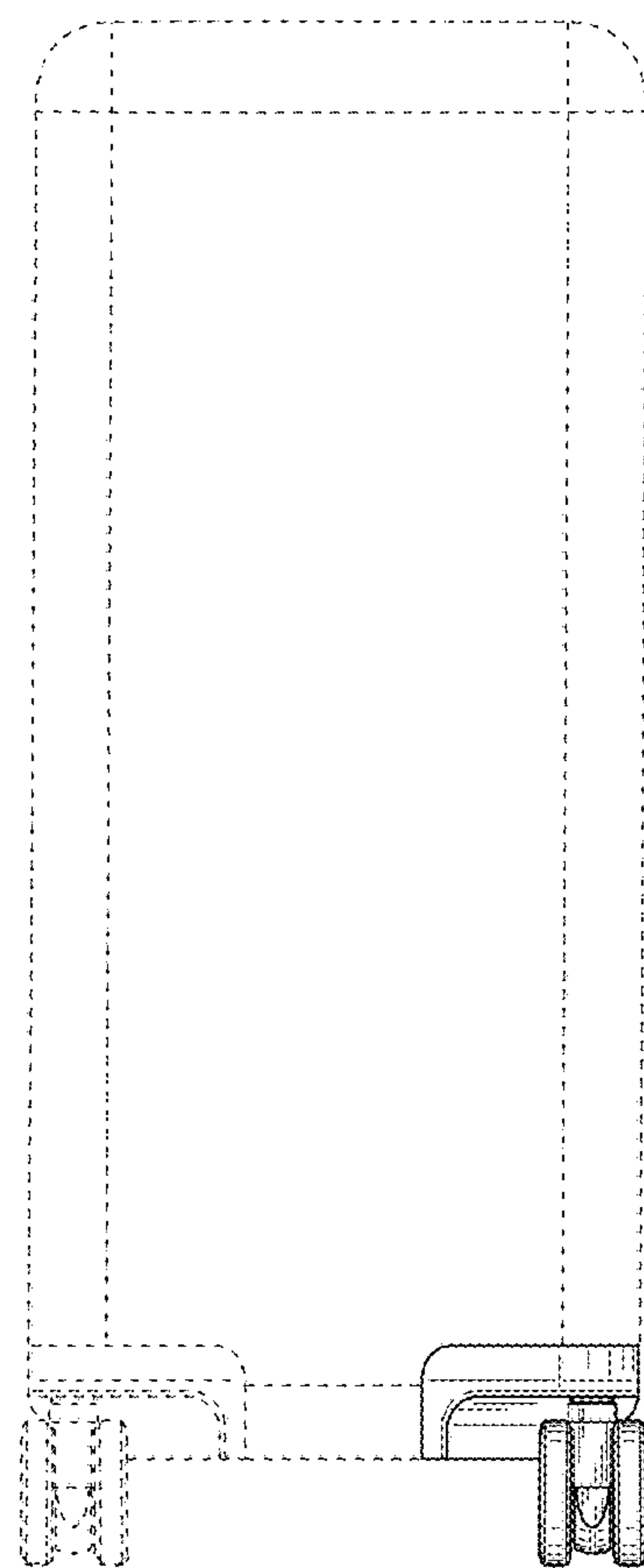

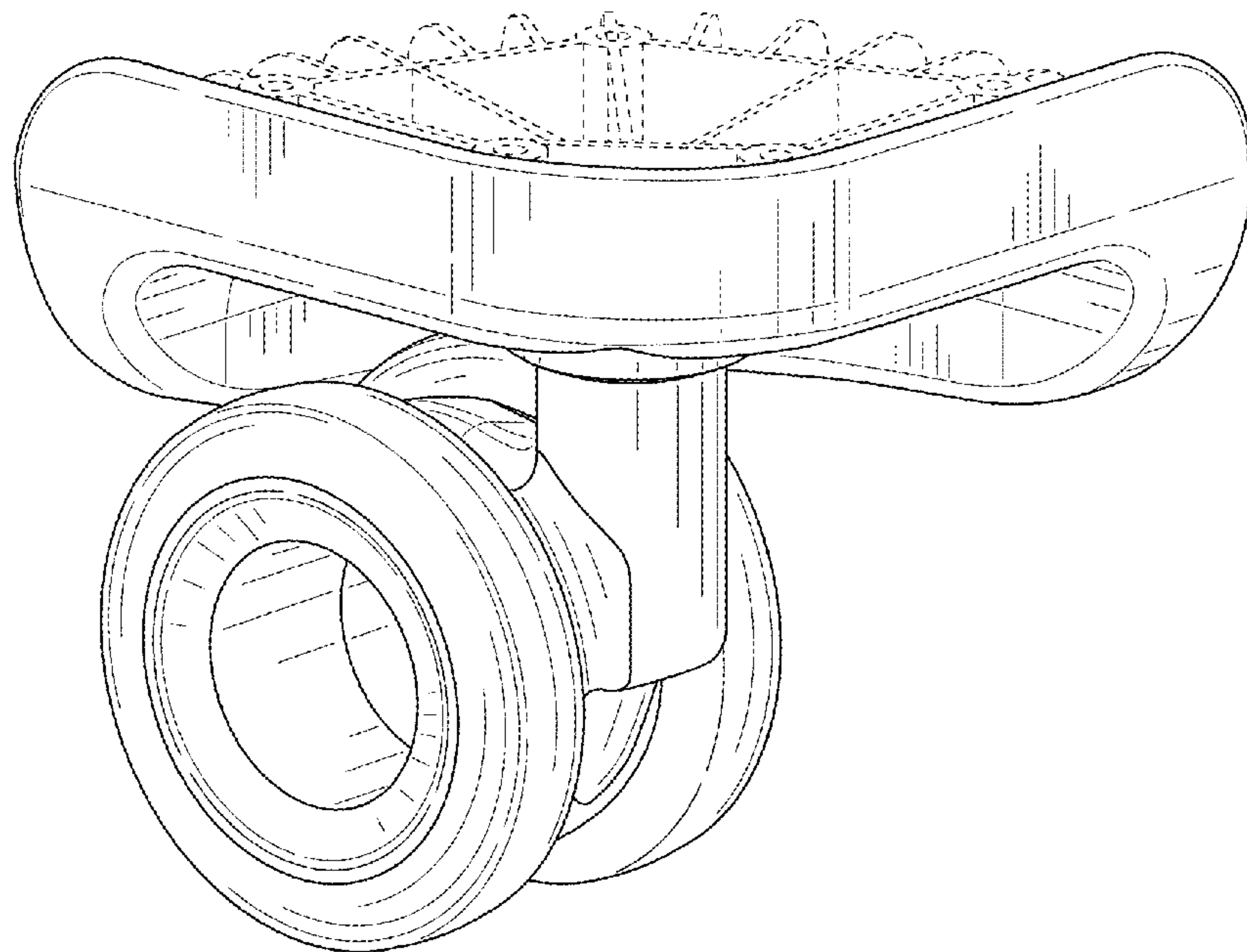
