The ornamental design for a tea box, as shown and described.

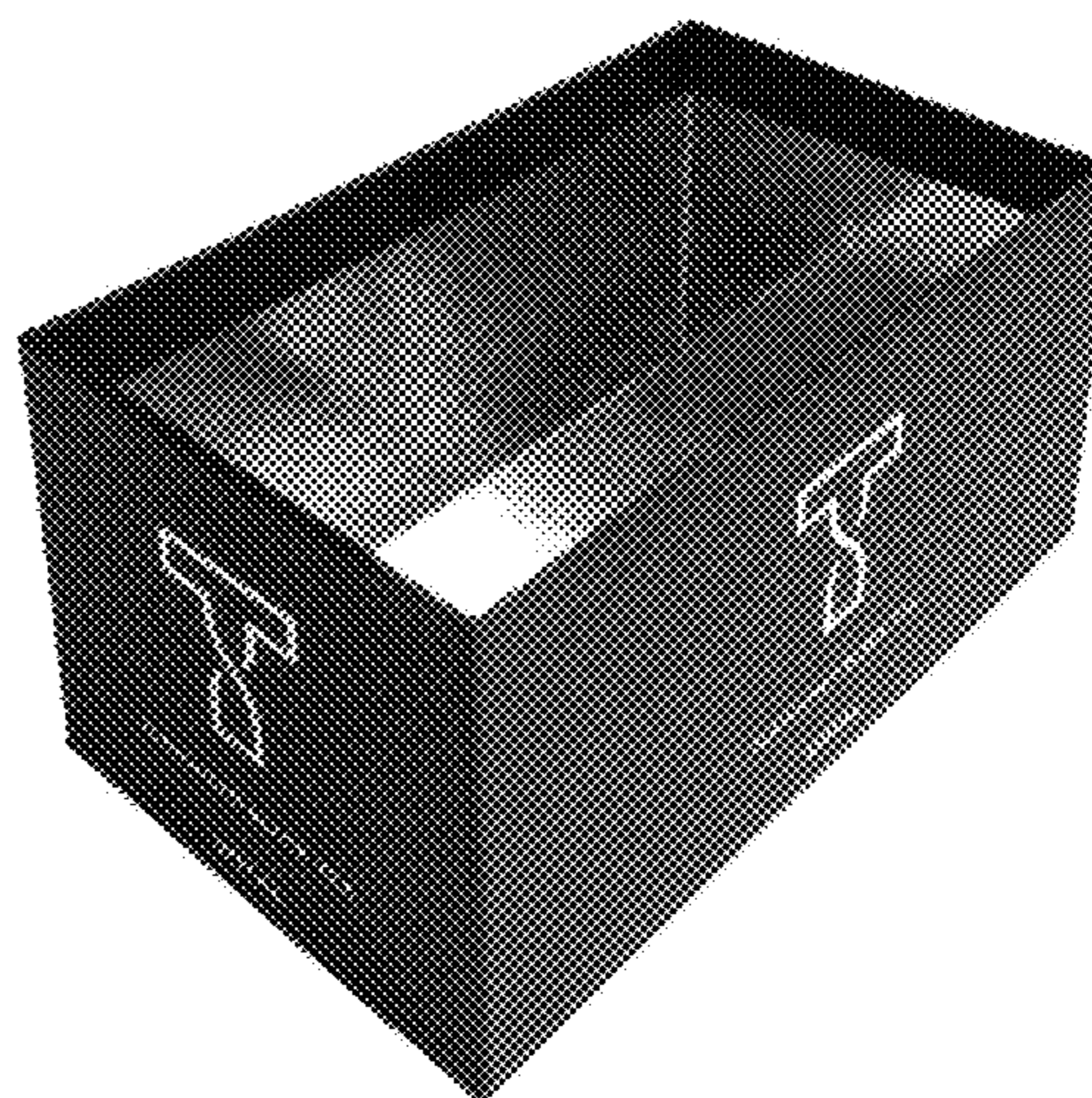
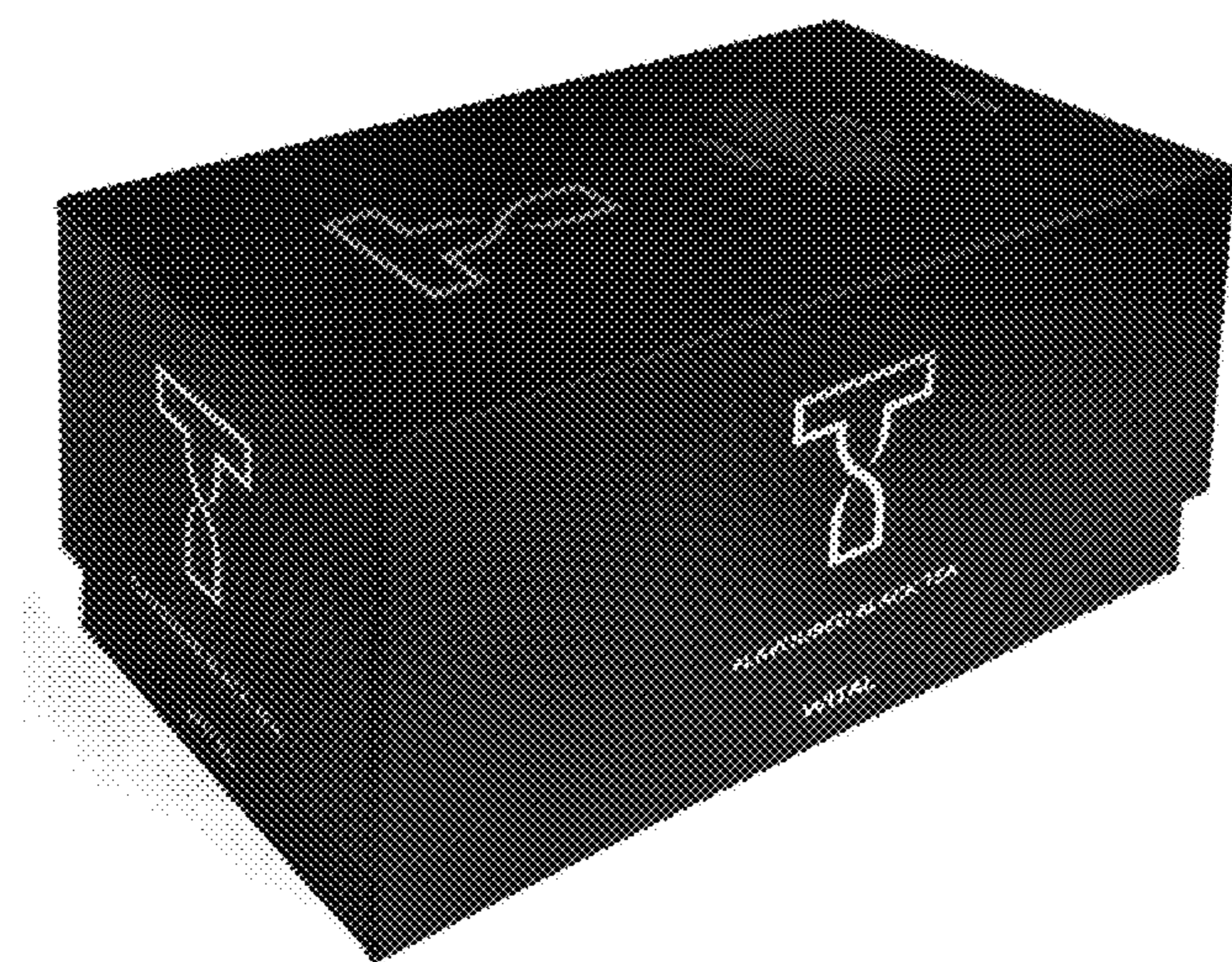
DESCRIPTION

1. Tea box

- 1.1 : Right rear perspective view, lid on
- 1.2 : Front left perspective view, lid on
- 1.3 : Top, right rear perspective view, lid on
- 1.4 : Front left perspective view, lid on
- 1.5 : Front left interior view, lid removed
- 1.6 : Right rear interior view, lid removed
- 1.7 : Front left interior view of the lid

A new ornamental design for a tea box, as set forth in the description, which can be used for the shipping and storage of tea bags.
