(57) **CLAIM**

The ornamental design for a liquid beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a liquid beverage container;

FIG. 2 is a front view of the liquid beverage container of FIG. 1;

FIG. 3 is a rear view of the liquid beverage container of FIG. 1;

FIG. 4 is a left side view of the liquid beverage container of FIG. 1;

FIG. 5 is a right side view of the liquid beverage container of FIG. 1; and,

FIG. 6 is a top elevational view of the liquid beverage container of FIG. 1.

The ornamental design which is claimed is shown in solid lines in the drawings. The shade lines show contour and not surface ornamentation.

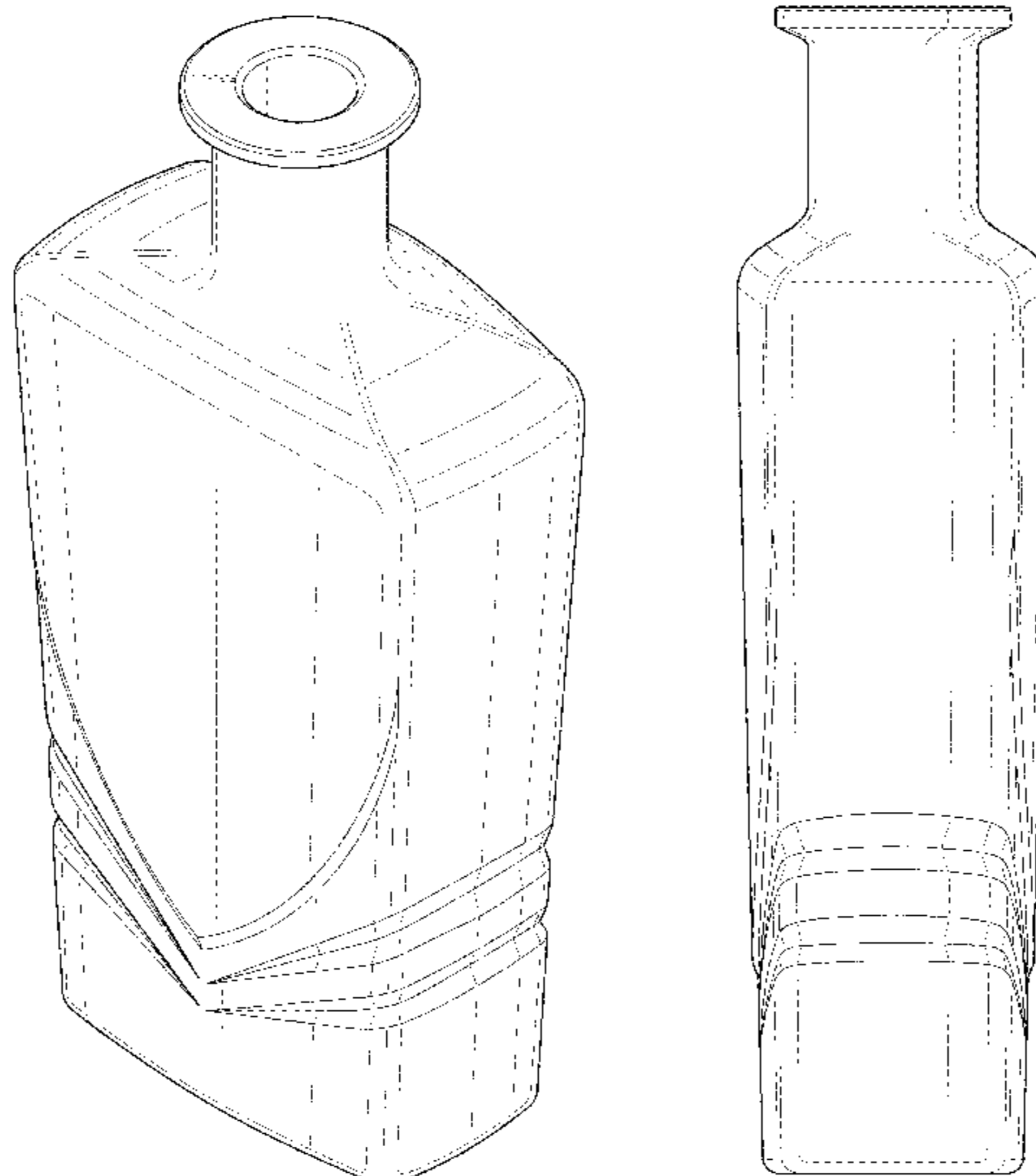

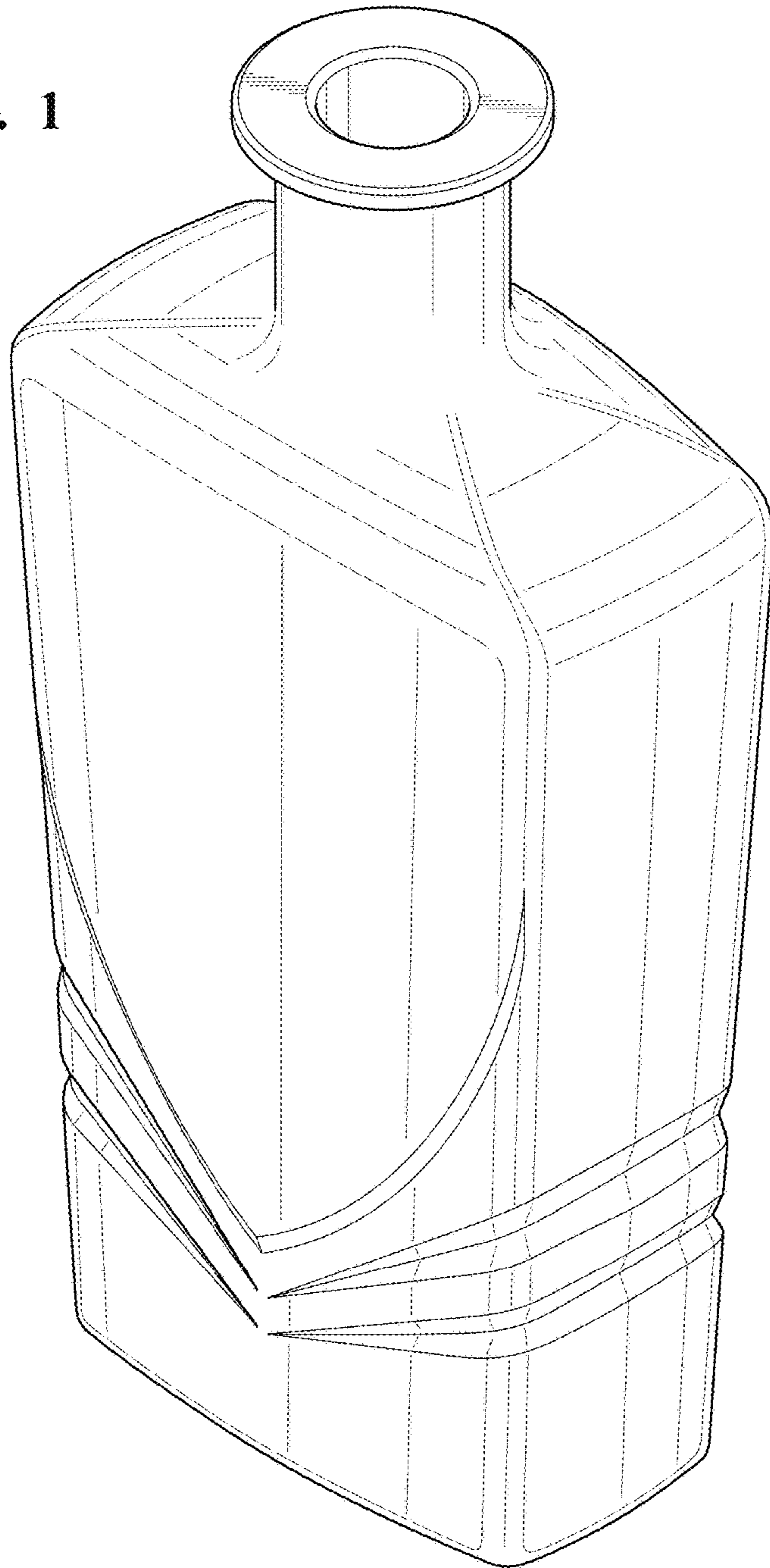

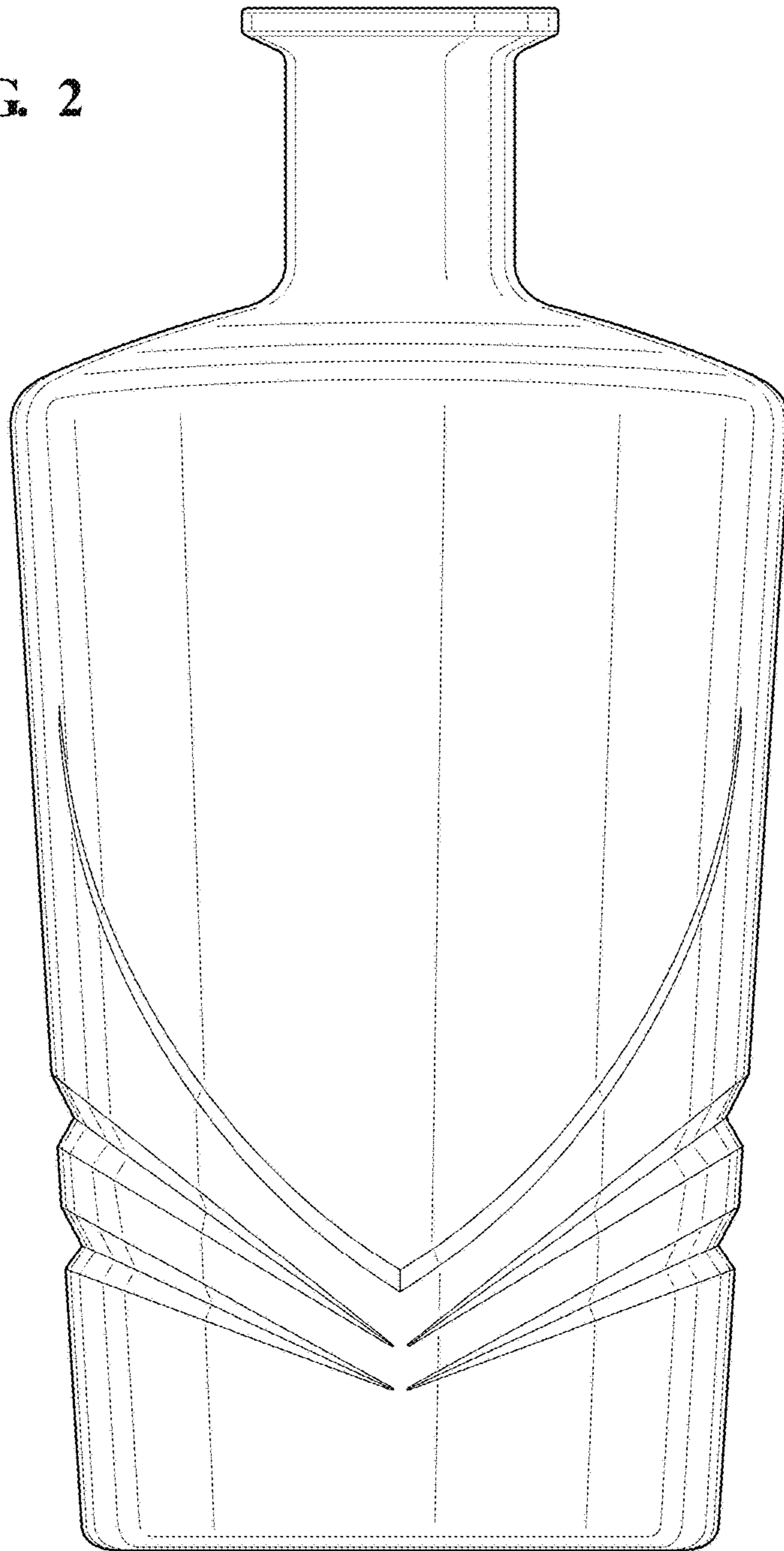

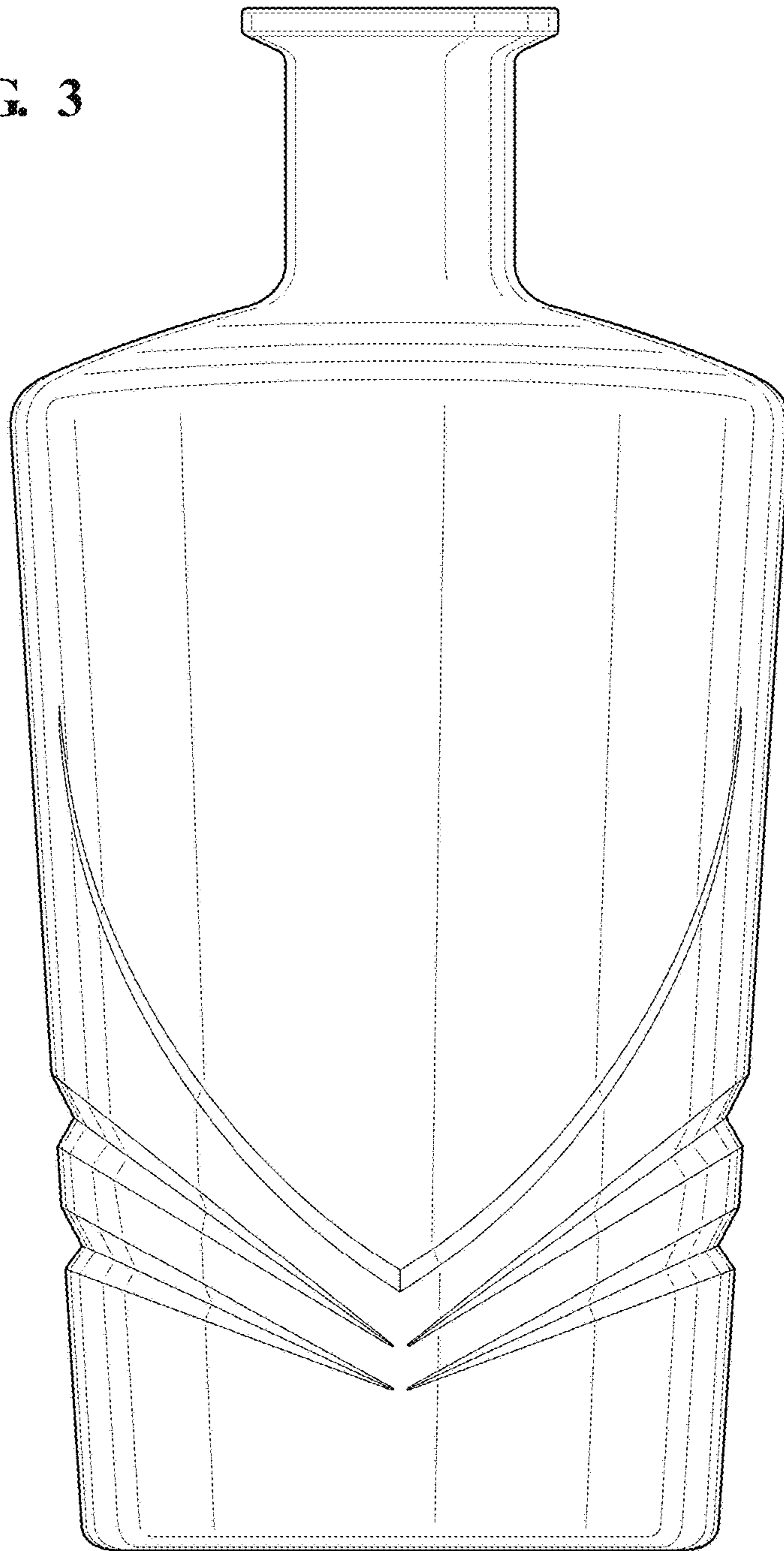

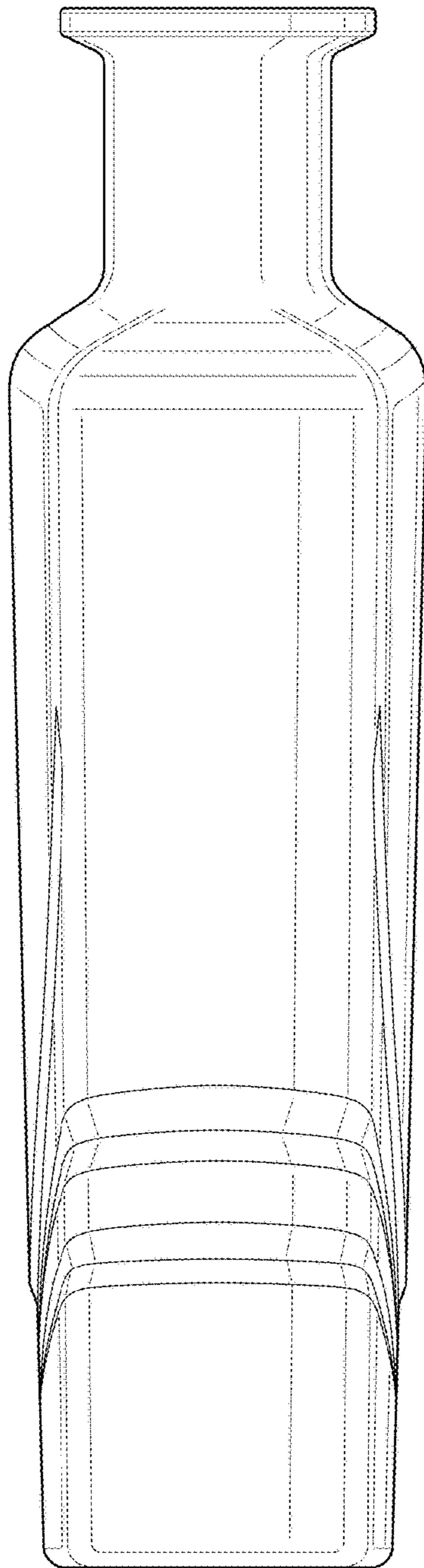

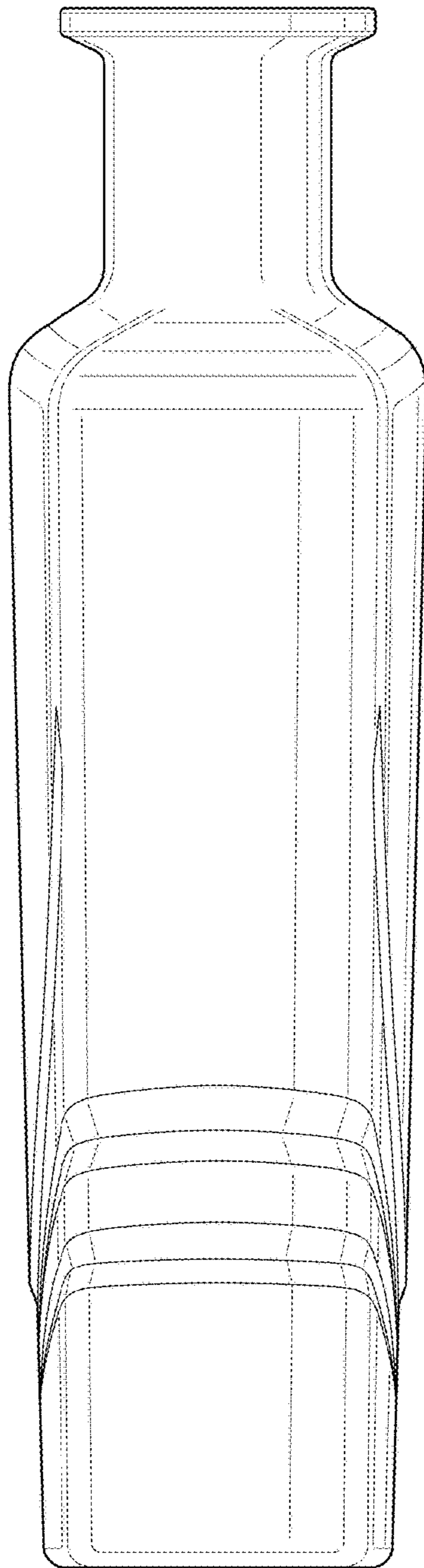
